By an Order of the High Court of Hong Kong on 11 October 2023, Mr. CHAN Leung Lee and Mr. YUEN Tsz Chun, Frank both of Frank Forensic and Corporate Recovery Limited were appointed as the Joint and Several Liquidators of the Company (the "Liquidators"). The Liquidators submitted this monthly return according to the information available to them and shall not be held personally liable for the contents of this monthly return.
