INTRODUCTION

The purpose of this circular is to give you the notice of AGM and provide you with information regarding certain ordinary resolutions to be proposed at the AGM and enable you to make decisions on whether to vote for or against those resolutions.

At the AGM, ordinary resolutions, amongst others, will be proposed for the Company to approve the re-election of Directors, the Issue Mandate, the Repurchase Mandate and extension of the Issue Mandate.

(1) RE-ELECTION OF DIRECTORS

The Nomination Committee of the Company has made a recommendation to the Board that Mr. YUEN Hoi Po and Mr. YUEN Kin will retire at the AGM and, being eligible, offer themselves for re-election pursuant to article 87(1) of the Articles.

Mr. YUEN Kin has served as an Independent Non-executive Director for more than 9 years as at the Latest Practicable Date. Pursuant to Code Provision B.2.3 of the CG Code, his further appointment should be subject to a separate resolution to be approved by the Shareholders.

As Mr. YUEN Kin (i) has fulfilled the independence criteria as set out in Rule 3.13 of the Listing Rules, and (ii) has not taken any management role in the Group nor in any relationships with any Director, senior management, substantial or controlling Shareholders of the Company, the Nomination Committee believes that there are not any circumstances which would interfere Mr. YUEN Kin to exercise his independent judgement and he can continue to demonstrate his ability to provide a balanced and independent view beneficial to the Company and Shareholders as a whole notwithstanding the length of his service.

Mr. YUEN holds a Bachelor of Business Administration degree from the University of Heilongjiang. Mr. YUEN Hoi Po is the sole member and the sole director of Smart Concept Enterprise Limited which is a substantial shareholder of the Company pursuant to Part XV of the Securities and Futures Ordinance and a director of several subsidiaries of the Company. Mr. YUEN Kin is currently an independent non-executive director of Emerson Radio Corporation (NYSEMKT: MSN), a company listed on The New York Stock Exchange. He is also an executive director of Culturecom Holdings Limited (Stock Code: 343), a company listed on The Stock Exchange of Hong Kong Limited.

As at the Latest Practicable Date, Mr. YUEN Kin does not have any interest in the securities of the Company within the meaning of Part XV of the SFO.

Save as disclosed above, Mr. YUEN Kin (i) has not held any other directorships in any public companies which are listed in Hong Kong or overseas in the last three years; (ii) does not hold other positions in the Company or any of its subsidiaries; (iii) does not have any relationship with any other Directors, senior management or substantial or controlling shareholders of the Company; (iv) does not have any interest in the listed securities of the Company within the meaning of Part XV of SFO; and (v) there is no information relating to Mr. YUEN Kin that is required to be disclosed pursuant to Rule 13.51(2)(h) to (v) of the Listing Rules and there are no other matters that need to be brought to the attention of the Shareholders in relation to the re-election of Mr. YUEN Kin.
