New Arrangements on Dissemination of Corporate Communications

Pursuant to the new Rule 2.07A¹ of the Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”) and the Amended and Restated Articles of Association of the Company, the Company will disseminate future corporate communications of the Company (the “**Corporate Communications**”)² to its Shareholders³ electronically and only send Corporate Communications in printed form to the Shareholders upon request.

In this connection, the following arrangements have come into effect on 31 December 2023.

ARRANGEMENTS

1. Actionable Corporate Communications⁴

The Company will send the Actionable Corporate Communications to its Shareholders individually in electronic form by email. If the Company does not possess the email address of a Shareholder or the email address provided by a Shareholder is not functional⁵, the Company will send to the Shareholder the Actionable Corporate Communications in printed form together with a request form for soliciting the Shareholder’s functional email address in order to facilitate electronic dissemination of Actionable Corporate Communications in the future.

2. Corporate Communications

The Company will make the Corporate Communications available on its website (www.sjwt.net) and the Stock Exchange’s website (www.hkexnews.hk).

A notice of publication of the Website Version⁶ of Corporate Communications, in both English and Chinese, will be sent by the Company to the Shareholders by email or by post (where the Company does not possess the functional email address of a Shareholder).

3. Provision of Shareholder’s email address to the Company

In support of electronic communications by email, the Company recommends its Shareholders to provide their email addresses by scanning the personalized QR code printed on the enclosed reply form (the “**Reply Form**”). Alternatively, Shareholders may provide their email addresses by signing and returning the Reply Form to the Branch Share Registrar or by email to starjoy.ecom@computershare.com.hk.

It is the responsibility of the Shareholders to provide their functional email addresses to the Company. If the Company does not possess the email address of a Shareholder or the email address provided is not functional, the Company will act according to the above arrangements. The Company will be considered to have complied with the Listing Rules if it sends Actionable Corporate Communications to the email address provided by a Shareholder without receiving any “non-delivery message”.

Please note that such request shall be valid for one year starting from the receipt date of your request and will expire thereafter.
