Electricity Sold for March 2024

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, the combined total electricity sold by the Company and its subsidiaries (collectively, the “Group”) in March 2024 amounted to 10,545,635MWh, representing an increase of 25.31% compared with the same period last year, while the total electricity sold for the first three months of 2024 was 29,970,060MWh, representing an increase of 31.99% compared with the same period last year.
