2.	(A) To declare a final dividend of HK3 cents per ordinary share of the Company (“Share(s)”) for the year ended 31 December 2023; and		
	(B) To declare a final special dividend of HK3 cents per Share for the year ended 31 December 2023.		
3.	(A) To re-elect the following retiring directors of the Company (the “Director(s)”):		
	(i) To re-elect Mr. Chau Ching as an executive Director;		
	(ii) To re-elect Mr. Seto John Gin Chung as an independent non-executive Director; and		
	(iii) To re-elect Mr. Asvaintra Bhanusak as an independent non-executive Director.		
	(B) To authorise the board of Directors (the “Board”) to fix the Directors’ remuneration.		
4.	To re-appoint PricewaterhouseCoopers as the auditor of the Company to hold office until the conclusion of the next annual general meeting of the Company and to authorise the Board to fix its remuneration.		
5.	(A) To give a general mandate to the Directors to allot, issue and deal with additional shares not exceeding 20% of the issued share capital of the Company (the “Issue Mandate”).		
	(B) To give a general mandate to the Directors to buy back shares not exceeding 10% of the issued share capital of the Company.		
	(C) To extend the Issue Mandate by the number of shares bought back by the Company.

1. If any proxy other than the chairman of the meeting is preferred, please insert the full name and address of the proxy desired in the space provided. A holder entitled to attend and vote at the meeting of the Company is entitled to appoint one or more proxies to attend and vote on his/her behalf. **ANY ALTERATION MADE TO THIS PROXY FORM MUST BE INITIALED BY THE PERSON WHO SIGNS IT.** The proxy needs not be a member of the Company but must attend the meeting (or any adjournment thereof) to represent you.

3. This proxy form must be signed and dated by the shareholder or his/her attorney duly authorised in writing. In the case of joint shareholders, any one shareholder may sign this proxy form. The vote of the senior joint shareholder who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint shareholder(s) and for this purpose seniority will be determined by the order in which the names stand in the register of members in respect of the joint shareholding.

Your proxy will also be entitled to vote at his/her discretion or to abstain on any resolution properly put to the meeting other than those referred to in the notice convening the meeting.

In order to be valid, a proxy form and the power of attorney or other authority (if any) under which it is signed, or a notarially certified copy of such power of attorney, must be deposited at the Hong Kong branch share registrar of the Company, Tricor Investor Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong, not less than 48 hours before the time fixed for holding the meeting or any adjournment thereof.
6. Completion and delivery of this proxy form will not preclude you from attending and voting at the meeting if you so wish, and in such case, the form of proxy previously submitted shall be deemed to be revoked.
7. Please provide one certificate number, if possible, to facilitate processing.
8. For the avoidance of doubt, we do not accept any special instructions written on this proxy form.
