

Dear Shareholders,

On behalf of the board of directors (the "Board"), I am pleased to present the annual report of Zhengye International Holdings Company Limited (the "Company" or "Zhengye International", together with its subsidiaries, "our Group" or the "Group") for the year ended 31 December 2023 (the "Period" or the "Period under Review").

#### **Review**

In 2023, the international situation was complex and volatile, with increased uncertainties, the impacts of the epidemic and geopolitical conflicts on supply chain restructuring persisted. Currently, global industrial and supply chains are gradually recovering, while a new round of technological revolution and industrial transformation is further developing, presenting a new landscape for China's economic development. In the first half of 2023, due to insufficient demand and oversupply in some industries, China's national income growth slowed, asset prices fell, and residents' expectations weakened, leading to a lack of consumer willingness. The government timely implemented proactive fiscal policies and prudent monetary policies, strengthened policy innovation and coordination. From the third quarter onwards, the national economy generally improved, with stable employment and prices, social stability maintained, and the dominant role of domestic circulation notably enhanced, achieving moderate growth overall.

In 2023, the Group experienced the most difficult and challenging year since listing. Particularly in the first half of the year, slow recovery of domestic demand and exports, coupled with insufficient demand and severe supply-demand imbalance, greatly impacted the paper and paper packaging industries. Additionally, the excessive cost of natural gas as an energy source, the Group's paper production segment recorded operating loss. In the second half of the year, the Group implemented various cost reduction measures, controlling cash flow, and maintained a stable capital structure. As the domestic economy gradually recovered, the Group's overall revenue increased and the increase in steam supply of biomass boiler helped to reduce energy costs, resulting in significant improvement in economic performance compared to the first half of the year. Despite recorded operating loss for the year, we were able to maintain operating cash flow. We believe the toughest period has passed, and the Company will continue to move forward steadily.

### 致尊敬的股東:

本人謹此代表董事會(「**董事會**」),向各位提呈正業國際控股有限公司(「本公司」或「正業國際」),連同其附屬公司統稱(「本集團」)截至二零二三年十二月三十一日止十二個月(「期內」或「回顧期」)的年度業績。

#### 回顧

二零二三年,國際局勢複雜多變,不確定因素增多,疫情影響、地緣政治衝突引發的供應鏈重組影響仍然存在,目前,全球產業鏈、供應鏈逐步恢復暢通,新一輪科技革命和產業變革正深入發展,中國經濟發展也呈現新的格局。二零二三年上半年,在需求不足、部分行業產能過剩影響下,中國國民收入增長放緩、資產價格下跌,居民預期轉弱、消費意願不足,政府適時實施積極的財政政策和穩健的貨幣政策,加強政策工具創新和協調配合,自第三季度開始,國民經濟總體回升向好,就業物價基本平穩,社會大局保持穩定,國內大循環主導作用明顯增強,整體經濟實現溫和增長。

二零二三年,本集團經歷上市以來最困難及最具挑戰一年。特別是上半年,內需和出口恢復緩慢,在需求不足、供求關係嚴重失衡影響下,紙和紙包裝行業受到較大衝擊,加上本集團使用天然氣能源造成能源成本過高,集團造紙板塊錄得經營虧損。下半年,本集團採取多項措施節降成本費用,控制現金流,保持穩定資本結構,隨著國內經濟逐步回暖,本集團整體收入增長,同時增加了生物質鍋爐發汽從而降低能源成本,經濟效益已較上半年明顯改善。雖全年錄得經營虧損,但仍能保持經營活動現金流,相信最困難的時期已過去,公司仍將穩步前行。



### Chairman's Statement 董事長報告

For the 12 months ended 31 December 2023, the Group recorded a total turnover of approximately RMB2,390,517,000, representing a decrease of 20.69% year-on-year (12 months ended 31 December 2022:RMB3,013,957,000). The Group's gross profit was RMB269,996,000 and gross profit margin was approximately 11.29%. Loss for the period attributable to owners of the Company amounted to RMB17,553,000, the Group recorded its first annual operating loss.

Facing the market challenges of weak demand and severe supply-demand imbalance in the first half of 2023, the Company intensified its product research and development and technological innovation efforts, the paper production segment achieved a basic balance between production and sales during the year. Additionally, the Company increased its focus on developing packaging businesses for home appliances and fast-moving consumer goods. Despite the temporary reduction in export orders from downstream customers, the packaging business was able to maintain order volumes from major customers. Through strengthened supply chain management, the gross profit margin of the packaging business increased by 1.07% compared to the corresponding period last year, reaching 22.57%. The cash dividend per share for the Group for the year is HKD0.01. Since its listing in 2011, the Group has maintained a consistent cash dividend policy based on business performance and shareholder returns. The Company's operations are currently facing challenges due to the factors such as the pandemic and changes in the macroeconomic environment. However, the Company's annual operating cash flow is ample, and implementing cash dividends does not affect normal operations and long-term development of the Company.

### **Prospects**

In 2024, as China's economy transitions from high-speed growth to high-quality development, macroeconomic policies will be adjusted towards the direction of "Promoting stability with progressing; Construction before destruction" (「以進促穩•先立後破」). This adjustment aims to boost residents' confidence in consumption and investment, while accelerating the cultivation of new quality-based productivity and enhancing overall factor productivity, providing new momentum for longer-term economic growth in the future. China's economy is expected to continue improving demonstrating its resilience and vitality in economic development.

In 2024, competition in the paper production and packaging market will continue to intensify, but we believe that crises and opportunities coexist. We will continue to invest in research and development as well as industry upgrades, and focus on customer-oriented approaches to provide personalized and high-quality products for our customers. The Group's packaging segment will continue to intensify efforts in developing packaging businesses for fast-moving consumer goods and household appliances, continuously explore new business directions, and promote greater development in the Group's packaging business. This will establish Zhengye International as a competitive leader in integrated paper production and packaging in the Greater Bay Area.

截至二零二三年十二月三十一日止十二個月,本集團總體營業額約人民幣2,390,517,000元,同比下降20.69%(二零二二年十二月三十一日止十二個月:人民幣3,013,957,000元)。本集團的毛利為人民幣269,996,000元,毛利率約11.29%。本公司擁有人應佔期內虧損為人民幣17,553,000元,本集團首次錄得年度虧損。

面對二零二三年上半年需求疲軟、供求嚴重失衡的市場情況,公司加強了產品研發,技術開發,年度內造紙產品基本實現產銷平衡。同時加大對家電包裝業務、快消品包裝業務的開發,在下游客戶出口訂單階段性減少影響下,包裝業務仍能保持基本大客戶的訂單量,通過加強供應鏈管理,包裝業務毛利率較去年同期上漲1.07%,達到22.57%。集團本年度現金派息每股1分。自2011年上市以來,集團根據經營業績情況以及股東回報規劃,保持連續一貫的現金派息政策,受疫情及宏觀經濟環境變化等多因素影響,公司目前經營受到挑戰,但公司年度經營現金流充裕,實施現金派息不影響公司正常經營和長期發展。

### 展望

二零二四年,隨著我國經濟從高速增長向高質量發展轉型,宏觀經濟政策將朝著「以進促穩、先立後破」的方向進行調整,居民對於消費和投資的信心,同時加快培育新質生產力,提高全要素生產率,為未來更長期的經濟增長提供新動力。中國經濟有望「持續向好」,彰顯經濟發展的韌性和活力。

二零二四年,造紙和包裝市場競爭將繼續加劇,但我們相信危機和機遇並存,我們將繼續投資於研發以及產業升級,並以客戶為導向,為客戶提供個性化和高質量的產品。集團包裝分部將繼續加大力度開發快消品包裝業務、家電包裝業務,不斷拓展新的業務方向,推動集團包裝業務取得更大發展,讓正業國際成為大灣區造紙包裝一體化具有競爭力的頭部企業。

### **Business Review**

In 2023, under the backdrop of the prolonged impact of the COVID-19 pandemic, escalating geopolitical conflicts, and complex changes in the international situation, China's macroeconomic situation entered a period of recovery after the pandemic. In the first half of the year, the Company faced triple pressures of shrinking demand, supply shocks, and weakening expectations. To address the new circumstances and challenges, China made significant adjustments to its macroeconomic policies. With the effective drive of proactive fiscal policies and prudent monetary policies, economic sentiment rebounded after the third quarter, achieving moderate growth for the year as a whole.

The paper and paper packaging products industry has always been regarded as a barometer of consumption. In the first half of the year, due to the weakening of China's domestic consumption demand and severe imbalances in supply and demand, the Group's business suffered significant impacts, particularly in the paper manufacturing business. In the first half of the year, the unit price of products continued to decline, coupled with the excessive energy costs incurred by the predominant use of natural gas, leading to an annual loss in the Group's paper manufacturing business. In the second half of the year, with the recovery of domestic consumption, the paper industry was further revitalized. From the fourth quarter onwards, paper prices stabilized and rebounded, sales of paper production increased, and the overall business of the Group expanded. Furthermore, the Company increased the steam supply of biomass boilers to reduce energy costs, significantly improving the Group's profitability.

### Paper manufacturing segment

The Group's paper production products mainly include corrugated medium paper and craft paper.

The Group produces 42 g/cm²-140 g/cm² high-strength corrugated medium paper and 70g/cm²-140g/cm² craft paper. While some of these are used as raw materials for our paper-based packaging products, they are mostly sold to cardboard manufacturers and carton packaging manufacturers in the Pearl River Delta region of Guangdong. Customers of the Group's paper-making business segment spread across Guangdong, Jiangxi, Fujian, Chaoshan, and other regions; the total number of which is currently nearly 400.

In the Year 2023, the Group's paper production business achieved operating revenue of RMB1,728,660,000 a significant decrease of 24.22% compared to RMB2,281,249,000 for the corresponding period last year. During the period, the gross profit margin of the paper production business decreased to 6.98% from 8.08% for the corresponding period last year. The gross profit amount significantly decreased as compared to the last year for RMB63,642,000. The Group's paper production business recorded an annual loss for the first time.

### 業務回顧

二零二三年,在新冠疫情長期影響尚存、地緣政治衝突加 劇、國際局勢複雜變化的大環境下,我國宏觀經濟進入疫 情後的恢復期,上半年,面臨需求收縮、供給衝擊、預期 轉弱三重壓力,為應對經濟新形勢新挑戰,我國宏觀經濟 政策作出重大調整,在積極的財政政策和穩健的貨幣政策 的有效帶動下,三季度後經濟景氣度回升,實現了全年經 濟的溫和增長。

紙及紙製品包裝行業一直以來被視為是消費的晴雨錶,上半年受到中國國內消費需求疲弱、供求關係嚴重失衡的影響,對集團業務造成較大衝擊,尤其集團造紙業務,上半年產品單價持續下跌,加上使用天然氣能源造成能源成本較高,集團造紙業務錄得年度虧損。下半年,隨著國內消費復甦,進一步推動造紙行業的回暖,第四季度起,紙價基本企穩有所回升,造紙銷售量上升,集團業務整體增加,而且增加了生物質鍋爐發汽使得能源成本降低,集團盈利狀況得到大幅改善。

### 造紙分部

本集團造紙產品主要是瓦楞芯紙和牛卡紙。

本集團生產42 g/cm²-140 g/cm²高強度瓦楞芯紙,70 g/cm²-140 g/cm²牛卡紙,除部分為本集團生產紙製包裝產品作為原材料外,主要向廣東珠三角地區紙板生產廠家、以及紙箱包裝廠家銷售,集團造紙客戶分佈於廣東、江西、福建、潮汕等地區,現集團造紙板塊服務的客戶總數量近400家。

二零二三年度,本集團造紙業務於期內實現營業收入人民幣1,728,660,000元,較去年同期人民幣2,281,249,000元大幅下降24.22%。期內造紙業務毛利率則由去年同期8.08%降至本期的6.98%。毛利額較去年大幅下降人民幣63,642,000元,本集團造紙業務首次錄得年度虧損。



### 管理層討論與分析

In the first half of 2023, facing a severe imbalance in supply and demand of the overall market, the Group's paper manufacturing sector persisted in product research and development, continuously optimized production costs and expenses, and enhanced product market competitiveness, enabling the Group's paper products to achieve a balance between production and sales. In the second half of 2023, as the consumer market experienced a turnaround, the Group's paper manufacturing sector business witnessed stable and substantial growth. With the increased of biomass boilers steam supply, energy costs were effectively reduced, leading to a significant improvement in the profitability of the Group's paper manufacturing.

本集團造紙板塊在面對二零二三年上半年整體市場產品供求關係嚴重失衡情況下,公司堅持產品研發,持續優化各項生產成本費用,提升產品市場競爭力,使集團造紙產品能夠實現產銷平衡。二零二三年下半年隨著消費市場回暖,集團造紙板塊業務穩定增長,在增加生物質鍋爐供汽後能源成本更是得以有效降低,集團造紙板塊盈利水平得到較大改善。

### **Packaging segment**

The Group's paper packaging products include craft cartons, color printing cartons, honeycomb paper-based products and exquisite color box packaging.

The Group's paper packaging products mainly serve large home appliance companies, major fast-moving consumer goods companies in the food sector, high-tech electronics products, daily chemical products and cosmetics, as well as the wine industry and other high-end manufacturing enterprises. The Group continues to ensure high-quality product supply and excellent after-sales service, aiming to enhance customer trust, gain the favor of multiple brand customers, and maintain long-term stable cooperation.

During the Period under Review, the Group's paper packaging business recorded a revenue of RMB661,857,000, a decrease of 9.67% as compared to RMB732,708,000 for the corresponding period last year. Among them, revenue from craft cartons, color printing cartons, honeycomb paper-based products and exquisite color box packaging reached RMB461,448,000, RMB105,303,000, RMB64,419,000, and RMB30,687,000 respectively (In 2022: RMB572,383,000, RMB91,559,000, RMB66,257,000, and RMB2,509,000 respectively). Due to the significant 21.5% decrease in the price of raw paper during the Period under Review, the gross profit margin of the paper packaging business for the period was 22.57%, representing an increase of 1.07% as compared to the corresponding period last year.

#### 包裝分部

本集團的紙製包裝產品包括牛卡紙箱、彩印紙箱、蜂窩紙 制品、精美彩盒包装。

本集團紙製包裝產品主要服務於大型家電企業、大型食品 快消品企業、高科技電子產品、日化美妝、酒類等高端製 造業企業,本集團持續確保較高品質產品供應與優質的售 後服務,提高客戶信賴程度,獲得多家品牌客戶青睞並保 持長期穩定合作。

於回顧期內,本集團紙製包裝業務錄得營業收入人民幣661,857,000元,較去年同期人民幣732,708,000元下降9.67%,其中牛卡紙箱、彩印紙箱、蜂窩紙製品及精美彩盒包裝各實現營業收入人民幣461,448,000元、人民幣105,303,000元、人民幣64,419,000元及人民幣30,687,000元(二零二二年分別為人民幣572,383,000元、人民幣91,559,000元、人民幣66,257,000元及人民幣2,509,000元)。得益於回顧期內原紙價格大幅下跌21.5%,期內紙製包裝業務毛利率22.57%,較去年同期上升1.07%。

### Packaging paper

The main production base of packaging paper is located in Zhongshan city and Jiangxi province. For the year ended 31 December 2023, the Group had 8 packaging paper production lines with a total designed annual capacity of 900,000 tons, making the Group one of the leading packaging paper producers in Guangdong region. The Group always attached emphasis on improvement of production efficiency and optimization of plant management. During the Year, the Group adopted the performance indicator approach to manage the packaging paper production lines, continuously improving production volume and capacity utilisation rate.

### Paper-based packaging products

For the year ended 31 December 2023, the Group had a total of 5 production lines (including 3 corrugated cartons production lines and 2 honeycomb paper-based products production lines) which are mainly located in three cities including Zhongshan, Zhuhai and Wuhan. The Group's planned annual capacity for corrugated cartons reached 191,617,000 square meters; whereas that yearly planned capacity for honeycomb paper-based products was 11,008,000 square meters. The Group's comprehensive production deployment enables it to generate synergies in terms of production costs, industrial chain integration, and customer service, which in turn enhanced the overall operational efficiency.

### 紙製包裝產品

### **Prospects**

Looking ahead to 2024, with the steady recovery of the Chinese economy and continuous policy support, the effects of growth-stabilizing policies will continue to manifest. Domestic demand is expected to sustain recovery, and the Chinese economy will gradually return to its potential growth rate, further consolidating its foundation of stable and positive development.

In 2024, in the paper manufacturing sector, the Group will continue to invest in the research and development of low-grammage high-strength corrugated paper products, strengthen technological innovation, and improve supply chain management. Through technological transformation, we will further enhance the operational efficiency of paper machines, strengthen product competitiveness, and continue to increase the market share of our company's low-grammage high-strength corrugated paper products in the Greater Bay Area. The Company is committed to becoming an influential producer of high-strength low-grammage corrugated paper in South China. In the packaging sector, the Company will continue to expand its customer base in industries such as home appliances and fast-moving consumer goods, and steadily promote the expansion of new packaging capacity in the Greater Bay Area. We will also increase investment in digitized and intelligent production facilities, accelerate industrial upgrading, and aim for steady growth in the sales of our paper packaging products while the industry rebounds. Our goal is to continue moving towards becoming a leading paper packaging enterprise in the Greater Bay Area.

### **Financial Review**

For the year ended 31 December 2023, the revenue of the Group was approximately RMB2,390,517,000 (2022: RMB3,013,957,000), representing a decrease of approximately 20.69% as compared to the corresponding period last year. Mainly due to the sales revenue from paper production segment significantly decreased by 24.22%, sales volume in the paper production product decreased by approximately 14.7% as compared to last year, sales unit price decreased by approximately 11.17%.

The Group's gross profit margin in 2023 was 11.29% (2022 the corresponding period: approximately 11.34%), basically staying level as compared to the corresponding period last year. Due to the impact of the Group's paper production business's gross profit amount significantly decreased by RMB63,642,000 as compared to the last year, the Group recorded operation loss for the first time.

For the year ended 31 December 2023, the loss attributable to owners of the Company during the Year is RMB17,553,000.

### 展望

展望二零二四年,隨著中國經濟穩步恢復,宏觀政策持續支撐,穩增長的政策效果將繼續顯現,國內需求有望持續修復,中國經濟將向潛在增速水平回歸,不斷鞏固穩中向好的基礎。

二零二四年,造紙板塊,本集團仍將繼續投入對低定量高強度瓦楞芯紙產品研發,加強技術創新,完善供應鏈管理,通過技術改造進一步提升紙機運行效率,增強產品競爭優勢,繼續推動集團低定量高強度瓦楞芯紙產品在大灣區的市場佔有率,公司致力成為華南地區具有影響力的高強度低定量瓦楞芯紙生產企業。包裝板塊,本集團將繼續拓展家電、快消品等行業的優質大客戶,持續推進於大灣區的新增包裝產能佈局,繼續加大對數字化、智能化生產工廠的投入,加快產業升級,以期在行業回暖的同時,本集團紙包裝產品銷售穩步向上增長,向成為大灣區頭部包裝企業的目標繼續邁進。

### 財務回顧

截至二零二三年十二月三十一日止年度,本集團的收入約為人民幣2,390,517,000元(二零二二年:人民幣3,013,957,000元),較去年同期減少約20.69%,主要受造紙板塊產品銷售收入同比大幅下降24.22%影響,造紙產品銷售數量較去年下降約14.7%、銷售單價下降約11.17%。

二零二三年集團毛利率11.29%(二零二二年同期約11.34%),與去年同期基本持平,但受集團造紙業務毛利額較去年大幅下跌人民幣63,642,000元影響,集團首次錄得經營虧損。

截至二零二三年十二月三十一日止年度,本公司擁有人年 內應佔虧損為人民幣17,553,000元。



### 管理層討論與分析

#### Cost of sales

The Group's cost of sales decreased from RMB2,672,227,000 in 2022 to RMB2,120,521,000 in 2023, representing a decrease of 20.65%.

#### Packaging paper

The cost of sales of packaging paper in 2023 were RMB1,608,071,000 (2022: RMB2,097,018,000), representing a decrease of 23.32%.

### Paper-based packaging products

The cost of sales of paper-based packaging products in 2023 were RMB512,450,000 (2022: RMB575,209,000), representing a decrease of 10.91%.

### Gross profit and gross profit margin

For the Year 2023, the gross profit recorded RMB269,996,000, representing a decrease of 20.99% as compared with RMB341,730,000 in the same period of Year 2022. The average gross profit margin decreased from 11.34% in Year 2022 to 11.29% for the Year, primarily due to the decreased market demand for paper-based packaging product as a result of sluggish consumption under the influence of the COVID-19 pandemic and other factors, leading to the decrease in sales price of packaging paper under the imbalance between supply and demand. Meanwhile, affected by the Russo-Ukrainian war, energy costs rose significantly. The marginal efficiency of the paper manufacturing sector of the Group dropped significantly compared with previous years.

### Packaging paper

For the Year 2023, the gross profit from packaging paper was RMB120,589,000 (2022: RMB184,231,000), representing a decrease of 34.54%. The overall gross profit margin for 2023 was 6.98% (2022: 8.08%), decreased by 1.1 percentage points.

### Paper-based packaging products

For the Year 2023, the gross profit from paper-based packaging products was RMB149,407,000 (2022: RMB157,499,000), representing a decrease of 5.14%. The overall gross profit margin for 2023 was 22.57% (2022: 21.50%), increased by 1.07 percentage points.

### Other income, other gains and losses

Other income, other gains and losses mainly included income from interest of RMB4,318,000 (2022: RMB3,731,000), government subsidies of RMB76,214,000 (2022: RMB125,881,000) and net amount of exchange losses of RMB904,000 (2022: net amount of exchange loss RMB3,526,000).

### 銷售成本

本集團的銷售成本由二零二二年度人民幣2,672,227,000 元下降至二零二三年度人民幣2,120,521,000元,減幅 20.65%。

### 包裝紙

包裝紙二零二三年度銷售成本為人民幣1,608,071,000元(二零二二年:人民幣2,097,018,000元),減少23.32%。

#### 紙製包裝產品

紙製包裝產品二零二三年度銷售成本為人民幣 512,450,000元(二零二二年:人民幣575,209,000元),下降10.91%。

#### 毛利及毛利率

本年度之毛利為人民幣269,996,000元,較二零二二年度 同期的人民幣341,730,000元減少20.99%。平均毛利率由 二零二二年度的11.34%下降至本年度的11.29%。主要原 因是受新冠疫情等因素影響,消費疲軟,包裝紙市場需求 量下降,在市場供需失衡之下包裝紙銷售價格下降,同 時,由於俄羅斯烏克蘭戰爭影響,能源成本大幅上漲,本 集團造紙板塊邊際效率較往年大幅下降。

### 包裝紙

包裝紙二零二三年度之毛利為人民幣120,589,000元(二零二二年:人民幣184,231,000元),下降34.54%。二零二三年度整體毛利率為6.98%(二零二二年:8.08%),減少1.1個百分點。

### 紙製包裝產品

紙製包裝產品二零二三年度毛利為人民幣149,407,000元 (二零二二年:人民幣157,499,000元),減少5.14%。二零 二三年度整體毛利率為22.57%(二零二二年:21.50%), 增加1.07百分點。

#### 其他收入、其他收益及虧損

其他收入、其他收益及虧損主要包括利息收入人民幣4,318,000元(二零二二年:人民幣3,731,000元)、政府補貼人民幣76,214,000元(二零二二年:人民幣125,881,000元)及匯兑虧損淨額人民幣904,000元(二零二二年:匯兑虧損淨額人民幣3,526,000元)。

### Distribution and selling expenses

The distribution and selling expenses of the Group decreased by approximately 6.26% from RMB92,103,000 for the Year 2022 to RMB86,334,000 for the Year 2023. During the Year, the distribution and selling expenses mainly included salaries of salesmen, transportation costs and business promotion expenses. The decrease in distribution and selling expenses was attributable to the substantial decrease in the Group's sales during the Year.

### Administrative expenses

Administrative expenses of the Group increased by approximately 5.57% from RMB131,637,000 for the Year 2022 to RMB138,972,000 for the Year 2023. The administrative expenses mainly included salaries of management, staff welfare, rent and depreciation.

#### **Finance costs**

Finance costs of the Group decreased by approximately 12.02% from RMB59,600,000 for the Year 2022 to RMB52,434,000 for the Year 2023. It was mainly due to the decrease in the Group's bank loan amount and the decrease in the Group's interest rate on bank loans during the Year.

### Research and development expenses

Research and development expenses of the Group decreased from RMB116,388,000 (approximately 3.86% of sales revenue) in the Year 2022 to RMB90,235,000 (approximately 3.77% of sales revenue) for the Year 2023.

### Profit and total comprehensive (expense) income

During the Year, the total loss attributable to equity holders of the Group was RMB16,842,000. The annual loss attributable to owners of the Company was RMB17,553,000, a decrease of 137.21% from the profit attributable to owners of the Company in 2022 to RMB47,167,000.

### **Dividend Policy**

The declaration, form, frequency and amount of any dividend payout of the Company must be in accordance with relevant laws, rules and regulations and subject to the Bye-laws of the Company. Subject to compliance with applicable laws, rules, regulations and the Bye-laws, in deciding whether to propose any dividend payout, the Board will take into account, among other things, the financial results, the revenue and distributable reserves, the operations and liquidity requirements, the debt ratio and possible impact of credit facilities, and the current and future development plans of the Company.

### 分銷及銷售費用

本集團分銷及銷售費用由二零二二年度的人民幣92,103,000元下降至二零二三年度的人民幣86,334,000元,降幅約為6.26%。於本年度內,分銷及銷售費用主要是銷售人員工資、運輸成本及業務推廣等費用。分銷及銷售費用下降原因是由於本集團年內銷售大幅下降所致。

#### 行政開支

本集團行政開支由二零二二年度的人民幣131,637,000元 上升至二零二三年度的人民幣138,972,000元,升幅約為 5.57%,行政開支主要是管理人員工資、福利費用、租金 及折舊等費用。

#### 融資成本

本集團融資成本由二零二二年度的人民幣59,600,000元下降至二零二三年度的人民幣52,434,000元,降幅約12.02%,這主要是本集團年內銀行借貸金額及銀行貸款平均利率均有所下降。

### 研發支出

本集團的研發支出由二零二二年度的人民幣116,388,000元(佔銷售收入約3.86%)下降至二零二三年度的人民幣90,235,000元(佔銷售收入約3.77%)。

### 年內全面(開支)收益總額

於年內,本集團股本持有人應佔虧損總額為人民幣 16,842,000元。本公司擁有人應佔年度虧損為人民幣 17,553,000元,較二零二二年度本公司擁有人應佔溢利為 人民幣47,167,000元,下降137.21%。

### 股息政策

本公司必須根據相關法律、規則、法規及受限於本公司細則制定任何股息派付的宣派、形式、頻率及金額。根據適用法律、規則、法規及公司細則,於決定是否提議派付股息時,董事會將考慮(其中包括)本公司的財務業績、收益及可分配儲備、營運及流動資金需求,負債比率及信貸額度可能產生的影響和現時及未來發展計劃。



### **Dividends**

The Board has recommended, subject to the approval of the Shareholders at the Annual General Meeting (the "AGM"), the payment of a final dividend of RMB1.00 cent (equivalent to HKD1.10 cents) per Share for the year ended 31 December 2023 (2022: a final dividend of RMB1.42 cents per Share) to those Shareholders whose names appear on the register of members of the Company on Tuesday, 2 July 2024. The recommended final dividend, if approved at the AGM on Friday, 21 June 2024, will be paid in Hong Kong dollars. The RMB to Hong Kong dollar exchange rate for the final dividend calculated using the opening indicative counter buying telegraphic transfer rate for off-shore RMB of The Hong Kong Association of Banks announced on 27 March 2024. The final dividend is expected to be paid on or around Friday, 12 July 2024.

### Liquidity, Financial Resources and Capital Structure

In 2023, the Group's main sources of funding were cash generated from operating activities and bank loans.

#### **Inventories**

As at 31 December 2023, the inventories of the Group decreased by 10.09% to RMB205,308,000 as compared to the inventories balance of RMB228,353,000 as at 31 December 2022. During the Year, the inventory turnover day was approximately 37 days (2022: 30 days), remaining at a normal level.

### Trade receivables not backed by bills

As at 31 December 2023, the trade receivables not backed by bills amounted to RMB304,545,000 (as at 31 December 2022: RMB423,150,000). The trade receivables turnover days was approximately 55 days (2022: 61 days). It is in line with the credit period granted by the Group to its customers.

#### Trade receivables backed by bills

As at 31 December 2023, the trade receivables backed by bills amounted to RMB476,490,000 (31 December 2022: RMB324,100,000).

### Trade payables

As at 31 December 2023, the trade payables amounted to RMB234,277,000 (as at 31 December 2022: RMB173,872,000). The trade payables turnover days was approximately 35 days (2022: 19 days).

#### **Borrowings**

As at 31 December 2023, the Group's bank and other borrowings balance amounted to RMB1,022,062,000 (as at 31 December 2022: RMB1,054,185,000).

#### Gearing ratio

As at 31 December 2023, the gross gearing ratio was approximately 34.15% (as at 31 December 2022: 35.33%), which was calculated on the basis of the total amount of bank and other borrowings as a percentage of the total assets. The net gearing ratio was 61.96%, which was calculated on the basis of the amount of bank and other borrowings less pledged bank deposits and cash and bank balances as a percentage of the shareholders' equity (as at 31 December 2022: 63.78%).

### Pledge of assets

As at 31 December 2023, the Group pledged certain assets with carrying value of RMB895,429,000 as collateral for the Group's borrowings (as at 31 December 2022: RMB1,155,148,000).

### **Capital commitments**

As at 31 December 2023, the Group's capital commitments (including the engaged and authorized capital commitments) were RMB12,611,000 (as at 31 December 2022: RMB36,367,000). All the capital commitments were related to acquisition of property, plant and equipment.

### **Contingent liabilities**

As at 31 December 2023, the Group had no significant contingent liabilities or litigation or arbitration of material importance.

### Foreign currency exposure

The Group collects most of its revenue and incurs most of the expenditures in RMB. Although the Group undertakes certain transactions denominated in foreign currencies, mainly the currency of United States and the currency of Hong Kong, the exposures to exchange rate fluctuations is minimal. The Group currently does not have a foreign currency hedging policy. The Board, however, will monitor foreign exchange rate closely and consider entering into foreign currency hedging arrangement should the need arise.

### **Human Resource Management**

The Group had 2,615 employees as at 31 December 2023 (as at 31 December 2022: 2,484 employees), in which approximately 495 were engineers and technical staff or employees with higher education backgrounds. The staff costs amounted to RMB287,052,000 for the year ended 31 December 2023 (for the year ended 31 December 2022: RMB281,497,000). The table below shows the number of employees of the Group by function as at 31 December 2023:

The Group offers remuneration packages determined by reference to the employees' experience, qualification and overall market situation, while the bonus is related to the financial performance of the Group and the individual performance. The Group also undertakes to provide proper trainings and sustainable professional development opportunities for the employees if needed.

The Company has adopted a share award scheme (the "Share Award Scheme") with a primary purpose of motivating our employees and other eligible persons entitled under the Share Award Scheme to further contribute to the Group and to reward them for their contribution to the Group.

### **Major Risks and Uncertainties**

In order to achieve stable business operations, the management of the Company pays close attention to the risk factors that the Company may face. Based on the key risk indicators, after evaluation and analysis, the risks faced by the Company mainly include:

### 1. Operational risks from macroeconomic control

Due to macroeconomic policy adjustments, certain impacts on the upstream and downstream customers of the Group will indirectly affect the sales and profits of packaging and papermaking enterprises (including the Group). Due to the tightening of the China's environmental protection policy, the cost of the paper packaging industry will increase and there will be certain operational risks

### 2. Business risks arising from fluctuations in raw material prices

Since the costs of raw material account for a relatively high proportion of production costs, fluctuations in raw material prices have a certain impact on profits.

### 3. Risks from market competition

The Group's packaging business has a low concentration. The enterprises with certain scale and strength in the industry are mainly expanding their production capacity and increasing their market share. The market competition is fierce. The papermaking business of the Group faces leading enterprises in the industry to compete in the same region and the competition is fierce.

### 4. Quality risks

Due to the inability to meet the product quality standards in the industry, the mass quality problems caused by customers' demand cannot be met, which resulting in losses from batch waste or inventories.

### 1. 宏觀調控帶來的經營風險

由於宏觀政策調控,對集團上、下游客戶產生一定 影響,會間接影響包裝和造紙企業(包括本集團)的 銷售及利潤。由於國家環保政策趨嚴,會造成造紙 包裝行業成本增加,有一定經營風險。

### 2. 原材料價格波動帶來的經營風險

由於原料成本在生產成本中佔比較高,因此,原料 價格的波動對利潤產生一定的影響。

### 3. 市場競爭風險

本集團包裝業務集中度較低,行業內具有一定規模和實力的企業均以進一步擴大產能、增加市場佔有率為主要經營目標,市場競爭激烈。本集團造紙業務面臨行業內的龍頭企業在同區域內競爭,競爭激烈。

### 4. 質量風險



The directors of the Company (the "**Directors**") are pleased to present the corporate governance report in the annual report of the Company for the year ended 31 December 2023 (the "**Year**").

The Company has consistently adopted the Corporate Governance Code (the "Code") promulgated by The Stock Exchange of Hong Kong Limited (the "Stock Exchange") as guidelines to reinforce our corporate governance principles. This report describes how the Company has applied the principles during the year.

The Company has complied with the code provisions set out in the Code as stated in Appendix C1 of the Rules Governing the Listing of Securities on the Stock Exchange (the "**Listing Rules**") in force throughout the year ended 31 December 2023.

### **Board of Directors**

The board of directors (the "Board") of the Company has a balance of skill and experience and a balanced composition of Executive and Nonexecutive Directors, the overall management of the Company's business was vested in the Board. The Board has delegated the day-to-day management of the Company's business to the executive management team, and focuses its attention on matters affecting the Company's overall strategic policies, finances and shareholders. As at 31 December 2023, the Board comprised nine members, consisting of five Executive Directors namely, Mr. Hu Zheng (Chairman), Mr. Hu Hancheng (Co-Chairman), Mr. Hu Hanchao, Mr. Hu Jianpeng and Ms. Chen Wei, one Non-Executive Director namely, Ms. Hu Jianwen and three Independent Non-executive Directors namely, Mr. Chung Kwok Mo John, Mr. Liew Fui Kiang and Mr. Shin Yick Fabian. The Directors are well-versed in respective areas such as knowledge and technical know-how of paper-making and packaging industries, accounting and finance and business management. The Board as a whole has achieved an appropriate balance of skills and experience. The profiles of all directors and the relationship among members of the Board (including financial, business, family or other material or relevant relationships, if any) are set out on pages 43 to 46.

Each Independent Non-executive Director who is subject to retirement by rotation will be appointed by a separate resolution in the Company's annual general meeting. The Company has received from each Independent Non-executive Director an annual confirmation of independence pursuant to the independence guidelines set out in Rule 3.13 of the Listing Rules.

As Mr. Chung Kwok Mo John has served on the Board for more than nine years, the Board is of the view that a director's independence should not be defined by his/her tenure on the Board. The Board assesses a director's independence on a case-by-case basis with reference to the director's business acumen, experience in related industries, professional qualification, international business exposure and the nature of the businesses of the Company in addition to tenure. A director who has over time gained in-depth insight into the Company's operations and its markets are well-positioned to offer his/her perspective and advice for discussion at the Board and that he/she can bring valuable contribution to the Company with comprehensive understanding of the operations of the Company. The Board is satisfied that Mr. Chung is a person of integrity and stature, independent in character and judgment. He is independent of management and free from any business or other relationships or circumstances which could materially interfere with the exercise of his independent judgment.

Ms. Chen Wei, who has been appointed as the Executive Director during the financial year ended 31 December 2023, has obtained the legal advice referred to in Rule 3.09D of the Listing Rules on 25 August 2023, and she has confirmed she understood her obligations as a director of a listed issuer.

### 董事會

本公司董事會(「董事會」)成員擁有全面之專長及經驗,且執行董事及非執行董事之組合亦有均衡合理。本公司業務的整體管理由董事會負責。董事會已指派行政管理團隊負責管理本公司日常業務,從而集中處理本公司的整體戰略、財務及股東事宜。於二零二三年十二月三十一日,董事會由九名成員組成,包括五名執行董事即胡正先生(董事長)、胡漢程先生(聯席董事長)、胡漢朝先生、胡健襲女士及三名執行董事即鍾國武先生、劉懷鏡先生及冼易先生。董事在造紙及包裝工作的知識與技能、會計與財務及業務管理等各範疇擁有深入精闢之認識。董事會整體更具備各方面之適當技能與經驗。所有董事的履歷以及董事會成員的關係(包括財務、業務、親屬或其他重大或相關關係(如有))於第43至46頁作出披露。

於本公司之股東週年大會上,每位須輪流告退之獨立非執行董事均以獨立決議案委任。本公司已根上市規則第3.13 條所載的獨立指引接獲各獨立非執行董事的年度獨立確認 書。

本公司獨立非執行董事鍾國武先生已獲委任多於九年。董事會認為,董事獨立性不應受其任期所限制。董事會將按個別董事情況,除考慮任期外,亦參考其商業決策能力、於相關行業之經驗、專業資格及國際視野,以及本公司業務性質,以評估董事獨立性。董事長久以來累積對本公司營運及市場之深入見解,正好具備優越條件提出觀點及建議以供於董事會上討論,且有關董事對本公司營運瞭如指掌,能為本公司作出寶貴貢獻。董事會信賴鍾先生之正直品格,以及其獨立之性格及判斷。彼等獨立於管理層,亦無牽涉任何業務或擁有其他關係或處於可能會重大干預作出獨立判斷之任何情況。

於截至二零二三年十二月三十一日止財政年度獲委任為執行董事的陳威女士已於二零二三年八月二十五日取得上市規則第3.09D條所提述的法律意見,並確認其瞭解其作為上市發行人董事的責任。

The Board has expressed the view in its circular for 2024 annual general meeting that each Independent Non-executive Director who is eligible for re-election has met the independence guidelines set out in Rule 3.13 of the Listing Rules and is independent in accordance with the terms of the guidelines. In accordance with the CG Code, the Company has to include its own recommendation in the circular to explain why a particular candidate should be re-elected. As their relevant credentials have been included in the circular for the shareholders' information, the Company opines that it is more important for the shareholders themselves to make their own independent decision on whether to approve a particular re-election or not.

Four board meetings were held during the financial year. All the Directors actively participated in each meeting in person, via telephone or videoconferencing. They received reports on the activities of the operating divisions and which required the Board approval. Board approval also be obtained through voting at the Board meetings.

Regular Board meetings in a particular year are usually scheduled towards the end of the immediately preceding year to give all Directors adequate time to plan their schedules to attend the meetings. The dates of the 2023 regular Board meetings, of which 14 days notice was given, were determined according to the requirement of the Bye-laws and any amendments to this schedule were notified to all the Directors at least 14 days before the meeting. The Board papers including supporting analysis and related background information are normally sent to the Directors at least three days before Board meetings. Suitable arrangements were in place to allow the Directors to include items in the agenda for regular Board meetings.

The Board endeavours to ensure the appointment of at least three independent non-executive Directors and at least one-third of whose members are independent non-executive Directors (or the higher minimum number as may be prescribed by the Board of Directors of the Company from time to time under the Rules Governing the Listing of Securities of The Stock Exchange of Hong Kong Limited (the "Listing").

In addition to complying with the requirements of the Listing Rules on the composition of certain Board committees, the Company also appoints independent non-executive Directors to other Board committees to ensure independent views as far as possible.

The Nomination Committee is empowered to assess the independence of all Independent Non-executive Directors on an annual basis in accordance with the independence criteria set out in the Listing Rules to ensure that they continue to exercise independent judgement.

Independent non-executive Directors (like other Directors) have the right to seek further information and documents from management on matters to be discussed at Board meetings. They may also seek assistance from the Company's Company Secretary and, if necessary, independent professional advice at the Company's expense.

The Board reviews the implementation and effectiveness of the aforementioned mechanisms on an annual basis.

The Chairman promotes a culture of openness and actively encourages Directors with different views to voice their opinion and be fully engaged in the Board's affairs so as to contribute to the Board's functions. The chairman also debates facilitating the effective contribution of non-executive directors in particular and ensuring constructive relations between executive and non-executive directors.

#### **Cultures and values**

A healthy corporate culture across the Group is vital for the Group to achieve its vision and mission towards sustainable growth. It is the Board's role to foster a corporate culture with integrity to guide the behaviours of its employees, and ensure that the Company's vision, values and business strategies are aligned to it.

### 1. Integrity, simple

The Group strives to maintain high standards of business ethics and corporate governance across all our activities and operations. The Directors, management and staff are all required to act lawfully, ethically and responsibly.

#### 2. Treasure talents, invest talents

In order for the Board to be effective, the Company may set additional measurable targets/specific diversity targets and review them from time to time to ensure that such targets are appropriate and feasible.

In terms of gender diversity, the Board currently comprises 2 female Directors, representing 22.2% of the Board.

### Measurable goals

In hiring and selecting candidates for appointment to the Board, the appointment will be based on the Company's nomination policy and from a diverse perspective, including but not limited to consideration of gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service.

After considering the Company's corporate strategy and business operations, the final decision will be based on the merits and other objective criteria of the candidate, and the contribution he or she will bring to the Board.

The Board recognised the benefits of diversity in the Board in enhancing the Board effectiveness and corporate governance. The Nomination Committee will give consideration to a number of factors as set out in the Policy when identifying suitable qualified candidates to become members of the Board, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, industry experience, skills, knowledge and length of service. The Board will consider well balanced and of a diverse mix which is appropriate for the business operation and development of the Company. The Company will also take into account its own business model and specific needs from time to time to determine the optimal composition of the Board. The Company will review the Policy on a regular basis to ensure its continuous effectiveness. The Board and the Nomination Committee review from time to time the Board Diversity Policy, monitor its implementation to ensure its continued effectiveness including conducting a review of the composition of the Board at least once a year, taking into account the benefits of all relevant diversity dimensions, and compliance with regulatory requirements and good corporate governance practices and the Nomination Committee makes recommendation on any revision as may be required to the Board for approval.

We recruit talents regardless of race, colour, nationality, religion, gender, sexual orientation, age, marital status, pregnancy, disability, medical condition, political affiliation, family responsibilities or any other characteristics protected by law.

As at 31 December 2023, in terms of gender diversity, female represent 18.01% of the senior management. At workforce levels, female present 20.92%. For details of gender diversity at workforce levels, please refer to the 2023 Environmental, Social, and Governance (ESG) Report. The Board is satisfied that the Company has achieved gender diversity in its workforce and possessed skill and expertise and a diverse mix appropriate for the business of the Company and will review the composition and diversity of the employees on a regular basis to ensure its continued effectiveness.

### **Board Committees**

The Board has established five committees, namely the Audit Committee, the Remuneration Committee, the Nomination Committee, the Risk Management Committee and the Budget Management Committee, throughout the year ended 31 December 2023. During the year, these committees adhered to their principles, procedures and arrangements set out below. The respective committee secretary or designated person took full minutes of the meetings of these committees and the work of these committees was reported to the Board regularly.

### Chairman and Chief Executive Officer ("CEO")

Under the Code provision C.2.1 in force, the roles of chairman and CEO should be separate and should not be performed by the same individual. The division of responsibilities between the Chairman and CEO should be clearly established and set out in writing.

Upon the appointment of Mr. Hu Zheng as the CEO becoming effective on 23 August 2023, Mr. Hu will perform both of the roles as the Chairman and the CEO of the Company. This deviates from code provision C.2.1 of the Code on Corporate Governance Practices contained in Appendix 14 of the Listing Rules.

For the Company's development, the Board is of the opinion that it is appropriate and in the best interest of the Company at the present stage for vesting the roles of the Chairman and the CEO of the Company in the same person. It does not affect the balance of power and authority between the board of directors and the management. The Board will nevertheless review this structure from time to time and will consider the segregation of the two roles at the appropriate time.

### Responsibilities of and Delegation by the Board

The Board is responsible for the overall leadership of the Group, overseas the Group's strategic decisions and monitors business and performance.

The management, consisting of Executive Directors along with the senior executives, is delegated with responsibilities for implementing the strategy and direction as adopted by the Board from time to time, and conducting the day-to-day operations of the Group. Executive Directors and the senior executives meet regularly to review the performance of the businesses of the Group as a whole, co-ordinate overall resources and make financial and operational decisions. The Board also gives clear directions as to their powers of management including circumstances where management should report back, and will review the delegation arrangements on a periodic basis to ensure that they remain appropriate to the needs of the Group.

All Directors shall ensure that they carry out duties in good faith, in compliance with applicable laws and regulations, and in the interests of the Company and its Shareholders at all times.

### **Non-executive Directors**

Each of Independent Non-executive Directors and Non-executive Director was appointed with specific terms. Each of Independent Non-executive Directors had signed a letter of appointment with the Company for a term of 1 year commencing from 1 January 2024, and the Non-executive Director had signed a letter of appointment with the Company for a term of 3 years commencing from 22 July 2023. They are all subject to retirement by rotation and re-election at the annual general meetings of the Company in accordance with the bye-laws of the Company (the "Bye-laws").

### **Directors' Securities Transactions**

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") contained in Appendix 10 to the Listing Rules as its own code of conduct regarding directors' securities transactions. Having made specific enquiries of all Directors, the Company confirms that all Directors have complied with the required standards set out in the Model Code throughout the year ended 31 December 2023.

- (e) to review the Company's compliance with the code provisions set out in the Code and Corporate Governance Report contained in Appendix C1 of the Listing Rules and its disclosure requirements in the Corporate Governance Report.

The work performed by the Board on corporate governance functions during the year ended 31 December 2023 included developing and reviewing the Company's policies on corporate governance and making relevant recommendations.

#### **Continuous Professional Development**

The Company has also adopted a share award scheme (the "Award Scheme") whereby the Board may at its discretion grant shares to such eligible participants to award the shares of the Company. The principal terms of the Award Scheme are set out in the announcement of the Company dated 23 April 2019. The purposes of the Option Scheme and Award Scheme are to enable the Company to grant options or award shares to selected eligible participants as incentives or rewards for their contribution to the Group.

#### **Nomination Committee**

According to the Bye-laws, the Directors shall have power from time to time and at any time to appoint any person as a director either to fill a casual vacancy or as an addition to the Board. A director appointed by the Board is subject to re-election by shareholders at the next following general meeting of the Company. The nomination of a director should be taken into consideration of the candidate's skills and experience which are appropriate for the needs of the Company's business.

The Company has established a Nomination Committee for the purpose of making recommendations to the Board on the appointment of Directors.

The Nomination Committee presently comprises four Directors, including Mr. Hu Zheng, an Executive Director, and three Independent Non-executive Directors, namely Mr. Chung Kwok Mo John, Mr. Liew Fui Kiang and Mr. Shin Yick Fabian. The Committee is chaired by Mr. Hu Zheng.

The Board delegates the responsibility of appointing and re-electing Directors to the Nomination Committee and they are responsible for considering the suitability of a candidate, and approving and terminating the appointment of a Director. Reviews of the plans for orderly succession for appointment to the Board and its structure, size and composition are done on a regular basis by the Nomination Committee. They are provided with sufficient resources to discharge its duties and external consultants may be engaged, if necessary, to access a wider range of potential candidate(s). The Nomination Committee reviews the Director Nomination Policy and the Board Diversity Policy of the Company periodically and make recommendation on any proposed revisions to the Board.

In evaluating whether an appointee is suitable to act as a director of the Company, the committee will review the professional knowledge, industrial experience and personal skills of the appointee, personal ethics and integrity of the appointee as well as how the individual contributes to diversity of the Board.

The terms of reference of the Nomination Committee (both English and Chinese versions) are posted on the websites of the Company and HKEx.

According the Bye-laws, at each AGM of the Company, one-third of the Directors shall retire from office by rotation and every Director shall be subject to retirement at least once every three years. Director(s) newly appointed by the Board shall hold office until the next following general meeting of the Company and shall then be eligible for re-election at the meeting.

The Board considers that it is the responsibility of the existing Directors to give an induction on the information of the Group to the newly appointed Director and present a manual on the duties and responsibilities as a director of a listed company to enable the newly appointed Director to have a proper understanding of the business.

根據本公司的細則,在本公司每屆股東週年大會上,三分之一的董事須輪席告退,且每名董事須至少每三年告退一次。董事會新委任的董事須任職至本公司下一屆股東大會,屆時將有資格於會上膺選連任。

董事會認為,現任董事有責任為新委任董事介紹本集團情況,並提供一份載有上市公司董事職責與責任的手冊,令 新委任董事能夠充分了解相關業務。

Each of the Independent Non-executive Directors had signed a letter of appointment with the Company for a term of one year commencing from 1 January 2024 and is renewable upon its expiration and may be terminated in accordance with the terms of the letter of appointment. The non-executive Director, Ms. Hu Jianwen had signed a letter of appointment with the Company for a term of three years commencing 22 July 2023 and is renewable upon its expiration and may be terminated in accordance with the terms of the letter of appointment. #### **Internal Controls**

The Board has kept the Company's system of internal controls under review to ensure its effectiveness and convened meetings regularly to discuss financial, operational and risk management control.

#### **Risk Management Committee**

The Risk Management Committee was set up on 18 December 2015 and currently comprises five members, including two executive Directors, namely Mr. Hu Zheng and Ms. Chen Wei, three Independent Non-executive Directors, namely Mr. Chung Kwok Mo John, Mr. Liew Fui Kiang and Mr. Shin Yick Fabian. The chairman of the Committee is Mr. Hu Zheng.

The Risk Management Committee is established to, without limitation, assist the Board to evaluate and determine the nature and extent of the risks the Board is willing to take in achieving the Group's strategic objectives, ensure that the Group establishes and maintains appropriate and effective risk management and internal control systems, and assist the Board to oversee the design, implementation and monitoring of the risk management system carried out by the management on an ongoing basis.

For the year ended 31 December 2023, the Risk Management Committee held two meeting and discussed and reviewed areas including but not limited to the key risks faced by the Group, risk management policy and practice annually.

#### **Risk Management and Internal Control Systems**

The Board is responsible for evaluating and determining the nature and extent of the risks it is willing to take in achieving the strategic objectives of the Group and ensuring that the Group establishes and maintains appropriate and effective risk management and internal control systems.

The Board is ultimately responsible for the Group's risk management and internal controls system and for reviewing its effectiveness.

The Group has adopted a set of internal control measures to address various potential operational, financial and legal risk identified in relation to the operation, including but not limited to procurement management, inventory management, information disclosure control, IT management and other various financial control and monitor procedures. All the identified risks are consolidated into a risk inventory.

The Group's risk management and internal control systems will be reviewed annually for the past financial year.

The Group has in place an anti-bribery and anti-corruption policy to safeguard against any corruption within the Group. The policy explains potential bribery and corruption conduct and the Group's anti-bribery and anti-corruption measures. The Group makes its internal reporting channel open and available for its employees to report any bribery and corruption acts, and its employees can also make anonymous reports to the compliance officer. The Group's compliance officer is reporting for investigating the reported incidents and taking appropriate measures in response to the relevant incidents, if any. To strengthen internal control of the Group in relation to anti-bribery and anti-corruption, the Group has also started to provide trainings of anti-bribery and anti-corruption to all its employees every year.

However, the Group's risk management and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objective, and can only provide reasonable and not absolute assurance against material misstatement or loss.

#### **Whistleblowing Policy**

The Board adopted a whistleblowing policy (the "Whistleblowing Policy") in March 2022.

The purpose of the Whistleblowing Policy is to (i) foster a culture of compliance, ethical behaviour and good corporate governance across the Group; and (ii) promote the importance of ethical behaviour and encourages the reporting of misconduct, unlawful and unethical behavior.

The nature, status and the results of the complaints received under the Whistleblowing Policy are reported to the chairman of the Audit Committee or the human resource director of the Group. No incident of fraud or misconduct that have material effect on the Group's financial statements or overall operations for the year ended 31 December 2023 has been discovered.

The Whistleblowing Policy is reviewed annually by the Audit Committee to ensure its effectiveness.

#### **Anti-corruption Policy**

The Board adopted an anti-corruption policy (the "Anti-corruption Policy") in March 2022. The Group is committed to achieving the highest standards of integrity and ethical behaviour in conducting business. The Anti-corruption Policy forms an integral part of the Group's corporate governance framework.

The Anti-corruption Policy sets out the specific behavioural guidelines that the Group's personnel and business partners must follow to combat corruption. It demonstrates the Group's commitment to the practice of ethical business conduct and the compliance of the anti-corruption laws and regulations that apply to its local and foreign operations. In line with this commitment and to ensure transparency in the Group's practices, the Anti-corruption Policy has been prepared as a guide to all Group employees and third parties dealing with the Group.

The Anti-corruption Policy is reviewed and updated periodically to align with the applicable laws and regulations as well as the industry best practice.

#### **Company Secretary**

Ms. Jiang Ying has been appointed by the Company as the company secretary since 31 March 2023, her biographical details are set out in the section headed "Profiles of Directors and Senior Management" in this annual report. Ms. Jiang has complied with the relevant professional training requirement under Rule 3.29 of the Listing Rules during the year.

Pursuant to the Bye-laws of the Company and Bermuda Companies Act, in addition to regular Board meetings, the Directors of the Company, on the requisition of shareholders of the Company holding not less than one-tenth of the paid-up capital of the Company, can convene a special general meeting to address specific issues of the Company within 21 days from the date of deposit of written notice to the principal place of business of the Company in Hong Kong. The same requirement and procedure also applies to any proposal to be tabled at shareholders' meetings for adoption.

#### Right to Put Forward Enquiries to the Board

Mr. Hu Zheng is responsible for overseeing the overall corporate management, operation and development planning and had over 30 years of experience in the paper-making and packaging industries. Prior to founding our Group, Mr. Hu Zheng worked as a technician and as an assistant engineer at a then state-owned paper factory since 1983 then he was a director of a PRC paper and packaging products manufacturing factory, responsible for the management of daily operation and strategic planning from 1990 to 2003. The provision rates applied in the provision matrix are estimated using the historical observed default rates of the debtors and contract assets taking into consideration forward-looking information that is reasonable, supportable and available to the directors of the Company without undue costs or effort, and are updated if considered to be required. 誠如綜合財務報表附註4及39所披露,就無銀行票據為後盾的貿易應 收款項及合約資產而言,對於具有大額結餘或出現信貸減值的賬款及 合約資產,預期信貸虧損會以單獨形式及/或使用主要基於債務人賬 齡資料的適當分組的撥備矩陣的集體形式進行評估。撥備矩陣所使用 撥備率,乃利用過往觀察的賬款及合約資產違約率,計及本公司董事 毋須花費不必要的成本或費力即可獲取的合理有根據(且在必要情況 下更新)的前瞻性資料後進行估計。

### 1. General Information

The Company is incorporated in Bermuda as an exempted company with limited liability and its shares are listed on the Stock Exchange. The addresses of the registered office and principal place of business of the Company are disclosed in the corporate information section to the annual report.

The Company acts as an investment holding company. Mr. Hu Zheng, Mr. Hu Hancheng, Mr. Hu Hanchao and Ms. Hu Jianwen, who collectively own 75% of the Company's shares in aggregate and act in concert, are regarded as the controlling shareholders of the Company.

The principal activities of its subsidiaries are mainly engaged in manufacture and sale of paper, paperboard and paper-based packaging products. The Company and its subsidiaries are hereinafter collectively referred to as the "Group".

The consolidated financial statements are presented in Renminbi ("RMB"), the currency of the primary economic environment in which the Company and its principal subsidiaries operate.

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange and by the Hong Kong Companies Ordinance.

The directors of the Company have, at the time of approving the consolidated financial statements, a reasonable expectation that the Group has adequate resources to continue in operational existence for the foreseeable future. Thus they continue to adopt the going concern basis of accounting in preparing the consolidated financial statements.

### Material accounting policy information

#### Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

### **Government grants**

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Specifically, government grants whose primary condition is that the Group should purchase, construct or otherwise acquire non-current assets are recognised as deferred income in the consolidated statement of financial position and transferred to profit or loss on a systematic and rational basis over the useful lives of the related assets.

Government grants related to income that are receivables as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable. Such grants are presented under "other income".

### **Taxation**

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before tax as reported in the consolidated statement of profit or loss and other comprehensive income because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

#### 政府補則

當可合理保證本集團符合附帶條件且會收到補貼時,方確認政府補貼。

政府補貼乃於有關補貼擬補償的相關成本獲本集團確認為開支的期間有系統地確認於損益。具體而言,以本集團購買、建造或以其他方式獲得非流動資產為主要條件的政府補貼,於綜合財務狀況表確認為遞延收入,並按相關資產的可使用年期有系統及合理地轉撥至損益。

與應收收入相關的政府補助是作為已產生的開支或 虧損補償,或旨在給予本集團即時的財務支援而發 放,並無未來相關成本,且在應收期間於損益中確 認。該等補貼呈列為「其他收入」。

### 税項

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax basis used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of the transaction does not give rise to equal taxable and deductible temporary differences. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for leasing transactions in which the Group recognises the right-of-use assets and the related lease liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 requirements to the lease liabilities and the related assets separately. The Group recognises a deferred tax asset related to lease liabilities to the extent that it is probable that taxable profit will be available against which the deductible temporary difference can be utilised and a deferred tax liability for all taxable temporary differences.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied the same taxable entity by the same taxation authority.

Current and deferred tax are recognised in profit or loss. Where current tax or deferred tax arises from the initial accounting for a business combination, the tax effect is included in the accounting for the business combination.

## Property, plant and equipment

Property, plant and equipment including buildings held for use in the production or supply of goods or services, or for administrative purposes (other than construction in progress as described below) are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Buildings and machinery in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Costs include any costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by the management, including costs of testing whether the related assets is functioning properly and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy. Sale proceeds of items that are produced while bringing an item of property, plant and equipment to the location and condition necessary for it to be capable of operating in the manner intended by management (such as samples produced when testing whether the asset is functioning properly), and the related costs of producing those items are recognised in the profit or loss. The cost of those items are measured in accordance with the measurement requirements of HKAS 2. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition. To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land is presented as "right-of-use assets" in the consolidated statement of financial position. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

# Internally-generated intangible assets – research and development expenditure

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

An internally-generated intangible asset arising from development activities (or from the development phase of an internal project) is recognised if, and only if, all of the following have been demonstrated:

- the technical feasibility of completing the intangible asset so that it will be available for use or sale;
- the intention to complete the intangible asset and use or sell it;
- the ability to use or sell the intangible asset;
- how the intangible asset will generate probable future economic benefits;
- the availability of adequate technical, financial and other resources to complete the development and to use or sell the intangible asset; and
- the ability to measure reliably the expenditure attributable to the intangible asset during its development.

The amount initially recognised for internally-generated intangible asset is the sum of the expenditure incurred from the date when the intangible asset first meets the recognition criteria listed above. Where no internally-generated intangible asset can be recognised, development expenditure is recognised in profit or loss in the period in which it is incurred. Subsequent to initial recognition, internally-generated intangible assets are reported at cost less accumulated amortisation and accumulated impairment losses (if any).

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains and losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the assets, are recognised in profit or loss when the asset is derecognised.

## Impairment on property, plant and equipment, right-ofuse assets and intangible assets

At the end of the reporting period, the Group reviews the carrying amounts of its property, plant and equipment, right-of-use assets and intangible assets with finite useful lives to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss, (if any).

The recoverable amount of property, plant and equipment, right-of-use assets, and intangible assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs.

In testing a cash-generating unit for impairment, corporate assets are allocated to the relevant cash-generating unit when a reasonable and consistent basis of allocation can be established, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be established. The recoverable amount is determined for the cash-generating unit or group of cash-generating units to which the corporate asset belongs, and is compared with the carrying amount of the relevant cash-generating unit or group of cash-generating units.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset or a cash-generating unit for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. For corporate assets or portion of corporate assets which cannot be allocated on a reasonable and consistent basis to a cashgenerating unit, the Group compares the carrying amount of a group of cash-generating units, including the carrying amounts of the corporate assets or portion of corporate assets allocated to that group of cash-generating units, with the recoverable amount of the group of cash-generating units. In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of any goodwill (if applicable) and then to the other assets on a prorata basis based on the carrying amount of each asset in the unit or the group of cash-generating units. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro rata to the other assets of the unit or the group of cash-generating units. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or a cash-generating unit or a group of cash-generating units) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a cash-generating unit or a group of cash-generating units) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss.

Bank balances and cash

Bank balances and cash presented on the consolidated statement of financial position include:

- (a) cash, which comprises of cash on hand and demand deposits;and
- (b) cash equivalents, which comprises of short-term (generally with original maturity of three months or less), highly liquid investments that are readily convertible to a known amount of cash and which are subject to an insignificant risk of changes in value. Cash equivalents are held for the purpose of meeting short-term cash commitments rather than for investment or other purposes.

Bank balances for which use by the Group is subject to third party contractual restrictions are included as part of cash unless the restrictions result in a bank balance no longer meeting the definition of cash. Contractual restrictions affecting use of bank balances are disclosed in note 24.

### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost of inventories are determined on a weighted average method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale. Costs necessary to make the sale include incremental costs directly attributable to the sale and non-incremental costs which the Group must incur to make the sale.

於綜合財務狀況表呈列的銀行結餘及現金包括:

- (a) 現金,包括手頭現金及活期存款;及

### 存貨

存貨乃按成本與可變現淨值之間較低者列賬。存貨 成本以加權平均法釐定。可變現淨值則指存貨的估 計售價減去所有估計完工成本及成功出售所需的成 本。成功出售所需的成本包括直接歸屬出售之增量 成本以及本集團成功出售必須承擔之非增量成本。

### **Financial instruments**

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instrument. All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the market place.

Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities other than financial liabilities at fair value through profit or loss ("FVTPL") are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset or financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

### Financial assets

Classification and subsequent measurement of financial assets
Financial assets that meet the following conditions are subsequently
measured at amortised cost:

- the financial asset is held within a business model whose objective is to collect contractual cash flows; and
- the contractual terms give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

In addition, the Group may irrevocably designate a financial asset that are required to be measured at the amortised cost as measured at fair value through profit or loss if doing so eliminates or significantly reduces an accounting mismatch.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL ("12m ECL") represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessment are done based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights. The Group uses a practical expedient in estimating ECL on trade receivables using a provision matrix taking into consideration historical credit loss experience, adjusted for forward-looking information that is available without undue cost or effort.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Property, plant and equipment, right-of-use assets, intangible assets and deposits for acquisition of property, plant and equipment are stated at costs less accumulated depreciation (excluding deposits for acquisitions of PPE) and impairment, if any. In determining whether an asset is impaired, the Group has to exercise judgement and make estimation, particularly in assessing: (1) whether an event has occurred or any indicators that may affect the asset value; (2) whether the carrying value of an asset can be supported by the recoverable amount, in the case of value in use, the net present value of future cash flows which are estimated based upon the continued use of the asset; and (3) the appropriate key assumptions to be applied in estimating the recoverable amounts including cash flow projections and an appropriate discount rate. When it is not possible to estimate the recoverable amount of an individual asset (including right-ofuse assets), the Group estimates the recoverable amount of the cash generating unit to which the assets belongs, including allocation of corporate assets when a reasonable and consistent basis of allocation can be established, otherwise recoverable amount is determined at the smallest group of cash generating units, for which the relevant corporate assets have been allocated. Changing the assumptions and estimates, including the discount rates or the growth rate in the cash flow projections, could materially affect the recoverable amounts.

As at 31 December 2023, the carrying amounts of property, plant and equipment, right-of-use assets, intangible assets and deposits for acquisition of property, plant and equipment subject to impairment assessment were RMB906,789,000, RMB149,246,000, RMB13,772,000 and RMB23,983,000 respectively. Based on the result of the assessment, the Group determined that the carrying amount of the respective cash generating unit does not exceed the recoverable amount and no impairment has been recognised.

As at 31 December 2023, a deferred tax asset of RMB1,046,000 (2022: RMB335,000) in relation to deductible temporary difference for certain operating subsidiaries has been recognised in the consolidated statement of financial position. No deferred tax asset has been recognised on the tax losses of RMB624,188,000 (2022: RMB345,715,000) and deductible temporary difference of RMB64,171,000 (2022: RMB68,522,000) due to the unpredictability of future profit streams. The realisability of the deferred tax asset mainly depends on whether sufficient future profits or taxable temporary differences will be available in the future, which is a key source of estimation uncertainty especially the uncertainty on how the volatility or disruptions in energy, financial, foreign currency or commodity markets may progress and evolve. In cases where the actual future taxable profits generated are less or more than expected, or change in facts and circumstances which result in revision of future taxable profits estimation, a material reversal or further recognition of deferred tax assets may arise, which would be recognised in profit or loss for the period in which such a reversal or further recognition takes place.

# (b) Performance obligations for contracts with customers and revenue recognition policies

# (1) Sales of packaging paper products (revenue recognised at a point in time)

For sales of packaging paper products, revenue is recognised when control of goods has transferred, being when the goods have been shipped to the customer's specific location. The normal credit term is 30–120 days.

The Group requires certain customers to provide deposits. When the Group receives a deposit before delivery of goods, this will give rise to contract liabilities at the start of a contract, until the revenue recognised on the specific contract exceeds the amount of the deposit.

# (2) Sales of paper-based packaging products (revenue recognised over time)

The Group's contracts with customers for the manufacture and sales of paper-based packaging products are tailor-made based on customers' specification with no alternative use to the Group. Taking into account the contract terms, the legal and regulatory environment in the PRC, the contracts provide the Group an enforceable right to payment for performance completed to date and revenue is recognised over time based on the stage of completion of the contract using input method. The normal credit term is 30–120 days.

Please refer to note 23 for details on recognition of contract assets.

# (c) Transaction price allocated to the remaining performance obligation for contracts with customers

The performance obligation under the contracts for the sales of packaging paper and paper-based packaging products has original expected duration of less than one year and as permitted under HKFRS 15, the transaction price allocated to these unsatisfied contracts is not disclosed.

Under the Law of the PRC on Enterprise Income Tax (the "EIT Law") and Implementation Regulation of the EIT Law, the tax rate of the PRC subsidiaries is 25% for both years. Certain PRC subsidiaries approved as advanced-technology enterprises or enterprises applicable to EIT policies for large-scale development in the Western Region by the relevant government authorities are subject to a preferential tax rate of 15%. During the year, certain PRC subsidiaries approved as "small and low-profit enterprises" by the relevant government authorities are subject to two-tiered preferential tax rates. The first RMB3 million of taxable profit of the qualifying group entities will be taxed at 5% (2022:The first RMB 1 million of taxable profit of the qualifying group entities will be taxed at 2.5% and taxable profit above RMB 1 million but less than RMB3 million will be taxed at 5%).

For both years, the Group leases various offices, warehouses, machinery and vehicles for its operations. Lease contracts are entered into for fixed term of 12 months to 50 years. Lease terms are negotiated on an individual basis and contain a wide range of different terms and conditions. In determining the lease term and assessing the length of the non-cancellable period, the Group applies the definition of a contract and determines the period for which the contract is enforceable.

In addition, the Group owns several industrial buildings where its manufacturing facilities are primarily located and office buildings. The Group is the registered owner of these property interests, including the underlying leasehold lands. Lump sum payments were made upfront to acquire these property interests. The leasehold land components of these owned properties are presented separately only if the payments made can be allocated reliably.

The Group regularly entered into short-term leases for motor vehicles and properties. As at 31 December 2023 and 2022, the portfolio of short-term leases is similar to the portfolio of short-term leases to which the short-term lease expense disclosed above.

#### Restrictions or covenants on leases

Lease liabilities of RMB27,540,000 (2022: RMB31,034,000) are recognised with related right-of-use assets of RMB23,616,000 as at 31 December 2023 (2022: RMB27,082,000). The lease agreements do not impose any covenants other than the security interests in the leased assets that are held by the lessor. Leased assets may not be used as security for borrowing purposes.

#### **Rent concessions**

During the year ended 31 December 2023 and 2022, there was no rent concession provided by the lessors.

### Sale and leaseback transactions - seller-lessee

To better manage the Group's capital structure and financing needs, the Group sometimes enters into sale and leaseback arrangements in relation to machinery leases. These legal transfers do not satisfy the requirements of HKFRS 15 to be accounted for as a sale of the machinery. During the year ended 31 December 2023, the Group has not raised new borrowings in respect of such sale and leaseback arrangements (2022: RMB67,600,000).





#### 33. Retirement Benefits Schemes

The Group operates a Mandatory Provident Fund Scheme for all qualifying employees in Hong Kong. The assets of the scheme are held separately from those of the Group, in funds under the control of a trustee. The Group contributes 5% of relevant payroll costs to the scheme, which contribution is matched by employees but subject to a maximum amount of HKD1,500 per month (2022: HKD1,500 per month) for each employee.

The employees of the Company's subsidiaries established in the PRC are members of state-managed retirement benefit schemes operated by the PRC government. The subsidiaries are required to contribute certain percentage of payroll costs to the retirement benefits schemes to fund the benefits. The only obligation of the Group with respect to the retirement benefit schemes is to make the specific contributions.

The total expense recognised in profit or loss of RMB24,609,000 (2022: RMB22,287,000) represents contributions payable to these schemes by the Group in respect of the current accounting period.

During the year ended 31 December 2023 and 2022, the Group had no forfeited contributions under the retirement benefits schemes utilised to reduce future contributions.

The amount was treated as deferred income at 31 December 2023 and 2022. The amount is transferred to income over the useful lives of the relevant assets and the amount transferred to income during the current year is RMB3,400,000 (2022: RMB12,110,000). As at 31 December 2023, an amount of RMB33,381,000 (2022: RMB26,319,000) remains to be amortised.

#### 35. Acquisition of a Subsidiary

On 22 October 2021, the Group entered into a sale and purchase agreement (as supplemented by a supplemental agreement dated 13 December 2021) (the "Sale and Purchase Agreement") with the equity owners of Zheng Ye Leasing, who are also then four directors of the Company, pursuant to which the Group has conditionally agreed them to acquire the entire equity interest in Zheng Ye Leasing at an aggregate cash consideration of RMB186,000,000, payable by four instalments from 2022 to 2024. The unpaid amount of the consideration will bear interest at the medium and long-term loan prime rate of the PRC.

On 10 February 2022, all conditions precedent to the Sale and Purchase Agreement were fulfilled and the Group had completed the acquisition of Zheng Ye Leasing. The Group determined that substantially all of the fair value of the gross assets (excluding cash and cash equivalents) acquired is concentrated in a single identifiable asset and concluded that the acquired set of assets and liabilities do not constitute a business and the transaction is accounted for as an asset acquisition.

Zheng Ye Leasing is engaged in real estate leasing and property management in the PRC. The acquisition can enhance the Group's asset base, help improve business financing and reduce the Group's reliance on the assets of the controlling shareholders.

The Group manages its capital to ensure the entities in the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior year.

The capital structure of the Group consists of net debts, which includes bank borrowings and other borrowings as disclosed in note 27, net of cash and cash equivalents and equity attributable to owners of the Company, comprising share capital and reserves.

The directors of the Company review the capital structure periodically. As part of the review, the directors consider the cost of capital and the risks associated with the capital. Based on recommendations of the directors, the Group will balance its overall capital structure through payment of dividends, new share issues as well as the issue of the new debt or the redemption of existing debt.

The Group undertakes certain transactions denominated in foreign currencies, hence exposure to exchange rate fluctuations arises. The Group currently does not have a foreign currency hedging policy. (ii) Interest rate risk

The Group is exposed to cash flow interest rate risk in relation to variable-rate bank balances, variable-rate bank and other borrowings and amounts due to directors.

The Group's fair value interest rate risk relates primarily to its fixed rate pledged bank deposits, bank and other borrowings and lease liabilities. The Group currently does not have any interest rate hedging policy to hedge its exposure to interest rate risk. However, the management will consider hedging significant interest rate exposure should the need arise.

The Group's exposures to interest rates on financial liabilities are detailed in the liquidity risk management section of this note.

As listed in note 27, several of the Group's HIBOR bank borrowings have been subject to the interest rate benchmark reform. The Group is closely monitoring the market and managing the transition to new benchmark interest rates, including announcements made by the relevant IBOR regulators.

While the Hong Kong Dollar Overnight Index Average ("HONIA") has been identified as an alternative to HIBOR, there is no plan to discontinue HIBOR. The multirate approach has been adopted in Hong Kong, whereby HIBOR and HONIA will co-exist. The Group's bank borrowings linked to HIBOR will continue till maturity and hence, not subject to transition.

Sensitivity analysis on bank balances is not presented as the management considers that the Group's exposure to interest rate fluctuation is insignificant.

The sensitivity analyses below have been determined based on the exposure to interest rates for the variable-rate bank and other borrowings at the end of the reporting period and the stipulated change taking place at the beginning of the financial year and held constant throughout the year. A 100 basis points (2022: 100 basis points) increase or decrease for variable-rate bank and other borrowings are used when reporting interest rate risk internally to key management personnel and represent management's assessment of the reasonably possible change in interest rates in respect of bank and other borrowings.

If interest rates had been 100 basis points (2022: 100 basis points) higher/lower and all other variables were held constant, the Group's post-tax loss (2022: profit) for the year ended 31 December 2023 would have increased/decreased (2022: decreased/increased) by RMB2,259,000 (2022: RMB1,620,000).

Trade receivables and contract assets arising from contracts with customers

In order to minimise the credit risk, the management has delegated a team responsible for determination of credit limits and credit approvals. Before accepting any new customer, the Group uses an internal credit assessment system to assess the potential customer's credit quality and defines credit limits by customer. Limits attributed to customers are reviewed regularly. The Group may require a deposit to be received from certain customers of packaging paper products before acceptance of orders. Other monitoring procedures are in place to ensure that follow-up action is taken to recover overdue debts. In addition, the Group performs impairment assessment under ECL model on trade balances individually or based on provision matrix. Trade receivables are assessed for ECL by categorising into receivables fully backed by bank bills and not backed by bank bills. Debtors with trade receivables backed by bank bills are assessed individually taking into consideration of the credit rating and reputation of the banks issuing the bills. The Group assessed the ECL on trade receivables not backed by bank bills and contract assets individually for debtors and contract assets with significant balance or credit-impaired and/or collectively based on provision matrix with appropriate groupings based primarily on the debtors' ageing profiles.

#### Pledged bank deposits/bank balances

The credit risks on bank balances are limited because the counterparties are banks with high credit ratings assigned by international credit-rating agencies.

#### Other receivables

Other receivables are assessed individually and not included in provision matrix. The credit quality of other receivables have been assessed with reference to the historical information about the past due information, default rate, the financial position of counterparties and also supportive forward-looking information. The directors of the Company consider that the credit risk of other receivables is low in view of the good collection history.
