Ordinary resolutions

- 1. To receive and adopt the audited consolidated financial statements of the Company and its subsidiaries and the reports of the directors and auditor for the year ended 31 December 2023.
- (a) To re-elect, each as a separate resolution, the following retiring directors of the Company:
 - (i) Ms. Li Yan as executive director;
 - (ii) Ms. Zhu Jiali as executive director; and
 - (iii) Mr. Yu Zhenrong as executive director.
