CHAIRMAN'S STATEMENT

The year 2023 is the first year for comprehensively implementing the spirit of the 20th National Congress of the Communist Party of China (the "CPC") by QHD Port as well as a year for starting a new undertaking and building a first-class enterprise by the Company after the reorganization and establishment of Hebei Port Group. In the face of the severe and complicated international and domestic situation and with the focus on the corporate target of building a world-class port enterprise for dry and bulk cargoes, QHD Port adhered to the principle of green transformation and effectively responded to various risks and challenges under the guidance of green transformation with system construction as support, achieving steady growth in operating results and the preservation and appreciation of corporate assets. In 2023, QHD Port was awarded the National Port Enterprise with "AAAAA Level Standardized Good Behavior", Top 20 at the First CRHC Cup • Golden Ox Award for ESG Governance, the May 1st Labor Award in Hebei Province, an Outstanding Organization on Voluntary Services in Hebei Province, an Outstanding Grass-roots Party Organization among state-owned enterprises under the systems of the Hebei SASAC as well as other honorary titles.

Improving management efficiency and effects and building first-class ports.

During the year, QHD Port followed the guidance of the spirit of the important instructions made by Secretary General Xi Jinping during his inspections on the ports in Hebei Province and resolutely fulfilled responsibilities in ensuring the sound supply and stable price of coals. It achieved total a coal throughput of 217 million tonnes, accounting for 30% of coals shipped from the Bohai Rim region, consolidating its core position as a pivot port for the "North-South coal transportation" and guaranteeing smooth energy transportation channels. It sped up in the construction of world-class ports and developed the "one center with three platforms" with the production scheduling and command center as the pivot with the integration of the intelligent environmental monitoring platform, the intelligent safety regulatory platform and the intelligent port management and control platform, resulting in more efficient production, more systematic management and more scientific decision-making. It solidly carried out the establishment of "six systems" on safety, risks, quality, budget, appraisal and remuneration and steadily improved the governance effectiveness. It comprehensively deepened the "double-hundred action" on the reform of state-owned enterprises and continuously boosted the vitality of the enterprise. It continuously advanced the special action on "stepping up to a new high in three years and enhancing the strength in five years", stepped up R&D efforts in scientific and technological programs and empowered the construction of "integrity, intelligent, efficient and green" ports with technological innovation. It practically focused on safety of production, implemented the new safety management model with "four colors and four regular actions" and successfully developed a Level-1 safety standardization enterprise under the Ministry of Transport. A new path promoting the transformation, upgrading and high-quality development of ports is speeding up in shaping.

Building a green hub and sharing the blue sea and sky.

During the year, QHD Port deeply practiced the concept of green development, implemented "carbon peaking and carbon neutrality" targets, improved the capabilities on identifying and responding to climate change risks and continuously upgraded the level of the intelligent environmental management and control. It comprehensively initiated the campaign on "mass entrepreneurship and innovation" and Phase 3, 4 and 5 of the coal terminals were successfully listed as the first "five-star" green port zone in the country. The industrial tourism area at Qinhuangdao Port successfully passed the review on the landscape quality by the Department of Culture and Tourism of Hebei Province and was included in the construction of AAAA scenic areas in the province. It innovatively carried out the activity on opening to citizens with the theme of "intelligent" port in the "green" future, demonstrating the new changes of the port and vividly displaying new achievements in the integration of ports with cities. The new quality productive forces on the transformation, upgrading and high-quality development of the port are gradually developing and expanding.

Fulfilling social responsibilities and creating a beautiful society together.

During the year, QHD Port steadily boosted efforts in performing social responsibilities and solidly advanced rural revitalization. With assistance through industry, consumption and health and in-village assistances, it consolidated and expanded results in poverty alleviation. It continued to carry out work such as offering coolness in summer and warmth in winter, education assistance in autumn and assistance to people with difficulties, developed platforms on the cultivation, practice and communications for young carders and continuously expanded channels for the comprehensive development of employees to enhance the sense of accomplishment, happiness and safety of employees. It actively displayed the role of public welfare activities and developed the brand of voluntary services with the characteristics of ports to bring warmth to and return the society with "blue ports" and "red voluntary services". The brand influence of QHD Port in fulfilling undertakings offers endless impetus to promote regional economic and social development.

In 2024, QHD Port will deeply implement the spirit of the important instructions made by Secretary General Xi Jinping during his inspections on the ports in Hebei Province, adhere to the general keynote of "seeking progress while maintaining stability, promoting stability with progress and building the new before discarding the old", focus on the overall requirements on the construction of an "integrity, intelligent, efficient and green" port, stay true to its original aspirations, firmly bear in mind its missions and speed up in facilitating the transformation, upgrading and high-quality development of the ports. STATEMENT OF THE BOARD

QHD Port has established an effective ESG management mechanism and governance mechanism, and the board (the "Board") of the Company as the highest decision-making body on the Company's ESG issues, assumes full responsibilities for the Company's ESG strategy and reporting, and is responsible for considering and approving the Company's sustainable development strategy, policies, objectives and risks, and reviewing the progress of ESG objectives to realize more independent, efficient and professional ESG management, ensuring the integration of its ESG concepts with the Company's policies, and exploring a new sustainable development model combining ESG issues with the Company's business operations. The ESG Working Group is composed of key responsible persons from all departments of the Company and periodically reports annual ESG related matters to the Board. The Company has arranged contact persons at the headquarters and all departments of branches and subsidiaries. Led by the Party Committee Work Department, it has established the ESG implementation group to specifically implement the work in areas of ESG or social responsibilities to promote the ESG management concept of the Company.

The Company attaches importance to the material impact that ESG risks may have on the Company. Based on the external social and economic macro environment and the Company's development strategy, it periodically conducts the materiality assessment of ESG-related issues and submits the same to the Board for review. The Board discusses and determines the Company's ESG risks and opportunities, regards the management and promotion of material issues as the key focus of ESG work, incorporates them into the overall strategy of the Company, and supervises the management of such issues and related performance. In 2023, the Company enhanced its ability to identify the risks and opportunities that climate change brought to the Company, and took actions to respond to such risks and opportunities. In the future, the Company will continue to strengthen its ability to manage and deal with climate risks and opportunities.

Upon the approval of the Board, the ESG implementation group is authorized to work on data collection and disclosure for ESG report of 2023. This report discloses in detail the progress and achievements of ESG work of QHD Port in 2023, which was considered and approved by the Board on March 2024. The Board and all directors of the Company guarantee that there are no false statements, misleading representations or material omissions in the content of this report, and assume individual and joint responsibility for the truthfulness, accuracy and completeness of the content.

A CLOSE LOOK AT THE QHD PORT

(I) COMPANY PROFILE

As a subsidiary of Hebei Port Group, Qinhuangdao Port Co., Ltd.* (秦皇島港股份有限公司) (Stock Code: SH601326, HK03369) is the world's largest public port operator for large-scaled dry and bulk cargoes, which was listed on the Hong Kong Stock Exchange and the Shanghai Stock Exchange respectively in 2013 and 2017, and became the first state-owned enterprise in Hebei Province to lay out the A+H share dual capital platforms.

As a global leading public port operator for large-scaled dry and bulk cargoes, QHD Port mainly operates Qinhuangdao Port, Tangshan Caofeidian Port Zone and Cangzhou Huanghua Port Zone, including 73 modern professional berths in total, principally handles various types of cargoes including coal, metal ores, oil and liquefied chemicals, containers and general cargoes, has formed a chain system of port logistics covering basic services including stevedoring, stacking, warehousing, transportation and logistics, as well as freight forwarding and multimodal combined transportation, etc., and possesses a designed throughput capacity of 410 million tonnes per year. In 2023, the annual throughput capacity of QHD Port was 392 million tonnes, representing an increase of 2.12 percentage points over the previous year.




(III) ORGANIZATIONAL STRUCTURE



Energy security and safety concern national economy and people's livelihood, and it is a "national priority" that cannot be neglected at any moment. The report of the 20th National Congress of the CPC explicitly proposed to strengthen the construction of systems of energy production, supply, storage and sales to ensure energy security. QHD Port actively responded to national calls, resolutely fulfilled tasks on ensuring smooth and ample supply of national energy and price stability, undertook the missions and responsibilities as a major pivot hub for transporting coal from the north to the south and implemented various "measure portfolios" on ensuring energy supply. It adopted various measures to enhance its capacity on guaranteeing energy security, vigorously ensured thermal coal transportation and made outstanding contributions to the safety of national energy transportation.

(I) SPEEDING UP VESSEL TURNOVER AT PORTS

Relying on the external "6+N" all-weather coordination mechanism on ensuring thermal coal transportation, QHD Port worked with key units in ensuring supply, developed "green channels" for energy and materials and strived to achieve "zero waiting" in entering and leaving the ports and "zero delays" in unloading goods. While guaranteeing safety and compliance, it effectively reduced the time of traffic restrictions. Internally, it made full use of the advantages of "anchorage", "two-way ring channel for entering and leaving the ports" and other navigation environment and strengthened the coordination of various production and operation units in the port through refined organization to shorten the berthing time of vessels.

Case: Seventh Company of QHD Port ensures thermal coal supply for the Asian Games

Relying on Daqin Railway, the Seventh Branch Company of QHD Port collects and distributes coal from Shanxi and other places through Qinhuangdao Port, and then transports it by sea to Eastern China, Southern China and other regions in China. As a unit for guaranteeing thermal coal supply for the Asian Games, the Seventh Branch Company of QHD Port set up an energy guarantee group for the Asian Games, opened a green channel for thermal coal transportation for the Asian Games, and initiated the coordination and command work of coal unloading, stacking and loading through the control room of the centralized control center. It guaranteed the prioritized entry, loading and departure of vessels for coal transportation for the Asian Games and contributed to the successful holding of the Hangzhou Asian Games.



(II) ENSURING SMOOTH TRANSPORTATION CHANNELS

In response to the impact of inclement weather on production and operation at ports, QHD Port formulated the Emergency Plan for Coal Transportation Guarantee and strictly implemented the "four precautions" in production at ports to ensure smooth channels for coal supply. It took the initiative to visit downstream customers, focused on the daily consumption and production and operation of end customers and accurately estimated their demands. It jointly developed a weather warning system with the meteorological station of Tianjin Ocean Center, and dynamically adjusted the sequence of port operations based on the probability of closure warning information for the next 10 days and the precise weather forecast for the next 3 days. It has scientifically organized all production sections to enhance the scientific and forward-looking indoor deductions.

We also conducted train unloading rehearsals for each section of the railroad, such as train requesting, train approval, train loading and in-transit trains, and carefully formulated unloading plans to maximize the unloading capacity of the ports.

(III) EMPOWERING INTELLIGENT PORTS WITH TECHNOLOGY

QHD Port insists on empowering development with technology, carries out active exploration and innovation and fully displays the role of Qinhuangdao Port as a super-large coal hub with full-process automation. It achieves all-weather efficient operation, real-time monitoring on full working conditions and full-process integrated operation to promote the transformation from "single intelligent points" to "full-process intelligence" in port production. With the implementation of centralized unloading and stacking control, centralized control of delivery and uploading, intelligent and centralized control on environmental protection and other technologies, it developed an intelligent framework system based on the centralized control of reclaiming, stacking, delivery and loading, consolidated the foundation of equipment protection and comprehensively enhanced the efficiency of thermal coal transportation.

Case: Empowering "World-Class" with an Intelligent Brain

QHD Port promoted low-carbon and high-efficiency operation of ports and developed the intelligent management system on "one center with three platforms" with the scheduling and command center, the remote centralized control platform, the environmental monitoring platform and the safety regulatory platform, resulting in more efficient production, more systematic management, more scientific decision-making and more considerate services.

 The scheduling and command center integrates five functions, namely, production command, operation scheduling, collaborative office, safety control and environmental monitoring, and leads the production

- The environmental protection and intelligent control platform realizes real-time monitoring, unified collection and analysis of data and information on air, water, exhaust from mobile sources as well as road and environmental conditions, etc.;
- The safety monitoring platform integrates the functions of safety inspection, risk identification, detection and management of latent danger and on-site monitoring on key production operations and forms a closed-loop safety management.

QHD Port has established a scientific and standardized management system according to the modern enterprise system requirements and improved the effectiveness of corporate governance with the improvement of the governance system as drivers. 






(I) Improving Governance System

QHD Port has strictly complied with the Company Law of the People's Republic of China and other laws and regulations and regulatory requirements of the places where it is listed, and has continuously improved the governance structure of the Company. The general meeting, the Board of directors and its special committee, the supervisory committee, and the management of president responsibility have clear division of rights and responsibilities and are efficient in ensuring the stable operation of the Company.



Governance Structure of QHD Port

General Meeting

The general meeting is the Company's supreme authority. The articles of association, the meeting rules and other requirements of the Company set forth the rules of procedure for the general meeting, clarify the Company's supreme authority and its functions, provide legal guarantee for its operation in accordance with the law, and fully ensure that all shareholders are entailed equal status and can exercise their rights to know, participate, inquire and vote. In 2023, QHD Port convened four general meetings, with all 15 proposed resolutions being passed.

2. Board of Directors

The Board of directors is the permanent decision-making body of the Company and is responsible to the general meeting. The directors abide by the principles of diligence, integrity and pragmatism in favor of all shareholders, and fulfill duties conscientiously. The Board of directors of QHD Port is comprised of 9 directors, including 3 executive directors, 2 non-executive directors and 4 independent non-executive directors. With a diversified and balanced composition, the Board of directors can effectively make independent judgments. In 2023, QHD Port convened a total of 10 Board meetings, considered a total of 51 resolutions including the annual report and ensured that the Company's work was carried out in an orderly manner.

(II) Safeguarding Stable Operation

QHD Port unswervingly upholds the leadership of the Party, continuously strengthens the Party's work in the Company and consolidates the "root" and the "soul"; focuses on improving the core competitiveness of itself as a state-owned enterprise and enhancing core functions, insists on comprehensively deepening reform and constantly unleashing the vitality of itself as a state-owned enterprise; boosts the competitive advantages of the enterprise in compliance with laws and regulations and safeguards the high-quality development of the enterprise with compliance management; insists on stable operation, abides by business ethics and keeps a "zero-tolerance" attitude on corruption; and strengthens communications with investors and protects the interests of medium and small investors to facilitate the stable operation of the enterprise.

1. Strengthening the leadership of Party's work

Under the guidance of Xi Jinping Thought on Socialism with Chinese Characteristics for a New Era, QHD Port conducts in-depth study, publicity and implementation of the spirit of 20th National Congress of the CPC, firmly grasps significant development opportunities in the integration of port resources in Hebei, gives full play to its leading role in setting the direction, managing the overall situation and ensuring implementation and leads Party members, cadres and staff to hold high the banner and forge ahead with cohesion and solidarity to lead the Company's high-quality development.

(1) Achieving results in thematic education

QHD Port launched in-depth learning and implementation of the thematic education on Xi Jinping Thought on Socialism with Chinese Characteristics for a New Era, firmly followed the general requirements on "learning thought, strengthening Party spirit, emphasizing practice and making new contributions". It has formulated and issued seven guiding documents, including the Implementation Plan for Thematic Education and the Investigation and Research Work Plan for Thematic Education, and has comprehensively adopted thematic learning, joint learning, thematic Party classes and advanced training courses, to consolidate the quality of learning and education. Adhering to the problem-oriented approach and focusing on scientific and technological innovation, green transformation, project construction and other key reform tasks, it has formed more than 90 high-quality research results and solved more than 100 major problems in the reform and development of the enterprise, and has achieved remarkable results in casting the soul by learning, increasing wisdom by learning, correcting the style by learning and promoting the work by learning.

QHD Port convened a thematic study seminar for the central group in the first time, focused on the spirit of the important speech made by Xi Jinping the general secretary of the CPC, studied measures for implementation,

(2) "Integration of Party work with industries" stimulates new vitality

QHD Port gives full play to the radiation and demonstration role of the brand of Party work, focuses on key points in production and operation and the difficulties in reform and development in Party work carries out the special campaign on "improving the integration of Party work with industries", and achieves the value creation of "three first-class" in Party work through the implementation of "six integrations"; and deepen the construction of "one unit with one brand and one branch with one highlight". It has developed 18 brand projects in Party-work, saved corporate costs by RMB13,395,800, increased revenue by RMB22,346,000, and has promoted a high compatibility between Party work and high-quality development of the enterprise.

(3) Vigorously carrying out publicity of the main theme

QHD Port consciously undertakes the mission of upholding the banner, gathering people's heart, educating new people, promoting culture and displaying its image. It upholds the main theme, gathers positive energy and focuses on typical cases such as ensuring the supply of thermal coal, "mass entrepreneurship and innovation, green and smart development as well as and model workers and craftsmen. It has published more than 1,800 press releases in various central, provincial and municipal mainstream media such as People's Daily, Xinhua News Agency, Workers' Daily, Science and Technology Daily and Hebei Daily. The Company's public account has published more than 500 pictures, texts and videos, depicting a magnificent picture of port reform in an all-round way, condensing the ideological consensus of observing justice and innovation, and actively advancing towards building the "big port zone with a history of 100 years", which demonstrated the confidence and determination of QHD Port in building a worldclass port enterprise for dry and bulk cargoes.

2. Comprehensively deepening the reform

QHD Port adheres to the concept of "seizing opportunities in the reform and promoting the Company to become stronger and better", seizes the policy "opportunities" and grasps the "window period" of transformation. It deeply carried out the special campaign on deepening state-owned enterprise reform and continuously strengthened corporate governance and transformed relevant mechanisms to boost the high-quality development of enterprises.

QHD Port's Measures on Comprehensively Deepening the Reform:

- Focusing on the annual excellence target, the Company made every effort to promote the reform of "Double Hundred Actions". QHD Port has conducted researches and formulated the "Double Hundred Action" 2023-2025 Comprehensive Reform Implementation Plan and the working ledger. With deepening the corporate governance structure, improving the market-based operation mechanism as well as incentive and restrictive mechanisms and speeding up in industrial upgrading as breakthroughs, it actively developed a local vole model with the characteristics of QHD Port in state-owned enterprise reform.
- Taking the initiative to steadily push forward the work of "transforming branches to subsidiaries". QHD Port resolutely implemented the deployment of Hebei Port Group's on "transforming branches to subsidiaries" and has successively issued documents such as the "Implementation Plan on Transforming Branches to Subsidiaries", "the Selection and Operation Plan on the First Batch of Targets Companies in Transforming Branches to Subsidiaries". It has successfully completed the registration of the new subsidiaries, which effectively promoted the First Company to become an independent market entity with "self-operation, self-financing, self-restriction and self-development".
- Achieving new breakthroughs in promoting the reform of special business. QHD Port continued to promote its affiliated companies to integrate the cleaning and coal cleaning business of the Sixth Company, the Seventh Company and the Ninth Company in the east port zone to achieve unified, standardized and professional management and achieve the goals of lowering costs and expenses, reducing safety risks, and improving the environmental surrounding management.

3. Strengthening compliance management

QHD Port has taken various measures to strengthen the compliance management, continued to improve the compliance system, and put the rule of law into practice. It has also carried out in-depth risk prevention and control and endeavored to prevent and dissolve various risks.

(1) Promoting corporate governance in accordance with relevant laws and regulations

In accordance with the "Measures for the Compliance Management of Enterprises under the Supervision of the State-owned Assets Supervision and Administration Commission of Hebei Province", QHD Port continued to improve the compliance management and control model that focuses on prior supervision and in-process monitoring, and improved the compliance management system. It has conducted legal education and trainings within the Company and strengthened the publicity of laws, and created an atmosphere with everyone complying and initiatively abiding by laws. In 2023, QHD Port organized a total of 22 trainings on law-bidding and compliance.

(2) Strengthening risk prevention and control

QHD Port revised the "Measures for Comprehensive Risk Management", established a reporting mechanism on major operational risks, and improved the "Management Measures for Legal Disputes"; optimized the "Contract Management Measures" and achieved a legal review rate of 100% on major proposals, systems and contracts. It also formulated the "Management Measures for New Business Expansion" to strictly prevent the risk potentially given rise to by new external businesses; effectively identified and prevented risks by launching comprehensive risk inspection and evaluation, comprehensively strengthened implementation and rectification and established long-term mechanisms.

4. Abiding by business ethics

QHD Port advocates the integrity in conducting business and requires business personnel to act in accordance with principles and regulations, not to use their powers and functions to solicit, take, hold, or ask for favors, not to practice favoritism in business acceptance, and not to accept money, goods or banquets from the counterparties. It has formulated and issued guiding documents related to thematic education, and launched special rectification of conduct and discipline within the Company; actively organized the Party members and cadres to participate in Hebei Port Group's special trainings on Party's disciplines and rules and regulations, carried out the publicity and education on integrity culture, and guided the Party members and cadres to build a strong line of defense on integrity and self-discipline. In 2023, the Company organized 28 anti-corruption trainings and recorded no major litigations in terms of corruption, bribery, extortion, fraud and money laundering.

Information disclosure

QHD Port fulfills its information disclosure obligations in strict compliance with the listing rules of the Shanghai Stock Exchange, the listing rules of the Hong Kong Stock Exchange and the articles of association and other internal and external regulations and establishes internal approval procedures on routine information disclosure to continuously improve the efficiency and quality of information disclosure and ensure the truthfulness, accuracy, completeness, timeliness and fairness of information disclosure. QHD Port has not been punished for any violation of information disclosure requirements since its onshore and offshore listings.

6. Protecting the rights and interests of small and medium-sized investors

QHD Port actively practices the concept of "respecting, rewarding and protecting investors", and continues to carry out investor exchanges, market communications, insurance and investment education. In 2023, the Company routinely held the annual results presentations, interim results presentations and third quarterly results presentations, and answered investors' questions and responded to more than 100 investors' suggestions through the investor hotline and SSE e-interaction to fully protect investors' right to know and their right to make suggestions. Five investor protection and education activities were carried out throughout the year, including the "3.15 Investor Protection Themed Education Activity" and the fourth "Prevention of Illegal Securities and Futures Publicity Month", to enhance the ability of small and medium-sized investors to protect their rights and interests by popularizing investment knowledge among the investors.

(III) Ensuring Production Safety

QHD Port has implemented various safety management measures such as system optimization, latent danger inspection and safety trainings, and made every effort to ensure the continuous stability of production safety. It has also launched an in-depth occupational health protection campaign to safeguard the occupational health of its employees. In 2023, QHD Port invested RMB123,771,200 in production safety and recorded no accidents in respect of production safety and no work-related death for three consecutive years.

1. Ensuring operation safety

QHD Port optimizes the production safety management system to promote the steady implementation of safety management; strengthens the inspection on latent dangers, reinforces emergency drills and resolutely fulfills the responsibility of production safety; strengthens trainings on safety skills for employees and related parties, publicizes safety production culture and strengthens the safety awareness.

(1) Strengthening safety management

QHD Port focused on advancing the construction of safe ports and preliminarily established the "33345" production safety management system; optimized the emergency rescue system of accidents and improved the response to extreme and severe weather emergencies; and completed the development and construction of the safety regulation platform and consolidated the defense line of safety risks through prevention with labor, materials and technology. QHD Port passed the annual review on Level-1 production safety standardization certificate for transportation.

(2) Carrying out inspections on latent dangers

QHD Port actively promotes the normalized inspection on latent dangers and carries out special actions such as special inspection and rectification of major accidents and latent dangers, "resolutely implements grass-roots construction, safety management, safety hazard inspection and rectification", fire safety inspections and rectification in this winter and next spring, and makes every effort to prevent production safety accidents. It strengthens the inspection and supervision on safety hazards, highlights the supervision and inspection of key fields, key areas and key periods, and improves the implementation of the rectification of latent hazards; set up incentives for reporting safety hazards, and promotes the participation of all employees in the inspection and management of latent hazards.

Latent danger inspections and rectifications carried out by branches and subsidiaries of QHD Port:

- > Second Company carried out inspections on latent electrical dangers in summer and conducted inspections on electrical equipment.
- > Sixth Company implemented special inspection and rectification on major risks and dangers and conducted inspections on operation with fire and electrical safety.
- Seventh Company carried out inspections on latent dangers on fire prevention in summer and found 29 fire hazards of various types, all of which have been rectified.
- > Railway Transportation Company carried out inspections on latent dangers in power and fire protection, and found and rectified 12 hidden safety dangers.
- > Cangzhou Mineral carried out special inspection actions on latent dangers in electric power, focused on fire protection and equipment inspection in the charging area for heavy trucks.

(3) Upgrading safety skills

QHD Port attaches importance to strengthening "labor defense", and actively organizes trainings and assessment of employees on safety risks and control measures, so as to improve the employees' level of "knowledge on risks and awareness on risks", and to achieve the purpose of "control and avoidance of risks". It utilizes the intelligent safety training center and the "Craftsman Academy in Ports" (河港工匠學苑) to provide education and training platforms and resources to the relevant parties to effectively enhance the safety attainment and skills of the relevant parties.

2. Safeguarding occupational health

In accordance with the Law of the People's Republic of China on the Prevention and Control of Occupational Diseases 《中華人民共和國職業病防治法》, the Administrative Regulations on Employers' Labor Protective Equipment 《用人單位勞動防護用品管理規範》), the Provisions on the Administration of Occupational Health at Work Sites 《工作場所職業衛生管理規定》 and other laws and regulations, QHD Port improves its occupational health management mechanism. The Company has set up occupational monitoring archives and occupational health management standing book for employees exposed to occupational diseases to keep records of the health conditions and the process of occupational disease prevention and control of employees. It implemented the subject responsibility on occupational health trainings, enhances the organization and management of trainings on occupational health and improves employees' occupational health attainment and skills. It actively organized and carried out occupational health examinations for employees to protect their legitimate rights and interests.


(I) Serving National Strategies

2. Facilitating the "Belt and Road" initiative

Adhering to the concept of "joint construction, building and sharing", QHD Port actively implements the strategy of the Hebei Provincial Party Committee and the Provincial Government on "promoting the province's development in marine economy and building it into a marine power", continuously optimizes the route layout, improves the sea-rail intermodal transportation network, and actively develops domestic and foreign trade markets to help Hebei Port Group better integrate into the "Belt and Road" initiative, demonstrate QHD Port's undertakings and contribute QHD Port's strength.

The "Baoding-Qinhuangdao-Incheon" searail intermodal transportation line is the first convenient multimodal transportation channel for foreign trade in Hebei Province. On 9 April 2023, the container train from Baoding Jinxiongbao International Intelligent Port directly arrived at the container terminal in Qinhuangdao Port and directly uploaded on the "New Tulip" vessel and shipped to South Korea through the Qinhuangdao-Incheon route, which effectively promoted the integrated customs clearance in Beijing-Tianjin-Hebei and improved the efficiency of logistics.

3. Facilitating the development of adjacent industries

QHD Port has effectively utilized the regional advantages of Qinhuangdao Port to significantly reduce the logistics cost of imported grains through the unique layout of "front port, middle warehouse and back factory", attracting projects such as the grain reserve base at ports for Sinograin and the comprehensive processing park of Yihai Kerry (Qinhuangdao) grain and oil products. In 2023, QHD Port continued to promote the construction of the grain transportation corridor project in Qinhuangdao Port to provide grain transportation for the grain silo areas of Sinograin and Yihai Kerry, effectively safeguarding national food security and serving the development of adjacent industries.

Case: Grain Transportation Corridor Project in the East Port Zone of Qinhuangdao Port Officially Commenced

On 20 September 2023, the grain transportation corridor project in the East Port Zone of Qinhuangdao Port invested by QHD Port officially commenced construction. The grain transportation corridor directly connects the grain unloading operation area in Qinhuangdao Port with the grain silo areas of Sinograin and Yihai Kerry and develops a grain transfer, storage and processing system with seamless connection of "front port and back factory". It can realize direct unloading of grain at the port, direct inspection upon unloading and efficient warehousing, which will significantly save grain transportation costs for enterprises, improve grain transportation efficiency and reduce inventory pressures.

1. Deeply exploring principal businesses

QHD Port continuously and deeply explores its existing principal businesses and has made continuous efforts in the transportation of coal, metal ores, general and other cargoes, containers, oil products and liquid chemicals. In 2023, QHD Port's annual throughput was 392 million tonnes, representing an increase of 2.12 percentage points as compared with the previous year.

(1) Coal transportation business

As a pivot hub as the transportation channel of China's domestic coal, QHD Port attaches great importance to precise marketing to expand cargo sources and continues to adhere to the strategy on major customers. It has launched special cooperation with 35 customers and adopted the cooperation mode of long-term lease to stabilize port throughput with a total contracted volume of 190 million tonnes. Adhering to the work philosophy of "working hard and cultivating high-quality customers", it has newly introduced a number of high-quality mineral and sales integrated supply sources. It also built a port business platform for its customers and provided customized services, which gained the trust and recognition of its customers. In 2023, QHD Port completed a coal throughput of 217 million tonnes.

Case: QHD Port Holds Special Meeting on Ensuring Coal Supply

In December 2023, QHD Port resolutely implemented the spirit of the meeting of Hebei Port Group on responding to heavy snowfalls and temperature plunge with the coals and equipment systems, promptly studied response measures in details on production organization, equipment guarantee and safety risks, and held a special deployment meeting to actively assume the political responsibility of ensuring coal supply and ensure smooth transportation on the Daqin line and sea transportation channels.

(2) Metal ore transportation business

QHD Port continues to carry out transportation metal ores. By taking advantage of the railway transportation, it actively strives for long-distance cargo sources from hinterlands to increase its cargo supply. It further improves transportation efficiency and service quality to enhance corporate competitiveness. In 2023, QHD Port completed metal ore throughput of 132 million tonnes.

Metal Ore Transportation Business of QHD Port's Subsidiaries:

- > Caofeidian Shiye boosted its marketing efforts towards ore customers, promoted the landing of the import vessels of Inner Mongolia Yaxin Iron & Steel for the first time during the year and the smooth arrival of the first import vessels of Baotou Steel.
- Relying on the favorable conditions of the first phase of the renewed berths, Cangzhou Mineral undertook the bauxite cargoes from Shanxi Dongfang Hope and Aokaida. Through the close cooperation with Caofeidian Shiye, it completed the trial operation of the water-to-water ore transfer business.

Case: Cangzhou Mineral Successfully Completes the Largest Direct Belt Trestle Hoisting

In September 2023, Cangzhou Mineral successfully completed the hoisting operation of the largest trestle in Phase 1 (expansion) of metal ores terminal project of Huanghua Port, realizing the direct belt delivery from "Unloading-Stacker-Customer" to "Unloading-Customer" and effectively reducing the logistics costs of customers.

(3) Transportation business for general cargoes and other goods

Leveraging on the "integrated" advantages of Hebei Port Group after integration, QHD Port has achieved significant progress in developing cargo sources in the hinterland by boosting efforts in attracting cargo supply in various port areas. In 2023, QHD Port achieved a throughput of 26.57 million tonnes of general cargoes and other goods.

In 2023, Qinhuangdao Port actively expanded its grain business and introduced new important cargo sources, achieving an annual grain throughput of 2.49 million tonnes. Among them, the east port zone completed the project application for the designated supervision project site for imported grains. The projects of changing the business area of the Customs Supervision Office in the C yard of the west port zone and the expansion of the designated supervision site for imported grains were approved by the local custom authority, effectively solving the problem of insufficient storage capacity of grains.

(4) Container transportation business

In 2023, domestic trade container routes such as "Qinhuangdao-Qingdao", "Huanghua Port-Guangzhou", "Huanghua Port-Quanzhou Port" and "Huanghua Port-Xiamen Port", and foreign trade container routes such as "Huanghua Port-Japan" and "Huanghua Port-Russian Far East" have been opened one after another, realizing the interconnection of container transportation and the immediate delivery of inbound cargoes, thus providing more transportation routes for enterprises in the hinterland of Hebei. In 2023, QHD Port achieved a container throughput of 1,095,400 TEUs.

(5) Transportation business for oil and liquefied chemicals

QHD Port has successfully completed the renewal of the "Certificate of Port for Dangerous Goods" to ensure the smooth development of the port's oil products and dangerous goods business and built a solid barrier for the safety of oil transportation, storage and production. In 2023, QHD Port achieved a throughput of 1.99 million tonnes oil and liquefied chemicals.

2. Providing high-quality services

Adhering to the philosophy and goal of "improving service quality with customers as the center; seeking continuous improvement of services and surpassing customers' expectations", QHD Port actively explores new models of customer services and strives to improve services by enhancing service quality, optimizing customer experience and proactively responding to complaints in order to create value for customers and win their trust.

(1) Improving service quality

QHD Port continues to improve its service quality management, strictly abides by the "Ten Commitments on Service Quality" and other relevant systems, promotes the deepening and implementation of service quality management, so as to build up trust with its customers and realize mutual benefits and win-win result.

Case: QHD Port Actively Responds to Challenges and Successfully Completes the Third Batch of Loading Operation of China Railway Shanhaiguan Bridge

QHD Port signed a cooperation agreement with China Railway Shanhaiguan Bridge to ship bridge equipment worth more than RMB300 million to Vancouver. Canada in 8 batches, among which the third batch of loading was extremely difficult. During the period of operation, extreme and inclement weather in Qinhuangdao occurred frequently and the production operation faced major challenges. QHD Port actively faced the challenges and developed a customized loading plan and finally completed the operation with high quality and efficiency and received a letter of appreciation from Chinese-Polish Joint Stock Shipping Company.

(2) Optimizing customer experience

QHD Port made continuous efforts in optimizing the port environment, scientific and coordinated scheduling, renovation of port facilities and improvement of data management, and is committed to providing professional and personalized services to customers and enhancing customer satisfaction.

Optimizing the port environment

Continuing to deepen multi-departmental cooperation and smoothen communication and liaison channels to ensure the effective convergence of vehicles, vessels and cargoes; developing a new meteorological data application system to enhance early warning capability and minimize the adverse impact of severe weather; supervising shipping companies to formulate rules on duty operations under severe weather to enhance the continuity and safety of tugboat berthing and de-berthing operations.

Scientific and coordinated scheduling

Formulating an integrated docking plan for vessels of the Sixth Company, the Seventh Company and the Ninth Company, approving the pre-completion time of vessels through process rehearsal, adjusting and alleviating the situation of centralized docking in advance, and realizing gradual docking to minimize the centralized docking of vessels; giving full play to the advantages of the "three integrations" and coordinating the deployment of port resources under the principle of "relative fixity with flexible adjustment"; coordinating the equipment inspection and maintenance plan of all companies, and reasonably deploying manpower and machinery to create conditions for sustainable and efficient production on the basis of guaranteeing the quality of inspection and maintenance.

Renovation of port facilities

Steadily pushing forward the dredging project of 707#, 905#, 906# berths and 423# pontoon waters to improve the navigation capacity and reduce the risk on entering and leaving the port; accelerating the berthing demonstration of ultra-wide coal vessels from the sea to the river to alleviate the problem of vessel queuing.

Improving data management

Relying on the construction of "one center with three platforms", continuously improving the capacity on remote monitoring of port production, safety and environmental protection; integrating the production data of Caofeidian Port and Cangzhou Port zones and Qinshan Chemical to provide data support for the subsequent development of the query service and function on production information for customers; timely releasing early warning information on severe weather such as strong winds, strong convection, and heavy rains, and using tides to solve problems of loading, unloading and entry and exit of large-draft vessels when conditions permit; and logging in for the online business with UKEY for business operation, ensuring the security of port customers' identity information and business information.

(3) Actively responding to complaints

QHD Port's freight service is subject to external supervision. Based on the Regulations on Coal Quality Management, Measures for the Administration of Quality Complaint Calls and Measures for the Administration of Quality Complaint Calls to President of Qinhuangdao Port Co., Ltd. and other rules and regulations, QHD Port has set up a president complaint hotline, which is networked with the 12345 service hotline, to properly handle complaints on service quality. In 2023, QHD Port's overall satisfaction score on customer service was 97.27, and the customer complaint rate was zero.

(III) Gathering the Strengths of Multiple Parties

QHD Port adheres to achieving mutual benefit and win-win results, and continues to gather the strength of multiple parties to jointly build sustainable and responsible supply chains. It optimizes the management mechanism on strategic cooperation to maximize value creation; and participates in the research and formulation of industrial standards, learns the advanced experience of outstanding enterprises in the industry, and works with outstanding enterprises to achieve common innovation and development in the industry.

1. Building responsible supply chains

QHD Port comprehensively improved the intelligent management of materials, strengthened platform sharing, and created an intelligent procurement system with the "integration of factors". It strengthened management from all aspects such as supplier access and review, and integrated the concept and requirements of social responsibility into the whole process of supply chain management, continuously improved the ESG management system on supply chains and optimized the structure of supply chains.

(1) Promoting intelligent procurement

QHD Port accelerated the full coverage of intelligent procurement. In accordance with the requirements of the centralized procurement centre, QHD Port applied the material management system, promoted the material procurement platform, seamlessly integrated high-quality suppliers at the beginning, accurately met differentiated customer demands at the end, promoted the online platform for each unit, benefiting more units with high-quality, low-price and efficient e-commerce procurement. In 2023, intelligent procurement covered 23 units of the Company, with a coverage rate of 82%.

(2) Supplier management

Access: QHD Port reviews the qualifications of suppliers in strict accordance with the admission procedures, and verifies the authenticity and validity of supplier information through various channels such as Qichahcha*(企查查), official websites and phone call to manufacturers; issues the Supplier Operation Manual for newly admitted suppliers to facilitate suppliers to quickly understand business processes, platform operations, assessment rules, etc.; gives extra credits and priority to suppliers who have obtained the China Environmental Labelling Product Certification and are included in the national green manufacturing list; actively implements green procurement, guides supplier companies to give priority to energy-saving and environmentally friendly products, and encourages suppliers to continuously improve the energy-saving and environmentally friendly performance of supplied products. As at the end of 2023, QHD Port had a total of 706 suppliers.

Evaluation and training: QHD Port actively carries out ESG review and evaluation of the supply chain, establishes and improves the risk warning mechanism of suppliers, identifies supplier risk points, and timely tracks or directly issues early warnings to avoid potential cooperation risks; sends the Notice Letter of Supplier Assessment and Disposal Results to help suppliers understand and solve problems, and effectively enhance their awareness of compliance performance. It organizes and carries out supplier social responsibility trainings to effectively improve the suppliers' awareness of social responsibility. In 2023, QHD Port reviewed 106 suppliers, and suspended cooperation with 31 suppliers, and rejected 24 potential suppliers due to non-compliance in social responsibility.

2. Deepening strategic cooperation

QHD Port closely follows regional policies and industrial development trends, actively carries out multi-party cooperation, continuously expands business space, gathers resources and forces, and realizes complementary advantages. It builds a mutually beneficial and win-win strategic cooperation mechanism and platform, improves cooperation efficiency, drives the coordinated development of upstream and downstream industrial chains and strives to ensure the smooth operation of industrial chains.



III. BUILDING GREEN PORTS WITH SINCERITY

It is necessary to plan and promote the ecological and environmental protection work on the new journey with higher position, broader vision and greater efforts to write a new chapter in the construction of ecological civilization in the new era.

QHD Port adheres to the development concept of "building a green hub and sharing the blue sea and blue sky", integrates green into the whole process of port planning, construction and operation, implements the "carbon peaking and carbon neutrality" strategy and demonstrates the firm determination of the Company to actively respond to climate change and take the path of green and low-carbon development. It continuously explores green production methods characterized by energy saving and carbon reduction, and develops unique green advantages of the enterprise. It carries out ecological and environmental protection, creates an atmosphere with all employees paying attention to environmental protection and participating in environmental protection in the Company, injecting green development momentum to achieve the common growth, prosperity and win-win results of ports, industries and cities.













(I) Practicing Low-carbon Operation

QHD Port anchors the "carbon peaking and carbon neutrality" targets, improves the system and mechanism, promotes the "14th Five-Year Development Plan on Green Ports" at a high level, and lays the solid foundation for green management. It improves the intelligent environmental monitoring and enhances accurate and scientific management and control. The Company carries out the identification of risks and opportunities in climate change, integrates climate change issues into its long-term development plan, and provides a strong guarantee for the construction of green and ecological ports.

Strengthening top design

With the target of "green, low-carbon and environmental protection", QHD Port established an Environmental Protection Committee and a Leading Group on Energy Conservation and Emission Reduction with the chairman as the responsible person. In strict compliance with the Environmental Protection Law of the People's Republic of China and the Management Measures for Environmental Protection of Qinhuangdao Port Co., Ltd. 《秦皇島港股份有限公司環境保護管理辦法》, the Company formulated and released the Implementation Plan on the Construction of "Five-star" Green Ports 《"五星級"綠色港口建設實施方案》 and the Work Plan on the Construction of Green Ports in 2023《2023 年綠色港口建設工作方案》 to enhance the top design on the construction of green ports. QHD Port maintained scheduling and deployment on a weekly basis and convened a total of 21 special scheduling meetings on the construction of green ports and 5 scheduling meetings on environmental governance and on-site standardized management during the year. It carried out internal supervision and inspection to ensure the smooth operation of various environmental governance work. In 2023, the Company invested RMB324 million in environmental protection.

Case: QHD Port Becomes the First Chinese Enterprise Passing On-site Review on "Five-star" Green Port Zone

With the strong support of the Municipal Party Committee and the Municipal Government of Qinhuangdao, QHD Port, under the leadership of Hebei Port Group, carried out the treatment of dust, sewage, solid waste and emissions, maintained daily summarization and monthly scheduling and continuously advanced innovation, achieving significant changes in the environmental level of phases 3, 4 and 5 of coal, green management as well as the appearance of the port zone.

In October 2023, the Coal Terminal Phases 3, 4 and 5 of QHD Port successfully passed the review on "five-star" green ports by the Ministry of Transport and China Ports and Harbours Association and became the first Chinese enterprise passing the on-site review on "five-star" green port zone, which is currently the highest level of appraisal on green ports in China. It initiated the new model with the integrated development of green ecosystems of cities and ports, entered the new stage of intelligent empowerment on the construction of green ports, established the new channel of railway-water and sea-river green transportation, developed new experience conducive to promotion and duplication for dry and bulk cargoes in public ports and demonstrated the rich historical and cultural heritage as a century-old ports.

Specific Measures of QHD Port

- Researching and issuing the Implementation Plan for the Construction of "Five-star" Green Port Zone, and determining 35 key tasks for 8 major projects;
- > Building an intelligent management system of "one centre with three platforms" to make production more efficient, management more systematic, decision-making more scientific and service more considerate;
- > Self-designed and developed mobile filter cake making machines and two marine garbage removal devices to empower the construction of green port zone with the ingenuity of port employees;
- Promote the "five-step dust suppression method" for unloading operations, carry out the campaign of coal scattering treatment, build a comprehensive three-dimensional sewage discharge system, and open up the water storage sedimentation tank of the ore yard, so as to truly manage and treat dust and water;
- > Take the lead in compiling the air pollutant emission list in the industry, identify key pollutants and main emission sources, and lead the development of the industry with the spirit of self-innovation;
- > The Group completed the electrification transformation of the first retired internal combustion locomotive in China, built the first hybrid-power tugboat in Bohai Bay, and promoted the in-depth reform of the energy structure of the industry with the spirit of innovation.

2. Green and Intelligent Control

QHD Port vigorously promotes the construction of an intelligent monitoring platform of environmental protection, establishes an online environmental monitoring system, and realizes online monitoring of major pollutants, pollution traceability analysis, environmental risk warning and other functions. It took the lead in the establishment of the information system for management of pollution discharge permits, completed the data connection with the production system and the centralized control system on environmental protection and achieved the electronic management of pollution discharge permits.

3. Responding to Climate Change

QHD Port is fully aware of the essential role of responding to climate change for the sustainable development of the Company and gradually considers the short-term and long-term impacts of climate change on the Company's business. In combination with national policies and industrial development trends, it identifies climate change risks and opportunities, sets environmental goals, integrates issues on climate change into the Company's long-term development planning, and takes measures to address climate change to mitigate and adapt to the potential impacts of climate change. The Company's total GHG emissions in 2023 was 240,179.59 tCO₂e, with a density of 0.57 tCO₂e/RMB10,000.

(1) Governance

QHD Port incorporates climate change-related issues such as scenario analysis, risk identification and opportunity management into the scope of supervision by the Board of directors, continuously improve its governance structure on climate change and identify potential impacts of climate change on operations, investments and other activity scenarios to ensure the orderly implementation of climate risk governance measures; carries out trainings related to climate change according to needs, organizes and implements knowledge sharing of the latest environmental policies and regulations, and consults external experts when necessary to ensure the professionalism and reliability of climate strategy, risk and opportunity management measures.

(3) Indicators and Targets

QHD Port implements relevant national, provincial and municipal requirements and actively carries out "carbon peak and carbon neutrality" work, conducts thorough investigations on the emission of the ports and formulates action plans on "carbon peak" and "carbon neutrality". It has issued the Action Plan for Fully Implementing the New Development Concept and Promoting the Construction of Green and Low-carbon Ports and proposed carbon emission reduction targets. Guided by the following targets, the Company continuously promote the adjustment of energy consumption structure and energy structure and strives to reduce the emission of greenhouse gas.

By 2030

- > To preliminarily establish an economic system with green, low-carbon and circular development and make breakthroughs in energy conservation and consumption reduction, green power application, environmental protection and other aspects;
- > To achieve the emission peak.

(II) Developing Green Advantages

QHD Port comprehensively benchmarks the standards of the "five-star" green port zone, adheres to the principle of "overall planning, distributed implementation, highlighting key points, coordination and balancing, performing respective duties, forming joint forces, based on the actual situation and moderately advancing", focuses on energy saving and consumption reduction, and promotes the green and low-carbon transformation and upgrading of the ports. It focuses on the management of the three types of wastes, and promotes the "quantitative reduction", "resource utilization" and "harmless treatment" of the three types of wastes. Adhering to the principles of giving priority to conservation, protection and natural restoration, the Company gradually created "zero-carbon terminals", "zero-waste terminals" and "garden-style ports" and other outstanding labels.

1. Strengthening energy conservation and consumption reduction

QHD Port strictly abides by the Energy Conservation Law of the People's Republic of China, the Water Law of the People's Republic of China and other laws and regulations, and has formulated and issued the Management Measures for Energy and Water Conservation of Qinhuangdao Port Co., Ltd. 《秦皇島港股份有限公司節能節水管理辦法》). The energy conservation management leading group is responsible for organizing and leading the Company's energy conservation and emission reduction work, strengthening energy conservation and water conservation management, and striving to build a green port zone.

(1) Energy saving management

QHD Port vigorously explores new approaches such as smart energy conservation, circular energy conservation and renewable energy conservation to further enhance the carbon reduction attributes of energy conservation. Through energy-saving technological transformation and promotion of the use of clean energy, it optimizes the energy structure and improved the efficiency of energy use. In 2023, the Company acquired 50 new-energy heavy trucks. The ships used shore power for 280 times with a total of 6,402 hours and an electricity consumption of 1,475,596kWh.

Energy-saving Initiatives of the Company

- > We promoted green and low-carbon transportation means, purchased the first hybrid-power tugboat in the port cluster of the Bohai Rim, completed the pure electric transformation of the first idle internal combustion locomotive in China, updated and purchased new-energy mobile machinery, and carried out the upgrading and transformation of large-scale mobile machinery engines.
- The Company promoted the construction project of zero-carbon smart port railway, completed the test record report and use evaluation report of the pure electric transformation of the first internal combustion locomotive in China, completed the preparation and declaration of the proposal for the pure electric transformation project of the second DF5 locomotive, and the engineering feasibility research report passed the Company's review.
- > We carried out the electrification transformation of fuel port vehicles, eliminated old non-road mobile machinery, and purchased new energy mobile machinery and equipment to increase the proportion of new energy flow vehicles in the port. In 2023, the proportion of new energy mobile machinery in Qinhuangdao Port was 23.42%.
- We optimized the Company's electricity consumption structure and carry out large-scale procurement of green electricity. In 2023, the Company used 192,710,000kWh of green electricity.
- > We promoted energy-saving management and control, put into use the intelligent lighting system, and replaced high-pole lamps with intelligent control lamps.
- We completed the PLC transformation of the steam hot water heat exchange station in the port zone, effectively achieving energy saving and efficiency improvement.

(2) Water saving management

QHD Port promotes the daily inspection and maintenance of water equipment and key water-consuming parts, eliminates "running, spraying, dripping and leaking", and implements energy and water management into all links of production and management to reduce energy waste and water consumption.

Case: Water Recycling Project of QHD Port

QHD Port has established water recycling plant to effectively improve water quality through technical improvement and increase the frequency of anti-cleaning, so as to provide high-quality recycled water for the construction of the Company's "five-star" green port zone. In 2023, the Company consumed 1,883,600 tonnes of municipal tap water and 4,832,000 tonnes of recycled water, which greatly reduced the water pressure in the port zone and reduced the investment cost in environmental protection.

2. Strengthening the management of three types of wastes

QHD Port focused on key tasks such as dust pollution control, exhaust emission monitoring, water pollution prevention and control, and whole-process management of hazardous waste, established a long-term mechanism for the preparation of pollutant emission list and regularly released it to identify the main sources of main pollutants.

(1) Exhaust gas management

The Company strictly complies with the laws and regulations such as the Environmental Protection Law of the People's Republic of China (《中華人民共和國環境保護法》) and the Law of the People's Republic of China on Prevention and Control of Air Pollution (《中華人民共和國大氣污染防治法》), and has formulated systems such as the Measures of Qinhuangdao Port Co., Ltd. for the Prevention and Control of Mobile Source Pollution 《秦皇島港股份有限公司移動源污染防治管理辦法》) and the Measures of Qinhuangdao Port Co., Ltd. for the Prevention and Control of Dust Pollution 《秦皇島港股份有限公司楊慶污染防治管理辦法》) to actively promote its subsidiaries to carry out monitoring of environmental quality and pollutant emissions, promote the construction of dust control system, and reduce the impact on the surrounding environment during production and construction.

In response to the prevention and control of dust pollution, the Company carried out the upgrading and transformation of the whole-process treatment facilities for stacking, reclaiming and loading, and implemented the fine water distribution of the bottom layer of the dump machinery to suppress dust pollution at the source. It carried out the cleaning of the large arms and tail belt of the stacking machinery, the treatment of the drop-off point of the reclaiming machinery, and the spilling of the large arms of the loading machinery to solve the problems of dust and material entering the sea; and conducted special treatment of tower dust and overflow of flushing water to completely solve the dust problem of professional bulk cargoes. It carried out research and analysis on the application of dust suppressants in the conjunctives, and combined the use of conjunctives with intelligent sprinkling. In 2023, the annual average of PM2.5 and PM10 in Qinhuangdao Port reached the secondary standard of air quality, and the annual average of PM2.5 is better than the urban area where it is located. The water quality of sea areas has always reached the Level-1 water quality standard, which is better than the national requirements for the Level-3 water quality standard for port waters.

Case: Dust Pollution Monitoring System of the Sixth Company of QHD Port Achieves Full Coverage

In October 2023, the remote laser sensing system for dust detection of the Sixth Company of QHD Port was officially put into operation. The system can accurately detect the on-site distribution and concentration of dust in real time, provide data support for the sprinkling of water on the site, and realize the intelligent linkage between monitoring and sprinkler guns.

(2) Waste management

QHD Port strictly complies with the laws and regulations such as the Law of the People's Republic of China on the Prevention and Control of Environmental Pollution by Solid Waste 《中華人民共和國固體廢物污染環境防治法》), the Management Measures for the Transfer of Hazardous Waste 《危險廢物轉移管理辦法》) and the Standard for Pollution Control on the Storage and Landfill of General Industrial Solid Waste 《一般工業固體廢物貯存和填埋污染控制標準》) and implemented the requirements of the Management Measures for the Prevention and Control of Hazardous Waste Pollution 《危險廢物污染防治管理辦法》). It prepares and reports the management plan for hazardous waste every year, continuously standardizes the whole process of disposal of hazardous waste, and is committed to ensuring environmental safety and harmless treatment.

(3) Wastewater management

QHD Port strictly implements water pollution prevention and control measures, implements the blockage of sewage outlets in the sea, and collects, treats and reuses all dust-containing sewage in the production area. In 2023, the Company completed the upgrading and renovation project of the sewage treatment plant, the upgrading and renovation project of the dust-containing sewage treatment capacity of the storage yard and the construction project of the water storage sedimentation tank of the ore storage yard, realizing the preliminary collection and purification of rainwater in the storage yard, which is used for road cleaning and greening watering in the port zone, and improving the capacity to recycle dust-containing water. In 2023, Qinhuangdao port zone treated and reused 707,100 tonnes of dust-containing sewage throughout the year.

3. Ecological and environmental protection

QHD Port actively carried out ecological protection, and applied the concept of pocket park and sponge city into the green construction of the port zone by implementing green construction and improvement and transformation, volunteer actions on environmental protection, and repairing old and recycling waste, so as to further improve the functions of green land and the greening and beautification effect of the port zone. In 2023, the Company completed more than 34,000 square meters of green construction and renovation.

Deploying green ecology and building a "Garden-like" port zone

- The Company established an incentive and restraint mechanism for the construction of a green port zone, promoted the reform of the management model of coal yard cleaning and coal cleaning business, and improved the quality of coal cleaning and relevant business in the port zone.
- The Company implemented the greening landscape improvement and transformation project in the port zone, focusing on organizing and completing the greening of areas such as the east side of the ore yard, the dispatch command centre, the delta of the sightseeing road, the west auxiliary area of the Seventh Company, and the east section of the Donggan Road.
- > Established the "Repair and Reuse Project Team" to create new works on waste machinery and accessories, and selected some excellent art and creative exhibits to beautify the landscape of the port zone.
- > We strengthened the supervision of the sea environment of the "Bay Chief System", carried out the garbage removal and fishing in the port pools of Qinhuangdao port zone, and entrusted a professional team to be equipped with special garbage removal vessels.

Case: The Ninth Company of QHD Port Upgrades Public Space into a "Pocket Park"

The Ninth Company of QHD Port transformed the public space on the east side of the idle production service department and the southwest side of the sightseeing road into the "Pocket Park". The trees, shrubs and grasses were planted together to form a green land with flowers in three seasons and landscape in four seasons, creating a "small, beautiful, exquisite, excellent and dedicated" micro space to effectively optimize the environment of the port zone.

(III) Creating Environmental Protection Culture

QHD Port advocates green office and smart office, and gradually forms a green and low-carbon lifestyle across the Company. It actively spread the concept of ecological civilization, vigorously carried out publicity and education on conservation culture and green life, and improved the ecological environment protection awareness, management and professional skills of management personnel and front-line employees.

1. Green office

QHD Port advocates the use of energy-saving lighting systems, energy-saving water-saving equipment and first-level energy-consuming air conditioners in office areas. It carries out paperless office, promotes the use of video conferences, reduces the cost of meeting attendance and improves communication efficiency. In 2023, the Company held a total of 2,306 video conferences, which improved the office efficiency of "three ports and four areas".

2. Green culture

QHD Port promotes all cadres and employees of the Company to accept environmental protection assessment horizontally and vertically. It regularly organizes and carries out relevant knowledge trainings covering all employees to form a strong ideological atmosphere for the construction of green port zone. By carrying out environmental protection trainings, environmental protection publicity week, environmental protection public welfare activities and other forms of cultural construction, we spread and publicize the concept of energy conservation and carbon reduction and green development, promote ecological culture, cultivate ecological ethics, and widely encourage all employees to participate in ecological and environmental protection. In 2023, more than 8,000 employees participated in environmental protection trainings, with a 100% on-the-job coverage rate.

Case: QHD Port Carried out Collection Activity of Works of Art with the Theme of "I Act in Support of Green Ports"

The news and media centre of QHD Port publicly solicited relevant image works from all employees and the public, and used images to record the practical actions of employees to participate in ecological and environmental protection activities and practice the low-carbon lifestyle, which effectively demonstrated the achievements of QHD Port's construction of a "five-star" green port zone, further encouraged all employees to participate in the creation of a "five-star" green port zone, and created a strong green cultural atmosphere.

IV. ADVANCING TOWARDS STRONG INTELLIGENT PORTS WITH CRAFTSMANSHIP

We will speed up in promoting the iteration and upgrading of key technologies and core products and the intelligent empowerment of new technologies to ensure national energy security and enhance the guarantee capacity.

QHD Port strengthens the confidence and determination in "focusing on innovation is to focus on development, and seeking innovation is to seek the future", integrates scientific and technological innovation resources, creates an innovation platform, promotes industry-university-research cooperation, and injects new momentum into scientific and technological innovation. The Company accelerated the development of scientific research projects, and achieved positive results in scientific and technological research and development, intellectual property protection, and the transformation of scientific and technological achievements, so as to fully promote the Company's process in building smart ports and support the Company to achieve safe, efficient and intelligent development.



(I) Integrating Technological Innovation Resources

QHD Port implements the requirements of Xi Jinping, the general secretary of the CPC, on accelerating the formation of new quality productive forces, improves innovation management, continuously increases investment in innovation and R&D, continues to build innovation studios, strengthens industry-university-research cooperation in scientific research projects, combines the advantages of resources and technologies of both parties, activates high-quality development momentum with innovation and strives to build new competitiveness and long-lasting power for the Company's development.

Improving innovation management

QHD Port insists on improving the scientific and technological innovation system and mechanism, solidly promotes scientific and technological innovation, and organizes and holds review meetings on the implementation results of the Company's scientific research projects to ensure that significant results are achieved in R&D investment. In 2023, we invested RMB251,830,000 in research and development, and a total of 9 projects won major innovation awards throughout the year.

2. Building an innovation platform

QHD Port attaches great importance to scientific and technological innovation, strives to create an innovation platform with wide coverage and great influence, and focuses on carrying out the innovation studio alliance; The Company establish a "three-in-one" innovation studioes with high standards, and an innovation practice centre of QHD Port integrating innovation of Party work, science and technologies and that of employees, so as to share technical resources and improve work efficiency. By the end of 2023, the Company has built 1 national innovation studio, 11 provincial innovation studios and 9 municipal innovation studios. In 2023, Wang Youbin, the leader of the "Wang Youbin Innovation Studio" of the Power Company, was awarded the "National Traffic Technical Expert" by the Ministry of Transport, Wang Xiao, the leader of the "Environmental Protection Innovation Studio" of the Sixth Company, was awarded the "2023 Hebei Master Craftsman Annual Figure", and Li Fuyu Innovation Studio, by the "Design and Realization of a New Type of Material Capturing Machine Arm Protection Device", was awarded the "Top Ten Innovation Achievements" of Qinhuangdao City.

Case: Building a Communication Platform and Integrating High-quality Resources

The Innovation Studio Alliance of the east port zone is one of the important platforms for QHD Port to implement regional technical cooperation, integrate high-quality resources and achieve talent exchange. It persistently focuses on improving employees' quality and professional level, promotes enterprise technological innovation, and cultivates more knowledge-based, skilled and innovative talents. In 2023, the Innovation Studio Alliance of the east port zone carried out special training on smart ports, and more than

30 key technical personnel learned from the "good suggestions" and "new ideas" in respect of construction of smart port.

3. Strengthening industry-university-research cooperation

QHD Port continuously promotes industry-university-research collaborative innovation, and adheres to the combination of "internal innovation" and "external introduction". Relying on the post-doctoral workstation and two provincial-level scientific and technological innovation platforms, namely the provincial-level technical center, and Hebei Modern Port Coal Logistics Engineering Technology Research Centre, QHD Port cooperates with many universities and scientific research institutes to carry out various scientific research projects. In 2023, the "Smart Port Underwater Inspection Robot" project of the post-doctoral workstation won the bronze award at the Second National Post-doctoral Innovation and Entrepreneurship Competition in Hebei Province.

Case: The Innovation Studio of the East Port Zone and Yanshan University Held Thematic Exchange Activity

On 25 September 2023, the Innovation Studio Alliance of the east port zone and Yanshan University carried out a themed exchange activity of "deepening the university-enterprise collaboration for green development", and visited the Engineering Research Centre of the Department of Education of Intelligent Control System and Intelligent Equipment of Yanshan University and the Key Laboratory of Power and Electronics Energy Conservation and Transmission Control of Hebei Province, and discussed port-related scientific projects in depth to comprehensively improve the scientific research capabilities and standards of the studio members.

(II) Strengthening Independent Research and Development

QHD Port closely follows the trend of digital and intelligent development and accelerates the progress of scientific research projects. It achieved remarkable results of innovation-driven development and created a number of technological innovation achievements. It attaches great importance to patent management and intellectual property protection, duly performs patent registration, and actively carries out intellectual property right protection for patent infringement, striving to continuously create value for the port industry.

1. Carrying out scientific research projects

QHD Port fully relies on digitalization and intelligence, and on the basis of ensuring the effectiveness of R&D investments, it leads the transformation of scientific research projects from being "small and scattered" to "systematic and comprehensive".

Through the transformation of the four ship loading systems, the project enables the ship loading machine to be automatically loaded under the conditions of remote control operation, automatic cabin transfer and large cabin capacity, and promotes the integration of the picking line according to the process, so as to realize the "one-position centralized control" of the reclaimer and the loader, and improve the uniformity and safety of the loading operation.

2. Display of outstanding achievements

Focusing on the core business and emerging industries of the ports, QHD Port continued to make efforts in building "integrity, intelligent, efficient and green" ports, accelerated the intelligent and automated transformation, and formed a series of achievements such as the platforms of safety command center and the environmental protection command center. In 2023, four achievements of the Company won the 19th National Transportation Enterprise Management Modernization Innovation Achievement Award, among which, the Construction and Implementation of the "Six-in-One" Port Material Management Pattern Based on the "Integration" Model won the first prize, and the Construction of Intelligent Port Material Procurement System Driven by Digital Transformation, the Construction and Implementation of Supply Chain Management System in the Inventory Management of Spare Parts of Port Enterprises, and the Practice and Exploration of Leading High-quality Development of Enterprises with Talent Team Construction won the third prizes.

The safety command center platform: It has functions such as risk classification control, latent danger investigation and management, fire safety management, fire operation, key project management, etc., and dynamically supervises the safety management of all units and fields in one port and three regions, so as to improve the comprehensive safety management level of QHD Port.

The environmental protection command center platform: Relying on the intelligent environmental management and control system, through the environmental key information dashboard and the environmental management system dashboard, QHD Port can quickly, accurately, real-time and comprehensively master and view key environmental protection information, and through analysis and prediction, provide support and basis for precise management and control, and realize the interaction between data and pollutant control.

Case: Intelligent Inspection Robot of the Ninth Company of QHD Port Officially Put into Use

In July 2023, the intelligent inspection robot developed by the Ninth Company of QHD Port was officially put into work. Through the combination of advanced technologies such as big data and intelligent sensors, the intelligent inspection robot can monitor multi-dimensional status such as light, temperature and sound, effectively replacing manual inspection for important parts and key locations in confined space, and fully ensure the safety, reliability and efficiency of energy transportation.

3. Protection of intellectual property rights

QHD Port continuously optimized the intellectual property management system, and successively completed the formulation and implementation of rules and regulations such as the Incentive Measures for Scientific and Technological Innovation of QHD Port (《秦港股份公司科技創新獎勵辦法》), the Patent Management Measures of QHD Port (《秦港股份公司專利管理辦法》), and the Software Copyright Management Measures of QHD Port (《秦港股份公司軟件著作權管理辦法》). The patents under application are related to many professional fields such as port electricity, machinery, information technology, environmental protection and energy conservation, and engineering technology, which further improve the ability to explore core technologies by independent innovation. In 2023, the Company obtained 26 software copyrights and 9 patents, including 1 invention and 8 utility models.

1. Equal employment

The Company adheres to the principle of "openness and equality, competitive selection and job matching", eliminates all forms of discrimination in recruitment, training, promotion and other matters, prohibits child labour, forced labour, harassment, bullying and other acts, and ensures that employees of different genders, religious beliefs and cultural backgrounds enjoy fair, just and open job opportunities; the Company boosts employment through multiple channels and methods, optimizes staffing, and focuses on privacy and confidentiality management in recruitment and assessment to ensure the security of employees' personal information.

2. Remuneration and benefits

The Company continued to optimize the remuneration system, revised the Administrative Measures for the Remuneration of Middle-level Leaders (Trial) and the Administrative Measures for Total Wages (Trial), adjusted the distribution structure, and effectively stimulated the enthusiasm and creativity of all employees. The Company adheres to the goal orientation, and the performance appraisal results of middle management are closely linked to the annual performance salary, strengthening the rigid realization; adhering to the value orientation, the Company focused on key indicators such as throughputs, and provided targeted incentives for key personnel, and formulated remuneration incentive plans.

The Company made every effort to acquire the requisite insurances for employees, ensured that all benefits were paid on time and in full, handled supplementary medical insurance and personal welfare commercial insurance for employees, continued to implement enterprise annuity plans for in-service employees, and shared development achievements with employees. In 2023, the Company paid five basic social insurance premiums totaling RMB396 million for employees participating in the insurances, with a social insurance coverage rate of 100% and a per capita paid vacation of 12.81 days.

3. Democratic management

The Company continuously deepens the democratic management, establishes and improves the democratic management system of the enterprise, listens to the opinions and suggestions of employees when formulating rules and regulations concerning the vital interests of employees or deciding on major issues, fully protects employees' right to know, participate and supervise, and cultivates employees' sense of ownership.

In 2023, the Company adhered to the system of the staff representatives' congresses, effectively utilized the role of the staff representatives' congresses, and collected 36 proposals among which 33 proposals were taken into consideration; carried out the study and publicity of regulatory documents such as the Regulations on the Democratic Management of Enterprises in Hebei Province and the Regulations on the Supervision of Labour Laws of the Labour Union in Hebei Province to protect the democratic rights and interests of employees.

(II) Strengthening Team Building

QHD Port pays attention to the growth and development of employees, continuously optimizes the employee training system, strengthens cultivation of talents, builds a team of high-level personnel, and formulates reasonable promotion channels for employees, gives full play to the strategic and decision-making role of talented personnel in the process of enterprise development, and forms a virtuous cycle of career motivation and career achievement by talents.

1. Construction of cadre team

QHD Port persists in selecting and assigning strong middle-level leaders, and timely adjusts and optimizes the positions of leaders according to the status of the cadre team; improved the corporate governance structure of the invested enterprises, and orderly recommended directors and senior management to the invested enterprises, with a total of 51 person-times recommended; the Company innovated the management mode of middle management of affiliated units, revised the Administrative Measures for Middle-level Management of Affiliated Units (Trial), implemented hierarchical management, increased the selection criterion for excellent performance appraisal and grassroots work experience, promoted the scientific and reasonable flow of cadres, specified the role of appraisal of grassroots units, and gave full play to the initiative of employers; The Company will continue to strengthen the training and cultivation of young cadres, and further expanded the promotion channels for young cadres.

2. Strengthening employee training

According to the employee education and training management system, the Company focused on the Company's production and operation, reform and development, and transformation and upgrading, and continuously improved the system and mechanism of talent cultivation and development, held training courses for new employees, organized middle-level leaders to participate in the advanced training classes of Hebei Port Group, organized management personnel to participate in the first batch of training courses for interview experts with the theme of "Practical Skills of Interviewing People and Knowledge for Identifying Talents", organized production staff, professional technicians and business personnel to participate in external trainings such as skills of operation, production business and strategic management, and carried out special skills trainings such as PLC technology, 3D printing and centralized control operation for young employees. In 2023, the Company carried out various skills trainings, with 28,214 online and offline participants, and the employee training coverage rate reached 100%.

3. Building development channels

In 2023, 1 employee of the Company was awarded the title of National Traffic Technical Expert, 4 senior technicians were rated as the first batch of Special-grade Technicians in Hebei Province, 3 employees were awarded the title of Chief Technician of Hebei Port Group Corporation, 8 front-line loading and unloading technicians were promoted from Level 4 of the professional technical sequence to Level 5, 108 employees were promoted to intermediate positions, and 109 employees were granted with professional titles.

4. Provision of growth platform

The Company takes improving the professional quality of employees as the main line, adheres to the combination of labour competition with the actual production and job skills, takes the training of highly skilled talents as an important part of the strategy of strengthening the enterprise with talents, and carries out labour competition activities closely focusing on safe production, skill improvement, innovation and efficiency creation, so as to achieve the purpose of "promoting learning through competition, training through competition, and practicing through competition", and lead employees to cultivate strong technical skills and grow into talents of their positions. In 2023, the Company deeply explored, cultivated and selected role models, selected 28 model teams and 20 experts through labour competition, and found a large number of advanced role models such as workers in Hebei Province and craftsmen in Hebei Province.

(II) Devotion to Rural Revitalization

QHD Port resolutely implements the rural revitalization strategy, earnestly implements the Opinions on Continuously Selecting and Dispatching the First Secretaries and Working Teams to Key Villages, the Administrative Measures for the Selection and Appointment of Village Cadres for Rural Revitalization in Hebei Province, and the deployment of the Hebei Provincial Party Committee and the Provincial Government on the key tasks of comprehensively promoting rural revitalization in 2023, aims to consolidate and expand the achievements of poverty alleviation, focuses on strengthening the endogenous development momentum of the assisted villages and poverty alleviation groups, and explores the path of rural revitalization in Shimenzi Village, Guanchang Township, Qinglong Manchu Autonomous County, Yangshugou Village, Shanwanzi Township, Weichang County and other places, and further improves the quality of life and happiness of villagers by implementing industrial assistance, consumption assistance, health assistance and village assistance.
