Recently, the Company received the Written Decision of Administrative Penalty of the National Administration of Financial Regulation (Jin Fa Jue Zi [2024] No. 1) (the "Administrative Penalty") from the National Administration of Financial Regulation (the "NAFR"), pursuant to which the NAFR concluded after its inspection that, among others, in 2020, a subsidiary of the Company used the investment assets derived from the utilization of insurance funds to extend loans to others, which violated the relevant provisions of the Insurance Law of the People's Republic of China. As a result, Mr. Li Gaofeng (who is now one of the Company's executive directors, being the then vice-general manager), who was responsible for management, was subject to a warning and a fine of RMB70,000.

The Company has conducted corresponding corrective measures in a timely manner after the inspection and will take this as a lesson to continuously enhance its legal and regulatory compliance. The Board considers that the Administrative Penalty has no material impact on the business operation and financial position of the Company.

Mr. Li Gaofeng has confirmed to the Company that save as disclosed in this announcement, there is no other information relating to him that is required to be disclosed pursuant to Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules and there is no other matter that needs to be brought to the attention of the shareholders of the Company.
