Dear Shareholders,

On behalf of Zhong An Group Limited (“**Zhong An**” or the “**Company**”) and its subsidiaries (together the “**Group**”), I am pleased to present the annual results of the Group for the year ended 31 December 2023 (“**2023**”).

REVIEW OF RESULTS

The audited consolidated revenue in 2023 was approximately RMB14,490.2 million, representing an increase of approximately 56.6% from that of 2022. The gross profit in 2023 was approximately RMB1,525.4 million and net profit was approximately RMB287.1 million, representing a significant increase by approximately 12 times from that of 2022. The profit attributable to owners of the parent company in 2023 was approximately RMB479.4 million, representing an increase of approximately 156.8% from that of 2022. The basic earnings per share was approximately RMB8.5 cents, representing an increase of approximately 156.8% from that of 2022. The board (the “**Board**”) of directors of the Company did not propose to declare a final dividend for the year 2023 (2022: Nil).

業績回顧

MARKET AND BUSINESS REVIEW

In the past year, faced with the complex international environment and frequent geopolitical conflicts, China withstood external pressure, overcame internal difficulties, continued to maintain a stable and positive development trend, and demonstrated strong economic resilience. After a period of recovery, the real estate industry in the post-pandemic period was still at the bottom and continued to adjust. Facing changes in the supply and demand relationship in the real estate market, the central government has timely optimized and adjusted real estate market control policies to further release rigid and improved demand for home purchases.

In the context of the industry-wide adjustments, Zhong An has demonstrated robust operational capacities, and maintained a reputation for stable operation over the years. Not only was it awarded the title of China's Excellent Enterprise in Real Estate Operation Safety in 2023, but it was also highly recognized by financial institutions and relevant government departments, and was included in the bank whitelist. In the complex and ever-changing market environment, the total sales revenue of the Group still ranked among the top 100 in the industry, with a continued improving ranking. The Company's cash flow was stable and key financial indicators remained at a green level. Under the guidance of "guaranteed property delivery" and with the goal of high-quality delivery, the first-day delivery rate of some projects reached 100%. Customer satisfaction has been much higher than the industry average, and industry influence has continued to increase, and the Company has been developing in a positive direction.

市場及業務回顧

在過去的一年裡，面對錯綜複雜的國際環境和頻發的地緣政治衝突，中國頂住外部壓力，克服內部困難，繼續保持了穩中向好的發展態勢，展現出強大的經濟韌性。後疫情時期的房地產行業經過一段時期的修復，仍在底部繼續調整。面對房地產市場供求關係的改變，中央政府適時優化調整樓市調控政策，進一步釋放剛性和改善性購房需求。

在行業深度調整的情況下，眾安的穩健經營能力凸顯，多年來保持穩健經營的口碑，不僅榮獲2023年中國房地產經營安全性優秀企業，還獲得了金融機構和政府相關部門的高度認可，並被列入銀行白名單。在複雜多變的市場環境中，本集團全口徑銷售額仍位列行業百強，且排名持續上升。企業現金流穩定，關鍵性財務指標始終保持綠檔；在「保交樓」的指引下，以高品質交付為目標，部分項目首日交付率達100%；客戶滿意度遠高於行業平均值，行業影響力持續提升，企業發展向好。

In the past year, the Group had a total of over 40 projects on sale in several cities and regions within the Zhejiang Province/Yangtze River Delta, maintaining a steady growth in contracted sales. For the year ended 31 December 2023, the Group recorded contracted sales of approximately RMB11.67 billion, the contracted sales area was approximately 616,000 sq.m., and the contracted average selling price was approximately RMB18,948 per sq.m.

As the real estate market enters an era of improvement in an all-round way, customer demand is gradually increasing. With the efforts of everyone at Zhong An, the Group has always maintained high-quality development requirements, strict standards, and high requirements. It has continuously strengthened its brand, optimized products, and improved services. It has achieved phased success in guaranteed property delivery and other aspects. It has continued to work hard to build a full life cycle service system of "Nine quality services for long-term living" and has strived to provide every customer with a system guarantee of "safe and secure living". All projects have been delivered on time, and many projects have achieved "100% handover rate upon the first-day visit", allowing Zhong An's "Better Life" to enter thousands of families.

In terms of finance, the Group continued to maintain the three red lines in "green" level and to keep financing cost at a low level, with stable overall operation. With solid financial data, the Company continued to rank as one of the "TOP10 Financial Stability for Listed Real Estate Companies in Hong Kong" and has been awarded the "TOP10 Investment Value for Listed Real Estate Companies in Hong Kong" for its strong development potential.

The Group established the Zhejiang Zhong An Charity Foundation (the "Foundation") in 2017 with the philosophy of "Charity from Zhong An and Love across the World (眾心向善，愛行天下)", focusing on serving the overall situation with one heart and one mind, with the goal of solidly promoting common prosperity, with the development of innovative public welfare as the driving force, and with the cultivation of a modern philanthropic culture as the direction, so as to give full play to Zhong An's role for the harmony and advancement of the society. In 2023, the Foundation made a comprehensive and in-depth layout in five major areas: education assistance, business philanthropy, humanistic care, emergency disaster relief, and rural revitalization. In the past year, a total of 27 charity activities were held, with more than RMB4.8 million in donations, directly benefiting more than 12,000 people, and more than 2 million indirect beneficiaries. The Foundation has also set up a charity workstation – Mass E Space – as a new integration attempt of public welfare + business. In the future, the Group will continue to work hand in hand with the Foundation and continue to be committed to fulfilling social responsibilities. It will also carry out more charity fundraising and social assistance, spread the power of love more broadly, and contribute Zhong An's power to building a more harmonious and beautiful society.

在過去的一年裡，本集團共有40餘個在售項目，主要分佈於浙江省內／長三角多個城市和地區，合約銷售保持平穩推進。截至2023年12月31日止年度，本集團錄得全年合同銷售金額約為人民幣116.7億元，全年合同銷售面積約61.6萬平方米，合同銷售均價約為每平方米人民幣18,948元。

隨著房地產市場全面步入改善時代，客戶需求逐步提高。在全體眾安人的努力下，本集團始終保持高質量的發展要求，嚴標準，高要求，不斷強化品牌力，優化產品力，提升服務力，在保交樓等方面都取得了階段性的成功。並堅持努力構建「九安久住」的全生命週期服務體系，全力為每位客戶提供「安心安住」的系統保障。所有項目均做到準時交付，多個項目實現「『首日到訪交付率』100%」，讓眾安式「美好生活」走進千家萬戶。

財務方面，三道紅線繼續保持「綠檔」，融資成本保持在較低水平，整體經營穩健。憑藉穩健的財務數據繼續蟬聯「在港上市房企財務穩健性TOP10」，並藉著強大的發展潛力，獲得「在港上市房企投資價值TOP10」的榮譽稱號。

本集團於二零一七年成立浙江眾安慈善基金會（「基金會」），以「眾心向善，愛行天下」為己任，聚力同心服務大局，已扎實推進共同富裕為目標，以創新公益發展為動力，以培育現代慈善文化為方向，為社會的和諧和進步發揮眾安的作用。2023年，基金會在教育助學、商業向善、人文關懷、應急救災、鄉村振興等五大領域進行了全面而深入的佈局。在過去的一年裡，一共舉辦了27場公益活動，支出善款逾480萬元人民幣，直接惠及超過1.2萬人次，間接受益人次超過200萬。基金會還設立了慈善愛心工作站—眾E空間，作為公益+商業的新融合嘗試。未來，本集團會將與基金會繼續攜手共進，持續致力於社會責任的履行。並將加強慈善募捐與社會救助的深度，讓愛的力量在更廣闊的天地中傳遞，為構建更加和諧美好的社會貢獻眾安力量。

In addition to its commitment to residential development, China New City Group Limited (“**China New City**”) (formerly known as “China New City Commercial Development Limited”), a subsidiary of the Company which is listed on The Stock Exchange of Hong Kong Limited (Stock Code: 1321), has officially changed its name to “China New City Group Limited” in 2023, uses its professional team to drive the diversified business development of its commercial operations, investment property and hotel management to create value-creating urban complexes in the city. In the past year, China New City actively integrated internal and external resources, expanded and developed various industry sectors, and initiated strategic cooperation with a number of well-known enterprises to accelerate urban regeneration and empower high-quality regional economic and social development.

In terms of commercial operations, the business types currently managed by the Group mainly include office buildings, shopping malls and community commercial complexes. In the past year, Zhong An Commercial has laid out new commercial life scenes in core cities such as Shanghai, Hangzhou, etc., with leasing business revenue increasing year-on-year. The overall rental rate of shopping malls was approximately 86%, the profitability has significantly improved, and the title of “Top 10 Enterprises in Commercial Property Operation in China 2023” and other honors were received during the year.

In terms of hotel operations, the hotels currently managed by the Group mainly include Holiday Inn Hangzhou Xiaoshan, Hangzhou Qiandao Lake Bright Resort Hotel, Ningbo Bright Hotel and Huaibei Bright Hotel. In the past year, benefiting from the increase in occupancy rates driven by the increase in travel of people from various places after the pandemic was relieved, the hotel occupancy rate was close to 70%, and the hotel management group's revenue and profits both exceeded the annual targets.

本公司附屬公司中國新城市集團有限公司（「**中國新城市**」）（前稱「中國新城市商業發展有限公司」，於香港聯合交易所有限公司上市（股份代號：1321））於2023年內正式更名為「中國新城市集團有限公司」，以其專業化團隊推進商業運營、投資物業及酒店管理多元化業務發展，積極打造為城市創造價值的城市綜合體。在過去的一年裡，中國新城市積極整合內外部資源，對各個產業進行拓展發展，並與多家知名企業展開戰略合作，加快推動城市更新，賦能區域經濟社會高質量的發展。

商業運營方面，本集團目前管理的業態主要包括寫字樓、購物商場及社區商業綜合體等。在過去的一年裡，眾安商業於上海、杭州等核心城市佈局全新商業生活場景，租賃業務收入同比增加。商場整體出租率大約86%，盈利能力得到顯著提升，並在年內獲得「2023中國商業地產運營十強企業」等殊榮。

酒店營運方面，本集團目前在管的酒店主要包括杭州蕭山假日酒店、杭州千島湖伯特度假酒店、寧波伯特酒店、淮北伯特酒店等。在過去的一年裡，得益於疫情放開後各地人員流動增加帶動入住率的提升，酒店入住率接近7成，酒管集團營收和利潤均超額完成年度目標。

In July 2023, the Group successfully spun off its property management company, Zhong An Intelligent Living Service Limited (“Zhong An Intelligent”), and listed it on the Main Board of the Hong Kong Stock Exchange. The Group has thus become a large-scale enterprise group with listed companies in real estate, commercial and property management sectors in Zhejiang Province. As a comprehensive property service provider with deep roots in the Yangtze River Delta, Zhong An Intelligent has been focusing on customer satisfaction for many years. It is committed to understanding customer needs, striving for excellence in services, and building a comprehensive service system under the “Zhong An” brand. In the past year, while strengthening basic services, Zhong An Intelligent has continued to expand its chain and business. In addition to providing many value-added services such as housekeeping and cleaning, it has continuously won the trust of customers with its high-quality services, and its area under management, expansion volume, revenue, and cash flow have all increased to a certain extent. As at 31 December 2023, Zhong An Intelligent has taken over a total of 27 new projects, with an additional area under management of approximately 4.20 million sq.m. The scale of the new community value-added business has continued to grow steadily, continued to be ranked among the “China’s Top 100 Property Management Service Providers”, and has been shortlisted for the TOP list by many authoritative organizations.

2023年7月，本集團成功分拆旗下物業管理公司「眾安智慧生活服務有限公司『眾安智慧』」於香港聯交所主板上市。本集團也因此成為浙江省內一家同時擁有房產、商業和物業管理上市公司的大型企業集團。作為一家深耕長三角的綜合物業服務提供商，眾安智慧多年以來一直以客戶滿意為中心，致力了解客戶需求，對服務精益求精，打造「眾安」品牌的全方面服務體系。在過去的一年裡，眾安智慧在夯實基礎服務的同時，不斷做長鏈條，做寬業務，除了提供家政及保潔等多項增值服務。憑藉高品質服務不斷贏得客戶信賴，在管面積、拓展數量、營收和現金流均得到一定程度提升。截至2023年12月31日，眾安智慧新增接管項目共計27個，新增在管面積約420萬方。新社區增值業務規模繼續保持穩定增長，並繼續蟬聯「中國物業服務百強企業」，入圍多家權威機構的TOP級榜單。

During the results period, the Group did not acquire any new land parcels. However, the Group will continue to implement a prudent land acquisition strategy in line with the current situation. While maintaining a sound financial position, the Group will make timely purchases of quality and lower-cost land that meets market demand and optimize its reserve structure. The Group will take practical actions to participate in the urban development process with an investment rhythm that suits our policies and ourselves. We will be a promoter of urban evolution and live in harmony with urban development and construction. As at 31 December 2023, the total GFA of the Group's land bank was approximately 8.63 million sq.m., mainly distributed in multiple different cities and regions in Yangtze River Delta and is expected to support the development of five years in the future. The average cost of the land was only approximately RMB2,977 per sq.m..

OUTLOOK AND DEVELOPMENT STRATEGY

After over two decades of rapid development, the real estate industry began to enter a new stage of development. With the loosening trend of property market policies in various cities, as well as the return of housing to its residential nature and the full implementation of long-term mechanisms, the real estate market has gradually returned to rationality, and the industry development model has fully returned to its essence. The era of enhancing competitiveness through product strength is opening up, and the competition among real estate companies is shifting from competition on speed to competition on quality.

業績期內，本集團並無新增土地面積。但本集團將繼續貫徹審時度勢的審慎的購地策略，在保持穩健的財政狀況下，適時購買符合市場需求、優質且較低成本的土地，優化儲備結構。本集團將以契合政策、契合自身的投資節奏，用實際行動參與到城市發展進程中。做城市進化的推動者，與城市發展建設和諧共生。截至2023年12月31日，本集團的土地儲備總建築面積約為863萬平方米，主要分佈在長三角多個不同的城市和地區，預計可支持未來五年的發展，樓面地價平均成本僅約每平方米人民幣2,977元。

前景展望與發展策略

經過二十逾年的高速發展，房地產行業開始步入新的發展階段。伴隨著各地樓市政策的寬鬆趨勢，以及住房回歸居住屬性和長效機制的全面落實，房地產市場已經逐漸回歸理性，行業發展模式全面回歸本質，以產品力提升競爭力的時代正在開啟，房企的競爭從競爭速度轉向競爭品質。

Management Discussion and Analysis

RESULTS

The consolidated revenue of the Group for the FY2023 was approximately RMB14,490.2 million, representing an increase of approximately 56.6% from that of the FY2022. The gross profit for the FY2023 was approximately RMB1,525.4 million, representing a decrease of approximately 38.3% from that of the FY2022. The profit attributable to owners of the parent for the FY2023 was approximately RMB479.4 million, representing an increase of approximately 156.8% from that of the FY2022. The basic earnings per share was approximately RMB8.5 cents (2022: approximately RMB3.3 cents).

INDUSTRY REVIEW

According to data from the National Bureau of Statistics of the PRC, in 2023, China's gross domestic product (GDP) reached RMB126,058.2 billion, representing a growth of 5.2% compared to the previous year calculated at constant prices. Faced with a complex and severe international environment and the arduous task of domestic reform, development, and stability, China has fully, accurately, and comprehensively implemented the new development philosophy, accelerated the construction of a new development pattern, focused on expanding domestic demand, optimising the structure, boosting confidence, and preventing and defusing risks. The economy has rebounded and shown positive signs, with steady improvement in supply and demand, active promotion of transformation and upgrading, solid progress in high-quality development, and the successful achievement of the main expected targets.

In 2023, nationwide real estate development investment amounted to RMB11,091.3 billion, representing a decrease of 9.6% compared to the previous year. Among them, residential investment amounted to RMB8,382 billion, representing a decrease of 9.3%. In 2023, the gross floor area ("GFA") of commodity properties sold was 1,117.4 million sq.m., representing a decline of 8.5% compared to the previous year. Among them, the decline of GFA of residential properties sold was 8.2%, while the decline of GFA of office building sold was 9.0%, and the decline of GFA of commercial business properties sold was 12.0%. The sales volume of commodity properties amounted to RMB11,662.2 billion, representing a decrease of 6.5%, with sales of residential properties decreasing by 6.0%, sales of office building decreasing by 12.9%, and sales of commercial business properties decreasing by 9.3%.

業績

行業回顧

據中國國家統計局的數據，2023年，中國國內生產總值達到人民幣1,260,582億元，按不變價格計算，比上年增長5.2%。面對複雜嚴峻的國際環境和艱巨繁重的國內改革發展穩定任務，中國完整、準確、全面貫徹新發展理念，加快構建新發展格局，著力擴大內需、優化結構、提振信心、防範化解風險，經濟回升向好，供給需求穩步改善，轉型升級積極推進，高品質發展紮實推進，主要預期目標圓滿實現。

2023年，全國房地產開發投資110,913億元，比上年下降9.6%；其中，住宅投資83,820億元，下降9.3%。2023年，商品房銷售面積111,735萬平方米，比上年下降8.5%，其中住宅銷售面積下降8.2%，辦公樓銷售面積下降9.0%，商業營業用房銷售面積下降12.0%。商品房銷售額116,622億元，下降6.5%，其中住宅銷售額下降6.0%，辦公樓銷售額下降12.9%，商業營業用房銷售額下降9.3%。

In 2023, the area under construction by property development enterprises amounted to 8,383.64 million sq.m., representing a decrease of 7.2% compared to the previous year. Among them, the area under construction of residential buildings was 5,898.84 million sq.m., representing a decrease of 7.7%. The newly started construction area of buildings amounted to 953.76 million sq.m., representing a decrease of 20.4%. Among them, the newly started construction area of residential buildings was 692.86 million sq.m., representing a decrease of 20.9%. The completed construction area of buildings amounted to 998.31 million sq.m., representing an increase of 17.0%. Among them, the completed construction area of residential buildings was 724.33 million sq.m., representing an increase of 17.2%. At the end of 2023, the area of commodity properties for sale amounted to 672.95 million sq. m., representing an increase of 19.0% compared to the previous year. Among them, the area of residential buildings for sale increased by 22.2%, the area of office buildings for sale increased by 17.7%, and the area of commercial business buildings for sale increased by 13.3%.

BUSINESS REVIEW

The recognised revenue of properties delivered by the Group in the FY2023 was approximately RMB13,692.1 million (2022: approximately RMB8,519.3 million), representing an increase of approximately 60.7%, which was mainly due to the increase in the total GFA of properties sold and delivered by the Group to approximately 718,117 sq.m. in the FY2023 from approximately 365,773 sq.m. in the FY2022, representing an increase of approximately 96.3%, and the corresponding amount of recognised revenue that can be counted in the FY2023 increased accordingly.

The recognised average selling price per sq.m. achieved by the Group in the FY2023 was approximately RMB19,066.7, representing a decrease of approximately 18.1% from approximately RMB23,291.2 for the FY2022.

International Office Center (IOC)

IOC is a large-scale integrated commercial complex located in Qianjiang Century City (錢江世紀城), Xiaoshan District, Hangzhou, which comprises serviced apartments, shopping malls and offices. LAND BANK

As at 31 December 2023, the total GFA of the Group's land bank was approximately 8.63 million sq.m., among which the total unsold or undelivered GFA of the completed properties projects was approximately 1.99 million sq.m. As at 31 December 2023, the average acquisition cost of the Group's overall land bank was approximately RMB2,977 per sq.m.

OTHER BUSINESS DEVELOPMENT

The Group's businesses have become increasingly diversified, which lays a solid foundation for more stable income and risk diversification in the future. The group will steadily advance its high-quality development strategic goals and light-asset operating management model. While solidifying the foundation of its real estate business, the Group has gradually expanded the scope of commercial operations, intelligent property management services, and other businesses, including not only hotel management, commercial operations, office building management, intelligent property management services and etc. and has continue to explore business development in the construction and capital sectors, so as to enhance the linkage and synergy among its upstream and downstream businesses in the real estate industry, and strive to maintain a good momentum of sustainable development.

HOTEL MANAGEMENT

There are currently four hotels under the Group's management, namely, Hangzhou Xiaoshan Holiday Inn Hotel, Hangzhou Qiandao Lake Bright Resort Hotel, Huaibei Bright Hotel, and Ningbo Bright Hotel. Among them, Ningbo Bright Hotel officially commenced operation in October 2019 and has been performing well. The Group recorded hotel operating revenue of approximately RMB257.9 million during the FY2023 (2022: approximately RMB221.7 million), representing a growth of approximately 16.3%. The hotels' overall occupancy rate for the FY2023 was approximately 69% (2022: approximately 56%).

土地儲備

其他業務發展

本集團業務日趨多元化，為未來創造更加穩定的收益及分散投資風險提供了保障基礎。本集團將穩步推進高品質發展戰略目標及輕資產運營管理模式，在紮實穩固房產業務基礎的同時，逐步擴展商業運營、智慧物業管理服務以及其他業務板塊的範圍，不但包括酒店管理、商業運營、辦公樓管理、智慧物業管理服務等，還持續開拓建築板塊以及資本板塊方面的業務發展，以增加房地產業上下游業務的相互聯動與協同，不懈努力維持企業可持續性發展的良好態勢。

酒店管理

本集團現有四間酒店正在營運，即杭州蕭山假日酒店、杭州千島湖伯瑞特度假酒店、淮北伯瑞特酒店及寧波伯瑞特酒店。其中寧波伯瑞特酒店於2019年10月正式開業，運營表現良好。本集團於2023財年錄得酒店經營收入約人民幣257.9百萬元（2022年：約人民幣221.7百萬元），增長約16.3%，而酒店綜合入住率約69%（2022年：約56%）。

COMMERCIAL OPERATIONS

For the FY2023, the Group's revenue from leasing business was approximately RMB110.7 million, representing an increase of approximately 9.1% as compared to approximately RMB101.5 million in the FY2022.

Currently, the Group's leasing income is mainly derived from Highlong Plaza, International Office Center (IOC), Yiwu Zhongan Square, Yuyao Zhongan Square, and the shopping units of Hidden Dragon Bay. Highlong Plaza consists of office buildings, a shopping center, a hotel, serviced apartments, and underground parking lots. The performance of the respective leasing properties has been satisfactory. The overall occupancy rate for the FY2023 was approximately 86% (2022: approximately 86%).

PROPERTY MANAGEMENT AND OTHER SERVICES

For the FY2023, the Group's revenue from property management and other services was approximately RMB429.5 million, representing an increase of approximately 5.3% as compared to RMB408.0 million in the FY2022. The Group provides high-quality property management and other services to the owners of properties developed by the Group and other developers. While solidifying the basic services, the Group continues to expand its business scope to provide value-added services, such as housekeeping and nanny services, and new services, such as beauty and washing, during the FY2023, which contributed to satisfactory revenue growth. By delivering high-quality services, the Group has gained the trust of its customers and managed to expand the property area under its management nationwide by continuously taking on new projects.

As the Group's businesses become increasingly diversified, the Group steadily advances its high-quality development strategic goals and light-asset operating management model. While maintaining a solid foundation of its real estate business, the Group has gradually expanded the scope of commercial operations, intelligent property management services, and other businesses. The Group not only extends its reach in hotel management, commercial operations, office building management, and intelligent property management services but also expands into modern agriculture, education and culture, film and entertainment, leisure tourism, and wellness industries to align with its overall industry development. The Group has also continued to explore business development in the construction and capital sectors to enhance the linkage and synergy among is upstream and downstream businesses in the overall real estate industry, has made unremitting efforts to maintain a good momentum of sustainable development.

商業運營

於2023財年物業管理及其他服務收入約人民幣429.5百萬元，較2022年的人民幣408.0百萬元增加約5.3%。本集團向本集團及其他開發商開發的物業業主提供優質的物業管理及其他服務。在夯實基礎服務的同時，不斷做長鏈條、做寬業務，除提供家政及保姆等服務外，於2023財年內還增設了洗美等增值服務，助力取得滿意的創收增速。憑藉提供高品質服務贏得客戶信賴，不斷新增接管專案，擴大全國在管面積規模。

隨著本集團業務日趨多元化，本集團穩步推進高品質發展戰略目標及輕資產運營管理模式。在紮實穩固房產業務基礎的同時，其已逐步擴展商業運營、智慧物業管理服務以及其他業務板塊的範圍。集團不但在包括酒店管理、商業運營、辦公樓管理、智慧物業管理服務等方面延伸推進現代農業、教育文化、影視娛樂、休閒旅遊及康養產業以配合全產業發展。集團還持續開拓建築板塊以及資本板塊方面的業務發展，以增加集團整體房地產業上下游業務的相互聯動與協同，不懈努力維持企業可持續性發展的良好態勢。

HUMAN RESOURCES

As at 31 December 2023, the Group employed a total of 5,017 staff (2022: 5,506 staff). In the FY2023, the staff cost of the Group was approximately RMB397.6 million (2022: approximately RMB447.2 million), representing a decrease of approximately 11.1%. The decrease was mainly due to the Group adopting a number of measures to reduce costs and increase efficiency, and optimising staff organisation according to business development. The employees' remuneration policy was determined with reference to factors such as remuneration information in respect of the local market, the overall remuneration standard in the industry, inflation level, corporate operating efficiency and performance of the employees. The Group conducts performance appraisal on a yearly basis for its employees, the results of which are taken into account of the annual salary review and promotion assessment. The Group's employees are considered for the entitlement of annual discretionary bonus according to certain performance conditions and appraisal results. To attract high calibre employees and solidify the management of the Group, eligible participants (including employee of the Group) may be granted options to subscribe for shares in the Company pursuant to the share option scheme adopted by the Company. The Group also provides continuous learning and training programmes to its employees to enhance their skills and knowledge, so as to maintain the attraction of the Company for talents and their competitiveness in the market.

DIVIDEND POLICY

The Company may distribute dividends by way of cash or by other means that the Board considers appropriate. Any proposed distribution of dividends is subject to the discretion of the Board and, where applicable, the approval of the shareholders of the Company (the "Shareholders"). The Board will consider various factors before declaring or recommending any payment of dividends. These factors include the results of operation of the business of the Group, the retained earnings and distributable reserves of the Company and each of the members of the Group, the Group's actual and expected financial performance, the general business conditions and strategies, the Group's expected working capital requirements and future expansion plans, the general economic conditions and business cycle of the Group's business, the future prospects of the business of the Group, Shareholders' interests, statutory and regulatory restrictions on the payment of dividend and other internal or external factors that the Board deems appropriate.

人力資源

於2023財年，本集團僱用員工5,017人（2022年：5,506人）。2023年，員工成本約人民幣397.6百萬元（2022年：約人民幣447.2百萬元），下降約11.1%，下降主要由於在回顧年度本集團採納了多項降本增效措施，根據業務發展優化人員組織。本集團的員工薪酬政策是參照當地市場薪資行情，結合市場同行業的整體薪資狀況、通脹水準、企業經營效益以及員工的績效等多方面因素而確定。本集團對僱員的表現每年作出一次審查，結果用於每年薪金審查及晉升評估。本集團的員工均會獲考慮根據若干表現條件及評核結果而獲發年度酌情花紅。為有利於引進高端人才和穩定本集團的管理層，合資格參與者（包括本集團員工）可根據本公司採納的購股權計劃獲授購股權以認購本公司股份。本集團亦向員工提供持續教育和培訓計劃，不斷提升員工的技能和知識，保持公司對人才的吸引力及人才的市場競爭力。

股息政策

FINANCIAL ANALYSIS

Revenue

For the year ended 31 December 2023, the Group recorded a total revenue of approximately RMB14,490.2 million, representing an increase of approximately 56.6% as compared to that of approximately RMB9,250.5 million in 2022. Among them, the revenue derived from the sale of properties had contributed and is expected to continually contribute to the vast majority of the Group's total revenue, accounting for approximately 94.5% of the total revenue for the year. The increase in the revenue was mainly due to the increase in the total GFA of the properties sold and delivered in 2023 as compared to that of 2022, and the corresponding increase in the amount of recognised revenue that can be counted in the FY2023.

Cost of sales

For the year ended 31 December 2023, the Group's cost of sales was approximately RMB12,964.8 million, representing an increase of approximately 91.2% as compared to that of RMB6,779.6 million in 2022. Such increase was mainly due to the increase in the total GFA of the properties sold and delivered in 2023 as compared to that of 2022.

Gross profit and Gross profit margin

For the year ended 31 December 2023, the Group recorded a gross profit of approximately RMB1,525.4 million, representing a decrease of approximately 38.3% as compared to that of approximately RMB2,470.9 million in the previous year. The gross profit margin was approximately 10.5%, which decreased by approximately 16.2 percentage points as compared to that of 2022. It was mainly due to the decrease in the average selling price recognised by the Group for the year as compared to the previous year.

Other income and gains

The other income and gains of the Group amounted to approximately RMB97.1 million for the year ended 31 December 2023, representing a decrease of approximately 69.0% as compared to that of approximately RMB313.7 million in 2022. This was mainly due to the fact that there was no one-time gain from re-measurement of investments in joint ventures in 2023, as well as a decrease in bank interest income and gain on disposal of items of property and equipment.

Selling and distribution expenses

The selling and distribution expenses increased by approximately 7.0% to approximately RMB337.8 million in 2023 from approximately RMB315.6 million in 2022. It was mainly due to the increase in sales and promotion expenses in 2023 as compared to that of the FY2022.

財務分析

收入

截至2023年12月31日止年度，本集團錄得總收入約人民幣14,490.2百萬元，較2022年度約人民幣9,250.5百萬元增加約56.6%。其中來自銷售物業的收入已構成及預期將繼續構成本集團收入總額的絕大部份，約佔年內收入總額的94.5%。收入增加的主要原因是本集團於2023年交付的物業總建築面積較2022年有所增加，從而可計入2023年確認收入的金額也相應增加。

銷售成本

截至2023年12月31日止年度，本集團銷售成本約人民幣12,964.8百萬元，較2022年度約人民幣6,779.6百萬元增加約91.2%。上升主要原因為於2023財年內交付的物業的面積較2022增長所致。

毛利及毛利率

截至2023年12月31日止年度，本集團錄得毛利約人民幣1,525.4百萬元，較2022年度約人民幣2,470.9百萬元減少約38.3%。毛利率約為10.5%，較2022年下降約16.2個百分點。主要是本集團本年確認的銷售均價較上年度降低所致。

其他收入及收益

截至2023年12月31日止年度，本集團錄得其他收入及收益約人民幣97.1百萬元，較2022年約人民幣313.7百萬元減少約69.0%。主要是由於2023年無重新計量於合營企業投資的一次性收益，以及銀行利息收入和出售物業及設備項目收益減少。

出售及分銷費用

出售及分銷費用由2022年約人民幣315.6百萬元上升約7.0%至2023年約人民幣337.8百萬元。主要是由於2023年度銷售及推廣費用較2022年同期有所增加。

Administrative expenses

Administrative expenses of the Group decreased by approximately 3.7% to approximately RMB589.3 million in 2023 from approximately RMB611.7 million in 2022. It was mainly as a result of the fact that the Group had adopted a number of measures to reduce costs and increase efficiency in 2023.

Other expenses

Other expenses of the Group decreased by approximately 35.8% to approximately RMB112.3 million in 2023 from approximately RMB174.9 million in 2022.

Finance costs

Finance costs of the Group decreased by approximately 12.4% to approximately RMB129.1 million in 2023 from approximately RMB147.3 million in 2022. The decrease was mainly due to the decrease in interest bearing liabilities in 2023.

Income tax expenses

Income tax expenses of the Group decreased by approximately 87.3% to approximately RMB164.1 million in 2023 from approximately RMB1,297.0 million in 2022. It was mainly due to the decrease of provision for LAT in 2023.

Capital structure

As at 31 December 2023, 5,635,809,800 shares in the Company were in issue (31 December 2022: 5,635,809,800 shares).

As at 31 December 2023, the Group had total assets of approximately RMB48,569.8 million (2022: approximately RMB59,096.9 million) which were financed by current liabilities of approximately RMB28,732.8 million (2022: approximately RMB36,497.7 million), non-current liabilities of approximately RMB6,881.7 million (2022: approximately RMB10,266.0 million) and shareholders' equity of approximately RMB12,955.2 million (2022: approximately RMB12,333.2 million).

As at 31 December 2023, the Group had aggregate cash and cash equivalents and restricted cash of approximately RMB2,897.5 million (2022: RMB6,633.4 million). The decrease was mainly as a result of effective utilisation of cash for settling interest-bearing borrowings during the FY2023.

行政費用

本集團行政費用由2022年約人民幣611.7百萬元下降約3.7%至2023年約人民幣589.3百萬元。主要是本集團於2023年度採納了多項降本增效措施。

其他費用

本集團其他費用由2022年約人民幣174.9百萬元下降約35.8%至2023年約人民幣112.3百萬元。

財務費用

本集團財務費用由2022年約人民幣147.3百萬元下降約12.4%至2023年約人民幣129.1百萬元。主要乃由於2023年度附息負債減少所致。

所得稅開支

本集團所得稅開支由2022年約人民幣1,297.0百萬元減少約87.3%至2023年約人民幣164.1百萬元。減少的主要原因為2023年度土地增值稅撥備減少所致。

資本結構

於2023年12月31日，本公司已發行股份為5,635,809,800股（2022年12月31日：5,635,809,800股）。

於2023年12月31日，本集團的資產總值約人民幣48,569.8百萬元（2022年：約人民幣59,096.9百萬元），由流動負債約人民幣28,732.8百萬元（2022年：約人民幣36,497.7百萬元）、非流動負債約人民幣6,881.7百萬元（2022年：約人民幣10,266.0百萬元）及股東權益約人民幣12,955.2百萬元（2022年：約人民幣12,333.2百萬元）提供資金。

For the FY2023, the total cost of borrowings of the Group was approximately RMB700.1 million (2022: approximately RMB868.2 million), and, among which, interests with an amount of approximately RMB576.7 million (2022: approximately RMB729.6 million) were capitalised.

The Group maintained a healthy liquidity position. The current ratio, being a ratio of total current assets to total current liabilities, was approximately 1.23 (2022: approximately 1.25) for the FY2023. The ratio of interest-bearing bank and other borrowings to total assets was approximately 0.17 (2022: approximately 0.25). The net gearing ratio of the Group (defined as net debt divided by total equity) was approximately 0.43 (2022: approximately 0.66) (net debt is defined as total interest-bearing bank and other borrowings less cash and cash equivalent and total restricted cash) for the FY2023. The Group always adopts a prudent financial policy in its operation and business development.

Capital commitments

As at 31 December 2023, the Group had capital commitments of approximately RMB5,535.8 million (2022: approximately RMB6,936.0 million) in respect of property and project development expenditure. It is expected that the Group will finance such commitments from its own funds, cash proceeds from sales and external financing (such as bank loans).

Contingent liabilities

As at 31 December 2023, the contingent liabilities of the Group were approximately RMB9,445.9 million (2022: approximately RMB11,107.8 million), which were guarantees provided by the Group in favour of certain banks for the grant of mortgage loans to buyers of the Group's properties.

Pledge of assets

As at 31 December 2023, investment properties with a carrying value of approximately RMB2,993.9 million (2022: approximately RMB213.3 million), properties under development of approximately RMB10,538.4 million (2022: approximately RMB29,021.6 million), completed properties held for sale of approximately RMB1,605.6 million (2022: approximately RMB628.7 million), property and equipment of approximately RMB1,081.6 million (2022: approximately RMB1,177.6 million) and restricted cash of approximately RMB208.0 million (2022: approximately RMB4.0 million) of the Group, and no equity interest in subsidiaries of the Group (2022: RMB60.0 million), were pledged to secure the banking facilities and other borrowings for the Group.

Foreign exchange risk

As the sales, purchase and external financing of the Group in the FY2023 and the FY2022 were made mainly in Renminbi, the foreign exchange risk exposed to the Group was relatively minor. The Group did not use foreign exchange hedging instruments to hedge foreign exchange risks in the FY2023 and the FY2022.

Interest rate risk

The interest rates of a certain portion of the Group's loans were floating. Upward fluctuations in interest rates will increase the interest cost of new loans and existing loans. Given that a certain portion of loans are RMB loans and the stable domestic economic situation of the PRC, the Group currently does not use derivative instruments to hedge its interest rate risks.

本集團部分貸款的利率為可變動的。利率向上波動將增加新貸款及現有貸款的利息成本。考慮到該部分貸款為人民幣貸款且中國國內經濟形勢穩定，因此本集團目前並無使用衍生金融工具以對沖其利率風險。

Corporate Governance Report

(A) CORPORATE CULTURE

The Board considered the continuous professional development participated and undertaken by the Directors are sufficient to discharge their duties.

The Company has arranged liability insurance for Directors and senior management of the Company with appropriate coverage in respect of legal action against them arising from their duties performed.

Save as disclosed in the section headed “Biographical Details of Directors and Senior Management” in this annual report, there are no relationships (including financial, business, family or other material/relevant relationships) among members of the Board.

Functions of the Board and the Senior Management

The Board is responsible for providing effective and responsible leadership for the Group. The Board is responsible for formulating the Group's overall objectives and strategies, monitoring and evaluating its operating and financial performance and reviewing the corporate governance standard of the Group. It also decides on matters such as annual and interim results, accounting policies, proposal of declaration of dividends, major transactions, appointment or re-appointment of Directors after considering, when necessary and appropriate, the recommendations from the committees established by the Board.

Senior management is delegated by the Board with the responsibility for the execution of the business plans and strategies adopted by the Board, assisting the Board in the preparation of the financial statements for approval by the Board, the establishment of adequate procedures put forward by the Board and/or the committees established by the Board and reporting regularly to and seeking approval from the Board on important matters from time to time.

Appointment, re-election and removal of Directors

The Articles provide that any Director appointed by the Board to fill a casual vacancy in the Board or as an additional member of the Board shall hold office only until the next following general meeting of the members of the Company and shall then be eligible for re-election at such meeting.

In accordance with the Articles, at each annual general meeting, one third of the Directors for the time being, shall retire from office by rotation provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years and, being eligible, offer themselves for re-election. The Shareholders may, at any general meetings convened and held in accordance with the Articles, remove a Director by ordinary resolution at any time before the expiration of his/her period of office notwithstanding anything contrary in the Articles or in any agreement between the Company and such Director and may by ordinary resolution elect another person in his/her stead.

Board Committees

The Board has established four committees and has delegated various responsibilities to the committees, including the remuneration committee (the “**Remuneration Committee**”), the nomination committee (the “**Nomination Committee**”), the audit committee (the “**Audit Committee**”) and the governance committee (the “**Governance Committee**”). All the Board committees perform their distinct roles in accordance with their respective terms of reference which are available for inspection by Shareholders on the Company’s website. The Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances, at the Company’s expense.

(E) CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Code provision C.2.1 of the CG Code stipulates that the roles of chairman and chief executive should be separate and should not be performed by the same individual. The division of responsibilities between the chairman and chief executive should be clearly established and set out in writing.

As at the date of this annual report, the positions of chairman and chief executive officer are held by Mr Shi Zhongan and Mr Zhang Jiangang respectively. Mr Shi Zhongan, is our chairman and executive Director. He is primarily responsible for the strategic and development planning of the Group. He also supervises project planning and the overall business operation. Mr Zhang Jiangang is our chief executive officer and executive Director. He focuses on the Company's business development and daily management and operations generally. The respective responsibilities of Mr Shi Zhongan and Mr Zhang Jiangang are clearly defined and set out in writing.

The Company has established a general division of responsibilities between the chairman and chief executive officer in writing. Further, the roles of chairman and chief executive officer are separated and performed by different individuals. In this connection, the Board is of the opinion that the Company has complied with the code provision C.2.1 sets out in the CG Code as at 31 December 2023.

The Board believes that the balance of power and authority is sufficiently maintained by the operation of the Board, comprising the executive Directors and independent non-executive Directors.

The chairman had held a meeting with all independent non-executive Directors in the absence of executive Directors. No specific or other issues had been raised or discussed as it had been concluded that all issues which would be discussed had been properly dealt with in the meetings of the Board.

(E) 主席及首席執行官

All independent non-executive Directors possess extensive academic, professional and industry expertise and management experience and have provided their professional advice to the Board.

(G) REMUNERATION COMMITTEE

The chairman of the Remuneration Committee is Professor Pei Ker Wei (an independent non-executive Director) and the members are Ms Shen Tiaojuan (an executive Director), Ms Jin Ni (an executive Director), Mr Zhang Huaqiao (an independent non-executive Director) and Mr Fung Che Wai Anthony (an independent non-executive Director).

The Company has adopted written terms of reference for the Remuneration Committee. The role and function of the Remuneration Committee include the following:

- (a) to make recommendations to the Board on the Company's policy and structure for all remuneration of Directors and senior management and on the establishment of a formal and transparent procedure for developing remuneration policy;
- (b) to have the delegated responsibility to determine the specific remuneration packages of all executive Directors and senior management, including benefits in kind, pension rights and compensation payments, including any compensation payable for loss or termination of their office or appointment, and make recommendations to the Board of the remuneration of non-executive Directors;
- (c) to review and approve performance-based remuneration by reference to corporate goals and objectives resolved by the Board from time to time;
- (d) to review and approve the compensation payable to executive Directors and senior management in connection with any loss or termination of their office or appointment to ensure that such compensation is determined in accordance with relevant contractual terms and that such compensation is otherwise fair and not excessive for the Company;

(F) 獨立非執行董事

(G) 薪酬委員會

本公司已書面訂明薪酬委員會的職權範圍。薪酬委員會的角色及職能如下：

- (a) 就董事及本公司高級管理人員的全體薪酬政策及架構，及就設立正規透明的程序制訂此等薪酬政策，向董事會提出建議；
- (b) 獲董事會轉授職責釐訂全體執行董事及高級管理人員的特定薪酬待遇，包括實物利益、退休金權利及補償金額(包括喪失或終止職務或委任的補償)，並就非執行董事的薪酬向董事會提出建議；
- (c) 透過參照董事會不時通過的公司目的和目標，檢討及批准按表現而釐定的薪酬；

- (f) to ensure that no Director or any of his/her associates is involved in deciding his/her own remuneration;
- (g) to review and/or approve matters relating to share schemes under Chapter 17 of the Listing Rules; and
- (h) to review and approve the remuneration report of the Group, if any.

The basis of the emolument payable to the Directors (including independent non-executive Directors) is determined with reference to the range of prevailing directors' fee for director of listed companies in Hong Kong and is subject to the approval of the Remuneration Committee. The Remuneration Committee will consider factors such as salaries paid by comparable companies, time commitment, experience and responsibilities of the Directors, employment conditions elsewhere in the Group and desirability of performance-based remuneration.

1 meeting of the Remuneration Committee was held during the year ended 31 December 2023. The Remuneration Committee had reviewed the remuneration policy of the Group, assessed the performance of all Directors and their terms of employment under their respective service contracts and (if applicable) their renewal. In fulfilling its roles and functions, the Remuneration Committee had ensured that no Director or any of his/her associates was involved in deciding his/her own remuneration. No material matters relating to share schemes under Chapter 17 of the Listing Rules were required to be reviewed or approved by the Remuneration Committee.

The individual attendance of each member of the Remuneration Committee was as follows:

- (c) to review the board diversity policy of the Company (the **“Diversity Policy”**) and the progress on achieving the objectives set for implementing the Diversity Policy, and to make disclosure of its review results in the corporate governance report of the Company’s annual report;
- (d) to assess the independence of the independent non-executive Directors;
- (e) to make recommendations to the Board on relevant matters relating to, among others, the appointment or re-appointment of Directors and succession planning for Directors (in particular, the chairman and the chief executive officer of the Company);
- (f) to give full consideration to, among others, the skills and expertise required from members of the Board and the relevant requirements of the Listing Rules with regard to Directors and such like in the discharge of the Nomination Committee’s duties;

The determination and review by the Board during the year ended 31 December 2023 of the Diversity Policy involved the consideration of various elements including gender, age, culture, qualification, ability, work experience, leadership and professional ethics of the candidates and against the objective criteria set out by the Board. The Board recognises the importance of having a diverse Board and considers the above essential elements (which have been taken into account when determining the existing composition of the Board) in maintaining a competitive advantage and achieving sustainable growth for the Group.

To ensure the composition of the Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business, the Company has, with the recommendation of the Nomination Committee, adopted a formal, considered and transparent procedures for the selection, appointment and re-appointment of Directors.

The criteria adopted by the Nomination Committee in selecting and approving candidates for directorship are based on the Diversity Policy including whether the candidates are appropriate in terms of experience and the potential contribution to the Group and with reference to the candidates' professional knowledge, industry experience, personal ethics, integrity and skills, as well as the ability of the candidates to devote sufficient time to the Board and/or various committees established by the Board on which they serve so as to allow them to benefit from the skills, expertise, and varied backgrounds and diversity of the candidates through their participation in the meetings of the Board and/or committees established by the Board.

If a candidate is proposed to be appointed as an independent non-executive Director (INED), his or her independence shall be assessed in accordance with, among other things, the factors (including independence criteria) as set out in Rule 3.13 of the Listing Rules, subject to any amendments as may be made by the Stock Exchange from time to time. Where applicable, the totality of the candidate's education, qualifications and experience shall also be evaluated to consider whether he/she has the appropriate professional qualifications or accounting or related financial management expertise for filling the office of an INED with such qualifications or expertise as required under Rule 3.10(2) of the Listing Rules.

If a candidate is a member of the Nomination Committee, he/she will abstain from voting at the meeting of the Nomination Committee when his/her own nomination is being considered.

2 meetings of the Nomination Committee were held during the year ended 31 December 2023. The Nomination Committee made recommendation to the Board on the re-election of Directors retiring at the 2023 annual general meeting, reviewed the structure, size and composition of the Board, and reviewed the implementation and effectiveness of the Diversity Policy during the year ended 31 December 2023.

These mechanisms in place are subject to annual review by the Board, including without limitation:

- (a) the Nomination Committee will assess the independence, qualification and time commitment of a candidate who is nominated to be a new independent non-executive director before appointment and also the continued independence of the independent non-executive Directors and their time commitments annually;
- (b) the Nomination Committee will conduct performance evaluation of the independent non-executive Directors annually to assess their contributions;

The Board has conducted an annual review of the implementation and effectiveness of these mechanisms and considered that they are satisfactorily implemented and are effective.

(M) BOARD DIVERSITY POLICY

The Company has adopted the Diversity Policy which sets out the approach to achieve diversity of the Board. The Company recognises the importance of having a diverse Board and embraces the benefits of having a diverse Board to maintain a competitive advantage and achieve sustainable growth for the Group.

All Board appointments will be based on meritocracy, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board. Selection of candidates for directorship will be based on a range of diversity perspectives based on the Diversity Policy, including but not limited to gender, age, culture, qualification, ability, work experience, leadership and professional ethics and against the objective criteria set out by the Board.

The Nomination Committee of the Board will disclose the composition of the Board in the corporate governance report of the Company every year and supervise the implementation of the Diversity Policy. The Nomination Committee will review the progress on achieving the objectives set for implementing the Diversity Policy annually to ensure the continued effectiveness of the Board, and will make disclosure of its review results in the corporate governance report of the Company.

The Company has reviewed the composition, membership and structure of the Board, and is of the opinion that the Board has an appropriate mix of skills, experience and diversity that are relevant to the Company's strategy, business and governance and to enable the Company to maintain high standard of operation. The Company is conscious of maintaining Board diversity with an appropriate level of female representation on the Board. During the year ended 31 December 2023 and up to the date of this annual report, the Board had three female members and it considers that the current gender diversity on Board level is satisfactory. The Company has implemented comprehensive programmes aimed at identifying and training on female employees who display leadership and potential, with the goal of promoting them to the senior management of the Group and developing a pipeline of potential successors to the Board.

As at 31 December 2023, the Group had a balanced gender ratio in its workforce (including senior management) of 41:59 (female:male). The Board considers that the current gender ratio in the Group's workforce (including senior management) is appropriate for its operations and the Group will aim to continue to maintain gender diversity in its workforce.

(N) DIRECTORS' RESPONSIBILITIES IN PREPARING THE ACCOUNTS

The Directors acknowledge that they are responsible for the preparation of accounts which give a true and fair view of the Company and the Group.

The statement of the auditor of the Company about its reporting responsibilities on the accounts of the Group is set out in the section headed "Independent Auditor's Report" in this annual report.

(O) INTERNAL CONTROL AND RISK MANAGEMENT

The Board is responsible for maintaining sound and effective internal control and risk management systems over the Group's asset and Shareholders' interests, as well as for reviewing such systems' effectiveness on an annual basis. Such systems are designed to provide reasonable, but not absolute, assurance against misstatement or loss, and to manage risks of failure in the Group's operational systems. The systems include a well-established organisational structure with clearly defined lines of responsibility and authority, which is designed to safeguard assets from inappropriate use, maintain proper accounts and ensure compliance with applicable laws and regulations. Regular reviews and internal audits are carried out to monitor compliance with internal control procedures focusing on those areas of the Group's activities with the greatest perceived risk.

For the year ended 31 December 2023, the Board along with the Audit Committee have reviewed the effectiveness of the Group's internal control and risk management systems and were of the view that the Group's internal control and risk management systems were effective and adequate. Such review had covered all material controls including financial, operational and compliance controls and risk management functions.

The Board and the Audit Committee have also reviewed the adequacy of resources, staff qualifications and experience, training programmes and budget of its accounting, internal audit and financial reporting functions for 2023 and are satisfied with the results.

The Group also adopts procedures to manage the handling and dissemination of inside information, so as to ensure that inside information remains confidential until the disclosure of such information is appropriately approved, and the dissemination of such information is efficiently and consistently made.

(P) COMPANY SECRETARY

Mr Pang Heung Fai is the company secretary and chief financial officer of the Company. The company secretary of the Company supports the Board by ensuring good and fluent information communication and that the board policies and procedures are strictly followed. The company secretary is also responsible for advising the Board on governance matters and facilitating the induction and professional development of Directors.

Mr Pang has around 15 years of experience in holding senior financial management positions in a couple of Hong Kong and overseas listed companies of different industries, and is a fellow member of the Association of Chartered Certified Accountants (FCCA). During the year, Mr Pang has taken no less than 15 hours of relevant professional training.

(Q) SHAREHOLDERS' RIGHTS

Convening extraordinary general meeting and putting forward proposals at Shareholders' meetings

Pursuant to article 64 of the Articles, an extraordinary general meeting shall be convened on the written requisition of one or more Shareholders made to Directors or the company secretary specifying the objects of the meeting, provided that such requisitionists held as at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company which carries the right of voting at general meetings of the Company. Such meeting shall be held within 2 months after the deposit of such requisition. If the Board does not within 21 days from the date of deposit of the requisition proceed duly to convene the meeting, the requisitionist(s) themselves may convene the extraordinary general meeting in the same manner and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to them by the Company.

Pursuant to article 113 of the Articles, if a Shareholder, who is entitled to attend and vote at the relevant general meeting, wishes to nominate a person (not being the nominating Shareholder) to stand for election as a Director, he or she should lodge to the company secretary notice in writing of the intention to propose a person for election as a Director and notice in writing by that person of his/her willingness to be so elected at least 7 clear days before the date of such general meeting and the period for lodgement of such notices shall commence no earlier than the day after the despatch of the notice of such general meeting appointed for such election and shall be at least 7 clear days in length.

(P) 公司秘書

3. Maximum number of Shares available for subscription:

The maximum number of Shares which may be allotted and issued upon exercise of all outstanding options granted and yet to be exercised under the Scheme and any other share option schemes adopted by the Group shall not exceed 30% of the share capital of the Company in issue from time to time.

Subject to the rules of the Scheme, the Company may seek approval of its Shareholders in general meeting to refresh the General Scheme Limit (as referred to in paragraph 4 below) provided that the total number of Shares which may be allotted and issued upon exercise of all options to be granted under the Scheme and any other share option scheme(s) of the Group must not exceed 10% of the Shares in issue as at the date of approval of the refreshed limit. For the purpose of calculating the refreshed limit, such options (including those outstanding, cancelled, lapsed or exercised in accordance with the Scheme and any other share option scheme(s) of the Group) previously granted under the Scheme and any other share option scheme(s) of the Group will not be counted.

As disclosed in the announcement dated 12 October 2017, the Bonus Issue (details of which are contained in the Company's circular dated 8 September 2017) was made on the basis of one Bonus Share for every one existing Share held by qualifying Shareholders whose names are on the register of members of the Company on the record date (that is, 4 October 2017). As at the record date, the Company had 2,918,298,400 Shares in issue and, accordingly, an aggregate of 2,918,298,400 bonus Shares were issued under the bonus issue on 12 October 2017 on the above basis. As a result of the bonus issue, the exercise price of such outstanding options and the number of Shares to be allotted and issued upon full exercise of the subscription rights attaching thereto were adjusted pursuant to the terms of the Scheme. On 12 October 2017, the adjusted number of Shares that can be subscribed for upon exercise of the outstanding options in full immediately after the bonus issue was 360,933,322 Shares.

PRINCIPAL RISKS AND UNCERTAINTIES

ENVIRONMENTAL POLICIES AND PERFORMANCE

The Company strives to balance business growth with environmental protection.

As the major businesses of the Group are property development, leasing and hotel operation in China, we (i) evaluate, manage and mitigate from time to time environmental issues within the context of the Group's business activities and objectives for the conservation of energy and other natural resources; (ii) devise environmental policies and measures for the Group so as to keep them in line with the standards required under the applicable laws, rules and regulations to the extent practicable; and (iii) apply our philosophy on environment protection to our supply chain and operations. These include but not limited to the scrutiny in the selection of our business partners or services providers and award the bids of construction and other projects of which the Group is involved to reputable and environmentally-conscientious corporations and contractors with good compliant and environmental records.

Several hotels as operated by the Group have been promoting environmental protection policies for energy management, water management and waste management to minimize the ecological footprint of the hotel operation for years. To name a few, all lightings and appliances will be replaced in phases by energy saving ones. Guest rooms have room card insert energy saving switches and reduction in paper usage in the office and promote storage of files in electronic forms instead of in paper files. On the front of our leasing business, we are careful in the selection of our lessees and implemented environmental policies and measures in the operation of leasing business, including the management of the properties leased by the Group.

The Group has also implemented energy saving practices in the workplace through (i) appropriately designing, constructing, maintaining and, if required, modifying facilities wherever applicable; (ii) using or to replacing gradually existing appliances with more energy efficient appliances for lighting, heating and ventilation systems to reduce energy consumption and (iii) raising awareness of environmental protection at workplace.

During the year under review, there had been no record of material breach or violation by the Group of applicable environmental laws, rules or regulations.

本公司竭力在業務增長與環境保護之間達成平衡。

由於本集團的主要業務為在中國從事物業開發、租賃及酒店經營，本集團(i)不時評估、管理及減輕其業務活動及目標中存在環境問題以保護能源及其他自然資源；(ii)在可行情況下制定本集團的環境政策及程序以符合適用法律、規則及條例規定的標準；及(iii)針對供應鏈及業務經營應用本集團的環保理念，包括但不限於在遴選業務夥伴及服務提供商時進行審查，將本集團參與的建設項目及其他項目的投標機會授予具有環保意識、合規及環保記錄良好的著名公司及承建商。

本集團運營的多家酒店一直就能源管理、用水管理及廢棄物管理推行環保政策，以最大限度地減少酒店經營造成的生態足跡。例如，所有照明及電器設備均將分階段由節能設備取代。客房配備房卡插入式節能開關，並減少辦公室用紙及提倡以電子方式而非紙質文檔備存文件。租賃業務方面，本集團審慎選擇承租人，並在租賃業務經營過程中（包括本集團已租出物業的管理）執行環保政策及措施。

1. CORPORATE AND GROUP INFORMATION

ZHONG AN GROUP LIMITED (formerly known as Zhong An Real Estate Limited) (the “Company”) is a limited liability company incorporated as an exempted company in the Cayman Islands on 13 March 2007 under the Companies Law (revised) of the Cayman Islands. The registered office address of the Company is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands.

The Company and its subsidiaries (together, the “Group”) are principally engaged in property development, property leasing and hotel operations. The Group’s property development projects during the year were mostly located in Zhejiang, Anhui, Jiangsu, Shandong and Yunnan provinces, the People’s Republic of China (the “PRC”). There were no significant changes in the nature of the Group’s principal activities during the year.

In the opinion of the Company’s directors (the “Directors”), the holding company and the ultimate holding company of the Company is Whole Good Management Limited, a company incorporated in the British Virgin Islands on 3 May 2007. Whole Good Management Limited is wholly owned by Mr. Shi Zhongan, the Chairman of the Company.

2.1 Basis of preparation

These financial statements have been prepared in accordance with International Financial Reporting Standards (“IFRSs”), which comprise standards and interpretations approved by the International Accounting Standards Board (the “IASB”), and International Accounting Standards and Standing Interpretations Committee interpretations approved by the International Accounting Standards Committee and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for investment properties, investment properties classified as held for sale, equity investments designated at fair value through other comprehensive income and financial assets at fair value through profit or loss which have been measured at fair value as explained in the accounting policies set out below. These financial statements are presented in Renminbi (“RMB”) and all values are rounded to the nearest thousand except when otherwise indicated.

Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries for the year ended 31 December 2023. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in associates and joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses.

The Group's share of the post-acquisition results and other comprehensive income of associates and joint ventures is included in the consolidated statement of profit or loss and consolidated other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate and joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its joint ventures are eliminated to the extent of the Group's investments in the joint ventures, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates or joint ventures is included as part of the Group's investments in associates or joint ventures.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

When an investment in an associate or a joint venture is classified as held for sale, it is accounted for in accordance with IFRS 5 *Non-current Assets Held for Sale and Discontinued Operations*.

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable assets acquired and liabilities assumed. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

Fair value measurement

The Group measures its investment properties and equity investments at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset, unless the asset is carried at a revalued amount, in which case the impairment loss is accounted for in accordance with the relevant accounting policy for that revalued asset.

Property and equipment and depreciation

Property and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Where parts of an item of property and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress is stated at cost less any impairment losses, and is not depreciated. It is reclassified to the appropriate category of property and equipment when completed and ready for use.

Investment properties

Investment properties are interests in land and buildings (including right-of-use assets) held to earn rental income and/or for capital appreciation. Investment properties comprise completed investment properties and investment properties under construction. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

The Group determines whether completed properties held for sale and properties under development would be transferred to investment properties when, only when, there is a change in use, evidenced by the following criteria: (a) the Group has prepared a business plan that reflects the future rental income generated by the property and this is supported with evidence that there is demand for rental space; (b) the Group can demonstrate that it has the resources, including the necessary financing or capital, to hold and manage an investment property; (c) the change in use is legally permissible; (d) if the property must be further developed for the change in use, the development has commenced and (e) the change in use is approved by the board.

Properties under development

Properties under development are stated at the lower of cost and net realisable value and comprise land costs, construction costs, borrowing costs, professional fees and other costs directly attributable to such properties incurred during the development period.

Properties under development which are already under construction or expected to be under construction within twelve months or have an explicit business plan for construction are classified as current assets. Other properties under development are classified as non-current assets.

Other intangible assets (other than goodwill)

Other intangible assets acquired separately are measured on initial recognition at cost. The cost of other intangible assets acquired in a business combination is the fair value at the date of the acquisition. The useful lives of other intangible assets are assessed to be either finite or indefinite. Other intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the other intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each reporting period.

After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

The Group applies the short-term lease recognition exemption to its short-term leases of machinery and equipment (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of office equipment and laptop computers that are considered to be of low value.

Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in revenue in the statement of profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. The classification is determined on an instrument-by-instrument basis.

Gains and losses on these financial assets are never recycled to the statement of profit or loss. Dividends are recognised as other income in the statement of profit or loss when the right of payment has been established, except when the Group benefits from such proceeds as a recovery of part of the cost of the financial asset, in which case such gains are recorded in other comprehensive income. Equity investments designated at fair value through other comprehensive income are not subject to impairment assessment.

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value recognised in the statement of profit or loss.

This category includes equity investments which the Group had not irrevocably elected to classify at fair value through other comprehensive income. Dividends on the equity investments are also recognised as other income in the statement of profit or loss when the right of payment has been established.

Impairment of financial assets

The Group recognises an allowance for expected credit losses (“ECLs”) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information. The Group considers that there has been a significant increase in credit risk when contractual payments are more than 30 days past due.

一般方法

於各報告日期，本集團評估金融工具的信貸風險自初步確認起是否已顯著增加。於評估時，本集團將於報告日期金融工具發生的違約風險與初步確認日起金融工具發生的違約風險進行比較，並考慮在無需付出過多成本或努力下即可獲得的合理及有理據的資料，包括過往經驗及前瞻性資料。本集團認為，當合約付款逾期超過30天時，則信貸風險已顯著增加。

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

Stage 1 – Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs

Stage 2 – Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs

Stage 3 – Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

除應收貿易款項應用下文所詳述之簡化方式外，按攤銷成本計量之金融資產須按一般方法進行減值，並於下列計量預期信貸虧損之階段進行分類。

Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For trade receivables that contain a significant financing component and lease receivables, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

Financial liabilities

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as loans and borrowings, or payables, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade and other payables, amounts due to related companies, lease liabilities and interest-bearing bank and other borrowings.

簡化方法

就並不包含重大融資成分或本集團已就此應用不調整重大融資成分影響的可行權宜方法的貿易應收款項而言，本集團於計算預期信貸虧損時應用簡化方法。根據簡化方法，本集團並無追溯信貸風險變動，而是根據各報告日期的全期預期信貸虧損確認虧損撥備。本集團已設立根據其過往信貸虧損經驗計算的撥備矩陣，並按債務人的特定前瞻性因素及經濟環境作出調整。

就包含重大融資成分的貿易應收款項以及應收租賃款項而言，本集團於計算預期信貸虧損時，根據上文所述政策採納簡化方法作為其會計政策。

金融負債

Financial liabilities at amortised cost (trade and other payables, and borrowings)

After initial recognition, trade and other payables, and interest-bearing borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial guarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contracts at the higher of: (i) the ECL allowance determined in accordance with the policy as set out in "Impairment of financial assets"; and (ii) the amount initially recognised less, when appropriate, the cumulative amount of income recognised.

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the weighted average basis. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and on disposal.

Cash and cash equivalents

Cash and cash equivalents in the statement of financial position comprise cash on hand and at banks, and short-term highly liquid deposits with a maturity of generally within three months that are readily convertible into known amounts of cash, subject to an insignificant risk of changes in value and held for the purpose of meeting short-term cash commitments.

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and at banks, and short-term deposits as defined above, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the Group expects some or all of a provision to be reimbursed, the reimbursement is recognised as a separate asset, but only when the reimbursement is virtually certain. The expense relating to a provision is presented in the statement of profit or loss net of any reimbursement.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the statement of profit or loss.

A contingent liability recognised in a business combination is initially measured at its fair value. Subsequently, it is measured at the higher of (i) the amount that would be recognised in accordance with the general policy for provisions above; and (ii) the amount initially recognised less, when appropriate, the amount of income recognised in accordance with the policy for revenue recognition.

Employee retirement benefits

Pursuant to the relevant regulations of the PRC government, the companies comprising the Group operating in Chinese Mainland (the “PRC group companies”) have participated in a local municipal government retirement benefit scheme (the “Scheme”), whereby the PRC group companies are required to contribute a certain percentage of the salaries of their employees to the Scheme to fund their retirement benefits. The only obligation of the Group with respect to the Scheme is to pay the ongoing contributions under the Scheme. Contributions under the Scheme are charged to the statement of profit or loss as incurred. Contributions paid to the Scheme for an employee are not available to reduce the Group’s future obligations to the Scheme even if the employee leaves.

Employee benefits to all eligible employees of the overseas subsidiaries are made in accordance with the rules set forth in the collective labor agreement, and recorded as an expense in the period they are due as a charge to the statement of profit or loss.

Income tax

Income tax comprises current and deferred tax and land appreciation tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to the statement of profit or loss over the expected useful life of the relevant asset by equal annual instalments or deducted from the carrying amount of the asset and released to the statement of profit or loss by way of a reduced depreciation charge.

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in IFRS 15.

(a) Revenue from the sales of properties

For property development and sales contracts for which the control of the property is transferred at a point in time, revenue is recognised when the purchasers obtain the physical possession or the legal title of the completed properties and the Group has the present right to payment from the purchasers.

(b) Revenue from hotel operation

Revenue from hotel operation is derived from room rental, food and beverage sales and income from the provision of other ancillary services, and is recognised when the services are rendered.

Revenue from property management and other services is recognised over the scheduled period on a straight-line basis because the customer simultaneously receives and consumes the benefits provided by the Group.

Revenue from other sources

Rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

Share-based payments

The Company operates a share option scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services in exchange for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees for grants after 7 November 2002 is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an external valuer using a binomial model, further details of which are given in note 34 to the financial statements.

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the statement of profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Where funds have been borrowed generally and used for the purpose of obtaining qualifying assets, a capitalisation rate of 4.96% (2022: 3.72%) has been applied to the expenditure on the individual assets.

Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting.

Interim dividends are simultaneously proposed and declared. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

Foreign currencies

The functional currency of the Company is the Hong Kong dollar ("HK\$"), and the functional currencies of subsidiaries incorporated outside Chinese Mainland are the "HK\$", the United States dollar ("US\$") and the Great Britain Pound ("GBP"), respectively. The functional currency of Chinese Mainland subsidiaries is the RMB. As the Group mainly operates in Chinese Mainland, the RMB is used as the presentation currency of the Group. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss with the exception of monetary items that are designated as part of the hedge of the Group's net investment of a foreign operation. These are recognised in other comprehensive income until the net investment is disposed of, at which time the cumulative amount is reclassified to the statement of profit or loss. Tax charges and credits attributable to exchange differences on those monetary items are also recorded in other comprehensive income.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of non-PRC established subsidiaries are currencies other than the RMB. As at the end of the reporting period, the assets and liabilities of these entities are translated into RMB at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into RMB at the exchange rates that approximate to those prevailing at the dates of the transactions.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve, except to the extent that the differences are attributable to non-controlling interests. On disposal of a foreign operation, the cumulative amount in the reserve relating to that particular foreign operation is recognised in the statement of profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of non-PRC established subsidiaries are translated into RMB at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of non-PRC established companies which arise throughout the year are translated into RMB at the weighted average exchange rates for the year.

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

(i) Property lease classification – Group as a lessor

The Group has entered into commercial property leases on its investment property portfolio. The Group has determined, based on an evaluation of the terms and conditions of the arrangements, such as the lease term not constituting a major part of the economic life of the commercial property and the present value of the minimum lease payments not amounting to substantially all the fair value of the commercial property, that it retains substantially all the significant risks and rewards incidental to ownership of these properties which are leased out and accounts for the contracts as operating leases.

(ii) Classification between investment properties, completed properties held for sale and owner-occupied properties

The Group determines whether a property qualifies as an investment property, and has developed criteria in making that judgement. Investment property is a property held to earn rentals or for capital appreciation or both. Therefore, the Group considers whether a property generates cash flows largely independently of the other assets held by the Group.

Some properties comprise a portion that is held to earn rentals or for capital appreciation and another portion that is held for use in the production or supply of goods or services or for administrative purposes. If these portions could be sold separately, the Group accounts for the portions separately. If the portions could not be sold separately, the property is an investment property only if an insignificant portion is held for use in the production or supply of goods or services or for administrative purposes. Judgement is made on an individual property basis to determine whether ancillary services are so significant that a property does not qualify as an investment property.

(i) 物業租賃分類—本集團作為出租人

本集團就其投資物業組合訂有商業物業租約。本集團根據對有關安排條款及條件的估值，如租期不構成商業物業經濟壽命的主要部分及最低租賃款項現值不等於商業物業的絕大部分公允值，本集團已釐定其保留該等物業所有權附帶的絕大部分風險及回報，並將有關合約以經營租賃入賬。

(ii) 投資物業、持作銷售已落成物業及業主自佔物業的分類

本集團決定一項物業是否合資格作為投資物業，並已制定作出該判斷的標準。投資物業為就賺取租金或資本增值或兩者兼得而持有的物業。因此，本集團認為，該物業能否產生現金流量，很大程度不受本集團持有的其他資產影響。

(iii) Classification of current and non-current properties under development

The Group classifies properties under development according to the construction progress and estimated commencement date of pre-sale. Properties under development are classified as current assets after the construction commences or having a clear plan for construction. As for the rest properties under development, the Group classify them as non-current.

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below:

(i) Fair value of investment properties

Investment properties were revalued based on the appraised market value by independent professional valuers. Such valuations were based on certain assumptions, which are subject to uncertainty and might materially differ from the actual results. In making the estimate, the Group considers information from current prices in an active market for similar properties and uses assumptions that are mainly based on market conditions existing at the end of the reporting period.

In the absence of current prices in an active market for similar properties, the Group considers information from a variety of sources, including:

- (a) current prices in an active market for properties of a different nature, condition or location or subject to different leases or other contracts, adjusted to reflect those differences;
- (b) recent prices of similar properties on less active markets, with adjustments to reflect any changes in economic conditions since the dates of the transactions that occurred at those prices; and

- (c) discounted cash flow projections based on reliable estimates of future cash flows, supported by the terms of any existing lease and other contracts and (when possible) by external evidence such as current market rents for similar properties in the same location and condition, and using discount rates that reflect current market assessments of the uncertainty in the amount and timing of the cash flows.

The principal assumptions for the Group's estimation of the fair value include those related to current market rents for similar properties in the same location and condition, appropriate discount rates, expected future market rents and future maintenance costs. The carrying amount of investment properties at 31 December 2023 was RMB4,858,800,000 (2022: RMB5,276,900,000). Further details, including the key assumptions used for fair value measurement and a sensitivity analysis, are given in note 13 to the financial statements.

(ii) Net realisable value of properties under development and completed properties held for sale

The Group's properties under development and completed properties held for sale are stated at the lower of cost and net realisable value. Based on the Group's historical experience and the nature of the subject properties, the Group makes estimates of the selling prices, the costs of completion of properties under development, and the costs to be incurred in selling the properties based on prevailing market conditions.

If there is an increase in costs to completion or a decrease in net sales value, the net realisable value will decrease and this may result in a provision for properties under development and completed properties held for sale. Such provision requires the use of judgements and estimates. Where the expectation is different from the original estimate, the carrying value and provision for properties in the period in which the estimate is changed will be adjusted accordingly.

(iii) PRC land appreciation tax (“LAT”)

LAT in the PRC is levied at progressive rates ranging from 30% to 60% on the appreciation of land value, being the proceeds from the sale of properties less deductible expenditures including land costs, borrowing costs and other property development expenditures.

The subsidiaries of the Group engaging in the property development business in Chinese Mainland are subject to LAT. However, the implementation of these taxes varies amongst various cities in Chinese Mainland and the Group has not finalised its LAT returns with various tax authorities. Accordingly, significant judgement is required in determining the amount of land appreciation and its related taxes. The ultimate tax determination is uncertain during the ordinary course of business. The Group recognises these liabilities based on management’s best estimates. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the statement of profit or loss and the provision for LAT in the period in which such determination is made.

(iv) Leases – Estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate (“IBR”) to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group “would have to pay”, which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease (for example, when leases are not in the subsidiary’s functional currency). The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates (such as the subsidiary’s stand-alone credit rating).

(iii) 中國土地增值稅 (「土地增值稅」)

中國的土地增值稅是就土地增值即銷售物業所得款項減可扣減開支 (包括土地成本、借貸成本及其他物業開發開支) 按介於30%至60%的遞進稅率徵收。

本集團屬下在中國內地從事物業開發業務的附屬公司須繳納土地增值稅。然而，在中國內地不同城市，該等稅項的實施各有差異，且本集團尚未與不同稅務機關最終落實其土地增值稅報稅表。因此，在釐定土地增值金額及其相關稅項時須作出重大判斷。於日常業務過程中最終的稅項釐定仍不確定。本集團按照管理層的最佳估計確認該等負債。倘該等事項的最終稅項結果與最初記賬的金額不同，則有關差異將會影響損益表，並就該釐定期間的土地增值稅作出撥備。

(iv) 租賃—估算增量借款利率

本集團無法輕易釐定租賃內所隱含的利率，因此，使用增量借款利率 (「增量借款利率」) 計量租賃負債。增量借款利率為本集團於類似經濟環境中為取得與使用權資產價值相近之資產，而以類似抵押品與類似期間借入所需資金應支付之利率。因此，增量借款利率反映了本集團「應支付」的利率，當無可觀察的利率時 (如就並無訂立融資交易之附屬公司而言) 或當須對利率進行調整以反映租賃之條款及條件時 (如當租賃並非以附屬公司之功能貨幣訂立時)，則須作出利率估計。當可觀察輸入數據可用時，本集團使用可觀察輸入數據 (如市場利率) 估算增量借款利率並須作出若干實體特定的估計 (例如附屬公司的單獨信貸評級)。

(v) Impairment of non-financial assets (other than goodwill)

The Group assesses whether there are any indicators of impairment for all non-financial assets (including the right-of-use assets) at the end of each reporting period. Other non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

(vi) Fair value of unlisted equity investment

The unlisted equity investments have been valued based on a market-based valuation technique as detailed in note 43 to the financial statements. The valuation requires the Group to determine the comparable public companies (peers) and select the price multiple. In addition, the Group makes estimates about the discount for illiquidity and size differences. The Group classifies the fair value of these investments as Level 3. The fair value of the unlisted equity investments at 31 December 2023 was RMB457,163,000 (2022: RMB438,201,000). Further details are included in note 17 to the financial statements.

(v) 非金融資產 (商譽除外) 減值

本集團於各報告期末時評估全部非金融資產 (包括使用權資產) 是否存在任何減值跡象。當有跡象顯示非金融資產賬面值可能不可收回時進行減值測試。當一項資產或現金產生單位的賬面值超過其可收回金額 (即公允價值減出售成本與其使用價值兩者中的較高者) 時即存在減值。公允價值減出售成本乃根據來自同類資產公平交易的受約束銷售交易的可用數據或可觀察市價減出售資產的增量成本計算。計算使用價值時, 管理層必須估計來自資產或使用主要假設 (如預算銷售額) 現金產生單位的預期未來現金流量, 並選取合適的貼現率, 以計算該等現金流量的現值。

(vi) 非上市股權投資的公允價值

非上市股權投資已根據財務報表附註43所詳述的市場基準估值技術進行估值。有關估值需要本集團確定可資比較的公眾公司 (同業公司) 及選擇價格倍數。此外, 本集團須就流動性不足及規模差異的貼現作出估計。本集團將該等投資的公允價值歸類為第3級。於2023年12月31日, 非上市股權投資的公允價值為人民幣457,163,000元 (2022年: 人民幣438,201,000元)。進一步詳情載於財務報表附註17。

(vii) Deferred tax assets

Deferred tax assets are recognised for all deductible temporary differences and unused tax losses to the extent that it is probable that taxable profit will be available against which the deductible temporary differences and losses can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies.

(viii) Provision for ECLs on trade receivables and other financial assets

The Group uses a provision matrix to calculate ECLs for trade receivables and other financial assets. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e. by service type, customer type and rating).

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions are expected to deteriorate over the next year which can lead to an increased number of defaults in the property development sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. 10. INCOME TAX

The Group's subsidiaries incorporated in Hong Kong, Canada and United Kingdom are not liable for income tax as they did not have any assessable profits arising in Hong Kong, Canada and United Kingdom during the year (2022: Nil).

The provision for the PRC income tax has been provided at the applicable income tax rate of 25% (2022: 25%) on the assessable profits of the Group's subsidiaries in Mainland China.

LAT is levied at progressive rates ranging from 30% to 60% on the appreciation of land value, being the proceeds from the sale of properties less deductible expenditures including land costs, borrowing costs and other property development expenditures. The Group has estimated, made and included in taxation a provision for LAT according to the requirements set forth in the relevant PRC tax laws and regulations. Prior to the actual cash settlement of the LAT liabilities, the LAT liabilities are subject to the final review/approval by the tax authorities.

A lower withholding tax rate may be applied if there is a tax treaty between Chinese Mainland and the jurisdiction of the foreign investors. For the Group, the applicable rate is 10%. The Group is therefore liable for withholding taxes on dividends distributed by those subsidiaries established in the PRC in respect of earnings generated from 1 January 2008.

Other than the above deferred tax liability in relation to the PRC withholding income tax provided, no deferred taxation has been provided for the distributable retained profits of approximately RMB4,983,886,000 (2022: RMB4,552,208,000), which were derived from the PRC subsidiaries as the Group is able to control the timing of the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future.

26. TRADE RECEIVABLES

The Group's trading terms with its customers are mainly on credit, except for new customers, where payment in advance is normally required. The credit period is generally one month, extending up to three months for major customers. Each customer has a maximum credit limit. The Group seeks to maintain strict control over its outstanding receivables to minimise credit risk. Overdue balances are reviewed regularly by senior management. In view of the aforementioned and the fact that the Group's trade receivables relate to various diversified customers, there is no significant concentration of credit risk. As at 31 December 2023, certain of the Group's non-current time deposits of RMB149,281,000 (2022: RMB136,956,000) were pledged to banks as guarantees for mortgage facilities granted to purchasers of the Group's properties.

Besides, certain of the Group's bank accounts of approximately RMB208,000,000 (2022: RMB4,033,000) were pledged to banks for the timely repayment of the loans as disclosed in note 32.

As at 31 December 2023, pursuant to relevant regulations in the local government, certain of the Group's non-current time deposits amounted to approximately RMB35,701,000 (2022: RMB10,000,000) were required to place in designated bank accounts as guarantee deposits for the construction of the related properties.

At the end of the reporting period, the cash and bank balances of the Group denominated in RMB amounted to RMB2,308,095,919 (2022: RMB6,377,395,000). The RMB is not freely convertible into other currencies, however, under Chinese Mainland's Foreign Exchange Control Regulations and Administration of Settlement, and Sale and Payment of Foreign Exchange Regulations, the Group is permitted to exchange RMB for other currencies through banks authorised to conduct foreign exchange business.

Share options granted to a director, chief executive or substantial shareholder of the Company, or to any of their associates, are subject to approval in advance by the independent non-executive directors. In addition, any share options granted to a substantial shareholder or an independent non-executive director of the Company, or to any of their associates, in excess of 0.1% of the shares of the Company in issue at any time or with an aggregate value (based on the price of the Company's shares at the date of grant) in excess of HK\$5 million, within any 12-month period, are subject to shareholders' approval in advance in a general meeting.

The offer of a grant of share options may be accepted by the grantee within 21 days from the date of offer at a consideration of HK\$1.00. The exercise period of the share options granted is determinable by the directors, and commences after a vesting period of one to five years and ends on a date which is not later than 10 years from the date of offer of the share options or the expiry date of the Scheme, if earlier.

In accordance with the Company Law of the PRC and the respective articles of association of the PRC group companies, each of the subsidiaries of the Group that is domiciled in Chinese Mainland is required to allocate 10% of its profit after tax, as determined in accordance with the PRC Accounting Regulations, to the statutory surplus reserve (the “SSR”) until such reserve reaches 50% of its registered capital.

In addition, certain of the PRC group companies are foreign investment enterprises which are not subject to the SSR allocation. According to the relevant PRC regulations applicable to foreign investment enterprises, each of these subsidiaries is required to allocate a certain portion (not less than 10%) of its profit after tax, as determined in accordance with the PRC Accounting Regulations, to the statutory reserve fund until such reserve reaches 50% of its registered capital.

36. ACQUISITION OF SUBSIDIARIES THAT ARE NOT A BUSINESS

In June 2022, the Group entered into agreements with the then shareholders to acquire the equity interests in Hangzhou Jin’an Star Enterprise Management Consulting Partnership (Limited Partnership), Taizhou Huahao Enterprise Management Consulting Co., Ltd., Zhejiang Zhongan Health Industry Co., Ltd. and Hangzhou Haohan Investment Consulting Co., Ltd. (together, the “Jinan Star Entities”), which were previously joint ventures of the Group. Jinan Star Entities are engaged in property development business in Taizhou, the PRC. The purchase consideration for the acquisition was partially in the form of cash of RMB217,993,000 and partially in the form of remeasurement of investments in joint ventures. The acquisition was completed in June 2022, and Jinan Star Entities became subsidiaries of the Group since then.

As disclosed in note 18, China New City Group Limited (“the Subsidiary”) allotted and issued 178,280,000 shares to Hangzhou Oriental Culture Tourism Group Co., Ltd. (“the Seller”) for the purpose of acquiring 22.65% of equity interests in Zhejiang Xinnongdu Industrial Co., Ltd.
