AS ORDINARY BUSINESSES

- 1. To receive and consider the audited consolidated financial statements of the Company and its subsidiaries (including the consolidated affiliated entities) and the reports of the directors of the Company (the "**Directors**") and of the Company's auditors for the year ended 31 December 2023;
- 2. To re-elect the following Directors:
 - (a) Mr. Fang Gongyu as executive Director;
 - (b) Mr. Tian Tao as executive Director; and
 - (c) Ms. Yu Yuan as executive Director.
- 3. To authorise the board of Directors (the "Board") to fix the remuneration of the Directors;
- 4. To re-appoint PricewaterhouseCoopers as the Company's auditors for the year ending 31 December 2024 and to authorise the Board to fix their remuneration.

5. To consider and, if thought fit, to pass with or without amendments, the following resolutions as ordinary resolutions:
