A proxy need not be a shareholder of the Company, but must attend the AGM in person in order to represent you.
- 3. If no name is inserted, the Chairman of the meeting will act as your proxy. Any changes should be initialed.

PERSONAL INFORMATION COLLECTION STATEMENT

By providing your appointed proxy's Personal Data, you hereby confirm that you have obtained the consent of your appointed proxy to provide their Personal Data to the Company and its Registrars. The Personal Data provided in this form may be used in connection with processing your appointment of proxy at the Company's AGM and instructions. Your supply of the Personal Data to the Company and/or its Registrars is on a voluntary basis.
