Chairman's Statement



On behalf of the Board of Directors of the Company (the "**Board**"), I hereby present the annual results of Chu Kong Shipping Enterprises (Group) Company Limited (the "**Company**") and its subsidiaries (the "**Group**") for the year ended 31 December 2023 to the shareholders. The Group recorded a consolidated revenue of HK\$2,553,835,000 (2022: HK\$2,899,545,000), representing a decrease of 11.9% as compared with last year, profit attributable to the shareholders of the Company amounted to HK\$114,069,000 (2022: HK\$93,490,000), representing an increase of 22.0% as compared with last year.

REVIEW

In 2023, the Group has strived to seize the opportunities arising from the development of the Guangdong-Hong Kong-Macao Greater Bay Area (the "Greater Bay Area"), remained focused on its primary responsibilities and continued to cultivate the core business, to actively create greater shareholder value for investors. After Guangdong, Hong Kong and Macao resumed normal traveller clearance in an orderly manner, the Group pursued progress while ensuring stability, resumed and expanded the waterway passenger transportation market, and innovated to promote the "Waterway Economy" of the Greater Bay Area, thereby effectively enhancing interconnectivity within the Greater Bay Area. By extending the business chain and exploring market opportunities, the Group has vigorously developed its modern logistics industries including terminal logistics, warehousing logistics, integrated logistics, cross-border e-commerce and air freight logistics. While the Group has continued to expand the local Hong Kong market, it has identified new business opportunities, explored new tracks, developed new forms of business, and actively sought new drivers for profit growth.

Chairman's Statement

Innovating business model, upgrading logistics industry. In 2023, the Group delved into the potential of the Modular Integrated Construction ("MIC") transportation and construction logistics market, successfully winning bids for a number of construction projects. The start of operations for the land transport of cross-border e-commerce business in February added new impetus for the Group to expand new markets and explore new customers. Moreover, the Group innovatively initiated the same-vessel shipping model for combining domestic and foreign trade container shipments to promote high-quality, integrated development of domestic and foreign trade businesses. During the year, the Group also overcame the adverse impact of weakened overseas demand, smoothly developed the cross-border railway transportation business, successfully undertook the freight cargo businesses of drones from well-known technology companies, and actively prepared for the construction of a logistics network in Vietnam.

Utilising the advantages of resources, optimising layout of passenger transportation. The Group's multiple cross-border waterway passenger transportation routes across Guangdong-Hong Kong and Hong Kong-Macao have resumed in an orderly manner following the resumption of normal traveller clearance. Three new routes, including "Shenzhen Airport Ferry Terminal-China Ferry Terminal", "Guangzhou Pazhou-China Ferry Terminal" and "Guangzhou Pazhou-Hong Kong International Airport" have been launched. The Group has coordinated and optimised the operating management of an integrated platform of cross-border passenger transportation, and continued to deepen cooperation with airlines and travel agency industries, as well as enhanced the marketing functions on new media platforms including "Tongcheng" and "TikTok" to achieve favourable situation. The passenger volume has steadily increased and business benefits has been improved progressively. Continuing to expand its project layout and business outreach around the Hong Kong International Airport, the Group has made every effort to ensure the smooth operation of baggage handling and apron vehicle sharing services. Simultaneously, the Group has continued to actively bid for other relevant high-quality strategic projects to further strengthen its competitive advantage.



Leveraging synergy effect, strengthening local business. The Group's sightseeing cruise "Oriental Pearl" has launched several specialty themed voyages to vigorously promote the development of Hong Kong's high-end "Harbour Cruise" waterway economy and successfully establish a new benchmark for water cultural tourism. By successfully winning the bid for the HKSAR Government's bunkering project and reaching a cooperation project as the lubricating oil supply agency, the diversity and profitability of the Group's fuel supply business have been enhanced strongly. The local ferry business achieved steady growth in passenger volume over the year, providing the Group with a stable source of business revenue and significantly enhancing synergy effects.

While successfully promoting several key projects, the Group has actively implemented the new development philosophy of "innovation, coordination, green, openness, and sharing". By continuing to expand its terminal navigation business network and innovatively activating the "Waterway Economy" in the Greater Bay Area, the transportation services for the public have been utilised and the travel demands of the Greater Bay Area have been enriched. By contributing to the emergence of a new green economy business model, the Group has empowered the principal terminal navigation businesses to achieve breakthrough developments through technological innovation and committed to achieving synergistic development that benefits the environment, society, and the economy. During the year, pursuant to the outstanding performance in Environmental, Social and Governance ("ESG") management, the Group was successfully included in the "ESG Pioneer 100 Index for Listed Stated-Owned Enterprise (2023)" list.

OUTLOOK

In 2024, with the national avocation for the evolution of new quality productive forces to achieve high-quality development in the real economy, the Group has been provided an important support in creating new engines of development and constructing new competitive advantages. Along with full utilisation of the comparative advantages of the Greater Bay Area cities, continuous optimisation of the functional layout of the regions, continuous improvement of talent exchange channels, and gradual appearance of the effects of integration and development, the Group will obtain a bigger scope and a better platform in its future development process. The Group will firmly grasp the strategic opportunities brought by the national policies to construct a development platform to expand new horizons for business growth, enhance the momentum of development to cultivate new competitive edges in project development, and drive the high-quality advancement of the enterprise.



Chairman's Statement

Firstly, the Group will build the terminal development platform and realise joint coordination development among the terminal cluster. The Group will strive to strengthen the integration of terminal logistics resources and actively build a modern terminal logistics industry system, to form a new landscape of terminal logistics characterised by reasonable allocation and coordinated development. With the goal of establishing scalable terminal platforms, the Group will plan its layout comprehensively and adjust its strategies dynamically with flexibility. The Group will precisely allocate incremental terminal resources, and proactively develop core terminals that have the capability to lead and provide supportive capacity. Through the dislocation development of regional terminals, driven by core terminals and coordinated with other regional terminals, a regional terminal consortium will be formed to enhance the overall strength and market competitiveness of the Group's terminal cluster.

Secondly, the Group will build the integrated logistics development platform to promote industry chain towards high-end level. By establishing a new pattern of synergistic development among terminal nodes in Mainland China, with Chu Kong Transhipment & Logistics Company Limited ("CKTL") serving as the link, the Group will construct an integrated logistics platform with formidable overall strength and competitive prowess. With a focus on building warehousing logistics centres with high self-operation proportion and outstanding efficiency, the Group will actively expand value-added businesses, strive to achieve new breakthroughs in the high-end logistics industry chain in order to become a leading regional supply chain service provider. In addition, by focusing on the vast infrastructure logistics market in Hong Kong and Macao and closely monitoring potential construction projects in Hong Kong, the Group will strive to establish a dominant market position in the field of infrastructure logistics.



Thirdly, the Group will build the development platform for waterway passenger transportation to promote synergistic effects of new business models. The Group will optimise and adjust the resources of waterway passenger transportation in the Greater Bay Area, with an emphasis on developing core cross-border routes from Guangzhou Pazhou to urban Hong Kong and its airport, thereby enhancing the operational efficiency of these routes. The Group will also strive to participate in the construction of Hong Kong "Airport City", and actively bid for the Hong Kong International Airport's strategic high-quality projects. The Group will strengthen the local ferry business by better utilising the business platform of Sun Ferry. In addition, by better developing the water-based tourism market and utilising resources as well as the brand of "Oriental Pearl", the Group will further deepen the multi-level and diversified water-based market. Furthermore, the Group will endeavour to carry out the oil supply in marine work projects of HKSAR Government, expand the fleet for lubricant vessels, expand oils and its related business, and establish the new "one-stop" and "end-to-end" oil supply chain business model.

Fourthly, the Group will strengthen the development momentum of the "Belt and Road" initiative and provide new avenues for business expansion. The Group will continue to promote the implementation of the "Going Out" strategy, and strive to accomplish a series of projects with promising prospects and strategic complementarity. To better exert the market "outpost" effect of overseas business nodes and networks, the Group will seek more business collaborations and foreign investment opportunities in ASEAN markets, including Singapore, Malaysia, Thailand and Vietnam.

APPRECIATION

On behalf of the Board, I would like to take this opportunity to express my heartfelt thanks to all of our investors and partners who have shown tremendous support to the Group, as well as to our management and staff who have worked hard to strive toward better results for the Group. We will "Strategise Quality Developments and Conquer New Frontiers", strive to create value for shareholders, and make further contributions to the prosperity of Guangdong-Hong Kong-Macao economy.





The directors of the Company (the "**Directors**") are pleased to present Report of the Directors together with the audited financial statements of the Group for the year ended 31 December 2023.

PRINCIPAL ACTIVITIES AND GEOGRAPHICAL OPERATIONS ANALYSIS

The Company is principally engaged in investment holding, focusing mainly on terminal logistics, waterway passenger transportation, and fuel supply business. The Group establishes its terminal logistics business based on a number of cargo terminal enterprises in Guangdong and Hong Kong, which forms a complete supply chain of terminal logistics including feeder transportation, freight forwarding, vessel agency, wharf handling, warehousing and storage services in Guangdong and Hong Kong. Another major business of the Group, the waterway passenger transportation based in Guangdong, Hong Kong and Macao, has developed into the largest operation network of waterway passenger transportation in the region. The Group also operates five inner harbour and outlying island ferry routes in Hong Kong and develops the Victoria Harbour water cultural tourism projects simultaneously. The fuel supply business of the Group mainly covers the provision of diesel and lubricants for passenger ferries and cargo vessels, and other businesses of the Group include the provision of operation and management of facilities maintenance services for properties in Macao.

There were no significant changes in the principal activities of the Group during the year.

An analysis of the Group's performance for the year by operating segments and geographical locations is set out in note 5 to the financial statements.



BUSINESS REVIEW

For the year ended 31 December 2023, the Group recorded a consolidated revenue of HK\$2,553,835,000 representing a decrease of 11.9% over the same period last year. Benefiting from the gradual normalisation of passenger transportation business as well as quality and efficiency improvements due to internal management optimisation, gross profit for the year amounted to HK\$285,468,000, representing an increase of 12.0% over the same period last year. Profit attributable to the shareholders of the Company amounted to HK\$114,069,000, representing an increase of 22.0% over the same period last year.

In 2023, despite facing multiple risks from the external environment and persistent pressures from a global economic downturn, the economy of the PRC exhibited sufficient resilience, sustaining a trend of recovery and improvement throughout the year. With the effective implementation of policies to stabilise growth, positive changes emerged across various upstream and downstream industry supply chains and the demand in the PRC's logistics market stabilised and rebounded gradually. Compared with the same period last year, the Group's terminal navigation logistics business progressed well, with continuous improvement in the cargoes transportation volume. Following the normalisation of traveller clearance resumption after the COVID-19 epidemic, routes resumed in an orderly manner; the cross-border waterway passenger transportation business has been greatly improved with a great rebound in the number of passengers.

Regarding the cargoes transportation business, the Group achieved steady progress by firmly grasping the strategic development opportunities presented by national and regional initiatives. During the year, the container transportation volume reached 1,321,000 TEU, representing a year-on-year increase of 2.8%, while break bulk cargoes transportation volume reached 1,143,000 tons, representing a year-on-year increase of 68.6%. As for the cargoes handling business, the container handling volume reached 1,095,000 TEU, representing a year-on-year decrease of 3.2%, while the break bulk cargoes handling volume reached 8,966,000 tons, representing a year-on-year decrease of 12.2%, and the container hauling and trucking volume amounted to 184,000 TEU, representing a year-on-year decrease of 8.0%.

Regarding the passenger transportation business, benefiting from the normalisation of traveller clearance, the Group's performance has improved. The cross-border waterway passenger routes of the Group resumed in an orderly manner since 8 January 2023, and three new routes, including "Shenzhen Airport Ferry Terminal-Hong Kong China Ferry Terminal", "Guangzhou Pazhou – Hong Kong International Airport" have also been launched. The local ferry business has seized the development opportunity brought by the resumption of normal traveller clearance, resulting in a rebound in the number of passengers. During the year, the total number of passengers for agency services was 1,476,000, representing a year-on-year increase of 1,062.2%. The number of passengers for terminal services was 953,000, representing a year-on-year increase of 650.4%. The number of passengers for local ferry service was 12,269,000, representing a year-on-year increase of

Subsidiaries

During the year, in the light of a global slowdown in multi-sector trade and persistently low freight prices, CKTL has been confronted with challenges stemming from the resumption of cross-border vehicle operations between Mainland China, Hong Kong, and Macao, as well as a sharp decline in the transportation volume of anti-epidemic and essential livelihood supplies. Despite these challenges, CKTL has managed to maintain a stable foundation in inland container transportation and achieved breakthroughs in construction logistics and integrated logistics by strengthening cooperation with terminals and successfully venturing into e-commerce local delivery services, resulting in commendable outcomes. The volume of container transportation for the year recorded 1,321,000 TEU, representing a year-on-year increase of 2.8%. The volume of break bulk cargoes transportation for the year recorded 1,143,000 tons, representing a year-on-year increase of 68.6%. The volume of container hauling and trucking on land for the year recorded 184,000 TEU, representing a year-on-year decrease of 8.0%.



Through actively responding to market changes, CKTL promptly adjusted its business strategy and began vigorously transitioning towards becoming an integrated logistics operator. For the construction logistics aspect, CKTL capitalised on the emerging trend of MIC, and on the basis of successfully bidding for the transportation of MIC components for campus refurbishment projects, has expanded its logistics services to include several small-medium transitional housing projects. Additionally, by leveraging its long-term accumulated project experience and customer resources. CKTL has successfully won the bid for a sand supply for certain phases of the Hong Kong International Airport construction project. In terms of cargo terminals and navigation cooperation, CKTL strengthened the collaboration with the Group's construction of the integrated operation platform for ports and barges as well as composite ports business model to give full play to the synergy effect and improve quality and efficiency. In terms of e-commerce business, the Group has strengthened the integrated business model of "barges + terminals and warehouse services + local delivery" and continues to explore the potential of e-commerce logistics business. In the future, CKTL will continue to focus on construction logistics and specialise in storage logistics. The company will fully utilise terminal resources in Hong Kong to diversify and expand new sources of goods, proactively innovate in various business areas, as well as enhance its capacity for revenue and profit generation.

Subsidiaries

During the year, the overall container handling volume experienced a slight decline. However, subsidiaries continued to optimise their business models. The synergy effect became apparent with the implementation of the integrated operation platform for ports and barges as well as the intelligent trailer system. By strengthening cost control and enhancing efficiency, the Group made concerted efforts to maintain smooth and orderly production and operations. During the year, the container handling volume was 1,095,000 TEU, representing a year-on-year decrease of 3.2%, while the break bulk cargoes handling volume during the year was 8,966,000 tons, representing a year-on-year decrease of 12.2%.

By adhering to the development route of "regional coordination, management integration, and synergistic development" the Zhaoqing region's container handling volume has achieved counter-cyclical growth, with overall development showing continuous improvement. During the year, the container handling volume recorded 201,000 TEU, representing a year-on-year growth of 8.1%. The overall break bulk cargoes handling volume recorded 6,282,000 tons, decreased by 3.6% year-on-year. During the year, each port in the Zhaoqing region accurately identified its own development position, enhanced communication and linkage among themselves, and implemented various measures to expand new sources of goods. Each port also innovated a new logistics model and launched the whole process waterway transportation service of "External to Internal + Waterway to Waterway". Over the year, a total of 122,000 TEU container handling volume for foreign trade was handled, with market shares increasing to nearly 70% of the total market of Zhaoqing city, progressively consolidating the foreign trade leading position over there. In which, Zhaoqing New Port successfully obtained the business qualification for importing homologous goods of medicine and food for non-pharmaceutical enterprises, and Sihui Port successfully obtained the "Attached Certificate for Dangerous Goods Operation at Ports", launched a container handling business for Class 9 Dangerous Goods, and also completed the direct export shipment of "Sihui-Yantian" for the first batch of lithium batteries.



Gaoming Port in Foshan region achieved a container handling volume of 275,000 TEU, representing a year-on-year increase of 3.0%, and a break bulk cargoes handling volume of 38,000 tons, representing a year-on-year decrease of 77.1%. During the year, affected by adverse factors including weakened domestic and overseas demand, fluctuating shipping prices, intensifying competition among surrounding ports etc., the break bulk cargoes handling volume decreased compared to last year. Gaoming Port strived to seek breakthroughs under these challenging circumstances, including exploring the development potential of the integrated operation platform for ports and barges, launching "Daily Feeder" services, exerting advantages of platform aggregation, optimising operational processes, extending the integrated logistics service chain, enhancing the level of informatisation, continuously improving production efficiency and reducing operational costs. In addition, Gaoming Port kept abreast of market changes and proactively adjusted its goods portfolio, which led to apparent effects in the specialised business of "renewable resources" and established an influential import port brand of "renewable resources" in the Greater Bay Area. Meanwhile, Gaoming Port seized the future strategic opportunities presented by the construction of Guangzhou's second airport, stuck to the logistics channel of "Air-Terminal", and actively fostered the burgeoning business model of cross-border e-commerce. During the year, Gaoming Port successfully obtained the qualification as a "Cross-Border E-Commerce Park" from the PRC Government of Foshan Municipality and officially launched its crossborder land transportation business. In the future, it will continue to optimise its land transportation capabilities to develop a more comprehensive logistics service platform.

During the year, the container handling volume at Qingyuan Port in Qingyuan region recorded 123,000 TEU, representing a year-on-year increase of 5.1%. The break bulk cargoes handling volume was 473,000 tons, representing a year-on-year increase of 98.7%. Qingyuan Port launched a new handling business for bagged cement, which led to a significant increase in the break bulk cargoes handling volume.

The overall container handling volume in the Zhuhai region recorded 196,000 TEU, representing a year-on-year decrease of 4.9%; break bulk cargoes handling volume recorded 149,000 tons. Doumen Port actively explored the market potential of foreign trade enterprises in Doumen District and its surrounding areas, successfully attracting sources of goods from major regional customers. Overcoming various difficulties brought on by the economic situation, Civet Port completed services for 7,853 sand and gravel ship voyages, as well as 10,861 trips for the specialised Hong Kong-Macao cross-border e-commerce vehicle business. In the future, Civet Port will continue to promote further cooperation with Hongwan Terminal, deepen the business cooperation between Hong Kong, Zhuhai and Macao by fully utilising the resources and strength of both sides, to develop Hongwan Terminal area into a foreign trade cargo distribution base for the Greater Bay Area.

Zhongshan Huangpu Port in Zhongshan region newly launched an export service for foreign trade break bulk cement and innovatively introduced "Railway + Highway + Waterway" multimodal transportation projects to meet customer needs. Benefiting from the recovery of the sand and gravel business volume and the development of the scrap steel business, the break bulk cargoes business experienced substantial growth.

The terminals in the Hong Kong region recorded 262,000 TEU of container handling volume, representing a year-on-year decrease of 19.1%. The break bulk cargoes handling volume recorded 732,000 tons, representing a year-on-year decrease of 38.6%. During the year, by seizing the opportunity from Hong Kong's international airline hub, CKTL transformed and upgraded its freight cargo business to provide destination customs clearance and delivery services, consistently expanded the customer base for its freight cargo warehouse, resulting in a 31% year-on-year increase in air freight handling volume. By expanding the climate-controlled and bonded storage area at Tuen Mun warehouses and successfully putting them into operation to store high-value items such as perfumes, cosmetics, as well as dutyfree alcohol, the climate-controlled warehouse is currently at full capacity. High-rise shelving has been added to certain areas of the warehouses to expand its storage capacity and efforts to actively seek new sources of goods led to the successful introduction of projects involving internationally renowned apparel brands.

Joint Ventures and Associates

For the break bulk cargoes handling business, on the foundation of stabilising the cargoes volume of its existing bulk grain-and-food commodities customers, Sanbu Port continued to develop break bulk cargo businesses and customer groups for sand and gravel commodities, optimised and adjusted the structure of its tractor business, and implemented competitive strategies to differentiate itself from surrounding terminals, resulting in sustained substantial growth in its break bulk cargoes handling business. In terms of the container handling business, Sanbu Port intensified its cargo acquisition efforts through joint marketing and business expansion with shipping companies. In collaboration with domestic trade shipowners, Sanbu Port proactively organised promotional events for ceramic customers and established several specialised cargo source collaborations, resulting in growth in both cargoes volume and revenue. Heshan Port recorded a break bulk cargoes handling volume of 1,291,000 tons, representing a year-on-year increase of 265.7%. Beicun Port in Foshan region successfully launched e-commerce business and has become a new e-commerce export terminal.



II. Passenger Transportation Business

Subsidiaries

Benefiting from the adjustments to the epidemic prevention policy, the Group's cross-border waterway passenger transportation has resumed since 8 January 2023. Following a series of preparation for the resumption of ferry routes, normal operation for six urban routes and five airport routes has been achieved. The volume of cross-border passenger traffic rose significantly compared to the same period last year. The total number of passengers for agency services was 1,476,000, representing a year-on-year increase of 1,062.2%, while the number of passengers for terminal services was 953,000, representing a year-on-year increase of 650.4%.

During the year, Chu Kong Passenger Transport Company Limited ("**CKPT**") concentrated on its superior resources and put great emphasis on airport core projects. It continued to deepen the service areas of the Hong Kong International Airport by actively seeking new project opportunities, participating in bidding for high-quality projects and stepping up efforts to develop the business of the Hong Kong International Airport. CKPT promoted the integration of the passenger transport business segment in an orderly manner and promoted the coordination of platform capacities and the consolidation of port resources. By innovating marketing models and collaborating with other business divisions within the Group, CKPT launched the ticket package "Cross-border Passenger Transportation +", creating synergy and aiding the development of convenient travel within the transportation industry and the Greater Bay Area. The operation scale of self-service baggage drop project at the Hong Kong International Airport has been restored to pre-pandemic levels and continues to expand. The Group is currently preparing for the next phase of the tender process. Through actively developing long-term customers and serving a number of ad-hoc customers, the apron vehicle sharing service maintained stable operation.

Regarding urban routes, with the increase in visitors to Hong Kong, the urban routes have been gradually resuming. Currently, six routes, including Zhongshan, Nansha, Shekou, Shenzhen Airport, Shunde and Pazhou are operating normally, which the number of passengers served during the year amounted to 1,017,000. During the year, Pazhou Port opened a new route between Guangzhou Pazhou Ferry Terminal and Hong Kong China Ferry Terminal. CKPT seized the prime opportunity for publicity presented by the resumption and inaugural voyages, leveraging various channels to promote its routes. CKPT completed the establishment of a new media live broadcasting team for the integrated passenger transportation platform, continuously expanding the visibility of its routes and achieving growth in both passenger sources and added value. During the year, the Group coordinated the management of the integrated passenger transportation platform, established mechanism for information exchange among various ports, facilitated the coordination of resources between ports, and consistently optimised the route resources in the Greater Bay Area.

Regarding airport routes, the number of passengers served during the year by the five operating routes of Shekou, Zhongshan, Humen, Pazhou and Shenzhen Airport amounted to 459,000. Since the inaugural voyage between Guangzhou Pazhou Terminal route and the Hong Kong International Airport on 4 May 2023. the passenger flow has increased steadily. The Group seized core airport projects and ensured the smooth operation and renewal of these airport projects. The Group consistently provided high-quality, convenient services through intermodal transportation services at the SkyPier and transit terminal, enhancing the overall travel experience for passengers.

Regarding local ferry services, following the full resumption of traveller clearance between Hong Kong and China, the local ferry business recorded a total number of passengers of 12,269,000, representing a year-onyear increase of 8.2%. Sun Ferry Services Company Limited ("Sun Ferry") was committed to enhancing its full-cycle service capabilities, optimising pier facilities, improving the passenger ferry ride experience, the nonfarebox revenue was increased through the promotion of outlying island tourism and terminal improvement projects. With the delivery and deployment of newly built vessels, Sun Ferry continued to prioritise safe production practices, ensuring the implementation of new ferry projects, shifting strategies to advance the disposal of old ferries, and seeking new growth points through resource utilisation. At the same time, Sun Ferry strengthened the business integration with other internal business segments to maximise the synergy effect and bring a stable source of long-term profit to the Group.

Regarding water cultural tourism business, the sightseeing cruise "Oriental Pearl" of Oriental Pearl Cruise Company Limited ("Oriental Pearl"), was the first large-scale high-end cruise ship providing Victoria Habour tour service in Hong Kong, which is a platform for water-based tourism and business activities with quality services. During the year, the "Oriental Pearl" cruise achieved regular berthing operations at the Central Pier, and its high-end business charter and sightseeing services attracted numerous upscale clients, gaining multiple media coverages. During the year, the Oriental Pearl operated a total of over 1,000 sailings with 55,000 passengers and recorded a profit for the first time.

Joint Ventures and Associates

During the year, benefiting from the growth in passenger volume of the Shekou to the Hong Kong International Airport route, the number of passengers at SkyPier (operated by Hong Kong International Airport Ferry Terminal Services Limited) amounted to 459,000, representing a year-on-year increase of 261.4%. Zhongshan-Hong Kong Passenger Shipping Co-op Co., Ltd. has resumed since 13 January 2023, the passenger transportation volume of the urban routes during the year was 599,000. The operation of Foshan Shunde Shungang Passenger Transportation Co-op Co., Ltd. has resumed since 30 March 2023, the passenger transportation volume served for the urban routes during the year amounted to 110,000.

During the year, the shuttle bus business volume for the Hong Kong-Zhuhai-Macao Bridge which is jointly operated by Hong Kong-Zhuhai-Macao Bridge Shuttle Bus Co., Ltd., an associate of the Group increased significantly, it achieved a passenger volume of 17,192,000 passengers during the year, representing a significant year-on-year increase of 6,174.5%, contributing favourably to the Group's revenue.

III. Fuel Supply Business

As to the fuel supply business, Sun Kong Petroleum Company Limited ("**Sun Kong Petroleum**") achieved growth in sales volume of both diesel and engine oil, turning a loss into a profit against the odds. During the year, Sun Kong Petroleum successfully renewed the China Hong Kong City Oil Supply Project and made use of its own advantage of scarce local refueling buoyancy resources at sea in Hong Kong and successfully won the bidding for the marine oil bunkering project from the HKSAR Government, thereby expanding its business scope. Meanwhile, Sun Kong Petroleum has continued to optimise its existing fuel transportation capacity. This year, it completed the production and deployment of a new 1,300-ton diesel transport vessel and initiated the construction of a 700-ton lubricating oil transport vessel project, further satisfying the development needs of the bunkering business and enhancing the hardware capacity of the bunkering services.

IV. Corporate and Other Businesses

As to the corporate and other businesses, Chu Ou Engineering and Technologies Company Limited ("Chu Ou Engineering"), whose main business is maintenance and repair of property facilities, focused on the operations and safety management of Sands Corporation water supply pipeline project during the year, which continued to be profitable. Chu Ou Engineering will continue to give full play to its technological advantages, on the basis of strengthening its existing business, it will pay close attention to the bidding projects of various government departments and enterprises in Macao, actively explore new long-term and stable projects, and strive to strengthen the core competitiveness.

During the year, Guangdong Digital Port & Shipping Technology Co., Ltd. ("Digital Port & Shipping"), a subsidiary of the Group, continued to advance and implement the Group's digital transformation projects. Digital Port & Shipping was successfully recognised as the "2023 High-tech Enterprise" and completed the registration of computer software copyrights for three proprietary products, among which the self-developed project of a smart tractor dispatching platform has been successively developed and inspected in the Zhaoqing area, which effectively enhancing the quality of the terminal's external services and further driving the Group's digital transformation efforts. In the future, Digital Port & Shipping will continue to increase its research and development investments, strengthen its capability to convert scientific and technological achievements into practical applications, and promote the Group in achieving digital upgrades and transformation.

During the year, the businesses of other subsidiaries, joint ventures and associates of the Group progressed well.

CORPORATE STRATEGIES AND PROSPECTS

Focused on the objective of becoming a first-class waterway public transportation service provider and a first-class full scope logistics services provider in the Greater Bay Area, the Group will strengthen the linkage between cargo terminals and navigation, integrate the advantages of resources, promote innovation and development in terminals; extend the industry chain, tap into market potential, optimise strategic layout of integrated logistics; cultivate core routes, establish cultural tourism brands, facilitate the transformation and upgrading of waterway passenger transportation. Moreover, the Group will actively seize opportunities for mergers and acquisitions and carry out core projects with an aim to improve the overall profitability of the Group.

In 2024, the Group will continue to seize strategic opportunities, relying on three development main platforms of port terminals, integrated logistics and waterway passenger transportation. The Group will continue to enhance development momentum and make every effort to expand, optimise and strengthen its presence in the Greater Bay Area and the "Belt and Road" markets. The Group will support the high-quality development of the enterprise by developing its air freight logistics, supply chain logistics, warehouse logistics, e-commerce logistics, construction logistics, cold chain logistics as well as its business in the Hong Kong International Airport, local ferry business, and water cultural tourism business. The Board and the management are optimistic about the future development of the Group in long term, and are committed to preparing for the opportunities and challenges that lie ahead in the coming year.

ENVIRONMENT, SOCIETY AND GOVERNANCE

This section highlights the Group's policies and performance in relation to ESG for the year ended as at 31 December 2023. For further details, please refer to the Environmental, Social and Governance Report 2023 ("ESG Report") separately released by the Group, which is prepared in accordance with the "Environmental, Social and Governance Reporting Guidelines" ("ESG Guidelines") set out in Appendix C2 under the Rules Governing the Listing of Securities (the "Listing Rules") of The Stock Exchange of Hong Kong Limited (the "Hong Kong Stock Exchange").

Issues such as extreme weather, environmental pollution, depletion of natural resources and loss of biodiversity have become the risks that global enterprises currently need to confront. The Group realises the importance of sustainable development for corporate growth and risk management. The Group believes that being environmentally and socially responsible could enhance not only the Group's performance but also drive the overall sustainable development of society.

The Group believes that all enterprises should take up the environmental responsibilities pertinent to their respective industries and integrate corporate social responsibility into their business operations. In adherence to strict internal compliance requirements, the Group has implemented various sustainable operating measures to promote sustainable development in environmental and social aspects. In order to enable all stakeholders to understand the Group's achievements in sustainable operations, the Group discloses its sustainable development performance and results in the ESG Report annually and strives to continuously improve the effectiveness and quality of the disclosures.

In order to enhance the management of sustainable development, the Group established a comprehensive governance framework. The Group already established Governance Group for ESG Report and Working Group for ESG Report, both of which have their respective scopes of authority defined in accordance with the ESG Guidelines set out in Appendix C2 of the Listing Rules. The Governance Group for ESG Report is headed by one executive director and operates under the authority granted by the Board to assist the Board in fulfilling its oversight functions in ESG, as well as in complying with and fulfilling its obligations under the Listing Rules and relevant laws and regulations. Meanwhile, the Governance Group for ESG Report regularly reports to the Board on ESG matters so as to align with the Group's long-term strategic development and enhance shareholders' value as well as to contribute to the overall sustainable development of the society.

During the year, the Group commenced an assessment of materiality issues and identified a total of six materiality issues, including environmental compliance, work safety, compliant operation, service quality, employees' rights and cargo security. The materiality assessment was analysed in two dimensions, namely "materiality to the Group (including the opinions of directors and senior management)" and "materiality to stakeholders (including the views of employees, substantial shareholders and investors, suppliers, customers and the general public)", and a balanced approach to stakeholder representation was adopted, ensuring that the perspectives of all parties involved were equitably considered. The Group will address the concerns of stakeholders in its sustainability efforts in accordance with the materiality principle set out in the ESG Guidelines by the Hong Kong Stock Exchange, and disclose and review the implementation of the materiality issues.

Regarding environmental protection, the Group strictly abided by the laws and regulations that are related to environmental protection and have a significant impact on the Group. The Group also places significant importance to environmental compliance in each operating location. Each subsidiary of the Group formulated policies, management systems, practices and measures according to their business natures and actual circumstances, so as to minimise the environmental impact of its business operations. Meanwhile, the Group also strictly abided by the Law of the PRC on the Environmental Protection (《中華人民共和國環境保護法》), the Law of the PRC on the Prevention and Control of Atmospheric Pollution (《中華人民共和國大氣污染防治法》), the Law of the PRC on the Prevention and Control of Environmental Pollution by Solid Waste (《中華人民共和國固體廢棄物污染環境防治 法》), the Law of the PRC on the Water Pollution Prevention and Control Law (《中華人民共和國水污染防治法》) and other relevant laws and regulations, so as to ensure that the discharge and treatment of all kinds of pollutants met the standards as required by the relevant laws and regulations. The Group also formulated the environmental related emergency response plans including Regulation on the Supervision and Management of Ecological Environmental Protection (《生態環境保護監督管理辦法》) and the General Emergency Response Plan for Incidents (《突發事件總體應急預案》), which outlines the potential environmental impacts in normal business operation, identifies and evaluates the possible environmental risks and establishes emergency prevention and response mechanism, ensuring that the Group possesses adequate capacity to react efficiently and orderly in the event of major environmental pollution incidents, so as to minimise the environmental impacts as much as possible.

The Group understands that the development of the passenger and freight transportation industry is inherently related to climate change, and addressing climate change represents a significant challenge for the industry. As one of the largest cross-border waterway passenger transportation operators and navigation logistics operators in the Greater Bay Area, the Group actively implemented different measures for mitigating and adapting to climate change. The Group actively promoted environmental protection awareness to its employees, and encouraged its subsidiaries to improve utilisation efficiency of resources by reducing the use of fuel oil, water, electricity and other resources and guaranteed waste would be properly treated. The Group also promoted the use of electrical equipment during the operation process, so as to reduce the emissions from fuel combustion. Meanwhile, the Group regularly inspected machinery and equipment to ensure compliance with the relevant discharge standards. In addition, the Group has also established annual environmental goals and action plans in accordance with the key performance indicators of the Hong Kong Stock Exchange's version of the ESG Reporting Guidelines (《ESG報告指号》), and coordinated the promotion and construction of a resource-saving and environmentally friendly society so as to promote the harmonious development of humans and nature.

Regarding compliance operation, the Group strictly complies with the laws and regulations of jurisdictions where its businesses operate, including but not limited to the relevant laws and regulations applicable to Hong Kong, Mainland China and Macao, and operates in accordance with laws and regulations. During the year, the Group operated its business in accordance with the requirements of the Guideline on Internal Control for Listed Companies (《上市公 司內部控制指引》), Guidelines for Enterprise Internal Control (《企業內部控制基本規範》), the Listing Rules and the relevant rules promulgated by the State-owned Assets Supervision and Administration Commission of Guangdong Province, and made continuous efforts to improve and fine-tune its corporate governance structure. Through methods including the general meetings, the Board, the independent director's system, procedural rules and the Governance and Working Groups for ESG Report, the Group strived to ensure a clearly-defined responsibility system in its daily operation, transparent and open decision-making procedure and sound and effective internal control and feedback system. Based on its business strategies and objectives, the Group has formulated the Comprehensive Risk Management Measures (《全面風險管理辦法》) which comprehensively take into consideration the factors such as business growth, risk and profitability. It builds an overall risk management structure by three layers of defense in the operating mechanism. The Group also puts forward requirements for risk management work and conducts risk assessments every year and incorporates key risks into audit priorities and ensures compliant operations by carefully reviewing relevant legal and regulatory requirements. During the year, there was no material change in relevant laws and regulations which could have a material impact on the business and operation of the Group and the Group had complied with them in all material aspects without major non-compliance.



As for human resources, the Group pursues principles of equality, voluntariness and consensus and abides by people-oriented principle in affairs such as the provision of employment opportunities, remuneration, training, performance assessment, promotion and other employee benefits. During the year, the Group strives to protect employees' rights by strictly complying with the laws and regulations related to employment and labour practices that have a significant impact on the Group. The Group has well established policies, practices and management standards to manage the procedures pertaining to compensation and dismissal, recruitment and promotion, working hours, period of leave, equal opportunity, diversity, anti-discrimination, other entitlements and welfare as well as to prevent child and forced labor. In addition, the Group provides its employees with a smoke-free, healthy, well-equipped and safe office environment to foster a healthy and comfortable working environment. The Group also continuously invests resources in offering vocational training for employees, aiming to enhance their skills, knowledge and understanding of the latest industry trends, as well as to raise their awareness of regulatory compliance, striving to improve their performance in their respective roles and to promote the realisation of their self-worth.

As for operation, safety is always our utmost priority, the Group makes every effort to ensure workplace safety during daily business operations. As such, the Group established a comprehensive safety management system, ensuring that the highest standard of occupational health and safety is embedded in every business segment of the Group. At the same time, the Group established policies, operating processes and guidelines such as the "Safety Production Inspection System" (《安全生產檢查制度》) and the "Measures for the Implementation of Safety Production Risk Assessment" (《安全生產風險評估實施辦法》) to govern our operation so as to reduce potential safety risks and protect our employees. The Group also established the mindset of safety, continually reinforcing employees' awareness of occupational health and safety, and further strengthening the management of occupational health and safety. Safety Training is provided to employees to equip them with comprehensive knowledge of safety operations to ensure they possess requisite safety skills for their job roles.

As for the customers and suppliers, the Group perceives them as important stakeholders and always keeps good cooperative relationships with them. As a responsible corporate citizen, through establishing a communication mechanism and intensifying information disclosure, actively communicating with key customers and suppliers to know their needs and take appropriate measures to respond timely. The Group also continuously explores various channels to maintain good communications with the stakeholders and to strengthen interaction between them so as to establish a close relationship with the stakeholders. Through constructive communication, the Group tries to balance the opinions and interests of the stakeholders so as to set the direction for the long-term development of the Group. As a responsible service provider, the Group strives to enhance the quality in delivering excellent services to its customers. Meanwhile, the Group makes every effort to protect customer privacy and strictly prevented abuse of customer information. During the year, the Group strictly complies with laws and regulations related to health and safety, advertisement, and privacy matters that have a significant impact on the Group. For the selection of suppliers, the Group sets stringent screening criteria and establishes a comprehensive bidding process. The Group established the "Domestic/Foreign Enterprise Tendering and Bidding Implementation Rules" (《境內/外 企業招標投標管理辦法》) to govern the tendering and bidding process, ensuring that the process is conducted in a fair and equal manner. For supplier management, the Group regularly evaluates the quality, delivery and services of suppliers in accordance with the standards and procedures of the ISO9001:2015 quality management system every year to ensure that their products and services conform to the standards. If the conditions of any supplier are found to be incompatible with the requirements, the Group shall suspend its cooperation with the supplier and require the supplier to carry out rectification, until the requirements are met.

During the year ended 31 December 2023, the Group is not in breach of any laws or regulations relating to its business and operations (environmental, labour, occupational health and safety, anti-corruption and data privacy, etc.) in Hong Kong, Mainland China and Macao.



FINANCIAL REVIEW

Financial Management and Control

The Group consistently adopted a prudent financial management policy. Fund management, financing and investment activities were all undertaken and monitored by the management of the Company.

Given the industry characteristics of the core business of the Group, the emphasis of routine financial control management was placed on the management of working capital, particularly the timely receipts of trade receivables. As at 31 December 2023, net trade receivables of the Group amounted to HK\$291,841,000, representing an increase of 33.5% as compared with last year, of which 81.5% of trade receivables were aged within 3 months. Exposure to bad debts was controlled at a reasonable level.

Review of Financial Results

The Group recorded a profit attributable to equity holders of the Company of HK\$114,069,000, representing an increase of HK\$20,579,000 or 22.0% as compared with last year, details of which are as follows:

The Group's share of profits less losses of joint ventures and associates for the year increased by HK\$50,994,000 or 266.6% from last year to profits of HK\$31,869,000. Among these, profit after taxation attributable to terminal navigation logistics business was HK\$11,375,000 (2022: HK\$12,312,000) and profit after taxation of passenger transportation business was HK\$20,494,000 (2022 losses: HK\$31,437,000).

Liquidity, Financial Resources and Capital Structure

The capital structure of the Group was constantly monitored by the Company. The use of any capital instruments, including banking facilities, by each subsidiary was under the central coordination and arrangement of the Company.

The Group closely monitored its working capital and financial resources to maintain a solid financial position. As at 31 December 2023, the Group secured a total credit facilities of HK\$1,186,650,000 and RMB122,815,000 (equivalent to approximately HK\$135,527,000) (2022: HK\$1,185,000,000 and RMB148,610,000 (equivalent to approximately HK\$166,361,000)) granted by bona fide banks.

As at 31 December 2023, the current ratio of the Group, calculated by dividing current assets by current liabilities, was 1.9 (2022: 1.8).

As at 31 December 2023, the Group's bank deposits and cash and cash equivalents amounted to HK\$1,038,838,000 (2022: HK\$1,063,573,000), which represented 22.8% (2022: 23.3%) of the total assets.

As at 31 December 2023, the gearing ratio of the Group, represented by bank borrowings divided by total equity and bank borrowings, was 8.8% (2022: 10.0%) and the debt ratio, representing total liabilities divided by total assets, was 23.1% (2022: 23.5%).

After considering its current cash and cash flows from operating activities, as well as the credit facilities available to the Group, it is believed that the Group has sufficient capital to fund its future operations and for business expansion and general development purposes.

During the year, the Group did not use any other financial instruments for hedging purpose.

DIVIDENDS

The Board has approved and adopted a "Dividend Policy" on 1 January 2019 in order to provide return to the shareholders of the Company (the "Shareholders"). For proposing distribution of dividends to the Shareholders' meeting, the Board will measure the capital needs in future years based on the future capital budget plan of the Company and consider factors such as profitability and financial structure of the Company comprehensively. However, the target dividend to be distributed to the Shareholders in any financial year shall be not less than 30% of the profit attributable to the equity holders of the Company (if any) in that financial year, which is payable wholly in cash or in non-cash benefits or partly in cash and partly in non-cash benefits, subject to: a) the Companies Ordinance (Chapter 622 of the Laws of Hong Kong); b) the Listing Rules; and (c) the Articles of Association of the Company (the "Articles of Association"). The Board may revise the target dividend payout ratio based on the overall operating conditions.

The Board had not declared an interim dividend (2022: HK0 cents per ordinary share). The Board has proposed a final dividend of HK5 cents per ordinary share (2022: HK4 cents and HK2 cents for special dividend per ordinary share), totaling approximately HK\$56,058,000 (2022: HK\$67,270,000) to Shareholders whose names appeared on the register of members on 7 June 2024. The final dividend is expected to be paid in cash.

With reference to the current bank deposits and cash and cash equivalents, the dividends declared for 2023 was HK5 cents per share, the percentage of total dividends over the profit attributable to equity holders of the Company (the "**Dividend Payout Ratio**") decreased as compared with previous year. EMPLOYEES AND REMUNERATION

As at 31 December 2023, the Group employed 2,206 employees (2022: 2,231) and remunerated its employees according to the duty of their positions and the market conditions. The staff costs of the Group for the year amounted to HK\$584,655,000 (2022: HK\$569,975,000), which included basic salaries and employee benefits such as discretionary bonus, medical and insurance plans, pension scheme and share option scheme, etc. The Group will also provide trainings for staff from time to time in addition to the above employee benefits.

SIGNIFICANT RISKS AND UNCERTAINTIES

The operating results, financial position, business and corporate prospects of the Group may be affected by various risks and uncertainties. The followings are the significant risks and uncertainties identified by the Group. Save as disclosed below, other risks that may become significant in the future but are unknown to the Group or are currently insignificant may exist.

Fluctuating Demand and Market Risk Ι.

Affected by the downward trend in the global economy, the worldwide navigation market is widely expected to remain subdued. In 2023, the recovery of global economy was impeded by the impacts of geopolitical conflicts and energy crises, leading to a significant decline in the navigation market compared to 2022. Against this backdrop, demand for global navigation in 2024 is anticipated to persist at the subdued levels observed in 2023. Compounded by increasing uncertainty, the negative effects of extreme weather events, escalating geopolitical disputes, and the imposition of carbon taxes by European Union on the navigation sector, the global navigation market is expected to continue experiencing pressure and volatility.

In the cargoes transportation business, as one of the largest river trade cargo terminal operators in the Greater Bay Area, the Group has expected to confront challenges arising from further declines in demand for navigation logistics business, an absence of underlying support for increased freight rate, and intensified competition at river terminals. These factors lead to a situation where the benefits of economies of scale are insignificant, and the core business encounters considerable challenges in its upgrades and transformation.

To cope with the risks, the Group has committed to actively promoting the high-end transformation and upgrading of the businesses, aiming to expand its core scale of the cargo terminals, navigation and storage businesses within the Greater Bay Area. On one hand, the Group has vigorously promoted the development of high-end storage business, focusing on establishing strategic storage logistics hubs centred around Hong Kong and Zhuhai, and deploying a number of comprehensive or specialised logistics parks and logistics centres as carrier platforms. On the other hand, the Group has extended the logistics service supply chain, fostered new core businesses, and robustly promoted modern logistics services, including air freight logistics, supply chain logistics, cold chain distribution, and duty-free product storage, etc., in order to establish a comprehensive supply chain logistics network.

In the passenger transportation business, as one of the largest waterway passenger service providers in the Greater Bay Area, the Group anticipated challenges stemming from the ongoing erosion of its core competitive advantage by land and air transportation alternatives, as well as intensified competition within the industry. Among these, the cross-border waterway passenger business was the most affected facing a conundrum of market contraction following the resumption of normal traveller clearance, with an inability to revert to prepandemic levels in the short term. Currently, the Group's cross-border waterway passenger business has been actively implementing measures to mitigate losses and still has a significant reliance on government subsidies.

To better address market risks, the Group will continue to fortify its coordination and control capabilities over passenger transportation terminals and the corresponding production factors in order to deepen integrated operation of cross-border passenger transportation. Firstly, this will involve rational coordination and planning of route layouts, the establishment of a new media marketing network, and the provision of one-stop ticket sales services to gradually enhance the comprehensive influence and conversion rate of the "Cross-border+" passenger transport product system. Secondly, the Group will further reduce operating costs and streamline management processes to improve levels of intensive control and operational efficiency. Thirdly, the Group will enhance route evaluations, make effective use of subsidies, and dynamically adjust strategies with flexibility. Additionally, the Group is working through multi-dimensional channels to add entry and exit channels at the SkyPier at Hong Kong International Airport, thereby developing new potential routes for cross-border passenger transportation.

II. Competitive Risk

Competitive risks faced by the Group are mainly reflected in two aspects. The first aspect is the further intensified disorderly competition. There are many cargo terminals in the Greater Bay Area city cluster hosting various kinds of terminal business. Large central enterprises and local enterprises possess stake holdings or controlling stakes in core terminals; under collectivised operation, some companies are willing to boost development in other businesses at the expense of profitability of their terminal business, and thus intensify competition in the industry. The second aspect is fierce competition in extension of terminal business. The efficiency of tractor and barge operations has seriously undermined competitiveness of the terminals, while some ports provide subsidies for cargo tractors and barges, thereby also undermine competitiveness of the Group's terminal business in the region.

To cope with these risks, the Group has primarily adopted the following measures. Firstly, the Group will restructure operations at core terminals by incorporating elements associated with various modes of transportation. This includes providing key freight logistics information and comprehensive logistics solutions, with the aim of extending trade and industry services. This initiative is designed to transform terminals from single logistics points into sophisticated and integrated logistics hubs. Secondly, the Group will optimise the freight and barge route network, with a focus on improving economic efficiency at terminals which are not directly operated by the Group. For those non-Group terminals that have a stable and sufficient flow of goods, along with convenient access to transportation networks, the routes shall be consolidated to amplify their economies of scale. Thirdly, the Group will strategically focus on enhancing the capabilities in modern logistics. By targeting project logistics and the transport of oversized cargo as entry points, the Group aims to improve the comprehensive service abilities across the entire logistics chain with the intention to expand the range of modern logistics services and coverage provided to customers, which in turn broadens business channels, strengthen customer retention, and increase market share of the Group in the logistics market.

III. Investment Risk

The Group's business investment is mainly focused on Guangdong, Hong Kong and Macao. In the future, the investment will gradually radiate to Southeast Asia, the Group has already commenced network business in Singapore, Malaysia and Vietnam. With further implementation and advancement of the Regional Comprehensive Economic Partnership Agreement, the Group will continue to strengthen its investment in the freight transportation businesses in relevant countries, and will strengthen its investment risk assessment in these relevant countries. Investments in projects in the Mainland China and Hong Kong are more influenced by overall economic environment, meanwhile as rules and regulations are continuously improving in the Mainland China, new investment projects will be more influenced by policies and local cooperation units, the Group is committed to conducting a comprehensive assessment of the risks involved.

IV. Human Resources Risk

In recent years, the Group's main business has been seriously affected by the overall economic and market environment, resulting in a contraction of its business. This trend has resulted in a relatively low overall salary level in the industry, which is not conducive to the healthy development of human resources as a whole, especially, there is a significant shortage of ship crews, equipment handlers, and senior management personnel, which has made recruiting new staff difficult and has led to a high turnover rate.

Major preventive measures to be implemented by the Group: Firstly, the Group is committed to enhance the standard of human resources management, which includes strengthening regional human resources management, improving internal work communication between employees, and enhancing job skills. Secondly, the Group will continuously optimise remuneration management system, which includes improving the remuneration system, insisting to conduct performance appraisal management, and continuing to broaden the promotion path for employees in order to stimulate employee motivation. Thirdly, the Group will take steps to strengthen staff training, to pay attention to pre-service training for new employees, and to enhance quality and practical training for skilled personnel; meanwhile the Group will also take steps to pay attention to employees' personal career development, and carry out talent reserve and talent ladder in an orderly manner. Fourthly, the Group is committed to enhancing its brand reputation through vigorous promotion, leveraging a positive corporate image and a broad development platform to increase the Group's attractiveness to key talent.



V. Funding Risk

The day-to-day operations and investment activities of the Group's subsidiaries are currently concentrated in Guangdong Province, Hong Kong, and Macao, with operating revenues and expenses mainly denominated in HKD, as well as in RMB and USD. The RMB revenue received from Mainland China may be used for payment of Group expenses incurred in the Mainland China denominated in RMB, while the HKD and USD revenue received in Mainland China may be remitted to the Group's bank accounts in Hong Kong through proper procedure as planned. In the short term, the Group will not be subject to significant foreign exchange risks as long as the linked exchange rate system in Hong Kong remains unchanged.

As the regulatory authorities in Mainland China continuously tightened the regulation magnitude on the remittance of funds abroad, the remittance of funds abroad is anticipated to be delayed. To mitigate financial risks in a timely manner, the Group will continue to maintain good communication with banks, keep abreast of policy directions and get well prepared in advance. At the same time, under the guidance of the Group, subsidiaries are required to make a sufficient risk assessment on the financing size, method, and channel in the process thereof. The Group will, when appropriate, increase the registered capital to certain companies, considering it in conjunction with strategic investment and development, so as to effectively reduce the financing cost.

PURCHASE, REDEMPTION OR SALE OF THE COMPANY'S LISTED SECURITIES

No listed securities of the Company were purchased or sold by the Company or any of its subsidiaries for the year. The Company did not redeem any of its shares during the year.

CAPITAL RAISING ACTIVITIES DURING THE YEAR AND USE OF PROCEEDS

There was no capital raising activity by the Group during the year.

SHARE CAPITAL

There were no changes in the share capital of the Company during the year. Details of the Company's capital during the year are set out in note 18 to the financial statements.

RESERVES

Details of movements in the reserves of the Group and the Company during the year are set out in consolidated statement of changes in equity and note 36 to the financial statements respectively.



DISTRIBUTABLE RESERVES

As at 31 December 2023, the Company's distributable reserves, calculated in accordance with Part 6 of Hong Kong Companies Ordinance, amounted to HK\$1,451,035,000 (2022: HK\$1,445,952,000), of which approximately HK\$56,058,000 (2022: HK\$67,270,000) has been proposed as final dividend for the year.

MAJOR CUSTOMERS AND SUPPLIERS

During the year ended 31 December 2023, the combined value of the Group's contracts with its five largest suppliers accounted for less than 30% of the total value of supplies purchased. The Group's five largest customers together contributed less than 30% of its total revenue and other income during the year ended 31 December 2023.

EQUITY-LINKED AGREEMENT

Share Option Scheme

In accordance with the share option scheme (the "Share Option Scheme") approved and adopted on the general meeting of the Company held on 8 December 2015 (the "Adoption Date"), the Board may grant share options to the incentive objects in accordance with the terms and conditions stipulated in the Share Option Scheme upon satisfaction of the specified conditions by the Company and the incentive objects.

Details of the Share Option Scheme are disclosed in the circular of the Company dated 23 November 2015, the main details of which are as follows:

Purposes

The purposes of the Share Option Scheme are to:

- (1) enhance Shareholders' value and safeguard the interest of the stakeholders;
- (2) optimise the reform of the remuneration system of the Company to form a profit-sharing and risk sharing mechanism among the shareholders, the Company and its employees, and to effectively motivate the incentive of the senior management and key personnel of the Company;
- (3) assist the management of the Company to balance short-term and long-term objectives and assist the strategic realisation and long-term sustainable development of the Company; and
- (4) attract and retain quality management and key business personnel to ensure the long-term development of the Company.



Incentive Objects

The grantees of share options shall, in principle, include the senior management including the chairman, Directors (excluding independent non-executive Directors), general manager, deputy general manager, financial controller, secretary to the Board, assistant to general manager and other members of the management of the same rank and taking executive positions of the Company and its subsidiaries.

Any grant of share options to Directors, chief executives or substantial Shareholders or their respective associates by the Company shall be subject to the approval of the independent non-executive Directors.

The Board may only grant share options to the incentive objects in accordance with the Share Option Scheme upon satisfaction of the following conditions by the Company and the incentive objects:

- (1) None of the following circumstances has occurred to the Company:
 - 1. a qualified opinion or disclaimer of opinion by the auditors in the auditor's report on the issued financial and accounting report for the most recent accounting year;
 - 2. imposition of administration penalties by the regulatory authorities during the most recent year due to material non-compliance of laws and regulations; and
 - 3. other circumstances that in the opinion of the Hong Kong Stock Exchange would render the implementation of the Share Option Scheme impossible.
- (2) According to the measures on the performance appraisal of the Company, the performance appraisal on the proposed incentive objects in the preceding financial year prior to the initial grant of share options must reach pass grade or above.
- (3) None of the following circumstances has occurred to the incentive objects:
 - 1. public censure or declaration as ineligible candidate to be a director by the Hong Kong Stock Exchange in the most recent three years;
 - 2. imposition of administrative penalties or public censure by the regulatory authorities during the most recent three years due to material non-compliance of laws and regulations.

Save as disclosed above, the Board is also entitled in accordance with the business performance of the Company to set concrete business performance indicators and targets as the additional conditions of grant of share options and to adjust the number of share options to be granted based on the fulfilment of performance-based conditions. Subject to the terms of the Share Option Scheme and the Listing Rules, the Board may in its absolute discretion impose any conditions, constraints, or restrictions as it sees fit upon the offer.

Limit

The total number of new shares of the Company that may be issued upon exercise of options that may be granted under the Share Option Scheme shall not, in aggregate, exceed 10% of the relevant class of shares of the Company as at the date on which the Share Option Scheme is approved by the Shareholders (the "Scheme Mandate Limit"), and the Company may at any time as the Board thinks fit, seek approval from the Shareholders to refresh the Scheme Mandate Limit, except that the number of shares to be issued upon exercise of all the share options granted but yet to be exercised under the Share Option Scheme and any other schemes shall not exceed 30% of the total number of issued shares of the Company from time to time; whereas the total number of the shares to be issued upon exercise of all the share options granted but yet to be exercised under all equity incentive schemes of the Company that are currently in force shall not, in aggregate, exceed 10% of the total number of issued shares of the Company from time to time.

The total number of share options to be granted initially under the Share Option Scheme shall not exceed 1% of the total number of issued shares of the Company.

Unless approved by the Shareholders, the total number of shares which are issued and will be issued upon exercise of options (including those exercised, cancelled and outstanding) granted and to be granted to any particular incentive object under the Share Option Scheme and any other share option schemes of the Company within any 12-month period must not exceed 1% of the total number of issued shares of the Company from time to time. Any further grant of share options to an incentive object which would result in the shares issued and to be issued upon exercise of options in the 12-month period up to and including the date of such further grant representing in aggregate over 1% of the total issued shares shall be subject to approval of the Shareholders in general meeting with such incentive object and his/her close associates (or his/her associates if such incentive object is a connected person) abstaining from voting.

Acceptance of Offer of Share Options and Payment

Upon the Board's approval of the grant of share options proposed by the Remuneration Committee, an offer which sets out the conditions of the offer of the share options is made to the incentive objects. Where the incentive objects accept the offer within 21 days from the offer date (or any other date as determined by the Board in its discretion in accordance with the Listing Rules) and a payment of HK\$1.00 is made to the Company as consideration of accepting the grant of share options, the offer shall be deemed to have been accepted and become effective. Such payment shall in no circumstances be refundable or deemed to be part of the subscription price.

Where the offer is not accepted in the manner stated in the Share Option Scheme within 21 days from the date on which the offer is made, the offer shall be deemed to have been irrevocably rejected and shall automatically lapse.



Effective Date of Share Options

All incentive objects shall not exercise their share options granted under the Share Option Scheme within two years from the grant date and in principle, from the grant date:

- (a) one-third (1/3) of the share options granted to each incentive object shall be vested after its second anniversary (after 24 months);
- (b) another one-third (1/3) of the share options granted to each incentive object shall be vested after its third anniversary (after 36 months);
- (c) the remaining one-third (1/3) shall be vested after its fourth anniversary (after 48 months).

The Board is also entitled in accordance with the business performance of the Company to set concrete business performance indicators and targets as the additional conditions of the vesting of share options and to adjust the number of share options to be vested based on the fulfilment of performance-based conditions, provided that the details of the performance-based conditions shall be determined by the Board and incentive objects be notified upon the grant of share options.

Validity Period of Exercise of Share Options

The validity period for the exercise of options granted under the Share Option Scheme shall be five (5) years from the effective date. Upon expiry of the validity period, the outstanding share options shall automatically lapse and cannot be exercised retrospectively.

Exercise Price

The exercise price of the share options shall be determined by the Board in its absolute discretion upon the grant of share options with reference to the fair market price and shall not be less than the higher one of the following two prices:

- (a) the closing price of the shares of the Company as stated in the daily quotation sheet of the Hong Kong Stock Exchange on the date of grant; and
- (b) the average closing price of the shares of Company as stated in the daily quotation sheets of the Hong Kong Stock Exchange for five consecutive business days immediately preceding the date of grant.



Validity Period of the Share Option Scheme

Unless the Share Option Scheme has been otherwise terminated as provided therein, it shall be valid for ten (10) vears from the Adoption Date and will terminate on 7 December 2025.

The Shares Issuable under the Share Option Scheme

The total number of shares that may be issued under the Share Option Scheme is 108,000,000, representing 9.6% of issued shares of the Company as at the date of this annual report. On 18 December 2015, the Company granted share options (which were duly accepted by the eligible persons subsequently) under the Share Option Scheme to certain eligible persons to subscribe for a total of 9,165,000 ordinary shares. All granted share options have lapsed due to reasons including failure to meet performance indicators, employee resignations or retirements, etc.

During the year, no share options were granted under the Share Option Scheme, so the Company did not receive any consideration.

The remaining total number of shares which may be issued under the Share Option Scheme amounts to 98,608,000 shares, representing approximately 8.8% of the issued shares of the Company as at the date of this annual report.

CONTINUING CONNECTED TRANSACTIONS (THE "CCT")

Master Passenger Transportation Agency Services Agreement

On 30 November 2021, the Company (on behalf of the Group, as a service provider) entered into a master passenger transportation agency services agreement (the "Master Passenger Transportation Agency Services Agreement") with GDPS (the Company's parent company, on behalf of the GDPS Group, as a service recipient), in respect of any member of the Group agree to accept the appointment of any member of the GDPS (as an agent or operator and/or owner of the passenger ferry services) as the exclusive agent/subagent of the Group's waterway passenger transportation business in Hong Kong (for routes to and from Hong Kong and Pearl River Delta region). Waterway passenger agency services include (i) ferry operation agency service; (ii) ticketing agency service; (iii) ferry berthing agency service and (iv) ferry technical support agency service.

The term of the Master Passenger Transportation Agency Services Agreement is three years from 1 January 2022 to 31 December 2024. The service fee charged by the Group for the provision of passenger transportation agency services for ferries operated by GDPS is based on a percentage of ticket sales, and taking into account of the cost of providing ticketing services, and the cost of passenger handling services (including passenger arrival and departure services and security checks), the cost of ferry (including the arrangement of regular maintenance and emergency ad hoc repairing services to ferries in Hong Kong), the cost of providing relevant facilities, and the cost of labour incurred by the Group in providing ground services plus a profit margin to be agreed. In order to ensure that the terms and profit margins for the provision of services are in line with the prevailing market rates and market terms, the Group will consider at least two quotations for service charges offered to other ferry operators (who are independent third parties berthing at the same terminal and require similar passenger transportation agency services from the Group) as a reference. The service fees offered by the Group shall be no more favourable than the service fees offered by the Group to other independent third parties for similar services. The annual caps of the Master Passenger Transportation Agency Services Agreement for the years ended 31 December 2022, 2023, and 2024 are HK\$9,000,000, HK\$12,000,000 and HK\$15,000,000 respectively. The total amount of the aforesaid transactions for the year ended 31 December 2023 was HK\$10,850,000.

2. Master Ferry Technical Support Agency Services Agreement

On 30 November 2021, the Company (on behalf of the Group, as a service recipient) entered into a master ferry technical support agency services agreement (the "Master Ferry Technical Support Agency Services Agreement") with GDPS (the Company's parent company, on behalf of the GDPS Group, as a service provider), in order to facilitate any member of the Group to provide passenger transportation agency services (as one-stop integrated agency services, which include services for arranging ferries for regular maintenance and repairing, and emergency ad hoc repairing services in Hong Kong) to those ferries for which such member of the Group was appointed by any member of the GDPS Group as agent and/or subagent for the provision of passenger transportation agency services (the "Relevant Ferries"). At the same time, such member of the Group and local ferries would acquire from any member of the GDPS Group the regular maintenance and repairing and emergency ad hoc repairing services under the Master Ferry Technical Support Agency Services Agreement.

The term of the Master Ferry Technical Support Agency Services Agreement is three years from 1 January 2022 to 31 December 2024. The pricing basis for the ferry technical support agency services is determined on the basis of the market rates for maintenance and repair technical support services charged by GDPS. In order to ensure that the service fees payable by the Group and the terms offered by GDPS are fair and reasonable and in line with the prevailing market rates, the Group will obtain two quotations from other service providers (who are independent third parties with scale similar to GDPS) that offered to other customers (with scale similar to the Group) for the provision of similar ferry technical support agency services prior to the renewal of the Agreement. The relevant fees and terms offered to the Group shall be no less favourable than those offered by independent third parties. The annual caps of the Master Ferry Technical Support Agency Services Agreement for the years ended 31 December 2022, 2023, and 2024 are HK\$19,000,000, HK\$21,000,000 and HK\$23,000,000 respectively. The total amount of the aforesaid transactions for the year ended 31 December 2023 was HK\$16,433,000.

Master Ferry Terminal Luggage Facilities and Handling Services Agreement

On 30 November 2021, the Company (on behalf of the Group, as a service recipient) entered into a master ferry terminal luggage facilities and handling services agreement (the "Master Ferry Terminal Luggage Facilities and Handling Services Agreement") with GDPS (the Company's parent company, on behalf of the GDPS Group, as a service provider) in respect of the provision of ferry terminal luggage facilities and handling services by any member of the GDPS Group, at the request of any member of the Group from time to time, to any member of the Group (who stop their ferries at the relevant terminal for passengers departing from and arriving in Hong Kong), in accordance with the terms and conditions of the relevant ferry terminal luggage facilities and handling services agreement to be entered into between any member of the Group and any member of the GDPS Group. The provision of the ferry terminal luggage facilities includes (among others) the provision of such facilities at the relevant terminals, which allows the passengers departing from and arriving in Hong Kong at the relevant terminals to check-in and/or undergo clearance of their luggage at the relevant terminals. The provision of luggage handling services includes (among others) the operation, maintenance and repairing of the luggage handling system and equipment situated at the relevant terminals, and the provision of luggage handling services and berthing services to all passenger ferries using the relevant terminals. All passenger ferries between the Pearl River Delta region and Hong Kong are designated by the relevant Hong Kong government agencies to berth at the relevant terminals in Hong Kong, one of which is the relevant terminal.

The term of the Master Ferry Terminal Luggage Facilities and Handling Services Agreement is three years from 1 January 2022 to 31 December 2024. The service fee charged by GDPS for the provision of terminal luggage facilities and handling services at the relevant terminals is the standard rate and is the same as the prevailing rate charged to other ferry service carriers (which are independent third parties) at the same relevant terminal. The service fee for the provision of the terminal luggage facilities and handling services comprises (i) passenger levy (which is based on the number of passengers departing from and arriving at the relevant terminals); and (ii) luggage handling charges (which is based on the number of luggage handled at the relevant terminals). The passenger levy and luggage handling charges shall be agreed by the parties from time to time after arm's length negotiations with reference to the prevailing rates charged to other ferry operators (other than the Group) of other routes at the same relevant terminal at the relevant time. Such terms shall be no less favourable than the terms on which GDPS provides similar services to independent third parties in the ordinary course of its business at the relevant terminals. The annual caps of the Master Ferry Terminal Luggage Facilities and Handling Services Agreement for the years ended 31 December 2022, 2023, and 2024 are HK\$4,400,000, HK\$5,800,000 and HK\$6,600,000 respectively. The total amount of the aforesaid transactions for the year ended 31 December 2023 was HK\$1.740.000.

Master Sub-baggage Handling Services Agreement

On 30 November 2021, the Company (on behalf of the Group, as a service provider) entered into a master subbaggage handling services agreement (the "Master Sub-Baggage Handling Services Agreement") with GDPS (the Company's parent company, on behalf of the GDPS Group, as a service recipient) in respect of any member of the Group agree to accept the appointment of any member of the GDPS Group (who is appointed and authorised by the relevant government authorities to provide terminal baggage facilities and handling services at the relevant terminal) as a subcontractor to provide baggage handling services at the relevant terminals. For that matter, any member of the Group agrees to provide baggage handling services directly to all ferry service carriers (including but not limited to the Group itself) that stop their ferries at the relevant terminals for passengers entering and leaving Hong Kong, at the request of any member company of GDPS from time to time, in accordance with the terms and conditions of the relevant sub-baggage handling service agreement to be signed between any member company of the Group and any member company of GDPS.

The term of the Master Sub-baggage Handling Service Agreement is three years from 1 January 2022 to 31 December 2024. The sub-baggage handling charges were agreed from time to time after arm's length negotiation between the parties by making reference to the amount of the handling charges received by the relevant member of the GDPS Group from all ferry service carriers based on the number of luggage handled at the relevant terminal. The service fee for baggage handling services provided by the Group under the Master Sub-baggage Handling Service Agreement shall be the same as the handling fee levied by the relevant member of the GDPS on all ferry carriers. These terms shall be no more favourable than the terms offered by the Group to independent third parties. For the years ended 31 December 2022, 2023 and 2024, the annual caps for the total baggage handling service agreement are HK\$5,500,000, HK\$7,500,000 and HK\$8,500,000 respectively. The total amount of the above transactions for the year ended 31 December 2023 was HK\$1,267,000.

5. Master Rental Agreement

On 30 November 2021, the Company (on behalf of the Group, as a lessee) entered into a master rental agreement (the "Master Rental Agreement") with GDPS (the Company's parent company, on behalf of the GDPS Group, as a lessor), in respect of any member of the GDPS Group agree to lease, at the request of any member of the Group, the property owned by any member of the GDPS Group (including but not limited to warehouses, offices, parking spaces and staff quarters) to any member of the Group from time to time, in accordance with the terms and conditions of the relevant rental agreement to be entered into between any member of the Group and any member of the GDPS Group.

The term of the Master Rental Agreement is three years from 1 January 2022 to 31 December 2024. The rent in respect of leasing of the warehouses, offices, car parking spaces and staff quarters are based on arm's length negotiation between each party involved with reference to the prevailing market rates for properties of similar size and quality of the said properties in the same region. Prior to the renewal of the rental agreement, the Group will obtain two lists of other comparable properties. The Group will compare the information obtained to determine whether the quoted prices and terms provided by the GDPS Group are no less favourable than those offered by independent third parties. The annual caps of the Master Tenancy Agreement for the years ended 31 December 2022, 2023 and 2024 are HK\$28,000,000, HK\$28,000,000 and HK\$28,000,000 respectively. The total amount of the aforesaid transactions for the year ended 31 December 2023 was HK\$17,077,000.

6. Master Vessels Rental Agreement

On 30 November 2021, the Company (on behalf of the Group, as a lessee) entered into a master vessels rental agreement (the "Master Vessels Rental Agreement") with GDPS (the Company's parent company, on behalf of the GDPS Group, as a lessor) in respect of the GDPS agrees, at the request of any member of the Group and in accordance with the terms and conditions of the relevant vessel rental agreement to be entered into between members of the Group and members of the GDPS Group, to (i) lease the cargo vessels owned by the GDPS Group to the Group from time to time (inclusive of relevant expenses for operating the cargo vessels but excluding fuel charge); and (ii) provide non-scheduled vessel space or charter vessels for transportation of cargo between the PRC and Hong Kong.

The term of the Master Vessels Rental Agreement is three years from 1 January 2022 to 31 December 2024. The rent in respect of the leasing of cargo vessels is determined with reference to the prevailing market rental of cargo vessels and the relevant cost of expenses for operating the cargo vessels (excluding fuel charge), and the service fees in respect of the provision of non-scheduled vessel space or charters vessels will be determined based on the space of the cargo vessel and the destination of transportation. The rental and service fees under the Master Vessels Rental Agreement are based on the number of monthly sailings and the charges for each route, and the charges for each route are based on the cargo tonnage and capacity of the cargo vessels. Prior to the renewal of the Agreement, the Group will obtain quotations from two cargo vessel providers operating similar routes, which are independent third parties with operation scale similar to that of the GDPS, to ensure that the terms of the Master Vessels Rental Agreement are no less favourable than those offered by the independent third parties. The annual caps of the Master Vessels Rental Agreement for the years ended 31 December 2022, 2023, and 2024 are HK\$48,000,000, HK\$51,000,000 and HK\$53,000,000 respectively. The total amount of the aforesaid transactions for the year ended 31 December 2023 was HK\$26,545,000.

7. **Master Ferries Rental Agreement**

On 30 November 2021, the Company (on behalf of the Group, as a lessee) entered into a master ferries rental agreement (the "Master Ferries Rental Agreement") with GDPS (the Company's parent company, on behalf of the GDPS Group, as a lessor) in respect of GDPS agree to lease its ferries, at the request of any member of the Group from time to time and in accordance with the terms and conditions of the relevant ferries rental agreements to be entered into between members of the Group and members of the GDPS Group.

The term of the Master Ferries Rental Agreement is three years from 1 January 2022 to 31 December 2024. The rent in respect of the leasing of ferries is based on the size and capacity of the ferries, the number of leased voyages and the prevailing market rates. Prior to the renewal of the agreement, the Group will obtain at least two quotations from ferry rental providers operating similar rental voyages, which are independent third parties of similar scale of operation to the Group, to ensure that the rental rates under the Master Ferries Rental Agreement are in line with the prevailing market rates and terms no less favourable than those offered by independent third parties. The annual caps of the Master Ferries Rental Agreement for the years ended 31 December 2022, 2023, and 2024 are HK\$7,000,000, HK\$7,800,000 and HK\$8,800,000 respectively. The total amount of the aforesaid transactions for the year ended 31 December 2023 was HK\$6,671,000.

8. Master Cargo Storage Agreement

On 30 November 2021, the Company (on behalf of the Group, as a service provider) entered into a master cargo storage agreement (the "Master Cargo Storage Agreement") with GDPS (the Company's parent company, on behalf of the GDPS Group, as a service recipient) in respect of any member of the Group agree to provide cargo storage services to any member of the GDPS Group, at the request by any member of the GDPS Group in accordance with the terms and conditions of the relevant cargo storage agreement to be entered into between any member of the Group and any member of the GDPS Group.

The Master Cargo Storage Agreement is for a term of three years commencing from 1 January 2022 to 31 December 2024, and the fees for the cargo storage services are determined by the parties at the time of entering into the relevant service agreement with reference to the weight and type of cargoes, mode of transportation, type of storage space required and operating costs. The fees quoted by the Group will be similar to those provided to independent third parties operating on a similar scale at the time of the relevant agreements to be entered into under the Master Cargo Storage Agreement to ensure that the terms under the Master Cargo Storage Agreement are no better than those provided by the Group to independent third parties. The annual caps of the Master Cargo Storage Agreement for the years ended 31 December 2022, 2023, and 2024 are HK\$3,600,000, HK\$3,800,000 and HK\$4,000,000 respectively. The total amount of the aforesaid transactions for the year ended 31 December 2023 was HK\$1,050,000.

Master Fuel Supply Agreement

On 30 November 2021, the Company (on behalf of the Group, as a service provider) entered into a master fuel supply agreement (the "Master Fuel Supply Agreement") with GDPS (the Company's parent company, on behalf of the GDPS Group, as a service recipient) in respect of supplying diesel and lubricants to passenger ferries and cargo vessels owned, chartered, operated or acted as agent by the GDPS Group in Hong Kong at the request by any member of the GDPS Group from time to time in accordance with the terms and conditions of the relevant fuel supply agreement to be entered into between members of the Group and members of the GDPS Group.

The term of the Master Fuel Supply Charge Agreement is from 1 January 2022 to 31 December 2024. Depending on the terms of supply and the size of customers, the price of diesel is determined by the terms of supply and customer size, and the Group's pricing basis for the supply of diesel is briefly described as follows: (a) the average spot price of diesel in the Singapore market for the month and (ii) the total of the diesel supplier's storage and transportation costs plus operational handling charges; or (b) based on the spot price of diesel in the Singapore market on the day prior to the supply of diesel, and with reference to Brent crude oil prices as well as the movement of diesel prices published by one of the largest diesel suppliers in Hong Kong. For the supply of lubricants, the Group will determine the amount based on cost plus prevailing market rate. The annual caps of the Master Fuel Supply Agreement for the years ended 31 December 2022, 2023, and 2024 are HK\$182,000,000, HK\$184,000,000 and HK\$185,000,000 respectively. The total amount of the aforesaid transactions for the year ended 31 December 2023 was HK\$73,093,000.

10. Master Transportation Agreement

On 30 November 2021, the Company (on behalf of the Group, as a service recipient) entered into a master transportation agreement (the "Master Transportation Agreement") with GDPS (the Company's parent company, on behalf of the GDPS Group, as a service provider) in respect of GDPS agree to the provision of (i) shipping transportation service; (ii) hauling and trucking service; (iii) wharf cargo handling service; and (iv) cargo agency service between Hong Kong and the PRC to the Group, at the request of any member of the Group from time to time in accordance with the terms and conditions of the relevant transportation agreement to be entered into between any member of the Group and any member of the GDPS Group.

The term of the Master Transportation Agreement is three years from 1 January 2022 to 31 December 2024. The service fee is determined based on the destination of transportation, size of the cargoes, weight of the cargoes and the number of cargoes. The Master Transportation Agreement includes the provision of cargo transportation services and related services to the relevant cargo terminals, which charged published rates for the provision of (i) shipping transportation services; (ii) hauling and trucking services; (iii) wharf cargo handling services; and (iv) cargo agency services similar to those between Hong Kong and the PRC. As the service fees and terms charged by the relevant terminals are based on published rates, the terms offered to the Group are no less favourable than those offered to independent third parties. The annual caps of the Master Transportation Agreement for the years ended 31 December 2022, 2023, and 2024 are HK\$74,000,000, HK\$78,000,000 and HK\$82,000,000 respectively. The total amount of the aforesaid transactions for the year ended 31 December 2023 was HK\$18.268.000.

11. Management Agreement

On 30 June 2023, the Company (on behalf of the Group, as a service provider) entered into a management agreement (the "Management Agreement") with CKSE (the Company's immediate holding company, as a service recipient) in respect of the provision of management services for the assets of CKSE.

The term of the Management Agreement was 3 years from 1 July 2023 to 30 June 2026. The management fees were agreed between CKSE and the Company on an arm's length basis, with reference to the costs incurred by the Company for providing the asset management service as well as the Company's experience in operating and managing the similar type of assets. The annual caps of the Management Agreement for the years ended 31 December 2023, 2024, 2025, and 2026 are HK\$12,500,000, HK\$25,000,000, HK\$25,000,000 and HK\$12,500,000 respectively. The total amount of the aforesaid transactions for the year ended 31 December 2023 was HK\$27,500,000.

The above CCT were beneficial for the operations of the Group and/or provided stable income and profit to the Group. The items (1) to (8) and (11) above were CCT subject to the reporting and announcement requirements and exempt from the independent Shareholders' approval requirement, while item (9) and (10) were CCT subject to the reporting, announcement requirement and the independent Shareholders' approval requirements which was approved by the independent Shareholders at the general meeting held on 20 January 2022.

The Board engaged the auditor of the Company to report on the Group's CCT in accordance with Hong Kong Standard on Assurance Engagement 3000 "Assurance Engagements Other Than Audits or Reviews of Historical Financial Information" and with reference to Practice Note 740 (Revised) "Auditor's Letter on Continuing Connected Transactions under the Hong Kong Listing Rules" issued by the Hong Kong Institute of Certified Public Accountants. The auditor has issued an unqualified letter containing the findings and conclusions in respect of the CCT set out above in accordance with Rule 14A.56 of the Listing Rules (the "Auditor's Letter"). The auditor has confirmed that the aforesaid CCT: (1) have been approved by the Board; (2) were in all material respects, in accordance with the pricing policies of the Group where the transactions involve the provision of goods or services by the Group; (3) were entered into, in all material respects, in accordance with the agreements relating to the transactions; and (4) have not exceeded the respective caps.

In accordance with Rule 14A.55 of the Listing Rules, the aforesaid CCT and the Auditor's Letter have been reviewed by the independent non-executive Directors. The independent non-executive Directors confirmed that the above CCT were entered into (a) in the usual course of business of the Group; (b) on normal commercial terms or better terms; (c) in accordance with the agreements relating to the transactions on terms that are fair and reasonable and in the interests of the Shareholders as a whole; and (d) without exceeding the relevant cap amount disclosed in previous announcements.

Part of the related party transactions (the "RPT") disclosed in note 35 to the financial statements are the CT/CCT under Chapter 14A of the Listing Rules. Mr. Zeng Lilang, aged 44, was appointed as a development officer of the Company in July 2022, mainly responsible for the investment development of the Group. Mr. Zeng joined the Group in 2003, and has worked successively as the deputy general manager and general manager of the human resources department of Cotai Chu Kong Shipping Management Services Company Limited since 2007, the general manager of the human resources department of Chu Kong High-Speed Ferry Company Limited since 2012, the assistant general manager, deputy general manager and general manager of Chu Kong Cargo Terminals (Gaoming) Co., Ltd. since 2013, and the general manager of Guangzhou Panyu Lianhuashan Pangang Transportation Co., Ltd. since 2019. Currently, Mr. Zeng is also the deputy chairman of Foshan New Port Ltd., director of Chu Kong Shipping (Guangdong) Investment Co., Ltd., Bonny Fair Development Limited, Chu Kong Shipping Investment (Norway) Limited, Brodrene AA Shipyard in Norway, Shenzhen State-owned Duty Free Goods (Group) Co., Ltd, and Guangzhou Nansha Feeders Terminal Co., Ltd.. Mr. Zeng has 20 years of experience in human resources management, passenger transportation and port logistics management.

Ms. Cheung Mei Ki Maggie, aged 57, joined the Company in 2008, she was appointed as a company secretary of the Company on 1 April 2012, and appointed as the deputy general manager of the capital operation department in 2018, responsible for the Group's capital planning, investor relations, company secretarial and corporate governance matters. Ms. Cheung served as the general manager in assurance and the deputy general manager of the internal audit department of the Company and was also the financial controller of Sun Ferry Services Company Limited from May 2020 to September 2022. Before joining the Company, Ms. Cheung had held a position in Hong Kong Air Cargo Terminals Limited. Ms. Cheung graduated from the Hong Kong Polytechnic University in 2010 with a master degree in corporate governance and graduated from The University of Strathclyde (in the United Kingdom) in 2003 with a master degree in business administration. She is a member of The Hong Kong Chartered Governance Institute (formerly known as The Hong Kong Institute of Chartered Secretaries), The Chartered Governance Institute in the United Kingdom (formerly known as The Institute of Chartered Secretaries and Administrators), the Hong Kong Institute of Certified Public Accountants, a fellow of the Association of Chartered Certified Accountants in the United Kingdom, a fellow of the Taxation Institute of Hong Kong and a Certified Tax Adviser in Hong Kong. She has over 30 years of experience in accounting, financial management and corporate governance.

Corporate Governance Report

The Company strives to maintain a high standard of corporate governance practices and procedures to safeguard the interests of its shareholders. The corporate governance level is constantly improved and enhanced by establishing an internal control and risk management system and enhancing accountability and transparency.

CORPORATE GOVERNANCE PRACTICE

The Directors have adopted various policies to ensure compliance with the requirement of the Corporate Governance Code (the "Code") under Appendix C1 of the Listing Rules (including the mandatory disclosure requirements set out in Part 1 of the Code (the "Mandatory Disclosure Requirements") and the provisions set out in Part 2 of the Code (the "Provisions") in the Listing Rules. The Board considers that the Company has complied with all the applicable provisions during the year except with the deviation as disclosed in this report. In the future, the Company will also adopt more Recommended Best Practices as set out in the Code according to actual needs, so as to further enhance the level of corporate governance.

CORPORATE CULTURE AND VALUES

In order to ensure that a healthy corporate culture is cultivated and that the Company's purpose, values and strategies are aligned with its culture, the Board will strictly enforce internal policies and internal risk assessments such as the Anti-Corruption Policy (《反貪腐政策》) and the Whistleblowing Policy (《舉報政策》). Apart from organising regular trainings for our employees, the Company will make appropriate adjustments to various policies from time to time in order to regulate and promote a legal, ethical and responsible corporate culture. The Company also places great emphasis on transparency and accountability, and will regularly communicate with relevant stakeholders with respect to their business performance. On the Board level, the Company requires all Directors to act with integrity, to lead by example, to be committed to promoting the said corporate culture, and to consistently reinforce the values of acting lawfully, ethically and responsibly.

The Company believes that fostering a legal, ethical, and responsible corporate culture is critical to the Company's long term sustainability goals, which in turn will enable the Company to nurture and attract talented individuals, build a healthy corporate culture, and maintain the Company's ability to grow sustainably and profitably.

DIRECTORS' AND EMPLOYEES' SECURITIES TRANSACTIONS

The Company has adopted a model code of conduct no less than that required by the Model Code as set out in Appendix C3 to the Listing Rules as its code of conduct of Directors conducting securities transactions. All Directors have confirmed, following specific inquiry of all Directors by the Company, that they have complied with the required standards set out in the Model Code in relation to such transactions during the year.

The Company has also formulated written guidelines regarding the securities transactions by the employees of the Company who may be exposed to insider information. The requirements of the written guidelines are no less exacting than those set out in the Model Code. The Company recorded no non-compliance events during the year.

THE BOARD OF DIRECTORS

The Board is responsible for formulating the overall development strategy, operation and financial reporting of the Company, internal control and risk management, major acquisitions, substantial connected transactions, annual and interim results, proposed interim and final dividends, proposed appointment or re-election of Directors, appointment of auditor, share issue and repurchase and other operational and financial matters relating to the Company. On 1 October 2019, the Board approved and adopted the "Management Measures for the Board of Directors" (《董事會管理辦法》) to regulate the operation of the Board.

Composition of the Board

As of 31 December 2023, the Board consisted of eight members, namely three executive Directors (Mr. Liu Guanghui, (chairman of the Board), Mr. Zhou Jun and Mr. Liu Wuwei), one non-executive Director (Ms. Zhong Yan) and four independent non-executive Directors (Mr. Chan Kay-cheung, Ms. Yau Lai Man, Mr. Chow Bing Sing and Hon. Rock Chen Chung-nin). The Company forms its Board based on the characteristics and uniqueness of its operations to ensure that each Director possesses the required industrial experience and managerial expertise. The personal biographies of the Directors are set out in pages 56 to 59 of the annual report. The Directors clearly understand that they should fulfill their duties diligently in the best interest of the Company and its shareholders. The Company has signed appointment letters with all Directors for a fixed term of three years unless terminated by either party giving to the other not less than 1 month's prior notice in writing, but the Directors are subject to retirement by rotation and re-election according to the Articles of Association.

Hon. Rock Chen Chung-nin (appointed as an independent non-executive Director on 1 April 2023) has, in accordance with the Listing Rule 3.09D, obtained legal advice from a law firm qualified to provide opinions on Hong Kong law on 31 March 2023, to understand all the provisions applicable to him as a director of a listed issuer under the Listing Rules, as well as the potential consequences of making false declarations or providing false information to the Hong Kong Stock Exchange.

The Board delegated its authorities and obligations in the management of daily operations, business strategies and the Group's business to the executive Directors and senior management, and delegated certain specific responsibilities to the committees under the Board.

Relationship between Board Members

To the best knowledge of the Company, there is no financial, business, family or other material/relevant relationship between the Board members.

Responsibilities of the Chairman and Managing Director

It is the consistent policy of the Company to appoint different individuals to act as chairman and managing Director to ensure the accountability and independence of the policymaking process of the Company. The chairman of the Group is responsible for leading the Board. The chairman should ensure that the Board works effectively and discharges its responsibilities, and be responsible for building the management of the Company, organising the formulation of the development strategies, etc. The managing Director is responsible for managing the daily business operations of the Company, implementing the development strategies formulated by the Board, expediting the development of high-end integrated logistics business, driving the development of the passenger transportation business, etc. and strengthening the internal management.

Corporate Governance Report

According to Provision C.2.7, the chairman of the Group has held a meeting with the non-executive Directors, including independent non-executive Directors, without other executive Directors' presence.

Term of Office of Non-executive Directors

The Company has entered into a letter of appointment with non-executive Director (Ms. Zhong Yan) for a fixed term of three years (from 1 April 2023 to 31 March 2026), subject to retirement by rotation and re-election in accordance with the Articles of Association.

Independent Non-executive Directors

In order to ensure the independence of the policymaking process of the Board and protect the interest of its shareholders, the Company appoints at least three qualified independent non-executive Directors in compliance with Rule 3.10(1). In addition, the Company has complied with Rule 3.10A of the Listing Rules of having at least one-third of the Board being represented by independent non-executive Directors. They are professionals experienced in banking, finance and logistics services. One of the independent non-executive Directors has the appropriate professional qualifications and accounting and related financial management expertise required under Rule 3.10(2) of the Listing Rules. The Company undertakes to give them adequate access to the information of the Company and encourages them to thoroughly discuss and provide independent opinions on matters of the Company.

According to the provisions of the Code, a service term of over nine years is one of the key factors in determining the independence of an independent non-executive director. Mr. Chan Kay-cheung ("Mr. Chan"), Ms. Yau Lai Man ("Ms. Yau") and Mr. Chow Bing Sing ("Mr. Chow") have served as independent non-executive Directors for over nine years. During their years of service with the Company, Mr. Chan, Ms. Yau and Mr. Chow have contributed by providing independent viewpoints and advice to the Company in relation to its businesses, operations, future development and strategy. The Board considers that Mr. Chan, Ms. Yau and Mr. Chow have the character, integrity, ability and experience to continue to fulfill his/her role as required effectively. The nomination committee of the Company, having separately assessed and reviewed each of Mr. Chan's, Ms. Yau's and Mr. Chow's duties, contributions and scope of work, also believes that Mr. Chan, Ms. Yau and Mr. Chow can independently express opinions on matters of the Company and there is no evidence that his/her over nine years of service with the Company would have any impact on his/her independence and therefore his/her independence is confirmed. According to the Provision B.2.3, if an independent non-executive Director serves more than nine years, his/her further appointment should be subject to a separate resolution to be approved by Shareholders. Mr. Chan and Mr. Chow retired on rotation at the annual general meeting held on 21 June 2023, and being eligible, offered themselves for re-election at the said meeting. Mr. Chan and Mr. Chow had already been re-appointed by separate resolutions of the Shareholders at the said meeting.

In addition, in accordance with Provision B.2.4(b), if all the independent non-executive Directors have served on the Board for more than nine years, a new independent non-executive Director should be appointed at the forthcoming annual general meeting. Hon. Rock Chen Chung-nin was appointed as a new independent non-executive Director at the annual general meeting held on 21 June 2023 in accordance with Article 84 of the Articles of Association.

In accordance with Article 88(i) of the Articles of Association, Ms. Zhong Yan, the non-executive Director and Mr. Liu Wuwei, the executive Director, will retire at the forthcoming annual general meeting of the Company and, being eligible, offer themselves for re-election. Ms. Zhong Yan and Mr. Liu Wuwei will be re-appointed by separate resolutions of the Shareholders at the said meeting.

The Company has received from each of the current independent non-executive Directors an annual confirmation of his/her independence. The Company considers that all the independent non-executive Directors have maintained their respective independence in accordance with Rule 3.13 of the Listing Rules.

Board Diversity Policy

Pursuant to the Provisions, the Board has adopted the Board Diversity Policy since 15 August 2013 which has been revised on 1 January 2019 and 25 August 2022, and is posted on the Company's website. To attain diversity of the Board, it is the Company's policy to consider an array of factors including professional skills, knowledge, experience, age, gender, cultural and educational background, as well as other factors that the Board considers relevant and applicable from time to time, in determining the appointment and reappointment of Board members. Selection to the Board will be made in accordance with the Company's nomination policy, taking into account the Board's diversity policy. All Board appointments will be based on the strengths of the appointee(s) and the potential contribution he or she can bring to the Company, taking into account the benefits of diversity on the Board. To enhance gender diversity, the Board will take opportunities to progressively increase the proportion of women on the Board and has set measurable targets to ensure that there is at least one Director of a different gender on the Board. During the year, the Company has appointed two female Directors, thus achieving gender diversity on the Board and will continue to maintain the aforementioned measurable targets to achieve a diverse Board.

The Board and the Nomination Committee will regularly discuss and review the Board Diversity Policy on an annual basis to ensure its ongoing effectiveness. In addition, in determining the composition of the Board, the Company will consider the diversity of the Board from various perspectives, including but not limited to gender, age, culture, educational background, experience, knowledge and the potential contribution that a candidate may bring to the Board. All Board members will be appointed on the basis of merit, and candidates will be considered on the basis of objective criteria to take full account of the benefits of diversity on the Board.

Directors' Responsibilities for Financial Statements

During each financial period, the Directors are responsible for the preparation of the financial statements that give a true and fair view of the state of affairs of the Group and of its results and cash flows during the relevant period. In preparing the financial statements for the year, the Directors selected and applied consistently appropriate accounting policies, made careful and reasonable judgments and estimates, and prepared the financial statements on a going concern basis. The Directors are responsible for the filing of appropriate accounting records that reasonably and accurately disclose the financial position of the Company at any time. The Board is not aware so far of any significant uncertain events or circumstances which would affect the business of the Company or its ability to continue its operation. The responsibilities of the Company's external auditor are set out in the Independent Auditor's Report on pages 79 to 83 of the annual report.

Board Meeting Procedures

If a Director has a conflict of interest in a matter to be considered at the meetings of the Board and the committee which the Board has determined to be material, such Director may express his/her recommendations but shall not be counted in the guorum and shall abstain from voting on the relevant resolution.

All Directors have unrestricted access to the Company Secretary who is responsible for ensuring that the Board/committee procedures are complied with, and for advising the Board/committee(s) on compliance matters.

The Company has established a Nomination Committee in accordance with the Code. The Nomination Committee has also reviewed the nomination policy in the year.

According to the Articles of Association, all Directors are subject to retirement by rotation and re-election at annual general meetings of the Company. New Directors appointed by the Board during the year are required to retire and offer themselves for re-election at the first annual general meeting immediately following their appointments. Further, at each annual general meeting, one-third (if not a multiple of three, then the number nearest to one-third) of Directors shall retire from office by rotation and according to the Provision B.2.2, every Director shall be subject to retirement by rotation at least once every three years.

In accordance with Article 88(i) of the Articles of Association, Ms. Zhong Yan and Mr. Liu Wuwei will retire at the forthcoming annual general meeting of the Company and, being eligible, offer themselves for re-election. The Nomination Committee recommended to the Board that Ms. Zhong Yan and Mr. Liu Wuwei be nominated for re-election at the forthcoming annual general meeting of the Company.

Nomination Procedures

- (i) If the Nomination Committee is required to appoint a Director, the secretary of the Nomination Committee may convene a meeting of the Nomination Committee and invite nominations for Directors, (if any), for consideration by the Nomination Committee prior to the meeting.
- (ii) In addition to Director nominees, the Nomination Committee may also nominate non-director nominees.
- (iii) Upon receipt of a proposal for the appointment of a new Director and the candidate's curriculum vitae, the Nomination Committee and/or the Board shall evaluate the candidate to determine whether the candidate is qualified in accordance with the criteria set out below.
- (iv) The Nomination Committee shall then make recommendations to the Board for its consideration and recommendation for re-election in respect of the appointment of a suitable candidate as a Director. The Nomination Committee may pass a written resolution for the nomination of a Director. A circular will be sent to shareholders for the purpose of providing information on candidates for election or re-election as Directors at general meetings. The names, biographical details (including qualifications and relevant experience), independence, remuneration and other information of the candidates will be included in the circular in accordance with applicable laws, rules and regulations.

The following criteria will be used as a reference by the Nomination Committee in assessing the suitability of the proposed candidates.

- Credibility;
- The required skills, expertise, experience, cultural and educational background, gender, age and other qualities, with due regard to the benefits of diversity on the Board;
- the extent to which the proposed candidate can contribute to the overall effectiveness of the Board and work constructively with existing Directors;
- the skills and experience of the proposed candidate as a Director and how the candidate could enhance the overall effectiveness and performance of the Board;
- the nature of the proposed candidate's existing position, including the directorship or other relationship with the Company and other Directors of the Company, and the impact that such relationships may have on the candidate's ability to exercise independent judgment; and
- other factors that could affect the amount of time the proposed candidate would devote to the performance
 of his duties in relation to the Company.



RISK MANAGEMENT AND INTERNAL CONTROL

The Group has established effective risk management and internal control systems to provide reasonable (though not absolute) assurance against material misstatement or loss and to manage (rather than eliminate) risks of failing to achieve business objectives. The Board shall be responsible for the risk management and internal control systems of the Group and shall review at least annually the effectiveness of such systems for that relevant financial year. The Audit Committee shall assist the Board in fulfilling its oversight and corporate governance functions in the Group's financial, operational, compliance, risk management (including environmental, social and governance risks) and internal control, and the resources of the finance and internal audit functions. The Group has established a set of organisational structure with a clear division of responsibilities and reporting mechanisms.



- the internal audit department of the Company ("Internal Audit Department") has an internal audit function, and shall assist the Board and/or the Audit Committee in the review of the effectiveness of the Group's internal control and risk management systems (including environmental, social and governance risks) on an ongoing basis. The head of the Internal Audit Department shall report directly to the Audit Committee;
- the Company has also established the Risk Management and Internal Control Committee (the "Risk Control Committee") comprising Mr. Zhou Jun, Mr. Liu Wuwei and heads of all departments, which shall determine the members of the committee and their respective responsibilities, define the work division among all departments and the duties and responsibilities of each group, and give instructions in relation to the commencement of risk assessment (including environmental, social and governance risks) and internal control assessment. The Risk Control Committee shall report directly to the Board about the significant risks that may affect the performance of the Group on a regular basis; and
- the Company will set up task group(s) in light of the actual situation, which will hold meetings regularly to review the effectiveness of the relevant financial, operational and compliance control as well as risk management procedures (including environmental, social and governance risks) and to review on how to make further improvement.

The Company has implemented the following procedures to identify, assess and manage significant risks (including environmental, social and governance risks):

- 1. the Company has formulated the Guideline on Risk Management (《風險管理工作指引》), and required the Company and all subsidiaries to manage risks in accordance with this guideline;
- 2. the Company has established a whistleblowing policy, which is disclosed on the Company's website and compendium of rules and regulations, to which employees, employees of subsidiaries and persons dealing with the Company may access, in order to enable them to raise concerns and report possible improprieties in any matter concerning the Company in a confidential and anonymous manner;
- 3. all subsidiaries have set up their own risk management and internal control committees and identified their officer-in-charge for risk management. An annual inspection shall be carried out to identify their respective risks, assess all kinds of significant risks, formulate relevant control measures and continuously monitor and improve the risk management and internal control systems. Each of the risk management and internal control committee shall conduct an annual review in the middle of the year for self-inspection and self-reporting of risks/to check the implementation of such control measures, so as to ensure the feasibility and effectiveness of existing control measures;
- after collecting information on the risk profile of each subsidiary and the relevant control measures implemented by them, the Company would summarise a list of significant risks based on the major risk categories (including market risks, strategic risks, operation risks, financial risks, environmental, social and governance risks, etc.). After ranking these significant risks by priority, the management of the Company would identify the most significant risks and request the relevant companies to focus on the supervision of such risks:

- 5. the Internal Audit Department would carry out the following tasks every year:
 - to examine if all companies have focused their supervision on the most significant risks;
 - to evaluate the report in relation to the most significant risks;
 - to assess and ensure the effectiveness of the risk management procedures and the audit reporting process;
 - to ensure accurate assessment of each risk; and
 - to implement independent internal audits according to its internal audit plan.
- 6. the Internal Audit Department would summarise and report the results of the work above to the Audit Committee on a yearly basis.

The formulation and execution procedures of the internal audit plan of the Company are as follows: the Internal Audit Department adopts a risk and control-based audit approach. An annual work plan will be formulated, covering the Group's operations and businesses as well as all the major activities and processes of each subsidiary, and a special review will be carried out on the demand of the management. The audit result shall be submitted to the Audit Committee promptly for review. Where any deficiency in the internal control is identified, the subsidiaries are required to make improvements promptly according to the recommendations. Audit issues are tracked and followed up by the Internal Audit Department for proper implementation. The Internal Audit Department shall report to the Audit Committee on a regular basis, while the Audit Committee shall report the audit findings and/or progress of the audit work to the Board after reviewing the relevant information.

The Company adopted the Inside Information Management Policy (《內幕消息管理制度》) in 2013 (as revised in 2015), which provides guideline on the handling and dissemination of the Group's inside information by the Directors and employees who may have access to such information as well as the relevant internal control measures. The Board has organised the establishment of the Inside Information Committee, a committee under the Executive Committee which comprises the executive Directors, the Company Secretary, the general manager of the capital operation department and the general manager of the legal department. The members of the Inside Information Committee shall take joint responsibility for the registration and management of the inside information and the insiders of the Group, which shall be organised and implemented by the Company Secretary and the capital operation department. The officer-in-charge of other departments, branch companies and subsidiaries of the Company as well as the invested companies over which the Company has significant influence shall be responsible for the confidentiality of such information arising within their management authority, and shall report and communicate such inside information that comes to their knowledge.

After being aware of any event potentially involving inside information, the senior officers shall fill in and submit the Inside Information Reporting Form (《內幕消息呈報表格》) truthfully on the date such inside information comes to their knowledge. Upon receipt of such alert, the Company Secretary shall promptly convey such inside information to the members of the Inside Information Committee for assessment. In accordance with the relevant provisions of the information disclosure rules, members of the Inside Information Committee shall assess on the potential inside information, fill in the Inside Information Assessment Report (《內幕消息評估報告》) and decide whether a disclosure on such information is required. Where it is determined that a disclosure is required to be made, it shall be reported to the securities regulatory authority and made within three working days or as required by the regulatory rules and regulations.

In respect of the review of the adequacy and effectiveness of the risk management and internal control systems, the Internal Audit Department provides independent assurance regarding the adequacy and effectiveness of the Group's risk management and internal control systems to the Board and the Audit Committee. The head of the Internal Audit Department shall report directly to the Audit Committee. With the assistance of the Internal Audit Department, the management of the Group shall be responsible for the design, implementation and monitoring of the risk management and internal control systems. The Annual Self-assessment Form of Internal Controls and Risk Management (《內部控制及風險管理年度自評表》) are dispatched to all subsidiaries, which shall be collected and consolidated by the Company. Such results shall be assessed by the Internal Audit Department and reported to the Audit Committee, which will then review such information and submit reports on the effectiveness of such systems to the Board on a regular basis. Where necessary, the task group(s) will hold meetings regularly to review the effectiveness of the relevant financial, operational as well as compliance control and risk management procedures and to make further improvements.

During the year, the Company has conducted the following major works relating to risk management and internal control:

- assisted in completing the revision of the comprehensive risk management system and confirmed the 4 major risks from last year's assessment, to further implement comprehensive risk management measures and ensure the relevant measures for those work associated with risk to be in place effectively. For the assessment of comprehensive risk management this year, there is no matter involving "One-vote Veto". Meanwhile, key controls on the risks of 2023, which were identified as production and operational safety risks, etc., were put in place, mainly through strictly executing safety management requirements and prevention measures, strengthening supervision and inspections; conducting specialised investigations; increasing the allocation of full-time safety management personnel and conducting business training, etc.. There was no major safety duties incident took place in the Group throughout the year;
- the 2023 Internal Audit Plan was properly organised and implemented so as to enhance the standard of the internal control and risk management of all subsidiaries, with an aim to improve the Company's awareness of risk management and internal control, strengthening the ability to respond to emergencies. This was accomplished by ways of the Annual Self-assessment Form of Internal Controls and Risk Management (《內部控制及風險管理年度自評表》) submitted by each subsidiary and the major risks of the Group confirmed through the Group's Risk Summary Form 《風險總滙表》 together with enhancing the management's goal of reducing costs and increasing efficiency by the management of the Company;

- conducted review and audit on the implementation and internal control processes related to the fund account management, fund utilisation efficiency, management system operation and security for the settlement center of the Group;
- organised the Group staff to carry out relevant training and cultural construction works to improve risk
 management and internal control awareness and enhance the standard of the internal audit work, including
 arranging dedicated internal auditors to attend online and offline practical audit training, inviting professionals
 to conduct anti-corruption and bribery prevention educational trainings for the Group's middle level
 management or above, and the executive positions members of its subsidiaries to enhance anti-corruption
 awareness; and
- during the year, the 2023 Internal Audit Plan was fully completed, a total of 14 internal audit reports were issued. In respect of the 16 audit comments and recommendations provided for the financial year of 2023, improvement works on addressing audit-related issues were in progress, of which 15 were completed. All subsidiaries had been asked to make improvements according to such recommendations.

This year, the Board, through the Audit Committee, reviewed the risk management and internal control systems of the Group. The Board also reviewed and ensured the adequacy of the Group's resources in accounting, internal audit and financial reporting functions, staff qualifications and experience as well as staff training courses. The Annual Self-assessment Form of Internal Controls and Risk Management (《內部控制及風險管理年度自評表》) had been dispatched to all subsidiaries, which had been collected and consolidated by the Company. Such results were assessed by the Internal Audit Department and reported to the Audit Committee, which then reviewed and reported the same to the Board. The Audit Committee and the Board were not aware of any areas of concern that would have a material impact on the financial position or operating results of the Group and considered the risk management and internal control systems to be generally adequate and effective.

COMMUNICATION WITH SHAREHOLDERS

The Board has established a shareholders' communication policy and the procedures for shareholders to nominate a candidate for election as a Director. The policy and procedure are available on the website of the Company.

1. Procedures for shareholders of the Company to convene a general meeting

Pursuant to the Articles of Association and the Companies Ordinance of Hong Kong, registered shareholders holding not less than one-twentieth (5%) of the paid up capital of the Company (the "General Meeting Requisitionists") can deposit a written request to convene a general meeting at the registered office of the Company (the "Registered Office"), which is presently situated at 22nd Floor, Chu Kong Shipping Tower, 143 Connaught Road Central, Hong Kong for the attention of the Company Secretary.

The General Meeting Requisitionists must state in their request(s) the objects of the general meeting and such request(s) must be signed by all the General Meeting Requisitionists and may consist of several documents in like form, each signed by one or more of the General Meeting Requisitionists.

The Company's share registrars (the "Share Registrars") will verify the General Meeting Requisitionists' particulars in the General Meeting Requisitionists' request. Promptly after confirmation from the Share Registrars that the General Meeting Requisitionists' request is in order, the Company Secretary will arrange with the Board to convene a general meeting by serving sufficient notice to all the registered shareholders in accordance with all the relevant statutory and regulatory requirements. On the contrary, if the General Meeting Requisitionists' request is verified to be not in order, the General Meeting Requisitionists will be advised of the outcome and accordingly, a general meeting will not be convened as requested.

The General Meeting Requisitionists, or any of them representing more than one-half of the total voting rights of all of them, may themselves convene a general meeting if the Board had not arranged to duly convene a general meeting within 28 days upon serving a written notice in relation to the general meeting within 21 days of the deposit of the General Meeting Requisitionists' request, provided that any general meeting so convened is held within three months from the date of the original General Meeting Requisitionists' request. Any reasonable expenses incurred by the General Meeting Requisitionists by reason of the Board's failure to duly convene a general meeting shall be repaid to the General Meeting Requisitionists by the Company.

2. Procedures for shareholders to put forward proposals at a general meeting

Fair value less costs of disposal is assessed based on independent valuations prepared by a firm of qualified • external valuers and value in use is assessed based on a discounted cash flow forecast prepared by management.

- obtaining and inspecting the valuation reports prepared by the external valuers engaged by management and on which the directors' assessment of the fair values of respective assets was based:
- assessing the external valuers' qualifications, experience and expertise in the assets being valued and considering their objectivity;
- evaluating the external valuers' valuation methodology and challenging the key estimates and assumptions adopted in the valuations, by comparison with available market data and/or government produced market statistics;
- assessing the management's evaluation of indicators of impairment, identification of CGU, the allocation of PP&E, land use rights, software and goodwill to each CGU and the methodology adopted by management in the preparation of the discounted cash flow forecasts with reference to our understanding of the Group's business and the requirements of prevailing accounting standards;

Key Audit Matter

How our audit addressed the Key Audit Matter

The preparation of discounted cash flow forecasts involves the exercise of significant management judgement in determining the relevant inputs to the discounted cash flow forecasts and the assumptions adopted therein, including forecast revenue growth rates and the discount rates.

We identified the assessment of impairment of PP&E, land use rights, software and goodwill as a key audit matter because the assessments involves significant management judgement which could be subject to management bias.

- assessing the management's cash flow forecasts by comparing the key assumptions adopted by management, in particular, forecast revenue growth rates and the discount rates, with reference to our understanding of the Group's business and industry and available market data;
- assessing the historical reliability of management's forecasting process by comparing the actual results for the current year with management's forecast prepared in the previous year;
- performing sensitivity analyses on the discount rates and other key assumptions adopted by management to assess the impact of changes on the conclusion reached in management's impairment assessments and considering whether there were any indicators of management bias in the key assumptions adopted; and
- assessing the disclosures in the consolidated financial statements in respect of the impairment assessment with reference to the requirements of the prevailing accounting standards.

INFORMATION OTHER THAN THE CONSOLIDATED FINANCIAL STATEMENTS AND AUDITOR'S REPORT THEREON

1 GENERAL INFORMATION

Chu Kong Shipping Enterprises (Group) Company Limited (the "Company") is a limited liability company incorporated in Hong Kong. The address of its registered office is 22nd Floor, Chu Kong Shipping Tower, 143 Connaught Road Central, Hong Kong.

The Company and its subsidiaries (collectively referred to as the "Group") are mainly engaged in provision of management and other related services to high-speed waterway passenger transportation in Guangdong, Hong Kong and Macao; the operation and management of river trade cargo terminals in the Mainland China and Hong Kong; cargo transportation, warehousing and storage business; provision of diesel and lubricants for passenger ferries and cargo vessels in Hong Kong; provision of operation and management of facilities maintenance services for properties and so forth in Macao; and provision of ferry services and charter hire of vessels services in Hong Kong.

The Company is listed on the Main Board of The Stock Exchange of Hong Kong Limited.

These financial statements have been approved for issue by the board of directors of the Company on 25 March 2024.

2 SUMMARY OF MATERIAL ACCOUNTING POLICIES

This note provides a list of the material accounting policies adopted in the preparation of these financial statements. These policies have been consistently applied to all years presented, unless otherwise stated. The consolidated financial statements are for the Group consisting of Chu Kong Shipping Enterprises (Group) Company Limited and its subsidiaries.

2.1 Basis of preparation

(i) The consolidated financial statements of the Group have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and the requirements of the Hong Kong Companies Ordinance ("HKCO"). These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited. Material accounting policies adopted by the Group are disclosed below.

The consolidated financial statements have been prepared on a historical cost basis, except that the following assets is stated at its fair value as explained in the accounting policies set out below:

The preparation of consolidated financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in note 4.

None of these development have had a material effect on how the Group's result and financial position for the current or prior periods have been prepared or presented. The Group has not applied any new standard or interpretation that is not yet effective for the current accounting period.

(iii) New HKICPA guidance on the accounting implications of the abolition of the MPF-LSP offsetting mechanism

In July 2023, the HKICPA published *Accounting implications of the abolition of the mandatory provident fund ("MPF")-long service payment ("LSP") offsetting mechanism in Hong Kong that provides accounting guidance relating to the offsetting mechanism and the abolition of the mechanism.*

To better reflect the substance of the abolition of the offsetting mechanism, the Group has changed its accounting policy in connection with its LSP liability and has applied the above HKICPA guidance retrospectively. This change in accounting policy did not have any material impact on the opening balance of equity at 1 January 2022 and 2023, and the cash flows and earnings per share amounts for the years ended 31 December 2022 and 2023. It also did not have a material impact on the company-level statement of financial position as at 31 December 2022 and 2023.

The Group is in the process of making an assessment of what the impact of these developments is expected to be in the period of initial application. So far it has concluded that the adoption of them is unlikely to have a significant impact on the consolidated financial statements.

2.2 Principles of consolidation and equity accounting

(i) Subsidiaries and non-controlling interests

Subsidiaries are entities (including structured entities) controlled by the Group. The Group controls an entity when it is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The financial statements of subsidiaries are included in the consolidated financial statements from the date on which control commences until the date on which control ceases

Intercompany balances and transactions, and any unrealised income and expenses (except for foreign currency transaction gains or losses) arising from intercompany transactions, are eliminated. Unrealised losses resulting from intercompany transactions are eliminated in the same way as unrealised gains, but only to the extent that there is no evidence of impairment.

For each business combination, the Group can elect to measure any non-controlling interests ("NCI") either at fair value or at the NCI's proportionate share of the subsidiary's net identifiable assets. NCI are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the company. NCI in the results of the Group are presented on the face of the consolidated statement of profit or loss and the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between NCI and the equity shareholders of the company. Loans from holders of NCI and other contractual obligations towards these holders are presented as financial liabilities in the consolidated statement of financial position depending on the nature of the liability.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions.

(ii) Associates

An associate is an entity in which the Group or the Company has significant influence, but not control or joint control, over the financial and operating policies. Investments in associates are accounted for using the equity method of accounting (see (iv) below), after initially being recognised at cost.

(iii) Joint ventures

A joint venture is an arrangement whereby the Group or Company has joint control, whereby the Group or the Company has the rights to the net assets of the arrangement, rather than rights to its assets and obligation for its liabilities.

Investments in joint ventures are accounted for using the equity method (see (iv) below), after initially being recognised at cost.

(iv) Equity accounting

Under the equity method of accounting, the investments are initially recognised at cost and adjusted thereafter to recognise the Group's share of the post-acquisition profits or losses of the investee in profit or loss, and the Group's share of movements in other comprehensive income of the investee in other comprehensive income. Dividends received or receivable from associates and joint ventures are recognised as a reduction in the carrying amount of the investment.

When the Group's share of losses in an equity-accounted investment equals or exceeds its interest in the entity, including any other unsecured long-term receivables, the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the other entity.

Unrealised gains arising from transactions with equity-accounted investees are eliminated against the investment to the extent of the Group's interest in the investee. Unrealised losses are eliminated in the same way as unrealised gains, but only to the extent there is no evidence of impairment. Accounting policies of equity accounted investees have been changed where necessary to ensure consistency with the policies adopted by the Group.

The carrying amount of equity-accounted investments is tested for impairment in accordance with the policy described in note 2.10.

2.2 Principles of consolidation and equity accounting (Continued)

(v) Changes in ownership interests

The Group treats transactions with non-controlling interests that do not result in a loss of control as transactions with equity owners of the Group. A change in ownership interest results in an adjustment between the carrying amounts of the controlling and non-controlling interests to reflect their relative interests in the subsidiary. Any difference between the amount of the adjustment to non-controlling interests and any consideration paid or received is recognised in a separate reserve within equity attributable to owners of the Company.

When the Group ceases to consolidate or equity account for an investment because of a loss of control, joint control or significant influence, any retained interest in the entity is remeasured to its fair value with the change in carrying amount recognised in profit or loss. This fair value becomes the initial carrying amount for the purposes of subsequently accounting for the retained interest as an associate, joint venture or financial asset. In addition, any amounts previously recognised in other comprehensive income in respect of that entity are accounted for as if the Group had directly disposed of the related assets or liabilities. This may mean that amounts previously recognised in other comprehensive income are reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRS.

If the ownership interest in a joint venture or an associate is reduced but joint control or significant influence is retained, only a proportionate share of the amounts previously recognised in other comprehensive income are reclassified to profit or loss where appropriate.

2.3 Separate financial statements

Investments in subsidiaries are accounted for at cost less impairment (see note 2.10). Cost includes direct attributable costs of investment. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

2.4 Foreign currency translation

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates ("the functional currency"). The consolidated financial statements are presented in Hong Kong dollars (HK\$), which is the Company's functional currency and the Group's presentation currency.

Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. The transaction date is the date on which the Group initially recognises such non-monetary assets or liabilities.

The results of foreign operations are translated into Hong Kong dollars at the exchange rates approximating the foreign exchange rates ruling at the dates of the transactions. Statement of financial position items, including goodwill arising on consolidation of foreign operations are translated into Hong Kong dollars at the closing foreign exchange rates at the end of the reporting period. The resulting exchange differences are recognised in other comprehensive income and accumulated separately in equity in the exchange reserve.

On disposal of a foreign operation, the cumulative amount of the exchange differences relating to that foreign operation is reclassified from equity to profit or loss when the profit or loss on disposal is recognised.

2.5 Property, Plant and equipment

(i) Construction in progress

Construction in progress represents vessels and barges or other property, plant and equipment under construction which is carried at cost less any accumulated impairment losses.

Construction in progress includes construction expenditure incurred, borrowing costs and other direct costs attributable to the construction. On completion, the construction in progress is transferred to appropriate categories of property, plant and equipment. No depreciation is provided for construction in progress.

2.5 Property, Plant and equipment (Continued)

Other right-of-use assets leased for own use

(ii) Property, plant and equipment

Property, plant and equipment, including right-of-use assets arising from leases over leasehold properties where the Group is not the registered owner of the property interest and right-of-use assets arising from leases of underlying plant and equipment (see note 2.21), are stated at historical cost less accumulated depreciation and impairment losses.

Depreciation is calculated to write off the cost or valuation of items of property, plant and equipment, less their estimated residual value, if any, using the straight-line method over their estimated useful lives as follows:

Buildings 20 - 50 years 5 - 8 years Leasehold improvements Plant and machinery 4 - 15 years Furniture, fixtures and equipment 3 - 8 vears Motor vehicles 3 - 8 years Containers 4 - 8 years Vessels and barges 3 - 15 years Other properties leased for own use Over the lease term

Major costs incurred in restoring the property, plant and equipment and vessels and barges to their normal working condition are charged to the profit or loss. Improvements are capitalised and depreciated over their expected useful lives.

Over the lease term

Vessel repairs and survey costs are charged as operating expenses as they are incurred. Vessel component costs include the cost of major components which are usually replaced or renewed at dry-dockings. Dry-docking costs of vessel and the costs incurred in replacing or renewing the separate assets are capitalised and depreciated over the period to the next estimated dry-dock date.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each balance sheet date. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Items may be produced while bringing an item of property, plant and equipment to the location and condition necessary for it to be capable of operating in the manner intended by management. The proceeds from selling any such items and the related costs are recognised in profit or loss.

Gains and losses on disposals are determined by comparing proceeds with carrying amounts of the assets and are recognised within 'other gains/(losses) - net', in the profit or loss.

2.6 Investment properties

Investment properties are land and/or buildings which are owned or held under a leasehold interest (see note 2.21) to earn rental income and/or for capital appreciation.

Investment properties are stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items. Depreciation on investment properties is calculated using the straight-line method to allocate their cost to their residual values over their estimated useful lives of 20 to 50 years. Rental income from investment properties is accounted for as described in note 2.19.

2.7 Land use rights

Land use rights represent lease payments for interest in land and are carried at cost less accumulated amortisation and impairment. Amortisation is calculated using the straight-line method to allocate the lease payments over the remaining lease term.

2.8 Intangible assets

(i) Goodwill

Goodwill arises on the acquisition of subsidiaries represents the excess of the consideration transferred, the amount of any non-controlling interest in the acquiree and the acquisition-date fair value of any previous equity interest in the acquiree over the fair value of the identified net assets acquired.

For the purpose of impairment testing, goodwill acquired in a business combination is allocated to each of the cash-generating units ("CGUs"), or groups of CGUs, that is expected to benefit from the synergies of the combination. Each unit or group of units to which the goodwill is allocated represents the lowest level within the entity at which the goodwill is monitored for internal management purposes.

Goodwill impairment reviews are undertaken annually or more frequently if events or changes in circumstances indicate a potential impairment. The carrying value of goodwill is compared to the recoverable amount, which is the higher of value in use and the fair value less costs of sale. Any impairment is recognised immediately as an expense and is not subsequently reversed.

2.8 Intangible assets (Continued)

(ii) Software

Costs associated with maintaining software programmes are recognised as an expense as incurred. Development costs that are directly attributable to the design and testing of identifiable and unique software products controlled by the Group are recognised as intangible assets when the following criteria are met:

- it is technically feasible to complete the software so that it will be available for use;
- management intends to complete the software and use or sell it;
- there is an ability to use or sell the software;
- it can be demonstrated how the software will generate probable future economic benefits;
- adequate technical, financial and other resources to complete the development and to use or sell the software are available; and
- the expenditure attributable to the software during its development can be reliably measured.

Directly attributable costs that are capitalised as part of the software include employee costs and an appropriate portion of relevant overheads.

Capitalised development costs are recorded as intangible assets and amortised from the point at which the asset is ready for use.

The Group amortises software with a limited useful life using the straight-line method over 5 - 10 years. Both the period and method of amortisation are reviewed annually.

2.9 Financial assets

(i) Classification

The Group categories financial assets into three principal classification: measured at amortised cost, at fair value through other comprehensive income ("FVOCI") and at fair value through profit or loss ("FVPL"). The classification of financial assets is based on the business model under which the financial asset is managed and its contractual cash flow characteristics.

The Group's financial assets include trade and other receivables (note 16), bank deposits and cash and cash equivalents (note 17) and other financial asset.

(ii) Recognition and measurement

Regular purchases and sales of financial assets are recognised on the trade-date - the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the investments have expired or have been transferred and the Group has transferred substantially all risks and rewards of ownership. Loans and receivables are subsequently carried at amortised cost using the effective interest method less allowance for credit losses.

2.10 Impairment of investments in subsidiaries, joint ventures, associates and non-financial assets

Assets that have an indefinite useful life, for example, goodwill, are not subject to depreciation/ amortisation and are tested annually for impairment. Other assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of sale and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows. Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date.

Impairment testing of the investments in subsidiaries, joint ventures and associates is required upon receiving dividends from these investments if the dividend exceeds the total comprehensive income of the subsidiaries, joint ventures and associates in the period the dividend is declared or if the carrying amount of the investment exceeds the carrying amount of the investee's net assets.

2.11 Trade and other receivables

Trade receivables are amounts due from customers for merchandise sold or services performed in the ordinary course of business when the Group has an unconditional right to receive consideration. If collection of trade and other receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If not, they are presented as non-current assets.

Trade receivables that do not contain a significant financing component are initially measured at their transaction price. Trade receivables that contain a significant financing component and other receivables are initially measured at fair value plus transaction costs. All receivables are subsequently stated at amortised cost using the effective interest method and including allowance for credit losses.

The Group assess on a forward-looking basis the expected credit loss associated. The impairment methodology applied depends on whether there has been a significant increase in credit risk. For trade receivables, the Group applied the simplified approach permitted by HKFRS 9, which requires expected credit losses to be recognised from initial recognition of the receivables. Impairment on other receivables is measured as either 12-month expected credit losses or lifetime expected credit loss, depending on whether there has been a significant increase in credit risk since initial recognition. If a significant increase in credit risk of a receivable has occurred since initial recognition, then impairment is measured as lifetime expected credit losses. The amount of the loss allowance is the difference between the asset's carrying amount and the present value of estimated future cash flows, discounted at the original effective interest rate. The carrying amount of the assets is reduced through the use of an allowance account, and the amount of the loss is recognised in other operating expenses in the statement of profit or loss. When a trade receivable is uncollectible, it is written off against the allowance account for trade receivables. Subsequent recoveries of amount previously written off are credited against other gains/ (losses) – net in the consolidated statement of profit or loss.

2.12 Cash and cash equivalents

For the purpose of presentation in the consolidated statement of cash flows, cash and cash equivalents includes cash on hand, demand deposits with banks and other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value, and bank overdrafts. Cash and cash equivalents are assessed for expected credit losses.

2.13 Share capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares are shown in equity as a deduction, net of tax, from the proceeds.

2.14 Trade payables, accruals and other payables

Trade payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Trade payables and other are classified as current liabilities if payment is due within one year or less (or in the normal operating cycle of the business if longer). If not, they are presented as non-current liabilities.

They are recognised initially at fair value and subsequently stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at invoice amounts.

2.15 Borrowings and borrowing costs

Borrowings are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently carried at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in the profit or loss over the period of the borrowings using the effective interest method.

Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facility will be drawn down. In this case, the fee is deferred until the draw-down occurs. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a pre-payment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least twelve months after the end of the reporting period.

General and specific borrowing costs that are directly attributable to the acquisition, construction or production of qualifying assets which necessarily takes a substantial period of time to be ready for their intended use or sale, are capitalised as part of the cost of the assets, until such time as the assets are substantially ready for their intended use or sale. All other borrowing costs are charged to the profit or loss in the financial period in which they are incurred.

2.16 Current and deferred income tax

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

(i) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of the reporting period in the countries where the Group's subsidiaries and associates operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

(ii) Deferred income tax

Deferred income tax is provided on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill. Deferred income tax is also not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred tax assets are recognised only if it is probable that future taxable amount will be available to utilise those temporary differences and losses.

Deferred tax liabilities and assets are not recognised for temporary differences between the carrying amount and tax bases of investments in foreign operations where the Group is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances related to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

2.17 Employee benefits

(i) Employee leave entitlements

Employee entitlements to annual leave is recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the balance sheet date.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(ii) Retirement benefit obligations

LSP under the Hong Kong Employment Ordinance

The Group's net obligation in respect of defined benefit plans is calculated separately for each plan by estimating the amount of future benefit that employees have earned in the current and prior periods and discounting that amount. For LSP obligations, the estimated amount of future benefit is determined after deducting the negative service cost arising from the accrued benefits derived from the Group's MPF contributions that have been vested with employees, which are deemed to be contributions from the relevant employees.

The calculation of defined benefit obligation is performed by a qualified actuary using the projected unit credit method.

(iii) Bonus entitlements

The Group recognises a liability and an expense for bonus when the Group has a present legal or constructive obligation as a result of services rendered by employees and a reliable estimate of the obligation can be made.

Liabilities for bonus are expected to be settled within twelve months and are measured at the amounts expected to be paid when they are settled.

(iv) Termination benefits

Termination benefits are payable when employment is terminated by the Group before the normal retirement date, or whenever an employee accepts voluntary redundancy in exchange for these benefits. The Group recognises termination benefits when it is demonstrably committed to a termination when the entity has a detailed formal plan to terminate the employment of current employees without possibility of withdrawal. In the case of an offer made to encourage voluntary redundancy, the termination benefits are measured based on the number of employees expected to accept the offer. Benefits falling due more than twelve months after the end of the reporting period are discounted to their present value.

2.18 Provisions and contingent liabilities

Provisions are recognised when the Group has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Where some or all of the expenditure required to settle a provision is expected to be reimbursed by another party, a separate asset is recognised for any expected reimbursement that would be virtually certain. The amount recognised for the reimbursement is limited to the carrying amount of the provision.

2.19 Revenue and other income

Income is classified by the Group as revenue when it arises from the sale of goods, the provision of services or the use by others of the Group's assets under leases in the ordinary course of the Group's business.

Revenue is recognised when control over a product or service is transferred to the customer, or the lessee has the right to use the asset, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Further details of the Group's revenue and other income recognition policies are as follows:

(i) Cargo transportation

Revenues from the rendering of services in river trade cargo direct shipment and transhipment are recognised in the financial period in which the services are rendered.

(ii) Cargo handling and storage

Revenues from the rendering of services in river trade wharf cargo handling, cargo consolidation and godown storage and container hauling and trucking are recognised in the financial period in which the services are rendered.

(iii) Passenger transportation agency service

Revenues from passenger transportation agency services are recognised based on net agency fee upon departure of ferries at terminals.

2.19 Revenue and other income (Continued)

(iv) Ferry terminal operation service

Revenues from ferry terminal operation service are recognised based on net ferry terminal operation service fee upon departure of ferries at terminals.

(v) Fare receipts, freight revenue, hiring income, berthing fee, commission, passenger and maintenance services income

Fare receipts, freight revenue, hiring income, berthing fee, commission, passenger services and ferry terminal maintenance services income are recognised when the services are rendered.

(vi) Management service

Revenues from management service are recognised when the service is rendered.

(vii) Interest income

Interest income is recognised using the effective interest method.

(viii) Dividend income

Dividend income is recognised in profit or loss on the date on which the group's right to receive payment is established.

(ix) Rental income and charter hire income

Rental income and charter hire income are recognised on a straight-line basis over the term of the lease.

(x) Oil trading

Revenue from trading of oil are recognised when the customer takes possession of and accepts the goods.

(xi) Marine bunkering services

Revenue from marine bunkering services is recognised when the services are rendered.

(xii) Advertising income

Advertising income is recognised when the related advertisement or commercial appears before the public.

2.20 Earning per share

(i) Basic earnings per share

Basic earnings per share is calculated by dividing the profit attributable to owners of the Company, excluding any costs of servicing equity other than ordinary shares by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the year and excluding treasury shares.

(ii) Diluted earnings per share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account:

- the after income tax effect of interest and other financing costs associated with dilutive potential ordinary shares, and
- the weighted average number of additional ordinary shares that would have been outstanding assuming the conversion of all dilutive potential ordinary shares.

2.21 Leased assets

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

(i) As a lessee

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets which, for the Group are primarily barges and offices. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

(i) As a lessee (Continued)

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses (see notes 2.5 and 2.10).

The initial fair value of refundable rental deposits is accounted for separately from the right-ofuse assets and subsequently stated at amortised cost. Any difference between the initial fair value and the nominal value of the deposits is accounted for as additional lease payments made and is included in the cost of right-of-use assets.

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The lease liability is also remeasured when there is a change in the scope of a lease or the consideration for a lease that is not originally provided for in the lease contract ("lease modification") that is not accounted for as a separate lease. In this case the lease liability is remeasured based on the revised lease payments and lease term using a revised discount rate at the effective date of the modification.

In the consolidated statement of financial position, the current portion of long-term lease liabilities is determined as the present value of contractual payments that are due to be settled within twelve months after the reporting period.

(ii) As a lessor

When the Group acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to the ownership of an underlying assets to the lessee. If this is not the case, the lease is classified as an operating lease.

The rental income from operating leases is recognised in accordance with note 2.19.

2.22 Dividend distribution

Provision is made for the amount of any dividend declared, being appropriately authorised and no longer at the discretion of the entity, on or before the end of the reporting period but not distributed at the end of the reporting period.

2.23 Government grants

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions.

Government grants relating to costs are deferred and recognised in the profit or loss over the period necessary to match them with the costs that they are intended to compensate.

Government grants relating to property, plant and equipment are included in non-current liabilities as deferred government grants and are credited to the profit or loss on a straight-line basis over the expected lives of the related assets.

2.24 Inventories and spare parts

Inventories are assets which are held for sale in the ordinary course of business, in the process of production for such sale or in the form of materials or supplies to be consumed in the production process or in the rendering of services.

Inventories and spare parts are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out method. Net realisable value is the estimated selling price in the ordinary course of business, less applicable variable selling expenses.

2.25 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the executive directors of the Company that makes strategic decisions.

(Expressed in Hong Kong dollars unless otherwise indicated)

3.1 FINANCIAL RISK FACTORS

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk and interest rate risk), credit risk and liquidity risk. The Group's overall risk management program focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(a) Market risk

(i) Foreign exchange risk

The Group mainly operates in Hong Kong and the People's Republic of China ("PRC") and is exposed to foreign exchange risk primarily through sales and purchases which give rise to receivables, payables and cash balances that are denominated in a foreign currency, i.e. a currency other than the functional currency of the operations to which the transactions relate. The currencies giving rise to this risk are Renminbi, Hong Kong dollar and United States dollar. The Group continuously monitors its foreign currency position and will consider hedging significant foreign currency exposure by using foreign exchange forward contracts when the need arises.

The Group has certain investments in foreign operations, whose net assets are exposed to foreign currency translation risk.

At 31 December 2023, if Hong Kong dollar had weakened or strengthened by 5% against the Renminbi with all other variables held constant, profit after income tax for the year of the Group would have been HK\$431,000 (2022: HK\$4,640,000) higher or lower respectively, mainly as a result of foreign exchange gains on translation of bank balances, receivable and payable balances denominated in a foreign currency.

Under the Linked Exchange Rate System in Hong Kong, Hong Kong dollar is pegged to the United States dollar. Therefore the Group does not expose to significant foreign exchange risk in respect of its assets and liabilities denominated in United State dollar.

(ii) Interest rate risk

The Group's amount due to the non-controlling interest, bank balances and bank borrowings bear interest at floating rates which expose the Group to cash flow interest rate risk. The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

At 31 December 2023, if interest rates on financial assets had been 100 basis points higher or lower with all other variables held constant, profit after income tax and retained profits for the year of the Group would have been HK\$8,231,000 (2022: HK\$8,620,000) higher or lower respectively, mainly as a result of higher or lower finance income from floating rate loan to a joint venture and bank balances.

3.1 FINANCIAL RISK FACTORS (Continued)

(a) Market risk (Continued)

(ii) Interest rate risk (Continued)

At 31 December 2023, if interest rates on financial liabilities had been 100 basis points higher or lower with all other variables held constant, profit after income tax for the year of the Group would have been HK\$3,709,000 (2022: HK\$2,144,000) lower or higher respectively mainly as a result of higher or lower finance cost from floating rate bank borrowings and amounts due to the non-controlling interests.

The Group currently does not have a hedging policy on interest rate exposure. However, management monitors interest rate exposure and will consider hedging significant interest rate exposure if necessary.

(b) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations, resulting in a financial loss to the Group. The Group's credit risk is primarily attributable to trade and other receivables, bank deposits, cash and cash equivalents and loan to a joint venture.

The Group does not provide any guarantees which would expose the Group to credit risk.

For bank deposits and cash and cash equivalents, a substantial portion of the Group's bank balances and deposits were placed with PRC state-owned banks which have sound credit ratings. Management considers the credit risk is low.

(i) Trade and other receivables

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer rather than the industry or country in which the customers operate and therefore significant concentrations of credit risk primarily arise when the Group has significant exposure to individual customers. There is no concentration of credit risk with respect to trade and other receivables as the Group has a large number of customers which are widely dispersed. No individual third party customers accounted for more than 10% of the Group's revenue.

The Group has established a credit risk management policy under which individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Trade receivables are due within seven days to three months from the date of billing. Normally, the Group does not obtain collateral from customers.

(b) Credit risk (Continued)

(i) Trade and other receivables (Continued)

The Group measures loss allowances for trade and other receivables at an amount equal to lifetime expected credit losses, which is calculated using a provision matrix. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases. The Group considered that there is no significant loss allowance recognised in accordance with HKFRS 9 as at 31 December 2023 and 31 December 2022, and no expected credit loss rate has therefore been disclosed.

(ii) Credit risk arising from loan to a joint venture

Loan to a joint venture was granted taken into account of their financial position, past experience and other factors. The Group monitored the credibility of the joint venture continuously by monitoring the operation and financial position of the joint venture and considered that the credit risk arising from the loan was insignificant.

(c) Liquidity risk

Prudent liquidity risk management implies maintaining sufficient cash, the availability of funding through an adequate amount of committed credit facilities. The Group aims to maintain flexibility in funding by maintaining available committed credit lines.

3.2 CAPITAL RISK MANAGEMENT

Capital represents the total equity as shown in the consolidated statement of financial position.

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders, issue new shares or sell assets to reduce short-term and long-term borrowings.

There were no changes in the management's approach to capital management of the Group during the year. Neither the Company nor any of its subsidiaries are subject to externally imposed capital requirements.

3.3 FAIR VALUE ESTIMATION

The carrying values less impairment loss (if applicable) of financial assets (including bank deposit and cash and cash equivalents) and the carrying values of financial liabilities with maturities within twelve months from the end of the reporting period are reasonable approximation of their fair values.

The financial instruments are measured in the statement of financial position at fair values and disclosed under the following fair value measurement hierarchy:

Level 1: Quoted prices (unadjusted) in active market for identical assets and liabilities;

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the assets and liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices); and

Level 3: Inputs for the asset or liability that are not based on observable market data (i.e. unobservable inputs).

The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities in future financial periods are stated below.

(i) Impairment assessment of property, plant and equipment, land use rights, software and goodwill

The Group's property, plant and equipment, land use rights, software and goodwill which primarily attributable to cargo handling and storage segment, amounted to HK\$2,541,561,000 as at 31 December 2023. Management has performed impairment assessment on these assets based on the policies set out below.

The Group tests annually whether goodwill has suffered any impairment, in accordance with the accounting policy stated in note 2.8. Determining whether goodwill is impaired requires an estimation of the recoverable amounts of CGUs to which goodwill has been allocated. The recoverable amounts of CGUs have been determined based on value-in-use calculations.

According to the accounting policies stated in notes 2.10 and note 2.8, property, plant and equipment, land use rights and software are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. Management judgement is required in the area of asset impairment particularly in assessing (i) whether any events including changes in government policies has occurred that may indicate that the related asset value may not be recoverable; (ii) whether the carrying value of an asset can be supported by the recoverable amount, being the higher of fair value less costs of sale or net present value of future cash flows which are estimated based upon the continued use of the asset in the business; and (iii) the appropriate key assumptions to be applied in preparing cash flow projections including revenue growth rates and discount rates.

The key assumptions applied in the cash flow projections of value-in-use calculations are revenue growth rates and discount rates and are set out in note 10.

(ii) Loss allowance for trade and other receivables

Management measures the loss allowance for expected credit losses of trade and other receivables based on the credit history of its customers, the current market situation and forecasts of future economic conditions. Management will reassess the estimations at each the end of each reporting period.

Revenue consists of revenues from cargo transportation, cargo handling and storage, passenger transportation, fuel supply and corporate and other businesses.

The directors of the Group regard CKSE as the immediate holding company, which owns 71% (2022: 70%) of the Company's ordinary shares. The parent company of the Group is Guangdong Provincial Port & Shipping Group Company Limited ("GDPS"), a state-owned enterprise established in the PRC. GDPS itself is controlled by the PRC government, which also owns a significant portion of the productive assets in the PRC.

In accordance with HKAS 24 (Revised), government-related entities and their subsidiaries, directly or indirectly controlled, jointly controlled or significantly influenced by the PRC government are defined as related parties of the Group. On that basis, related parties include GDPS and its subsidiaries (other than the Group), other government-related entities and their subsidiaries, other entities and corporations in which the Company is able to control or exercise significant influence and key management personnel of the Company and GDPS as well as their close family members.

For the years 2023 and 2022, the Group's significant transactions with entities that are controlled, jointly controlled or significantly influenced by the PRC government, mainly include most of its bank deposits and the corresponding interest income and part of sales and purchases of goods and services. The price and other terms of such transactions are set out in the underlying agreements, based on market prices or as mutually agreed.
