NOTICE IS HEREBY GIVEN THAT the annual general meeting (the "Annual General Meeting" or "AGM") of Yadong Group Holdings Limited (the "Company") will be held at Conference Room, 4/F., No. 381 Laodong East Road, Tianning District, Changzhou, Jiangsu Province, China on Friday, 28 June 2024 at 9:30 a.m. for the purposes of considering and, if thought fit, passing with or without modifications, the following resolutions as ordinary resolutions.

Unless otherwise specified, capitalised terms used in this notice and the following resolutions shall have the same meanings as those defined in the circular of the Company dated 29 April 2024 (the "Circular").

ORDINARY RESOLUTIONS

- 1. To receive and adopt the audited consolidated financial statements of the Company for the year ended 31 December 2023 and the reports of the directors of the Company (the "**Directors**") and auditors of the Company thereon.
