The Board proposed that Ernst & Young Hua Ming LLP be appointed as the internal control auditor for 2024 to audit the effectiveness of the internal control of the Company and issue an audit report therefore, until the conclusion of the 2024 annual general meeting of the Company, and that the Board be authorized to fix its remuneration.

SPECIAL RESOLUTIONS

6. Proposal on Amending the Articles of Association, Rules of Procedure of the General Meeting, Rules of Procedure of the Board and Rules of Procedure of the Supervisory Committee

In February 2023, the State Council published the "Decision of the State Council to Repeal Certain Administrative Regulations and Documents" (《國務院關於廢止部分行政法規 和文件的決定》), and the CSRC published the "Trial Administrative Measures of Overseas Securities Offering and Listing by Domestic Companies"(《境內企業境外發行證券和上市管 理試行辦法》), accordingly, the "Special Regulations of the State Council on the Overseas Securities Offering and Listing of Shares by Joint Stock Limited Companies" (《國務院關於 股份有限公司境外募集股份及上市的特別規定》) and the "Mandatory Provisions for Articles of Association of Companies to be Listed Overseas"(《到境外上市公司章程必備條款》) were abolished. The Hong Kong Stock Exchange amended the Hong Kong Listing Rules based on the aforementioned new regulations, with effect from 1 August 2023. The CSRC also published the "Measures for the Administration of Independent Directors of Listed Companies" (《上市 公司獨立董事管理辦法》) in August 2023, and amended the "Guidelines to Articles of Association of Listed Companies" (《上市公司章程指引》) in December 2023. In addition, the Company is planning to amend its scope of operation to reflect its actual business development. Based on the aforementioned situations and taking into account the Company's actual operation and management needs, the Board proposed to amend relevant provisions in the Articles of Association to continuously comply with relevant regulatory requirements. In light of the proposed amendments to the Articles of Association, the Rules of Procedure of the General Meeting of the Company (the "Rules of Procedure of the General Meeting"), the Rules of Procedure of the Board of the Company (the "Rules of Procedure of the Board") and the Rules of Procedure of the Supervisory Committee of the Company (the "Rules of Procedure of the Supervisory Committee") are proposed to be amended to, among others, align with the proposed amendments to the Articles of Association (collectively referred to as the "Proposed Amendments").

The Proposed Amendments will not cause any changes to the existing rights of the Company's class Shareholders or the existing arrangements for class Shareholders' meetings. A special resolution will be proposed at the AGM, the A Shareholders' Class Meeting and the H Shareholders' Class Meeting to consider and approve the proposed 2023 Profit Distribution and Capital Reserve Capitalization Plan.

Details of the Plan

The Board proposed to pay a final dividend of RMB1.00 (inclusive of tax) per Share for the year ended 31 December 2023 to the Shareholders. As at the Latest Practicable Date, the Company has a total of 168,707,203 Shares in issue, net of 1,346,828 A Shares which have been repurchased but not yet cancelled, and the total proposed final dividend is calculated as RMB167,360,375.00 (inclusive of tax). In the event that the total share capital of the Company changes before the shareholding registration date, the Company will maintain the dividend distribution per Share unchanged, and adjust the aggregate amount accordingly.

The Board also proposed the issue of the Capitalization Shares on the basis of 4 Capitalization Shares for every existing 10 Shares out of reserves of the Company to the Shareholders as at the shareholding registration date for determining Shareholders' entitlements to the Capitalization Issue. As at the Latest Practicable Date, the Company has a total of 168,707,203 Shares (comprising 139,108,603 A Shares and 29,598,600 H Shares) in issue, net of 1,346,828 A Shares which have been repurchased but not yet cancelled, the proposed increase of Capitalization Shares is calculated as 66,944,150 Shares comprising 55,104,710 New A Shares and 11,839,440 New H Shares. In the event that the total share capital of the Company changes before the shareholding registration date, the Company will maintain the proportion of the Capitalization Issue per Share unchanged, and adjust the total shares of the Capitalization Issue, the total share capital of the Company will be 235,651,353 Shares, provided that the actual number of Shares shall be subject to the disclosure in an announcement to be separately issued upon the completion of the statutory procedures by the Company.

The Capitalization Issue is subject to the following conditions:

- (i) approval of the Shareholders by way of a special resolution at the AGM, the H Shareholders' Class Meeting and the A Shareholders' Class Meeting;
- (ii) the Hong Kong Stock Exchange granting the listing of, and permission to deal in, the New H Shares; and
- (iii) compliance with the relevant legal procedures and requirements under the Company Law to effect the Capitalization Issue.

The Independent Non-executive Directors have expressed their view that the 2023 Profit Distribution and Capital Reserve Capitalization Plan fully considered the Company's actual operating performance, cash flow and capital needs and etc., while considering the reasonable appeal of investors. This plan is conducive to return investors, and will not affect the normal operation and long-term development of the Company.

The decision procedure and mechanism of this Plan are complete, and its distribution (capitalization) standard and proportion are clearly specified and in line with the provisions of the Articles of Association and relevant review procedures, and the legitimate rights and interests of minority investors are fully protected. There is no unreasonable situation such as arbitrage of major Shareholders and the situation of relevant Shareholders abusing its rights to interfere with the Company's decisions.

Reasons for the Capitalization Issue

As of 31 December 2023, the balance of capital reserve as shown at the financial statements of the Company amounted to approximately RMB3,121.40 million. Based on the expectations on the future development of the Company, and with reference to the operating results and the overall financial status of the Company, the Board proposed the 2023 Profit Distribution and Capital Reserve Capitalization Plan so as to share the fruitful result of the Company's business performance with the Shareholders. The Board believes that the Capitalization Issue will allow the Shareholders to enjoy a pro-rata increase in the number of Shares held by them in the Company without incurring any significant costs to them, and further afford the Shareholders with more flexibility in managing their own investment portfolios. The Capitalization Issue will also result in the increase of the number of Shares in issue, and the number of Shares held by H Shareholders, which will motivate the trading of Shares by the H Shareholders, and thus will enhance the trading activities and liquidity of the Shares in the market. Besides, the trading price per Share traded after ex-entitlement to the Capitalization Shares is expected to decrease after the Capitalization Issue. This decrease in the trading price for each Share traded after ex-entitlement will reduce transaction costs incurred by the Shareholders and potential investors of the Company for acquiring each board lot of Shares in the future and hence help further broaden the shareholder base of the Company.

By way of illustration only, the closing price per Share as quoted on the Hong Kong Stock Exchange as of the Latest Practicable Date was HK\$38.000 and the board lot value of the Shares as of the Latest Practicable Date was HK\$3,800.0. As the number of Shares to be held by the Shareholders would increase by 40% had the Capitalization Issue taken place, the market value per board lot would theoretically decrease by approximately 28.57% after the Capitalization Issue. With reference to the aforementioned closing price per Share, the theoretical board lot value as a result of the Capitalization Issue would be approximately HK\$2,714.3.

In determining the ratio of the Capitalization Issue on the basis of 4 new Shares for every 10 existing Shares, the Board has considered the following factors (i) the amount to be capitalized out of the capital reserve account of the Company as a result of the Capitalization Issue (i.e. approximately RMB66,944,150), (ii) the number of Capitalization Shares which the Company will issue (i.e. 66,944,150 Shares, comprising of 55,104,710 New A Shares and 11,839,440 New H Shares), and (iii) the existing board lot size of 100 Shares, the creation of odd lots as a result of the Capitalization Issue and arrangements on minimising fractional Shares.

The Company is aware of other methods, such as share subdivision and a change in board lot size. However, these methods, when compared to the Capitalization Issue, involve more administrative procedures, such as arrangements for exchanging new share certificates for existing share certificates, and have not simultaneously achieved the effect of increasing the shareholding number of the Shareholders and reducing the transaction price per Share. And practices similar to such methods are not correspondingly applicable to A Shareholders. Accordingly, the Directors are of the view that the Capitalization Issue is appropriate in the circumstances and is in the interests of the Company and the Shareholders as a whole.

As of the Latest Practicable Date, the Company does not have any concrete plan to conduct any equity fundraising activity in the next 12 months. Save for 326,363 Shares to be vested under the Company's 2021 Restricted A Share Incentive Scheme, there are no outstanding options, convertible bonds, warrants or other similar securities of the Company which are convertible into Shares.

Status of Capitalization Shares

The Capitalization Shares will, subject to the Articles of Association, rank *pari passu* in all respects with the Shares in issue on the date of the issue of the Capitalization Shares. Holders of the Capitalization Shares will be entitled to receive all future dividends and distributions (if any) which are declared, made or paid after the date on which the Capitalization Shares are allotted and issued. The Capitalization Issue should not result in any change to the rights of the Shares nor any new class of Shares to be listed.

Fractional Capitalization Shares

In respect of H Shareholders, the New H Shares will be issued on a pro rata basis and any fractional Shares (if any) will be rounded down to the nearest whole unit. No fractional Shares will be issued and distributed pursuant to the Capitalization Issue but will be aggregated and sold for the benefit of the Company.

In respect of A Shareholders, in accordance with requirements under the Guideline of the Shanghai Branch of China Securities Depository and Clearing Corporation Limited on Business of Security Issuers (《中國證券登記結算有限責任公司上海分公司證券發行人業務指 南》), in the event of registration of fractional shares, CSDC requires that the fractional shares less than one share arising from the issuance of bonus shares or the issuance of shares by capitalization of capital reserve are sorted in descending order by the number of fractional shares held by shareholders, and if the numbers of fractional shares are same, they shall be sorted randomly by electronic settlement system. The CSDC shall register them as one share one by one according to the order until the issuance of bonus shares or the issuance of shares by capitalization of capital reserve is completed. Accordingly, no fractional New A Shares shall be allotted to A Shareholders under the Capitalization Issue.

Odd Lot Arrangement

H Shareholders in odd lots should note that successful matching of the sale and purchase of odd lots of the H Shares is not guaranteed. H Shareholders who are in doubt about this service are recommended to consult their professional advisors.

Overseas H Shareholders

As at the Latest Practicable Date, according to the latest register of members available to the Company, the Company had one H Shareholder with a registered address in the United Kingdom. The Company has been advised that there are no legal restrictions to issue New H Shares to the H Shareholder with the above registered address and therefore, such H Shareholder will also be entitled to the New H Shares.

Upon the Capitalization Issue becoming unconditional, or should there be any overseas Shareholders on the shareholding registration date, the Company will make enquiry on whether there are any overseas Shareholders located in other jurisdictions, and if there are such overseas Shareholders, the Company will make enquiry regarding the legal restrictions (if any) under the laws of the relevant places and the requirements of the relevant regulatory bodies or stock exchanges for the relevant overseas Shareholders to be eligible to take part in the Capitalization Issue pursuant to the Hong Kong Listing Rules. Upon such enquiry, if the Board is of the view that the exclusion of the overseas Shareholders is necessary or expedient on account either of the legal restrictions under the laws of the relevant place or the requirements of the relevant regulatory body or stock exchange in that place, the Capitalization Shares will not be issued to those overseas Shareholders. Note: Mr. Jiang Wei directly holds 47,520,000 A Shares in the Company. He is the spouse of Ms. You Jie, a non-executive Director, and therefore he is deemed under the SFO to be interested in the 28,800,000 A Shares held by Ms. You Jie in the Company. Tax Arrangement

According to the relevant provisions of the State Administration of Taxation of the PRC, the Capitalization Issue shall be proceeded by the reserves of the Company, and is exempt from any tax or any withholding tax.

In accordance with the Enterprise Income Tax Law of the People's Republic of China (《中華人民共和國企業所得税法》) and its implementation rules effective on January 1, 2008, where a PRC domestic enterprise distributes dividends for financial periods beginning from January 1, 2008 to non-resident enterprise shareholders, it is required to withhold 10% enterprise income tax for such non-resident enterprise shareholders. Therefore, the Company will, after withholding 10% of the final dividend as enterprise income tax, distribute the final dividend to non-resident enterprise shareholders, i.e. any shareholders who hold the Company's shares in the name of non-individual shareholders, including but not limited to HKSCC Nominees Limited, other nominees, trustees, or holders of H Shares registered in the name of other organizations and groups.

However, if otherwise provided by tax laws, relevant tax treaties or notices, the tax will be withheld in accordance with the relevant requirements and tax levy and administration requirements.

For dividends of the shares listed on the Hong Kong Stock Exchange received by mainland securities investment funds from investment through the Shanghai-Hong Kong Stock Connect, the tax payable shall be the same as that for above individual investors. For dividends of the shares listed on the Hong Kong Stock Exchange received by mainland enterprise investors from investment through the Shanghai-Hong Kong Stock Connect, H-share companies shall not withhold income tax of dividends, and mainland enterprise investors shall report and pay the tax amount by themselves. In particular, the dividends received by resident enterprises in mainland which hold H shares for at least 12 consecutive months shall be exempted from enterprise income tax according to law.

According to the requirements of the Notice on the Tax Policies Concerning the Pilot Program of the Shenzhen-Hong Kong Stock Connect published by the Ministry of Finance, the State Administration of Taxation and the CSRC (Cai Shui [2016] No. 127) (《財政部、國家税 務總局、中國證監會關於深港股票市場交易互聯互通機制試點有關税收政策的通知》(財税 [2016]127號)), H-share companies shall withhold an individual income tax at the rate of 20% on dividends from the H shares of the company invested by mainland individual investors on the Hong Kong Stock Exchange through the Shenzhen-Hong Kong Stock Connect. For dividends of the shares listed on the Hong Kong Stock Exchange received by mainland securities investment funds from investment through the Shenzhen-Hong Kong Stock Connect, the tax payable shall be the same as that for above individual investors. For dividends of the shares listed on the Hong Kong Stock Exchange received by mainland enterprise investors from investment through the Shenzhen-Hong Kong Stock Connect, H-share companies shall not withhold income tax of dividends, and mainland enterprise investors shall report and pay the tax amount by themselves. In particular, the dividends received by resident enterprises in mainland which hold H shares for at least 12 consecutive months could be exempted from enterprise income tax according to law.

Application for Listing

The A Shares and H Shares are listed on the Sci-Tech Innovation Board of the SSE and the Main Board of the Hong Kong Stock Exchange, respectively. Application will be made by the Company to the Listing Committee of the Hong Kong Stock Exchange for the approval for the listing of, and permission to deal in, the New H Shares. The New A Shares will be listed on the Sci-Tech Innovation Board of the SSE. Subject to the satisfaction of the conditions as set out in this circular (including but not limited to the granting of the aforesaid approval by the Hong Kong Stock Exchange), the New H Shares will be accepted as eligible securities by HKSCC for deposit, clearance and settlement in CCASS. All necessary arrangements will be made by the Company for the New H Shares to be admitted into CCASS. All activities under CCASS are subject to the General Rules of CCASS and CCASS Operational Procedures in effect from time to time.

Aside from the Hong Kong Stock Exchange, the New H Shares will not be listed at or dealt in any other stock exchanges, and the Company is not currently seeking for or proposing to seek for the listing at or dealing in any other stock exchanges for the New H Shares. All Capitalization Shares are non-renounceable.

Dear Shareholders,

In 2023, the Board complied with the relevant laws, regulations, normative documents and the provisions of the Company's system, including the Company Law, the Securities Law, the STAR Market Listing Rules, the Hong Kong Listing Rules, the Articles of Association, the Rules of Procedure of the Board of Shanghai Haohai Biological Technology Co., Ltd.*, effectively performed the duties entrusted to the Board by the Shareholders, and carried out all work diligently and responsibly to promote the Group's continued healthy and stable development. The following is the work report of the Board for 2023:

I. GENERAL OPERATIONS FOR 2023 (THE FOLLOWING FIGURES ARE FROM THE CONSOLIDATED FINANCIAL STATEMENTS PREPARED IN ACCORDANCE WITH THE CHINESE ACCOUNTING STANDARDS)

During the year of 2023, with the stable progression and gradual recovery of the overall national economy of China and the returning to normal of the demand and supply for healthcare resources, the Company and its subsidiaries respectively carried out production and operating activities normally. During the Reporting Period, the Group actively expanded its marketing and promotion channels and intensified its product marketing efforts, resulting in significant growth in sales volume and revenue of each product line as compared to the previous year. During the year of 2023, the Group recorded aggregate revenue of RMB2,654.0391 million, representing an increase of RMB523.7631 million or 24.59% as compared to the previous year, of which, revenue from principal business amounted to RMB2,645.0687 million, representing an increase of RMB530.9021 million or 25.11% as compared to the previous year.

The Company's net profit attributable to shareholders of the Company and net profit attributable to shareholders of the Company (net of non-recurring gains or losses) for the year of 2023 were RMB416.1213 million and RMB383.4064 million, increased on 130.58% and 141.52% respectively as compared to the previous year, which were mainly attributable to the increase in operating profit and net profit as a result of the substantial increase in revenue from high-margin hyaluronic acid products during the Reporting Period, as well as the dual effect of events of production and operation stoppage and asset impairment loss in 2022 not occurring during the Reporting Period.

The Supervisory Committee is of the opinion that: the deposit and actual use of the proceeds of the Company are in compliance with the Rules Governing the Listing of Securities on the Sci-Tech Innovation Board of the Shanghai Stock Exchange, the Guidelines for Self-Regulatory Supervision of Companies Listed on the STAR Market of the Shanghai Stock Exchange No. 1 – Standardized Operation, the Company's Share Proceeds Management System and other laws and regulations and normative documents. The proceeds have been stored in special accounts and used for special purposes, and the relevant information disclosure obligations have been fulfilled in a timely manner. The specific use of proceeds is consistent with that disclosed by the Company. There is no disguised change in the use of proceeds and damage to the interests of shareholders, and there is no illegal use of proceeds.

(V) Implementation of internal control

During the Reporting Period, the Supervisory Committee monitored the implementation of the Company's internal control.

The Supervisory Committee is of the opinion that: the Company has maintained effective internal control in all material respects and the internal control system is operating effectively in accordance with the requirements of the corporate internal control standard system and relevant regulations. There were no major deficiencies in internal control of financial reports or non-financial reports during the Reporting Period.

(VI) Implementation of equity incentives

During the Reporting Period, the Supervisory Committee supervised the implementation of the equity incentives under the 2021 Restricted A Share Incentive Scheme of the Company (hereinafter referred to as the "Incentive Scheme"), including the adjustment of the price of the Incentive Scheme, the cancellation of certain restricted shares, and the vesting of the first vesting period of the first grant and reserved grant.

The Supervisory Committee is of the view that the relevant matters were in compliance with the Management Measures for Share Incentive Scheme Adopted by Listed Companies and other laws and regulations and the requirements of the 2021 Restricted A Share Incentive Scheme of Shanghai Haohai Biological Technology Co., Ltd.*, the review process was in compliance with the laws and regulations, and there are no circumstances that jeopardize the legal rights and interests of the Company and all shareholders.

III. WORK PLAN OF THE SUPERVISORY COMMITTEE FOR 2024

In 2024, with the further development of the Company's various businesses, the Supervisory Committee will continue to strictly comply with the duties regulated under the national laws and regulations, the Articles of Association and the Rules of Procedure of the Supervisory Committee, perform its duties with due diligence, and effectively safeguard and protect the legitimate interests of the Company and its Shareholders. The main work plan is set out as follows:

1. Continuously carry out the daily deliberation activities of the Supervisory Committee, ensure the legal compliance of various decision-making procedures, and supervise the legal operation of the Company. At the same time, strengthen communication with the management of the Company to gain an in-depth understanding of the daily operation and management of the Company; supervise the performance of duties of Directors and senior management to prevent actions that damage the interests of the Company and Shareholders;

- 2. Inspect the Company's financial position, enhance communication with the Company's internal and external auditors through regular understanding and review of financial reports, and supervise the Company's financial operations for ensuring that the financial statements are true and accurate;
- 3. Continuously strengthen the supervision and inspection on the Company's internal control, connected (related) transactions, deposit and use of share proceeds, share incentive and other major matters to ensure that the Company implements effective internal control measures to prevent risks;
- 4. Strengthen self-construction and enhance its own learning by participating in training related to the standardized operation of listed companies so as to enhance the quality of supervision and inspection work and effectively safeguard the interests of the Company and its shareholders.

REPURCHASE MANDATE

Reasons for Repurchasing H Shares

The Directors believe that the flexibility afforded by the Repurchase Mandate would be beneficial to and in the best interest of the Company and its Shareholders. As at the Latest Practicable Date, to the best knowledge and belief of the Directors, Mr. Jiang Wei ("Mr. Jiang") and Ms. You Jie ("Ms. You") were deemed to be interested in 77,990,000 A Shares (as defined in Part XV of the SFO), representing approximately 46.23% of the Company's total issued capital. 77,990,000 A Shares were held directly by Mr. Jiang as to 47,520,000 A Shares and through Shanghai Zhanze Corporate Management Partnership Enterprise* (上海湛澤企業管理合夥企業(有限合夥)), a limited partnership controlled by him through his wholly-owned company, Shanghai Zhanxi Corporate Management Limited Company* (上海湛溪企業管理有限公司), as to 1,670,000 A Shares and directly by Ms. You as to 28,800,000 A Shares, respectively. Mr. Jiang, as the spouse of Ms. You, was deemed to be interested in the 28,800,000 A Shares held by Ms. You in the Company under the SFO. Ms. You, as the spouse of Mr. Jiang, was deemed to be interested in the 49,190,000 A Shares held by Mr. Jiang in the Company under the SFO.
