In September 1999, he was appointed as Deputy General Manager and Member of CPC Committee of PetroChina Daging Petrochemical Company; in December 2001, he was appointed as General Manager and Deputy Secretary of CPC Committee of PetroChina Daqing Petrochemical Company; in September 2003, he was appointed as General Manager and Secretary of CPC Committee of PetroChina Lanzhou Petrochemical Company; in June 2007, he was appointed as General Manager and Deputy Secretary of CPC Committee of PetroChina Lanzhou Petrochemical Company and General Manager of Lanzhou Petroleum & Chemical Company; in September 2008, he was appointed as a member of the Leading Party Member Group and Deputy General Manager of China National Petroleum Corporation; in May 2011, he acted concurrently as Director of PetroChina Company Limited; in June 2018, he was appointed as a Member of the Leading Party Member Group and Vice President of China Petrochemical Corporation; in September 2020, he was appointed as Senior Vice President of Sinopec Corp.; in November 2021, he was appointed as President of Sinopec Corp. In October 2018, he was elected as Director of Sinopec Corp.

As at the date of this announcement, Mr. Zhao Dong, Mr. Wan Tao and Mr. Yu Baocai did not have any interest in the shares of Sinopec Corp. within the meaning of Part XV of the Securities and Futures Ordinance and have not received any regulatory sanction imposed by the China Securities Regulatory

Commission, or any other government authorities or stock exchanges.

Mr. Zhao Dong, Mr. Wan Tao and Mr. Yu Baocai will enter into relevant service contracts with Sinopec Corp. for a term of service to the date when the eighth session of the Board expires. As Executive Directors and/or Senior Management of the Company, their remuneration will mainly consist of annual base salary, annual performance-based salary and incentive during the tenure. The Company will disclose in its annual report the remuneration obtained by Mr. Zhao Dong, Mr. Wan Tao and Mr. Yu Baocai in the Company during the reporting period.

Due to work arrangement, Mr. Yu Baocai resigned as the President of the Company. Mr. Yu Baocai confirmed that he has no disagreement with the Board and there are no other matters relating to his resignation that need to be brought to the attention of shareholders of the Company. Mr. Yu Baocai performed his duties faithfully, has been diligent and responsible during his tenure and has made important contributions to the production and operation management and transformation development of the Company. The Board would like to express its sincere gratitude to him for his hard work and contributions.
