



CHAIRMAN'S STATEMENT 主席報告

Dear Shareholders.

On behalf of the board (the "Board") of director(s) (the "Director(s)") of Imagi International Holdings Limited (the "Company", together with its subsidiaries as the "Group"), I would like to present the annual report of the Company for the year ended 31 December 2023 (the "Year under Review") to the shareholder(s) of the Company (the "Shareholder(s)").

BUSINESS REVIEW

The past year had been challenging for the Company. In 2023, the Hong Kong and China equity markets were the worst performing major market of the world as a result of the damaging effect of a plummeting property market in China with its rippling effects on China financial markets, the net worth of the population which, in turn depressed consumers' consumption appetite. During that period, the Hong Kong and China financial markets were also detrimentally affected by the remnants of the world's inflation, high interest rates and energy prices, all of which are resistant to turnaround. All these combined to adversely affected Hong Kong, China and the world business and economy. As aforementioned, China's property market was severely impacted by the China regulatory authorities' severe curtailment in credits to the over-leveraged property companies. As one of the Company's principal business is financial service, the operating business of the Company and its investment portfolio for the Year under Review suffered as a result of the combined aforementioned adverse factors. For 2023, the Group recorded a revenue of approximately HK\$49 million which represents a decrease of 17% as compared to financial year of 2022 while impairment allowances on margin loans receivable and loans receivable for 2023 increased in line with the deteriorating market environment and expectation. All the above combined to adversely affect the Company's results which ended with a net loss attributable to the shareholder of the Company of approximately HK\$13 million for the Year under Review.

親愛的股東:

本人謹代表意力國際控股有限公司(「本公司」, 連同其附屬公司統稱「本集團」)董事(「董事」) 會(「董事會」),謹此向本公司股東(「股東」)呈 報本公司截至二零二三年十二月三十一日止年 度(「回顧年度」)之年報。

業務回顧

過去的一年對本公司而言充滿挑戰。於二零 二三年,香港及中國股票市場為全球表現最差 的主要市場,乃由於中國房地產市場暴跌的破 壞性影響,對中國金融市場、人口淨值產生連 鎖影響,進而令消費者的消費意欲不振。於此 期間,香港及中國金融市場亦遭受全球通貨膨 脹、利率以及能源價格高企余留的負面影響, 而所有該等因素不易扭轉。凡此種種綜合對香 港、中國以及全球商業及經濟產生不利影響。 如上文所述,中國監管部門對槓桿率過高房地 產公司的信貸大幅縮減,嚴重影響中國房地產 市場。由於本公司其中之一主營業務為金融服 務,綜合上述不利因素,本公司於回顧年度之 經營業務及投資組合受到影響。二零二三年, 本集團錄得收入約49,000,000港元,較二零 二二財政年度減少17%,而由於市場環境及預 期疲弱,二零二三年應收保證金貸款及應收貸 款之減值撥備有所增加。上述所有因素綜合對 本公司業績造成不利影響,導致於回顧年度本 公司股東應佔虧損淨額約為13,000,000港元。

In view of the continuing poor economic and depressed financial market conditions and resulting uncertainties, the Group will continue to take a cautious stance in its business development by mainly consolidating its existing business and forego rapid expansion. For the Year under Review, the Company continued to focus its attention and devote resources in developing its core business being the integrated financial services business with stable return and, looking forward into 2024, will continue to do so.

鑒於持續疲弱且低迷的的經濟及金融市場,以及由此產生的不確定性,本集團將繼續於業務發展上採取審慎態度,以鞏固現有業務為主,並放棄快速擴張。於回顧年度,本公司繼續專注並投入資源發展其核心業務,即具有穩定回報的綜合金融服務業務,展望二零二四年將繼續如此行事。

PROSPECTS

With China regulatory authorities beginning to ease their clampdowns and starting to loosen its credit policies, it is expected that the China property market will begin to stabilise. This will in turn filter through the general economy in China and Hong Kong. General business environment in Hong Kong and China for 2024 is expected to see gradual and consistent improvement. We also expect that the high interest regime, which have been topped out recently will begin its reverse in the second half of 2024 thus heralding better environment for the global economy and financial markets. The Company will strive to make more progress in its principal core business of integrated financial services and is confident that there will be improvement in performance for the coming year.

(a) Securities brokerage and related services business

The Company will maintain its strategy of making financial services as a core business and will continue to steadily develop such businesses. With the effects of aforementioned promising improvement in its operating environment, we expect the outlook will improve for the foreseeable future. The management of the Company (the "Management") will persist with its expansion strategy but will proceed with caution and constantly assess and monitor the market situation. The Company expects that performance of securities brokerage and related services business will continue to improve in 2024 and remain a significant contributor to the Group's operations and profits for the coming future.

前景

隨著中國監管機構開始放鬆整頓並著手放寬信貸政策,預期中國房地產市場將開始企穩。這將轉而影響中國及香港的整體經濟。預計二零二四年香港及中國的總體商業環境將逐步並持續地改善。我們亦預計高利率制度近期已封頂並將於二零二四年下半年開始逆轉,從而預示全球經濟及金融市場的環境將會好轉。本公司將致力於主要核心業務綜合金融服務取得更多進展,並有信心於來年改善業績。

(a) 證券經紀及相關服務業務

本公司將堅持以金融服務為核心業務的策略,繼續穩步發展該業務。在前述營運環境將有希望改善的影響下,我們預期於可見未來的前景將有所改善。本公司管理層(「管理層」)將堅持其擴展戰略,但將謹慎行事,並不斷評估及監控市場形勢。本公司預計證券經紀及相關服務業務的表現將於二零二四年繼續改善,並於未來繼續為本集團營運及溢利作出重要貢獻。

(b) Money lending business

During the Year under Review, the Group made total new loan principal of HK\$170.2 million and generated interest income of approximately HK\$10 million which was recorded under provision of finance segment. With the difficult economic environment stated previously, the Group had slowed down its money lending business but the Management is still confident that the money lending business will in future continue to provide steady and attractive returns to the Group.

(c) Securities investments and proprietary trading

For the Year under Review, the Hong Kong and China economy and financial markets had been negatively affected as previously mentioned. As such, the Group intends to acquire listed securities for long-term purpose in future and realising their performance in the long run.

(d) Computer graphic imaging ("CGI") business and entertainment business

The Management believes that CGI business will not be profitable in the near terms and as a result, the Company will devote only minimal resources to maintain the business until there is significant turnaround in prospects for this business.

As Hong Kong began returning to normal in 2023, the Company started film distribution license rights business and artiste management during the Year under Review. The Company will actively seek, in 2024, for additional opportunities in movie investment or production and also will look towards to broaden its entertainment business in film distribution license rights related areas, especially focus on local movies.

(b) 放債業務

於回顧年度,本集團新增貸款本金總額 為170,200,000港元及產生利息收入約 10,000,000港元,並計入提供融資分部 項下。由於上文所述困難的經濟環境,本 集團已放慢其放債業務,惟管理層仍相 信,放債業務未來將繼續為本集團帶來 穩定及可觀回報。

(c) 證券投資及自營交易

於回顧年度內,香港和中國經濟以及金融市場受到上文所述的負面影響。因此本集團擬於未來,就長期目的收購上市證券並且從長遠變現其表現。

(d) 電腦造像(「電腦造像」)業務及娛樂業務

管理層認為,電腦造像業務將於短期內 不會盈利,因此,於該業務前景出現重大 好轉前,本公司將僅投入極少資源來維 持該業務。

隨著香港於二零二三年開始恢復正常, 本公司於回顧年度內開始從事電影發 行許可權業務及藝人管理。於二零二四 年,本公司將積極物色更多電影投資或 製作機遇,且亦將尋求於電影發行許可 權相關領域擴大其娛樂業務,尤其是專 注於本地電影。

BUSINESS AND OPERATIONAL REVIEW

For the Year under Review, the principal business of the Group remain engaging in integrated financial services ("Integrated Financial Services"), investment holdings, CGI business and entertainment business. The Integrated Financial Services comprises of provision of securities brokerage and related financial advisory services, margin financing services, asset management services, corporate finance advisory services, money lending services, listed and unlisted securities investments and proprietary trading. During the Year under Review, the Group started engaging in film distribution license rights business and provision of artiste management services which are reported under entertainment segment. Since 2016, the Integrated Financial Services is the core business of the Group and the Group will continue to devote its principal resources to this business.

There are two main business operations of the Group, namely (a) Integrated Financial Services business; and (b) entertainment business. The Management monitors these two operation results based on four different segments: (i) securities brokerage and asset management (including securities related financial services and margin financing services); (ii) provision of finance (excluding margin financing services under securities brokerage business); (iii) trading of securities; and (vi) entertainment.

The major segments of the Group's business for the Year under Review are as follows:

業務及營運回顧

於回顧年度,本集團的主要業務仍為從事綜合金融服務(「綜合金融服務」)、投資控股、電腦造像業務及娛樂業務。綜合金融服務包括提供證券經紀及相關金融顧問服務、保證金融資服務、資產管理服務、企業融資顧問服務、放債服務、上市及非上市證券投資及自營交易。於了關年度,本集團開始從事電影發行許可權業務以及提供藝人管理服務,該等業務於娛樂分頭下呈報。自二零一六年起,綜合金融服務為項下呈報。自二零一六年起,綜合金融服務為本集團的核心業務,並且本集團將繼續向此業務投入其主要資源。

本集團主要經營兩項業務,即(a)綜合金融服務業務;及(b)娛樂業務。管理層根據四個不同分部監測該等兩項業務的經營業績:(i)證券經紀及資產管理(包括證券相關金融服務及保證金融資服務):(iii)提供融資(不包括證券經紀業務項下的保證金融資服務):(iii)證券買賣:及(vi)娛樂。

本集團於回顧年度的主要業務分部如下:

(a) Integrated Financial Services business

i) Securities brokerage and related financial services

The Group conducts its securities brokerage and related financial services through Imagi Brokerage Limited ("Imagi Brokerage") and Supreme China Securities Limited ("Supreme China"), both are licensed by Securities and Futures Commission of Hong Kong (the "SFC") to carry out regulated activities in Hong Kong. Imagi Brokerage and Supreme China have different risk appetites targeting different clienteles and both of which are indirect nonwholly-owned subsidiaries of the Company. The Company engages in full range of securities brokerage and related services business with different licenses granted by the SFC to Imagi Brokerage including Type 1 (dealing in securities), Type 2 (dealing in futures contracts), Type 4 (advising on securities), Type 5 (advising on futures contracts), Type 6 (advising on corporate finance) and Type 9 (asset management) regulated businesses. Supreme China is principally engaged in securities brokerage, provision of margin financing and provision of underwriting and placing services in Hong Kong and is licensed by the SFC to carry out Type 1 (dealing in securities) regulated activity. Imagi Brokerage is a main contributor to the Group's business and the Management is confident that it will remain a significant contributor to the Group's operations and profits through revenues from brokerage commission and clearing fee income, underwriting and placement commission, related financial services income, interest income on margin clients and asset management fee income.

(a) 綜合金融服務業務

(i) 證券經紀及相關金融服務

本集團透過Imagi Brokerage Limited (「Imagi Brokerage」)及智華證券有 限公司(「智華」)(均獲香港證券及 期貨事務監察委員會(「證監會」) 發牌於香港開展受規管活動)開 展其證券經紀及相關金融服務。 Imagi Brokerage及智華針對不同 客戶擁有不同風險偏好,均為本公 司的間接非全資附屬公司。在證監 會向Imagi Brokerage授出不同牌 照後,本公司從事全面的證券經 紀及相關服務業務,其中包括第 1類(證券交易)、第2類(期貨合約 交易)、第4類(就證券提供意見)、 第5類(就期貨合約提供意見)、第 6類(就企業融資提供意見)及第9 類(提供資產管理)受規管業務。 智華主要於香港從事證券經紀、 提供保證金融資及提供包銷及配 售服務,且獲證監會發牌從事第1 類(證券交易)受規管活動。Imagi Brokerage是本集團業務的主要貢 獻者之一,且管理層相信,透過經 紀佣金及結算費收入、包銷及配 售佣金、相關金融服務收入、保證 金客戶利息收入及資產管理費收 入,其仍將為本集團的營運及溢利 作出重大貢獻。

管理層討論及分析

The Board believes that acquisition and/or forming informal strategic alliance with other local securities brokerage firms would enable the Company to further consolidate the existing clientele, technological infrastructure, and type of services of the allied securities brokerage firms and attract more customers for different financial services. The Group continues to explore other opportunities including co-operations with other securities brokerage firms and through acquisitions of potential securities brokerage firms with clientele in different risk appetites and solid client base so as to enhance the varieties and quality of securities brokerage related services.

For the Year under Review, securities brokerage and related financial services business segment generated a total revenue of approximately HK\$42 million for the Group. As at 31 December 2023, the outstanding margin loans receivable arising from securities brokerage business was approximately HK\$297 million (before impairment allowances) which was secured by underlying equity securities held by the brokerage customers. With reference to the expected credit loss assessment performed by an independent professional valuer, approximately HK\$10 million impairment allowances was provided on the outstanding margin loans receivable as at 31 December 2023. Further details of margin loans receivable, assessment and the related movement of impairment allowances are disclosed in notes 29 to the consolidated financial statements.

With the steady advance in our securities brokerage operations, the Management is confident the Company will maintain its pace in the expansion of its financial services and securities brokerage operations which will remain as a core, sustainable and profitable business for the Group in the foreseeable future.

董事會相信收購及/或與其他本地 證券經紀公司建立非正式戰略聯盟 將令本公司進一步鞏固聯盟證券經 紀公司的現有客戶群、技術基礎設 施及服務類型,並為不同金融服務 吸引更多客戶。本集團繼續探索設 他機遇,包括與其他證券經紀紀 合作以及通過收購具有不同風險婦 好客戶及穩固客戶基礎的潛在證券 經紀公司,以提升證券經紀相關服 務的類別及質素。

於回顧年度,證券經紀及相關金融服務業務分部為本集團產生總收入 約42,000,000港元。於二零二三十十二月三十一日,自證券經紀至 產生之尚未償還應收保證金宣統 為約297,000,000港元(未計減值 備),乃以經紀客戶持有之相關值 備),乃以經紀客戶持有之相關值 份,乃以經紀客戶持有之, 證券作抵押。參考獨立專業付 之預期信貸虧損評估,已之 資還應收保證金貸款計提減值 大之預期信發金貸款計提減值 大之 一步詳情披露於綜合財務報表附 計29。

隨著我們證券經紀業務之穩步發展,管理層有信心本公司將繼續保持其金融服務的擴張步伐,並且於可見未來證券經紀業務仍將成為本集團之核心、持續盈利業務。

(ii) Provision of finance

The Group conducts its money lending business through Imagi Lenders Limited ("Imagi Lenders") which is a licensed money lender and is governed under the Money Lenders Ordinance (Chapter 163 of Laws of Hong Kong) ("MLO") to undertake money lending business in Hong Kong. The Group focuses on providing sizeable loans to niche customers including corporate customers and high-net-worth individuals instead of the mass customer market. These niche customers mostly have been repeat customers and had been customers for a number of years who were mostly acquired through business referrals or introductions by the Company's senior management, business partners or clients or had past business or dealings with the Group. Besides in compliance with all rules and regulations imposed under the MLO, Imagi Lenders conducts the money lending business also with reference to internal money lending policy ("ML Manual"), the Group's overall internal control and operation manual and applicable requirements under the Listing Rules. The business team of Imagi Lenders is led by the general manager of the Company as a compliance officer who is responsible for credit assessment of the loan application and directors of Imagi Lenders are with full power and authorities to review and to approve or reject the loan application in accordance with MLO, the Listing Rules, ML Manual and the Group's internal control and operation manual. The loan terms would be arrived at after considering a combination of factors including prevalent market interest rates, the financial strength of the borrower, the collaterals offered and past credit history of the borrower with Imagi Lenders and adjusted, if necessary, by arms-length negotiations with the borrower. The Group has not entered into any agreement, arrangement, understanding or undertaking (whether formal or informal and whether express or implied) with a connected person with respect to the grant of loans to the borrower(s) whose loan(s) was granted during the Year under Review and was still outstanding as at 31 December 2023.

(ii) 提供融資

本集團透過Imagi Lenders Limited (「Imagi Lenders」,為香港法例第163 章放債人條例(「放債人條例」)項下 之持牌放債人並受其規管以於香港 從事放債業務)開展其放債業務。 本集團專注於向優質客戶(包括公 司客戶及高淨值個人)提供大額貸 款,而非面向大眾客戶市場。該等客 戶大部分為重複客戶以及多年的老 客戶,大部分通過本公司高級管理 層、業務夥伴或客戶之業務引薦及 介紹或與本集團有過過往業務或交 易而獲得。除遵守放債人條例項下 施加之所有規則及規例之外,Imagi Lenders亦參照內部放債政策(「放債 手冊」)、本集團之整體內部監控及營 運手冊以及上市規則項下適用規定 開展放債業務。Imagi Lenders之業 務團隊由本公司總經理(作為合規人 員)領導,彼負責貸款申請之信貸評 估,而Imagi Lenders之董事具有十 足權力及權限以根據放債人條例、 上市規則、放債手冊及本集團之內 部監控及營運手冊核查及批准或拒 絕貸款申請。貸款條款將於考慮多 種因素後達致,包括現行市場利率, 借款人之財務實力、所提供抵押品 以及借款人與Imagi Lenders之過往 信用歷史,以及如有需要,將會與借 款人進行公平磋商以作出調整。本 集團就向於回顧年度已授出貸款且 於二零二三年十二月三十一日貸款 仍未償還之借款人授出貸款,並無 與關連人士訂立任何協議、安排、諒 解書或承諾(不論正式或非正式及不 論明確或隱含)。

Control procedures for money lending service

Imagi Lenders has internal control policy in place and the exposure to the credit risk is monitored on an ongoing basis. The credit risk assessment and internal control procedures for the operation of its money lending business are summarised as follows:

Loan application

Upon receipt of a loan application from potential customers, know-your-client ("KYC") procedures are performed by the servicing team including but not limited to background search including compliance infringements search, verification of the identity documents (e.g. identity card and address proof), review of income or asset proof of the potential customer which include financial statements of corporate clients, securities statements and other proof of assets in relation to the loan principal amount. If and when necessary, the KYC procedures may include interview with the applicants to understand their financial needs and repayment ability. The results of the KYC will be reported to the management of Imagi Lenders for further approval of the subject application.

Loan approval

With reference to the loan application information and the KYC results, the credit assessment team of Imagi Lenders will make recommendation to the management of Imagi Lenders for those loan application with satisfactory results. Imagi Lenders would consider the requests from clients, its own financial situation at the time, risks assessment, the prevailing market/ economic conditions, the prevailing market interest rates (i.e. the prime rate quoted from major banks and the interest rates for personal loans generally offered by banks or licensed money lenders in the market), potential future businesses to arrive at the interest rate, loan tenure, provision of security and/or collateral, if so, and repayment method.

The following factors are taken into account in the approval process:

- the financial conditions of the applicant including overall assessment of the assets, liabilities and annual income of the applicant;
- the availability of guarantee or provision of collateral, if any;
- historical payment record of applicant with the Group, if applicable;
- prevalent market interest rate; and
- the finance cost of Imagi Lenders.

Given the model of business of Imagi Lenders with its focus on niche customers, Imagi Lenders would assess the borrowers on case by case basis instead of relying on a mechanic box-ticking exercise on the credit assessment. If loan application is being approved, a loan agreement together with related loan documents (collectively as the "Loan Documents") will be prepared and executed. Once the Loan Documents are duly executed, the borrower can request for the loan drawdown in accordance with the terms of the Loan Documents.

Loan monitoring and repayment collection

Loan monitoring mechanism had been established. The management of money lending segment is responsible for on-going monitoring of the loan portfolio, loan recoverability, debt collection, identifying potential problems and recommending mitigating measures. The management of Imagi Lenders will conduct regular company searches, internet searches and regulatory compliance searches in order to monitor the risk level. The management of Imagi Lenders will request borrowers for provision of any updated financial information if considered necessary to update their financial ability, credit risk and assess the loan recoverability. These exercises are to monitor if any material adverse change may arise on the financial or legal conditions on the borrowers.

Upon a loan is overdue, this would be immediately advised to senior management of Imagi Lenders for discussion and appropriate actions will be taken on case by case basis. In respect of the mature loans, the management of Imagi Lenders reminds the borrowers of the repayment schedules via phone calls, email or other text message.

In the event of a loan delinquency, the management of Imagi Lenders applies different collection methods depending on the time of delinquency. Follow-up action will include reminding calls, reminders issued by Imagi Lenders, demand letter issued by lawyer and legal proceedings may also be taken if necessary.

During the Year under Review, the new loan facilities granted by the Group were of the size in a range from HK\$0.1 million to HK\$13 million. The total loan principal drawdown during the Year under Review were HK\$170.2 million. The source of funds for the money lending business is funded by internal resources of the Group and thus no external financial cost. For the Year under Review, total interest income generated from money lending business was approximately HK\$10 million, with interest rates ranging from 4% to 12% per annum which are competitive interest rate in the market. As at 31 December 2023, the outstanding loans receivable (including the loan principal and accrued interest) amounted approximately HK\$85 million were due from eleven customers, of which the largest single loan and the five largest loans in aggregate represent approximately 16% (approximately HK\$13.4 million) and approximately 76% (approximately HK\$64.8 million) respectively to the total loans receivable (before impairment allowances). The Company retained an independent professional valuer to conduct impairment assessment on the outstanding loans for each reporting period end date, approximately HK\$4.6 million impairment allowances were provided on the outstanding loans receivable of approximately HK\$85 million as at 31 December 2023. Further details of loans receivable, maturity profile, assessment and movement of impairment allowances on the loans receivable are disclosed in note 31 to the consolidated financial statements.

於回顧年度,本集團授出新貸款 融資金額之規模介乎100,000港 元至13,000,000港元。於回顧年 度內已支取之貸款本金總額為 170,200,000港 元。放 債 業 務 之 資金來源通過本集團內部資源撥 付,因此並無外部融資費用。於 回顧年度,放債業務產生總利息 收入約10,000,000港元,利率介 乎每年4%至12%,為市場上具 有競爭力之利率。於二零二三年 十二月三十一日,尚未償還應收 貸款(包括貸款本金及應計利息) 約85,000,000港元乃應收十一位 客戶之貸款,其中最大單筆貸款 及五筆最大額貸款合共金額分別 佔應收貸款總額(未計減值撥備) 之約16%(約13,400,000港元)及 約76%(約64,800,000港元)。本 公司聘請獨立專業估值師對於各 個報告期末尚未償還之貸款進行 減值評估,就於二零二三年十二 月三十一日之尚未償還應收貸款 約85.000.000港元已計提減值撥 備約4,600,000港元。應收貸款、 應收貸款到期情況、評估及減值 撥備變動之進一步詳情披露於綜 合財務報表附註31。

The Management is confident that the money lending business will remain a consistent and rewarding business for the Group.

(iii) Securities investments and proprietary trading

Securities investments and proprietary trading is one of business operation under the Integrated Financial Services which mainly comprises of purchase and sale of listed and unlisted equity/debt investments. For the Year under Review, the Group recorded a net realised losses from sales of listed equity investments and unrealised losses from changes in fair value of listed equity investments classified as heldfor-trading for the Year under Review of approximately HK\$3.7 million and approximately HK\$20.9 million respectively. As at 31 December 2023, the market value of listed equity investments classified as held-for-trading (for short-term purpose) were approximately HK\$22.3 million and market value/fair value of investment in equity instruments designated at fair value through other comprehensive income (for long-term purpose) were approximately HK\$391.7 million, respectively.

The Company is continuously carefully reviewing its strategy in this business model. As aforementioned, the financial markets in China and Hong Kong were depressed by various factors in 2023. During the Year under Review, the Group cautiously look for securities on performance prospects in longer run instead of the short term and not held-for trading.

(iii) 證券投資及自營交易

證券投資及自營交易為綜合金融 服務項下營運業務之一,主要包 括購買及出售上市及非上市股 票/債務投資。於回顧年度內, 本集團錄得出售上市股本投資的 已變現虧損淨額及因分類為持作 買賣上市股本投資公平值變動 而產生的未變現虧損分別為約 3,700,000港 元 及 約20,900,000 港元。於二零二三年十二月 三十一日,分類為持作買賣(短期 目的)上市股本投資的市值約為 22,300,000港元,且指定為按公 平值計入其他全面收入之股本工 具投資(長期目的)之市值/公平 值約為391,700,000港元。

本公司將繼續審慎檢討該業務模式中的策略。如上文所述,二零二三年中國及香港金融市場受到各種因素影響而表現低迷。於回顧年度內,本集團審慎尋找擁有長期表現前景而非短期及並非持作買賣的證券。

(b) Entertainment business

The operation of CGI business and film related business/investment are reported under entertainment segment. The Management does not see immediate improving prospects for the CGI business. After considering costs and benefits, the Company will devote minimal resources with the intention of just maintaining the CGI business until there are substantial improvements in the potential and prospects. Accordingly, the Company had temporarily suspended efforts on the production side of the CGI business but will only retain efforts on the distribution side of the CGI business.

The Group suspended its film investment in 2022 upon expiry of film investment agreement dated 30 November 2018 which was supplemented by a supplemental agreement dated 28 December 2020 (collectively as the "Film Investment Agreements") on 31 December 2021. Pursuant to the Film Investment Agreements, the Group agreed to invest in six proposed films within the contract period with a total budget of approximately HK\$20.4 million. The Group is entitled to share income generated from such six proposed film based on the proportion of investment amounts for each proposed film. Up to the expiry of Film Investment Agreements, the Group had invested approximately HK\$16.9 million in four proposed films. Three of the films were screened and the remaining film that the Group had invested of approximate HK\$4.7 million is in post-production stage and expect to be released in the second quarter of 2024.

In view of recovery of film industry after COVID, during the Year under Review, the Group started to develop the film distribution license rights business in Hong Kong/Macau and North America. To expand the entertainment segment, the Group also started to invest in film production or variety show and engaged in artiste management services. The Company will take a conservative stance in reviewing any future opportunities towards film investments but remains confident in the longer term future for film industry.

(b) 娛樂業務

電腦造像業務及電影相關業務/投資均於娛樂分部項下呈報。管理層預計電腦造像業務的前景不會立即改善。考慮到成本及效益,本公司將投入最少資源維持電腦造像業務,直至該業務分部的潛力及前景出現實質性改善為止。因此,本公司已暫停電腦造像業務製作方面的活動,但將僅繼續從事電腦造像業務的發行方面。

本集團在日期為二零一八年十一月三十 日並經日期為二零二零年十二月二十八 日之補充協議所補充之電影投資協議 (統稱「電影投資協議」)於二零二一年 十二月三十一日屆滿後在二零二二年暫 停其電影投資。根據電影投資協議,本 集團同意於合約期內投資六部擬定電影 (預算總額為約20,400,000港元)。本集 團有權根據各部擬定電影的投資金額比 例分享該六部擬定電影所產生的收入。 截至電影投資協議屆滿時,本集團已於 四部擬定電影投資約16.900.000港元。 三部電影已上映及餘下一部電影(本集 團已投資約4,700,000港元)正處在後期 製作階段,預計將於二零二四年第二季 度上映。

鑒於新冠病毒疫情後電影行業的復甦,於回顧年度內,本集團開始在香港/澳門及北美發展電影發行許可權業務。為擴大娛樂業務,本集團亦開始投資電影製作或綜藝節目,並從事藝人管理服務。本公司將採取審慎態度檢視任何未來的電影投資機會,但對電影行業的長遠未來充滿信心。

FINANCIAL REVIEW

Review of results

The net loss attributable to the Shareholders for the Year under Review was approximately HK\$13 million compared to a net loss attributable to the Shareholders of approximately HK\$11 million for the corresponding financial year in 2022. Such increase in loss as compared to last year was primarily attributable to, among other factors, (i) reduce in revenue for the Year under Review that interest income from loans receivable dropped from approximately HK\$16 million to approximately HK\$10 million and total revenue from securities brokerage and asset management segment dropped from approximately HK\$49 million to approximately HK\$42 million respectively; and (ii) increase in unrealised losses from changes in fair value of financial assets classified as held-for-trading from approximately HK\$13.1 million to approximately HK\$20.9 million for the Year under Review. The aforementioned factors was partially offset by absence of loss on disposal of associates (2022: approximately HK\$6.9 million).

LIQUIDITY AND FINANCIAL RESOURCES

During the Year under Review, the Group primarily financed its existing operations with internally generated cash flows. The liquidity and financial position of the Group as at 31 December 2023 remain healthy, with bank balances amounting to approximately HK\$31 million (2022: approximately HK\$76 million) and a current ratio (the total amount of current assets over the total amount of current liabilities) of approximately 13 times (2022: approximately 26 times).

As at 31 December 2023, the Group had no bank or other borrowings and therefore the gearing ratio (expressed as a percentage of total borrowings over total Shareholders' equity) was zero (2022: zero).

SIGNIFICANT INVESTMENTS

As at 31 December 2023, save as disclosed in note 21 to the consolidated financial statements, the Group did not hold any significant investments with a value of 5% or more of the Group's total assets as at 31 December 2023.

於二零二三年十二月三十一日,本集團並無銀行或其他借款,因此資產負債比率(以總借貸除以總股東權益之百分比表示)為零(二零二二年:零)。

重大投資

CAPITAL STRUCTURE

During the Year under Review, the Company has not conducted any equity fund raising activities.

As at 31 December 2023, the total number of issued shares of the Company (the "Share(s)") was 829,921,572 Shares with a par value of HK\$0.04 each. Based on the closing price of HK\$1.470 per Share as at 29 December 2023 (being the last trading day), the market value of the Company as at 31 December 2023 was approximately HK\$1,220 million (2022: approximately HK\$270 million).

The consolidated net asset value attributable to the Shareholders per Share as at 31 December 2023 was approximately HK\$0.84 (2022: approximately HK\$0.92).

EXPOSURE TO EXCHANGE RATES

Most of the Group's business transactions, assets and liabilities are denominated in Hong Kong dollars and United States dollar. The Group's exposure to currency risk is minimal as Hong Kong dollar is pegged to United States dollar. The Group does not have any currency hedging policy and has not entered into any hedging or other instrument to reduce currency risk. However, the Management will closely monitor the exposure of the Group to the fluctuation of exchange rates and take appropriate measures as necessary to minimise any adverse impact that may be caused by such fluctuation.

As at 31 December 2023, the Group employed 40 employees including 6 Directors (2022: 37 employees including 7 Directors). The emolument policy of the Group is to reward its employees with reference to their qualifications, experience and work performance as well as to market benchmarks. The Company will review regularly to ensure compliance of the latest labor laws and market norms where the Group has operations. In addition to basic salaries, incentives in the form of bonus, share options and share award may also be offered to eligible employees on the basis of individual performance and the Group's business results. The total staff cost paid to Directors and staff for the Year under Review amounted to approximately HK\$17 million (2022: approximately HK\$15 million).

Board Diversity Policy

The Board recognises and embraces the benefits of having a diverse Board and endeavors to ensure that the Board maintaining an appropriate range and balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business, and ensure that the Directors devote sufficient time and make contributions to the Company that are commensurate with their role and Board responsibilities. A policy concerning Board diversity (the "Board Diversity Policy") had been adopted on 26 August 2013 by the Board. The Nomination Committee is delegated be responsible for supervising the implementation of such policy and review the measureable objectives from time to time to ensure its appropriateness and effectiveness.

In determining the optimum composition of the Board and diversity of Board members, the Nomination Committee will consider a number of factors, among other things, gender, age, cultural and educational backgrounds, professional qualifications, skills, experience and knowledge on Company's business and such other factors as it deems appropriate given the then-current and anticipated future needs of the Board and the Company. Regarding the nomination of independent non-executive Director, the Nomination Committee will also particularly consider the independence of such candidates. The Nomination Committee is responsible for reviewing the structure, size and composition of the Board on annual basis and where appropriate, make recommendations on changes to the Board so as to ensure the Board maintains a balanced diverse profile.

All Board appointments will continue to be made on a merit basis with due regard for the benefits of diversity of the Board members. The Nomination Committee shall first discuss the nomination of candidates for new Directors, examine the qualification, experiences and proposed commitment to the Company of these candidates. Candidates will also be assessed in the context of the then-current composition of the Board, the operating requirements of the Group. The Nomination Committee then recommend such candidates to the Board and the Board shall determine whether such candidates be appointed and proposed for election at the general meeting in accordance with bye-laws of the Company (the "Bye-laws") and the Listing Rules. The ultimate decision will be made according to the merits of candidates and their contribution to the Board, having due regard to the benefits of diversity on the Board and also to the development of the Board without focusing on a single diversity aspect.

Appointment and re-election of Directors

Each of the non-executive Director has entered into a letter of appointment with the Company for a term of two years and can renew subsequently for a term of two years thereafter upon each expiry. All existing executive Directors have entered into a letter of appointment with the Company initially for a term of two years and can renew subsequently for a term of three years upon each expiry since their initial appointment. According to Code Provision B.2.2 of the CG Code, every director, including those appointed for specific terms, should be subject to retirement by rotation at least once every three years. Furthermore, in accordance with the bye-law 87(1) of the Bye-laws, at each annual general meeting, one-third of the Directors for the time being (or if their number is not a multiple of three (3), the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years.

According to the Bye-law 86(2), the Directors shall have the power from time to time and at any time to appoint any person as a Director to fill a casual vacancy on the Board or, subject to authorisation by the Shareholders in general meeting, as an addition to the existing Board but so that the number of Directors so appointed shall not exceed any maximum number determined from time to time by the Shareholders in general meeting. Any Director so appointed shall hold office until the next following annual general meeting of the Company and shall then be eligible for reappointment.

Such induction will also include meeting with senior management to conduct briefing on the Group's business and activities and the latest published financial reports of the Company and the documentations in relation to corporate governance practices adopted by the Board will also be provided.

The Board takes responsibility for all significant financial and operational matters of the Company. Directors are encouraged and have timely access to all relevant information as well as to consult with Company's senior management and company secretary (the "Company Secretary") independently, with a view to ensure the Board decisions and all applicable laws and regulations are followed. In discharge its responsibilities, the Board meets regularly and all Directors have carried out their duties in good faith with due diligence and care, in compliance with applicable laws and regulations, taking decisions objectively and acting in the interests of the Company and the Shareholders at all times. Directors, at reasonable request to the Board, could seek independent professional advice in performing their duties at the Company's expenses.

To ensure Directors' contributions to the Board remains informed and relevant, all the Directors are encouraged to participate in continuous professional development to develop and refresh their knowledge and skill. During the Year under Review, the Company (i) provided reading materials on latest updates to laws, rules and regulations, and business updates applicable to the Company from time to time; and (ii) recommended and encouraged Directors to attend relevant training course/workshop at the expenses of the Company. During the year ended 31 December 2023, the Company received training records from existing Directors attending various continuous professional development seminars in compliance with Code Provision C.1.4 of the CG Code.

Insurance of the Directors and officers

The Company has arranged appropriate liability insurance cover in respect of legal action against the Directors and officers in compliance with Code Provision C.1.8 of the CG Code.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Under Code Provision C.2.1 of the CG Code, the roles of chairman and chief executive should be separate and should not be performed by the same individual. Since appointment of general manager of the Company in January 2016 and all existing executive Directors in May 2016, the responsibilities of chief executive have been delegated to the executive Directors and general manager of the Company who are collectively responsible for day-to-day operations and business development generally. Mr. Kitchell Osman Bin, being the Chairman of the Board, provides leadership for the Board and ensures that the Board works effectively and discharges its responsibility. The respective responsibilities of chairman and chief executive officer have been established and set out in writing.

The main role and functions of the Audit Committee include (i) assisting the Board in fulfilling its audit duties through the review and supervision of the Company's financial reporting, risk management and internal control principles; and (ii) monitoring and maintaining an appropriate relationship with the Company's external auditors with reference to their term of engagement, fees and performance. The Audit Committee shall also have the responsibilities and discretion, among others, to make recommendations to the Board on the appointment, re-appointment and removal of external auditors, engagement of external professional for internal control review. There is no disagreement between the Board and the Audit Committee regarding the re-appointment of the external auditor.

The Board recognises its overall responsibility to establish and maintain sound and effective risk management and internal control systems. The Board also oversees the design, implementation, and evaluation of the internal control system to mitigate the risk identified and faced by the Company.

The risk management and internal control mechanism of the Company include the following elements:

- identify significant risks that may potentially impact the Company's performance;
- implement appropriate action plans and controls to manage identified risks; and
- monitor and review the effectiveness of such controls at least once a year.

The top-down approach is adopted in the Company, involving the Board, the Audit Committee, and key business units to manage the risk and execute the relevant control system. All the relevant parties assume and perform their responsibilities in the risk management and internal control system. The goal of risk management and internal control system is not meant to eliminate all risks but rather to identify, understand and manage them within acceptable limits in order to create long-term value in alignment with the Group's strategic objectives.

The Board and the Management constantly deliberate on the risk and opportunities matters which would include, amongst others, material risk relating to Environmental, Social and Governance ("ESG") and other prevailing and emerging risk in the strategic, commercial, operational, compliance and financial functions. Risk identification and assessment has been carried out to evaluate and determine the nature and extent of the risks that the Company shall take in achieving its strategic objectives.

The internal control system includes control procedures implemented to ensure risk are managed and mitigated within Board's risk appetite and tolerance limits. One of the key control measures implemented is strict access control to confidential information. A policy on the disclosure of inside information has been established to act as a guideline for the Directors, officers, senior management and relevant employees of the Company in handling confidential information, monitoring information disclosure and responding to enquiries. The Company's Code of Conduct further contains a strict prohibition on the unauthorised use of confidential or non-public information.

The Board, supported by the Audit Committee and the Management, has engaged a team of independent internal control advisors to conduct a review on the adequacy and effectiveness of the Company's risk management and internal control systems during the Year under Review. The review covered financial, operational and compliance controls, as well as the adequacy and effectiveness of resources deployed in the accounting, financial reporting, and internal audit functions. The risk assessment has been conducted based on risk parameters such as the likelihood and impact of the risks, critical points that may trigger the risk control measures, and the prioritisation of risk control, among others. The relevant information has been collected from the Management during the assessment period for the purpose of classifying and analysing the identified risk areas, reasonable estimates about the probability of these risks, as well as the losses they may generate.

During the Year under Review, remuneration in respect of audit and non-audit services provided by Crowe and its associate firm to the Group was HK\$1,579,000 and HK\$629,000 respectively. The non-audit services include interim review for the period ended 30 June 2023 and provision for tax advisory and filing services for the Year under Review.

The Audit Committee is mandated to monitor the independence of the external auditor to ensure the objectivity in the financial statements. The Audit Committee has been notified of the nature and the service charges of Crowe and its associate firm and considered that such services have no adverse effect on the independence of the external auditor.

All other general meetings must be called by notice not less than 14 days (excluding the day when the notice is given or deemed to be given and the day for which it is given or on which it is to take effect) but if permitted by the Listing Rules, a general meeting may be called by shorter notice if it is so agreed.

The Company intends to strike a balance between maintaining sufficient capital to develop and operate the business of the Group and rewarding the Shareholders. A dividend policy of the Company (the "Dividend Policy") had been adopted in deciding whether to propose a dividend and in determining the dividend amount, the Board shall take into account, among other things, the following factors:

- the Company's operating results;
- the liquidity position, the level of liquid ratio, return on equity and the relevant financial covenants;
- the expected financial performance;
- the cash flow forecast based on expected working capital requirements, expected capital expenditure requirements and any future expansion plans;
- any restrictions on payment of dividend with reference to any applicable laws, rules and regulations and the Bye-laws; and
- any other factors that the Board may deem appropriate and relevant.

Any declaration and payment of dividend under the Dividend Policy are subject to Board's determination that the same would be in best interest of the Company and the Shareholders as a whole.

The Dividend Policy shall in no way constitute a legally binding commitment by the Company that dividends will be paid in any particulars amount and/or in no way obligate the Company to declare a dividend at any time or from time to time. The Board will review the Dividend Policy from time to time and may exercise at its sole discretion to amend and/or modify the Dividend Policy at any time as appropriate.

Way to convene a special general meeting

According to Bye-law 58, Shareholder(s) holding at the date of deposit of the requisition not less than one-tenth of the paid-up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the Company Secretary, to require a special general meeting to be called by the Board; and such meeting shall be held within two (2) months after the deposit of such requisition. The requisition shall be in writing stating the purposes of the meeting, signed by the requisitionists, addressed to the Board or the Company Secretary and deposited at the principal place of business in Hong Kong of the Company.

In accordance with the law of Bermuda, if the Board do not within twenty-one days from the date of the deposit of the requisition proceed duly to convene a meeting, the requisitionists, or any of them representing more than one half of the total voting rights of all of them, may themselves convene a meeting, but any meeting so convened shall not be held after the expiration of three months from the said date.

Procedures for putting enquiries to the Board

Shareholders may at any time put their enquires to the Board in writing by sending to the principal place of business of the Company in Hong Kong or to the email address investor@imagi.hk for the attention of the Board or the Company Secretary.

Procedures for putting forward proposals at Shareholders' meeting

In accordance with the law of Bermuda, Shareholders representing (i) not less than one-twentieth of the total voting rights of all the Shareholders having at the date of the requisition a right to vote at the meeting; or (ii) not less than one hundred Shareholders shall have the right to put forward resolution to be dealt with at a meeting at their own expense.

The Group did not utilise the margin financing facilities as at 31 December 2023 and 2022.

During the Year under Review, the revenue excluding dividend income and net realised losses from sales of investments classified as held-for-trading (the "Adjusted Revenue") contributed by the Group's largest customer and the five largest customers were approximately 18% (2022: approximately 30%) and 56% (2022: approximately 53%) to the Group's total Adjusted Revenue, respectively. The aforesaid major customers of the Group were all from the Integrated Financial Services, of which approximately 90% (2022: 85%) under securities brokerage and asset management segment and 10% (2022: 15%) under provision for finance segment.

In view of the operation of the business, the Group did not have any major supplier that have significant influence on the operations.

The Group recognises that maintaining good and stable relationship with customers is key for the sustainable development of the Group. Therefore, the Group maintains good business relationships with its major customers in a long run.

Mr. Kitchell Osman Bin, being the executive Director, as at 31 December 2023 had approximately 24.5% beneficial interest in listed shares of one of the five largest customers of the Group. Notwithstanding beneficial interest of Mr. Kitchell, he does not have any role in such customer. Save as aforesaid, none of the Directors or any of their close associates (to the best knowledge of the Directors) had any beneficial interests more than 5% in the aforesaid five largest customers of the Group.

Also, referring to the corporate substantial shareholder notice filed by Advance Beauty Holdings Limited ("Advance Beauty") to the Company on 27 March 2017 pursuant to section 324 of the SFO, Advance Beauty claimed to own 44,175,200 Shares, representing 6.41% of the total issued shares of the Company as at 22 March 2017. However, based on the result of the investigation of ownership of interests in voting Shares as conducted by an independent professional firm commissioned by the Company by virtue of section 329 of the SFO as periodical review to reporting date of each interim period-end and financial year-end since 30 June 2018 to 31 December 2021, the aforesaid shareholding percentage figure of 6.41% held by Advance Beauty appeared to be no longer valid as all aforementioned investigation results showing the shareholding of Advance Beauty in the Company was below 5%. As such, the Company is of the view that the percentage figure of Advance Beauty's shareholding at each interim/year financial reporting end date since 30 June 2018 should be below 5%. The Company has engaged a legal advisor to handle and follow-up on this matter. Despite written request of the Company had been sent to Advance Beauty for rectification of the above incorrect information disclosed in the public domain, up to the date of this annual report, the Company has received no response from Advance Beauty.

Save as disclosed above, as at 31 December 2023, the Company has not been notified of any other interests or short positions in the Shares and/or underlying Shares that were required to be recorded in the register kept by the Company under section 336 of the SFO.

The share option scheme of the Company adopted on 11 June 2012 (the "2012 Scheme") expired on 11 June 2022 and there was no outstanding option granted under the 2012 Scheme. The specific objectives of the Share Award Scheme are (i) to recognise the contributions by certain eligible participants and to provide them with incentives in order to retain them for the continual operation and development of the Group; and (ii) to attract suitable personnel for further development of the Group. The Share Award Scheme would be valid and effective for ten years commencing from the Adoption Date to 21 October 2029. The maximum number of awarded shares that may be issued pursuant to the Share Award Scheme would be 10% of the issued share capital of the Company at the Adoption Date (the "Share Award Mandate Limit"), being 69,192,157 Shares.

The Board operate the Share Award Scheme, subject always to the Share Award Scheme Mandate Limit, by way of a specific mandate on annual basis at a limit equal to 3% of the Company's issued share capital as at the date on which the specific mandate is approved at the annual general meeting by the Shareholders as the maximum number of awarded shares which can be issued annually (the "Annual Limit"). Upon expiry of the Annual Limit of 24,897,647 Shares on 28 June 2023 (being equal to 3% of the Company's issued share capital at annual general meeting held on 21 June 2022 which was the maximum awards that may be granted under specific mandate at the beginning of the Year under Review and up to 27 June 2023), the Company did not refresh the Annual Limit. As such, there was no awards may be granted under the Share Award Scheme since 28 June 2023.

Such early termination shall not affect any subsisting rights of selected grantees as no share is granted or allotted under the Share Award Scheme since the Adoption Date. No awards remain unvested or which have vested but not yet been issued to a selected grantee immediately prior to termination.

With effect from 1 January 2023, Chapter 17 Share Schemes of the Listing Rules had been amended, inter alia, to govern both share option schemes and share award schemes of the listed issuer or their principal subsidiaries (the "Amended Rules"). Upon early termination of the Share Award Scheme on 21 December 2023, apart from the 2022 Scheme, the Company or any of its principal subsidiaries have no other scheme involving issue of new shares as at 31 December 2023 and at the date of this annual report.

As the 2022 Scheme was adopted before the effective of the Amended Rules, in addition to rules set out in the 2022 Scheme, the Board would also operate the 2022 Scheme in compliance with the Amended Rules which including but limited to (i) requirements on the eligible scheme participants; (ii) the terms of the grants; and (iii) disclosure requirements in respect of announcement of grant of shares or options under the 2022 Scheme and disclosures requirements in interim or annual reports. The Board will make such other decisions or determinations in relation to the offers and/or the administration of the 2022 Scheme provided that there is any inconsistent between the provisions of the 2022 Scheme and the Amended Rules and it shall deem appropriate for listing rules compliance purpose.

OPINION

We have audited the consolidated financial statements of Imagi International Holdings Limited (the "Company") and its subsidiaries (together the "Group") set out on pages 79 to 286, which comprise the consolidated statement of financial position as at 31 December 2023, and the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended and notes to the consolidated financial statements, including a summary of material accounting policy information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2023, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the HKICPA. Our responsibilities under those standards are further described in the *Auditor's responsibilities for the audit of the consolidated financial statements* section of our report. We are independent of the Group in accordance with the HKICPA's *Code of Ethics for Professional Accountants* (the "Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

意見

我們已審核載列於第79至286頁的意力國際控股有限公司(「貴公司」)及其附屬公司(統稱「貴集團」)的綜合財務報表,當中包括於二零二三年十二月三十一日的綜合財務狀況表、截至該日止年度的綜合損益及其他全面收入表、綜合權益變動表及綜合現金流量表,以及綜合財務報表附註(包括重大會計政策資料概要)。

我們認為,綜合財務報表已根據香港會計師公會(「香港會計師公會」)頒佈的《香港財務報告 準則》(「香港財務報告準則」)真實而公平地反映 貴集團於二零二三年十二月三十一日的綜合財務狀況及 貴集團截至該日止年度的綜合財務表現及綜合現金流量,並已遵照香港《公司條例》之適用披露要求妥為編製。

意見的基準

我們已按照香港會計師公會頒佈的香港核數準則(「香港核數準則」)進行審核工作。我們根據該等準則的責任進一步描述於本報告「核數師審核綜合財務報表的責任」一節。按照香港會計師公會的「專業會計師操守守則」(「守則」),我們獨立於 貴集團,且我們已按照守則履行其他道德責任。我們相信,我們獲取的審核證據屬充分和適當,為意見提供了基礎。

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Impairment of margin loans receivable

The Key Audit Matter

Given the size of balances and the risk that some of the margin loans receivable may not be recoverable, judgement is required to evaluate whether any allowance should be made to reflect the risk.

The expected credit losses ("ECL") measurement involves significant management judgement and estimation in (i) the selection of appropriate models and key inputs used in the ECL model and (ii) the selection and use of reasonable and supportable forward-looking information without undue cost or effort in the ECL model.

At each reporting date, the Group assesses whether there has been a significant increase in credit risk for exposures. The Group considers reasonable and supportable information that is relevant and available without undue cost or effort for this purpose. This includes quantitative and qualitative information and also, forward-looking analysis.

Due to the uncertainty inherent in such estimates, we considered this as a key audit matter.

How the matter was addressed in our audit

Our audit procedures to assess the recoverability of margin loans receivable included the followings:

- Understood the Group's established credit risk policies and procedures for impairment assessment in relation to the application of ECL model under HKFRS 9, including model set up and approval and selection and application of assumptions and key inputs into the model;
- Understood the key controls over ongoing monitoring processes, including the process of margin call procedures for margin shortfall and identification of impaired margin loans receivable;
- Assessed the reasonableness and appropriateness of the management's judgement on staging criteria for determining if the significant increase in credit risk has occurred (stage 1 or 2) or the financial asset is credit-impaired (stage 3) and the basis for classification of exposures into the 3 stages as required by HKFRS 9 and examined supporting information on a sample basis to assess the appropriateness of the classification of margin loans receivable exposures as at the end of the reporting period;

預期信貸虧損(「預期信貸虧損」)計量涉及以下方面的重大管理層判斷及估計: (i)選擇適當的模型及預期信貸虧損模型中使用的關鍵輸入數據及(ii)選擇及使用預期信貸虧損模型中無需過度成本或努力即可獲得的合理並有支持的前瞻性資料。

於各報告日, 貴集團評估信貸風險有否大幅增加。 貴 集團就此考慮無需過度成本或努力即可獲得的合理並有 支持的資料。這包括定量及定性資料以及前瞻性分析。

由於該等估計固有的不確定性,我們將其視為一項關鍵審核事項。

我們評估應收保證金貸款可收回性的審核程序包括 以下各項:

- 了解 貴集團有關根據香港財務報告準則第9 號應用預期信貸虧損模型的減值評估的現有信 貸風險政策及程序,包括制定模型與批准及選 擇並應用模型假設及關鍵輸入數據;
- 了解持續監控過程的關鍵控制,包括保證金缺額的保證金催繳程序及識別已減值應收保證金貸款;
- 評估管理層在釐定是否已發生信貸風險大幅增加(第1階段或第2階段)或財務資產已信貸減值(第3階段)的階段劃分標準時的判斷以及按香港財務報告準則第9號的要求將風險劃分為3個階段的基準的合理性及適當性,並抽樣檢查支持資料,以評估截至報告期末的應收保證金貸款風險劃分的適當性;

The Key Audit Matter

Given the size of balances and the risk that some of the loans receivable may not be recoverable, judgement is required to evaluate whether any allowance should be made to reflect the risk.

The measurement of ECL requires the application of significant judgement and increased complexity which include the identification of exposures with a significant deterioration in credit quality, and assumptions used in the ECL models, such as the expected future cash flows and forward-looking macroeconomic factors.

Due to the uncertainty inherent in such estimates, we considered this as a key audit matter.

How the matter was addressed in our audit

Our audit procedures to assess the recoverability of loans receivable included the followings:

- obtained an understanding of and assessed the design, implementation and operating effectiveness of management's internal controls relating to credit risk management, debt collection and the assessment of expected loss for the loans receivable;
- assessed whether terms in the loans receivable ageing report are classified within the appropriate ageing bracket;
- obtained an understanding of the basis of management's judgements about the recoverability of overdue balances and evaluated, on a sample basis, whether management had performed appropriate credit assessments of the related debtors;
- assessed the effectiveness of key controls over the application of the impairment methodology, the governance for the ECL models, inputs and assumptions used by the Group in calculating the ECL;

The Key Audit Matter

As at 31 December 2023, the carrying amount of the Group's financial assets measured at fair value that are classified as level 3 totalled approximately HK\$254 million, which are unlisted equity investments measured at fair value through other comprehensive income.

The valuation of these financial assets is based on a combination of valuation techniques and key unobservable inputs. Estimates of unobservable inputs that need to be developed can involve significant management and external valuation specialist's judgment.

We identified assessing the fair value of level 3 financial assets as a key audit matter because of the degree of complexity involved in valuing these financial assets, the significance of balances of the level 3 financial assets to the consolidated financial statements as a whole, and because of the significant degree of judgment exercised by management and external valuation specialist in determining the valuation techniques and inputs used.

How the matter was addressed in our audit

Our audit procedures in relation to assessing the fair value of level 3 financial assets included the followings:

- obtained confirmations from the unlisted investee companies and broker of the Group to confirm the Group's shareholding in unlisted equity investments and listed equity investment, respectively;
- obtained the financial information of unlisted investee companies and assessed the liquidity and major assets of the unlisted investee companies by checking to the underlying supporting documents;
- understood the process of preparation, monitoring, reviewing, approval and recording the fair value of these level 3 financial assets implemented by management;
- evaluated the competence, capabilities and objectivity of management's specialist;
- engaged our valuation specialists to review and challenging the appropriateness of valuation model, key assumptions, and key inputs adopted by the Group;

該等財務資產之估值乃結合估值技術及主要不可觀察輸 入資料得出。需要編製的不可觀察輸入資料估計可能涉 及重大管理層及外部估值專家的判斷。

由於對該等財務資產進行估值涉及之複雜性、第三級財務資產結餘對整體綜合財務報表之重要性,以及管理層及外部估值專家於釐定所使用之估值技術及輸入資料時作出之重大判斷,我們已將評估第三級財務資產之公平值確定為主要審核事項。

我們有關評估第三級財務資產公平值的審核程序包括以下各項:

This report is made solely to you, as a body, in accordance with Section 90 of the Bermuda Companies Act 1981, and for no other purpose. We do not assume responsibility towards or accept liability to any other person for the contents of this report.

Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with HKSAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these consolidated financial statements.

As part of an audit in accordance with HKSAs, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the consolidated financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Group's internal control.

我們的目標是就綜合財務報表整體是否不存在 重大失實陳述(不論因欺詐或錯誤導致)取得合 理保證,並出具包含我們意見的核數師報告。 我們根據百慕達一九八一年公司法第90條僅 向 閣下(作為整體)作出本報告,除此之外本 報告別無其他目的。我們概不就本報告的內容 向其他任何人負有或承擔任何責任。

合理保證是一種高水平的保證,但並不保證按 照香港核數準則進行的審核一直能發現所存在 的重大失實陳述。失實陳述可能因欺詐或錯誤 而產生,如個別或整體合理預期可能影響用戶 基於該等綜合財務報表作出的經濟決定,則屬 重大。

作為按照香港核數準則進行審核的一部分,我們在整個審核期間作出專業判斷並保持專業懷疑。我們亦:

- 識別及評估綜合財務報表中存在重大失實陳述(不論因欺詐或錯誤導致)的風險,設計及執行應對該等風險的審核程序,並取得充分適當的審核證據,為我們的意見提供基礎。未發現欺詐導致重大失實陳述的風險,原因是欺詐可能涉及勾結、偽造、故意遺漏、虛假陳述或超越內部控制。
- 取得與審核相關的內部控制的理解, 以設計適當的審核程序,但目的並非 對 貴集團內部控制的有效性發表意見。

1. GENERAL INFORMATION

Imagi International Holdings Limited (the "Company") is a public limited company incorporated in Bermuda as an exempted company with limited liability under the Companies Act 1981 of Bermuda and its shares are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The addresses of the registered office and principal place of business of the Company are disclosed in the "Corporate Information" to the annual report.

The Company (together with its subsidiaries, the "Group") acts as an investment holding company. The principal activities of its subsidiaries are disclosed in note 46.

The consolidated financial statements are presented in Hong Kong dollar ("HK\$"), which is also the functional currency of the Company.

The general model uses current assumptions to estimate the amount, timing and uncertainty of future cash flows and it explicitly measures the cost of that uncertainty, it takes into account market interest rates and the impact of policyholders' options and guarantees HKFRS 17 and related amendments are to be applied retrospectively unless impracticable, in which case the modified retrospective approach or the fair value approach is applied.

The Group does not have any contracts that meet the definition of an insurance contract under HKFRS 17.

Amendment to HKAS 1 and HKFRS Practice Statement 2 Disclosure of Accounting Policies

HKAS 1 is amended to replace all instances of the term "significant accounting policies" with "material accounting policy information". Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements.

The amendments also clarify that accounting policy information may be material because of the nature of the related transactions, other events or conditions, even if the amounts are immaterial. However, not all accounting policy information relating to material transactions, other events or conditions is itself material. If an entity chooses to disclose immaterial accounting policy information, such information must not obscure material accounting policy information.

HKFRS Practice Statement 2 Making Materiality Judgements (the "Practice Statement") is also amended to illustrate how an entity applies the "fourstep materiality process" to accounting policy disclosures and to judge whether information about an accounting policy is material to its financial statements. Guidance and examples are added to the Practice Statement.

Amendments to HKAS 8 Definition of Accounting Estimates

The amendments define accounting estimates as "monetary amounts in financial statements that are subject to measurement uncertainty". An accounting policy may require items in financial statements to be measured in a way that involves measurement uncertainty - that is, the accounting policy may require such items to be measured at monetary amounts that cannot be observed directly and must instead be estimated. In such a case, an entity develops an accounting estimate to achieve the objective set out by the accounting policy. Developing accounting estimates involves the use of judgements or assumptions based on the latest available, reliable information. In addition, the concept of changes in accounting estimates in HKAS 8 is retained with additional clarifications.

The application of the amendments in the current year has no impact on the Group's consolidated financial statements.

Amendments to HKAS 12 Deferred Tax related to Assets and Liabilities arising from a Single Transaction

The amendments narrow the scope of the recognition exemption of deferred tax liabilities and deferred tax assets in paragraphs 15 and 24 of HKAS 12 *Income Taxes* so that it no longer applies to transactions that, on initial recognition, give rise to equal taxable and deductible temporary differences.

Amendments to HKAS 12 International Tax Reform – Pillar Two Model Rules

The amendments apply to income taxes arising from tax law enacted or substantively enacted to implement the Pillar Two model rules published by the Organisation for Economic Cooperation and Development, including tax law that implements qualified domestic minimum top-up taxes described in those rules.

The Group has applied the amendments for the first time in the current year retrospectively. In accordance with the transitional provisions, the Group applies the mandatory temporary exception to recognising and disclosing information about deferred tax assets and liabilities related to Pillar Two income taxes. Following the amendments, the Group is required to disclose that it has applied the exception and to disclose separately its current tax expense (income) related to Pillar Two income taxes.

(b) Basis of preparation of the financial statements

The consolidated financial statements for the year ended 31 December 2023 comprise the Company and its subsidiaries (together referred to as the "Group").

Items included in the financial statements of each entity in the Group are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). These financial statements are presented in Hong Kong dollars ("HK\$"), rounded to the nearest thousand except for per share data. Hong Kong dollar is the Company's functional and the Group's presentation currency.

The measurement basis used in the preparation of the financial statements is the historical cost basis except for investment in equity instruments designated at fair value through other comprehensive income ("FVTOCI") and held-for-trading investments, which are stated at their fair value as explained in the accounting policies set out below (see note 3(n)).

The preparation of financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying amounts of assets and liabilities not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs and HKASs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in note 4.

(c) Subsidiaries and non-controlling interests

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered. The Group reassesses whether or not it controls an entity if facts and circumstances indicate that there are changes to one or more of the elements of control.

Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

Non-controlling interests represent the equity in a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. Changes in the Group's interests in subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's relevant components of equity and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries, including re-attribution of relevant reserves between the Group and the non-controlling interests according to the Group's and the non-controlling interests' proportionate interests. No adjustments are made to goodwill and no gains or losses are recognised. Any difference between the amount by which the non-controlling interests are adjusted, and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

A business is an integrated set of activities and assets which include an input and a substantive process that together significantly contribute to the ability to create outputs. The acquired processes are considered substantive if they are critical to the ability to continue producing outputs, including an organised workforce with the necessary skills, knowledge, or experience to perform the related processes or they significantly contribute to the ability to continue producing outputs and are considered unique or scarce or cannot be replaced without significant cost, effort, or delay in the ability to continue producing outputs.

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

For business combinations in which the acquisition date is on or after 1 January 2022, the identifiable assets acquired and liabilities assumed must meet the definitions of an asset and a liability in the Conceptual Framework for Financial Reporting 2018 issued in June 2018 (the "Conceptual Framework") except for transactions and events within the scope of HKAS 37 Provisions, Contingent Liabilities and Contingent Assets ("HKAS 37") or HK(IFRIC)-Int 21 Levies ("HK(IFRIC)-Int 21"), in which the Group applies HKAS 37 or HK(IFRIC)-Int 21 instead of the Conceptual Framework to identify the liabilities it has assumed in a business combination. Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

Further details of the Group's revenue and other income recognition policies are as follows:

Commission income is recognised at a point in time on the execution date of the trades at a certain percentage of the transaction value of the trades executed. The Group provides custodian and handling services for securities customer accounts. Clearing fee income is recognised when the transaction is executed and service is completed, except for custodian service fee which is recognised over time.

Revenue from provision of asset management services and financial service is recognised over time.

Royalty income from the licensing of trademarks and copyrights is generally recognised over time when royalties are reported by licensees about the related product sales.

Dividend income from unlisted investments is recognised when the shareholder's right to receive payment is established. Dividend income from listed investments is recognised when the share price of the investment goes ex-dividend.

Income from the sales of securities is recognised on a trade date basis.

Interest income is recognised as it accrues under the effective interest method using the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the gross carrying amount of the financial asset. For financial assets (other than purchased or originated credit-impaired financial assets) measured at amortised cost or FVTOCI (recycling) that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset (see note 3(n)).

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was measured. When a fair value gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is also recognised in profit or loss. When a fair value gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is also recognised in other comprehensive income. Non-monetary items that are measured in terms of historical cost in a foreign currency are not re-translated.

Exchange differences on monetary items are recognised in profit or loss in the period in which they arise, except those arising from foreign currency borrowings used to hedge a net investment in a foreign operation which are recognised in other comprehensive income and for exchange differences on monetary items receivable from or payable to a foreign operation for which settlement is neither planned nor likely to occur (therefore forming part of the net investment in the foreign operation), which are recognised initially in other comprehensive income and reclassified from equity to profit or loss on disposal or partial disposal of the Group's net investment in the foreign operation.

Functional currency of a group entity is changed only if there is a change to the underlying transactions, events and conditions that are relevant to the entity. Such effect is accounted for prospectively at the date of change, the entity translates all items into the new functional currency using the prevailing exchange rate at the date of the change. The resulting translated amounts for non-monetary items are treated as their historical cost. Exchange differences arising from the translation of a foreign operation previously recognised in comprehensive income are not reclassified from equity to profit or loss until the disposal of the operation.

For the purposes of presenting consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of each reporting period. Income and expense items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case the exchange rates at the dates of the transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve.

On the disposal of a foreign operation (that is, a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest in an associate that includes a foreign operation of which the retained interest becomes a financial asset), all the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

Goodwill is stated at cost less accumulated impairment losses. Goodwill arising on a business combination is allocated to each cashgenerating unit, or groups of cash generating units, that is expected to benefit from the synergies of the combination and is tested annually for impairment (see note 3(r)).

On disposal of a cash generating unit during the year, any attributable amount of purchased goodwill is included in the calculation of the profit or loss on disposal.

Intangible assets with finite useful lives that are acquired separately are carried at costs less accumulated amortisation and any accumulated impairment losses. Amortisation for intangible assets with finite useful lives is recognised on a straight-line basis over their estimated useful lives. The estimated useful lives and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis. Intangible assets with indefinite useful life that are acquired separately are carried at cost less any subsequent accumulated impairment losses. The assessment of indefinite life is reviewed annually to determine whether the indefinite life continues to be supportable. If not, the change in useful life from indefinite to finite is made on a prospective basis.

Intangible assets acquired in a business combination are recognised separately from goodwill and are initially recognised at their fair value at the acquisition date (which is regarded as their cost).

Subsequent to initial recognition, intangible assets acquired in a business combination with finite useful lives are reported at cost less accumulated amortisation and any accumulated impairment losses, on the same basis as intangible assets that are acquired separately.

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gain or loss arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, is recognised in profit or loss when the asset is derecognised

CGI animation pictures, which represent CGI animation pictures in which the Group retains ownership, consist of film rights of completed CGI animation pictures and CGI animation pictures of which the productions are still in progress.

CGI animation pictures in progress are stated at costs incurred to date, including all the costs directly attributable to the CGI animation pictures in progress and borrowing costs capitalised, less accumulated impairment losses. Upon completion and release of the CGI animation pictures, the costs are amortised based on the proportion of actual income earned during the year to the estimated total income expected to be generated from the relevant CGI animation pictures.

Completed CGI animation pictures are stated at cost incurred to date, representing all the costs directly attributable to the completed CGI animation pictures and borrowing costs capitalised, less accumulated amortisation and accumulated impairment losses.

Trading rights represent the eligibility rights to trade on or through the Stock Exchange and Hong Kong Futures Exchange Limited with indefinite useful lives. They are carried at cost less accumulated impairment losses. The trading rights have no foreseeable limit to the period over which the Group can use to generate net cash flows. As a result, the trading rights are considered by the management of the Group as having an indefinite useful life because they are expected to contribute to net cash flows indefinitely. The trading rights will not be amortised until their useful lives are determined to be finite. Instead they will be tested for impairment annually and whenever there is an indication that they may be impaired.

Other trading rights (where the estimated useful life is finite) that are acquired by the Group are stated at cost less accumulated amortisation and impairment losses (see note 3(r)). Amortisation of intangible assets with finite useful lives are amortised from the date they are available for use and is charged to profit or loss on a straight-line basis over the assets' estimated useful lives of 5 years.

Both the period and method of amortisation are reviewed annually, with the effect of any changes in estimate being accounted for on a prospective basis.

Investment in film rights are the Group's investments in film production project which entitles the Group to share certain percentage of income to be generated from the related films based on the proportion of investment amounts as specified in respective film rights investment agreements.

Investment in film rights are stated at cost, less any identified impairment loss. The costs of investment in film rights are recognised as expenses in cost of sales upon the entitlement of income in accordance with respective film rights investments agreements.

Film distribution license rights

Investment in film distribution license rights enables the Group to collaborate with distributors in Hong Kong and other countries to distribute films internationally. The Group will share the income generated from the related sources with respective film distribution agreements,.

Investment in film distribution license rights are stated at cost less any accumulated amortisation and impairment loss (see note 3(r)). Amortisation of film distribution license rights are amortised from the date they are available for use and is charged to profit or loss on a straight-line basis over the contractual licensing period.

Derecognition of intangible assets

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gain or loss arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, is recognised in profit or loss when the asset is derecognised.

Impairment losses recognised in an interim period in respect of goodwill are not reversed in a subsequent period. This is the case even if no loss, or a smaller loss, would have been recognised had the impairment been assessed only at the end of the financial year to which the interim period relates.

(x) Borrowing costs

Borrowing costs that are directly attributable to the acquisition, construction or production of an asset which necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of that asset. Other borrowing costs are expensed in the period in which they are incurred.

The capitalisation of borrowing costs as part of the cost of a qualifying asset commences when expenditure for the asset is being incurred, borrowing costs are being incurred and activities that are necessary to prepare the asset for its intended use or sale are in progress. Capitalisation of borrowing costs is suspended or ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are interrupted or complete.

5. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to stakeholders through the optimisation of the debt and equity balance. In addition, two subsidiaries of the Group licensed by the Securities and Futures Commission ("SFC") are obliged to meet the regulatory liquid capital requirements under the Securities and Futures (Financial Resources) Rules ("FRR") at all times.

The capital structure of the Group consists of equity attributable to owners of the Company, comprising issued share capital and various reserves.

The directors of the Company review the capital structure regularly. As part of this review, the directors of the Company consider the cost of capital and the risks associated with share capital. Based on recommendations of the directors of the Company, the Group will balance its overall capital structure through the payment of dividends, new share issues and share buy-backs as well as the issue of new debt. For the subsidiaries licensed by the SFC, the Group ensures these licensed subsidiaries maintain liquid capital level adequate to support the level of activities with sufficient buffer to accommodate for increases in liquidity requirements arising from potential increases in the level of business activities. During the years ended 31 December 2023 and 2022, these licensed subsidiaries complied with the liquid capital requirements under the FRR at all times.

During 2023, the Group's strategy on capital risk management was unchanged from 2022.

Other than the subsidiaries licensed by the SFC, the Company and other subsidiaries are not subject to any externally imposed capital requirements.

Listed investments held in the FVTOCI (non-recycling) portfolio have been chosen based on their long term growth potential and are monitored regularly for performance against expectation.

All the Group's unquoted investments are held for long term strategic purposes. Their performance is assessed at least bi-annually against performance of similar listed entities, based on the limited information available to the Group, together with an assessment of their relevance to the Group's long term strategic plans.

In order to manage the credit risk in the accounts receivable due from clients arising from securities brokerage and margin financing business, individual credit evaluation are performed on all clients including cash and margin clients. Accounts receivable from cash clients relate to a wide range of customers who generally settle the accounts receivable in two days after trade date, credit risk arising from the accounts receivable due from cash clients is therefore considered minimal. For margin clients, the Group normally obtains liquid securities as collateral based on the margin requirements. The margin requirement is closely monitored on a daily basis by the designated team. The Group considers there has been a significant increase in credit risk when clients cannot meet margin call requirement and uses the loan-to-collateral value ("LTV") to make its assessment. In certain cases, the Group may consider a margin client receivable to be in default when there is a margin shortfall which indicates that the Group is unlikely to receive the outstanding contractual amounts in full, taking into account the pledged securities held by the Group. A margin loans receivable is written off when there is no reasonable expectation of recovering the contractual cash flows.

The credit risk on deposit with bank (maturity over 3 months) and bank balances with gross carrying amount of HK\$3,600,000 (2022: HK\$3,600,000) and HK\$59,212,000 (2022: HK\$99,553,000), respectively, is limited because the counterparties are reputable banks with high credit ratings assigned by international credit-rating agencies, which the Group considers to represent low credit risk. The Group assess 12-month ECL for deposit with bank (maturity over 3 months) and bank balances by reference to information relating to probability of default and loss given default of the respective credit rating grades published by external credit rating agencies. Based on the average loss rates, the 12-month ECL on bank balances is considered to be insignificant and therefore no loss allowance was recognised.

There is no movement in the loss allowance amount in respect of other receivables and deposits, deposit with bank (maturity over 3 months) and bank balances during the year ended 31 December 2023 and 2022.

At 31 December 2023, the Group has certain concentration of credit risk on liquid funds which are deposited with several banks with high credit ratings.

The Group's operating segments are determined based on information reported to the chief operating decision maker of the Group (the directors of the Company) (the "CODM"), for the purpose of resource allocation and performance assessment.

The Group organises business units based on their services and the CODM regularly reviews revenue and results analysis of the Group by the reportable operating segments as below.

- securities brokerage and asset management segment engages in provision of securities brokerage services, margin financing services, asset management services and financial services;
- provision of finance segment engages in the provision of financing services (other than margin financing);
- trading of securities segment engages in the purchase and sale of securities investments;

- entertainment segment engages in CGI business and entertainment business (including film rights investment, film distribution license rights business and provision of artiste management services).

All assets are allocated to reportable segments with the exception of corporate assets (including bank balances and cash). All liabilities are allocated to reportable segments other than corporate liabilities.

38. ACQUISITION OF BUSINESS

On 27 May 2022, the Group completed acquisition of 51% of the issued share capital of Supreme China Securities Limited ("Supreme China"), a company principally engaged in securities brokerage, provision of margin financing, and provision of underwriting and placing services in Hong Kong, by cash consideration of HK\$21,594,000. The acquisition provides a good opportunity for the Group to expand its reach to different clientele and to trim the operating expenses, manifesting the synergy effects in terms of clientele and trading infrastructure with an aim to increasing efficiencies. The acquisition has been accounted for as acquisition of business using the acquisition method.

Since the acquisition, Supreme China contributed HK\$3,007,000 to the Group's revenue and loss of HK\$2,507,000 to the consolidated loss during the year ended 31 December 2022.

Had the combination taken place at the beginning of the period, the revenue of the Group and the loss after tax of the Group for the year ended 31 December 2022 would have been HK\$59,800,000 and HK\$22,384,000, respectively. The pro forma information is for illustrative purposes only and is not necessarily an indication of revenue and results of operations of the Group that actually would have been achieved had the acquisition been completed on 1 January 2022, nor is it intended to be a projection of future results.
