We, as the Manager of the Sub-Funds, are writing to inform you that with effect from the date of this document, certain amendments have been made to the Hong Kong Offering Document of the Sub-Funds to reflect (i) updates to prohibited securities related risk disclosure; (ii) updates of stamp duty related disclosure; (iii) removal of inter-counter transfer fee payable by investors; (iv) updates to index information; and (v) renaming of FRC to AFRC. Please refer to the “Amendments to the Hong Kong Offering Document of the Sub-Funds” enclosed for details.

For the avoidance of doubt: (i) the amendments outlined in this document do not amount to a material change to the Sub-Funds; (ii) there will be no material change or increase in the overall risk profile of the Sub-Funds as a result of the amendments outlined in this document; and (iii) the amendments outlined in this document do not have any material adverse impact on the rights or interests of the Unitholders of the Sub-Funds.

Amendments to the Hong Kong Offering Document of the Sub-Funds

The following amendments have been made to the Hong Kong Offering Document of the Sub-Funds with effect from the date of this document. These amendments form part of and should be read in conjunction with the Hong Kong Offering Document of the Sub-Funds.

A. All references to “FRC” and “the Financial Reporting Council” have been replaced with “AFRC” and “the Accounting and Financial Reporting Council” respectively.

B. WHAT ARE THE RISKS OF INVESTING IN A SUB-FUND?

1. The risk factor headed “*Prohibited securities risks*” under the sub-section headed “**Risks applicable to both Listed Class Units and Unlisted Class Units**” has been deleted in its entirety and replaced by the following:

“Prohibited securities risks

A Sub-Fund may not invest in securities of certain companies, for example, companies and/or securities deemed incompatible with the best interest of investors, such as those subject to sanctions, ESG or sustainability concerns or those with potential tax issues (“non-investment in incompatible companies and/or securities”). In addition, in accordance with HSBC Group policy (which applies as the Manager is a member of the HSBC Group) (“HSBC Group policy”, together with “non-investment in incompatible companies and/or securities”, defined as “policy”), a Sub-Fund may not invest in the securities of companies considered to be involved directly in the use, development, manufacturing, stockpiling, transfer or trade of controversial weapons banned by international convention. As this policy aims to prohibit investment in certain types of securities, investors should be aware that this reduces the investment universe and prevents a Sub-Fund from benefitting from any potential returns from these companies (in case there is originally no such restriction at the fund or index level). The HSBC Group policy does not apply to third party funds or derivative instruments any Sub-Fund may invest in.”

2. The first bullet point of the risk factor headed “*Differences in fee and cost arrangements between Listed Class and Unlisted Class Units*” under the sub-section headed “**Risks applicable to both Listed Class Units and Unlisted Class Units**” has been deleted in its entirety and replaced by the following:

“For Listed Class Units, the Transaction Fee may be payable by the Participating Dealer in respect of Creation and Redemption Applications. In relation to cash Creation and Redemption Applications by Participating Dealers, the Manager reserves the right to require the relevant Participating Dealer to pay an additional sum on the creation amount or deduct from the redemption proceeds such sum representing the Duties and Charges for the purpose of compensating or reimbursing the relevant Sub-Fund. Investors in the secondary market will not be subject to the foregoing, but may incur SEHK-related fees such as brokerage fees, transaction levy and trading fee.”

C. TAXATION

1. The last paragraph in the part headed “*Stamp Duty*” under the sub-section “*Hong Kong*” under the section headed “**Taxes and Duties Payable by the Trust and the Sub-Funds**”, has been deleted in its entirety and replaced by the following:

“The sale and purchase of the Index Constituent Stocks by a Sub-Fund will be subject to Hong Kong stamp duty under the Stamp Duty Ordinance (Cap. 117).”

2. The first paragraph in the part headed “*Stamp Duty in respect of Unlisted Class Units*” under the sub-section headed “*Hong Kong*” under the section headed “**Taxes and Duties Payable by Investors**”, has been deleted in its entirety and replaced by the following:

“No Hong Kong stamp duty should be payable where the sale or transfer of the Unlisted Class Units is effected by selling the relevant Units back to the Manager, who then either extinguish the Unlisted Class Units or re-sells the Unlisted Class Units to another person within two months thereof. Other types of sales or purchases or transfers of Unlisted Class Units by the Unitholders in a Sub-Fund should normally be liable to Hong Kong stamp duty under the Stamp Duty Ordinance (Cap. 117).”

1. The last row of the table entitled “**(B) Fees and expenses payable by investors**” under the sub-section headed “*Fees and expenses payable by Participating Dealers and investors*” under the section headed “**Current Fees and Charges**” has been deleted in its entirety.
2. The last point of the sub-section headed “*Notes*” under the section headed “**Current Fees and Charges**” has been deleted in its entirety.
3. The first paragraph under the part headed “**Other Information**” under the sub-section headed “**(B) Information about the Index**” has been deleted in its entirety and replaced by the following:

“As at 28 March 2024, the Index comprised 50 constituents listed on SEHK with total market capitalisation of HKD 6,871.0 billion.”

**Amendments to the Hong Kong Offering Document of the Sub-Funds
and Product Key Facts Statement of Hang Seng TECH Index ETF**

We, as the Manager of the Sub-Funds, are writing to inform you that with effect from the date of this document, certain amendments have been made to the Hong Kong Offering Document of the Sub-Funds and Product Key Facts Statement of the Hang Seng TECH Index ETF to reflect (i) reduction of the rate of Stamp Duty on Hong Kong Stock Transfers; and (ii) the changes to the underlying Index of the Hang Seng TECH Index ETF as mentioned in the Announcement dated 3 November 2023.

In relation to (i) above, according to the Stamp Duty (Amendment) (Stock Transfers) Bill 2023, the rate of Stamp Duty on Hong Kong Stock Transfers has been reduced from 0.13% to 0.1% with effect from 17 November 2023.

TAXATION

1. In the section headed “**Taxes and Duties Payable by the Trust and the Sub-Funds**”, the last paragraph in the part headed “*Stamp Duty*” under the sub-section “Hong Kong” has been deleted in its entirety and replaced by the following:

“The sale and purchase of the Index Constituent Stocks by a Sub-Fund will be subject to Hong Kong stamp duty at the current rate of 0.2% of the price of the Hong Kong stocks being sold and purchased. The relevant Sub-Fund will be liable to one half of such Hong Kong stamp duty.”

2. In the section headed “**Taxes and Duties Payable by Investors**”, the first paragraph in the part headed “*Stamp Duty in respect of Unlisted Class Units*” under the sub-section “Hong Kong” has been deleted in its entirety and replaced by the following:

“No Hong Kong stamp duty should be payable where the sale or transfer of the Unlisted Class Units is effected by selling the relevant Units back to the Manager, who then either extinguish the Unlisted Class Units or re-sells the Unlisted Class Units to another person within two months thereof. Other types of sales or purchases or transfers of Unlisted Class Units by the Unitholders in a Sub-Fund should normally be liable to Hong Kong stamp duty of 0.2 per cent (equally borne by the buyer and the seller) on the higher of the consideration amount or market value and where instrument of transfer (if any) is executed in relation to any such

sales or purchases or transfers, Hong Kong stamp duty is payable at the fixed rate of HK\$5 on each instrument of transfer (if any) executed.”

APPENDIX 2: Hang Seng Tech Index ETF

1. In the section headed “**(B) Information about the Index**”, the part headed “*Universe*” has been deleted in its entirety and replaced by the following:

“The universe of securities of the Index includes securities of companies listed on the Main Board of the SEHK, but excludes secondary-listed foreign companies and investment companies listed under Chapter 21 of the SEHK’s Main Board Listing Rules.”

2. In the section headed “**(B) Information about the Index**”, the part headed “*Index Calculation*” has been deleted in its entirety and replaced by the following:

“The Index adopts a freefloat-adjusted market capitalisation weighted methodology with a 8% cap on individual non-foreign companies constituent, 4% cap on individual foreign companies constituent and 10% cap on aggregate foreign companies constituents. The weighting of a constituent may exceed the cap level after the rebalancing date due to price movement.”

Amendments to the Hong Kong Offering Document and Key Facts Statement of the Sub-Fund

We, as the Manager of the Sub-Fund, have been informed by Hang Seng Indexes Company Limited (“HSIL”), the Index Provider of the underlying Index of the Sub-Fund, namely Hang Seng TECH Index (the “Index”), that HSIL will apply the changes described in Section A below (the “Index Change”) starting from the index review in November 2023, which will be effective in the December 2023 index rebalancing (i.e. on 4 December 2023 (“Effective Date”).

A. Index Change

According to the existing index methodology of the Index, the Index universe includes securities of Greater China companies that are listed on the Main Board of the HKEX and excludes foreign companies and investment companies listed under Chapter 21 of HKEX’s Listing Rules. The Index adopts a freefloat-adjusted market capitalisation weighted methodology with a 8% cap on each constituent. The weighting of a constituent may exceed 8% after the rebalancing date due to price movement.

Pursuant to the Consultation result on Eligibility of Foreign Companies announced on 7 July 2023 to the Index conducted by HSIL, primary-listed foreign companies will be eligible for the Index constituent selection. Individual constituent weighting of foreign companies constituents will be subject to a 4% cap and aggregate weighting of foreign companies constituents will be capped at 10%.

B. Impact to the Sub-Fund

Investors should note that (i) the investment objective and policies of the Sub-Fund will remain unchanged; (ii) the Index Change will not amount to a material change to the Sub-Fund and the overall risk profile of the Sub-Fund; (iii) the Index Change will not affect the acceptability of the Index under the SFC's Code on Unit Trusts and Mutual Funds; (iv) the Sub-Fund's normal operation will not be disrupted and the Index Change will not affect the way that the Sub-Fund is managed; and (v) the change to the Sub-Fund resulting from the Index Change will not materially prejudice the rights and interests of Unitholders.

The costs incurred by the Sub-Fund resulting from the Index Change will be borne by the Sub-Fund but such costs are expected to be immaterial.

Pursuant to section 19(1DA) and Part 2 of Schedule 10 of the Stamp Duty Ordinance (Chapter 117 of the Laws of Hong Kong) and according to the Stamping Circular No.02/2019, each Sub-Fund is an “authorized open-ended collective investment scheme” as defined under the Stamp Duty Ordinance, and, provided that the value of the Hong Kong stock is proportionate to the value of the Unit, any Hong Kong stamp duty (i.e. fixed and ad valorem) on the delivery of Hong Kong stocks as consideration for the allotment of Units will be exempted. Similarly, provided that the value of the Hong Kong stock is proportionate to the value of the Unit, Hong Kong stamp duty on the delivery of Hong Kong stocks as consideration for redemption of Units will also be exempted. The allotment or redemption is considered to be proportionate if the value of the Hong Kong stock sold or purchased is equivalent to the asset value of the Sub-Fund which the allotted or redeemed Unit represents as at the date of allotment or redemption (as the case may be).

No Hong Kong stamp duty is payable by each Sub-Fund on an issue or redemption of Units in cash.

The sale and purchase of the Index Constituent Stocks by a Sub-Fund will be subject to Hong Kong stamp duty at the current rate of 0.26% of the price of the Hong Kong stocks being sold and purchased. The relevant Sub-Fund will be liable to one half of such Hong Kong stamp duty.”

Similarly, provided that the value of the Hong Kong stock is proportionate to the value of the Unit, Hong Kong stamp duty on the delivery of Hong Kong stocks as consideration for redemption of Units will also be exempted. The allotment or redemption is considered to be proportionate if the value of the Hong Kong stock sold or purchased is equivalent to the asset value of the Sub-Fund which the allotted or redeemed Unit represents as at the date of allotment or redemption (as the case may be).

APPENDIX 2: Hang Seng TECH Index ETF

- (a) In the sub-section headed “*What is the HSTECH ETF?*” under the section headed “**(A) Key Information in respect of the HSTECH ETF**”, the second paragraph has been deleted in its entirety and replaced by the following:

“The Index tracks the performance of the 30 largest technology companies listed in Hong Kong which have high business exposure to the selected technology themes, including internet (including mobile), fintech, cloud, e-commerce, digital and autonomous.”

- (b) In the section headed “**Is an investment in the HSTECH ETF suitable for me?**”, the second paragraph has been deleted in its entirety and replaced by the following:

“By way of background, the HSTECH ETF has been established for investors seeking a relatively inexpensive and passive means of investing in a portfolio of technology companies listed in Hong Kong. In tracking the Index, the HSTECH ETF is investing in companies which have high business exposure to the selected technology themes, including internet (including mobile), fintech, cloud, e-commerce, digital and autonomous.”

- (c) In the sub-section headed “*Risks associated with investing in companies with technology themes*” under the section headed “**What are the Risks of Investing in the HSTECH ETF?**”, the first paragraph has been deleted in its entirety and replaced by the following:

Overview

The Index is a freefloat-adjusted market capitalisation weighted index, and is designed to represent the 30 largest technology companies listed in Hong Kong which have high business exposure to the selected technology themes, including internet (including mobile), fintech, cloud, e-commerce, digital and autonomous.

The Index is denominated in HKD. It was launched on 27 July 2020 with a base value of 3,000 as of 31 December 2014. It is calculated and disseminated real-time at 2-second intervals during trading hours of the SEHK.

The Fund aims to match as closely as practicable, before fees and expenses, the performance of the total return (net of withholding tax) version of the Index, which is calculated on the basis that dividends are reinvested after the deduction of withholding taxes.

Both the Manager and the Index provider are presently subsidiaries of Hang Seng Bank Limited. The functions which the Index provider and the Manager will perform in connection with the Fund may give rise to potential conflicts of interest but the Manager will manage any such conflicts in the best interest of investors.

Universe

The universe of securities of the Index includes securities of Greater China companies listed on the Main Board of the SEHK, but excludes foreign companies and investment companies listed under Chapter 21 of the SEHK’s Main Board Listing Rules.

Eligibility Criteria

A security is eligible for Index constituent selection if it fulfils the following eligibility criteria:

- I) Turnover Requirements

Velocity Test for Tradable Indexes: A security is regarded as passing the monthly turnover test if it attains a minimum velocity of 0.1% in that month (details of velocity test as described in the Index Methodology General Guide published by HSIL)

- II) Sector Requirements

An eligible security must be classified in one of the following industries in the Hang Seng Industry Classification System:

III) Theme Requirements

An eligible security must have high business exposure to at least one of the below technology themes:

- internet (including mobile);
- fintech;
- cloud;

IV) Innovation Screening

An eligible security must meet at least one of the below criteria:

- 1) a technology-enabled business (e.g. via internet or mobile platform);
- 2) the research and development expense to revenue ratio is equal to 5% or more; or
- 3) the year-on-year revenue growth is equal to 10% or more.

The eligibility criteria of the Index including the sector requirements, the theme requirements and the innovation screening are reviewed at least annually.

Constituent Selection

Selection Criteria

The top 30 eligible securities with the highest MV Rank will be selected as constituents of the Index. For details of MV Rank, please refer to the Index Methodology General Guide published by HSIL.

Fast Entry

A newly listed security will be added to the Index if its full market capitalisation ranks within the top 10 of the existing constituents on its first trading day. The ad-hoc addition will normally be implemented after the close of the 10th trading day of the new issue.

Number of Constituents

Fixed at 30

Review Frequency

The review of the Index is conducted quarterly.

Index Calculation

The Index adopts a freefloat-adjusted market capitalisation weighted methodology with a 8% cap on each constituent. The weighting of a constituent may exceed 8% after the rebalancing date due to price movement.

Change to the underlying index of the Sub-Fund

We, as the Manager of the Sub-Fund, have been informed by Hang Seng Indexes Company Limited (“HSIL”), the index provider of the underlying index of the Sub-Fund, namely Hang Seng TECH Index (the “Index”), that HSIL will implement the change described in Section A below (the “Index Change”) starting from the November 2021 index review, which will be effective in the December 2021 index rebalancing (i.e. on 6 December 2021 (“Effective Date”)).

A. Index Change

According to the existing index methodology of the Index, securities that are classified as Industrials, Consumer Discretionary, Healthcare, Financials or Information Technology in the Hang Seng Industry Classification System¹, and that have high business exposure to at least one of the five selected technology themes (i.e. internet (including mobile), fintech, cloud, e-commerce, or digital) are eligible for inclusion in the Index. Besides, the eligibility criteria of the Index including the Sector Requirements², the Theme Requirements² and the Innovation Screening² are reviewed at least annually.

¹ Capitalized terms of Industrials, Consumer Discretionary, Healthcare, Financials or Information Technology are defined in the Hang Seng Industry Classification System published by HSIL.

² Capitalized terms of Sector Requirements, Theme Requirements and Innovation Screening are defined in the index methodology published by HSIL.

With reference to the annual methodology review by HSIL, “Autonomous” will be added as a sixth eligible technology theme to the Theme Requirement of the eligible criteria for constituent selection.

B. Impact to the Sub-Fund

We, as the Manager of the Sub-Funds, are writing to inform you that, according to the Revenue (Stamp Duty) Ordinance 2021, with effect from 1 August 2021 (the “Effective Date”), the rate of stamp duty payable on contract notes for sale or purchase of Hong Kong stock (the “Stamp Duty”) will be changed from 0.1% to 0.13%. Certain updates would be made to the Hong Kong Offering Document of the Sub-Funds with effect from the Effective Date to reflect (i) the new rate of Stamp Duty and (ii) other administrative, clarificatory and editorial amendments.

Amendments to the Hong Kong Offering Document of the Sub-Funds

The following amendments would be made to the Hong Kong Offering Document of the Sub-Funds with effect from 1 August 2021. These amendments form part of and should be read in conjunction with the Hong Kong Offering Document of the Sub-Funds.

1. Taxes and Duties Payable by the Trust and the Sub-Funds

The part headed “*Stamp Duty*” under the sub-section headed “Hong Kong” is deleted in its entirety and replaced by the following:

“Stamp Duty

Pursuant to a remission order issued by the Secretary for the Treasury of Hong Kong on 20 October 1999, any Hong Kong stamp duty (i.e. fixed and ad valorem) on the transfer of a Basket to a Sub-Fund by an investor as consideration for an allotment of Units will be remitted or refunded. Similarly, Hong Kong stamp duty on the transfer of a Basket by a Sub-Fund to an investor upon redemption of Units will also be remitted or refunded.

No Hong Kong stamp duty is payable by each Sub-Fund on an issue or redemption of Units in cash.

The sale and purchase of the Index Constituent Stocks by a Sub-Fund will be subject to Hong Kong stamp duty at the current rate of 0.26% of the price of the Hong Kong stocks being sold and purchased. The relevant Sub-Fund will be liable to one half of such Hong Kong stamp duty.”

2. Taxes and Duties Payable by Investors

- a. The part headed "*Stamp Duty in respect of Unlisted Class Units*" under the sub-section headed "*Hong Kong*" is deleted in its entirety and replaced by the following:

"Stamp Duty in respect of Unlisted Class Units

No Hong Kong stamp duty should be payable where the sale or transfer of the Unlisted Class Units is effected by selling the relevant Units back to the Manager, who then either extinguish the Unlisted Class Units or re-sells the Unlisted Class Units to another person within two months thereof. Other types of sales or purchases or transfers of Unlisted Class Units by the Unitholders in a Sub-Fund should normally be liable to Hong Kong stamp duty of 0.26 per cent (equally borne by the buyer and the seller) on the higher of the consideration amount or market value and where instrument of transfer (if any) is executed in relation to any such sales or purchases or transfers, Hong Kong stamp duty is payable at the fixed rate of HK\$5 on each instrument of transfer (if any) executed.

Subscription of Unlisted Class Units/switching into Unlisted Class Units effected through allotment of new Unlisted Class Units and redemption/switching out effected through cancellation of Unlisted Class Units respectively will normally not be subject to Hong Kong stamp duty."

- b. The corresponding footnotes under the sub-section headed "*Automatic Exchange of Financial Account Information*" are deleted in their entirety and replaced by the following:

Permission for the offering of any Units in Hong Kong and the distribution of this offering document (including the Product Key Facts Statement for each Sub-Fund) in Hong Kong has been obtained. Units may also be listed on other stock exchanges in the future. For the authorisation/listing status of a Sub-Fund in the relevant jurisdiction(s), investors may contact the authorised agent(s) in the relevant jurisdiction(s) or the Manager.

The HKD traded Units and the RMB traded Units of the HSCEI ETF and the HKD traded Units of the HSTECH ETF are listed on the SEHK and have been accepted as eligible securities by HKSCC for deposit, clearing and settlement in the Central Clearing and Settlement System ("**CCASS**"). Settlement of transactions between participants of the SEHK is required to take place in CCASS on the second CCASS Settlement Day after any trading. All activities under CCASS are subject to the General Rules of CCASS and CCASS Operational Procedures in effect from time to time.

The distribution of this offering document and the offering of the Units may be restricted in certain jurisdictions.  - a. that was created or organised under U.S. federal or state law including any non-U.S. agency or branch of such entity; or
 - b. where regardless of place of formation or organisation, was organised principally for passive investment (such as an investment company or fund or similar entity other than an employee benefit plan or employee pension scheme for the employees, officers, or principals of a non-U.S. entity having its principal place of business outside the United States);
 - and owned directly or indirectly by one or more US Persons, with respect to which such US Persons (unless defined as a Qualified Eligible Person under CFTC Regulation 4.7(a)) directly or indirectly hold in the aggregate 10% or greater beneficial interest; or
 - where a US Person is the general partner, managing member, managing director or other position with authority for directing the entity's activities; or
 - was formed by or for a US Person principally for the purpose of investing in securities not registered with the Securities and Exchange Commission ("**SEC**"); or
 - where more than 50% of its voting ownership interests or non-voting ownership interests are directly or indirectly owned by US Persons; or
 - c. that is any agency or branch of a non-U.S. entity located in the U.S.; or
 - d. has its principal place of business in the U.S.; or
 - ii. that is a trust created or organised under U.S. federal or state law or regardless of the place of creation or organisation:
 - a. where one or more US Persons has the authority to control all substantial decisions of the trust; or
 - b. where the administration of the trust or its formation documents are subject to the supervision of one or more U.S. courts; or
 - c. where any settlor, founder, trustee, or other person responsible for decisions related to the trust is a US Person; or

- iii. that is an estate of a deceased person regardless of where the person resided while alive where an executor or administrator is a US Person.
3. An employee benefit plan established and administered in accordance with the laws of the U.S.
4. A discretionary or non-discretionary investment account or similar account (other than an estate or trust) held by a non-U.S. or U.S. dealer or other fiduciary for the benefit or account of a US Person (as defined above).

Units may not, except pursuant to a relevant exemption, be acquired or owned by, or acquired with the assets of an ERISA Plan. An "ERISA Plan" is any retirement plan subject to Title 1 of the United States Employee Retirement Income Securities Act of 1974, as amended; or any individual retirement account or plan subject to section 4975 of the United States Internal Revenue Code of 1986, as amended.

For the purpose of this definition, the "**United States**" and "**U.S.**" means the United States of America (including the States and the District of Columbia), its territories, possessions and other areas of subject to its jurisdiction.

If, subsequent to a Unitholder's investment in a Sub-Fund, the Unitholder becomes a US Person, such Unitholder (i) will be restricted from making any additional investments in the relevant Sub-Fund and (ii) as soon as practicable have its Units compulsorily redeemed by the relevant Sub-Fund (subject to the requirements of applicable law).

The Manager may, from time to time, waive or modify the above restrictions subject to the provisions of the Trust Deed.

- (B) Units will not be offered for sale in Canada. In addition, no offer or invitation to subscribe for Units may be made to, and no Units may be held by or transferred to Canadian residents or for the benefit of any Canadian resident. A distribution or solicitation may be deemed to occur in Canada where a distribution or solicitation is made to a person (including an individual, corporation, trust, partnership or other entity, or other legal person) resident or otherwise located in Canada at the applicable time. For these purposes, the following persons will generally be considered to be a Canadian resident:

1. An individual, if
 - i. the individual's primary principal residence is located in Canada; or
 - ii. the individual is physically located in Canada at the time of the offer, sale or other relevant activity.
2. A corporation, if
 - i. the corporation's head office or principal office is located in Canada; or
 - ii. securities of the corporation that entitle the holder to elect a majority of the directors are held by Canadian Resident individuals (as described above) or by legal persons resident or otherwise located in Canada; or
 - iii. the individuals that make investment decisions or provide instructions on behalf of the corporation are Canadian Resident individuals (as described above).
3. A trust, if
 - i. the principal office of the trust (if any) is located in Canada; or
 - ii. the trustee (or in the case of multiple trustees, the majority of trustees) are Canadian Resident individuals (as described above) or are legal persons resident or otherwise located in Canada; or
 - iii. the individuals that make investment decisions or provide instructions on behalf of the trust are Canadian Resident individuals (as described above).
4. A partnership, if
 - i. the partnership's head office or principal office (if any) is located in Canada; or
 - ii. the holders of the majority of the interests of or in the partnership are held by Canadian Residents (as described above); or
 - iii. the general partner (if any) is a Canadian Resident (as described above); or
 - iv. the individuals that make investment decisions or provide instructions on behalf of the partnership are Canadian Resident individuals (as described above).

In addition and without prejudice to the above, the Manager has the power to impose such restrictions as the Manager may think necessary for the purpose of ensuring that no Units are acquired or held by:

- (a) any person in breach of the law or requirements of any country or governmental authority or the SEHK in circumstances which, in the opinion of the Manager, might result in the Trust or the Sub-Funds suffering an adverse effect which the Trust or the Sub-Funds might not otherwise have suffered; or
- (b) any person or persons in circumstances (whether directly or indirectly affecting such person or persons and whether taken alone or in conjunction with any other persons, connected or not, or any other circumstances appearing to the Manager to be relevant) which, in the opinion of the Manager, might result in the Trust or the Sub-Funds incurring any liability to taxation or suffering any other pecuniary disadvantage which the Trust or the Sub-Funds might not otherwise have suffered.

If the Manager becomes aware that any Units are owned directly or beneficially by any person in contravention of any restrictions applied by the Manager, the Manager may require such person to transfer or redeem such Units.

PART 1 – GENERAL INFORMATION RELATING TO THE TRUST AND THE SUB-FUNDS

Part 1 of this offering document includes information relevant to the Trust and all Sub-Funds established under the Trust.

The information presented in this Part 1 should be read in conjunction with the information presented in the relevant Appendix in Part 2 of this offering document in respect of a particular Sub-Fund. Where the information in Part 2 of this offering document conflicts with the information presented in this Part 1, the information in the relevant Appendix in Part 2 prevails, however, it is applicable to the specific Sub-Fund of the relevant Appendix only. Please refer to “PART 2 – SPECIFIC INFORMATION RELATING TO EACH SUB-FUND” for further information.

In this offering document (including the relevant Appendix for any Sub-Fund), unless the context requires otherwise, capitalised terms shall have the meanings set out in the Glossary. Other capitalised terms used, but not defined in the glossary shall have the meaning given to those terms in the Trust Deed.

INTRODUCTION

The Trust

The Trust is an umbrella unit trust created by the Trust Deed between the Manager and the Trustee made under Hong Kong law to facilitate the establishment of various index-tracking funds including exchange traded funds. The Trust and each Sub-Fund is authorised as a collective investment scheme by the SFC under Section 104 of the SFO and each Sub-Fund falls within Chapter 8.6 of the Code. SFC authorisation is not a recommendation or endorsement of a Sub-Fund nor does it guarantee the commercial merits of a Sub-Fund or its performance. It does not mean that a Sub-Fund is suitable for all investors nor is it an endorsement of its suitability for any particular investor or class of investors.

The Sub-Funds

The Trust may issue different classes of Units and the Trustee shall establish a separate pool of assets under the Trust Deed as separate trusts (each such separate pool of assets a “**Sub-Fund**”) to which one or more class of Units shall be attributable. The assets of a Sub-Fund will be invested and administered separately from the other assets of the Trust. Each Sub-Fund will be an exchange traded fund listed on the SEHK (with Listed Class Units only or with both Listed Class Units and Unlisted Class Units).

The Manager and the Trustee reserve the right to establish other Sub-Funds and/or issue further classes of Units relating to a Sub-Fund or Sub-Funds in the future in accordance with the provisions of the Trust Deed. Where indicated in the relevant Appendix, the Listed Class Units in a Sub-Fund may be available for trading on the SEHK using a Dual Counter. Each Sub-Fund will have its own Appendix.

Each Sub-Fund may issue Listed Class Units and/or Unlisted Class Units. In respect of a Sub-Fund which offers both Listed Class Units and Unlisted Class Units, please refer to the table set out in the relevant Appendix which sets out the key similarities and differences between the Listed Class Units and Unlisted Class Units. Currently, the HSCEI ETF offers Listed Class Units only and the HSTECH ETF offers both Listed Class Units and Unlisted Class Units.

INVESTMENT OBJECTIVE AND STRATEGY

Investment Objective

The investment objective of each Sub-Fund is to provide investment results that, before fees and expenses, closely correspond to the performance of the relevant Index unless otherwise stated in the relevant Appendix.

Investment Strategy

Index-tracking funds are not managed according to traditional methods of active investment management, which involve the buying and selling of securities based on the fund manager's economic, financial and market analysis and investment judgement.

Unlike an actively managed investment fund, an index-tracking fund does not attempt to outperform any particular stock market or sector thereof nor any underlying benchmark or stock index.

Instead, using a passive approach or indexing investment strategy, the fund manager attempts to match, as closely as practicable, the performance of the underlying index relevant to the index-tracking fund.

What are indexing investment strategies?

Indexing investment strategies are used by fund managers to fulfil an index-tracking fund's investment objective. Replication and representative sampling are the two most common strategies.

Replication Strategy

Using a replication strategy, an index-tracking fund invests in substantially all the Index Securities in substantially the same weightings (i.e. proportions) as these stocks have in the underlying index. When a stock ceases to be an Index Security rebalancing occurs which involves selling the outgoing Index Security and using the proceeds to acquire the incoming Index Security. The downside of using a replication strategy is that transaction costs may be higher than when a representative sampling strategy is being used.

Representative Sampling Strategy

Using a representative sampling strategy, an index-tracking fund invests in a representative sample of Index Securities selected by the fund manager using quantitative analytical models in a technique known as portfolio sampling. Under this technique, each stock is considered for inclusion in the fund based on its contribution to certain capitalisation, industry and fundamental investment characteristics. The fund manager seeks to construct the portfolio of the fund so that, in the aggregate, its capitalisation, industry and fundamental investment characteristics perform like those of its underlying index. The risk of using a representative sampling strategy is that it may not track the underlying index as closely as a replication strategy would allow, but a representative sampling strategy does provide for a close correlation to the underlying index in a cost-efficient manner.

WHAT ARE THE RISKS OF INVESTING IN A SUB-FUND?

Investors should note that the risk factors mentioned below are general risks associated with investments in a Sub-Fund and investors should consider the information included in this offering document before investing in a Sub-Fund. Whilst to the best of knowledge of the Manager, this offering document includes the information necessary for investors to be able to make an informed judgment of their investments and in particular the risks attached thereto, investors should however not solely rely upon such information for any investment in a Sub-Fund. Investors should note that there may be various other risks or considerations arising from the then prevailing political, economic, social and other conditions which may also need to be taken into account before making any decision to invest in a Sub-Fund.

Investors should carefully consider the risks involved in investing in a Sub-Fund together with all other information included in this offering document (including the additional risk factors specific to each Sub-Fund as set out in the relevant Appendix) and satisfy themselves that such Sub-Fund is suitable for them having regard to their own circumstances, including their financial situation, investment experience and investment objectives before making an investment decision. Investors should note that the decision whether or not to invest remains with them. If investors have any doubt as to whether or not a Sub-Fund is suitable for them, they should consult their investment adviser and obtain independent professional advice.

The Net Asset Value per Unit may fall or rise. There can be no assurance that an investor will achieve any return on an investment in the Units or a return on the capital invested. Investors should not invest in a Sub-Fund unless they fully understand and are willing to take the various risks associated with the underlying investments of such Sub-Fund (which may expose the Sub-Fund to significant losses in terms of income as well as principal), and have the financial resources necessary to bear the substantial, or even total, loss of the capital invested.

In addition, investors should avoid excessive investment in any single type of investment (in terms of its proportion in the overall investment portfolio) including any proposed investment in a Sub-Fund so as to avoid having the investment portfolio being over-exposed to any particular investment risk.

Many factors will affect the performance of a Sub-Fund.

A Sub-Fund's Net Asset Value will change based on changes in market conditions in response to other economic, political, monetary and financial developments. A Sub-Fund's reaction to these developments will be affected by the types of securities in which the Sub-Fund invests, the financial condition, industry and economic sector, and geographic location of an issuer, and the Sub-Fund's level of investment in the securities of that issuer.

To the extent that the Index concentrates in the securities of a particular industry or group of industries, the Manager may similarly concentrate a Sub-Fund's investments. Such Sub-Fund's performance could depend heavily on the performance of that industry or group of industries and could be more volatile than the performance of less concentrated funds.

In addition, because the Manager may invest a significant percentage of a Sub-Fund's assets in a single issuer, such Sub-Fund's performance could be closely tied to that one issuer and could be more volatile than the performance of more diversified funds.

Index-tracking funds like the Sub-Funds are not actively managed. The Manager does not have the discretion to select stocks individually or to take defensive positions in declining markets. Hence, any fall in the Index will result in a corresponding fall in the value of the relevant Sub-Fund.

When you redeem or sell your Units they may be worth more or less than what you paid for them, which means that you could lose money.

The following additional factors should be borne in mind when deciding to invest in Units.

Risks applicable to both Listed Class Units and Unlisted Class Units

Correlation to the Index and tracking error risk

No assurance can be given that the performance of a Sub-Fund at any time will be an exact or identical replication

of the performance of the Index, primarily because (i) there are various fees and expenses payable out of the relevant Sub-Fund's assets, (ii) the assets of a Sub-Fund may not be fully invested at all times, for example, minimal cash balances may arise from cash creation applications and cash redemption applications, (iii) the investment strategy used by the Manager may not result in the relevant Sub-Fund holding all of the Index Constituent Stocks in exactly the same weightings as those stocks have in the Index, (iv) of any adjustment made to the Net Asset Value per Unit which is considered to be an appropriate allowance to reflect the Duties and Charges which would be incurred if the investments of a Sub-Fund were to be acquired or sold in certain circumstances as referred to in the section headed "Calculation of Issue Price and Redemption Price", (v) of timing differences associated with additions to and deletions from the Index when rebalancing occurs, and (vi) the number of shares outstanding of the Index Constituent Stocks may change from time to time. The use of sampling techniques or futures or other derivative positions may also affect a Sub-Fund's ability, for a particular Dealing Day or otherwise, to achieve close correlation with the Index. The Manager will monitor and seek to manage such tracking error risk and to minimise tracking error.

Risks relating to the Index

If the Index is discontinued or the Manager's licence from the Index Proprietor and Index Provider is terminated, the Manager may, in consultation with the Trustee, seek the relevant regulators' prior approval to replace the Index with an index that is tradable and has similar objectives to the Index. For the avoidance of doubt, the index-tracking element of a Sub-Fund's investment objective would remain unchanged. Please refer to the section headed "Replacement of an Index" for details.

The composition of the Index may change and Index Constituent Stocks may be delisted.

Concentration risk

A Sub-Fund is subject to concentration risk as a result of tracking the performance of a single geographical region, country or jurisdiction, and its Index may be comprised of a limited number of securities. The value of such Sub-Fund may be more volatile than that of a fund having a more diverse portfolio of investments, as it is more susceptible to fluctuations in value of its Index resulting from adverse conditions in the particular geographical region, country or industry sector.

Where a Sub-Fund's Index tracks a particular region or country or industry sector or where the Index has a small number of constituents, risk factors specific to the relevant Sub-Fund are set out in its Appendix. Please refer to each Sub-Fund's Appendix for details.

Equity market risk

A Sub-Fund's investments in equity securities including the Index Constituent Stocks are subject to general market risks, and the value of such investments may fluctuate due to various factors such as changes in investment sentiment, political and economic conditions and issuer-specific factors. In the short term, equity prices can fluctuate dramatically in response to these developments. Different parts of the market and different types of equity securities can react differently to these developments. For example, large cap stocks can react differently from small cap stocks, and "growth" stocks can react differently from "value" stocks. Issuer, political or economic developments can affect a single issuer, issuers within an industry or economic sector or geographic region, or the market as a whole. Securities exchanges normally have the right to suspend or limit trading in any securities traded on the relevant exchanges under certain circumstances. A suspension or limitation on trading means liquidation of such securities is impossible or trading of such securities is limited during the relevant period and where a Sub-Fund invests in these securities, such Sub-Fund may be subject to losses.

Liquidity risk

In respect of the underlying investments of a Sub-Fund, liquidity risk exists. It is possible that a particular investment or position cannot be easily unwound or offset in a timely manner and/or at a reasonable price due to insufficient market depth or market disruption. Liquid investments may become illiquid or less liquid in particular during period of market turmoil or economic uncertainty. The liquidity of the underlying investments of a Sub-Fund would have an impact on the ability of the Sub-Fund to meet the redemption applications of its Unitholders. Absence of liquidity of the underlying investments may have an adverse impact on a Sub-Fund and the value of its underlying investments.

In addition, securities exchanges normally have the right to suspend or limit trading in any securities traded on the relevant exchanges under certain circumstances. A suspension or limitation on trading means liquidation of such securities is impossible or trading such securities is limited during the relevant period and where a Sub-Fund invests in these securities, it may be subject to losses. In case of low trading volume in respect of an underlying security, the liquidity of such security may be adversely affected. Accordingly, the ability of a Sub-Fund to meet the redemption applications of its Unitholders may be adversely affected.

Effect of Redemptions risk

If significant redemptions of Units are requested by the Participating Dealers or Unitholders of Listed Class Units or Unlisted Class Units, it may not be possible to liquidate the relevant Sub-Fund's investments at the time such redemptions are requested or the Manager may be able to do so only at prices which the Manager believes does not reflect the true value of such investments, resulting in an adverse effect on the return to investors. Where significant redemptions of Units are requested, the right of Unitholders to require redemptions in excess of 10% of the total Net Asset Value of Units in the relevant Sub-Fund then in issue may be deferred, or the period for the payment of redemption proceeds may be extended. Such redemption gate applies to redemption applications in cash only for both Listed Class Units and Unlisted Class Units.

Prohibited securities risks

In accordance with the relevant HSBC Group policy (which applies as the Manager is a member of the HSBC Group), a Sub-Fund will not invest in the securities of companies that are involved directly and indirectly in the use, development, manufacturing, stockpiling, transfer or trade of cluster munitions and/or anti-personnel mines. As this policy aims to prohibit investment in certain types of securities, investors should be aware that this reduces the investment universe and prevents a Sub-Fund from benefitting from any potential returns from these companies (in case there is originally no such restriction at the fund level).

Financial Derivative Instruments Risks

The risks associated with the use of FDIs are different from, or possibly greater than, the risks associated with investing directly in securities and other traditional investments. Generally, a derivative is a financial contract the value of which depends upon, or is derived from, the value of an underlying asset, reference rate or index, and may relate to stocks, bonds, interest rates, currencies or currency exchange rates, commodities, and related indices. Both exchange-traded and over-the-counter derivatives may be utilised. Compared to equity securities, FDIs can be more sensitive to changes in market prices of the underlying assets and thus market prices of FDIs may fall in value as rapidly as they may rise. Investors investing in such a fund are exposed to a higher degree of fluctuation in value than other funds which does not invest in FDIs. Transactions in over-the-counter FDIs may involve additional risk such as the risk that a counterparty defaults as there is no regulated market for such FDIs. Investing in FDIs also involves other types of risks including, but not limited to, the risk of adopting different valuation methodologies and imperfect correlation between the FDI and its underlying securities, rates and indices. Risks associated with FDIs also include counterparty/credit risk, liquidity risk, valuation risk, volatility risk and over-the-counter transaction risk. The leverage element/component of a FDI can result in a loss significantly greater than the amount invested in the FDI. Exposure to FDIs may lead to a high risk of significant loss. There is no assurance that the derivative strategy used by a Sub-Fund (if any) will succeed.

Short selling

A Sub-Fund may make short sales in the expectation of covering the short sale with securities purchased in the open market at a price lower than that received in the short sale. However, the possible losses to a Sub-Fund from short selling a security differ from losses that could be incurred from a cash investment in the same security. Such losses are unlimited due to the lack of an upper limit on the price to which a security may rise, whereas the maximum potential loss from a cash investment is a finite amount i.e. the total amount of the cash investment.

Issuer-specific changes

Changes in the financial condition of an issuer, changes in specific economic or political conditions that affect a particular type of security or issuer, and changes in general economic or political conditions can affect the value of an issuer's securities. The value of securities of smaller, less well-known issuers can be more volatile than that of

larger issuers. Such issuer-specific changes may have an impact on the Index Constituent Stocks.

Risk associated with investments in companies with weighted voting rights

A Sub-Fund may invest in, or the constituents of the relevant index tracked by the relevant Sub-Fund may include, companies which have a weighted voting rights (WVR) structure (or the so-called dual-class shares structure) under which some key individuals including the founders and key management hold specific classes of shares that are attached with higher voting power than ordinary shares and are disproportionate to the shareholding, or other governance right or arrangement of the beneficiary's economic interest in the equity securities of the issuer. This leads to issues relating to shareholder rights and corporate governance as well as investor protection, which may have a negative impact on the relevant Sub-Fund where the Sub-Fund invests in the ordinary shares of such companies.

Reliance on the same group risk

Both the Manager and the Index Provider are presently subsidiaries of Hang Seng Bank Limited (the "**Hang Seng Bank Group**"). One or more of the Participating Dealers and/or Market Makers (applicable to the Listed Class Units only) may from time to time be members of the Hang Seng Bank Group. Nonetheless, the Manager does not consider this will be a risk for the following reasons:

- (a) The Index Provider's operations and the Manager's investment management operations are under the responsibility of different staff and management teams. There are no common directors between the Index Provider and the Manager.
- (b) The Hang Seng Bank Group has internal policies and procedures in place which ensure that effective "Chinese Walls" are created and maintained between different legal entities of the Hang Seng Bank Group and their operations and which impose strict obligations of confidentiality on such legal entities' staff. Information is disclosed between different operations within the same legal entity and between different legal entities of the Hang Seng Bank Group on a "need to know" basis only.
- (c) The Hang Seng Bank Group has procedures in place restricting access to important systems to authorised personnel. All of the Hang Seng Bank Group's staff are required to comply with the Hang Seng Bank Group's internal policies and procedures and the IT security standards of the Hang Seng Bank Group.
- (d) As indicated in the relevant Appendix, each Index has clear and well documented methodology and rules by which the Index is calculated.

Apart from the above, the Trustee (also acting as the Registrar), the Manager (also acting as the Listing Agent with respect to the Listed Class Units only) and the Index Provider are members of the HSBC Group (the "**Group**"). One or more of the Participating Dealers and/or Market Makers (applicable to the Listed Class Units only) may also from time to time be members of the Group. Whilst these are separate legal entities and operationally independent, in the event of a financial catastrophe or the insolvency of any member of the Group, there may be adverse implications for the business of the Group as a whole or other members of the Group which could affect the provision of services to the relevant Sub-Fund. In such event the Net Asset Value of the relevant Sub-Fund may be adversely affected and its operation disrupted.

It should be noted that the Trustee, the Manager and the Index Provider are presently all members of the Group, and one or more of the Participating Dealers and/or Market Makers (applicable to the Listed Class Units only) may from time to time be members of the Group. As such, although all transactions will be at arm's length, conflicts of interest in respect of the relevant Sub-Fund may arise from time to time amongst any of them whilst they belong to the Group. In particular, the Manager and the Trustee may be in dispute with the present Index Provider if it terminates the licence to use the Index. The Manager and each of its Connected Persons will have regard to its obligations to relevant Sub-Fund and Unitholders and will endeavour to ensure such conflicts are resolved fairly. The attention of investors is drawn to the section headed "Conflicts of Interest that may apply to the Sub-Funds".

Counterparty to custodian risk

Deposits of securities or cash with a custodian, bank or financial institution ("custodian or depository") will carry counterparty risk as the custodian or depository may be unable to perform their obligations due to credit-related

and other events like insolvency of or default of them. In most cases, the relevant Sub-Fund's assets will be maintained by the custodian or depository in segregated accounts and would be protected in the event of the insolvency of the custodian or depository.

Risk of termination of a Sub-Fund

A Sub-Fund may be terminated by the Trustee under certain circumstances as specified in the section headed "**Termination**". It is possible that, at the time of such termination, investors have to realise their investment loss and will not be able to receive an amount equal to their capital originally invested.

General legal and regulatory risk

A Sub-Fund must comply with regulatory constraints or changes in the laws affecting it or its investment restrictions which might require a change in the investment policy and objectives followed by the relevant Sub-Fund. Furthermore, such change in the laws or regulations may have an impact on the market sentiment which may in turn affect the performance of the relevant Index or the securities in a Sub-Fund's portfolio and possibly, the performance of the relevant Sub-Fund. Changes in the laws and regulations in relevant jurisdictions may trigger sanctions and other measures by certain countries, and may adversely affect the operations of companies in a Sub-Fund's portfolio. Stock exchanges may also impose certain requirements for the continued listing of securities. Investors cannot be assured that the relevant securities in a Sub-Fund's portfolio will continue to meet the requirements necessary to maintain the listing on the relevant stock exchange, or that the relevant stock exchange will not change the listing requirements. It is impossible to predict whether such an impact caused by any change of law or regulations will be positive or negative for the investments of the Sub-Fund and accordingly for the Sub-Fund. In the extreme case, a Unitholder may lose a material part of its investments in the Sub-Fund.

FATCA related risk

Although the Sub-Funds will attempt to satisfy any obligations imposed on it to avoid the imposition of the FATCA withholding tax, no assurance can be given that the relevant Sub-Fund will be able to satisfy these obligations. If the Sub-Fund becomes subject to a withholding tax as a result of the FATCA regime, the value of the Units held by Unitholders may suffer material losses. Please refer to the sub-section "The United States of America – Foreign Account Tax Compliance Act (FATCA)".

Risks associated with distribution of dividend out of capital or effectively out of capital

The Manager may, at its discretion, pay dividend out of capital or effectively out of capital. Payment of dividends out of capital and/or effectively out of capital amounts to a return or withdrawal of part of an investor's original investment or from any capital gains attributable to that original investment. Any distributions of dividends involving payment of dividends out of the capital of a Sub-Fund or effectively out of the capital of a Sub-Fund may result in an immediate reduction of the Net Asset Value per Unit of the Sub-Fund. Please refer to the section "**Dividend Policy**".

Contagion across sub-funds risk

The Trust Deed allows the Trustee and the Manager to issue Units in separate sub-funds. The Trust Deed provides for the manner in which the liabilities are to be attributed across the various sub-funds under the Trust, including a Sub-Fund (liabilities are to be attributed to the specific sub-fund in respect of which the liability was incurred). A person to whom such a liability is owed has no direct recourse against the assets of the relevant sub-fund (in the absence of the Trustee granting that person a security interest). However, the Trustee will have a right of reimbursement and indemnity out of the assets of the Trust as a whole or any part thereof, against any action, costs, claims, damages, expenses or demands relating to the Trust as a whole, which may result in Unitholders of one sub-fund being compelled to bear the liabilities incurred in respect of other sub-funds in which such Unitholders do not themselves own units, if there are insufficient assets in that other sub-fund to satisfy the amount due to the Trustee. Accordingly, there is a risk that liabilities of one sub-fund may not be limited to that particular sub-fund and may be required to be paid out of one or more other sub-funds.

Non-recognition of sub-fund segregation risk

The assets and liabilities of each sub-fund (including a Sub-Fund) under the Trust will be tracked, for book keeping

purposes, separately from the assets and liabilities of any other sub-funds, and the Trust Deed provides that the assets of each sub-fund should be segregated from each other. There is no guarantee that the courts of any jurisdiction outside Hong Kong will respect the limitations on liability and that the assets of any particular sub-fund will not be used to satisfy the liabilities of any other sub-fund.

Differences in dealing arrangements between Listed Class and Unlisted Class Units

A Sub-Fund may offer both Listed Class Units and Unlisted Class Units. Dealing arrangements in respect of Listed Class Units and Unlisted Class Units are different, and depending on market conditions, investors of the Listed Class Units may be at an advantage compared to investors of the Unlisted Class Units, or vice versa.

Unlike investors of Listed Class Units who may buy and sell Listed Class Units in the secondary market during SEHK trading hours, investors of Unlisted Class Units are only able to subscribe and redeem at the relevant Issue Price and Redemption Price (as the case may be) based on the latest available Net Asset Value as at the end of each Dealing Day. As such, holders of Listed Class Units would have intra-day trading opportunities which will not be available to holders of Unlisted Class Units. In a stressed market scenario, holders of Listed Class Units can sell their units on the secondary market during SEHK trading hours if the market continues to deteriorate, while holders of Unlisted Class Units will not be able to do so.

Conversely, investors in the secondary market generally do not have access to the redemption facilities which are available to investors of Unlisted Class Units. During stressed market conditions, Participating Dealers may, on their own account or on behalf of investors, redeem Listed Class Units on the primary market at the Net Asset Value of the relevant Sub-Fund, but the secondary market trading prices may have diverged from the corresponding Net Asset Value. In such circumstances, holders of the Listed Class Units in the secondary market will be at an apparent disadvantage to holders of the Unlisted Class Units as the latter will be able to redeem from the relevant Sub-Fund at Net Asset Value whilst the former will not.

Differences in fee and cost arrangements between Listed Class and Unlisted Class Units

The levels and types of fees and costs applicable to each of the Listed Class Units and the Unlisted Class Units may differ. As such, the Net Asset Value per Unit of each of the Listed Class Units and Unlisted Class Units may also be different due to the different fees and costs applicable to each class of Units.

- For Listed Class Units, the Transaction Fee may be payable by the Participating Dealer in respect of Creation and Redemption Applications. In relation to cash Creation and Redemption Applications by Participating Dealers, the Manager reserves the right to require the relevant Participating Dealer to pay an additional sum on the creation amount or deduct from the redemption proceeds such sum representing the Duties and Charges for the purpose of compensating or reimbursing the relevant Sub-Fund. Investors in the secondary market will not be subject to the foregoing, but may incur SEHK-related fees such as brokerage fees, transaction levy, trading fee, and inter-counter transfer fee.
- For Unlisted Class Units, Unitholders may be subject to a Preliminary Charge and/or a Redemption Charge in respect of subscription and redemption respectively. For subscription and redemption applications in cash, the Manager may, in good faith and in the best interest of Unitholders, make adjustments to the Net Asset Value per Unit in determining the Issue Price or Redemption Price per Unit (as the case may be) which it considers to be an appropriate allowance to reflect the Duties and Charges allocated to the subscribing investors or the redeeming Unitholders (as the case may be). For further details, please refer to the section headed "Calculation of Issue Price and Redemption Price".

For details of the fees and costs applicable to each class of Units, please refer to the section headed "Current Fees and Charges" in the relevant Appendix.

Risks applicable to the Listed Class Units only

Net Asset Value and price fluctuations

The Net Asset Value per Unit of a Sub-Fund will generally fluctuate with changes in the Index. Intra-day highs and lows of the Index may be significantly different from its level at the end of the trading day. Listed Class Units may be bought and sold in the secondary market through the SEHK at market prices which will fluctuate during the

trading day. Although the market price of a Listed Class Unit is expected to approximate its Net Asset Value, it is possible that the market price of a Listed Class Unit and the Net Asset Value per Listed Class Unit will vary due to, market demand and supply, liquidity and the “bid/ask” spread in the secondary market (as explained further below). As a result, the market price of a Listed Class Unit in the secondary market could be higher or lower than the Net Asset Value per Listed Class Unit.

As with any ETF, the market price of Listed Class Units will be subject to a “bid/ask” spread – being the difference between the prices being bid by potential purchasers and the prices being asked by potential sellers. In times of severe market disruption or when there is an insufficient number of buyers and sellers of Listed Class Units, the bid/ask spread may increase significantly. When the market price of Listed Class Units is falling rapidly, Listed Class Units are most likely to be traded at a discount to the Net Asset Value per Listed Class Unit, which may be the time that you most want to sell your Listed Class Units. In the case of suspension of creations and/or redemptions of Listed Class Units, the Manager anticipates that there may be larger discounts or premiums as between the secondary market price of Listed Class Units and the Net Asset Value per Listed Class Unit.

Trading and listing issues

If the Listed Class Units are delisted from the SEHK, the Manager may, in consultation with the Trustee, seek the relevant regulators’ prior approval to operate a Sub-Fund as a traditional index fund and will notify investors accordingly. In this case, investors in such Sub-Fund would not be subject to any Redemption Charge should they wish to redeem their Listed Class Units for cash. Alternatively, in such circumstances, the Manager may liquidate the relevant Sub-Fund if the Trustee deems it to be in the best interests of investors and will notify the investors accordingly. Investors would then receive Net Asset Value per Listed Class Unit (which may be higher or lower than the amount paid by the investors per Listed Class Unit at the time of original investment) as of the date of liquidation as a result of the Manager having to liquidate all of such Sub-Fund’s investments.

If Listed Class Units deposited with CCASS become non-eligible securities for deposit with CCASS, Listed Class Units will be transferred out of CCASS to, and registered in the name of, the respective CCASS Participants through the Manager. CCASS and HKSCC Nominees Limited will inform the CCASS Participants (the nominee holders of Units) about the “de-list day”. Any expenses arising from such transfer and registration shall be borne by the relevant Sub-Fund. In such circumstances, the Manager, the Trustee, CCASS and the CCASS Participants will use their best efforts to ensure that the transfer and registration of Listed Class Units will be done in a timely manner. However, you should be aware that there could be a delay in transferring and registering the Units.

In the event the Listed Class Units of a Sub-Fund are also listed on stock exchange(s) other than the SEHK, it is possible that such Listed Class Units are still listed on the stock exchange on which they are primarily listed (i.e. the SEHK) whilst they are no longer listed or dealt with on other stock exchange(s). The Manager may apply for withdrawal of listing on such other stock exchange(s) in accordance with the relevant provisions of the Trust Deed, whilst maintaining the listing status on the SEHK. In such case, the prior approval from the relevant stock exchange(s) and regulatory authority(ies) shall be sought and notification of the delisting arrangement (the details of which shall be available at the authorised agent(s) in such jurisdiction(s)) will be sent to the relevant investors. Please note that Listed Class Units which are listed on such other stock exchange(s) but are not redeemed as of the “de-list day” may be sold with the proceeds, after deducting the necessary transaction costs and currency conversion (if applicable), paid to the relevant investors in compliance with the requirements under all applicable laws and regulations (if any). Such net amount may be higher or lower than the amount of the capital invested, thus such investors may suffer losses.

Cost of trading Listed Class Units

Trading of Listed Class Units on the SEHK may involve various types of costs that apply to all securities transactions. When trading Listed Class Units through a broker investors will incur a brokerage commission or other charges imposed by the broker. In addition, investors on the secondary market will also incur the cost of the trading spread, being the difference between what investors are willing to pay for the Listed Class Units (bid price) and the price at which they are willing to sell the Listed Class Units (ask price). Frequent trading may detract significantly from investment results and an investment in Listed Class Units may not be advisable particularly for investors who anticipate regularly making small investments.

Absence of active trading market in the Listed Class Units and liquidity risks

Although Listed Class Units of the Sub-Funds are listed for trading on the SEHK and one or more Market Makers have been appointed, there can be no assurance that an active or liquid trading market for such Listed Class Units will develop or be maintained or that such Market Maker(s) will not cease to fulfil that role. In addition, if the underlying securities which comprise a Sub-Fund's assets have limited trading markets, or if the spreads are wide, this may adversely affect the price of the Listed Class Units and the ability of an investor to dispose of its Listed Class Units at the desired price. There can be no assurance that Listed Class Units will experience trading or pricing patterns similar to those of exchange traded funds which are issued by investment companies in other jurisdictions or those traded on the SEHK which are based upon indices. If an investor needs to sell its Listed Class Units at a time when no active market for them exists, the price it receives for its Listed Class Units (assuming it is able to sell them) is likely to be lower than the price received if an active market did exist.

Further, the Listed Class Units in the RMB counter of applicable Sub-Funds are securities traded on the SEHK, and settled in CCASS, in RMB. Not all stockbrokers or custodians may be ready and able to carry out trading and settlement of the RMB traded Listed Class Units. The limited availability of RMB outside the PRC may also affect the liquidity and trading price of the RMB Listed Class traded Units.

Risk of suspension of trading

Investors and potential investors will not be able to buy, nor will investors be able to sell, Listed Class Units on the SEHK during any period in which trading of the Listed Class Units is suspended. The SEHK may suspend the trading of Listed Class Units whenever the SEHK determines that it is appropriate in the interests of a fair and orderly market to protect investors. The creation and redemption of Listed Class Units may also be suspended if the trading of Listed Class Units is suspended.

Reliance on Market Makers risk

The Manager will use its best endeavours to put in place arrangements so that at least one Market Maker will maintain a market for the Listed Class Units traded in each counter. Nevertheless, it should be noted that liquidity in the secondary market for the Listed Class Units may be adversely affected if there is no Market Maker for Listed Class Units in a particular counter. There may also be less interest by potential Market Makers in making a market in Listed Class Units traded in RMB. Further, any disruption to the availability of RMB may adversely affect the capability of Market Makers in providing liquidity for RMB traded Listed Class Units. It is possible that there is only one Market Maker to a counter or to a Sub-Fund or the Manager may not be able to engage a substitute Market Maker within the termination notice period of a Market Maker, and there is also no guarantee that any market making activity will be effective.

Risk of reliance on Participating Dealers risk

The creation and redemption of Listed Class Units may only be effected through Participating Dealers. A Participating Dealer may charge a fee for providing this service. Participating Dealers will not be able to create or redeem Listed Class Units during any period when, amongst other things, dealings on the SEHK are restricted or suspended, settlement or clearing of relevant securities through the CCASS is disrupted or the Index is not compiled or published. In addition, Participating Dealers will not be able to issue or redeem Listed Class Units if some other event occurs that impedes the calculation of the Net Asset Value of the relevant Sub-Fund or disposal of the relevant Sub-Fund's securities cannot be effected. Since the number of Participating Dealers at any given time will be limited, and there may even be only one Participating Dealer at any given time, there is a risk that investors may not always be able to have creation or redemption of Listed Class Units freely.

Risks applicable to the Unlisted Class Units only

Currency and exchange rate control risk

A class of Units of a relevant Sub-Fund may be designated in a currency other than the base currency of such Sub-Fund. In addition, assets of the relevant Sub-Fund may be denominated in currencies other than the class currencies of the respective classes of Units of such Sub-Funds. The performance and distribution (if any) of these Sub-Funds may be adversely affected by changes in exchange rates between the currencies in which the assets of the relevant Sub-Fund are held and the base currency of such Sub-Fund or the relevant class currency or by changes in exchange rate controls.

LIQUIDITY RISK MANAGEMENT

Liquidity Risk Management Process

Liquidity risk management process is in place for the Manager to manage and monitor liquidity profile of each Sub-Fund in a prudent manner under both normal and adverse market situations.

When managing a Sub-Fund, in addition to risk factors such as market risk, credit risk, exchange rate risk, interest rate risk, etc., the portfolio management team of the Manager considers the liquidity of the Sub-Fund's investments and the corresponding impact on the liquidity profile of the Sub-Fund as well as the Sub-Fund's potential liquidity requirement, in a manner which shall facilitate the Sub-Fund to meet its redemption obligations.

An investment liquidity risk monitoring framework is employed by the Manager to assess and manage liquidity risk of each Sub-Fund. Ongoing liquidity risk assessments and monitoring are performed, taking into account the potential liquidity requirements of the Sub-Fund and the market liquidity under normal and stressed circumstances.

In assessing the potential liquidity requirements of a Sub-Fund, the Manager considers the historical and expected redemption patterns of the Sub-Fund to the extent practicable and how concentration of holding of Units of the Sub-Fund (if any) might impact the redemption profile and hence the level of liquidity risk of the Sub-Fund.

Mechanism is in place for the Manager to assess, review and decide on the actions which may be required at short notice to meet liquidity demands of a Sub-Fund under unexpected stressed conditions.

Independent control monitoring is put in place by the Manager to ensure the ongoing implementation of the liquidity risk management process for a Sub-Fund. Liquidity risk management for a Sub-Fund is also subject to oversight by an internal committee of the Manager.

Liquidity Risk Management Tools

The following liquidity risk management tools are in place for the Manager to manage the liquidity risk of a Sub-Fund and to ensure that Unitholders are treated fairly:

Suspension of the Determination of Net Asset Value and the Right to Redeem Units

There are circumstances in which the Net Asset Value of a Sub-Fund may not be ascertained or it is not reasonably practicable to realise any investments of a Sub-Fund. In such cases, the Manager may, in consultation with the Trustee, having regard to the best interests of the unitholders, declare a suspension of the determination of the Net Asset Value of the relevant Sub-Fund and the right to redeem Units of such Sub-Fund. After the Manager has consulted with the Trustee, no Units will be issued or redeemed during such a period of suspension. For details of such circumstances and the relevant notification arrangement by the Manager, please refer to the point below headed "Suspension of the Determination of Net Asset Value and the Right to Redeem Units".

Deferred Redemption

In order to manage and maintain the liquidity profile of the Sub-Fund in a prudent manner and protect the interests of the remaining Unitholders of the Sub-Fund amid large redemption demand, in the event that redemption requests are received for the redemption of Units representing in aggregate more than 10% of the total Net Asset Value of Units in the Sub-Fund then in issue, the Manager may direct the Trustee to reduce the requests rateably and pro rata amongst all Unitholders seeking to redeem Units on the relevant Dealing Day and carry out only sufficient redemptions which, in aggregate, amount to 10% of the total Net Asset Value of Units in the Sub-Fund then in issue. For details, please refer to the sub-section headed "Deferred redemption" in the section headed "Schedule 2 – Procedures for Creation and Redemption". The redemption gate applies to redemption applications in cash only for both Listed Class Units and Unlisted Class Units.

Borrowings

There may be circumstances in which sufficient cash is not readily available for payment of redemption proceeds of a Sub-Fund, e.g. redemption payment is due to be settled before proceeds from disposal of underlying investments of a Sub-Fund is received. Borrowing can be used as a liquidity risk management tool for a Sub-Fund to meet redemption obligations, subject to the restrictions as set out in the sub-section headed "Borrowing restrictions" under "Schedule 1 – Investment Restrictions, Security Lending and Borrowing" of this offering document.

Adjustments to the Issue Price and Redemption Price of a Sub-Fund

Where there is net cash inflow to a Sub-Fund, the Manager will generally invest for the Sub-Fund; where there is net cash outflow to a Sub-Fund, investments may generally need to be sold to fulfil the redemption obligations of the Sub-Fund. Duties and Charges (such as stamp duties) so incurred, if significant, will adversely affect the interest of the remaining investors of the Sub-Fund. As such, for cash subscriptions and redemptions, the Manager may make adjustments to Issue Price and Redemption Price of the Listed Class Units and/or the Unlisted Class Units to reflect not only the Net Asset Value per Unit but also the appropriate provision for Duties and Charges, as set out in the section headed "Calculation of Issue Price and Redemption Price". This, in effect, is to allocate the costs of subscription to subscribing investors and the costs of redemption to redeeming investors.

Impact of the Use of the Liquidity Risk Management Tools on a Sub-Fund and Investors

The liquidity risk management tools aim to protect the interests of Unitholders under circumstances as stated above and determined by the Manager from time to time. Investors should pay attention to the impact of the use of liquidity risk management tools on a Sub-Fund and the investors:

- *Suspension of the Determination of Net Asset Value and the Right to Redeem Units:*
 - (1) Any such suspension shall take effect forthwith upon the declaration thereof and thereafter there shall be no determination of the Net Asset Value until the Manager shall declare the suspension at an end. No Units will be issued or redeemed during such a period of suspension.
 - (2) In the case of suspension of creations and/or redemptions of Units, the Manager anticipates that there may be larger discounts or premiums as between the secondary market price of Units and the Net Asset Value per Unit.
- *Deferred Redemption:* Units which are not redeemed but which would otherwise have been redeemed will be redeemed on the next Dealing Day (subject to further deferral if the deferred requests in respect of the Sub-Fund themselves exceed 10% of the total Net Asset Value of Units in the Sub-Fund then in issue) in priority to any other Units in the Sub-Fund for which redemption requests have been received. Units will be redeemed at the Redemption Price prevailing on the Dealing Day on which they are redeemed.
- *Borrowings:* While borrowings may provide liquidity for a Sub-Fund, it will increase its operating expenses and hence would affect the performance of the Sub-Fund.
- *Adjustments to the Redemption Price of a Sub-Fund:* Adjustments to reflect not only the Net Asset Value per Unit but also the appropriate provision for Duties and Charges for a Sub-Fund aim to allocate the costs of redemption to redeeming investors. Investors should note that such costs of redemption charged to the redeeming investors and so received by a Sub-Fund may be greater than or less than the actual costs of redemption incurred by such Sub-Fund.

THE OFFERING AND REDEMPTION OF LISTED CLASS UNITS

This section headed “The Offering and Redemption of Listed Class Units” contains disclosure relating to the Listed Class Units only. For information relating to the offer, redemption and switching of the Unlisted Class Units, please refer to the section headed “The Offering, Redemption and Switching of Unlisted Class Units”.

Initial Offer Period

During the Initial Offer Period, Participating Dealers (acting for themselves or for their clients) may apply for Listed Class Units (to be available for trading on the Listing Date) by means of cash or in-kind Creation Applications on each Dealing Day for themselves and/or their clients by transferring cash or (in the case of in-kind creations) a basket of the Index Constituent Stocks and a cash amount as determined and announced by the Manager in advance in accordance with the Operating Guidelines.

To be dealt with during the Initial Offer Period, the relevant Participating Dealer must submit the Creation Applications to the Trustee (with a copy to the Manager) on a Business Day before the above deadline unless otherwise stated in the relevant Appendix.

If a Creation Application is received by the Trustee after the deadline as specified in the Appendix, that Creation Application shall be carried forward and deemed to be received at the opening of business on the next following Dealing Day, which shall be the Dealing Day for the purposes of that Creation Application.

Unless with consent by the Manager, Creation Applications must be made in Application Unit size or whole multiples thereof, which is the number of Listed Class Units specified in the relevant Appendix. During the Initial Offer Period the Participating Dealers (acting for themselves or for their clients) can apply for Listed Class Units on each Dealing Day at the Issue Price.

Please refer to “Schedule 2 – Procedures for Creation and Redemption” for the operational procedures in respect of Creation Applications.

After Listing

The After Listing phase commences on the Listing Date and continues until the relevant Sub-Fund is terminated.

Purchase and Sale of Listed Class Units on the SEHK and Creation and Redemption of Listed Class Units

Investors may:

- (1) purchase and sell Listed Class Units in the secondary market on the SEHK in the relevant currency in respect of the relevant Listed Class Units under the Dual Counter (where adopted by the relevant Sub-Fund);
- (2) apply for in-kind creation and redemption through Participating Dealers; and/or
- (3) apply for cash creation or redemption through Participating Dealers, subject to the Manager’s absolute discretion to decide whether to accept a cash creation application or cash redemption application.

Where specified in an Appendix, special creations and redemptions for Listed Class Units in the relevant Sub-Fund (both in cash and in-kind) through the Manager are available.

Purchase and sale of Listed Class Units on the SEHK

After Listing, investors can purchase and sell Listed Class Units in Trading Board Lot Size (as described in the section “Key Information” in the relevant Appendix) or whole multiples thereof like ordinary listed stocks through an intermediary such as a stockbroker or through any of the share dealing services offered by banks or other financial advisers at any time the SEHK is open.

However, investors should note that transactions in the secondary market on the SEHK occur at market prices which may vary throughout the day and may differ from Net Asset Value per Unit due to market demand and supply, liquidity and scale of trading spread for the Listed Class Units in the secondary market. As a result, the market price of the Listed Class Units in the secondary market may be higher or lower than

Net Asset Value per Listed Class Unit.

Please refer to the section headed “Current Fees and Charges” as stated in the relevant Appendix for fees payable by investors in secondary market trading.

Creation and redemption

Investors may also apply for cash or in-kind creation of Listed Class Units based on Net Asset Value per Unit through Participating Dealers by tendering (in the case of cash creations) a cash payment of an amount equivalent to the aggregate of the Issue Price multiplied by the relevant number of Listed Class Units, or (in the case of in-kind creations) a basket (the “**Basket**”) of the Index Constituent Stocks and a cash amount (the “**Cash Component**”) as determined and announced by the Manager in advance. Cash or in-kind redemptions of Listed Class Units based on Net Asset Value per Unit can also be made in a similar manner by tendering the relevant number of Listed Class Units in exchange for (in the case of cash redemptions) a cash payment of an amount equal to the aggregate of the Redemption Price multiplied by the relevant number of Listed Class Units, or (in the case of in-kind redemptions) the Basket and Cash Component.

Investors should note that creations and redemptions are made in high minimum transaction sizes and the current cash minimum transaction size and in-kind minimum transaction size are as stated in the relevant Appendix. In addition, by applying for an in-kind creation or an in-kind redemption, investors are essentially exchanging the underlying Index Constituent Stocks for the Listed Class Units (in the case of creations) and vice versa (in the case of redemptions). There is no material change in market exposure of their holdings. In other words, their exposure to the relevant market is neither increased nor decreased through an in-kind creation or redemption but investors should note that the relevant Sub-Fund will be subject to tracking error due to fees and other factors.

In determining the composition of the Basket, the Manager will take into account the Sub-Fund's index tracking strategy, the weightings of the Index Constituent Stocks in the Index and any forthcoming index rebalancing event. The Cash Component is the cash value of the difference between the Net Asset Value of the Listed Class Units comprising the application and the closing market value of the Basket on the Dealing Day the in-kind creation or redemption application is received. The Cash Component may be positive or negative.

Please refer to the relevant Appendix for the cut-off time for Participating Dealers making a cash creation application and a cash redemption application or an in-kind creation application and an in-kind redemption application.

In respect of in-kind creations, Listed Class Units will be issued against the relevant Basket and Cash Component (or vice versa) two CCASS Settlement Days after receipt of the creation application (unless otherwise stated in the relevant Appendix) or on such later date as determined by the Manager. In respect of cash creations, Listed Class Units will be issued against the cash payment two CCASS Settlement Days after receipt of the creation application (unless otherwise stated in the relevant Appendix), or on such other date as determined by the Manager in accordance with the Operating Guidelines.

In respect of cash creation and redemption applications by Participating Dealers, the Manager may charge the relevant Participating Dealer an additional sum on the creation amount or deduct from the redemption proceeds such sum representing the difference between (a) the prices used when valuing the Securities in the Sub-Fund for the purpose of such issue or redemption of Units and (b) (in the case of an issue of Units) the prices which would be used when acquiring the same Securities if they were acquired by the Sub-Fund with the amount of cash received by the Sub-Fund upon such issue of Units or (in the case of a redemption of Units) the prices which would be used when selling the same Securities if they were sold by the Sub-Fund in order to realise the amount of cash required to be paid out of the Sub-Fund upon such redemption of Units.

The Manager may charge the relevant Participating Dealer on the creation or redemption application such amount or rate (if any) that the Manager may consider represents the appropriate provision for the Duties and Charges and the Transaction Fee.

Please refer to Schedule 2 – Procedures for Creation and Redemption for the operational procedures in respect of creation and redemption applications. A Transaction Fee is applied to each creation and redemption. Please refer to “Current Fees and Charges” as stated in the relevant Appendix for details.

Special creation and redemption

Unless otherwise stated in the relevant Appendix, the Manager may also facilitate cash subscriptions and cash redemptions and in-kind creations and in-kind redemptions of Listed Class Units based on Net Asset Value per Unit by the HS Funds in the Manager's sole discretion. Cash subscriptions and redemptions for all Listed Class Units must be in the relevant Sub-Fund's base currency.

The Dealing Deadline for making a Special Creation Application and a Special Redemption Application by the HS Funds is the official closing time of the SEHK on the relevant Dealing Day, or such other time prior to the calculation of the Net Asset Value of the relevant Sub-Fund on that Dealing Day as the Manager may determine and agree with the Trustee, unless otherwise stated in the relevant Appendix.

Deferred Redemption

In the event that redemption requests are received for the redemption of Units representing in aggregate more than 10% of the total Net Asset Value of Units in the Sub-Fund then in issue, the Manager may direct the Trustee to reduce the requests rateably and pro rata amongst all Unitholders seeking to redeem Units on the relevant Dealing Day and carry out only sufficient redemptions which, in aggregate, amount to 10% of the total Net Asset Value of Units in the Sub-Fund then in issue. Units which are not redeemed but which would otherwise have been redeemed will be redeemed on the next Dealing Day (subject to further deferral if the deferred requests in respect of the Sub-Fund themselves exceed 10% of the total Net Asset Value of Units in the Sub-Fund then in issue) in priority to any other Units in the Sub-Fund for which redemption requests have been received. Units will be redeemed at the Redemption Price prevailing on the Dealing Day on which they are redeemed. The redemption gate applies to redemption applications in cash only.

Switching between Unlisted Class and Listed Class Units

Investors should note that switching between Unlisted Class Units and Listed Class Units, by a Participating Dealer or otherwise, is not available.

Timetable

Initial Offer Period

The Initial Offer Period and the Listing Date of a new Sub-Fund is set out in the Appendix of the new Sub-Fund.

The purpose of the Initial Offer Period is to enable Participating Dealers to subscribe for Listed Class Units either on their own account or for their clients, in accordance with the Trust Deed and the Operating Guidelines. During this period, Participating Dealers (acting for themselves or for their clients) may apply for Listed Class Units to be available for trading on the Listing Date by creation. No redemptions are permitted during the Initial Offer Period.

Upon receipt of a Creation Application from a Participating Dealer (acting for itself or its clients) during the Initial Offer Period, the Manager shall procure the creation of Listed Class Units for settlement on the Initial Issue Date.

Participating Dealers may have their own application procedures for their respective clients and may set application and payment cut-off times for their respective clients which are earlier than those set out in this offering document and which may change from time to time. The Dealing Deadline in respect of Listed Class Units in a Sub-Fund may also change due to market related events. Investors are therefore advised to consult the relevant Participating Dealer on its requirements if they want a Participating Dealer to subscribe for Listed Class Units on their behalf.

After Listing

"After Listing" commences on the Listing Date and continues until the relevant Sub-Fund is terminated.

All investors may purchase and sell Listed Class Units in the secondary market on the SEHK and Participating Dealers (for themselves or for their clients) may apply for creation and redemption of Listed Class Units in the primary market.

Are there any Special RMB Payment or Account Procedures for Sub-Funds adopting a Dual Counter

Arrangement?

Although the base currency of Listed Class Units for certain Sub-Funds adopting a Dual Counter Arrangement (as specified in the relevant Appendix) may be in HKD, Listed Class Units in the RMB counter are available to be bought and sold on the secondary market in RMB. Investors should note that RMB is the only official currency of the PRC. While both onshore RMB (“CNY”) and offshore RMB (“CNH”) are the same currency, they are traded in different and separated markets. Since the two RMB markets operate independently where the flow between them is highly restricted, CNY and CNH are traded at different rates and their movement may not be in the same direction. Although there is a significant amount of RMB held offshore (i.e. outside the PRC), CNH cannot be freely remitted into the PRC and is subject to certain restrictions, and vice versa. As such, whilst CNH and CNY are both the same currency, certain special restrictions do apply to RMB outside the PRC. The liquidity and trading price of the Listed Class Units may be adversely affected by the limited availability of, and restrictions applicable to, RMB outside the PRC.

If any investors wish to buy or sell Listed Class Units in RMB on the secondary market, they should contact their brokers and they are reminded to confirm with their brokers in respect of Listed Class Units traded in RMB such as brokers’ readiness for dealing and/or clearing transactions in RMB securities and to check other relevant information published by the SEHK regarding readiness of its participants for dealing in RMB securities from time to time. CCASS Investor Participants who wish to settle the payment in relation to their trades in the Listed Class Units traded in RMB using their CCASS Investor Participant account should make sure that they have set up an RMB designated bank account with CCASS.

Investors intending to purchase Listed Class Units traded in RMB from the secondary market should consult their brokers as to the RMB funding requirement and settlement method for such purchase. Investors may need to open and maintain securities dealing accounts with the broker first before any dealing in Listed Class Units traded in either HKD or RMB can be effected.

Investors should ensure they have sufficient RMB to settle trades of Listed Class Units traded in RMB. Investors should consult the banks for the account opening procedures as well as terms and conditions of the RMB bank account. Some banks may impose restrictions on their RMB cheque account and fund transfers to third party accounts. For non-bank financial institutions (e.g. brokers), however, such restriction may not be applicable and investors should consult their brokers as to the currency exchange service arrangement if required.

The transaction costs of dealings in the Listed Class Units on the SEHK include the SEHK trading fee and SFC transaction levy. All these secondary trading related fees and charges will be collected in HKD and, in respect of Listed Class Units traded in RMB, calculated based on an exchange rate as determined by the Hong Kong Monetary Authority on the date of the trade which will be published on HKEx’s website by 11:00 a.m. or earlier on each trading day.

Investors should consult their own brokers or custodians as to how and in what currency the trading related fees and charges and brokerage commission should be paid by the investors.

Where payment in RMB is to be made by cheque investors should consult the bank at which their respective RMB bank accounts are opened in advance as to whether there are any specific requirements in relation to the issue of RMB cheques. In particular, investors should note that some banks have imposed an internal limit (usually RMB80,000) on the balance of RMB cheque account of their clients or the amount of cheques that their clients can issue in a day and such limit may affect an investor’s arrangement of funding for purchase of Listed Class Units traded in RMB.

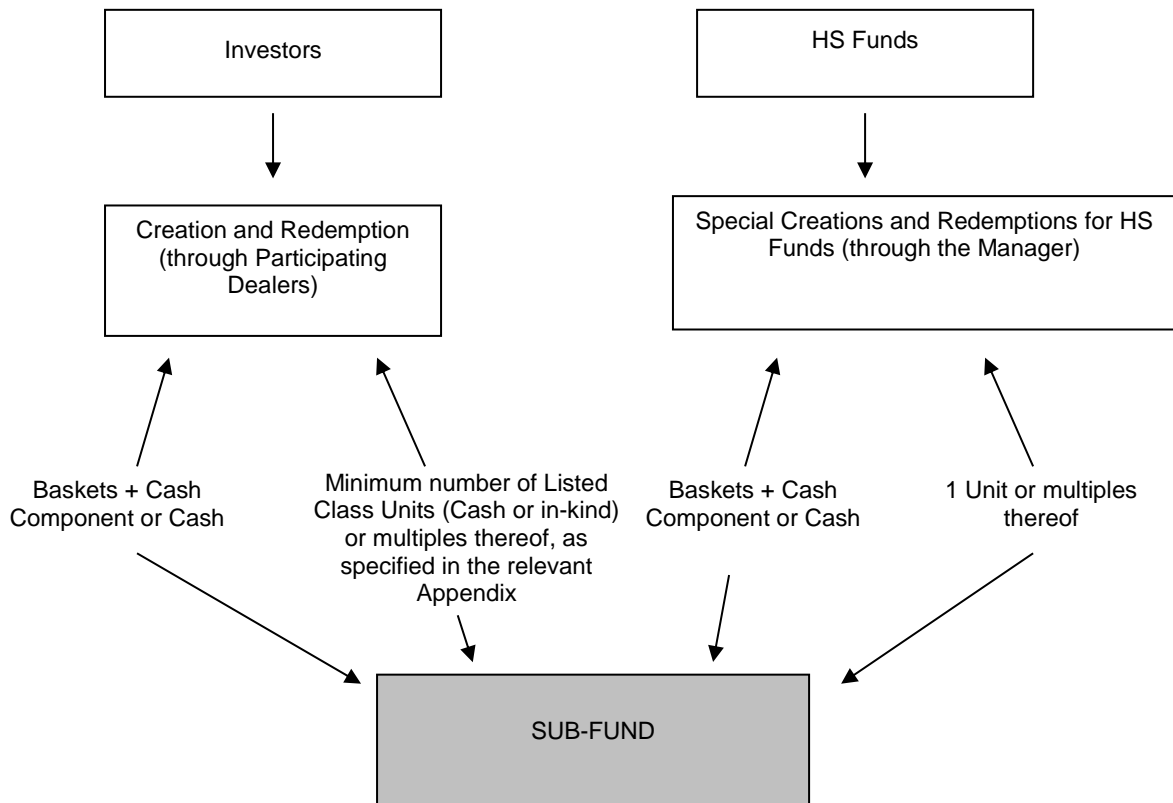
When an individual investor opens an RMB bank account or settle RMB payments, he or she will be subject to a number of restrictions, including the daily maximum remittance amount to the PRC of RMB80,000, and that a remittance service is only available to an RMB deposit account-holder who remits from his or her RMB deposit account to the PRC and provided that the account name of the account in the PRC is identical with that of the RMB bank account with the bank in Hong Kong.

Please also refer to the sub-section headed “General risks of investments associated with RMB currency” in the section headed “WHAT ARE THE RISKS OF INVESTING IN A SUB-FUND?” for further details.

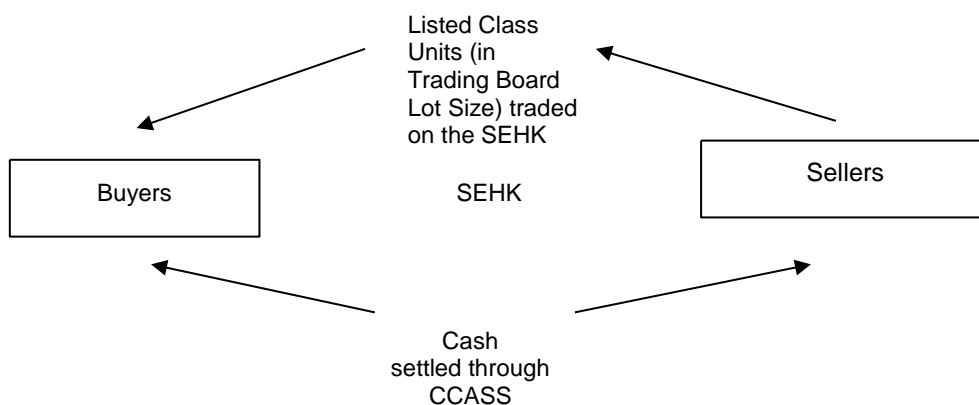
Diagrammatic illustration of investment in the Sub-Funds

Certificates

No physical certificates in respect of the Listed Class Units will be issued.

All Listed Class Units will be registered in the name of HKSCC Nominees Limited on the register of the relevant Sub-Fund. The register of the relevant Sub-Fund is the evidence of ownership of Listed Class Units. Your beneficial interest in Listed Class Units shall be established through your account with your chosen CCASS Participant or, as the case may be, other intermediary.

The Manager reserves the right to reject applications to subscribe for/create Listed Class Units.

Fractional Listed Class Units

The Sub-Funds will not issue fractional Listed Class Units unless otherwise stated in the relevant Appendix.

THE OFFERING, REDEMPTION AND SWITCHING OF UNLISTED CLASS UNITS

This section headed “The Offering, Redemption and Switching of Unlisted Class Units” contains disclosure relating to the Unlisted Class Units only. For information relating to the offering and redemption of the Listed Class Units, please refer to the section headed “The Offering and Redemption of Listed Class Units”.

Subscription of Unlisted Class Units

Initial Offer (if applicable)

Unlisted Class Units in a Sub-Fund may, at the discretion of the Manager, be offered for the first time at an initial Issue Price during the Initial Offer Period of such Unlisted Class as specified in the relevant Appendix in Part 2 of this Prospectus.

The offering of the Unlisted Class Units in a Sub-Fund may be conditional upon a minimum investment (if applicable) being received on or prior to the close of the Initial Offer Period (if applicable).

In the event that the minimum subscription level of the Unlisted Class Units is not achieved or the Manager is of the opinion that it is not in the commercial interest of investors or not feasible, as a result of adverse market conditions or otherwise, to proceed with the relevant Unlisted Class Units, the Manager may in its discretion extend the Initial Offer Period (if applicable) or determine that the Unlisted Class Units will not be launched. In such event, the Unlisted Class Units shall be deemed not to have commenced.

Notwithstanding the aforesaid, the Manager reserves the discretion to proceed with the issue of the Unlisted Class Units during the Initial Offer Period (if applicable) even if the minimum subscription level has not been achieved.

After the expiry of the Initial Offer Period, Unlisted Class Units may only be issued on a Dealing Day.

Issue Price

After the close of the Initial Offer Period (if applicable), the Issue Price per Unit for the Unlisted Class on a Dealing Day will be equal to the Net Asset Value per Unit of that Unlisted Class determined as at the appropriate Valuation Point (for further details please refer to the section headed “DETERMINATION OF NET ASSET VALUE”).

In calculating the Issue Price of a Unit of an Unlisted Class, the Manager may impose such amount or rate (if any) as the Manager may estimate as appropriate to reflect any Duties and Charges which would be incurred for the account of the relevant Sub-Fund in investing an amount equal to that Net Asset Value per Unit of such Unlisted Class. For details please refer to the section headed “Calculation of Issue Price and Redemption Price”.

The Issue Price shall be rounded to the number of decimal places as specified in the relevant Appendix. Any amount corresponding to such rounding will accrue to the relevant Unlisted Class.

Where so specified in the relevant Appendix, the Manager has the power to charge a Preliminary Charge not exceeding 5% of the Issue Price on the issue of each Unit of an Unlisted Class.

Minimum Investment and Subsequent Holding

Save as otherwise provided in the relevant Appendix, the Manager does not require a minimum investment or holding amount for the Unlisted Class Units. However, Authorised Distributors may impose an amount which is equal to or higher than any minimum investment and holding criteria specified in the relevant Appendix.

The Manager has the discretion to waive, change or accept an amount lower than the minimum investment or subsequent holding amount from time to time, whether generally or in a particular case.

Application Procedures

Unless otherwise specified in the relevant Appendix, applications for Units may be made by completing the relevant instruction form of any Authorised Distributor or through the Manager (as the case may be) and sending it to the relevant Authorised Distributor or the Manager (and / or its delegate) by facsimile or SWIFT messaging only for

subsequent subscription application, as the case may be, together with payment for the Units and the Preliminary Charge. The relevant Authorised Distributor or the Manager, as the case may be, will provide payment details for payment of the Units and the Preliminary Charge.

Where application monies are paid in a currency other than the currency of the relevant class of Units, they will be converted, at the cost of the investor, into such currency before being applied (net of all currency conversion costs) in the purchase of Units. Conversion of currencies may involve some delay. No payment by any person other than the applicant will be allowed.

Please refer to the relevant Appendix for deadlines for submitting the instruction forms and paying application monies.

Save where there is a suspension of the determination of the Net Asset Value of the relevant Sub-Fund or relevant Unlisted Class, a request for subscription once given cannot be revoked without the consent of the Manager.

Authorised Distributors

The Manager may appoint one or more distributor(s) to market, promote, sell and/or distribute Unlisted Class Units in one or more Sub-Fund(s), and to receive applications for subscription, redemption and/or switching of Unlisted Class Units ("**Authorised Distributor**").

Where application for Unlisted Class Units is made through an Authorised Distributor, Unlisted Class Units may be registered in the name of a nominee company of the Authorised Distributor through whom the applicant applies for the Unlisted Class Units. As a result of this arrangement, the applicant will be dependent on the person in whose name the applicant's Unlisted Class Units are registered to take action on his/her behalf. As the Authorised Distributor (or its nominee) is the Unitholder of the Unlisted Class Units of the relevant Sub-Fund, the Manager and the Trustee shall not be responsible for any arrangements between the relevant applicant and the Authorised Distributor regarding the subscription, holding and redemption of such Unlisted Class Units and any related matters, as well as any costs or losses that may arise therefrom. The Manager will however, exercise reasonable care in the selection and appointment of the Authorised Distributor(s), in accordance with the *Overarching Principles of the SFC Handbook for Unit Trusts and Mutual Funds, Investment-Linked Assurance Schemes and Unlisted Structured Investment Product*.

Investors who apply for subscription, redemption and/or switching of Unlisted Class Units through Authorised Distributor(s) should note that such Authorised Distributor(s) may impose earlier Dealing Deadlines for receiving instructions for subscriptions, redemptions or switching. Investors should pay attention to the arrangements of the Authorised Distributor(s) concerned.

For the avoidance of doubt, any fees, costs and expenses payable to the Authorised Distributor(s) arising out of any advertisement or promotional activities in connection with the Trust or the Sub-Fund(s) will not be paid from the assets of the Trust or the Sub-Fund(s).

Payment Procedures

Please refer to the relevant Appendix for specific payment procedures.

Payment of application monies shall be in cash. If a Unitholder requests payment in a currency other than the class currency of the relevant Class, and such currency is acceptable to the Manager, the conversion will be made at the then prevailing market rate, at the cost of the investor, into such currency before being applied (net of all currency conversion costs) in the purchase of Units. Conversion of currencies may involve some delay. No payment by any person other than the applicant will be allowed.

The Manager may also, at its sole discretion accept subscriptions in-kind.

No money should be paid to an intermediary in Hong Kong who is not licensed or registered to carry on Type 1 Regulated Activity (dealing in securities) under Part V of the Securities and Futures Ordinance.

General

The Manager has an absolute discretion to accept or reject in whole or in part any application for Unlisted Class Units.

If an application is rejected (either in whole or in part) or the Manager determines that the relevant Unlisted Class Units will not be launched, application monies (or the balance thereof) will be returned as soon as practicable from the relevant Dealing Day or close of the relevant Initial Offer Period (as the case may be) without interest and after deducting any of out-of-pocket fees and charges incurred by the Manager and the Trustee/Registrar by telegraphic transfer to the bank account from which the moneys originated at the risk and expense of the applicant or in such other manner as the Manager and the Trustee may from time to time determine. Save for any liability imposed under the laws of Hong Kong or for breach of trust through fraud or negligence of the Trustee or the Manager, none of the Manager, the Trustee or their respective delegates or agents will be liable to the applicant for any loss the applicant suffers as a result of the rejection or delay of any application.

Unlisted Class Units issued by the Trust will be held for investors in registered form. Certificates will not be issued. A contract note will be issued upon acceptance of an applicant's application and the receipt of cleared funds and will be forwarded to the applicant (at the risk of the person entitled thereto). In case of any error in a contract note, applicants should contact the relevant intermediaries or the relevant distributor promptly for rectification.

Fractions of an Unlisted Class Unit may be created or issued, as specified in the relevant Appendix.

Restrictions on Issue

No Unlisted Class Units in a Sub-Fund will be issued where the determination of the Net Asset Value of that Sub-Fund or that Unlisted Class Units and/or the allotment or issuance of that Unlisted Class Units is suspended (for further details please refer to the section headed "Suspension of the Determination of Net Asset Value and the Right to Redeem Units") or when the Manager determines, with prior notification to the Trustee, that subscriptions for such Sub-Fund or Unlisted Class Units are closed.

Redemption of Unlisted Class Units

Redemption of Unlisted Class Units

Subject to the restrictions (if any) as specified in the relevant Appendix in Part 2 of this Prospectus, any Unitholder may redeem his/her Unlisted Class Units on any Dealing Day in whole or in part.

Redemption Price

Unlisted Class Units redeemed on a Dealing Day will be redeemed at the Redemption Price, which is equal to the Net Asset Value per Unit of the relevant Unlisted Class determined as at the appropriate Valuation Point (for further details, please refer to the section headed "DETERMINATION OF NET ASSET VALUE").

In calculating the Redemption Price, the Manager may at its discretion, deduct such amount or rate (if any) as the Manager may estimate as appropriate to reflect any Duties and Charges which would be incurred for the account of the relevant Sub-Fund in realising assets or closing out positions to provide funds to meet any redemption request and any applicable Redemption Charge. For details please refer to the section headed "Calculation of Issue Price and Redemption Price".

The Redemption Price shall be rounded to the nearest decimal places as specified in the relevant Appendix. Any amount corresponding to such rounding will accrue to the relevant Unlisted Class.

If at any time during the period from the time as at which the Redemption Price is calculated and the time at which redemption proceeds are converted out of any other currency into the class currency of the relevant Unlisted Class there is an officially announced devaluation or depreciation of that currency, the amount payable to any relevant redeeming Unitholder may be reduced as the Manager considers appropriate to take account of the effect of that devaluation or depreciation.

Minimum Redemption and Minimum Holding

Save as otherwise provided in the relevant Appendix, the Manager does not require a minimum redemption or holding amount for the Unlisted Class Units. However, Authorised Distributors may impose an amount which is equal to or higher than any minimum redemption or holding criteria specified in the relevant Appendix.

Redemption Procedures

Unless otherwise specified in the relevant Appendix, investors who purchased their Units through an Authorised Distributor and have the relevant Units held by the nominee appointed by the Authorised Distributor on their behalf should refer to such Authorised Distributor for details of the redemption procedure. Unitholders may redeem their Units on any Dealing Day in whole or in part by submitting application to the Manager as described below. The Manager may refuse to accept an application for a partial redemption of Units if, as a result, the Unitholder would hold Units of the relevant class having a value of less than the minimum holding for such Units.

A redemption application must be given in writing. It must specify the number (or in cases where the Manager, in its discretion, considers as appropriate, the redemption amount) and class of Units to be redeemed, the Fund to which the Units relate and the name(s) of the registered holder(s) and must give payment instructions for the redemption proceeds to be paid. In order for redemption to take effect on a particular Dealing Day, the redemption application must be submitted by facsimile or SWIFT messaging to the Manager and / or its delegate not later than the redemption cut-off time for that Dealing Day (as specified in the relevant Appendix). Different redemption cut-off times may apply in relation to different classes of Units. Subject to the Manager's discretion to accept some late applications from an Authorised Distributor as redemption applications received before the relevant cut-off time for that Dealing Day in certain situations as specified in the relevant Appendix, redemption applications received after the relevant cut-off time for that Dealing Day will be processed on the next Dealing Day.

Units redeemed on a Dealing Day will be redeemed at a price based on the Net Asset Value of the relevant class of the relevant Sub-Fund as at the applicable Valuation Point on the Dealing Day to which the redemption request relates.

Where so specified in the relevant Appendix, the Manager has the power to deduct from the proceeds of redemption a Redemption Charge of up to 4% of such proceeds. The Manager has discretion to waive this Redemption Charge in whole or in part in relation to any redemption request. If at any time during the period from the time as at which the Redemption Price is calculated and the time at which redemption monies are converted out of any other currency into the base currency of the relevant Sub-Fund there is an officially announced devaluation of that currency, the amount payable to any relevant redeeming Unitholder may be reduced as the Manager considers appropriate to take account of the effect of that devaluation.

Payment of Redemption Proceeds

Redemption proceeds will normally be paid by telegraphic transfer in the class currency of the relevant Unlisted Class to the pre-designated bank account of the Unitholder (at the risk and expense of the Unitholder). No third party payments will be permitted. Any bank charges associated with the payment of such redemption proceeds will be borne by the redeeming Unitholder. Redemption proceeds will be paid in the class currency of the relevant Unlisted Class of the relevant Sub-Fund. If a Unitholder requests payment in any currency other than the class currency of the relevant Class, and such currency is acceptable to the Manager, the conversion will be made at the then prevailing market rate, as determined by the Manager and any conversion costs will be borne by the Unitholder.

Redemption proceeds will be paid on or before the expiration of four weeks after the relevant Dealing Day or (if later) the day on which the Manager or its duly authorised agents shall have received the redemption request duly completed and signed and/or (if applicable) the relevant certificate, subject to the requirements under the Trust Deed and the Code.

The Manager shall have the right to reject, acting in good faith, any redemption request under exceptional circumstances, including without limitation the following circumstances:

- (a) any period during which (i) the creation or issue of Units of the relevant Unlisted Class, (ii) the redemption of Units of the relevant Unlisted Class, and/or (iii) the determination of Net Asset Value of the relevant Unlisted Class is suspended;
- (b) where in the opinion of the Manager, acceptance of the redemption request would have an adverse effect on the Trust or the relevant Sub-Fund;
- (c) where there is in existence any trading restriction or limitation such as the occurrence of a market disruption event, suspected market misconduct or the suspension of dealing in relation to any of the Securities in the relevant Index,
- (d) where acceptance of the redemption request would render the Manager in breach of any regulatory restriction or requirement, internal compliance or internal control restriction or requirement of the Manager and/or any of its connected persons;
- (e) circumstances outside the control of the Manager; or
- (f) the redemption request is not submitted in the form and in the manner required.

In the event of such rejection, the Manager shall notify the relevant Unitholder and Trustee of its decision to reject such redemption request.

The Manager may suspend the right of the Unitholders to redeem the Units of any class and/or may delay the payment of any moneys in respect of any such redemption during any suspension period. Any Unitholder may at any time after such a suspension has been declared and before termination of such suspension withdraw the relevant redemption request by notice in writing to the Manager. If no such notice has been received by the Manager before termination of such suspension, the Manager shall realise Units at the Dealing Day next following the termination of such suspension.

Redemption in-kind

The Manager may in their absolute discretion serve a notice in writing on the relevant Unitholder within 5 Business Days of the Dealing Day immediately following the redemption request electing that the redemption and cancellation of the Units is to be satisfied by transferring to such Holder Investments (or partly Investments and partly cash) instead of purchase of the relevant Units by the Manager.

Where the Unitholder consents to such transfer, the Manager shall effect such redemption in accordance with the requirements in the Trust Deed. In particular, the Manager shall, subject to the consent of the Trustee, select the Investments to be transferred and the value of the Investments to be transferred shall be calculated as at the appropriate Valuation Point.

Deferred Redemption

No Unlisted Class Units in a Sub-Fund may be redeemed where the determination of the Net Asset Value of that Sub-Fund or Unlisted Class is suspended (for further details please refer to the section headed "Suspension of the Determination of Net Asset Value and the Right to Redeem Units").

In the event that redemption requests are received for the redemption of Units representing in aggregate more than 10% of the total Net Asset Value of Units in the Sub-Fund then in issue, the Manager may direct the Trustee to reduce the requests rateably and pro rata amongst all Unitholders seeking to redeem Units on the relevant Dealing Day and carry out only sufficient redemptions which, in aggregate, amount to 10% of the total Net Asset Value of Units in the Sub-Fund then in issue. Units which are not redeemed but which would otherwise have been redeemed will be redeemed on the next Dealing Day (subject to further deferral if the deferred requests in respect of the Sub-Fund themselves exceed 10% of the total Net Asset Value of Units in the Sub-Fund then in issue) in priority to any other Units in the Sub-Fund for which redemption requests have been received. Units will be redeemed at the Redemption Price prevailing on the Dealing Day on which they are redeemed. The redemption gate applies to redemption applications in cash only.

Switching of Unlisted Class Units

Unless otherwise specified in the relevant Appendix, Unitholders shall be entitled (subject to such limitations as the Manager may impose after consulting with the Trustee) to switch all or part of their Units in an Unlisted Class in a Sub-Fund (the “**Existing Class**”) into unlisted class units of any Collective Investment Scheme managed by the Manager (the “**New Class**”) available for subscription or switching provided that no Unlisted Class Units may be switched if to do so would result in a holding of less than the minimum holding of Units of the Existing Class or the New Class.

If there is, at any time during the period from the time as at which the Redemption Price per Unit of the Existing Class is calculated and the time at which any necessary transfer of funds from the Sub-Fund to which Units of the Existing Class relate to the Sub-Fund to which Units of the New Class relate takes place, an officially announced devaluation of any currency in which any investment of the first mentioned Fund is denominated or normally traded, the Redemption Price per Unit of the Existing Class shall be reduced as the Manager considers appropriate to take account of the effect of that devaluation and the number of Units of the New Class which will arise from that switching shall be recalculated as if that reduced Redemption Price had been the Redemption Price ruling for redemptions of Units of the Existing Class on the relevant Dealing Day.

Any fraction smaller than one-thousandth of a Unit of the New Class so arising (or such smaller fraction as specified in the Appendix for the New Class) will be ignored and monies representing any such fraction will be retained as part of the Sub-Fund to which Units of the Existing Class relate.

A request for switching will not be effected if as a result the relevant Unitholder would hold less than the minimum holding amount of the Existing Class or the New Class, or is prohibited from holding Units of the New Class.

In addition, specific limitations or restrictions may apply when a Unitholder intends to convert his Units in an Unlisted Class into Units of another Unlisted Class in same Sub-Fund or another Sub-Fund. The relevant limitations or restrictions (if any) will be set out in the Appendix for the relevant Sub-Fund.

Where the switching is between Units (of the same class) denominated in different currencies, currency conversion is involved and the relevant Unitholders are subject to exchange rate risk.

In respect of any switching, the Manager may require the Unitholder to pay a Switching Fee (for further details please refer to the section headed “FEES AND EXPENSES”) in addition to a reasonable fee sufficient to cover any stamp duty or other governmental taxes or charges payable in connection with such switching.

The Manager may in its absolute discretion to accept or reject in whole or in part any switching request.

Switching Procedures

Subject to such limitations as the Manager may impose and subject as noted below, Unitholders and/or investors have the right to switch all or part of their Units of the Existing Class into Units of the New Class by sending written instruction to any Authorised Distributor or written application to the Manager (as the case may be). Units of the Existing Class will not be switched into Units of the New Class where the terms of issue of Units of either the Existing Class or the New Class do not allow switching into Units of the New Class or where the determination of the Net Asset Value of any relevant fund has been suspended.

In order for switching to take effect on a particular Dealing Day, the switching instruction as signed by the Unitholder and/or investor must be received by the Authorised Distributor or the switching application as signed by the Unitholder must be received direct by the Manager and / or its delegate (as the case may be) via facsimile or SWIFT messaging not later than the cut-off time for receipt of switching application for that Dealing Day which shall be the cut-off time for receipt of applications for the Existing Class or the New Class, whichever is earlier. Subject to the Manager’s discretion to accept some late switching applications from an Authorised Distributor as switching applications received before the relevant cut off time for that Dealing Day in certain situations as specified in the relevant Appendix, switching applications received after the relevant cut off time for that Dealing Day will be processed on the next Dealing Day. For the avoidance of doubt, where the cut-off time for receipt of applications for the Existing Class is earlier than that for the New Class, any switching instruction received by the Authorised Distributor or switching application received by the Manager after the relevant cut-off time for receipt of applications for the Existing Class will be processed on the next Dealing Day even if the switching instruction or application is received before the relevant cut-off time for receipt of applications for the New Class. On the other hand, where

the cut-off time for receipt of applications for the New Class is earlier than that for the Existing Class, any switching instruction received by the Authorised Distributor or switching application received by the Manager after the relevant cut-off time for receipt of applications for the New Class will be processed on the next Dealing Day even if the switching instruction or application is received before the relevant cut-off time for receipt of applications for the Existing Class. Switching will be effected by redeeming the Units of the Existing Class on the relevant Dealing Day and issuing Units of the New Class on the Dealing Day for Units of the New Class falling on or after (i) the date of redemption of Units of the Existing Class and (ii) the satisfaction of any conditions attaching to the issue of the Units of the New Class (for example, that such Units may only be issued on receipt of cleared funds for the account of the relevant fund) or such later Dealing Day as the Manager may have determined as applicable for switches into Units of the New Class.

Restrictions on Switching of Unlisted Class Units

Unlisted Class Units shall not be switched during any period when the determination of the Net Asset Value of any relevant Sub-Fund is suspended (for further details please refer to the section headed "Suspension of the Determination of Net Asset Value and the Right to Redeem Units") or when redemption of Units of the Existing Class is limited (for further details please refer to the section headed "Deferred Redemption").

Switching between Unlisted Class and Listed Class Units

Investors should note that switching between Unlisted Class Units and Listed Class Units, by a Participating Dealer or otherwise, is not available.

DETERMINATION OF NET ASSET VALUE

Calculation of Net Asset Value

The Net Asset Value of each Sub-Fund will be determined in the base currency of the relevant Sub-Fund in accordance with the Trust Deed. The Manager may, with the prior written consent of the Trustee, adjust the value of any investment made by the relevant Sub-Fund or permit some other method of valuation of such investment to be used if, having regard to exchange rates, applicable rates of interest, maturity dates, marketability and other considerations the Manager deems relevant, the Manager considers such adjustment or use of such other method is required to reflect the fair value of such investment.

The Net Asset Value will be determined as at each Valuation Point on each Dealing Day.

Set out below is a summary of how assets held by a Sub-Fund are valued:

- (a) Investments (including an interest in a Collective Investment Scheme quoted, listed or normally dealt in on a recognised securities market but excluding an interest in an unlisted Collective Investment Scheme or a commodity) shall, at the discretion of the Manager, be calculated by reference to the price appearing to the Manager to be the last traded price or closing price as calculated and published by the recognised securities market for such investment or (if no last traded price or closing price is available) the latest available price on the recognised securities market on which the investment is quoted, listed, traded or normally dealt in for such amount of such investment at or immediately preceding the Valuation Point, as the Manager may consider in the circumstances to provide a fair criterion, provided that: (i) subject to (ii) below, if an investment is quoted, listed, traded or normally dealt in on more than one recognised securities markets, the Manager shall adopt the nominal closing price quoted on the market which, in its opinion, provides the principal market for such investment; (ii) in the case of any investment which is quoted, listed or normally dealt in on a recognised securities market but in respect of which, for any reason, prices on that market may not be available at any relevant time or such market's nominal closing price is not considered to provide a fair value for such investment by the Manager, the value thereof shall be certified by such firm or institution making a market in such investment as may be appointed for such purpose by the Manager or, if the Trustee so requires, by the Manager after consultation with the Trustee; and (iii) interest accrued on interest bearing investments up to (and including) the date as at which the valuation is made should be taken into account, unless such interest is included in the quoted or listed price;
- (b) the value of any investment (other than an interest in a Collective Investment Scheme or a commodity) which is not quoted, listed or ordinarily dealt in on a recognised securities markets shall be the initial value thereof equal to the amount expended out of the Sub-Fund in the acquisition of such investment (including in each case the amount of stamp duties, commissions and other acquisition expenses) provided that the Manager may at any time with the approval of the Trustee and shall at such times or at such intervals as the Trustee may request cause a revaluation to be made by a professional person approved by the Trustee as qualified to value such investments (which may be the Manager or any Connected Person of the Manager);
- (c) cash, deposits and similar investments shall be valued at their face value (together with accrued interest) unless, in the opinion of the Manager, any adjustment should be made to reflect the value thereof;
- (d) futures contracts will be valued based on the formulae set out in the Trust Deed;
- (e) the value of each unit, share or other interest in any Collective Investment Scheme (other than an interest in a Collective Investment Scheme quoted, listed, traded or normally dealt in on a securities market) shall be the last published net asset value per unit, share or other interest in such Collective Investment Scheme (where available) or (if the same is not available) a price calculated by aggregating the last published bid price for such a unit, share or other interest and the last published offer price therefor (excluding any preliminary or initial charge included in such offer price) and dividing the result by two, and if no net asset value, bid and offer prices or price quotations are available, the value thereof shall be determined from time to time in such manner as the Manager shall determine; and
- (f) notwithstanding the foregoing, the Manager may with the prior written consent of the Trustee adjust the value of any investment or permit some other method of valuation to be used if, having regard to currency, applicable rate of interest, maturity, marketability and other considerations they deem relevant, they consider that such adjustment or use of such other method is required to reflect the fair value thereof.

The above is a summary of the key provisions of the Trust Deed with regard to how the various assets of a Sub-Fund are valued.

Suspension of the Determination of Net Asset Value and the Right to Redeem Units

The Manager may, in consultation with the Trustee, having regard to the best interests of the unitholders, declare the suspension of the determination of Net Asset Value of a Sub-Fund and the right to redeem Units for the whole, or any part of, any period when:

- (1) the SEHK is closed;
- (2) dealings on the SEHK or the Hong Kong Futures Exchange Limited are restricted or suspended;
- (3) the settlement or clearing of dealings via CCASS is disrupted;
- (4) the Index is not compiled or published;
- (5) there exists any state of affairs as a result of which delivery or purchase of Index Constituent Stocks or disposal of investments for the time being comprised in the relevant Sub-Fund cannot, in the opinion of the Manager, be effected normally or without prejudicing the interests of investors in the relevant Sub-Fund;
- (6) there is any breakdown in the means normally employed in determining Net Asset Value or when, for any other reason, the value of any investment of the relevant Sub-Fund cannot, in the opinion of the Manager, be reasonably, promptly and fairly be ascertained; or
- (7) the remittance or repatriation of other funds which will or may be involved in the realisation of, or in the payment for, investments of the relevant Sub-Fund or the issue or redemption of Units is delayed or cannot, in the opinion of the Manager, be carried out promptly at normal rates of exchange.

Any such suspension shall take effect forthwith upon the declaration thereof and thereafter there shall be no determination of the Net Asset Value of the relevant Sub-Fund until the Manager shall declare the suspension at an end, except that the suspension shall terminate in any event on the day following the first Dealing Day on which (i) the condition giving rise to the suspension shall have ceased to exist and (ii) no other condition under which suspension is authorised shall exist.

Whenever the Manager declares such a suspension it shall, as soon as may be practicable after any such declaration, publish a notice on www.hangsenginvestment.com (*this website has not been reviewed by the SFC*) and the SEHK's website www.hkex.com.hk (*this website has not been reviewed by the SFC*) in respect of the Listed Class Units and/or cause a notice to be given to investors and to all those (whether investors or not) whose applications to redeem Units shall have been affected by such suspension stating that such declaration has been made.

In respect of the Listed Class Units, no Application shall be made by any of the Participating Dealers and in the event any Application is received in respect of any Dealing Day falling within such period of suspension (that has not been otherwise withdrawn), such Application shall be deemed as having been received immediately following the termination of the suspension.

In respect of the Unlisted Class Units, no subscription application shall be made by any investors and in the event any subscription application is received in respect of any Dealing Day falling within such period of suspension (that has not been otherwise withdrawn), such subscription application shall be deemed as having been received immediately following the termination of the suspension.

No Units relating to the relevant Sub-Fund will be created and issued or redeemed during such a period of suspension after the Manager has consulted with the Trustee.

In respect of Listed Class Units, a Participating Dealer may at any time after a suspension has been declared and before termination of such suspension withdraw an Application submitted prior to such suspension by notice in writing to the Manager and the Trustee. If the Manager has not received any such notification of withdrawal of such Application before termination of such suspension, the Trustee shall, subject to and in accordance with the provisions of the Trust Deed, create and issue Listed Class Units or redeem Listed Class Units in respect of such Application and such Application shall be deemed to be received immediately following the termination of such

suspension.

In respect of Unlisted Class Units, an applicant may at any time after a suspension has been declared and before termination of such suspension withdraw any subscription, switching, redemption or transfer application submitted prior to such suspension by notice in writing to the Manager and the Trustee. If the Manager has not received any such notification of withdrawal of such subscription, switching, redemption or transfer application before termination of the suspension, the Trustee shall, subject to and in accordance with the provisions of the Trust Deed, issue, switch, redeem or transfer such Unlisted Class Units in respect of such application and such application shall be deemed to be received as at the Dealing Day next following the termination of such suspension.

Suspension of Dealings in Listed Class Units on the SEHK

Dealings in Listed Class Units on the SEHK may at any time be suspended by the SEHK if the SEHK considers it necessary for the protection of investors or for the maintenance of an orderly market in such circumstances and subject to such conditions as the SEHK sees fit.

Calculation of Issue Price and Redemption Price

The initial Issue Price of a Listed Class Unit and an Unlisted Class Unit during the Initial Offer Period of each Sub-Fund (if applicable) may be determined by the Manager in its discretion and will be set out in the relevant Appendix.

After the expiry of the Initial Offer Period (if any), notwithstanding any Dual Counter being adopted for a Sub-Fund, the Issue Price or Redemption Price of each Listed Class Unit or an Unlisted Class Unit for any relevant Dealing Day will, subject to the qualification below, be based on the Net Asset Value of the relevant Sub-Fund in its base currency at the Valuation Point divided by the number of Listed Class Units or Unlisted Class Units (as the case may be) then in issue or deemed to be in issue, rounded to the number of decimal places as specified in the relevant Appendix. The benefit of any such rounding shall accrue to the relevant Sub-Fund.

Where there is net cash inflow to a Sub-Fund, the Manager will generally acquire investments for the Sub-Fund; where there is net cash outflow to a Sub-Fund, investments may need to be sold to fulfil the redemption obligations of the Sub-Fund. Duties and Charges incurred in such processes, if significant, will adversely affect the interest of the remaining Unitholders of the Sub-Fund. To ensure all investors in each Sub-Fund are treated fairly, the Manager may make adjustments to the Net Asset Value per Unit. This, in effect, is to allocate the Duties and Charges to the subscribing investors and the redeeming Unitholders (as the case may be).

For subscription and redemption applications in cash for Unlisted Class Units, in determining the Issue Price of a Unit, where the net subscription with respect to the relevant classes on a Dealing Day exceeds the pre-defined threshold (if any), the Manager may, in good faith and in the best interest of Unitholders, add to the Net Asset Value per Unit (before making any rounding adjustment) an amount or rate, for the account of the relevant Sub-Fund, which it considers to be an appropriate allowance to reflect the Duties and Charges which would be incurred if the appropriate number of underlying securities were purchased at the values attributed to them in calculating the Net Asset Value per Unit.

Similarly, for subscription and redemption applications in cash for Unlisted Class Units, when determining the Redemption Price of any Unit, where the net redemption with respect to the relevant classes on a Dealing Day exceeds the pre-defined threshold (if any), the Manager may, in good faith and in the best interest of Unitholders, deduct for the account or rate of the relevant Sub-Fund from the Net Asset Value per Unit (before making any rounding adjustment) an amount which it considers to be an appropriate allowance to reflect the Duties and Charges which would be incurred if the appropriate number of underlying securities were to be sold at the values attributed to them in calculating the Net Asset Value per Unit.

In practice (subject to specific provisions of the relevant Sub-Fund), for subscription and redemption applications in cash for Unlisted Class Units, in determining any adjustment to the Net Asset Value per Unit in good faith and in the best interest of Unitholders, the Manager may take into account various factors, including whether the net subscription or net redemption for Units received in respect of all relevant classes of the Sub-Fund on a Dealing Day has reached a pre-defined threshold (in terms of a percentage of the Net Asset Value of a Sub-Fund) (if any) and the amount of Duties and Charges which would be incurred in relation to such subscription or redemption. Such pre-defined threshold (if any) will be determined and reviewed on a periodic basis by the Manager. Where an adjustment is to be made, the rate of adjustment will be at a pre-defined rate and it will be applied to all relevant

classes of Units of the Sub-Fund in one direction to enable the Sub-Fund to recover an appropriate amount reflecting the Duties and Charges to be incurred as a result of such net subscription or net redemption. The pre-defined threshold (if any) and the adjustment rate may be different for different Sub-Funds and may vary over time. However, the adjustment rate may not exceed 2% of the original Net Asset Value per Unit.

Investors should note that the adjustments to the Net Asset Value per Unit are related to the cash inflow into and outflow from all relevant classes of Units of the Sub-Fund in relation to subscription and redemption applications in cash for Unlisted Class Units, and are not predictable on any Dealing Day. Consequently it is not possible to accurately predict how frequently such adjustments will need to be made. Besides, the adjustments made may be greater than or less than the actual Duties and Charges incurred. If the adjustments made are less than the actual Duties and Charges incurred, the difference will be borne by the Sub-Fund. Furthermore, before reaching the pre-defined threshold (if any), no adjustments will be made to the Net Asset Value per Unit in which case the relevant Duties and Charges will be borne by the Sub-Fund. This would result in a reduction in the value of the Sub-Fund's assets. Investors should also be aware that where an adjustment needs to be made on a particular Dealing Day, the same rate of adjustment will be applied to all relevant classes of Units of the Sub-Fund in one direction. Therefore it may be the case that the adjustment may have the effect of benefitting certain investor(s). For instance, an investor subscribing for the Units of a class on a Dealing Day on which the Net Asset Value per Unit of the relevant class is adjusted downwards as a result of net redemption of the relevant Sub-Fund may benefit from paying a lower issue price in respect of his subscription than he would otherwise have to pay. On the other hand, an investor redeeming the Units of a class on a Dealing Day on which the Net Asset Value per Unit of the relevant class is adjusted upwards as a result of net subscription of the relevant Sub-Fund may benefit from receiving a higher redemption price in respect of his redemption than he would otherwise have received. Investors should be aware that swing pricing adjustments may not always, or fully, prevent the dilution of the relevant Sub-Fund's assets.

For the avoidance of doubt, neither the Issue Price nor the Redemption Price takes into account the Duties and Charges, Transaction Fee or fees payable by a Participating Dealer.

For Special Creation Applications and Special Redemption Applications in cash for Listed Class Units, the Manager reserves the right to request the HS Funds to reimburse the relevant Sub-Fund for all reasonable costs representing an appropriate provision for the Duties and Charges for the purpose of compensating or reimbursing the relevant Sub-Fund incurred in relation to the Special Creation Application or Special Redemption Application.

Market Price

Dealings in the Listed Class Units on the secondary market may be effected at market prices on the SEHK which may vary throughout the day and may be higher or lower than the Net Asset Value per Listed Class Unit.

FEES AND EXPENSES

Fees and Expenses Payable by a Sub-Fund (applicable to both Listed and Unlisted Classes)

For details of the amount of fees and expenses currently payable by a Sub-Fund (or Class), please see the section below and the section headed "Current Fees and Charges" in the relevant Appendix.

Management Fee

Each Sub-Fund (or Class) pays the Manager a monthly fee calculated by reference to daily Net Asset Value of the relevant Sub-Fund (or Class). Any increase from the current level up to the maximum level (please refer to the relevant Appendix) will be announced or published on the SEHK's website www.hkex.com.hk (*this website has not been reviewed by the SFC*) and via www.hangsenginvestment.com (*this website has not been reviewed by the SFC*). Any increase in the maximum level must be approved by registered holders of Units in the relevant Sub-Fund (or Class) at an extraordinary general meeting.

Trustee Fee

Each Sub-Fund (or Class) pays the Trustee a monthly fee calculated by reference to daily Net Asset Value of the relevant Sub-Fund (or Class). Any increase from the current level up to the maximum level (please refer to the relevant Appendix) will be announced or published on the SEHK's website www.hkex.com.hk (*this website has not been reviewed by the SFC*) and via www.hangsenginvestment.com (*this website has not been reviewed by the SFC*). Any increase of the maximum level must be approved by registered holders of Units in the relevant Sub-Fund (or Class) at an extraordinary general meeting.

Other Expenses

Each Sub-Fund (or Class) bears the expenses which are attributable to it. Such expenses include but are not limited to the costs of the Manager investing on behalf of the Sub-Fund (or Class) (including applicable duties), the securities transaction fee, the fees and expenses of the custodians of its assets, the fees and expenses of the Registrar, the fees and expenses of its auditors, valuation costs, legal fees, index licensing fees, the costs incurred in connection with the listing of the Sub-Fund on the SEHK and authorisation as a collective investment scheme by the SFC, reconciliation fee by the Service Agent (in respect of the Listed Class, if applicable), the costs of preparation and publication of this offering document (including the Product Key Facts Statement for each Sub-Fund (or Class)) and the Trust Deed, the costs of communicating with and holding meetings of investors, the costs incurred in the preparation and printing of any document or reports to investors (including, as may be agreed to the Manager, postage costs incurred by any nominee for the benefit of the underlying investors in distributing such reports), costs payable to the data vendor and all other operating costs and ordinary out-of-pocket expenses incurred by the Manager, the Trustee or any of their agents. For the avoidance of doubt, no expenses arising out of any advertising or promotional activities in connection with a Sub-Fund (or Class) will be paid from the assets of the relevant Sub-Fund (or Class).

Soft dollar benefits

Neither the Manager, its delegates (including any investment delegates) nor its Connected Persons will receive cash or other rebates from brokers or dealers in respect of transactions for the account of a Sub-Fund. However, the Manager, its delegates (including any investment delegates) or any of their Connected Persons may receive, and are entitled to retain, goods, services or other benefits, such as research and advisory services, economic and political analysis, portfolio analysis (including valuation and performance measurement), market analysis, data and quotation services, computer hardware and software incidental to the above goods and services, clearing and custodian services and investment-related publication (known as soft dollar benefits) which are of demonstrable benefit to a Sub-Fund (as may be permitted under the Code, applicable rules and regulations) from brokers and other dealers through whom investment transactions are carried out provided that the quality of transaction execution is consistent with best execution standards, brokerage rates are not in excess of customary institutional full-service brokerage rates and the availability of soft dollar arrangements is not the sole or primary purpose to perform or arrange transaction with such broker or dealer. For the avoidance of doubt, such goods and services do not include travel accommodation, entertainment, general administrative goods or services, general office equipment or premises, membership fees, employee salaries or direct money payments. Details of soft dollar arrangements will be disclosed in each Sub-Fund's annual report.

Pricing or rebate arrangements

The Manager may share any fees, charges or amounts it is entitled to receive as manager of a Sub-Fund with any persons who distribute or otherwise procure investors to invest into that Sub-Fund. Investors should note that any of the Manager's employees, Authorised Distributors and/or its employees and/or its agents may, out of any fees, charges or amounts the Manager is entitled to receive from the relevant Sub-Fund and retain for its own use and benefit, receive or enjoy rebates, discounts, commissions, sales incentives, fees, benefits and/or other advantages in different forms and at varying rates arising out of or in connection with an investor's investment in that Sub-Fund. Such amounts will not be borne by any Sub-Funds.

The Manager may enter into separate pricing arrangements with end investors to offer discounts of fees and charges to them. Such discounts will only be offered out of the fees or charges the Manager is entitled to receive from the relevant Sub-Fund and retain for its own use and benefit and will not have any implication on the Sub-Fund.

Fees and Charges Payable by Participating Dealers and Investors for Dealing in the Listed Class Units on the SEHK

Participating Dealers are required to pay fees and expenses for creation or redemption of Listed Class Units in the primary market, including where applicable, a transaction fee, service agent fee, conversion agent fee (where applicable), cancellation fee, extension fee, partial delivery request fee, and other Duties and Charges.

Investors are required to pay fees and charges imposed by the Participating Dealer in respect of creations and redemptions (as applicable) via the Participation Dealer.

Investors are required to pay brokerage fees, transaction levies and the SEHK trading fees in respect of any dealing in the Listed Class Units on the SEHK.

For details of the amount of fees and expenses currently payable, please see above and the section headed "Current Fees and Charges" in the relevant Appendix.

Fees and Charges Payable by Investors for Dealing in the Unlisted Class Units only

Preliminary Charge

The Manager, its agents or delegates (including any Authorised Distributors appointed by the Manager from time to time) may charge a Preliminary Charge on the issue of each Unlisted Class Unit of a percentage of the Issue Price of such Unlisted Class Unit as at the appropriate Valuation Point. The maximum and current rate of Preliminary Charge (if any) and the manner in which it will be imposed are specified in the relevant Appendix. For the avoidance of doubt, a lower maximum rate of Preliminary Charge may be imposed in relation to the issue of Units of an Unlisted Class in a Sub-Fund as compared to other Sub-Funds and also in relation to different Unlisted Classes of a Sub-Fund.

Subject to the applicable requirements of the Code, the Manager may at any time increase the rate of the Preliminary Charge of an Unlisted Class or a Sub-Fund up to the permitted maximum rate (which is 5.0%) as set out in the Trust Deed.

The Manager, its agents or delegates may on any day differentiate between applicants or Unlisted Classes as to the amount of the Preliminary Charge. The Preliminary Charge will be retained by or paid to the Manager, its agents or delegates for their own absolute use and benefit.

Redemption Charge

The Manager may charge a Redemption Charge on the redemption of Unlisted Class Units of a percentage of the Redemption Price of such Units as at the appropriate Valuation Point. The maximum and current rate of Redemption Charge (if any) and the manner in which it will be imposed are specified in the relevant Appendix. For the avoidance of doubt, a lower maximum rate of Redemption Charge may be imposed in relation to the redemption of Unlisted Class Units of a Sub-Fund as compared to other Sub-Funds and also in relation to different Unlisted

Classes of a Sub-Fund.

Subject to the applicable requirements of the Code, the Manager may at any time increase the rate of the Redemption Charge payable for a Sub-Fund or an Unlisted Class up to the permitted maximum rate (which is 4.0%) as set out in the Trust Deed.

For the purpose of calculating the Redemption Charge payable on a partial redemption of a Unitholder's holding, Unlisted Class Units subscribed earlier in time are deemed to be redeemed prior to Unlisted Class Units subscribed later in time unless the Manager and the Trustee agree otherwise.

The Manager shall be entitled to differentiate between Unitholders or Unlisted Classes as to the amount of the Redemption Charge (within the authorised rate of Redemption Charge). The Redemption Charge will be retained by or paid to the Manager for its own absolute use and benefit or, if so stated in the relevant Appendix, retained by the relevant Sub-Fund. Where the Redemption Charge is retained by the Manager, it may at its discretion, pay all or part of the Redemption Charge to its agents or delegates.

Switching Fee

A Switching Fee of the Issue Price per Unit of the New Class as at the appropriate Valuation Point may be charged by the Manager in respect of each Unit of the New Class to be issued upon such switching.

Subject to the applicable requirements of the Code, the Manager may at any time increase the rate of the Switching Fee up to the permitted maximum rate (which is 4.0%) as set out in the Trust Deed.

The Switching Fee shall be retained by or paid to the Manager for its own absolute use and benefit.

DIVIDEND POLICY AND REPORTING

Dividend Policy

The Manager will adopt a distribution policy for each Sub-Fund as the Manager considers appropriate having regard to the Sub-Fund's net income, fees and costs. For each Sub-Fund this distribution policy (including the currency of such distribution) will be set out in the relevant Appendix. Distributions will always depend on payments on securities held by the relevant Sub-Fund which will in turn depend on factors beyond the control of the Manager including, general economic conditions, and the financial position and distribution policies of the relevant underlying entities. Unless otherwise specified in the relevant Appendix, no distribution will be paid out of capital and/or effectively out of capital of the Sub-Fund. There can be no assurance that such entities will declare or pay dividends or distributions.

Reporting to Investors

Reports and Accounts

The year-end of the Trust and each Sub-Fund is 31 December in each calendar year. An audited annual financial report will be made available to Unitholders within four months of the end of each financial year.

The interim unaudited financial reports will also be made available to Unitholders within two months of the period which they cover.

The interim and annual financial reports will be available in both English and Chinese language, and provide a summary illustrating the differences between the daily closing price for the Listed Class Units on the SEHK and its Net Asset Value per Unit over the reporting period.

Notice will be given to Unitholders to notify them where the financial reports, in printed and electronic forms, can be obtained within the relevant timeframe.

Information on the Internet

The Manager will publish information with respect to each Sub-Fund (including in respect of the relevant Index), both in Chinese and in English, on www.hangsenginvestment.com (*this website has not been reviewed by the SFC*) (and a hyperlink from the SEHK's website www.hkex.com.hk (*this website has not been reviewed by the SFC*) is also available in respect of the Listed Class Units). You should regularly review such information. Such information will include:

- this offering document (including the Product Key Facts Statement in respect of each Sub-Fund), as may be updated from time to time. Investors should note that where a Sub-Fund offers both Listed Class Units and Unlisted Class Units, a separate set of Product Key Facts Statement will be available for each of the Listed Class Units and Unlisted Class Units of the same Sub-Fund;
- the latest annual audited and interim unaudited financial reports of each Sub-Fund;
- the last Net Asset Value of each Sub-Fund in the base currency of the Sub-Fund and the last Net Asset Value per Unit of each class of Units of the Sub-Fund (including, in respect of the Listed Class Units, in each trading currency of the Sub-Fund) (updated on a daily basis);
- (in respect of the Listed Class Units) the near real-time indicative Net Asset Value per Unit of each Sub-Fund (updated every 15 seconds during the SEHK trading hours throughout each Dealing Day) in each trading currency of the Sub-Fund;
- (in respect of the Listed Class Units) the latest list of Participating Dealers and Market Makers;
- the full holdings of each Sub-Fund (updated on a daily basis);
- any notices relating to material changes to each Sub-Fund which may have an impact on its investors, such as material alterations or additions to this offering document or any of the constitutive documents of

the Trust and/or a Sub-Fund;

- any public announcements made by the Manager in respect of any of the Sub-Funds, including information with regard to a Sub-Fund and the Sub-Fund's Index, as well as notices of suspension and resumption of creation and redemption of units, suspension of the calculation of the Net Asset Value, changes in fees and suspension and resumption of trading;
- the ongoing charges figure and the past performance information of each Sub-Fund;
- the annual tracking difference and tracking error of each Sub-Fund; and
- the compositions of the dividends (i.e. the relative amounts paid out of (i) net distributable income and (ii) capital), if any, for a rolling 12-month period (such information is also available from the Manager on request).

For the relevant Listed Class Units of the relevant Sub-Funds, the near real-time indicative Net Asset Value per Unit in RMB is indicative and for reference only. MANAGEMENT OF THE TRUST

Manager / Listing Agent

The manager and listing agent of each Sub-Fund is Hang Seng Investment Management Limited. The Manager may appoint other investment managers or investment delegates to assist the Manager in managing the Sub-Funds. No such investment manager or investment delegate has yet been appointed as at the date of this offering document.

Hang Seng Investment Management Limited was incorporated in Hong Kong with limited liability in April 1993. It is a wholly-owned subsidiary of Hang Seng Bank Limited (“**Hang Seng Bank**”) and is the investment arm of Hang Seng Bank. It also provides investment management services to Hang Seng Bank and Hang Seng Bank’s customers and has extensive experience in managing index-tracking funds, retirement funds, institutional accounts and private client portfolios.

Founded in 1933, Hang Seng Bank is one of Hong Kong’s largest listed companies. Hang Seng Bank is a principal member of the HSBC Group, one of the world’s largest banking and financial organisations.

Trustee, Custodian and Registrar

The Trustee of the Trust is HSBC Institutional Trust Services (Asia) Limited which was appointed as trustee of the Trust in place of HSBC Provident Fund Trustee (Hong Kong) Limited with effect on and from 1 May 2019. The Trustee is also the custodian of the Trust and each Sub-Fund’s assets and its registrar and provides services in respect of the establishment and maintenance of the register of the Unitholders.

The Trustee is a registered trust company under the Trustee Ordinance (Chapter 29 of the Laws of Hong Kong) and approved by the Mandatory Provident Fund Schemes Authority as trustee of registered MPF schemes under the Mandatory Provident Fund Schemes Ordinance (Chapter 485 of the Laws of Hong Kong). HSBC Institutional Trust Services (Asia) Limited is an indirect wholly-owned subsidiary of HSBC Holdings plc, a public company incorporated in England and Wales.

Under the Trust Deed, the Trustee is responsible for the safe-keeping of the assets of the Trust and each Sub-Fund. The Trustee may also appoint any other person or persons to be the custodian of the Trust and each Sub-Fund’s assets, or jointly with the Manager appoint any other person or persons to act as registrar.

The Trustee may from time to time (1) appoint such person or persons as it thinks fit (including, without limitation, any of its Connected Persons) to hold as custodian, nominee or agent, all or any of the investments, assets or other property comprised in the Trust Fund or any of the sub-funds and may empower any such custodian, nominee or agent to appoint, with the prior consent in writing of the Trustee, co-custodians and/or sub-custodians (each such custodian, nominee, agent, co-custodian and sub-custodian a “**Correspondent**”) and (2) delegate all or any of its duties, powers and discretions under any provisions of the Trust Deed to any person or corporation (including a Connected Person of the Trustee) approved by the Manager. The Trustee is required to (a) exercise reasonable care, skill and diligence in the selection, appointment and ongoing monitoring of Correspondents and delegates and (b) be satisfied that each Correspondent or delegate retained remain suitably qualified and competent on an ongoing basis to provide the relevant services to the relevant Sub-Fund. The Trustee shall be liable for the acts and omissions of any Correspondent and of any delegate which is a Connected Person of the Trustee as if the same were the acts or omissions of the Trustee. Provided that the Trustee has discharged its obligations set out in (a) and (b) as set out in this paragraph, the Trustee shall not be liable for any act, omission, insolvency, liquidation or bankruptcy of any Correspondent and of any delegate which is not a Connected Person of the Trustee.

The Trustee shall not be liable for: (i) any agents and persons appointed by the Manager; (ii) any depositary or clearing system in relation to any security deposited with such depositary or clearing system; (iii) any Registrar (other than where the Trustee is the Registrar), Participating Dealers, counterparties, third party service providers and advisers (including any third party service providers appointed to provide service in respect of the Trust at the instruction of the Manager, where the Trustee is not involved in the selection of such service providers).

Subject as provided in the Trust Deed, the Trustee shall not be liable for losses caused by the performance of investments made by the Trust and/or a Sub-Fund.

Subject to the terms of the Trust Deed, the Trustee is entitled to be indemnified from the assets of the Trust and/or a Sub-Fund from and against any action, costs, claims, damages, expenses or demands relating to the relevant Sub-Fund (other than those arising out of any liability or obligation to unitholders imposed on the Trustee pursuant to the laws of the Hong Kong or the Trust Deed or for breach of trust through its fraud or negligence) to which it may be put as Trustee to have recourse to the assets of the relevant Sub-Fund or any part thereof but shall not have a right of recourse to the assets of any other sub-fund under the Trust (if any).

The Trustee in no way acts as guarantor or offeror of the Units or any underlying investment.

The Trustee will not participate in transactions and activities, or make any payments denominated in US dollars, which, if carried out by a US person, would be subject to sanctions by The Office of Foreign Assets Control (the "OFAC") of the US Department of the Treasury. The OFAC administers and enforces economic sanction programs primarily against countries and groups of individuals, such as terrorists and narcotics traffickers by using the blocking of assets and trade restrictions to accomplish foreign policy and national security goals. In enforcing economic sanctions, OFAC acts to prevent "prohibited transactions," which are described by OFAC as trade or financial transactions and other dealings in which US persons may not engage unless authorised by OFAC or expressly exempted by statute. OFAC has the authority to grant exemptions to prohibitions on such transactions, either by issuing a general licence for certain categories of transactions, or by specific licences issued on a case-by-case basis. HSBC group of companies has adopted a policy of compliance with the sanctions issued by OFAC. As part of its policy, the Trustee may request for additional information if deemed necessary.

The appointment of the Trustee may be terminated in the circumstances set out in the Trust Deed.

The Trustee is entitled to the fees set out in "Fees and Expenses Payable by a Sub-Fund" in the "FEES AND EXPENSES" section and to be reimbursed for all costs and expenses in accordance with the provisions of the Trust Deed.

The Manager has sole responsibility for making investment decisions in relation to the Trust and/or a Sub-Fund and subject to the terms of the Trust Deed and the requirements of the Code, the Trustee (including its delegate) is not responsible and has no liability for any investment decision made by the Manager. Except as provided in the Trust Deed or expressly stated in this offering document and/or required by the Code, neither the Trustee nor any of its employees, service providers or agents are or will be involved in the business affairs, organisation, sponsorship or investment management of the Trust or a Sub-Fund, and they are not responsible for the preparation or issue of this offering document other than their description under this section.

Conversion Agent or Service Agent (applicable in respect of Listed Class Units only)

The Conversion Agent or Service Agent (as applicable) in respect of the Sub-Funds is HK Conversion Agency Services Limited ("HKCAS"), a wholly-owned subsidiary of Hong Kong Exchanges and Clearing Limited. Where applicable as set out in the respective Appendix for the relevant Sub-Fund, the HKCAS performs services as conversion agent under the terms of the Conversion Agency Agreement entered into among the Manager, the HKCAS and HKSCC in connection with the in-kind creation and in-kind redemption of Listed Class Units by Participating Dealers, and/or as service agent under the terms of each Service Agreement entered into among the Trustee, the Manager, the Registrar, the Participating Dealer, the agent of the Participating Dealer (if applicable), the HKCAS and HKSCC in connection with the cash creation and cash redemption of Listed Class Units by Participating Dealers.

Participating Dealers (applicable in respect of Listed Class Units only)

A Participating Dealer is a broker or dealer who acts (or who has appointed an agent or delegate who acts) for its own account or for the account of its clients to make creation and redemption applications in respect of the Listed Class Units of a Sub-Fund for a large minimum number of Listed Class Units (or multiples thereof), as specified in the relevant Appendix. The latest list of the Participating Dealers which offers Listed Class Units is available at www.hangsenginvestment.com (*this website has not been reviewed by the SFC*).

Market Makers (applicable in respect of Listed Class Units only)

A Market Maker is a broker or dealer permitted by the SEHK to act as such by making a market for the Listed Class Units in the secondary market and whose obligations include quoting bid prices to potential sellers and offer prices

to potential buyers when there is a wide spread between the prevailing bid prices and offer prices for the Listed Class Units on the SEHK. Market Makers facilitate the efficient trading of Listed Class Units by providing liquidity in the secondary market when it is required, in accordance with the market making requirements of the SEHK. If the SEHK withdraws its permit to the existing Market Maker(s), the Manager will endeavour to ensure that there is at least one other Market Maker for each Sub-Fund which offers Listed Class Units or counter (as appropriate) to facilitate the efficient trading of such Units of the relevant eligible currency. The latest list of Market Makers for each Sub-Fund which offers Listed Class Units is available at www.hkex.com.hk (*this website has not been reviewed by the SFC*). Please refer to the section headed “**References to Websites**” for the warning and the disclaimer regarding information contained in such website.

Hang Seng Data Services Limited

Hang Seng Data Services Limited (“**HSDS**”) is the proprietor and absolute owner of all of the goodwill, rights, title and interest in the name and mark of the Index and has granted a licence in respect of the use of such name and mark to Hang Seng Indexes Company Limited (“**HSIL**”), which manages and compiles the relevant Indices and is the index provider to the HSCEI ETF and HSTECH ETF. Additional information about HSIL is available at www.hsi.com.hk (*this website has not been reviewed by the SFC*). Please refer to the section headed “References to Websites” for the warning and the disclaimer regarding information contained in such website.

Conflicts of Interest that may apply to the Sub-Funds

The Manager and the Trustee may from time to time act as trustee, administrator, registrar, secretary, manager, custodian, investment manager or investment delegate (as the case may be) or provide other services in relation to, or be otherwise involved in or with, other funds and clients which have a similar investment objective to the Trust and the Sub-Funds. It is possible that in the course of business, the connected persons to the Manager and/or the Trustee may have potential conflicts of interest with a Sub-Fund. If such conflicts arise, the Manager will use its best efforts to ensure that Unitholders are treated fairly.

The Manager, any investment delegate or any of their Connected Persons may enter into transactions with the Trust and the Sub-Funds as principal.

Such transactions will be disclosed in the relevant Sub-Fund’s audited annual report and shall only be made with the prior written consent of the Trustee except where such transactions are (i) unit creation or redemption applications or (ii) an investment in a Collective Investment Scheme managed by the Manager or the connected persons to it, conducted at the prevailing Net Asset Value of the relevant Sub-Fund or, as the case may be, the prevailing net asset value of the Collective Investment Scheme, on no more favourable terms and conditions than those available to any other person.

The Manager, the Trustee and persons connected to the Manager and/or the Trustee may have banking or other financial relationships with a company whose shares are an Index Constituent Stock.

The Manager, the Trustee and persons connected to the Manager and/or the Trustee may hold and deal in Units or in investments held by a Sub-Fund either for their own account or for the account of their customers.

Monies for the account of a Sub-Fund can be borrowed from any of the Trustee, the Manager, any investment delegate or any of their Connected Persons (being a bank) provided that such person shall charge interest at no higher rate, and any fee for arranging or terminating the loan is of no greater amount, than is in accordance with its normal banking practice at the rate for a commercial loan of the size and nature of the loan in question negotiated at arm’s length.

Any arrangements for deposit of any monies for the account of the relevant Sub-Fund may be made with any of the Trustee, the Manager, any investment delegate or any of their Connected Persons being an institution licensed to accept deposits provided that such cash deposit shall be maintained in a manner that is in the best interests of the Unitholders having regard to the prevailing commercial rate for a deposit of similar type, size and term negotiated at arm’s length in accordance with the ordinary and normal course of business.

The index provider to the HSCEI ETF and HSTECH ETF, HSIL, and the index proprietor, HSDS are both members of the HSBC group of companies.

The operating parties (including the Manager, the Trustee, Participating Dealers and Market Makers) may have banking or other financial relationships with each other. Situations may arise where there are conflicts of interest among such entities. If such conflicts arise, the Manager will use its best efforts, to ensure that Unitholders are treated fairly.

The Manager is also the manager of the Hang Seng China Enterprises Index Fund under the Hang Seng Investment Series and the investment manager of the Hang Seng China Enterprises Index Tracking Fund under the Hang Seng and HSBC MPF schemes.

Subject to applicable rules and regulations, the Manager, its delegate or any of its connected persons may enter into portfolio transactions for or with each Sub-Fund as agent in accordance with normal market practice, provided that commissions charged to each Sub-Fund in these circumstances do not exceed customary full service brokerage rates. If a broker does not provide research or other lawful services in addition to brokerage execution, such broker will generally charge a brokerage commission that is discounted from customary full service brokerage rates. For so long as the relevant Sub-Fund is authorised by the SFC and it is an applicable requirement of the Code, the Manager, if transacting with brokers or dealers connected to the Manager, investment delegates or any of their respective connected persons, must ensure it complies with the following obligations:

- (a) such transactions should be on arm's length terms;
- (b) it must use due care in the selection of brokers or dealers and ensure that they are suitably qualified in the circumstances;
- (c) transaction execution must be consistent with applicable best execution standards;
- (d) the fee or commission paid to any such broker or dealer in respect of a transaction must not be greater than that which is payable at the prevailing market rate for a transaction of that size and nature;
- (e) the Manager must monitor such transactions to ensure compliance with its obligations; and
- (f) the nature of such transactions and the total commissions and other quantifiable benefits received by such broker or dealer shall be disclosed in the annual report of the relevant Sub-Fund.

The Manager will take all reasonable steps to identify, prevent, manage and monitor any actual or potential conflicts of interest, including conducting all transactions in good faith at arm's length and in the best interest of each Sub-Fund on normal commercial terms.

TAXATION

The following summary is of a general nature, for information purposes only, and is not intended to be an exhaustive list of all of the tax considerations that may be relevant to a decision to purchase, own, redeem or otherwise dispose of Units. This summary does not constitute legal or tax advice and does not purport to deal with the tax consequences applicable to all categories of investors. Prospective investors should consult their own professional advisers as to the implications of their subscribing for, purchasing, holding, redeeming or disposing of Units under the laws and practice of Hong Kong, the PRC and the laws and practice of other relevant jurisdictions. The information below is based on the law and practice in force in the relevant jurisdictions at the date of this offering document (save as otherwise specified). The relevant laws, rules and practice relating to tax are subject to change and amendment (and such changes and amendments may be made on a retrospective basis). As such, there can be no guarantee that the summary provided below will continue to be applicable after the date of this offering document/the date on which the advice regarding the law and practice in force in the relevant jurisdictions was received. Furthermore, tax laws can be subject to different interpretations and no assurance can be given that relevant tax authorities will not take a contrary position to the tax treatments described below.

Taxes and Duties Payable by the Trust and the Sub-Funds

The information below regarding taxation and duties is based on the law and practice in force in Hong Kong and in the PRC at the date of this offering document.

Hong Kong

Profits Tax

As the Trust and each Sub-Fund are Authorised Funds, profits of the Trust and each Sub-Fund arising from the sale or disposal of securities, net investment income received by or accruing to the Trust and each Sub-Fund and all other profits of the Trust and each Sub-Fund are exempt from Hong Kong profits tax.

Stamp Duty

Pursuant to a remission order issued by the Secretary for the Treasury of Hong Kong on 20 October 1999, any Hong Kong stamp duty (i.e. fixed and ad valorem) on the transfer of a Basket to a Sub-Fund by an investor as consideration for an allotment of Units will be remitted or refunded. Similarly, Hong Kong stamp duty on the transfer of a Basket by a Sub-Fund to an investor upon redemption of Units will also be remitted or refunded.

No Hong Kong stamp duty is payable by each Sub-Fund on an issue or redemption of Units in cash.

The sale and purchase of the Index Constituent Stocks by a Sub-Fund will be subject to Hong Kong stamp duty at the current rate of 0.2% of the price of the Hong Kong stocks being sold and purchased. The relevant Sub-Fund will be liable to one half of such Hong Kong stamp duty.

The PRC

Investors should consult their own tax advisors regarding the possible PRC tax implications on an investment in the Sub-Fund(s) (including capital gains thereon) with respect to their own situation.

Corporate Income Tax

Under current PRC Corporate Income Tax Law and regulations, if the Trust or a Sub-Fund is considered as a PRC tax resident enterprise, it will be subject to PRC Corporate Income Tax (“**CIT**”) at the rate of 25% on its worldwide taxable income. If the Trust or a Sub-Fund is considered as a non-PRC tax resident enterprise with an establishment or place of business (a “**PE**”) in the Mainland, the profits attributable to that PE would be subject to CIT.

The Manager intends to manage and operate the Trust and each Sub-Fund in such a manner that the Trust and each Sub-Fund should not be treated as a PRC tax resident enterprise or non-PRC tax resident enterprise with a PE in the Mainland for CIT purposes, although this cannot be guaranteed.

Unless a specific exemption or reduction is available under current PRC tax laws and regulations or relevant tax

treaties, non-PRC tax resident enterprises without a PE in the Mainland are subject to CIT on a withholding basis (“WIT”), generally at a rate of 10% (such rate may however be subject to change from time to time), to the extent it directly derives the PRC sourced passive income. PRC sourced passive income (such as dividend income) may arise from investments in the H-Shares, certain Red-chips and/or certain P-chips. Accordingly, the Trust or the Sub-Funds may be subject to WIT on any cash dividends it receives from its investment in H-Shares, certain Red-chips and/or certain P-chips. Such WIT will reduce the income from the relevant Sub-Fund and adversely affect the performance of such Sub-Fund. The entity distributing or paying such PRC sourced passive income is required to withhold such tax. The Manager reserves the right to make relevant provision on dividends if the WIT is not withheld at source.

There are still uncertainties as to the application of the PRC CIT Law and its implementation rules. It is also uncertain as to whether a Sub-Fund may be subject to other taxes imposed in the Mainland in respect of its investments. It is possible that the current tax laws, rules, regulations and practice in the Mainland and/or the current interpretation or understanding thereof may change in the future and such change(s) may have retrospective effect. A Sub-Fund could become subject to additional taxation that is not anticipated as at the date hereof or when the investments are made, valued or disposed of. Any of those changes may reduce the income from, and/or the value of, that Sub-Fund’s investments. Any increased tax liabilities on that Sub-Fund may adversely affect that Sub-Fund’s value.

Where no provision is made by the Manager in relation to all or part of the actual tax levied by the relevant PRC tax authorities in future, investors should note that the Net Asset Value of a Sub-Fund may be lowered, as the Sub-Fund will ultimately have to bear the full amount of tax liabilities. In this case, such amount of tax liabilities will only impact Units in issue at the relevant time, and the then existing Unitholders and subsequent Unitholders will be disadvantaged. The Manager reserves the right to provide for WIT and to deduct or to withhold the tax for the account of the relevant Sub-Fund so warranted.

Value-Added Tax

With the Circular Caishui [2016] No. 36 (“**Circular 36**”) promulgated by the Ministry of Finance and the State Administration of Taxation of the PRC on 23 March 2016 regarding the final stage of PRC Value-Added Tax (“**VAT**”) reform which came into effect on 1 May 2016, gains derived from the trading of PRC securities will be subject to VAT instead of PRC Business Tax starting from 1 May 2016. If VAT is applicable, there may also be other surtaxes.

There are still uncertainties as to the application of the rules and regulations on the VAT and its surtaxes (e.g. it is not clear as to whether gains realised on the disposals of a Sub-Fund’s investments in H-Shares, certain Red-chips and certain P-chips would be subject to VAT and its surtaxes). Where no provision is made by the Manager in relation to all or part of the actual taxes levied by the relevant PRC tax authorities in future, investors should note that the Net Asset Value of a Sub-Fund may be lowered, as the Sub-Fund will ultimately have to bear the full amount of tax liabilities. In this case, such amount of tax liabilities will only impact Units in issue at the relevant time, and the then existing Unitholders and subsequent Unitholders will be disadvantaged. The Manager reserves the right to provide for VAT and its surtaxes and to deduct or to withhold the taxes for the account of a Sub-Fund if so warranted.

Please refer to the risk factor “PRC tax risk” under “What are the Risks of Investing in the HSCEI ETF?” for further information in this regard.

Taxes and Duties Payable by Investors

You should consult your professional advisers on the consequences to you of acquiring, holding, redeeming, transferring or selling Units under the relevant laws of the jurisdictions to which you are subject, including the tax consequences and any exchange control requirements. The consequences, including the availability of, and the value of, tax relief will vary with the law and practice of your country of citizenship, residence, domicile or incorporation and your personal circumstances.

The information below regarding taxation and duties is based on the law and practice in force in Hong Kong at the date of this offering document. You should be aware that levels and bases of taxation are subject to change and that the value of any relief from taxation depends upon your personal circumstances. The following statements are intended as a general guide only and do not necessarily describe the tax consequences for all types of investors in the Sub-Funds.

Hong Kong

Profits Tax

Hong Kong profits tax is not payable by the investors in respect of profits from the purchase and sale of Units effected outside Hong Kong, profits in the nature of capital gains rather than trading profits and income or profits otherwise exempt under the Inland Revenue Ordinance (Chapter 112 of the Laws of Hong Kong).

There is generally no capital gains tax payable on the sale of the Units, save and except that where a person is or is deemed as carrying on a trade, profession or business in Hong Kong, gains or profits on the sale of the Units may be treated as normal trading receipts from that trade, profession or business and thus attract Hong Kong profits tax.

Distributions to the Unitholders are not subject to withholding taxes in Hong Kong.

Stamp Duty in respect of Listed Class Units

Pursuant to a remission order issued by the Secretary for the Treasury of Hong Kong on 20 October 1999, any Hong Kong stamp duty (i.e. fixed and ad valorem) on the transfer of a Basket to a Sub-Fund by an investor as consideration for an allotment of Listed Class Units will be remitted or refunded. Similarly, Hong Kong stamp duty on the transfer of a Basket by a Sub-Fund to an investor upon redemption of Listed Class Units will also be remitted or refunded.

No Hong Kong stamp duty is payable by an investor in relation to an issue of Listed Class Units (both RMB traded and HKD traded Listed Class Units) to him or her or the redemption of Listed Class Units (both RMB traded and HKD traded Units) by him or her or on the sale and purchase of Listed Class Units (both RMB traded and HKD traded Units) by him or her in the secondary market.

Stamp Duty in respect of Unlisted Class Units

No Hong Kong stamp duty should be payable where the sale or transfer of the Unlisted Class Units is effected by selling the relevant Units back to the Manager, who then either extinguish the Unlisted Class Units or re-sells the Unlisted Class Units to another person within two months thereof. Other types of sales or purchases or transfers of Unlisted Class Units by the Unitholders in a Sub-Fund should normally be liable to Hong Kong stamp duty of 0.2 per cent (equally borne by the buyer and the seller) on the higher of the consideration amount or market value and where instrument of transfer (if any) is executed in relation to any such sales or purchases or transfers, Hong Kong stamp duty is payable at the fixed rate of HK\$5 on each instrument of transfer (if any) executed.

Subscription of Unlisted Class Units/switching into Unlisted Class Units effected through allotment of new Unlisted Class Units and redemption/switching out effected through cancellation of Unlisted Class Units respectively will normally not be subject to Hong Kong stamp duty.

Automatic Exchange of Financial Account Information

The Inland Revenue (Amendment) (No.3) Ordinance 2016 (the “**Amendment Ordinance**”), which is the legislative framework for the implementation of Automatic Exchange of Financial Account Information (the “**AEOI**”) in Hong Kong, came into force on 30 June 2016.

The AEOI is a new system that involves the transmission of financial account information from Hong Kong to an overseas tax jurisdiction with which Hong Kong has entered into an AEOI agreement¹. Under the Amendment Ordinance, reporting financial institutions in Hong Kong are required to apply due diligence procedures to identify the tax residency of the account holders and controlling persons for the purpose of AEOI² and collect the specified

information. The financial institution is required to report to the Inland Revenue Department (the “**IRD**”) the required information collected in respect of the reportable accounts on an annual basis. IRD will then transmit the information to the tax administration of the relevant jurisdiction of which the account holder is tax resident³. Under the Amendment Ordinance, information that may be reported to the IRD includes details of account holders, including but not limited to their name, date of birth, place of birth (if any), address, jurisdiction of tax residence, tax identification number (if any), account number, account balance/value, distribution income and sales/redemption proceeds.

Each Sub-Fund, as a reporting financial institution, is required to, amongst other things:

- (i) conduct due diligence on its financial accounts to identify whether any such accounts are considered as “Reportable Accounts” for AEOI purpose; and
- (ii) report to the IRD the required information on such Reportable Accounts.

By investing and/or continuing to invest in the Sub-Funds, Unitholders acknowledge that:

- (i) the IRD may automatically exchange information of the Unitholders (and information on controlling persons including beneficial owners, beneficiaries, direct or indirect shareholders or other persons associated with such Unitholders that are passive non-financial entities) as outlined above with relevant tax authorities in other jurisdictions;
- (ii) Unitholders may be required to provide additional information and/or documentation for AEOI purpose; and
- (iii) in the event that an Unitholder fails to provide the requested information and/or documentation, irrespective of whether or not that actually leads to non-compliance on the part of the Sub-Fund(s) and/or the Manager, the Manager reserves the right to take remedial actions including, without limitation, to require the Unitholder to transfer the Unitholder’s Units or, failing such transfer, redeem such Units in accordance with the Trust Deed, and to the extent permitted by applicable laws and regulations.

Unitholders and prospective investors should consult their professional advisers and obtain independent professional advice on the implications of AEOI on their current and/or proposed investment in a Sub-Fund.

The United States of America – Foreign Account Tax Compliance Act (FATCA)

Sections 1471 through 1474 of the U.S. Internal Revenue Code (“**FATCA**”) impose a 30% withholding tax on certain payments to a foreign financial institution (“**FFI**”) if that FFI is not compliant with FATCA. Each of the Sub-Funds is a FFI and thus, subject to FATCA. Each Sub-Fund in the Trust intends to comply with FATCA by qualifying as a Deemed-Compliant FFI.

This withholding tax applies to payments to each Sub-Fund that constitute interest, dividends and other types of income from U.S. sources (such as dividends paid by a U.S. corporation).

These FATCA withholding taxes may be imposed on payments to a Sub-Fund unless (i) the relevant Sub-Fund becomes FATCA compliant pursuant to the provisions of FATCA and the relevant regulations, notices and announcements issued thereunder, or (ii) the relevant Sub-Fund is subject to an appropriate Intergovernmental Agreement to improve international tax compliance and to implement FATCA (“**IGA**”). The Sub-Funds intend to comply with FATCA so that no FATCA withholding is imposed on any payments to the Sub-Funds.

Hong Kong and the U.S. have entered into an IGA for the implementation of FATCA, adopting “Model 2” IGA arrangements. Under these “Model 2” IGA arrangements, FFIs in Hong Kong (such as the Sub-Funds) will be required to register with the U.S. Internal Revenue Service (“**IRS**”) and comply with the terms of the FFI Agreement. Otherwise, they will be subject to a 30% withholding tax on relevant US-sourced payments to them. As a sponsoring entity, the Manager has registered with the U.S. IRS on behalf of each Sub-Fund. Each Sub-Fund intends to take any other measures that may be required to ensure compliance under the terms of the IGA and local implementing regulations.

In order to comply with its FATCA obligations, each Sub-Fund is required to obtain certain information from its Unitholders so as to ascertain their U.S. tax status, including the appropriate IRS withholding statement on Form W-8 or W-9. If the Unitholder is a specified U.S. person, U.S. owned non-U.S. entity, non-participating FFI (“NPFFI”) or does not provide the requisite documentation, each Sub-Fund may need to report information on these Unitholders to the appropriate tax authority, as far as legally permitted.

If a Unitholder either fails to provide the relevant Sub-Fund, its agents or authorised representatives with any correct, complete and accurate information that may be required for the Sub-Fund to comply with FATCA or is a NPFFI, to the extent that it is required to comply with the terms of the IGA, the Unitholder may be subject to withholding on amounts otherwise distributable to the Unitholder (provided that the Manager or the Trustee shall observe relevant legal requirements and shall act in good faith and on reasonable grounds). The Sub-Fund may at its discretion enter into any supplemental agreement without the consent of Unitholders to provide for any measures that the Sub-Fund deem appropriate or necessary to comply with FATCA.

Other countries have adopted or are in the process of adopting tax legislation concerning the reporting of information, including AEOI as described above. Each of the Sub-Funds also intends to comply with such other similar tax legislation that may apply to each Sub-Fund, although the exact parameters of such requirements are not yet fully known. As a result, each Sub-Fund may need to seek information about the tax status of Unitholders under such other country’s laws and each Unitholder for disclosure to the relevant governmental authority.

The disclosure in this section is based on advice received by the Trust regarding the law and practice in force in the U.S. as at 8 November 2019. Unitholders/Investors should consult their own tax advisors regarding the FATCA requirements with respect to their own situation. In particular, investors who invest in a Sub-Fund through intermediaries should confirm the FATCA compliance status of those intermediaries to ensure that they do not suffer FATCA withholding tax on their investment returns.

Although each Sub-Fund will attempt to satisfy any obligations imposed on it to avoid the imposition of the FATCA withholding tax, no assurance can be given that the Sub-Fund will be able to satisfy these obligations. If the Sub-Fund becomes subject to a withholding tax as a result of the FATCA regime, the value of the Units held by Unitholders may suffer material losses.

STATUTORY AND GENERAL INFORMATION

Trust Deed and Participation Agreements

The Trust and each Sub-Fund were established under Hong Kong law by the Trust Deed. There are a number of Participating Dealers for each Sub-Fund and each has entered into a Participation Agreement. All investors are entitled to the benefit of, are bound by and are deemed to have notice of, the provisions of the Trust Deed and those in the form of the Participation Agreement. In the event of any inconsistency between any of the provisions of this offering document (including the Product Key Facts Statement for each Sub-Fund) and those of the Trust Deed or of the form of Participation Agreement, the provisions of the Trust Deed or of the form of Participation Agreement shall prevail. The Trust Deed contains provisions for the indemnification of the Trustee and the Manager and their relief from liability in certain circumstances. You should refer to the relevant terms of the Trust Deed for further details.

Supply and Inspection of Documents

You may inspect a copy of a Sub-Fund's constitutive documents, including the Trust Deed, and its agreement(s) with the HKCAS and the form of the Participation Agreement free of charge at any time during normal business hours on any day (excluding Saturdays, Sundays and public holidays) at the office of the Manager, 83 Des Voeux Road Central, Hong Kong and copies may be purchased at that address on payment of a reasonable fee.

Material Changes to an Index

The SFC should be consulted on any events that may affect the acceptability of an Index. Significant events relating to an Index will be notified to the Unitholders as soon as practicable. These may include a change in the methodology or rules for compiling or calculating the Index, or a change in the objective or characteristics of the relevant Index.

Replacement of an Index

The Manager reserves the right, with the prior consent of the Trustee and the prior approval of the SFC and any other relevant regulator(s) and provided that in its opinion the interests of the Unitholders would not be adversely affected, to replace an Index with another index that is tradable and has similar objectives to the relevant Index, in accordance with the provisions of the Code and the Trust Deed. The circumstances under which any such replacement might occur include but are not limited to the following events:

- (a) the relevant Index is discontinued; or
- (b) the Manager's licence from the Index Proprietor and Index Provider to use the relevant Index is terminated.

The Manager may change the name of a Sub-Fund if the relevant Index changes or for any other reasons including if licence to use the relevant Index is terminated. Any change to (i) the use by a Sub-Fund of the Index and/or (ii) the name of a Sub-Fund will be notified to Unitholders.

General Information

Anti-Money Laundering Regulations

As part of the Trustee's and the Manager's responsibility to prevent money laundering, they may require detailed verification of your identity and the source of your payment for any investment in Units.

The Codes on Takeovers and Mergers and Share Repurchases

You should be aware that any shareholding of Index Constituent Stocks resulting from an "in-kind" redemption of Units may be subject to the application of the Hong Kong Takeovers Code. In circumstances where you hold a significant amount of Index Constituent Stocks you should consult a solicitor or financial adviser so as to ensure full compliance with the Hong Kong Takeovers Code.

Notices to Investors

With the prior consent of the SFC and the SEHK (as the case may be), notice of general matters may be given to investors in the Units by publication on www.hangsenginvestment.com (*this website has not been reviewed by the SFC*) and via the SEHK's website www.hkex.com.hk (*this website has not been reviewed by the SFC*) in respect of the Listed Class Units. In all other cases, as required by the SFC, notices will be sent to investors by post to their mailing address or, if approved by the SFC and agreed with the relevant investors, by electronic mail, electronic publication or other electronic means.

Meetings of Investors

The Trust Deed provides for meetings of investors to be convened by the Trustee or the Manager upon at least 21 days' notice.

Proxies may be appointed. The quorum at any meetings is investors present in person or by proxy holding not less than 10% (or, in relation to a resolution proposed as an extraordinary resolution, 25%) of the Units in the relevant Class or the relevant Sub-Fund then in issue. If a quorum is not present, the meeting will be adjourned for not less than 15 days. At an adjourned meeting investors in the Units who are present at the adjourned meeting, whatever their number or the number of units held by them, will form a quorum.

An extraordinary resolution is required under the Trust Deed for certain purposes and is a resolution proposed as such and passed by 75% or more of the total number of votes cast.

The Trust Deed provides that at any meeting of investors in the Units, on a poll, every investor who (being an individual) is present in person or (being a partnership or corporation) is present by an authorised representative shall have one vote for every unit of which he is the holder.

Responsibility Statement

The Manager accepts full responsibility for the accuracy of the information contained in this offering document (including the Product Key Facts Statement for each Sub-Fund) as at the date of publication and confirms, having made all reasonable enquiries, that to the best of its knowledge and belief there are no other facts the omission of which would make any statement misleading. For a Sub-Fund which issues both Listed Class Units and Unlisted Class Units, a separate set of Product Key Facts Statement will be available for the Listed Class Units and Unlisted Class Units.

Termination

The Trust may be terminated by the Trustee in the following circumstances:

- (a) if the Manager shall go into liquidation (except a voluntary liquidation for the purpose of reconstruction or amalgamation upon terms previously approved in writing by the Trustee) or if a receiver is appointed over any of its assets and is not discharged within 60 days;
- (b) if in the opinion of the Trustee the Manager shall be incapable of performing or shall in fact fail to perform its duties satisfactorily or shall do any other thing which in the opinion of the Trustee is calculated to bring the Trust into disrepute or to be harmful to the interests of investors;
- (c) if any law shall be passed which renders it illegal or in the opinion of the Trustee impracticable or inadvisable to continue the Trust;
- (d) if the Manager shall have ceased to be the Manager and, within a period of 30 days thereafter, no other person acceptable to the SFC shall have been appointed by the Trustee as successor Manager; or
- (e) if the relevant Index of the Sub-Funds is discontinued or the Manager's license with the index provider and index proprietor is terminated or if the Listed Class Units cease to be listed on the SEHK.

The Trust and/or a Sub-Fund may be terminated by the Manager in the following circumstances;

- a) if the aggregate Net Asset Value of all Units outstanding of the Trust shall be less than HK\$10,000,000 or, if the aggregate Net Asset Value of the Units of the relevant Sub-Fund shall be less than HK\$4,000,000;
- b) if the Trust and/or the relevant Sub-Fund (as the case may be) ceases to be authorised pursuant to the Securities and Futures Ordinance; or
- c) if any law shall be passed which renders it illegal or in the opinion of the Manager impracticable or inadvisable to continue the Trust and/or any Sub-Fund.

Any unclaimed proceeds or other cash held by the Trustee under the provisions in the event of termination may at the expiration of twelve months from the date upon which the same became payable be paid into court subject to the right of the Trustee to deduct therefrom any expenses it may incur in making such payment.

Investors should note that, due to the nature of the listing of the Listed Class Units on the SEHK, the termination procedures applicable to Listed Class Units and Unlisted Class Units of the same Sub-Fund may differ. In the event of termination of the Trust, a Sub-Fund or a particular Class of Units, Unitholders will be notified of the relevant termination procedures applicable to its holding of the relevant Class of Units.

What is the HSCEI ETF?

The HSCEI ETF is the first sub-fund of the Trust and was established on 19 November 2003.

The HSCEI ETF is an index-tracking fund that seeks to provide investment returns for investors that match the performance of the Hang Seng China Enterprises Index as closely as practicable. The Manager intends to adopt a replication strategy to pursue this objective.

The Index tracks the performance of Mainland securities listed in Hong Kong including H-Shares, Red-chips and P-chips.

Trading of Units

Units in the HSCEI ETF are denominated in HKD. Investors may:

- (1) purchase and sell Units in the secondary market on the SEHK in board lot of 200 Units (or multiples thereof) either in HKD in respect of HKD traded Units or in RMB in respect of RMB traded Units under the Dual Counter;
- (2) apply for in-kind creation and redemption through Participating Dealers in a minimum number of 100,000 Units (or multiples thereof); and/or
- (3) apply for cash creation or redemption through Participating Dealers in a minimum number of 100,000 Units (or multiples thereof), subject to the Manager's absolute discretion to decide whether to accept a cash creation application or cash redemption application.

For the HS Funds, special creations and redemptions for the Units (both in cash and in-kind) through the Manager are available.

Is an investment in the HSCEI ETF suitable for me?

The answer really depends on an assessment of your own circumstances. You should satisfy yourself that the HSCEI ETF is suitable for you having regard to your own circumstances, including your financial situation, investment experience and investment objectives, before making any decision to invest in the HSCEI ETF. Please note that the decision whether or not to invest remains with you. If you have any doubt as to whether or not the HSCEI ETF is suitable for you, you should consult your investment adviser and obtain independent professional advice.

By way of background, the HSCEI ETF has been established for investors seeking a relatively inexpensive and passive means of investing in a portfolio of H-Shares, Red-chips and P-chips. In tracking the Index, the HSCEI ETF is investing in companies which have major business exposure to growth opportunities in the Mainland.

You should carefully consider the risks involved in investing in the HSCEI ETF together with all other information included in this offering document before making an investment decision. Please specifically see the section headed "What are the Risks of Investing in the HSCEI ETF?".

In addition, you should avoid excessive investment in any single type of investment (in terms of its proportion of your overall portfolio) including any proposed investment in Units so as to avoid having your investment portfolio being over-exposed to any particular investment risk.

What is the Investment Objective of the HSCEI ETF?

The HSCEI ETF is an index-tracking fund tracking the performance of the Index, as more fully described below.

The investment objective of an index-tracking fund is to match, before expenses, as closely as practicable, the performance of an underlying index against which the index-tracking fund is benchmarked.

A stock index tracks the performance of the Index Securities which an index provider selects as representative of a market, specific industry sector or market segment.

The index provider calculates the relative weightings of the group of Index Securities in an index according to the index methodology and publishes the information regarding the market value of the index.

The HSCEI ETF seeks to provide investment returns that match as closely as practicable the performance of the Index. For more information about the Index and the Index Constituent Stocks, please see section headed "(B) Information about the Index" below.

What Investment Strategy is used by the HSCEI ETF?

The Manager primarily adopts a replication strategy.

In order to maximise portfolio management efficiency, minimise transaction costs and tracking error, exposure to the Index may also be obtained through other index-tracking strategies or FDIs from which the return to the HSCEI ETF substantially reflects the performance of the Index. Such strategies and instruments are chosen based on their correlation to the Index and cost efficiency in order to reflect the characteristics of the Index. Hence, the Manager may decide to utilise a representative sampling strategy or another investment strategy from time to time to achieve the HSCEI ETF's investment objective.

If a representative sampling strategy is implemented by the Manager, the Manager will apply such strategy in accordance with the HSCEI ETF's investment restrictions (please see the section headed "**Are there any Investment or other Restrictions Applicable to the HSCEI ETF?**") thereby enabling the Manager to overweight the Index Constituent Stocks relative to their respective weightings in the Index in accordance with the below limits.

Note:

Disclosures will be made in the HSCEI ETF's financial reports whether the above limits have been complied in full.

Are there any Investment or other Restrictions Applicable to the HSCEI ETF?

Yes. Please refer to Schedule 1 – Investment Restrictions, Security Lending and Borrowing of this offering document.

What are the Risks of Investing in the HSCEI ETF?

In addition to the risk factors presented in Part 1 of this offering document, the risk factors set forth below are, in the opinion of the Manager, also considered to be relevant and presently applicable to the Sub-Fund.

Dual Counter risk

The SEHK's Dual Counter model in Hong Kong is relatively recent. The HSCEI ETF is an exchange traded fund with Dual Counter traded Units, which means that Units are traded and settled in RMB under the RMB counter and traded and settled in HKD under the HKD counter. The nature of the Dual Counter for exchange traded funds may make investment in the Units riskier than in single counter units or shares of an SEHK listed issuer, for example where for some reason there is a settlement failure on an inter-counter transfer if the Units of one counter are delivered to CCASS at the last settlement on a trading day, leaving insufficient time to transfer the Units to the other counter for settlement on the same day.

In addition, where there is a suspension of the inter-counter transfers of Units between the HKD counter and the RMB counter due to, for example, operational or systems interruption, Unitholders will only be able to trade their Units in the currency of the relevant counter. Accordingly it should be noted that the inter-counter transfers may not always be available.

There is a risk that the market price on the SEHK of Units traded in HKD may deviate significantly from the market price on the SEHK of Units traded in RMB due to market liquidity, supply and demand in each counter and the exchange rate between the RMB and the HKD (in both the onshore and the offshore markets). The trading price of HKD traded Units or RMB traded Units is determined by market forces and so will not be the same as the trading price of Units multiplied by the prevailing rate of foreign exchange. Accordingly when selling Units traded in HKD or buying Units traded in HKD, an investor may receive less or pay more than the equivalent amount in RMB if the trade of the relevant Units is in RMB and vice versa. There can be no assurance that the price of Units in each counter will be equivalent.

Investors without RMB accounts may buy and sell HKD traded Units only. Such investors will not be able to buy or sell RMB traded Units.

It is possible that some brokers and CCASS Participants may not be familiar with and may not be able to (i) buy Units in one counter and to sell Units in the other, (ii) carry out inter-counter transfers of Units, or (iii) trade Units in both counters at the same time. In such a case another broker or CCASS Participant may need to be used. Accordingly this may inhibit or delay an investor dealing in both HKD traded and RMB traded Units and may mean investors may only be able to sell their Units in one currency. Investors are recommended to check the readiness of their brokers in respect of the Dual Counter trading and inter-counter transfer.

Concentration and Mainland market risk

The HSCEI ETF is subject to concentration risk as a result of tracking the performance of a single geographical region (i.e. the PRC including the Mainland and Hong Kong). The value of the HSCEI ETF may be more volatile than that of a fund having a more diverse portfolio of investments. The Index Constituent Stocks are securities listed on the SEHK of companies having major business exposure to the Mainland market, an emerging market. Investments of the HSCEI ETF may involve increased risks and special considerations not typically associated with investment in more developed markets, such as liquidity risks, currency risks/control, political and economic uncertainties, legal and taxation risks, settlement risks, custody risk and the likelihood of a high degree of volatility.

General risks of investments associated with the Mainland

Political and economic considerations

The HSCEI ETF tracks the Index and its investments may include H-Shares, red-chips and P-chips. They are shares of enterprises having major business exposure to growth opportunities in the Mainland. However, investors should be aware that the economy of the Mainland differs from the economies of most developed countries in many respects, including with respect to government involvement in its economy, level of development, growth rate and control of foreign exchange. The regulatory and legal framework for capital markets and companies in the Mainland is not well developed when compared with those of developed countries.

By investing in H-Shares, Red-chips and P-chips, the HSCEI ETF is subject to the risks of investing in emerging markets generally and the risks specific to the Mainland market in particular, which are not typically associated with investing in those of developed countries. General risks of investing in emerging markets include but are not limited to:

- less liquid and less efficient securities markets;
- greater price volatility;
- exchange rate fluctuations and exchange controls;
- less publicly available information about issuers;
- the imposition of restrictions on the repatriation of funds or other assets out of the country;
- higher transaction and custody costs and higher settlement risks;
- difficulties in enforcing contractual obligations;
- lesser levels of regulation of the securities markets;
- different accounting, disclosure and reporting requirements;
- more substantial government involvement in the economy;
- higher rates of inflation;
- social, political and economic instability; and
- risk of nationalisation or expropriation of assets and risk of war or terrorism.

The above may affect the ability of the HSCEI ETF to fully implement or pursue the investment objective and strategy of the HSCEI ETF.

Investors should be aware that, for more than 50 years, the PRC government has adopted a planned economic system. Since 1978, the PRC government has implemented economic reform measures which emphasise decentralisation and the utilisation of market forces in the development of the Mainland economy. Such reforms have resulted in significant economic growth and social progress. However, many of the economic reforms in the Mainland are unprecedented or experimental and are subject to adjustment and modification, and such adjustment and modification may not always have a positive effect on securities markets. Also, many laws and regulations in the Mainland are new and therefore untested and there is no certainty as to how they will be applied. They may also be varied in the future.

The Mainland economy has experienced significant growth in the past few years, but such growth has been uneven both geographically and among the various sectors of the economy. Moreover, there can be no assurance that such growth can be sustained.

Investments associated with the Mainland will be sensitive to any significant change in political, social or economic policy in the Mainland. Such sensitivity may, for the reasons specified above, adversely affect the capital growth and thus the performance of these investments.

Accounting, auditing and financial reporting standards and practices

Accounting, auditing and financial reporting standards and practices applicable to companies in the Mainland may be different to those standards and practices applicable to countries that have more developed financial markets. For example, there are differences in the valuation methods for properties and assets and in the requirements for disclosure of information to investors.

Legal system

The legal system of the Mainland in general and for securities markets in particular have been undergoing a period of rapid change over recent years which may lead to difficulties in interpreting and applying newly evolving regulations. The revised Securities Law which came into force on 1 January 2006 has made a comprehensive revision to the old Securities Law relating to the issuing, listing and trading system etc. of securities, and the revised Securities Law was amended on 29 June 2013.

The PRC government has implemented a number of tax reform policies in recent years. There can be no assurance that the current tax laws and regulations will not be revised or amended in the future. Any revision or amendment in tax laws and regulations may affect the after-taxation profit of companies in the Mainland.

PRC tax risk

Investors should consult their own tax advisors regarding the possible PRC tax implications on an investment in the HSCEI ETF (including capital gains thereon) with respect to their own situation.

Currently, the Manager does not make any tax provision on realised gains derived from trading of H-Shares, certain Red-chips and certain P-chips by the HSCEI ETF. However, the Manager reserves the right to make any provision for taxes or withhold any tax for the account of the HSCEI ETF.

There are still uncertainties as to the application of the laws, rules and/or regulations on PRC Corporate Income Tax and PRC Value-Added Tax and surtaxes. It is also uncertain as to whether the HSCEI ETF may be subject to other taxes imposed in the PRC. It is possible that the current tax laws, rules, regulations and practice in the Mainland and/or the current interpretation or understanding thereof may change in the future and such change(s) may have retrospective effect. Where no provision is made by the Manager in relation to all or part of the actual taxes levied by the relevant PRC tax authorities in future, investors should note that the Net Asset Value of the HSCEI ETF may be lowered, as the HSCEI ETF will ultimately have to bear the full amount of tax liabilities. In this case, such amount of tax liabilities will only impact Units in issue at the relevant time, and the then existing Unitholders and subsequent Unitholders will be disadvantaged.

Please refer to the section "Taxes and Duties Payable by the Trust and the Sub-Funds" – "The PRC" – "Corporate Income Tax" and "Value-Added Tax" above for further details.

General risks of investments associated with RMB currency

RMB is not freely convertible and subject to exchange controls and restrictions risk

It should be noted that the RMB is currently not a freely convertible currency as it is subject to foreign exchange control policies and repatriation restrictions imposed by the PRC government. Since 1994, the conversion of RMB into US dollar has been based on rates set by the PBOC, which are set daily based on the previous day's PRC interbank foreign exchange market rate. On 21 July 2005, the PRC government introduced a managed floating exchange rate system to allow the value of RMB to fluctuate within a regulated band based on market supply and demand and by reference to a basket of currencies. In addition, a market maker system was introduced to the interbank spot foreign exchange market. In July 2008, the PRC announced that its exchange rate regime was further transformed into a managed floating mechanism based on market supply and demand. Given the domestic and overseas economic developments, the PBOC decided to further improve the RMB exchange rate regime in June 2010 to enhance the flexibility of the RMB exchange rate. In April 2012, the PBOC decided to take a further step to increase the flexibility of the RMB exchange rate by expanding the daily trading band from +/- 0.5% to +/- 1%. Effective 11 August 2015 the RMB central parity is fixed against the US dollars by reference to the closing rate of the inter-bank foreign exchange market on the previous day (rather than the previous morning's official setting). However it should be noted that the PRC government's policies on exchange control and repatriation restrictions are subject to change, and any such change may adversely impact the HSCEI ETF. There can be no assurance that the RMB exchange rate will not fluctuate widely against the US dollar or any other foreign currency in the future.

Foreign exchange transactions under the capital account, including principal payments in respect of foreign currency-denominated obligations, currently continue to be subject to significant foreign exchange controls and require the approval of the State Administration of Foreign Exchange. On the other hand, the existing PRC foreign exchange regulations have significantly reduced government foreign exchange controls for transactions under the current account, including trade and service related foreign exchange transactions and payment of dividends. Nevertheless, the Manager cannot predict whether the PRC government will continue its existing foreign exchange policy or when the PRC government will allow free conversion of the RMB to foreign currency.

RMB trading and settlement of Units risk

The trading and settlement of RMB traded securities are recent developments in Hong Kong and there is no assurance that there will not be problem with the systems or that other logistical problems will not arise. Although end-to-end simulation trading and clearing of listed RMB products testing sessions and payment pilot runs for participants of the SEHK were held by the SEHK in 2011, some brokers may not have participated in such testing sessions and pilot runs and for those who have, not all of them may be able to successfully complete such testing sessions and pilot runs, and there is no assurance of their readiness for dealing in RMB traded securities. Investors should note that not all brokers may be ready and able to carry out trading and settlement of RMB traded Units and thus they may not be able to deal in the RMB traded Units through some brokers. Investors should check with their brokers in advance if they intend to engage Dual Counter trading or in inter-counter transfers and should fully understand the services which the relevant broker is able to provide (as well as any associated fees). Some exchange participants may not provide inter-counter transfer or Dual Counter trading services.

Exchange rates movement between the RMB and other currencies risk

Investors in RMB traded Units whose assets and liabilities are predominantly in HKD or in currencies other than RMB should take into account the potential risk of loss arising from fluctuations in value between such currencies and RMB. In addition, investors in RMB traded Units should note that dividends on RMB traded Units will only be paid in HKD. Accordingly, foreign exchange risk will also apply to investors in RMB traded Units. There is no guarantee that RMB will appreciate in value against HKD or any other currency, or that the strength of RMB may not weaken. In such case an investor may enjoy a gain in RMB terms but suffer a loss when converting funds from RMB back into HKD (or any other currency).

Future movements in RMB exchange rates risk

The exchange rate of RMB ceased to be pegged to US dollars on 21 July 2005, resulting in a more flexible RMB exchange rate system. The China Foreign Exchange Trading System, authorised by the PBOC, promulgates the central parity rate of RMB against US dollars, Euro, Yen, pound sterling and HKD at 9:15 a.m. on each business day, which will be the daily central parity rate for transactions on the Inter-bank Spot Foreign Exchange Market and OTC transactions of banks. The exchange rate of RMB against the above-mentioned currencies fluctuates within a range above or below such central parity rate. Effective 11 August 2015, the PBOC changed the central parity system for the US dollars to a more market based system by which the central parity is set by reference to the closing rate of the inter-bank foreign exchange market on the previous day. As the exchange rates are based primarily on market forces, the exchange rates for RMB against other currencies, including US dollars and HKD, are susceptible to movements based on external factors. There can be no assurance that such exchange rates will not fluctuate widely against US dollars, HKD or any other foreign currency in the future. From 1994 to July 2005, the exchange rate for RMB against US dollar and the HKD was relatively stable. Since July 2005, the appreciation of RMB has begun to accelerate. Although the PRC government has constantly reiterated its intention to maintain the stability of RMB, it may introduce measures (such as a reduction in the rate of export tax refund) to address the concerns of the PRC's trading partners. Therefore, the possibility that the appreciation of RMB will be further accelerated cannot be excluded. On the other hand, there can be no assurance that RMB will not be subject to devaluation.

Offshore RMB (CNH) market risk

The onshore RMB (CNY) is the only official currency of the PRC and is used in all financial transactions between individuals, state and corporations in the PRC. Hong Kong is the first jurisdiction to allow accumulation of RMB deposits outside the PRC. Since June 2010, the offshore RMB (CNH) is traded officially, regulated jointly by the Hong Kong Monetary Authority and the PBOC. While both CNY and CNH represent RMB, they are traded in different and separated markets. The two RMB markets operate independently where the flow between them is highly restricted. Though the CNH is a proxy's of the CNY, they do not necessarily have the same exchange rate and their movement may not be in the same direction. This is because these currencies act in separate jurisdictions, which leads to separate supply and demand conditions for each, and therefore separate but related currency markets.

However, the current size of RMB-denominated financial assets outside the PRC is limited. In addition, participating authorised institutions are also required by the Hong Kong Monetary Authority to maintain a total amount of RMB (in the form of cash and its settlement account balance with the RMB Clearing Bank) of no less than 25% of their RMB deposits, which further limits the availability of RMB that participating authorised institutions can utilise for conversion services for their customers. RMB business participating banks do not have direct RMB liquidity support from PBOC. The Renminbi Clearing Bank only has access to onshore liquidity support from PBOC (subject to annual and quarterly quotas imposed by PBOC) to square open positions of participating banks for limited types of transactions, including open positions resulting from conversion services for corporations relating to cross-border trade settlement and for individual customers. The Renminbi Clearing Bank is not obliged to square for participating banks any open positions resulting from other foreign exchange transactions or conversion services and the participating banks will need to source RMB from the offshore market to square such open positions. Although it is expected that the offshore RMB market will continue to grow in depth and size, its growth is subject to many constraints as a result of PRC laws and regulations on foreign exchange. There is no assurance that new PRC regulations will not be promulgated or the relevant settlement agreements between Hong Kong banks and the PBOC will not be terminated or amended in the future which will have the effect of restricting availability of RMB offshore. The limited availability of RMB outside the PRC may affect the ability of investors to acquire Units or to sell Units of the HSCEI ETF affecting the liquidity and trading price of the Units on the SEHK.

HKD dividends risk

Investors should note that where a Unitholder holds Units traded under the RMB counter, the relevant Unitholder will only receive dividends in HKD and not RMB. In the event the relevant Unitholder has no HKD account, the Unitholder may have to bear the fees and charges associated with the conversion of such dividend from HKD into RMB or any other currency. Unitholders should check with their brokers concerning arrangements for dividends.

The Offering

The attention of investors is drawn to the section entitled "THE OFFERING AND REDEMPTION OF LISTED CLASS UNITS" in Part 1 of this offering document.

Notwithstanding a Dual Counter being adopted for the HSCEI ETF, the Issue Price or Redemption Price of each Unit for any relevant Dealing Day will, subject to the qualification below, be based on the Net Asset Value of the HSCEI ETF in HKD at the Valuation Point divided by the number of Units then in issue or deemed to be in issue, rounded to the nearest two decimal places with any amount of 0.005 or above being rounded up (unless otherwise agreed by the Manager and the Trustee). The benefit of any such rounding shall accrue to the HSCEI ETF.

The Dealing Deadline is 2:00 p.m. Hong Kong time on each Dealing Day (for making a cash creation application and a cash redemption application by a Participating Dealer) and 15 minutes after the official closing time of the SEHK on each Dealing Day (for making an in-kind creation application and an in-kind redemption application by a Participating Dealer), or such other time prior to the calculation of the Net Asset Value of the HSCEI ETF on that Dealing Day as the Manager may determine and agree with the Trustee.

The Dealing Deadline for making a special creation application and a special redemption application by the HS Funds is the official closing time of the SEHK on the relevant Dealing Day, or such other time prior to the calculation of the Net Asset Value of the HSCEI ETF on that Dealing Day as the Manager may determine and agree with the Trustee.

Dealings on the SEHK in HKD traded Units commenced on 10 December 2003. Dealings on the SEHK in RMB traded Units commenced on 4 September 2015.

Investors can purchase and sell HKD and RMB traded Units in board lots of 200 Units (or multiples thereof) like ordinary listed stocks through an intermediary such as a broker or any of the share dealing services offered by banks or other financial advisers at any time the SEHK is open.

Has the HSCEI ETF adopted any Dual Counter arrangement?

With effect from 4 September 2015, the Manager has arranged for the Units to be available for trading on the secondary market on the SEHK under a Dual Counter arrangement. There will be two trading counters on the SEHK (i.e. HKD counter and RMB counter), Units traded in HKD counter will be settled in HKD and Units traded in

RMB counter will be settled in RMB. Apart from settlement in different currencies, the trading prices of Units in the two counters may be different as the HKD counter and RMB counter are two distinct and separate markets.

In the primary market, under the Dual Counter arrangement, a Participating Dealer may subject to arrangement with the Manager elect to CCASS to have Units which it creates deposited in either HKD counter or RMB counter. Both HKD traded Units and RMB traded Units may be redeemed by way of a Redemption Application through a Participating Dealer. However, the cash creation of new Units in a special creation application and cash redemption of Units in a special redemption application are in HKD only. Furthermore, the Units created in a special creation application can be deposited in HKD counter only and only Units in the HKD counter can be withdrawn directly in a special redemption application.

Units traded on both counters are of the same class and all Unitholders of both counters are treated equally. The two counters will have different stock codes, different stock short names and different ISIN numbers as follows: HKD counter and traded Units have a SEHK stock code 02828 and a stock short name "HSCEI ETF" whilst the RMB counter and traded Units have a SEHK stock code 82828 and a stock short name "HSCEI ETF-R". The ISIN for HKD counter and traded Units is HK2828013055 and the ISIN number for RMB counter and traded Units is HK0000251360.

Normally, investors can purchase and sell Units traded in the same counter or alternatively buy in one counter and sell in the other counter provided their brokers provide both HKD and RMB trading services at the same time and offer inter-counter transfer services to support Dual Counter trading. Inter-counter purchase and sell is permissible even if the trades take place within the same trading day provided the relevant broker can provide such a service. However, investors should note that the trading price of Units traded in the HKD counter and that of RMB counter may be different and may not always maintain a close relationship depending on factors such as market demand and supply and liquidity in each counter.

More information with regard to the Dual Counter is available in the frequently asked questions in respect of the Dual Counter published on HKEx's website https://www.hkex.com.hk/Global/Exchange/FAQ/Featured/RMB-Readiness-and-Services/Dual-Tranche-Dual-Counter-Model?sc_lang=en (*this website has not been reviewed by the SFC*).

Investors should consult their brokers if they have any questions concerning fees, timing, procedures and the operation of the Dual Counter, including inter-counter transfers. Investors' attention is also drawn to the risk factor above entitled "Dual Counter Risks".

What is Renminbi Equity Trading Support Facility?

The Renminbi Equity Trading Support Facility ("TSF") was launched on 24 October 2011 by HKEx to provide a facility to enable investors who wish to buy RMB-traded shares in the secondary market with HKD if they do not have sufficient RMB or have difficulty in obtaining RMB from other channels. With effect from 6 August 2012, the coverage of TSF was extended and the HSCEI ETF is eligible for the TSF. As such the TSF is currently available to investors who wish to invest in the HSCEI ETF by purchasing Units trading in RMB on the SEHK. Investors should consult their financial advisers if they have any questions concerning the TSF. More information with regard to the TSF is available on HKEx's website https://www.hkex.com.hk/Global/Exchange/FAQ/Featured/RMB-Readiness-and-Services/RMB-Equity-Trading-Support-Facility?sc_lang=en (*this website has not been reviewed by the SFC*).

Distribution Policy

The Manager may, at its discretion, distribute semi-annual cash dividends (if any), which are expected to be in respect of the first half and the second half of each calendar year respectively. The Manager currently intends to make declaration of dividends in June and September of each year. Each Unitholder will receive dividends in HKD only (whether holding HKD traded Units or RMB traded Units). There is no guarantee of regular distribution of dividends and if dividend is paid the amount being distributed.

The Manager may, at its discretion, pay dividend out of capital of the HSCEI ETF as contemplated by FAQ34 on the Code issued by the SFC. The Manager may also, at its discretion, pay dividend out of gross income while all or part of the fees and expenses of the HSCEI ETF are charged to/paid out of the capital of the HSCEI ETF, resulting in an increase in distributable income for the payment of dividends by the HSCEI ETF and therefore, the

HSCEI ETF may effectively pay dividend out of capital as contemplated by FAQ34.

Payment of dividends out of capital or effectively out of capital amounts to a return or withdrawal of part of an investor's original investment or from any capital gains attributable to that original investment. Any distributions of dividends involving payment of dividends out of capital or effectively out of capital may result in an immediate reduction of the Net Asset Value per Unit.

The compositions of the dividends (i.e. the percentages of dividends being paid out of (i) net distributable income and (ii) capital) for a rolling 12-month period are available from the Manager on request and on the website www.hangsenginvestment.com (*this website has not been reviewed by the SFC*). Details of ex-dividend dates and dividend payment dates shall also be published on the website www.hangsenginvestment.com (*this website has not been reviewed by the SFC*) and via the SEHK's website www.hkex.com.hk (*this website has not been reviewed by the SFC*). The Manager may amend the policy regarding paying dividends out of capital or effectively out of capital by giving not less than 1 month's advance notice to Unitholders.

The Index is compiled and managed by HSIL, a wholly-owned subsidiary of Hang Seng Bank Limited.

closely as practicable. The Manager intends to primarily adopt a full replication strategy to pursue this objective.

The Index tracks the performance of the 30 largest technology companies listed in Hong Kong which have high business exposure to selected technology themes, including internet (including mobile), fintech, cloud, e-commerce and digital activities.

What is the Investment Objective of the HSTECH ETF?

The HSTECH ETF is an index-tracking fund tracking the performance of the Index, as more fully described below.

The investment objective of an index-tracking fund is to match, before fees and expenses, as closely as practicable, the performance of an underlying index against which the index-tracking fund is benchmarked.

A stock index tracks the performance of the Index Securities which an index provider selects as representative of a market, specific industry sector or market segment.

The index provider calculates the relative weightings of the group of Index Securities in an index according to the index methodology and publishes the information regarding the market value of the index.

The HSTECH ETF aims to match, before fees and expenses, as closely as practicable the total return performance (net of withholding tax) of the Index. For more information about the Index and the Index Constituent Stocks, please see section headed "(B) Information about the Index" below.

What Investment Strategy is used by the HSTECH ETF?

The Manager primarily adopts a full replication strategy.

In order to maximise portfolio management efficiency, minimise transaction costs and tracking error, exposure to the Index may also be obtained through representative sampling strategies or FDIs (such as futures) from which the return to the HSTECH ETF substantially reflects the performance of the Index. Such strategies and instruments are chosen based on their correlation to the Index and cost efficiency in order to reflect the characteristics of the Index. Hence, the Manager may decide to utilise a full replication strategy or representative sampling strategy from time to time to achieve the HSTECH ETF's investment objective.

In addition to the risk factors presented in Part 1 of this offering document, the risk factors set forth below are, in the opinion of the Manager, also considered to be relevant and presently applicable to the Sub-Fund.

Sector and geographical concentration risk

As the HSTECH ETF's investments are concentrated in securities listed on the SEHK of companies having major business exposure to selected technology themes, the HSTECH ETF may be subject to a greater risk and a higher volatility than other funds which invest in a broader range of securities covering different economic or business sectors. The equity securities of the companies in which the HSTECH ETF may invest are likely to be affected by world-wide scientific or technological developments, and the products or services of such companies may rapidly fall into obsolescence. Such companies may be challenged by dynamic market conditions, new competing products and services, and rapid improvements in existing products and services. As such, such companies may be subject to significant instability and fluctuations in valuations.

The Index is subject to concentration risk as a result of tracking the performance of securities incorporated in, or with majority of revenue derived from, or with a principal place of business in, the Greater China region. The HSTECH ETF's Net Asset Value is therefore likely to be more volatile than a broad-based fund.

Risks associated with investing in companies with technology themes

The HSTECH ETF may invest in equity securities of companies which have high business exposure to technology related themes, industries and sectors, such as internet (including mobile), cloud, e-commerce, digital activities and software. Rapid changes could render obsolete the products and services offered by the companies in which the HSTECH ETF invests and cause severe or complete declines in the prices of the securities of those companies. In addition, technology companies are heavily dependent on patent and intellectual property rights, the loss or impairment of which may adversely affect profitability. Additionally, companies in these sectors may face dramatic and often unpredictable changes in growth rates and competition for the services of qualified personnel.

In addition, some of these companies offer products or services that are subject to governmental regulation and may, therefore, be adversely affected by change in governmental policies. Thus, investment in equity securities of such companies may drop sharply in value in response to market, research or regulatory setbacks.

As such, valuations of companies with this theme may be subject to significant instability and fluctuations in valuations. In addition, the valuation of companies with this theme may be higher than those of more traditional industries, and the HSTECH ETF may suffer a loss when there is a revaluation of these securities.

Risks associated with internet companies and internet related industries (e.g. e-commerce, cloud, digital activities)

Companies that have high business exposure to the internet, cloud computing and e-commerce industries are dependent on internal infrastructure and on the availability, reliability and security of the internet and related systems. Critical systems and operations may be vulnerable to damage or interruption from fire, flood, power loss, telecommunications failure, terrorist attacks, cyber-attacks, acts of war, break-ins, earthquake and similar events. Any system interruption that results in the unavailability of a company's website or mobile application or reduced performance of transaction systems could interrupt or substantially reduce a company's ability to conduct its business. Companies in the internet and e-commerce industries are dependent on paid and unpaid natural search engines and are therefore dependent on business decisions made by companies that offer natural search engines. Any business changes by dominant providers of natural search engines can be detrimental to an internet and/or e-commerce company's business while being outside of the control of such company.

Undetected software errors risks

Generally, the products and services offered by internet and related services companies incorporate complex software. Such software has contained, and may now or in the future contain, errors, bugs or vulnerabilities. Some errors in the software code may only be discovered after the product or service has been released. Any errors, bugs or vulnerabilities discovered in the code of an internet and related services company after release could result in damage to such company's reputation, loss of users, loss of platform partners, loss of advertisers or advertising revenue or liability for damages, any of which could adversely affect the business and operating results of such company. If the HSTECH ETF invests in any of these companies, its investment may be adversely affected.

Risks associated with investing in companies with fintech themes

An eligible security for the Index may also have high business exposure to a fintech theme. The HSTECH ETF's investment in such companies is likely to be affected by world-wide rapid technological developments as well as regulatory development in the banking and finance sector. The products or services of such companies may rapidly fall into obsolescence (or may be dependent on technologies which rapidly fall into obsolescence) and so the value of the securities of these companies may be negatively impacted as a result.

Companies that have high business exposure to and generate revenue from the fintech sector are heavily dependent on patent and intellectual property rights and/or licences, the loss or impairment of which may adversely affect profitability. Companies with high business exposure to a fintech theme may face dramatic and often unpredictable changes in growth rates and competition among the companies themselves and for the services of qualified personnel. Also, such companies are subject to cyber security risks which may cause issues like system breakdown, suspension of offering of products or services, loss or misuse of corporate or personal data, etc., and result in undesirable legal, financial, operational and reputational consequences.

Government intervention risk

There may be substantial government intervention in the technology industries, including restrictions on companies that have high business exposure to the internet (including mobile), fintech, cloud, e-commerce and digital activities sectors, if such companies are deemed sensitive to relevant national interests. Some governments in the world have sought, and may in the future seek, to censor content available through internet, restrict access to products

and services offered by such companies that the HSTECH ETF invests in from their country entirely or impose other restrictions that may affect the accessibility of such products and services for an extended period of time or indefinitely. In the event that access to the relevant products and services is restricted, in whole or in part, in one or more countries, the ability of companies with technology themes to retain or increase their user base and user engagement may be adversely affected, and their operating results may be harmed. This may in turn affect the value of investment of the HSTECH ETF.

Changes in laws and regulations risk

Companies that have high business exposure to technology related themes, industries and sectors, including internet (including mobile), fintech, cloud, e-commerce and digital activities, are subject to complex laws and regulations including privacy, data protection, content regulation, intellectual property, competition, protection of minors, consumer protection and taxation. These laws and regulations are subject to change and uncertain interpretation, and could result in claims, changes to the business practices, monetary penalties, increased cost of operations or declines in user growth, user engagement or advertisement engagement, or otherwise harm the internet business. They may also delay or impede the development of new products and services. Compliance with these existing and new laws and regulations can be costly and may require significant time and attention of management and technical personnel.

All these may have impact on the business and/or profitability of the companies with technology themes in which the HSTECH ETF invests and this may in turn adversely affect the value of investment of the HSTECH ETF.

Risks associated with investing in the industrials, consumer discretionary, healthcare, financials and information technology sectors

As the HSTECH ETF may invest in securities of companies in the industrials, consumer discretionary, healthcare, financials and information technology sectors, an investment in the HSTECH may be more vulnerable to price fluctuations of securities of companies in these industries and other factors that particularly affect these industries as compared to an investment in a fund having a more diverse portfolio of investments.

A downturn in the business for companies in these sectors may have adverse effects on the HSTECH ETF.

Risks associated with investing in the industrials sector

The HSTECH ETF may invest in companies in the industrials sector with a technology theme. Such companies will be adversely affected by imposition of import controls, increased competition, depletion of resources, strained labour relations, negative changes in government regulation, environmental damage claims, commodity price volatility, changes in interest rates, world events and economic conditions.

Risks associated with investing in the consumer discretionary sector

The HSTECH ETF may invest in companies with a technology theme that are in the consumer discretionary sector. The HSTECH ETF may have particular exposure to the consumer discretionary sector in the Mainland market. The performance of Mainland companies active in the consumer discretionary sector are correlated to the growth rate of the consumer market, individual income levels and their impact on levels of domestic consumer spending in the Mainland, which in turn depend on the worldwide economic conditions, which have recently deteriorated significantly in many countries and regions and may remain depressed for the foreseeable future. These companies may also be subject to government regulation affecting production methods, which may have an adverse impact on their operating results and profit margin. This may in turn adversely affect the value of investment of the HSTECH ETF. There are many factors affecting the level of consumer spending, including but not limited to disposable income and wealth, interest rates, currency exchange rates, economic growth rate, inflation, deflation, political uncertainty, taxation, stock market performance, unemployment level and general consumer confidence. There can be no assurance that historical growth rates of the Mainland economy and the Mainland consumer market will continue. Any future slowdowns or declines in the Mainland economy or consumer spending may materially and adversely affect the business of the companies in the consumer discretionary sector and as a result the performance of the HSTECH ETF.

The Mainland consumer discretionary sector may be reliant upon trade and an increase in global trade restrictions, or even the threat thereof, may negatively affect the performance of Mainland companies in the consumer discretionary sector.

Risks associated with investing in the healthcare sector

An eligible security for the Index may be in the healthcare sector. The economic prospects of the healthcare sector are generally subject to greater influences from governmental policies and regulations than those of many other industries. Certain healthcare companies may allocate greater than usual financial resources to research and product development (a screening requirement for purposes of an eligible security of the Index is that the research and development expense to revenue ratio must be equal to 5% or more), and experience above-average price movements associated with the perceived prospects of success of the research and development programs. In addition, certain healthcare companies may be adversely affected by lack of commercial acceptance of a new product or process or by technological change and obsolescence.

The internet healthcare market is relatively new and it is uncertain whether it would achieve and sustain high levels of demand, consumer acceptance and market adoption. Many internet healthcare providers have a short operating history and it may be difficult to assess their future prospects or forecast their future results. They may need to rely on self-developed technology which is time-consuming, expensive and complex, and may involve unforeseen difficulties. Online healthcare services also rely upon services provided by medical professionals, hospitals and product suppliers and vendors, who may provide sub-standard services, mishandle sensitive information, engage in other misconduct or commit medical malpractice, which could subject the company to medical liability claims that may not be fully covered by insurance. Companies also face risks in handling large volumes of personal medical data and in securing and protecting such data. Any systems failure or security breach that results in the unauthorized release of user data could harm a company's reputation and business, in addition to exposing it to potential legal liability.

Risks associated with investing in the financial sector

The HSTECH ETF may invest in companies with a technology theme that are in the financial sector (e.g. banks, insurance and other financial services companies). There exists a certain degree of instability in the financial service markets and certain companies in the financial sector have incurred large (or even huge) losses. Some financial service companies have experienced declines in the valuations of their assets, taken action to raise capital or even ceased operations. In certain jurisdictions, companies in the financial sector are subject to extensive governmental regulation, which may adversely affect the scope of their business activities. Governmental regulation may also change frequently. The financial sector is exposed to risks that may impact the value of investments in the financial sector more severely than investments outside this sector, and may also be adversely affected by increases in interest rates and loan losses, decreases in the availability of money or asset valuations and adverse conditions in other related markets.

New Index Risk

The Index is a new index having only been launched on 27 July 2020. As such, the HSTECH ETF may be riskier than other index funds tracking more established indices with longer operating history.

The Offering and Redemption of Listed Class Units

The attention of investors is drawn to the section entitled "THE OFFERING AND REDEMPTION OF LISTED CLASS UNITS" in Part 1 of this Prospectus.

The Initial Offer Period of the Listed Class Units has ended. Dealings in the Listed Class Units on the SEHK commenced on 4 September 2020.

The Issue Price or Redemption Price of each Listed Class Unit for any relevant Dealing Day will, subject to the qualification below, be based on the Net Asset Value of the Listed Class Units of the HSTECH ETF in HKD at the Valuation Point divided by the number of Listed Class Units then in issue or deemed to be in issue, rounded to the nearest four decimal places with any amount of 0.00005 or above being rounded up (unless otherwise agreed by the Manager and the Trustee). The benefit of any such rounding shall accrue to the HSTECH ETF.

The Dealing Deadline is 3:30 p.m. Hong Kong time on each Dealing Day (for making a cash creation application and a cash redemption application by a Participating Dealer) and 4:30 p.m. Hong Kong time on each Dealing Day (for making an in-kind creation application and an in-kind redemption application by a Participating Dealer), or such other time prior to the calculation of the Net Asset Value of the HSTECH ETF on that Dealing Day as the Manager may determine and agree with the Trustee.

The Dealing Deadline for making a special creation application and a special redemption application by the HS Funds is the official closing time of the SEHK on the relevant Dealing Day, or such other time prior to the calculation of the Net Asset Value of the HSTECH ETF on that Dealing Day as the Manager may determine and agree with the Trustee.

All investors may purchase and sell Listed Class Units in the secondary market on the SEHK and Participating Dealers (for themselves or for their clients) may apply for cash or in-kind creation and redemption of Listed Class Units in the primary market.

Has the HSTECH ETF adopted any Dual Counter arrangement? (applicable to Listed Class Units only)

No. The HSTECH ETF has not adopted a Dual Counter arrangement.

Exchange Listing and Trading (Secondary Market) of the Listed Class Units

Application has been made to the Listing Committee of the SEHK for the listing of, and permission to deal in the Listed Class Units.

Listed Class Units are neither listed nor dealt on any other stock exchange and no application for such listing or permission to deal is being sought as at the date of this Prospectus. Application may be made in the future for a listing of Listed Class Units on one or more other stock exchanges.

Dealings on the SEHK in Listed Class Units traded in HKD began on 4 September 2020. Listed Class Units trade on the SEHK in board lots of 200 Listed Class Units. The ISIN number for traded Listed Class Units is HK0000640323.

Participating Dealers should note that they will not be able to sell or otherwise deal in the Listed Class Units on the SEHK until dealings begin on the SEHK.

The benefit of any such rounding shall accrue to the HSTECH ETF.

Switching

Switching between Unlisted Class Units and Listed Class Units, by a Participating Dealer or otherwise, is not available.

Unless otherwise agreed by the Manager, Unlisted Class Units of the HSTECH ETF may only be switched into the same unlisted class units of any Collective Investment Scheme managed by the Manager. Similarly, unless otherwise agreed by the Manager, the unlisted class units of any Collective Investment Scheme managed by the Manager may only be switched into Units of the same Unlisted Class of the HSTECH ETF. Where the switching is between Units denominated in different currencies, currency conversion is involved and the relevant Unitholders are subject to exchange rate risk.

Distribution Policy

The Manager may, at its discretion, distribute annual cash dividends (if any). The Manager currently intends to make declaration of dividends in September of each year. Each Unitholder will receive dividends in HKD only. There is no guarantee of regular distribution of dividends and, if dividend is paid, the amount being distributed.

The Manager may, at its discretion, pay dividend out of capital of the HSTECH ETF as contemplated by FAQ34 on the Code issued by the SFC. The Manager may also, at its discretion, pay dividend out of gross income while all or part of the fees and expenses of the HSTECH ETF are charged to/paid out of the capital of the HSTECH ETF, resulting in an increase in distributable income for the payment of dividends by the HSTECH ETF and therefore, the HSTECH ETF may effectively pay dividend out of capital as contemplated by FAQ34.

Payment of dividends out of capital or effectively out of capital amounts to a return or withdrawal of part of an investor's original investment or from any capital gains attributable to that original investment. Any distributions of dividends involving payment of dividends out of capital or effectively out of capital may result in an immediate reduction of the Net Asset Value per Unit.

The compositions of the dividends (i.e. the percentages of dividends being paid out of (i) net distributable income and (ii) capital) for a rolling 12-month period are available from the Manager on request and on the website www.hangsenginvestment.com (*this website has not been reviewed by the SFC*). Details of ex-dividend dates and dividend payment dates shall also be published on the website www.hangsenginvestment.com (*this website has not been reviewed by the SFC*) and via the SEHK's website www.hkex.com.hk (*this website has not been reviewed by the SFC*). The Manager may amend the policy regarding paying dividends out of capital or effectively out of capital by giving not less than 1 month's advance notice to Unitholders.

This policy applies to the Listed Class. Currently, only Accumulation Units are offered for the Unlisted Class and no distributions will be made for such Units.

Establishment costs

The costs of establishing the Listed Class of the HSTECH ETF including the preparation of this Prospectus, inception fees, the costs of seeking and obtaining the listing and authorisation by the SFC and all initial legal and printing costs (which are estimated to be HKD1.65 million) are borne by the HSTECH ETF (unless otherwise determined by the Manager) and will be amortised over the first 5 financial years of the Sub-Fund or such other period as determined by the Manager after consulting the Auditor. The costs of establishing the Listed Class of the HSTECH ETF are borne by the HSTECH ETF at the Sub-Fund level.

The costs of establishing the Unlisted Class of the HSTECH ETF including the preparation of this Prospectus, inception fees, the costs of seeking and obtaining the authorisation by the SFC and all initial legal and printing costs (which are estimated to be HKD600,000) will be borne by the HSTECH ETF and will be amortised over the first 5 financial years since the launch of the Unlisted Class of the Sub-Fund or such other period as determined by the Manager after consulting the Auditor. The costs of establishing the Unlisted Class of the HSTECH ETF will be borne by the HSTECH ETF at the Sub-Fund level.

(B) Information about the Index

Overview

The Index is a freefloat-adjusted market capitalisation weighted index, and is designed to represent the 30 largest technology companies listed in Hong Kong which have high business exposure to the selected technology themes, including internet (including mobile), fintech, cloud, e-commerce and digital activities.

The Index is denominated in HKD. It was launched on 27 July 2020 with a base value of 3,000 as of 31 December 2014. It is calculated and disseminated real-time at 2-second intervals during trading hours of the SEHK.

The Fund aims to match as closely as practicable, before fees and expenses, the performance of the total return (net of withholding tax) version of the Index, which is calculated on the basis that dividends are reinvested after the deduction of withholding taxes.

Both the Manager and the Index provider are presently subsidiaries of Hang Seng Bank Limited. The functions which the Index provider and the Manager will perform in connection with the Fund may give rise to potential conflicts of interest but the Manager will manage any such conflicts in the best interest of investors.

The universe of securities of the Index includes securities of Greater China companies listed on the Main Board of the SEHK, but excludes foreign companies and investment companies listed under Chapter 21 of the SEHK's Main Board Listing Rules.

Eligibility

A security is eligible for Index constituent selection if it fulfils the following eligibility criteria:

I) Turnover Requirement

Turnover velocity in each of the past 12 months is calculated for each eligible security based on the following formula:

$$\text{Turnover velocity} = \frac{\text{Median of daily traded shares in specific calendar month}}{\text{Freefloat-adjusted issued shares at month end}}$$

The minimum requirement of turnover velocity is 0.1%. For new constituents, the turnover velocity of an eligible security must meet the minimum requirement for at least 10 out of the past 12 months and for the latest three months. For existing constituents, the turnover velocity must meet the minimum requirement for at least 10 out of the past 12 months, subject to a supplementary turnover test. Separate minimum requirements apply for securities with a trading history of less than 12 months.

Turnover requirement is not applied to the ad hoc inclusion under the Fast Entry Rule (i.e. a newly listed security will be added to the Index between regular reviews if its full market capitalisation ranks within the top 10 of the existing Index constituents at the market close of its first trading day). The ad hoc addition will normally be implemented after the market close of the 10th trading day of the new issue.

II) Sector Requirement

An eligible security must be classified in one of the following industries in the Hang Seng Industry Classification System:

III) Theme Requirement

An eligible security must have high business exposure to at least one of the following Tech themes: internet (including mobile), fintech, cloud, e-commerce or digital activities.

IV) Innovation Screening

An eligible security must meet at least one of the below criteria:

- 1) the security carries on a technology-enabled business (e.g. via internet or mobile platform);
- 2) the research and development expense to revenue ratio is equal to 5% or more; or
- 3) the year-on-year revenue growth is equal to 10% or more.

The Index adopts a freefloat-adjusted market capitalisation weighted methodology with a 8% cap on each constituent. The weighting of a constituent may exceed 8% after the rebalancing date due to price movement. The review of the Index is conducted quarterly. The eligibility criteria of the Index including the Sector, Theme and Innovation Screening Requirements are reviewed at least annually. As at 17 June 2021, the Index has 30 constituent securities and a freefloat-adjusted index market capitalisation (after capping) of HKD 2,123.0 billion.

Real-time update of the Index can be obtained through Refinitiv, Bloomberg, WIND and the website of Hang Seng Indexes Company Limited ("HSIL") at: www.hsi.com.hk (*this website has not been reviewed by the SFC*). Other important news relating to the Index are available at the HSIL website, www.hsi.com.hk (*this website has not been reviewed by the SFC*).

Please note:

- The list of constituent securities which comprise the Index is reviewed by HSIL on a quarterly basis. Buffer zone will be applied to the Index. Existing constituents of the Index will be removed from the Index if they rank lower than 36th by market value and eligible securities will be included in the Index if they rank 24th or above by market value. Securities will be added to or excluded from the Index according to their market value rank to maintain the number of constituents at 30. In case of any ad hoc constituent removal (e.g. due to prolonged suspension or delisting), the outgoing constituent will be replaced by the highest ranked candidate from the last regular review.
- The accuracy and completeness of the calculation of the Index may be affected if there is any problem with the system for the computation and/or compilation of the Index.
- Under the terms of the licence agreement regarding the use of the Index, the Manager will indemnify HSIL and HSDS against, among other things, any loss of whatsoever nature which either of them may suffer (including in respect of any claim by any current, former or future Unitholder or investor) as a result of any act or omission of HSIL and HSDS in respect of or in connection with the trading in the HSTECH ETF, use of the Index in connection with such trading, computation of the Index, or any errors, mistakes or omissions in making such computation or in collecting or using relevant information for that purpose (except in cases of their wilful misconduct, bad faith or dishonesty). The Manager will also indemnify HSIL and HSDS on a full indemnity basis for, among other things, any loss which either of them may suffer as a result of any default by the Manager or any of its duly appointed agents in the performance and observance of the provisions of the license agreement and any misuse or unauthorised use of the Index. As the Manager is entitled to be indemnified from the assets of the HSTECH ETF in respect of any claims made against it including those in relation to the license agreement provided that such losses are not due to the negligence, default, breach of duty or trust on the part of the Manager, this may result in a decrease in the Net Asset Value of the HSTECH ETF.

Index license agreement

The Manager has entered into a licence agreement with the Index Provider, HSIL, as well as Hang Seng Data Services Limited. The term of the licence agreement commenced on 5 August 2020. Since the license agreement does not have an expiry date, it should remain in full force unless three months' prior written notice is given. The license agreement may otherwise be terminated in accordance with the provisions of the license agreement.

The Hang Seng TECH Index (the "**Index**") is published and compiled by Hang Seng Indexes Company Limited pursuant to a licence from Hang Seng Data Services Limited. Schedule 1 – Investment Restrictions, Security Lending and Borrowing

Each Sub-Fund is a collective investment scheme authorised by the SFC for sale to investors in Hong Kong pursuant to the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (an “**Authorised Fund**”), SFC authorisation is not a recommendation or endorsement of a scheme nor does it guarantee the commercial merits of the scheme or its performance. It does not mean the scheme is suitable for all investors nor is it an endorsement of its suitability for any particular investor or class of investors. The SFC has the right to withdraw such authorisation of the Trust or a Sub-Fund if it no longer considers the Index is acceptable. In addition, as an Authorised Fund, a Sub-Fund is not permitted to make certain investments or to engage in certain borrowing or lending activities.

If any of the restrictions or limitations set out in this section are breached, the Manager will make it a priority objective to take all necessary steps within a reasonable period to remedy such breach, taking into account the Unitholders’ interests.

The Trustee will take reasonable care to ensure compliance with the investment and borrowing limitations set out in the constitutive documents and the conditions under which the Sub-Fund was authorised.

Unless otherwise specifically provided for in the relevant Appendix, the investment, borrowing and lending restrictions applicable to each Sub-Fund (that are included in the Trust Deed) are summarised below.

Investment restrictions

- (a) the aggregate value of a Sub-Fund’s investments in, or exposure to, any single entity through the following may not exceed 10% of the Net Asset Value of such Sub-Fund (save as permitted by Chapter 8.6(h) and as varied by Chapter 8.6(h)(a) of the Code):
 - (1) investments in securities issued by such entity;
 - (2) exposure to such entity through underlying assets of FDI; and
 - (3) net counterparty exposure to such entity arising from transactions of over-the-counter FDIs,
- (b) subject to (a) above and Chapter 7.28(c) of the Code and unless otherwise approved by the SFC, the aggregate value of a Sub-Fund’s investments in, or exposure to, entities within the same group through the following may not exceed 20% of the Net Asset Value of the Sub-Fund:
 - (1) investments in securities issued by such entities;
 - (2) exposure to such entities through underlying assets of FDIs; and
 - (3) net counterparty exposure to such entities arising from transactions of over-the-counter FDIs;
- (c) unless otherwise approved by the SFC, the value of a Sub-Fund’s cash deposits made with the same entity or entities within the same group may not exceed 20% of the Net Asset Value of the Sub-Fund, unless:
 - (1) the cash is held before the launch of the Sub-Fund and for a reasonable period thereafter prior to the initial subscription proceeds being fully invested; or
 - (2) the cash is proceeds from liquidation of investments prior to the merger or termination of a Sub-Fund, whereby the placing of cash deposits with various financial institutions may not be in the best interest of investors; or
 - (3) the cash is proceeds received from subscriptions pending investments and held for the settlement of redemption and other payment obligations, whereby the placing of cash deposits with various financial institutions is unduly burdensome and the cash deposits arrangement would not compromise investors’ interests;

For the purposes herein, "cash deposits" generally refer to those that are repayable on demand or have the right to be withdrawn by a Sub-Fund and not referable to provision of property or services.

- (d) ordinary shares issued by any single entity (other than Government and other Public Securities) held for the account of a Sub-Fund, when aggregated with other holdings of ordinary shares issued by the same entity held for the account of all other Sub-Funds under the Trust collectively may not exceed 10% of the nominal amount of the ordinary shares issued by the entity;
- (e) not more than 15% of the Net Asset Value of a Sub-Fund may be invested in securities and other financial products or instruments that are neither listed, quoted nor dealt in on a stock exchange, over-the-counter market or other organised securities market which is open to the international public and on which such Securities are regularly traded;
- (f) notwithstanding (a), (b), (d) and (e), where direct investment by a Sub-Fund in a market is not in the best interests of investors, a Sub-Fund may invest through a wholly-owned subsidiary company established solely for the purpose of making direct investments in such market. In this case:
 - (1) the underlying investments of the subsidiary, together with the direct investments made by the Sub-Fund, must in aggregate comply with the requirements of Chapter 7 of the Code;
 - (2) any increase in the overall fees and charges directly or indirectly borne by the Unitholders or the Sub-Fund as a result must be clearly disclosed in this offering document; and
 - (3) the Sub-Fund must produce the reports required by the Code in a consolidated form to include the assets (including investment portfolio) and liabilities of the subsidiary company as part of those of the Sub-Fund;
- (g) notwithstanding (a), (b) and (d), not more than 30% of the Net Asset Value of the Sub-Fund may be invested in Government and other Public Securities of the same issue;
- (h) subject to (g), a Sub-Fund may fully invest in Government and other Public Securities in at least six different issues. Subject to the approval of the SFC, a Sub-Fund which has been authorised by the SFC as an index fund may exceed the 30% limit in (g) and may invest all of its assets in Government and other Public Securities in any number of different issues;
- (i) unless otherwise approved by the SFC on a case-by-case basis taking into account the liquidity of the physical commodities concerned and availability of sufficient and appropriate additional safeguards where necessary, a Sub-Fund may not invest in physical commodities;
- (j) for the avoidance of doubt, exchange traded funds that are:
 - (1) authorised by the SFC under Chapter 8.6 or Chapter 8.10 of the Code; or
 - (2) listed and regularly traded on internationally recognised stock exchanges open to the public (nominal listing not accepted) and (i) the principal objective of which is to track, replicate or correspond to a financial index or benchmark, which complies with the applicable requirements under Chapter 8.6 of the Code; or (ii) the investment objective, policy, underlying investments and product features of which are substantially in line with or comparable with those set out under Chapter 8.10 of the Code,may either be considered and treated as (x) listed securities for the purposes of and subject to the requirements in paragraphs (a), (b) and (d) above; or (y) collective investment schemes for the purposes of and subject to the requirements in paragraph (k) below. However, the investments in exchange traded funds shall be subject to paragraph (e) above and the relevant investment limits in exchange traded funds by a Sub-Fund should be consistently applied and clearly disclosed in this offering document;
- (k) where a Sub-Fund invests in shares or units of other collective investment schemes ("underlying schemes"),

- (1) the value of such Sub-Fund's investment in units or shares in underlying schemes which are non-eligible schemes (as determined by the SFC) and not authorised by the SFC may not in aggregate exceed 10% of the Net Asset Value of the Sub-Fund; and
- (2) such Sub-Fund may invest in one or more underlying schemes which are either schemes authorised by the SFC or eligible schemes (as determined by the SFC), but the value of the Sub-Fund's investment in units or shares in each such underlying scheme may not exceed 30% of the Net Asset Value of the Sub-Fund, unless the underlying scheme is authorised by the SFC and its name and key investment information are disclosed in this offering document,

provided that in respect of (1) and (2) above:

- (i) the objective of each underlying scheme may not be to invest primarily in any investment prohibited by Chapter 7 of the Code, and where that underlying scheme's objective is to invest primarily in investments restricted by Chapter 7 of the Code, such investments may not be in contravention of the relevant limitation prescribed by Chapter 7 of the Code. For the avoidance of doubt, a Sub-Fund may invest in scheme(s) authorised by the SFC under Chapter 8 of the Code (except for hedge funds under Chapter 8.7 of the Code), eligible scheme(s) (as determined by the SFC) of which the net derivative exposure (as defined in the Code) does not exceed 100% of its total net asset value, and exchange traded funds satisfying the requirements in paragraph (j) above in compliance with paragraph (k)(1) and (k)(2);
 - (ii) where the underlying schemes are managed by the same management company as that of a Sub-Fund that invests in them, or by other companies within the same group that the Manager belongs to, then paragraphs (a), (b), (d) and (e) above are also applicable to the investments of the underlying scheme;
 - (iii) the objective of the underlying schemes may not be to invest primarily in other collective investment scheme(s);
- (3) where an investment is made in any underlying scheme(s) managed by the Manager or any of its Connected Persons, all initial charges and redemption charges on the underlying scheme(s) must be waived; and
 - (4) the Manager or any person acting on behalf of the Sub-Fund or the Manager may not obtain a rebate on any fees or charges levied by an underlying scheme or the management company of an underlying scheme, or any quantifiable monetary benefits in connection with investments in any underlying scheme;
- (l) a Sub-Fund may invest 90% or more of its total Net Asset Value in a single collective investment scheme and may be authorised as a feeder fund by the SFC. In this case:
- (1) the underlying scheme ("**master fund**") must be authorised by the SFC;
 - (2) the relevant Appendix must state that:
 - (i) the Sub-Fund is a feeder fund into the master fund;
 - (ii) for the purpose of complying with the investment restrictions, the Sub-Fund and its master fund will be deemed a single entity;
 - (iii) the Sub-Fund's annual report must include the investment portfolio of the master fund as at the financial year end date; and
 - (iv) the aggregate amount of all the fees and charges of the Sub-Fund and its underlying master fund must be clearly disclosed;
 - (3) unless otherwise approved by the SFC, no increase in the overall total of initial charges, redemption charges, Manager's annual fee, or any other costs and charges payable to the Manager or any of its Connected Persons borne by the Unitholders or by the Sub-Fund may result, if the master fund in which the Sub-Fund invests is managed by the Manager or by its

Connected Person; and

- (4) notwithstanding paragraph (k)(iii) above, the master fund may invest in other collective investment scheme(s) subject to the investment restrictions as set out in paragraphs (k)(1) and (k)(2); and
- (m) if the name of the Sub-Fund indicates a particular objective, investment strategy, geographic region or market, the Sub-Fund should, under normal market circumstances, invest at least 70% of its Net Asset Value in securities and other investments to reflect the particular objective, investment strategy or geographic region or market which the Sub-Fund represents.

The Manager shall not, on behalf of the Sub-Fund:

- (A) invest in a security of any class in any company or body if any director or officer of the Manager individually owns more than 0.5% of the total nominal amount of all the issued securities of that class, or the directors and officers of the Manager collectively own more than 5% of those securities;
- (B) invest in any type of real estate (including buildings) or interests in real estate (including options or rights, but excluding shares in real estate companies and interests in real estate investment trusts (“REITs”)). In the case of investments in such shares and REITs, they shall comply with the investment limits as set out in Chapters 7.1, 7.1A, 7.2, 7.3 and 7.11 of the Code, where applicable. For the avoidance of doubt, where investments are made in listed REITs, Chapter 7.1, 7.1A and 7.2 of the Code apply and where investments are made in unlisted REITs, which are either companies or collective investment schemes, then Chapters 7.3 and 7.11 of the Code apply respectively;
- (C) make short sales if as a result such Sub-Fund would be required to deliver securities exceeding 10% of the Net Asset Value of such Sub-Fund (and for this purpose securities sold short must be actively traded on a market where short selling is permitted). For the avoidance of doubt, the Sub-Fund is prohibited to carry out any naked or uncovered short sale of securities and short selling should be carried out in accordance with all applicable laws and regulations;
- (D) lend or make a loan out of the assets of the such Sub-Fund, except to the extent that the acquisition of bonds or the making of a deposit (within the applicable investment restrictions) might constitute a loan;
- (E) subject to (e), assume, guarantee, endorse or otherwise become directly or contingently liable for or in connection with any obligation or indebtedness of any person, save and except for reverse repurchase transactions in compliance with the Code;
- (F) enter into any obligation in respect of such Sub-Fund or acquire any asset or engage in any transaction for the account of such Sub-Fund which involves the assumption of any liability which is unlimited. For the avoidance of doubt, the liability of Unitholders is limited to their investment in the relevant Sub-Fund; or
- (G) apply any part of such Sub-Fund in the acquisition of any investments which are for the time being nil paid or partly paid in respect of which a call is due to be made for any sum unpaid on such investments unless such call could be met in full out of cash or near cash forming part of such Sub-Fund whereby such amount of cash or near cash has not been segregated to cover a future or contingent commitment arising from transaction in FDIs for the purposes of Chapter 7.29 and 7.30 of the Code.

Note: The investment restrictions set out above apply to each Sub-Fund, subject to the following: A collective investment scheme authorised by the SFC under the Code is usually restricted from making investments which would result in the value of that collective investment scheme’s holdings of the securities of any single entity exceeding 10% of the collective investment scheme’s total net asset value. For a Sub-Fund authorised under Chapter 8.6 of the Code as an index tracking ETF, given the investment objective of the Sub-Fund and the nature of the Index, the relevant Sub-Fund is allowed under Chapter 8.6(h) of the Code to hold investments in constituent

securities of any single entity exceeding 10% of the relevant Sub-Fund's Net Asset Value if such constituent securities account for more than 10% of the weighting of the Index and the relevant Sub-Fund's holding of any such constituent securities does not exceed their respective weightings in the Index, except where the weightings are exceeded as a result of changes in the composition of the Index and the excess is only transitional and temporary in nature. However, the Manager may cause a Sub-Fund to deviate from the Index weighting (in pursuing a representative sampling strategy) under Chapter 8.6(h)(a) of the Code on the condition that (i) the representative sampling strategy must be clearly disclosed in this offering document, (ii) the excess of weightings of the constituent securities held by the Sub-Fund over the weightings in the Index must be caused by the implementation of the representative sampling strategy and (iii) the maximum deviation from the Index weighting of any constituent will not exceed the percentage as determined by the Manager after consultation with the SFC, as disclosed in the relevant Appendix. In determining this limit, the Sub-Fund must consider the characteristics of the underlying constituent securities, their weightings and the investment objectives of the Index and any other suitable factors. The Manager shall report to the SFC on a timely basis if there is any non-compliance with this limit. The annual and interim financial statements of the relevant Sub-Fund shall also disclose whether or not such limit has been complied with during such period and account for any non-compliance in those reports.

Borrowing restrictions

A Sub-Fund is permitted to borrow an amount up to a maximum of 10% of its Net Asset Value except that back-to-back loans will not be taken into account when determining whether or not such limit has been breached. Where the Manager so determines, a Sub-Fund's permitted borrowing level may be a lower percentage as set out in the relevant Appendix. The Trustee may at the request of the Manager borrow for the account of a Sub-Fund any currency for the following purposes:

- (1) facilitating the subscriptions or redemption of Units or defraying operating expenses;
- (2) enabling the Manager to acquire investments for the account of the Sub-Fund;
- (3) enabling the Manager to realise Units or to pay expenses of the Sub-Fund; or
- (4) for any other proper purpose, as the Manager and the Trustee may agree to.

The assets of a Sub-Fund may be charged or pledged to secure such borrowing for the account of such Sub-Fund.

Securities financing transactions

Currently, the Manager has no intention to have any securities lending, repurchase or similar over-the-counter transactions entered into for the account of the relevant Sub-Fund. In the future, where the Manager intends to have any securities lending, repurchase or similar over-the-counter transactions entered into for the account of the relevant Sub-Fund, subject to SFC's prior approval, 1 month's prior notice will be given to the relevant Unitholders.

Financial Derivative Instruments

Subject always to the provisions of the Trust Deed and the Code, the Manager may on behalf of a Sub-Fund enter into any transactions in relation to swaps or other FDI.

A Sub-Fund may acquire FDIs for non-hedging purposes ("**investment purposes**"), subject to the limit that a Sub-Fund's net exposure relating to these FDIs ("**net derivative exposure**") does not exceed 50% of its total Net Asset Value (unless otherwise approved by the SFC pursuant to Chapter 8 of the Code). For the avoidance of doubt:

- (a) for the purpose of calculating net derivative exposure, the positions of FDIs acquired by a Sub-Fund for investment purposes are converted into the equivalent position in the underlying assets of the FDIs, taking into account the prevailing market value of the underlying assets, the counterparty risk, future market movements and the time available to liquidate the positions; and
- (b) the net derivative exposure should be calculated in accordance with the requirements and guidance issued by the SFC which may be updated from time to time.

Subject to the above, a Sub-Fund may invest in FDIs provided that the exposure to the underlying assets of the

FDI, together with the other investments of the Sub-Fund, may not in aggregate exceed the corresponding investment restrictions or limitations applicable to such underlying assets and investments as set out in the relevant provisions of Chapter 7 of the Code.

For the avoidance of doubt, restrictions and limitations on counterparty as set out in paragraphs (a) and (b) under the section entitled "Investment restrictions" above and paragraph (c) below will not apply to FDIs that are (i) transacted on an exchange where the clearing house performs a central counterparty role; and (ii) marked-to-market daily in the valuation of their FDI positions and subject to margining requirements at least on a daily basis.

The FDIs invested by a Sub-Fund shall be either listed or quoted on a stock exchange, or dealt in over-the-counter market and comply with the following provisions:

- (a) the underlying assets consist solely of shares in companies, debt securities, money market instruments, units/shares of collective investment schemes, deposits with substantial financial institutions, Government and other Public Securities, highly-liquid physical commodities (including gold, silver, platinum and crude oil), financial indices, interest rates, foreign exchange rates or currencies or other asset classes acceptable to the SFC, in which a Sub-Fund may invest according to its investment objectives and policies. Where a Sub-Fund invests in index-based FDIs, the underlying assets of such FDIs are not required to be aggregated for the purposes of the investment restrictions or limitations set out in Chapters 7.1, 7.1A, 7.1B and 7.4 provided that the index is in compliance with the requirements under Chapter 8.6(e) of the Code;
- (b) the counterparties to over-the-counter FDI transactions or their guarantors are substantial financial institutions or such other entity acceptable to the SFC;
- (c) subject to paragraphs (a) and (b) under the section entitled "Investment Restrictions" above, the net counterparty exposure to a single entity arising from transactions of the over-the-counter FDIs may not exceed 10% of the Net Asset Value of the Sub-Fund. Exposure of the Sub-Fund to a counterparty of over-the-counter FDIs may be lowered by the collateral received (if applicable) by the Sub-Fund and shall be calculated with reference to the value of collateral and positive marked-to-market value of the over-the-counter FDIs with that counterparty, if applicable; and
- (d) the valuation of the FDIs is marked-to-market daily, subject to regular, reliable and verifiable valuation conducted by the Manager or the Trustee or their nominee(s), agent(s) or delegate(s) independent of the issuer of the FDIs through such measures as may be established from time to time. The FDIs can be sold, liquidated or closed by an offsetting transaction at any time at their fair value at the initiative of a Sub-Fund. Further, the calculation agent/fund administrator should be adequately equipped with the necessary resources to conduct independent marked-to-market valuation and to verify the valuation of the FDIs on a regular basis.

A Sub-Fund shall at all times be capable of meeting all its payment and delivery obligations incurred under transactions in FDIs. The Manager shall, as part of its risk management process, monitor to ensure that the transactions in FDIs are adequately covered on an ongoing basis. A transaction in FDIs which gives rise to a future commitment or contingent commitment of a Sub-Fund should also be covered as follows:

- in the case of FDI transactions which will, or may at a Sub-Fund's discretion, be cash settled, such Sub-Fund should at all times hold sufficient assets that can be liquidated within a short timeframe to meet the payment obligation; and
- in the case of FDI transactions which will, or may at the counterparty's discretion, require physical delivery of the underlying assets, a Sub-Fund should hold the underlying assets in sufficient quantity at all times to meet the delivery obligation. If the Manager considers the underlying assets to be liquid and tradable, a Sub-Fund may hold other alternative assets in sufficient quantity as cover, provided that such assets may be readily converted into the underlying assets at any time to meet the delivery obligation provided further that such Sub-Fund shall apply safeguard measures such as to apply haircut where appropriate to ensure that such alternative assets held are sufficient to meet its future obligations.

The above policies relating to FDIs apply to financial instruments which embed financial derivatives as well.

Although FDIs may be used (as aforesaid), they will not be used extensively for investment purpose.

Schedule 2 – Procedures for Creation and Redemption

Set out below is a summary of the provisions in the Trust Deed governing the cash and in-kind creation and redemption procedures to be followed by Participating Dealers.

This summary should be read in conjunction with the Trust Deed.

Procedures for Creation in Application Unit Size

The Manager has the exclusive right to effect, for the account of a Sub-Fund, the creation of Listed Class Units:

- in exchange for the transfer, by a Participating Dealer, to or for the account of a Sub-Fund, of the Index Constituent Stocks constituting a Basket for the relevant Listed Class Units and a cash amount equivalent to any Duties and Charges and Transaction Fee payable plus, if the Cash Component is a positive value, a cash payment equivalent to the amount of the Cash Component. If the Cash Component is a negative value, the Trustee shall be required to make a cash payment equivalent to the amount of the Cash Component (expressed as a positive figure) to the Participating Dealer. In the event that the relevant Sub-Fund has insufficient cash required to pay any Cash Component payable by such Sub-Fund, the Manager may effect sales of the deposited property of the relevant Sub-Fund, or may borrow moneys to provide the cash required; or
- in exchange for a cash payment, by a Participating Dealer, of an amount equivalent to the aggregate of the Issue Price multiplied by the number of Listed Class Units which is the subject of the cash creation application, provided that the Manager has the absolute discretion in deciding whether to accept such cash creation application.

The Manager has the right to reject a creation application or suspend receipt of creation applications if (i) in the opinion of the Manager, acceptance of the Index Constituent Stocks constituting a Basket would have certain adverse tax consequences for the relevant Sub-Fund; (ii) the Manager reasonably believes that the acceptance of the Index Constituent Stocks constituting a Basket would be unlawful; (iii) the acceptance of the Index Constituent Stocks constituting a Basket would otherwise, in the opinion of the Manager, have an adverse effect on the relevant Sub-Fund; (iv) circumstances outside the control of the Manager make it for all practicable purposes impossible to process creation applications or (v) the Manager has suspended the rights of Participating Dealers pursuant to the Trust Deed.

Currently, under the Dual Counter arrangement (where adopted for the relevant Sub-Fund), a Participating Dealer may subject to arrangement with the Manager elect to CCASS to have Listed Class Units which it creates deposited in either HKD counter or RMB counter. However, the cash creation of new Listed Class Units in a special creation application is in HKD only and the Listed Class Units created in a special creation application can be deposited in HKD counter only. Once the Listed Class Units are created, the Manager shall effect, for the account of the relevant Sub-Fund, the issue of Listed Class Units to a Participating Dealer in accordance with the Operating Guidelines.

Currently, the Listed Class Units are denominated in HKD (unless otherwise determined by the Manager) and no fractions of a Listed Class Unit shall be created or issued by the Trustee unless otherwise specified in the relevant Appendix.

An application for the creation and issue of Listed Class Units shall only be made or accepted (as the case may be) on a Dealing Day, shall only be in respect of Listed Class Units constituting an Application Unit size or whole multiples thereof and shall only be accepted if made by or through a Participating Dealer in accordance with the terms of a Participation Agreement.

The creation and issue of Listed Class Units pursuant to a creation application shall be effected on the Dealing Day on which the creation application is received (or deemed received) and accepted in accordance with the Operating Guidelines but, for valuation purposes only, Listed Class Units shall be deemed created and issued after the Valuation Point on the Dealing Day on which the relevant creation application was received or deemed received and the register of the relevant Sub-Fund will be updated on Settlement Day.

If a creation application is received on a day which is not a Dealing Day or is received after the Dealing Deadline on a Dealing Day, that creation application shall be treated as having been received at the opening of business on

the next following Dealing Day, which shall be the relevant Dealing Day for the purposes of that creation application.

No Listed Class Units shall be issued to any Participating Dealer unless:

- the application is in a form and substance satisfactory to, and accompanied by such documents as may be required by, the Trustee and the Manager in accordance with the Operating Guidelines;
- the Trustee and the Manager receive copies of the certifications required under the Participation Agreement in respect of the creation of new Listed Class Units; and
- the Trustee and the Manager receive such other certifications and opinions of counsel as each may consider necessary to ensure compliance with applicable securities laws and other laws in relation to the creation and issue of Listed Class Units which are the subject of the creation application.

The Manager may charge the Participating Dealer on the creation application such amount or rate (if any) as the Manager may consider represents the appropriate provision for Duties and Charges and the Transaction Fee. The Duties and Charges and the Transaction Fee shall be paid by or on behalf of the Participating Dealer applying for such Listed Class Units (and may be set off and deducted against any Cash Component due to the Participating Dealer in respect of such creation application(s)), for the account of the relevant Sub-Fund, the Trustee, the Registrar, the Conversion Agent and/or the Service Agent.

Any commission, remuneration or other sum payable by the Manager to any agent or other person in respect of the issue or sale of any Listed Class Unit shall not be added to the Issue Price of such Listed Class Unit and shall not be paid from the deposited property of the relevant Sub-Fund.

The Trustee shall be entitled to refuse to enter (or allow to be entered) Listed Class Units in the register if at any time the Trustee is of the opinion that the provisions of the Trust Deed, in regard to the issue of Units, are being infringed.

Cancellation of Listed Class Units

The Trustee shall cancel Listed Class Units created and issued in respect of a creation application if:

- in relation to an in-kind creation application, all the Index Constituent Stocks constituting the Basket deposited for exchange have not been vested by or on the relevant Settlement Day in the relevant Sub-Fund or to the Trustee's satisfaction or evidence of title and instruments of transfer satisfactory to the Trustee have not been produced to or to the order of the Trustee; or the full amount of (i) the Cash Component (if applicable) and (ii) any Duties and Charges and Transaction Fee payable have not been received in cleared funds by or on behalf of the Trustee by such time on the Settlement Day as prescribed in the Operating Guidelines; or
- in relation to a cash creation application, (i) the cash payment representing the aggregate of the Issue Price multiplied by the number of Listed Class Units which is the subject of the cash creation application; or (ii) any Duties and Charges and Transaction Fee payable have not been received in cleared funds by or on behalf of the Trustee by such time on the Settlement Day as prescribed in the Operating Guidelines,

provided that, in either event the Manager may, in its discretion, with the approval of the Trustee, extend the settlement period (either for the creation application as a whole or for a particular Index Constituent Stock or Index Constituent Stocks) such extension to be on such terms and conditions (including as to the payment of an Extension Fee to the relevant Sub-Fund) as the Manager may determine.

Upon the cancellation of any Listed Class Units as provided for above or if a Participating Dealer otherwise withdraws a creation application other than in the circumstances contemplated in the Trust Deed, such Index Constituent Stocks constituting the Basket deposited for exchange (or equivalent Index Constituent Stocks of the same type) as have been vested in the relevant Sub-Fund and any cash received by or on behalf of the relevant Sub-Fund in connection with a creation application (in respect of such cancelled Listed Class Units) shall be redelivered to the Participating Dealer and the relevant Listed Class Units shall be deemed for all purposes never to have been created and the applicant therefore shall have no right or claim against the Manager or the Trustee in respect of such cancellation provided that:

- the Manager may charge the Participating Dealer for the account of the relevant Sub-Fund an Application Cancellation Fee and such other fees and amounts in accordance with the Participation Agreement (including the Operating Guidelines); and
- no previous valuations of the relevant Sub-Fund shall be re-opened or invalidated as a result of the cancellation of such Listed Class Units.

Manager's Discretion to Accept Cash for Creation and Issue of Listed Class Units

- If the Manager determines in its discretion (following an in-kind creation application by a Participating Dealer) that Index Constituent Stocks are likely to be unavailable for delivery or available in insufficient quantity for delivery to the Trustee in connection with a creation application; or
- if the Manager (following an in-kind creation application by a Participating Dealer) is satisfied that, in connection with the issue of any Listed Class Units, the Participating Dealer in question is prevented by regulation or otherwise from investing or engaging in a transaction in any Index Constituent Stock,

then the Manager shall have the right, in its discretion, to accept cash (currently in HKD notwithstanding a Dual Counter being adopted for the relevant Sub-Fund) equal to the market value at the Valuation Point for the relevant Dealing Day of such Index Constituent Stocks in lieu of accepting such Index Constituent Stocks as constituting part of the relevant Basket provided that the Manager shall be entitled in its discretion to charge (for the account of the relevant Sub-Fund) to the applicant of any Listed Class Units for which cash is paid in lieu of delivering any Index Constituent Stocks such additional sum as represents the appropriate provision for Duties and Charges.

Manager's Discretion to Accept Cash Collateral

If the Manager determines in its discretion (following a partial delivery request by a Participating Dealer) that any Index Constituent Stocks are likely to be unavailable for delivery or available in insufficient quantity for delivery to the Trustee in connection with a creation application, then the Manager shall have the right in its discretion to accept an amount of cash (currently in HKD notwithstanding a Dual Counter being adopted for the relevant Sub-Fund) determined by reference to the market value at the Valuation Point for the relevant Dealing Day of such Index Constituent Stocks as collateral for such Index Constituent Stock(s) until they are delivered.

Any such collateral will be held for the account of the relevant Sub-Fund in a non-interest bearing account and shall be redelivered to the Participating Dealer after delivery of such Index Constituent Stocks (by 4:00 p.m. on the Delivery Date if such Index Constituent Stocks have been successfully debited by 2:00 p.m. on the Delivery Date or, by 2:00 p.m. on the Dealing Day immediately following the Delivery Date if such Index Constituent Stocks have been successfully debited after 2:00 p.m. on the Delivery Date) or, immediately upon demand in the circumstances described in (b) below.

The unavailable Index Constituent Stocks will be marked to market daily by the Manager by reference to their closing price on the previous trading day and if the cash collateral (a) falls below the prescribed percentage of such market value, the Manager may, in its discretion, request the Participating Dealer to provide additional cash collateral to make up the shortfall; or (b) exceeds the prescribed percentage of such market value, the Manager shall inform the Participating Dealer and shall offer to return any such excess cash collateral to the Participating Dealer.

The Manager may, subject to the provisions of the Participation Agreement, charge the Participating Dealer for the account of the relevant Sub-Fund a Partial Delivery Request Fee.

Procedures For Redemption in Application Unit Size

The Manager has the exclusive right, at any time and from time to time following a redemption application (whether in cash or in-kind) made by a Participating Dealer in accordance with the Operating Guidelines, by notice in writing to the Trustee to effect a reduction of the relevant Sub-Fund on the relevant Settlement Day by the order of the Trustee for the cancellation of the Listed Class Units represented thereby and by requiring the Trustee to cancel the number of Listed Class Units specified in such notice.

Notwithstanding a Dual Counter being adopted for the relevant Sub-Fund, currently any cash proceeds received

by an HS Fund in a special redemption application in cash shall be paid in HKD and only Listed Class Units in the HKD counter can be withdrawn directly in a special redemption application. However, both HKD traded Listed Class Units and RMB traded Listed Class Units may be redeemed by way of a redemption application through a Participating Dealer. Where a Participating Dealer wishes to redeem RMB traded Listed Class Units the redemption process is the same as for HKD traded Listed Class Units.

A redemption application shall only be made or accepted (as the case may be) on a Dealing Day and shall only be in respect of Listed Class Units constituting an Application Unit size or whole multiples thereof and shall only be accepted if made by or through a Participating Dealer in accordance with the terms of a Participation Agreement.

If a redemption application is received on a day which is not a Dealing Day or is received after the Dealing Deadline on a Dealing Day, that redemption application shall be treated as having been received at the opening of business on the next following Dealing Day, which shall be the relevant Dealing Day for the purposes of that redemption application. For the purpose of valuation, the relevant Valuation Point shall be the Valuation Point for the Dealing Day on which the redemption application is treated as having been received.

The Manager shall, on receipt of an effective redemption application for the relevant Sub-Fund from a Participating Dealer, effect the redemption of the relevant Listed Class Units and shall require the Trustee to:

- in relation to a redemption application in kind, transfer to the Participating Dealer the appropriate number of Index Constituent Stocks constituting the Basket for the relevant Listed Class Units plus, where the Cash Component is a positive value, a cash payment equivalent to the amount of the Cash Component; or
- in relation to a redemption application in cash, pay cash out of the relevant Sub-Fund of an amount equal to the aggregate of the Redemption Price multiplied by the number of Listed Class Units which is the subject of the cash redemption application.

In the event that the Sub-Fund has insufficient cash required to pay any Cash Component payable by such Sub-Fund, the Manager may effect sales of the deposited property of the Sub-Fund, or borrow moneys to provide the cash required. If the Cash Component is a negative value, the Participating Dealer shall be required to make a cash payment equivalent to the amount of the Cash Component (expressed as a positive figure) to or to the order of the Trustee.

To be effective, a redemption application must:

- be given by a Participating Dealer in accordance with the Participation Agreement;
- specify the number and class of Application Units which is the subject of the redemption application; and
- include the certifications required in the Operating Guidelines in respect of redemptions of Listed Class Units, together with such certifications and opinions of counsel as the Trustee and the Manager may consider necessary to ensure compliance with applicable securities laws and other laws in relation to the redemption of Listed Class Units which are the subject of the redemption application.

A redemption application once given cannot be revoked or withdrawn without the consent of the Manager. The HKCAS may charge a Unit Cancellation Fee in connection with each accepted redemption application.

The Manager may charge the Participating Dealer on the redemption application such amount or rate (if any) as the Manager may consider represents the appropriate provision for Duties and Charges and the Transaction Fee. The Transaction Fee may on any day vary, but not as between different Participating dealers in respect of the relevant Sub-Fund. The Duties and Charges and the Transaction Fee shall be paid by or on behalf of the Participating Dealer submitting the redemption application(s) for such Listed Class Units (and may be deduct from and set off against any Cash Component other cash to a Participating Dealer in respect of such redemption application(s)), for the account of the relevant Sub-Fund, the Trustee, the Registrar, the Conversion Agent and/or the Service Agent.

To the extent that the Cash Component is insufficient to pay such Duties and Charges and the Transaction Fee payable on such redemption the Participating Dealer shall promptly pay the shortfall in the base currency of the relevant Sub-Fund to or to the order of the Trustee. The Trustee shall not be obliged to deliver (and shall have a

general lien over) the Index Constituent Stocks constituting the Basket to be transferred or cash payable in respect of the relevant redemption application until such shortfall and any Cash Component, Transaction Fee and Extension Fee payable by the Participating Dealer is paid in full in cleared funds to or to the order of the Trustee.

Unless specifically requested to do so by the Participating Dealer concerned, not later than one month after the relevant Dealing Day, the Trustee shall be under no obligation to check the calculation of the Redemption Price in connection with any redemption or cancellation of Listed Class Units but shall be entitled at any time before the audited financial report of the relevant Sub-Fund, covering the relevant Dealing Day, have been prepared, to require the Manager to justify its calculation of the Redemption Price.

Any Index Constituent Stocks transferable and Cash Component or other cash payable (less any amount deducted) to a Participating Dealer in respect of a redemption application may be transferred or paid sooner but shall be transferred and paid on the Settlement Day, provided that a redemption application duly signed by a Participating Dealer (to the satisfaction of the Manager and, where any amount is to be paid by telegraphic transfer to a bank account, verified in such manner as may be required by, and to the satisfaction of, the Trustee) has been received in accordance with the Operating Guidelines and the full amount of any Cash Component payable by the Participating Dealer and any Duties and Charges and the Transaction Fee payable have been deducted or otherwise paid in full.

On the relevant Settlement Day in relation to an effective redemption application:-

- the Listed Class Units, which are the subject of the redemption application, shall be redeemed and cancelled;
- the relevant Sub-Fund shall be reduced by the cancellation of those Listed Class Units but, for valuation purposes only, such Listed Class Units shall be deemed to have been redeemed and cancelled after the Valuation Point as at the Dealing Day on which the redemption application was received; and
- the name of the holder of such Listed Class Units shall be removed from the register in respect of those Listed Class Units on the relevant Settlement Day,

the Trustee shall transfer the Index Constituent Stocks constituting the Basket relevant to the in-kind redemption application out of the deposited property of the relevant Sub-Fund or cash out of the relevant Sub-Fund equal to the relevant Redemption Price multiplied by the number of Listed Class Units which is the subject of the cash redemption application to the Participating Dealer and shall pay any Cash Component (with such deductions as are permitted by the Trust Deed) payable by the Trustee.

No Index Constituent Stocks shall be transferred and no Cash Component and cash shall be paid in respect of any redemption application unless the requisite documents in respect of the Listed Class Units which are the subject of the redemption application have been delivered to the Manager by such time on the Settlement Day as the Trustee and the Manager shall for the time being prescribe for redemption applications generally.

In the event that such documents are not delivered to the Manager in accordance with the foregoing:

- the redemption application shall be deemed never to have been made except that the Transaction Fee in respect of such application shall remain due and payable and once paid, shall be retained by and for the account of the relevant Sub-Fund, the Trustee, the Registrar, the Conversion Agent and/or the Service Agent;
- the Manager may charge the Participating Dealer for the account of the relevant Sub-Fund an Application Cancellation Fee and such other fees and amounts in accordance with the Participation Agreement (including the Operating Guidelines); and
- no previous valuations of the relevant Sub-Fund shall be re-opened or invalidated as a result of an unsuccessful redemption application.

The Manager, with approval of the Trustee, may at its discretion extend the settlement period with respect to a redemption application, such extension to be on such terms and conditions (including as to the payment of an Extension Fee to the relevant Sub-Fund) as the Manager may determine but, in any event, not later than one month from the receipt of an effective redemption application.

Deferred redemption

In the event that redemption requests are received for the redemption of Units representing in aggregate more than 10% of the total Net Asset Value of Units in the Sub-Fund then in issue, the Manager may direct the Trustee to reduce the requests rateably and pro rata amongst all Unitholders seeking to redeem Units on the relevant Dealing Day and carry out only sufficient redemptions which, in aggregate, amount to 10% of the total Net Asset Value of Units in the Sub-Fund then in issue. Units which are not redeemed but which would otherwise have been redeemed will be redeemed on the next Dealing Day (subject to further deferral if the deferred requests in respect of the Sub-Fund themselves exceed 10% of the total Net Asset Value of Units in the Sub-Fund then in issue) in priority to any other Units in the Sub-Fund for which redemption requests have been received. Units will be redeemed at the Redemption Price prevailing on the Dealing Day on which they are redeemed. Such redemption gate applies to redemption applications in cash only for both Listed Class Units and Unlisted Class Units.

Application Unit	in respect of a Listed Class, such number of Units of a Listed Class or whole multiples thereof as specified in this offering document or such other multiple of Units of a Listed Class from time to time determined by the Manager and approved by the Trustee
Authorised Distributor	in respect of an Unlisted Class, a distributor appointed by the Manager to market, promote, sell and/or distribute Unlisted Class Units in one or more Sub-Fund(s), and to receive applications for subscription, redemption and/or switching of Unlisted Class Units
Authorised Fund	a Collective Investment Scheme that is authorised by the SFC pursuant to Section 104(1) of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (SFC authorisation is not a recommendation or endorsement of a Collective Investment Scheme nor does it guarantee the commercial merits of a Collective Investment Scheme or its performance. It does not mean the Collective Investment Scheme is suitable for all investors nor is it an endorsement of its suitability for any particular investor or class of investors.)
Basket	a portfolio of Index Constituent Stocks based on the stock weightings in the Index on the relevant Dealing Day for the purpose of an in-kind creation or an in-kind redemption of Units
Business Day	unless the Manager and the Trustee otherwise agree, a day on which (a)(i) the SEHK is open for normal trading; and (ii) the relevant securities market on which Securities comprised in the relevant Index are traded is open for normal trading or if there are more than one such securities market, the securities market designated by the Manager is open for normal trading, and (b) the relevant Index is compiled and published, or such other day or days as the Manager and the Trustee may agree from time to time provided that if on any such day, the period during which the relevant securities market is open for normal trading is reduced as a result of a Number 8 Typhoon Signal, Black Rainstorm warning or other similar event, such day shall not be a Business Day unless the Manager and the Trustee otherwise agree
Cash Component	the difference between (i) the aggregate Net Asset Value of the Units comprising an Application Unit (in the case of a Participating Dealer Application) or of such other number of Units as determined by the Manager from time to time (in the case of a Special Application) and (ii) the value of the applicable Basket

CCASS	the Central Clearing and Settlement System established and operated by HKSCC
CCASS Participant	a participant in CCASS
CCASS Settlement Day	a settlement day as determined by HKSCC for CCASS
Code	the Code on Unit Trusts and Mutual Funds issued by the SFC, as amended from time to time and any successor instruments thereto
Collective Investment Scheme	has the same meaning as in the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong)
Connected Person	has the meaning as set out in the Code which at the date of this offering document means in relation to a company: <ul style="list-style-type: none"> (a) any person or company beneficially owning, directly or indirectly, 20% or more of the ordinary share capital of that company or able to exercise directly or indirectly, 20% or more of the total votes in that company; (b) any person or company controlled by a person who or which meets one or both of the descriptions given in (a); (c) any member of the group of which that company forms part; or (d) any director or officer of that company or of any of its connected persons as defined in (a), (b) or (c)

Dealing Deadline	in relation to any particular place and any particular Dealing Day, means the time on each Dealing Day specified in the Appendix of a Sub-Fund
