## CHAIRMAN'S STATEMENT

主席報告書





Dear Shareholders,

I would like to thank you for your long term trust and support of Huarong Energy. On behalf of the Huarong Energy Board, I am pleased to present our results for the year ended 31 December 2023.

In 2023, the international situation was uncertain and fluctuated, with the impact of the geopolitical turmoil of the Russia-Ukraine conflict and the Israeli-Palestinian conflict, as well as the impact of high interest rates due to the Fed's interest rate hike, which resulted in a precarious global economy due to a slowdown in the growth of demand, weakened upstream investment, and the expansion of debt. Crude oil and its downstream products, as the most important commodities, also experienced macroeconomic pressures, risks of supply disruptions and constraints from expectations of falling demand.

At the same time, the Group's oil extraction segment has been, to a certain extent, troubled with the recurrence of the COVID-19 pandemic and under the impact of the crude oil export ban by Kyrgyzstan and the war between Russia and Ukraine.

Looking forward, the prospects for the oilfield development in Kyrgyzstan remain positive with the increasing demand for fossil fuels in the global market, particularly in developing countries in Central Asia, and the expected stabilization of oil and gas prices. However, the economy and energy market in Kyrgyzstan may be also subjected to uncertainties from factors, such as geopolitical conflicts, high inflation and high interest rate pressures, which may affect the situation of oilfield development and operation. Therefore, for the management of the Group, it is necessary to pay close attention to market dynamics and technological development trends in order to formulate reasonable strategies and plans to cope with challenges and opportunities in the future.

In terms of the oil storage segment of the Group, the management believes that China's economy will continue to rebound and support the growth of oil demand, and that China's oil demand will rise steadily. As a storage enterprise of oil, we need to seize the market opportunities, improve our storage services, enhance our core competitiveness and seek development amidst opportunities and challenges.

二零二三年,國際形勢波譎雲詭,俄烏衝 突、巴以衝突的地緣動盪以及美聯儲加息 導致高利率衝擊等影響,需求增速放緩、 上游投資減弱,而債務擴大,全球經濟風 雨飄搖。作為最重要的大宗商品的原油及 其下游產品同樣經歷了來自宏觀經濟的壓 力,供應中斷的風險和需求下降預期的制 約。

與此同時,隨著新冠肺炎疫情反覆、受吉 爾吉斯原油出口禁令和俄、烏戰爭影響, 給集團石油開採板塊造成了一定的困擾。

對於集團油儲板塊,管理層認為中國經濟 持續回升向好支撐石油需求增長,中國石 油需求將穩中有升。作為倉儲企業需抓住 市場機遇,提高倉儲服務水平,提升核心 競爭力,在機遇與挑戰中尋求發展。

## MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論與分析





### **Business Review**

Under tough industrial market in China and escalation of geopolitical tensions, the Group's revenue decreased to RMB82.6 million for the year ended 31 December 2023 (the "**Year**"), compared to revenue of approximately RMB102.8 million for the year ended 31 December 2022 (the "**Comparative Year**"). The Group generated a gross profit of RMB31.5 million (for the Comparative Year: RMB45.8 million) from the oil exploration business, as well as the oil storage business.

Loss attributable to the equity holders of the Company was approximately RMB526.4 million for the Year, while loss attributable to the equity holders of the Company was RMB682.7 million for the Comparative Year.

The decrease of loss attributable to equity holders of the Company was mainly driven by the stabilization of currency exchange fluctuation. The Group recorded a net foreign exchange loss of RMB125.5 million during the Year, which was mainly caused by the significant appreciation of borrowings denominated in USD and Hong Kong dollar. This is compared with a foreign exchange loss of the Group of RMB332.4 million for the Comparative Year.

#### **Disposal and Relevant Guarantee**

On 9 October 2018, the Company entered into a conditional sale and purchase agreement [the "Agreement"] to dispose of the core assets and liabilities of its shipbuilding, offshore engineering, engineering machinery and marine engine building segments [the "Shipbuilding and Engineering Businesses", together with the holding company of the Shipbuilding and Engineering Businesses, referred to as the "Disposal Group"] with an independent third party, Unique Orient Limited [the "Purchaser"] [the "Disposal"]. The Disposal constituted a very substantial disposal for the Company under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited [the "Listing Rules"]. An extraordinary general meeting of the Company was held on 13 December 2018 in which the Disposal was approved by the shareholders.

The Company signed the second supplemental agreement on 3 March 2019 regarding the Disposal, pursuant to which (1) the transfer of the sale share of Able Diligent Limited (the "**Sale Share**"), the holding company of Disposal Group, to the Purchaser shall take place on or before 31 March 2019; (2) the Purchaser agreed to procure the release or discharge of the relevant guarantees provided by the Company in respect of borrowings owed by the Disposal Group (the "**Relevant Guarantees**"); and (3) the Purchaser agreed to execute a share charge over the Sale Share in favour of the Company.

### 業務回顧

在中國嚴峻的工業市場及地緣政治緊張局 勢升級的情况下,本集團於截至二零二三 年十二月三十一日止年度(「本年度」)錄得 的收益減少至人民幣82.6百萬元,而截至 二零二二年十二月三十一日止年度(「可比年 度」)的收益約為人民幣102.8百萬元。本集 團主要自石油勘探業務以及油儲業務產生 毛利潤人民幣31.5百萬元(於可比年度:人 民幣45.8百萬元)。

本公司權益持有人於本年度應佔虧損約為 人民幣526.4百萬元,而本公司權益持有人 於可比年度應佔虧損為人民幣682.7百萬 元。

本公司權益持有人應佔虧損減少主要由於 匯兑波動趨於穩定所致。本集團於本年度 錄得外匯虧損淨額人民幣125.5百萬元,主 要由於以美元及港元計值的借款出現大幅 升值所致。相較之下,本集團於可比年度 則錄得外匯虧損人民幣332.4百萬元。

#### 出售事項及相關擔保

於二零一八年十月九日,本公司已與獨立第 三方東唯有限公司(「**買方**」)訂立有條件買 賣協議(「協議」),以出售造船、海洋工程、 工程機械及動力工程板塊(「造船及工程業 務」,連同造船及工程業務控股公司統稱 為「出售集團」)的核心資產及負債(「出售事 項」)。根據香港聯合交易所有限公司證券 上市規則(「上市規則」),出售事項構成本 公司非常重大的出售事項。本公司於二零 一八年十二月十三日舉行股東特別大會, 其中出售事項已獲股東批准。

本公司於二零一九年三月三日就出售事項 簽訂第二份補充協議,據此(1)出售集團之 控股公司Able Diligent Limited將於二零一九 年三月三十一日或之前向買方轉讓銷售股 份(「銷售股份」);[2]買方同意促成免除或 解除本公司就出售集團借款所提供的相關 擔保(「相關擔保」);及[3]買方同意以本公 司為受益人就銷售股份訂立股份質押。



The Disposal was completed on 10 March 2019 (the "**Disposal Day**") when the Sale Share was transferred to the Purchaser. All the assets and liabilities associated with the Disposal, except the financial guarantee contract as mentioned hereafter, were derecognized on the Disposal Day. The Company signed the third, fourth, fifth and sixth supplemental agreements on 29 August 2019, 30 October 2019, 25 March 2021 and 25 March 2022, respectively. According to the latest supplemental agreements, the Purchaser will procure the release or discharge of the Relevant Guarantees and complete the relevant registration in due course.

The Group and the Purchaser have been working closely to procure the release or discharge of all remaining Relevant Guarantees in full and it was agreed that all debts owing by the Disposal Group will be assigned to the Purchaser when the Relevant Guarantees have been released or discharged in full and the relevant registrations have been completed.

Despite there has been no Relevant Guarantees discharged in the Year, the Company has taken the following actions in respect of the release and discharge of the Relevant Guarantees since the Disposal Day:

- the Company has ongoing discussions with the Purchaser on a regular basis regarding the status and progress of the release or discharge of the Relevant Guarantees;
- the Company, together with the Purchaser, has been actively negotiating with the relevant banks and lenders to release or discharge the Relevant Guarantees; and
- (iii) the Company is also maintaining its relationship with the banks and the lenders of the Disposal Group so that no action will be taken by them to demand immediate repayment of its outstanding borrowings under the Relevant Guarantees.

出售事項已於二零一九年三月十日(「**出售** 日」)完成,銷售股份已轉讓予買方。與出 售事項有關的所有資產及負債(下文所提 述的財務擔保合約除外)均於出售日終止確 認。本公司分別於二零一九年八月二十九 日、二零一九年十月三十日、二零二一年三 月二十五日及二零二二年三月二十五日訂 立第三份、第四份、第五份及第六份補充 協議。根據最新補充協議,買方將促成免 除或解除相關擔保,並於適當時候完成相 關登記。

本集團及買方一直就促成全部免除或解除 所有餘下的相關擔保緊密合作及同意當相 關擔保全部免除或解除及相關登記手續 完成時,出售集團之所有債務將由買方承 擔。

儘管於本年度並無解除相關擔保,本公司 自出售日起已就免除及解除相關擔保採取 以下行動:

- (i) 本公司定期與買方就免除或解除相關 擔保的狀況和進度進行持續討論;
- (ii) 本公司與買方一直積極與相關銀行及 貸款人磋商,以免除或解除相關擔保;及
- (iii) 本公司亦維持其與銀行及出售集團的 貸款人的關係,以確保彼等不會採取 行動要求即時償還相關擔保項下的未 償還借款。



The Company and/or the Purchaser (as appropriate) have prepared and submitted discharging proposals to the relevant banks and lenders since 2018, with an initial goal of discharging the Relevant Guarantees in batches by 2020. However, despite that the above actions had been taken by the Company and the Purchaser, the Relevant Guarantees could not be fully discharged in the period from 2020 to 2023 because of (1) the ongoing distraction and suspension of business caused by the novel coronavirus pneumonia (the "COVID-19") throughout 2020, 2021 and 2022; (2) outbreaks of more contagious COVID-19 variants and lockdown in major cities in Mainland China in 2022; and (3) the fact that the discharging process of banks was time-consuming and procedurally and administratively complicated, particularly given that each bank or lender would have its own internal review procedures as well as approval hierarchy. As the discharging progressed further, additional time was required for the relevant banks and lenders to conduct their internal risk assessment in respect of the discharging proposals. As the Company is only in the capacity as the guarantor of the Relevant Guarantees, the Company may not always be in the position to negotiate with the relevant banks and lenders concerning certain financial conditions or obligations which would be imposed on the Purchaser. Such discussions could only be initiated by the Purchaser, and the Company would not have control over the relevant progress and timing.

Nonetheless, both the Company and the Purchaser are committed to procuring the full discharge of the Relevant Guarantees by 2024.

As at the date of this report, the latest status of the Relevant Guarantees (classified by the Company as Relevant Guarantees A to D for ease of reference) and the expected time for discharging are summarised as follows: 本公司及/或買方(視情況而定)自二零一八 年起已編製並向相關銀行及貸款人提交解 除擔保建議,初步目標為於二零二零年前 分批解除相關擔保。然而,儘管本公司及 買方已採取上述行動,但相關擔保未能於 二零二零年至二零二三年期間全部解除, 乃因為[1]新型冠狀病毒肺炎(「COVID-19」)於 二零二零年、二零二一年及二零二二年持 續影響業務運作及導致停業;[2]中國大陸 主要城市於二零二二年爆發更具傳染性的 COVID-19變種並導致封鎖;及[3]銀行的解除 過程耗時,並且在程序及管理上很複雜, 特別是各銀行或貸款人有其自身的內部審 查程序和審批層級。隨著解除擔保工作的 進一步推進,相關銀行及貸款人需要更多 時間就解除擔保建議進行內部風險評估。 由於本公司僅作為相關擔保的擔保人,本 公司未必總能與相關銀行及貸款人就若干 財務狀況或將會對買方施加的責任進行磋 商。該等討論只能由買方發起,而本公司 將無法控制相關進度和時間。

儘管如此,本公司及買方均致力於促使相 關擔保在二零二四年以內全部解除。

As at 31 December 2023 and the date of this report, the Relevant Guarantees provided by the Company to the Disposal Group in the process of being discharged or released amounted to RMB6,021.8 million (31 December 2022: RMB5,827.9 million), inclusive of principals and interests. In consideration of such financial guarantees, the Group recognized financial guarantee contracts of RMB5,036.9 million (31 December 2022: RMB4,873.0 million) which will be released upon the releasing or discharging of these Relevant Guarantees.

Details of the Disposal were disclosed in note 18 of the 2019 annual report, and the announcements of the Company dated 9 October 2018, 15 November 2018, 25 December 2018, 4 March 2019, 11 March 2019, and the circular of the Company dated 23 November 2018.

於二零二三年十二月三十一日及本報告日 期,本公司向出售集團提供在解除或免除 過程中的相關擔保(包括本金及利息),金 額為人民幣6,021.8百萬元(二零二二年十二 月三十一日:人民幣5,827.9百萬元)。作為該 等財務擔保的代價,本集團確認財務擔保 合約人民幣5,036.9百萬元(二零二二年十二 月三十一日:人民幣4,873.0百萬元),將於 免除或解除該等相關擔保後免除。

出售事項的詳情披露於二零一九年年報附 註18、本公司日期為二零一八年十月九日、 二零一八年十一月十五日、二零一八年十二 月二十五日、二零一九年三月四日及二零 一九年三月十一日之公告以及本公司日期 為二零一八年十一月二十三日之通函。



#### **Debt Restructuring**

Together with the Disposal, the Group has also conducted the following measures to optimize its debt structure with an aim to ease the financial burden of the Group. The lenders have been supportive in general to the Group and the overall situation has been improved over the years.

(a) Repayment of a secured loan

The secured loan was secured by certain assets of the Disposal Group, and the Group has bundled the settlement of the loan in together with Relevant Guarantees D. This loan was a secured bank loan and has been transferred to an independent financial institution in December 2021.

It is the intention of the Company to repay such secured loan by utilizing the US dollar facility entered with a shareholder of the Company (the "**Shareholder**") in 2018 (the "**Facility**"). The Facility has a total amount of USD250 million. It is an interest-free and unsecured facility with a maturity date of 31 December 2025. The Company expects to utilise the Facility to repay the outstanding secured loan in batches and all such repayments shall be made by the end of 2024. Based on the best knowledge and information available to the Company after discussions with the Shareholder, the Shareholder is committed to providing the Facility required by the Company to settle the outstanding secured loan in full in 2024.

(b) Extension of maturity date of promissory notes As at 31 December 2023, the Company had outstanding promissory notes of RMB2.4 billion (31 December 2022: RMB2.4 billion).

The Company has been in continuous discussions and negotiations with the promissory noteholders with the objective of obtaining their agreements to extend the overdue liabilities during the Year. The management of the Company has taken a proactive approach and had numerous discussions with all the promissory noteholders regarding the extension of maturity dates of the promissory notes. By 31 December 2023, the maturity date of promissory notes with aggregate principal amount of RMB1,144.3 million were successfully extended to December 2025.

#### 債務重組

進行出售事項的同時,本集團亦已實施以 下優化債務結構的措施,旨在減輕本集團 的財務負擔。貸款人對本集團表示支持, 且整體情況近年來已有所改善。

(a) 償還有抵押貸款

有抵押貸款以出售集團的若干資產作 抵押,本集團已將清償貸款與相關擔 保D一同捆綁。該貸款為有抵押銀行 貸款並已於二零二一年十二月轉讓予 一家獨立金融機構。

本公司有意動用與本公司一名股東(「**該** 股東」)於二零一八年訂立的美元融資 (「融資」) 償還該有抵押貸款。融資總 額為250百萬美元,為免息無抵押,到 期日為二零二五年十二月三十一日。 本公司預期將動用融資分批償還的 有抵押貸款,所有該等還款預 於二零二四年年底前償還。經與該股 東,以於二零二四年全額結清未償還 有抵押貸款。

(b) 延長承兑票據到期日 於二零二三年十二月三十一日,本公司 未償還承兑票據為人民幣24億元(二 零二二年十二月三十一日:人民幣24億 元)。

> 本公司於本年度一直與承兑票據持有 人進行持續討論及磋商,以期取得其 同意延長逾期負債。本公司管理層已 採取積極做法並與所有承兑票據持有 人就延長承兑票據到期日進行多次討 論。於二零二三年十二月三十一日前, 本金總額為人民幣1,144.3百萬元的承兑 票據之到期日已成功延長至二零二五 年十二月。



Despite the remaining noteholders have not yet granted the final consents to the Company for extending the maturity of the remaining liabilities, the Company has been proactively negotiating the extension of the maturity dates of the promissory notes with these noteholders. These negotiations were not finalized as at 31 December 2023 as certain commercial terms remain in discussion and finalization.

The Company is currently working out a plan to settle the outstanding promissory notes, which would depend on the Company's financial performance and upcoming discussions with the financial institutions on refinancing. As at the date of this report, no definite settlement terms have been reached by the Company with any relevant parties in this regard. The management of the Company has been actively following up on the status and progress of the above matters and has been continuously monitoring the relevant progress and development through regular meetings.

These aforesaid debt-restructuring actions are devised to align with the Disposal to improve the overall financial position of the Group. The Group expects that the completion of the Disposal and the successful release or discharge of Relevant Guarantees shall have a positive impact on the extension of maturity date, and settlement of promissory notes.

#### **Obtaining Financial Resources**

To further improve the Group's financing position for its future development, the Group has continued to utilise certain financing arrangements during the Year, mainly being the Facility entered with a shareholder in 2018. This Facility has a total amount of USD250.0 million. It is an interest-free and unsecured facility with an initial maturity date of 31 December 2025. Up to 31 December 2023, the Company had utilised approximately USD120.0 million, mainly for the oilfield development, repayment of remaining debts and general working capital.

儘管餘下票據持有人尚未就延長餘下 負債到期日向本公司授出最終同意, 本公司一直就延長承兑票據到期日積 極與該等票據持有人進行磋商。有關 磋商於二零二三年十二月三十一日尚 未定案,乃由於若干商業條款仍待討 論及定案。

本公司目前正在制定償還尚未償還承 兑票據的計劃,該計劃將視乎本公司 的財務表現及與金融機構就再融資即 將進行的討論而定。截至本報告日期, 本公司尚未就此與任何相關方達成明 確的償還條款。本公司管理層一直積 極跟進上述事項的狀況及進度,並通 過例會持續監控相關進展和發展。

上述債務重組措施之目標為改善本集團的 整體財務狀況,與出售事項的目標一致。 本集團預期完成出售事項以及成功免除或 解除相關擔保將為承兑票據的到期日延長 及結清帶來正面影響。

#### 獲取財政資源

為進一步改善本集團就其未來發展之融資 情況,本集團於本年度繼續動用若干融資 安排,主要為於二零一八年與一名股東訂 立之融資。融資總額為250.0百萬美元,為 免息及無抵押,且初步到期日為二零二五 年十二月三十一日。直至二零二三年十二 月三十一日,本公司已動用約120.0百萬美 元,主要用於油田開發、償還剩餘債務及 一般營運資金。



The Company also expects to continue to utilise the Facility for its repayment of debts, its capital expenditure on the Company's Energy Business and for general working capital purpose. The combination of geopolitical turmoil and concerns about oil output levels in major producing countries contributed to the decline in crude oil futures by over 10% in 2023. These factors underscore the complexity and volatility inherent in the global oil market. Due to the present economic uncertainty, it is expected that expenditures in Energy Business would only start to be resumed by the Group by 2026, the earliest. The management of the Group is taking a prudent approach to manage the capital expenditure of the Energy Business and will continue to monitor the development of the oil market in making any capital expenditure decisions.

The Company and the Shareholder are engaged in ongoing discussions as to the provision of further financial assistance by the Shareholder to the Company, which is still preliminary and subject to further discussion. If any such plan is materialised, the Company will make announcement accordingly.

#### **Energy Exploration and Production**

The Group acquired 60% interest in the project involving five oilfields zones located in the Fergana Valley of the Republic of Kyrgyzstan [the "**Kyrgyzstan Project**"], which marked a breakthrough of the Group into the energy exploration and production industry in 2014.

Under the agreements entered into with the national oil company of Kyrgyzstan, KыргызжерНефтегаз ["**Kyrgyzjer Neftegaz**" Limited Liability Company], a subsidiary of the Company was granted rights to cooperate with the national oil company of Kyrgyzstan in the operation of the five oilfields zones, namely, Maili-Su IV, Eastern Izbaskent, Izbaskent, Changyrtash and Chigirchik. The first three oilfields zones are located at the northeastern part of the Fergana Valley while the latter two are located at the Southeastern part of Fergana Valley. The total area covered by these five fields is approximately 545 square kilometers.

On the exploration front, the Group has drilled a total of 81 wells across the five oilfields zones, including 76 in exploration, 2 currently being construction-in-progress and 3 being abandoned. The Group has also held a number of appraisal wells for exploration and development. As at 31 December 2023, 76 wells were at production (2022: 73 wells). 本公司亦預期將繼續將融資用於償還債務、本公司能源業務的資本開支及作一般 營運資金用途。地緣政治動盪及對主要產 油國石油產量水平的擔憂導致二零二三年 原油期貨下跌超過10%。該等因素突顯了 全球石油市場固有的複雜性及波動性。由 於現時的經濟不確定性,預計本集團在能 源業務方面的開支最早將於二零二六年前 開始恢復。本集團管理層正採取審慎態度 管理能源業務的資本開支,並將在作出任 何資本開支決策時持續關注石油市場的發 展。

本公司與該股東已就該股東向本公司提供 進一步財務援助進行持續討論,該討論仍 屬初步,有待進一步討論。如任何有關計 劃實現,本公司將相應作出公告。

#### 能源勘探及生產

本集團收購位於吉爾吉斯共和國費爾幹納 盆地五個油田區塊之項目(「**吉爾吉斯項目**」) 60%權益,標誌著本集團於二零一四年於 能源勘探及生產行業的突破。

根據與吉爾吉斯國家石油公司簽訂的協議, 本公司附屬公司Kыprы3жepHeфтera3 (「**吉爾吉斯大陸油氣**」有限公司\*)獲授與吉 爾吉斯國家石油公司合作經營五個油田區 塊的權利,即馬里蘇Ⅳ、東伊斯巴克特、 伊斯巴克特、羌格爾塔什及奇克爾奇克。 前三個油田區塊位於費爾幹納盆地東北 部,其餘兩個油田區塊位於費爾幹納盆地 東南部。該等五個油田區塊總覆蓋面積約 達545平方公里。

在勘探方面,本集團於五個油田區塊合共 鑽井81座,包括76座在產井、2座正在建設 中及3座已廢棄。本集團亦擁有多個用於勘 探及開發的評價井。於二零二三年十二月 三十一日,76座油井處於生產中(二零二二 年:73座油井)。

For the Year, the Kyrgyzstan Project recorded sales of 124,200 barrels (bbl) (2022: 124,790 bbl) of light crude oil. Revenue from the Energy Business was approximately RMB37.9 million for the Year, decreasing by approximately 28.2% from RMB52.7 million for the Comparative Year.

The decrease of revenue in 2023 was primarily driven by the decline in local oil prices.

In the first half of 2023, due to the slow decline in inflation levels in Europe and the United States, continued interest rate hikes by the Federal Reserve and the European Central Bank leading to negative feedback on the economy, the probability of an economic recession increased. Particularly in March, a crisis erupted in the banking industry in Europe and the United States, causing international crude oil prices to also experience wide fluctuations and declines. In the second half of 2023, driven by tight supply and strong demand, oil prices rose from July to September. However, with the anticipation of a Federal Reserve interest rate hike in September and increased pressure on the economy from the high-interest rate environment, market expectations for demand began to decline, and international oil prices also fell accordingly.

Furthermore, the local market in Kyrgyzstan was impacted by the Russia-Ukraine war, with restricted Russian oil exports resulting in large quantities of crude oil being imported into Kyrgyzstan at low prices. Consequently, the overall decline in local oil prices in Kyrgyzstan was greater than the decline in international oil prices.

In response to the changing and complex market of refined products, the management of the Group decided to postpone the capital expenditures plan and strictly implement companywide cost-saving measures, with an aim to maintain its financial position while protecting value in a volatile market environment. The Group has been implementing a new oil well development method which had been proved to improve and achieve a better production efficiency in the oil well-drilling operation. The Group remains positive with the business model in long term.

The management of the Group is committed to maintaining its liquidity and will manage its business through this unprecedented market cycle.

於本年度,吉爾吉斯項目錄得銷售輕質原 油124,200桶(二零二二年:124,790桶)。能 源業務於本年度錄得收益約為人民幣37.9 百萬元,較可比年度人民幣52.7百萬元減 少約28.2%。

二零二三年的收益减少主要是由於當地油 價下跌所致。

於二零二三年上半年,由於歐洲和美國通 脹水平緩慢下降,美聯儲和歐洲央行持續 加息導致經濟出現負反饋,經濟衰退的可 能性增加。尤其在三月份,歐洲和美國現 行業爆發危機,導致國際原油價格亦出現 行業爆發危機,導致國際原油價格亦出現 大幅波動及下跌。於二零二三年下半年, 在供應緊張及需求強勁的推動下,七月至 九月油息的預期以及高利率環境對經濟的壓 力增長,市場對需求的預期開始下降,國 際油價亦相應下跌。

此外,吉爾吉斯當地市場受俄烏戰爭的影響,俄羅斯石油出口受到限制,導致大量 原油以低價進口至吉爾吉斯。因此,吉爾 吉斯當地石油價格的總體跌幅大於國際石 油價格的跌幅。

為應對不斷變化的複雜成品油市場,本集 團管理層決定推遲資本開支計劃並嚴格 實施全公司的成本節約措施,旨在維持財 務狀況的同時,亦能在動盪市場環境中保 值。本集團已實施新的油井開發方式,其 已獲證實於油井鑽井作業方面有所改進, 並提高生產效率。長遠而言,本集團對該 業務模式仍持積極態度。

本集團管理層致力於保持其流動性,並 將在這個前所未有的市場週期中管理其業 務。



#### **Oil Storage**

The Group has acquired approximately 50.46% of the equity interest of Nantong Zhuosheng Petrochemical Co., Ltd. ("**Nantong Zhuosheng**"). Nantong Zhuosheng is principally engaged in provision of tank storage and associated services for fuel oil and its related products in the PRC. It has (i) 37 storage tanks with total volume of 242,000 cubic meters; (ii) land and buildings with land area of 412,120 square meters and gross floor area of 6,156.27 square meters, respectively; (iii) certain shoreline rights; and (iv) a bare land with total area of 33,334.19 square meters.

Nantong Zhuosheng possesses the facility, capacity and expertise in the provision of oil storage services. The Board believes that the Group can accumulate sufficient experience in the operation and management in this area, and further expand its business presence within the oil sector after acquiring Nantong Zhuosheng. This acquisition also reflected the Group's strategy of investing in oiland-gas-related storage and logistic projects, which would enable the Group to expand its energy business vertically.

For the Year, Nantong Zhuosheng has generated revenue of RMB44.7 million and a net profit of RMB1.9 million.

#### **Proved and Probable Oil Reserve and Estimates**

A competent person's report was prepared in September 2018 in accordance with Petroleum Resources Management System (PRMS) to estimate the oil resources and reserves as of 30 June 2018. The following table sets out the revised estimates of the Group's reserves as at 31 December 2023 by using the abovementioned report as the basis:

南通焯晟於提供油儲服務方面擁有設備、 能力及專業知識。董事會認為,於收購南 通焯晟後,本集團可於該領域積累豐富的 營運及管理經驗,並進一步擴大其於石油 領域的業務。收購事項亦反映了本集團於 油氣相關倉儲及物流項目的投資策略,令 本集團能垂直擴大其能源業務。

於本年度,南通焯晟已產生收益人民幣44.7 百萬元以及淨利潤人民幣1.9百萬元。

### **Financial Review**

The Group's operating results for the Year were primarily contributed by the Company and its subsidiaries engaged in the energy exploration and production, as well as the oil storage.

#### Revenue

For the Year, the Group recorded a revenue of approximately RMB82.6 million (for the Comparative Year: approximately RMB102.8 million). The decrease in revenue was primarily attributable to (1) a decrease of approximately 28.2% in revenue from the energy exploration and production section as compared to that of RMB52.7 million for the Comparative Year due to the decline in crude oil prices in Kyrgyzstan; and (2) a slight decline of oil storage revenue by approximately 4.4% to RMB44.7 million under tough industrial market in China.

#### **Cost of Sales**

For the Year, the Group's cost of sales decreased by approximately 10.4% to RMB51.1 million (for the Comparative Year: RMB57.1 million), which was in line with the decrease of revenue.

#### Other Gains — Net

For the Year, the Group's other gains — net was approximately RMB54,000 (for the Comparative Year: RMB11.4 million), and the movement was mainly due to the decline of net foreign currency exchange gain associated with working capital for the Year.

#### **Net Finance Costs**

Net finance costs for the Year decreased by approximately 33.3% to RMB347.8 million (for the Comparative Year: RMB521.6 million). The reduction was primarily attributable to the relatively modest fluctuations in the exchange rates of the USD and Hong Kong Dollar.

### 財務回顧

於本年度,本集團之經營業績主要來自本 公司及其附屬公司,其從事能源勘探及生 產,以及油儲。

#### 收益

於本年度,本集團錄得收益約人民幣82.6百 萬元(於可比年度:約人民幣102.8百萬元)。 收益減少主要由於[1]吉爾吉斯原油價格下 跌致使能源勘探及生產板塊的收益較可比 年度的人民幣52.7百萬元減少約28.2%;及 [2]在中國嚴峻的工業市場下,油儲收益小 幅下降約4.4%至人民幣44.7百萬元。

#### 銷售成本

於本年度,本集團的銷售成本減少約10.4% 至人民幣51.1百萬元(於可比年度:人民幣 57.1百萬元),與收益減少變動一致。

#### 其他收益 — 淨額

於本年度,本集團的其他收益-淨額約為 人民幣54,000元(於可比年度:人民幣11.4百 萬元),有關變動主要是由於本年度與營運 資金有關的外匯收益淨額減少所致。

#### 融資成本淨額

於本年度,融資成本淨額減少約33.3%至人 民幣347.8百萬元(於可比年度:人民幣521.6 百萬元),該減少主要由於美元及港元的 匯率波動相對適度。



#### **Total Comprehensive Loss for the Year**

During the Year, the Group recorded total comprehensive loss of approximately RMB510.4 million (for the Comparative Year: RMB617.2 million), of which total comprehensive loss attributable to the equity holders of the Company was approximately RMB519.6 million (for the Comparative Year: RMB626.7 million). The decline of the total comprehensive loss for the Year was mainly driven by the decrease in foreign exchange loss. The Group recorded a net foreign exchange loss of RMB125.5 million during the Year, which was mainly due to the appreciation of borrowings denominated in USD and Hong Kong Dollars. This is compared with a foreign exchange loss of the Group of RMB332.4 million for the Comparative Year.

#### Liquidity and Going Concern

The Group recorded a net loss of RMB525.1 million (for the Comparative Year: RMB670.9 million) and had an operating cash inflow of RMB7.0 million (for the Comparative Year: RMB21.9 million) for the Year. As at 31 December 2023, the Group had a deficit of RMB9,020.7 million (2022: RMB8,510.3 million) and the Group's current liabilities exceeded its current assets by RMB8,108.9 million (2022: RMB7,532.7 million). The Group maintained cash and cash equivalents of RMB2.1 million (2022: RMB14.6 million) as at 31 December 2023.

As at 31 December 2023, borrowings of the Group, amounted to RMB3,934.7 million, out of which RMB1,569.1 million were overdue. As at 31 December 2023, overdue interest payables amounted to RMB907.0 million (2022: RMB675.6 million). Certain borrowings of the Group contain cross-default terms, causing borrowings of the Group of RMB8.6 million at 31 December 2023 to become immediately repayable.

A series of plans and measures have been taken to mitigate liquidity pressure and to improve the financial position of the Group. In order to enhance the liquidity and improve the financial position of the Group, the Group has restructured its operations, refinancing its debts and proactively liaising with relevant financial institutions to discharge the Relevant Guarantees.

Details regarding uncertainties on the going concern of the Group and the respective plans and measures are set out in the section headed "Going Concern Basis" in Note 2.1(b) to the notes to the consolidated financial statements.

#### 本年度全面虧損總額

於本年度,本集團錄得全面虧損總額約人 民幣510.4百萬元(於可比年度:人民幣617.2 百萬元),其中本公司權益持有人應佔全面 虧損總額約為人民幣519.6百萬元(於可比年 度:人民幣626.7百萬元)。本年度全面虧損 總額減少主要由外匯虧損減少所致。本集 團於本年度錄得外匯虧損淨額人民幣125.5 百萬元,主要由於以美元及港元計值的借 款升值所致。相較之下,本集團於可比年 度則錄得外匯虧損人民幣332.4百萬元。

#### 流動資金及可持續經營

於本年度,本集團錄得淨虧損人民幣525.1 百萬元(於可比年度:人民幣670.9百萬元)及 經營現金流入人民幣7.0百萬元(於可比年 度:人民幣21.9百萬元)。於二零二三年十二 月三十一日,本集團虧絀為人民幣9,020.7百 萬元(二零二二年:人民幣8,510.3百萬元), 且本集團的流動負債超過其流動資產人民 幣8,108.9百萬元(二零二二年:人民幣7,532.7 百萬元)。於二零二三年十二月三十一日, 本集團維持現金及現金等價物人民幣2.1百 萬元(二零二二年:人民幣14.6百萬元)。

於二零二三年十二月三十一日,本集團借款 為人民幣3,934.7百萬元,當中人民幣1,569.1 百萬元已逾期。於二零二三年十二月三十一 日,逾期應付利息為人民幣907.0百萬元(二 零二二年:人民幣675.6百萬元)。本集團的 若干借款含交叉違約條款,導致本集團借 款人民幣8.6百萬元須於二零二三年十二月 三十一日立即償還。

我們已採取一系列計劃及措施減輕流動資 金壓力,改善本集團財務狀況。為增加本 集團的流動資金及改善財務狀況,本集團 重組其運營及再融資債務,以及積極與有 關金融機構協商解除相關擔保。

有關本集團可持續經營的不確定性及相關 計劃與措施的詳情,載列於綜合財務報表 附註之附註2.1(b)「持續經營基準」一節。

#### **Borrowings**

The Group's short-term borrowings increased by RMB164.6 million from RMB1,534.3 million as at 31 December 2022 to RMB1,698.9 million as at 31 December 2023, and the Group's long-term borrowings increased by RMB59.7 million from RMB2,295.5 million as at 31 December 2022 to RMB2,235.8 million as at 31 December 2023.

As at 31 December 2023, our total borrowings were RMB3,934.7 million (as at 31 December 2022: RMB3,829.8 million), of which RMB124.1 million (approximately 3.2%) was denominated in RMB (as at 31 December 2022: RMB116.0 million (approximately 3.0%))] and the remaining RMB3,810.6 million (approximately 96.8%) was denominated in other currencies such as USD and HKD (as at 31 December 2022: RMB3,713.8 million (approximately 97.0%)]. Approximately 91.3% of the borrowings bear interests at fixed rate (as at 31 December 2022: approximately 91.3%).

#### Significant Investments

Save as disclosed in this report, the Group did not have any other significant investments during the Year.

#### Material Acquisition and Disposal of Subsidiaries

The Group did not undertake material acquisitions or disposals of subsidiaries during the Year.

#### Future Plans for Material Investments and Capital Assets

As at 31 December 2023, the Group did not have other plans for material investments and capital assets.

#### Foreign Exchange Risks

The Group incurred net foreign exchange loss of approximately RMB125.5 million (for the Comparative Year: RMB332.4 million) due to the fluctuation of RMB against USD and HKD during the Year, which resulted in exchange loss on certain USD-denominated and HKD-denominated liabilities, such as trade and other payables and borrowings of the Group.

#### **Capital Expenditure**

For the Year, our capital expenditure was approximately RMB8.1 million (for the Comparative Year: RMB13.8 million), which was mainly used in the oil storage and trading segment.

#### 借款

於二零二三年十二月三十一日,我們的借款 總額為人民幣3,934.7百萬元(於二零二二年 十二月三十一日:人民幣3,829.8百萬元),其 中人民幣124.1百萬元(約3.2%)以人民幣計值 (於二零二二年十二月三十一日:人民幣116.0 百萬元(約3.0%)),而餘下人民幣3,810.6百 萬元(約96.8%)則以其他貨幣(如美元及港 元)計值(於二零二二年十二月三十一日:人 民幣3,713.8百萬元(約97.0%))。約91.3%的 借款以固定利率計息(於二零二二年十二月 三十一日:約91.3%)。

#### 重大投資

除本報告所披露外,本集團於本年度並無 任何其他重大投資。

#### 附屬公司的重大收購及出售

本集團於本年度並無進行任何重大收購或 出售附屬公司。

#### 未來重大投資及資本資產計劃

於二零二三年十二月三十一日,本集團並 無其他重大投資及資本資產計劃。

#### 外匯風險

於本年度,本集團產生外匯虧損淨額約人 民幣125.5百萬元(於可比年度:人民幣332.4 百萬元),乃由於於本年度人民幣兑美元及 港元的波動,導致本集團應付賬款及其他 應付款項及借款等若干以美元及港元計值 的負債產生匯兑虧損。

#### 資本開支

於本年度,我們的資本開支約為人民幣8.1 百萬元(於可比年度:人民幣13.8百萬元), 主要用於油儲及貿易板塊。





#### **Gearing Ratio**

Our gearing ratio (measured by total borrowings divided by the sum of total borrowings and total deficit) decreased from approximately 81.8% as at 31 December 2022 to approximately 77.4% as at 31 December 2023. Affected by the total comprehensive loss of RMB510.4 million for the year ended 31 December 2023, the total deficit was increased to approximately RMB9,020.7 million as at 31 December 2023 (as at 31 December 2022: RMB8,510.3 million).

#### **Contingent Liabilities**

As at 31 December 2023, the Group had contingent liabilities of RMB985.0 million (as at 31 December 2022: RMB955.0 million), which was resulted from certain Relevant Guarantee provided by the Company to the Disposal Group that did not meet the recognition criteria for Financial Guarantee Contracts.

#### **Credit Assessment and Risk Management**

Credit risk is managed on a group basis. Credit risk arises from cash and cash equivalents, outstanding trade and other receivables. As at 31 December 2023, the Group had cash and cash equivalents of approximately RMB2.1 million (as at 31 December 2022: RMB14.6 million), of which approximately RMB1.2 million (approximately 55.1%) was denominated in RMB and the remaining RMB0.9 million (approximately 44.9%) was denominated in USD, HKD and other currencies. The Group does not use any financial instruments for hedging purposes.

All of the Group's cash and bank balances, short-term and longterm bank deposits were placed with reputable banks which the management believes are of high creditworthiness and without significant credit risk.

The Group carries out customer credit checks prior to entering into sales contract with customers. The Group offers credit lines after evaluating the customer's credit profiles, financial conditions, past experiences and other factors.

#### 資本負債比率

我們的資本負債比率(根據總借款除以總借 款與總虧絀之和計算)從二零二二年十二月 三十一日約81.8%減少至二零二三年十二月 三十一日約77.4%。受截至二零二三年十二月 月三十一日止年度的全面虧損總額約人民 幣510.4百萬元影響,於二零二三年十二月 三十一日的總虧絀增加至約人民幣9,020.7 百萬元(於二零二二年十二月三十一日:人 民幣8,510.3百萬元)。

#### 或然負債

於二零二三年十二月三十一日,本集團有 或然負債人民幣985.0百萬元(於二零二二年 十二月三十一日:人民幣955.0百萬元),乃 由於本公司向出售集團提供若干相關擔保 所致,而該擔保不符合財務擔保合約的確 認標準。

#### 信貸評估及風險管理

信貸風險乃按集團基準管理。信貸風險來 自現金及現金等價物、未償還應收賬款及 其他應收款項。於二零二三年十二月三十一 日,本集團的現金及現金等價物約為人民 幣2.1百萬元(於二零二二年十二月三十一日: 人民幣14.6百萬元),其中約人民幣1.2百萬 元(約55.1%)以人民幣計值,餘下人民幣0.9 百萬元(約44.9%)以美元、港元及其他貨幣 計值。本集團並無使用任何金融工具作對 沖用途。

本集團所有現金及銀行結餘、短期及長期 銀行存款均存置於有良好信譽的銀行,管 理層認為該等銀行具有高信貸資質且無重 大信貸風險。

本集團與客戶訂立銷售合約前審核客戶信 貸狀況。本集團會先評估客戶信用資質、 財務狀況、過往經驗及其他因素,然後授 予信貸限額。

#### **Human Resources**

As at 31 December 2023, the Group had approximately 143 employees (as at 31 December 2022: approximately 149 employees). Total staff costs (including directors' emoluments) for the Group were approximately RMB26.2 million for the Year (for the Comparative Year: approximately RMB23.4 million). The principal elements of remuneration package includes basic salary and other benefits, contribution to pension schemes, discretionary bonus and/or share options granted under an approved share option scheme. Such remuneration should reflect work complexity, time commitment, responsibility and performance with a view of attracting, motivating and retaining high performing individuals.

#### Additional Information on Auditors' Modified Opinions

The Board wishes to draw the attention of the shareholders of the Company (the "**Shareholders**") to the section headed "Basis for Disclaimer of Opinion" as contained in the Independent Auditor's Report dated 27 March 2024 issued by the Company's auditors, Crowe (HK) CPA Limited, now contained in pages 91 to 94 of this annual report. On the basis set out therein, our auditors do not express an opinion on the consolidated financial statements of the Group for the year ended 31 December 2023.

As explained in the "Basis for Disclaimer of Opinion", the auditors' disclaimer of opinion were principally caused by the multiple uncertainties relating to going concern.

As set out in Note 2.1(b) of this report, the directors of the Company have been undertaking a number of measures to mitigate the liquidity pressure, to improve its financial position, to refinance its operation and to restructure its debts. Despite that the auditors could not obtain sufficient evidence regarding the going concern of the Group, the Group's overall financial position for the year ended 31 December 2023 had improved comparing to that of 2022. With all the measures mentioned above (refer to the "Business Review" section of "Management Discussion and Analysis"), we are expecting the Group's overall financial position to be further improved in the year to come.

#### 人力資源

誠如「導致無法表示意見的基礎」所闡釋, 核數師之無法表示意見乃主要由於有關持 續經營的多項不確定事項所致。

誠如本報告附註2.1(b)所載,本公司董事一 直採取多項措施,以減緩流動性壓力,並 改善其財務狀況,同時對其運營進行再融 資及重組債務。儘管核數師無法獲得關 於本集團持續經營的足夠證據,本集團截 至二零二三年十二月三十一日止年度之整 體財務狀況較二零二二年已改善。憑藉上 述所有措施(請參閱「管理層討論與分析」的 「業務回顧」一節),我們預期本集團的整體 財務狀況將於來年有進一步的改善。



The Board and audit committee agreed with the views of the management and the auditors regarding the uncertainties relating to going concern. There is no disagreement by the Board, the management nor the audit committee with the position taken by the Company's auditors regarding the disclaimer of opinion.

The Directors will continue to use their best efforts to protect and uphold the Company's best interest, including ongoing negotiation with various lenders over the debt restructuring arrangements. Our independent non-executive Directors offer diverse industry expertise, serve the important functions of advising the management on strategies, ensuring that the Board fulfils high standards of financial and other mandatory reporting requirements as well as providing adequate checks and balances for safeguarding the interests of shareholders and the Company as a whole.

### **董事會** 董事會成員

董事會現由三名執行董事即牛建民先生(主 席)、洪樑先生(首席執行官及首席營運官) 及朱文花女士,以及三名獨立非執行董事 即王錦連先生、周展女士及林長茂先生組 成。董事會認為這個組合權力平衡,能加 強對整體管理運作的獨立審查及監督。

#### 董事會角色及責任

董事會負責制定整體策略,並檢討本集團 營運及財務表現。董事會負責審議本集團 整體策略、重大收購及出售、年度及中期 業績、批准委任董事加入董事會、重大資 本交易及其他重大營運及財務事宜,以及 進行有關方面的決策。

本集團獨立非執行董事具備不同行業的專 業知識,負責履行的重要職務包括向管理 層提供策略方面的建議,並確保董事會在 達致高水平財務及其他強制申報規定的同 時,具備充分權力制衡,以保障股東及本 公司整體利益。



#### **Delegation to Management**

Day-to-day operational responsibilities are specifically delegated by the Board to the management. Major responsibilities include:

- execution of business and operational strategies and initiatives adopted by the Board;
- preparation of reports and accounts for the Board's approval before publication;
- adoption of the remuneration policy approved by the Board;
- implementation of internal control and risk management procedures; and
- compliance with relevant statutory requirements, rules and regulations.

## Mechanism to ensure independent views and input

The Board has established different ways to ensure independent views and input from Directors. The Board reviews the implementation and effectiveness of such mechanism on an annual basis to ensure that independent views and input are available to the Board.

The mechanism is disclosed below:

(i) Composition

The Board ensures the appointment of at least three independent non-executive Directors and at least one-third of its members being independent non-executive Directors with at least one independent non-executive Director possessing appropriate professional qualifications, or accounting or related financial management expertise.

#### (ii) Independence Assessment

The nomination committee assess the independence, qualification and time commitment of a candidate who is nominated to be a new independent non-executive Director before an appointment. On an annual basis, all independent non-executive Directors are required to confirm in writing their compliance of independence requirements pursuant to Rule 3.13 of the Listing Rules.

#### 轉授於管理層

提名委員會在任命前評估被提名為新 獨立非執行董事的候選人的獨立性、 資格和時間承諾。根據上市規則第3.13 條,所有獨立非執行董事均須每年書 面確認其遵守獨立性規定。



#### (iii) Board Decision Making

The Directors (including INEDs), upon reasonable request, may seek independent professional advice at the Company's expense.

(iv) Independent non-executive Directors meeting

The Chairman of the Board meets with all independent non-executive Directors annually without the presence of the other executive Directors and management of the Company.

#### **Board Practices**

The Board holds at least four regular meetings annually at, approximately quarterly intervals to discuss the Group's business development, operations and financial performance. Notice of at least 14 days is given to all Directors for all regular Board meetings. All regular Board meetings adhere to a formal agenda in which a schedule of matters is addressed to the Board and the Directors are invited to include matters of special concerns for discussion in the agenda. The agenda and accompanying board papers are then sent in full to all Directors at least 3 days in advance or within reasonable time prior to the relevant Board meetings.

All Directors have access to the Board papers and all related materials and are provided with adequate information by the management to enable the Board to make informed decisions on the matters to be discussed. Directors should declare any conflict of interest in a matter to be considered by the Board which the Board has determined to be material, the matter should be dealt by a physical Board meeting rather a written resolution. The minutes of the Board meetings have sufficient details of the matters discussed at Board meetings which are prepared and kept by the Company Secretary and are opened for inspection by any Director. The Directors are free to access to the management for enquiries about further information, when required, and the Directors can obtain independent professional advice at the Company's expense.

#### Attendance Records of Directors and Board Committee Members

During the year ended 31 December 2023, the Board held four regular Board meetings and one general meeting. The agendas and accompanying board papers are given to all Directors in a timely manner. The Chairman of the Board shall ensure the Directors being properly briefed on issues arising at those Board meetings. (iii) 董事會決策

#### **Continuous Professional Development**

Code Provision C.1.4 of the Code stipulates that all directors should participate in continuous professional development to develop and refresh their knowledge and skills. The Group also makes available continuous professional development to the Directors at the expense of the Company and to ensure that their contribution to the Board remains informed and relevant.

During the year ended 31 December 2023, the Company arranged Directors to join an online training on (1) Trading arrangements for corporate actions; and (2) Share schemes to enhance their capacities to carry out directors' duties.

Beside, every newly appointed Director will receive comprehensive, formal and tailored induction package from the Company's external legal advisor ensuring that he/she has a proper understanding of the Company's operation, business, the relevant laws and regulations, the Listing Rules and governance policies. The company secretary also provides the updates on latest development and changes in the Listing Rules and other relevant legal and regulatory requirements to the Board from time to time.

## Independence of Independent Non-executive Directors

During the year ended 31 December 2023, the Board at all times met the requirements of the Listing Rules relating to the appointment of independent non-executive Director, whereby at least one of whom possesses appropriate professional qualifications or accounting or related financial management expertise.

The Board has received from each independent non-executive Director a written annual confirmation of his independence pursuant to Rule 3.13 of the Listing Rules and is satisfied with the independence of all the independent non-executive Directors.

Each independent non-executive Director is required to inform the Company as soon as practicable if there is any change that may affect his/her independence.

#### 持續專業發展

#### 獨立非執行董事之獨立性

倘出現任何可能影響他/她的獨立性的轉 變,各獨立非執行董事須在可行情況下盡 快知會本公司。



#### **Appointment and Re-election of Directors**

The procedures for appointing and re-electing directors are set out in the Articles of Association. The Board is responsible for selecting and recommending candidates for directorship, taking into consideration factors such as appropriate professional knowledge and industry experience, personal ethics, integrity and personal skills.

Under the Articles of Association, one-third of the Directors must retire, and if eligible, may be subject to re-election at each annual general meeting. Furthermore, any Director appointed to fill a casual vacancy or as an addition to the Board should hold office until the first general meeting of the Company after his appointment and shall be subject to re-election at such meeting.

To further reinforce accountability, any further re-appointment of an independent non-executive Director who has served the Company's Board for more than nine years will be subject to separate resolution to be approved by the shareholders of the Company.

In accordance with the Articles of Association, Mr. Niu Jianmin and Mr. Lam Cheung Mau will retire by rotation at the 2024 AGM. All retiring Directors, being eligible, has offered themselves for reelection as Directors at the 2024 AGM.

Each of the executive Directors entered into renewed service contracts with the Company for a term of three years commencing on 24 October 2022.

Each of the independent non-executive directors is appointed for a specific term, subject to re-election, which will run until the conclusion of the third annual general meeting from the date of their last re-election and in accordance with the Company's Articles of Association.

#### **Directors' Interests in Shares**

Details of Directors' interests in the Shares are set out in the "Report of the Directors" section on page 32 of this annual report.

#### 委任及重選董事

根據細則,牛建民先生及林長茂先生將於 二零二四年股東週年大會上輪值退任董事 一職。所有退任董事合資格並願意於二零 二四年股東週年大會上膺選連任。

各執行董事已與本公司訂立自二零二二年 十月二十四日起計為期三年的重續服務合 約。

每位獨立非執行董事乃按特定任期委任及 可膺選連任,任期由上次重選當日起計至 第三個股東週年大會結束時為止,並需根 據本公司公司細則之規定。

**Directors' Securities Transactions** 

The Company has adopted a code of conduct regarding directors' securities transactions on terms no less than the required standards of the Model Code for Securities Transactions by Directors of Listed Issuers as set out in Appendix C3 to the Listing Rules (the "**Model Code**"). Having made specific enquiry of the directors of the Company, all directors confirmed that they complied with the required standards set out in the Model Code and the Company's code of conduct regarding directors' securities transactions for the year ended 31 December 2023.

#### Directors' Liability Insurance and Indemnity

The Company has arranged for appropriate liability insurance to indemnify its Directors for their liabilities arising out of corporate activities undertaken for the Company. During the year ended 31 December 2023, no claim was made against the Directors.

#### **Board Committees**

The Board has established an audit committee (the "Audit Committee"), a remuneration committee (the "Remuneration Committee"), a nomination committee (the "Nomination Committee"), a corporate governance committee (the "Corporate Governance Committee") and a finance and investment committee (the "Finance and Investment Committee") with defined terms of reference. Details and reports of the committees are set out below.

### Audit Committee

The Audit Committee was established to review the Group's financial reporting, risk management and internal control systems and make relevant recommendations to the Board. The Audit Committee comprises of three members: Ms. Zhou Zhan, being chairman of the Audit Committee, Mr. Wang Jin Lian and Mr. Lam Cheung Mau, all of whom are independent non-executive Directors. Ms. Zhou Zhan, as the chairman of the Audit Committee, possesses appropriate professional qualifications, accounting or related financial management expertise as required under the Listing Rules.

#### 董事進行的證券交易

### 審核委員會

審核委員會的成立乃為審查本集團的財務 申報、風險管理及內部監控,並向董事會 提出相關建議。審核委員會由三名成員組 成,分別為周展女士(即審核委員會主席)、 王錦連先生及林長茂先生,彼等均為獨立 非執行董事。審核委員會主席周展女士具 備上市規則規定的適當專業資格、會計或 相關財務管理專業知識。



Pursuant to the terms of reference of the Audit Committee, the main duties of the Audit Committee are to audit and supervise the financial reporting procedures of the Group, consider the appointment, re-appointment and remuneration of the auditor and any matters related to the removal and resignation of the auditor. In addition, the Audit Committee is responsible for examining and inspecting the effectiveness of the Group's risk management and internal control systems, including conducting reviews, on a regular basis, in respect of the risk management and internal control over various corporate structures and business procedures, and considering their potential risks and imminence, so as to ensure the effectiveness of the Company's business operations and to achieve its corporate objectives and strategies. The scope of such reviews covers finance, operations, compliance and regulations.

During the year ended 31 December 2023, the Audit Committee held five meetings. The following is a summary of the work of the Audit Committee during the year:

- reviewed and made recommendations for the Board's approval of the Group's consolidated financial statements for the year ended 31 December 2022;
- reviewed and made recommendations for the Board's approval the Group's interim condensed consolidated financial information for the six months ended 30 June 2023;
- reviewed and made recommendations for the Board's approval the re-appointment of the external auditor;
- reviewed the external auditor's remuneration and terms of engagement;
- reviewed the reports from the external auditor;
- reviewed the annual audit plan;
- reviewed the risk management and internal control systems of the Group;
- review of the reports from the internal auditor; and
- reviewed the effectiveness of the internal audit function.

The consolidated financial statements of the Group for the year ended 31 December 2023 have been reviewed and approved by the Audit Committee, and the Audit Committee is of the opinion that such financial statements comply with the applicable accounting standards, the Listing Rules and all other applicable legal requirements. The Audit Committee therefore recommended the Board's approval of the Group's consolidated financial statements for the year ended 31 December 2023.

#### **Remuneration Committee**

The Remuneration Committee was established on 24 October 2010 and has been delegated with the responsibility of determining the remuneration policy and structure for all Directors and senior management, reviewing and approving matters relating to share schemes under Chapter 17 of Listing Rules and the specific remuneration packages of all Directors and making recommendations to the Board regarding the remuneration of independent non-executive Directors. The Remuneration Committee comprises three members: Ms. Zhou Zhan (an independent non-executive Director) being the chairman of the Remuneration Committee, Mr. Niu Jianmin (Chairman of the Board and an executive Director) and Mr. Wang Jin Lian (an independent non-executive Director).

During the year ended 31 December 2023, the Remuneration Committee held one meeting. The following is a summary of the work of the Remuneration Committee during the year:

- annual review of the remuneration packages of the Directors and senior management of the Company, and
- reviewed and made recommendations to the Board the directors' fee for Independent Non-executive Directors.

The particulars regarding Directors' remuneration and the five highest paid employees as required to be disclosed pursuant to Appendix 16 to the Listing Rules are set out in Notes 20 and 25 to the consolidated financial statements.

#### **Remuneration Policy**

The remuneration of directors are recommended by the remuneration committee of the Company and approved by the Board, based on prevailing market conditions and with reference to other companies of a similar size, business nature and scope as the Company. In addition, the Company may grant share options to eligible directors and employees as incentives for their contributions to the Group.

The primary goal of our policy for remuneration packages is to ensure that Directors are fairly rewarded and they receive appropriate incentives to maintain high standards of performance.

The principal elements of the Directors' remuneration package include:

- basic salary and other benefits;
- contribution to pension schemes;
- discretionary bonus; and
- share options granted under an approved option scheme.

Details of the Directors' emoluments, the five highest-paid individuals and senior management of the Group for the year ended 31 December 2023 are set out in Notes 20 and 25, respectively, to the consolidated financial statements.

#### **Nomination Committee**

The Nomination Committee was established on 1 April 2012 with written terms of reference. The Nomination Committee comprises of three members, namely Mr. Wang Jin Lian (an independent non-executive Director) being the chairman of the Nomination Committee, Ms. Zhu Wen Hua (an executive Director) and Ms. Zhou Zhan (an independent non-executive Director).

The key duties of the Nomination Committee are as follows:

- (a) to review the structure, size and composition (including the skills, knowledge and experience) of the Board at least annually and make recommendations on any proposed changes to the Board to complement the Company's corporate strategy;
- (b) to identify individuals suitably qualified to become members of the Board and select, or make recommendations to the Board on the selection of, individuals nominated for directorships;

The Nomination Committee is to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business. To ensure changes to the Board composition can be managed without undue disruption, a formal, considered and transparent procedure is in place for selection, appointment and re-appointment of Directors, as well as plans in place for orderly succession (if considered necessary), including periodical review of such plans.

During the year ended 31 December 2023, the Nomination Committee held one meeting. The following is a summary of the work of the Nomination Committee during the year:

- reviewed on the structure, size and composition (including the skills, knowledge and experience) of the Board; and
- assessed the independence of each of the independent non-executive Directors.

#### **Nomination Procedures and Criteria**

The appointment of a new Director (to be an additional Director or fill a casual vacancy as and when it arises) or any re-appointment of Directors is a matter for decision by the Board upon the recommendation of the proposed candidate by the Nomination Committee. The criteria to be applied in considering whether a candidate is qualified shall be his or her ability to devote sufficient time and attention to the affairs of the Company and contribute to the diversity of the Board as well as the effective carrying out by the Board of the responsibilities. Further details of the selection criteria and the procedure are set out in the terms of reference of the Nomination Committee which are available on the websites of the Stock Exchange and the Company. #### 提名程序及準則

委任新董事(作為新增董事或填補所出現的 臨時空缺)或重新委任任何董事乃經提名 委員會推薦候選人後由董事會作出決定。 用於考慮候選人是否符合資格的標準,應 視乎候選人是否能投入足夠時間及精神以 處理本公司事務,並促進董事會成員多元 化,使董事會能有效履行其職責。更多甄 權之程序的詳情載於提名委員會職權 範圍,該職權範圍已於聯交所及本公司網 站內登載。



A shareholder may at any general meeting nominate a candidate for directorship if, within the 7 days commencing the day after the despatch of the notice of such general meeting, such shareholder (being entitled to attend and vote at such general meeting and not being the candidate) gives to the company secretary a written notice of his/her intention to propose such candidate for election and also a written notice signed by such candidate of his/her willingness to be elected.

Other than the nomination of directors by shareholders, at present, candidates for directorship may be nominated by the Chief Executive Officer of the Company, who will provide the Nomination Committee with notice of such nomination once a candidate has been identified.

The Nomination Committee is responsible for making recommendations to the Board with respect to the nomination of candidates for directorship by making reference to the Company's Board Diversity Policy, which was adopted by the Board on 26 March 2013 and various aspects of the candidate, including (but not limited to) his/her education background, professional experience, experience in the relevant industry and past directorships. In particular, for candidates to be independent non-executive directors, the Nomination Committee assesses his/her independence under Rule 3.13 of the Listing Rules. Then, the Nomination Committee will make its recommendations to the Board for consideration and approval.

#### **Board Diversity Policy**

The Board Diversity Policy was adopted by the Company pursuant to the resolutions passed at a Board meeting held on 26 March 2013. The Company sees increasing diversity at the Board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. The Board reviews the implementation and effectiveness of the Company's Board Diversity Policy annually. In designing the Board's composition, the nomination and the board appointments during the year ended 31 December 2023 were made after considering the board diversity in a number of aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service.

The Board emphasis on diversity (including gender diversity) across all levels of the Group. As at the date of this annual report, the Board comprises six Directors, two of whom are female, it stands at 33.3%. The Board considers that gender diversity on the Board has been achieved. Further details on the gender ratio of the Group and initiatives taken to improve gender diversity across the workforce (including senior management), together with relevant data, can be found in the "Environmental, Social and Governance Report", which sets out on pages 63 to 90.

#### **Corporate Governance Committee**

The Corporate Governance Committee was established on 1 April 2012 with written terms of reference. The Corporate Governance Committee comprises of three members, namely Mr. Wang Jin Lian (an independent non-executive Director) being the chairman of the Corporate Governance Committee, Mr. Niu Jianmin (Chairman of the Board and an executive Director), and Mr. Lam Cheung Mau (an independent non-executive Director).

The key duties of the Corporate Governance Committee are as follows:

- (a) to develop and review the Company's policies and practices on corporate governance;
- (b) to review and monitor the training and continuous professional development of Directors and senior management;
- (c) to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements;
- (d) to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees and directors; and
- (e) to review the Company's compliance with the Code on Corporate Governance Practices (Appendix C1 to the Listing Rules) and disclosure in the Corporate Governance Report.

During the year ended 31 December 2023, the Corporate Governance Committee held two meetings. The meetings were held:

- reviewed the compliance with the Code and the relevant disclosure in the draft 2022 Annual Report and the draft 2023 interim report; and
- reviewed the training and continuous professional development of Directors and senior management.

#### 企業管治委員會

截至二零二三年十二月三十一日止年度, 企業管治委員會舉行兩次會議。會議舉行 乃為:

- 檢討守則的遵守情況及二零二二年年 度報告及二零二三年中期報告草案內 的相關披露;及
- 檢討董事及高級管理層的培訓及持續 專業發展。



#### **Finance and Investment Committee**

The Finance and Investment Committee was established on 1 April 2012 with written terms of reference. The Finance and Investment Committee comprises of four members, namely Mr. Niu Jianmin (Chairman of the Board and an executive Director) being the chairman of the Finance and Investment Committee, Mr. Hong Liang (an executive Director), Mr. Wang Jin Lian (an independent non-executive Director) and Ms. Zhou Zhan (an independent non-executive Director).

The key responsibilities of the Finance and Investment Committee are as follows:

- (a) to develop and review the Company's investment policies, financial strategies and objectives and make recommendations to the Board;
- (b) to consider, evaluate and review major project investments, acquisitions and disposals of the Group and to make recommendations to the Board;
- (c) to conduct post-investment evaluations on investment projects of the Group;
- (d) to arrange and approve banking facilities, loans, financial instruments, guarantees and indemnities of the Group;
- (e) to approve the opening and cancellation of bank or securities accounts of the Group and to approve the authorised signatories and mode of operations of the accounts;
- (f) to oversee the overall management of all the risks of the Group, including, without limitation, the financial and operational risks by setting and formulating risk management policies and strategies; and
- (g) to review and assess the adequacy and effectiveness and risk management policies and framework in identifying, measuring, monitoring and controlling risks.

#### 財務及投資委員會

財務及投資委員會成立於二零一二年四月 一日,並以書面形式劃定其職權範圍。財 務及投資委員會由四名成員組成,分別為 財務及投資委員會主席牛建民先生(董事會 主席兼執行董事)、洪樑先生(執行董事)、 王錦連先生(獨立非執行董事)及周展女士 (獨立非執行董事)。

財務及投資委員會之主要職責如下:

- 制定及檢討公司的投資政策、財務策略及目標,並向董事會提供意見;
- (b) 考慮、評估及檢討本集團主要項目投 資、收購及出售,並就此向董事會提 供意見;
- [c] 就本集團投資項目開展投資後進行評估;
- (d) 安排及批准本集團的銀行融資、借貸、金融工具、擔保及彌償保證;
- [e] 批准本集團銀行或證券戶口之開戶及 取消,並批准其戶口之授權簽署及運 作模式;
- (f) 設定及規劃風險管理政策及策略以監 督本集團的風險的全面管理,包括但 不限於財務及運營風險;及
- (g) 檢討及評估風險管理政策及架構是否 足夠及有效發現、估量、監察及控制 風險。

#### **Risk Management and Internal Control**

The Board places great importance on internal controls and is responsible for the risk management and internal control systems and reviewing the effectiveness of those risk management and internal control annually. The Company has provided directors training materials, which contain, amongst other things, inside information regulatory requirements, prepared by the Company's external legal advisor in order to ensure the Company is compliance with regulatory requirements.

The risk management and internal control systems are designed to manage the risk of failure to achieve corporate objectives and to protect the Group's assets and information. It aims to provide reasonable assurance against material misstatements, losses, damages or fraud and to manage rather than eliminate risks of failure in operations systems. The Board has delegated the design, implementation and ongoing assessment of risk management and internal control systems to the management, while the Board, through its Audit Committee, oversees and reviews the adequacy and effectiveness of relevant financial, operational and compliance controls and risk management procedures in place. Qualified personnel of the Group maintain and monitor these systems of controls on an ongoing basis.

The Board reviewed the effectiveness of the Group's risk management and internal control systems, including financial, operational and compliance control and risk management systems. The Board acknowledges that it is responsible for the risk management and internal control systems and reviewing their effectiveness. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. The Board reviewed the adequacy and effectiveness of the Group's risk management and internal control systems semi-annually through the Audit Committee. During the year ended 31 December 2023, no irregularity or material weakness was noted within any function or process. The Audit Committee is satisfied that the risk management and internal control systems had functioned effectively as intended.

The Company had established internal audit function and regularly carries out reviews on the effectiveness of the risk management and internal control in order to ensure that they are able to meet and deal with the dynamic and ever changing business environment.

The Board considers the risk management and internal control systems are effective and adequate for the Group as a whole. The Board further considers that there was no issue relating to the material controls, including financial, operational and compliance controls and risk management functions of the Group.

#### 風險管理及內部監控

本公司有設立內部審核功能並定期對風險 管理及內部監控的有效性進行審閱,確保 其能夠符合及應對靈活多變的經營環境。

董事會認為,風險管理及內部監控系統對 本集團整體而言屬有效及充足。董事會並 認為,本集團在財務、營運及合規監控以 及風險管理職能各方面未有任何重大監控 問題。



In addition, the Board and/or its committees have also reviewed the adequacy of the Company's resources, staff's qualifications and experience, training programmes and the related budgets in the Company's accounting, internal audit and financial reporting functions.

#### **Inside Information**

The Company has established a disclosure committee to oversee disclosure of inside information in accordance with a policy on disclosure of inside information (the "**Disclosure Policy**"). The Disclosure Policy sets out the procedures and internal controls for handling and dissemination of inside information in a timely manner and in such a way so as not to place any person in a privileged dealing position and to allow sufficient time for the market to price the listed securities of the Company with the latest available information of the Company.

All directors and employees of the Company must comply with the Disclosure Policy which provides guidelines to the directors, senior officers and other relevant employees of the Group to ensure proper safeguards in place to prevent the Company from breaching the statutory disclosure requirements of inside information. The Disclosure Policy also includes appropriate internal control and reporting systems to identify and assess potential inside information and relevant steps to be taken.

The Disclosure Policy also stipulates that dissemination of inside information of the Company shall be conducted by publication of the relevant information on the websites of Hong Kong Exchanges and Clearing Limited and the Company, according to the requirements of the SFO and the Listing Rules.

### **Company Secretary**

Ms. Leung Yin Fai is the Company Secretary of the Company and responsible for advising the Board on corporate governance matters and ensuring that the Board policy and procedures, and the applicable laws, rules and regulations are followed. All Directors have access to the advice and services of the company secretary to ensure that the Board procedures and all applicable laws are followed. Moreover, the company secretary is responsible for facilitating communications among Directors as well as with management. 此外,董事會及/或其委員會亦審閲本公 司的資源、員工資歷及經驗、培訓項目, 以及本公司會計、內部審核及財務報告功 能相關預算之足夠性。

#### 內幕消息

本公司設有披露委員會,以根據內幕消息 披露管理規定(「**披露規定**」)監督內幕消息 披露。披露規定載列有關處理及發佈內幕 消息之程序及內部監控,使內幕消息得以 適時處理及發佈,並不會導致任何人士在 本公司上市證券交易上處於佔優地位,亦 讓市場在得悉本公司最新可得資料的情況 下,有充足時間定出本公司上市證券之價 格。

本公司所有董事及僱員必須遵守披露規定。 該規定為本集團董事、高級人員及其他 相關僱員提供指引,確保設有適當措施, 以預防本公司違反法定的內幕消息披露規 定。披露規定亦載有適當的內部監控及匯 報制度,以識別及評估潛在的內幕消息及 採取相關行動。

根據證券及期貨條例及上市規則規定,披 露規定亦規範本公司內幕消息之發佈方法 乃於香港交易及結算所有限公司及本公司 網站內刊載相關消息。

### 公司秘書

梁燕輝女士為本公司公司秘書及負責就企 業管治事宜向董事會提供意見並確保遵守 董事會政策及程序、適用法例、規則及規 例。所有董事均可獲得公司秘書的建議及 服務以確保董事會遵守議事程序及所有適 用法律。此外,公司秘書負責促進董事之 間以及管理層之間的溝通。



The Company engages an external service provider, Ms. Leung Yin Fai, as its company secretary. Mr. Hong Liang, executive director of the Company, is the primary contact person whom Ms. Leung Yin Fai can contact. During the year ended 31 December 2023, the company secretary has undertaken more than 15 hours of relevant professional training.

# External Auditor and Auditor's Remuneration

The Company has engaged Crowe (HK) CPA Limited as its external auditor. The aggregate remuneration in respect of services provided by external auditor for the year ended 31 December 2023 was approximately HKD3.0 million (2022: HKD3.0 million), which represents annual audit services.

### Directors' Responsibility for Consolidated Financial Statements and Auditor's Responsibility

All Directors acknowledge their responsibility for preparing the consolidated financial statements of the Company for the year ended 31 December 2023 and of ensuring that the preparation of the consolidated financial statements of the Company is in accordance with the applicable standards and requirements.

The statement of the auditor about their reporting responsibilities on the consolidated financial statements of the Group is set out in the Independent Auditor's Report on pages 91 to 94 of this annual report.

### Going Concern and Mitigation Measures

As set out in Note 2.1(b) to the consolidated financial statements, as at 31 December 2023, the Group had a total deficit of RMB9,020,675,000 and the Group's current liabilities exceeded its current assets by RMB8,108,929,000. The Group maintained cash and cash equivalents of RMB2,143,000 as at 31 December 2023.

### 持續經營及應對措施

誠如綜合財務報表附註2.1(b)所載,於二零 二三年十二月三十一日,本集團總虧絀為 人民幣9,020,675,000元,而本集團流動負債 超出其流動資產人民幣8,108,929,000元。於 二零二三年十二月三十一日,本集團維持 現金及現金等價物人民幣2,143,000元。



On 9 October 2018, the Group entered into a conditional sale and purchase agreement to dispose of the core assets and liabilities of shipbuilding, offshore engineering, engineering machinery and marine engine building segments (the "Shipbuilding Business", together with the holding company of the Shipbuilding Business referred to as the "Disposal Group") with an independent third party. Pursuant to certain supplemental agreements signed with Unique Orient Limited (the "Purchaser"), an independent third party, the sale shares of Able Diligent Limited, the holding company of the Disposal Group, was transferred to the Purchaser on 10 March 2019. As at 31 December 2023, Relevant Guarantees provided by the Company to the banks and lenders of the Disposal Group, inclusive of principals and interest, amounted to RMB5,036,883,000. The Group has considered and recognised the corresponding impact of such financial guarantee contracts as at 31 December 2023.

During the year, the Group's operation was focused primarily on the energy exploration and production segment (the "**Energy Business**"), and oil storage and trading segment (the "**Oil Storage Business**"), the development of which has however been limited due to market conditions and availability of funds for investing in exploration and drilling of wells. As at 31 December 2023, borrowings of the Group, amounted to RMB3,934,716,000, out of which RMB1,569,065,000 were overdue. As at 31 December 2023, overdue interest payables of the Group amounted to RMB907,037,000. Certain borrowings of the Group contain crossdefault terms, causing borrowings of RMB8,618,000 as at 31 December 2023 to become immediately repayable. The Group had cash and cash equivalents of RMB2,143,000 as at 31 December 2023.

These conditions, together with others described in Note 2.1(b) to the consolidated financial statements, indicate the existence of multiple uncertainties which may cast significant doubt over the Group's ability to continue as a going concern. 於二零一八年十月九日,本集團已與獨立第 三方訂立有條件出售及購買協議,以出售 造船、海洋工程、工程機械及動力工程板 塊(「造船業務」,連同造船業務控股公司統 稱為「出售集團」)的核心資產及負債。根據 與獨立第三方東唯有限公司(Unique Orient Limited,「買方」)簽訂的若干補充協議,出 售集份已於二零一九年三月十日轉讓予買 方。於二零二三年十二月三十一日,本公司 就出售集團向銀行及借款人提供的相關擔 保(包括本金及利息)為人民幣5,036,883,000 元。本集團已考慮並於二零二三年十二月 三十一日確認有關財務擔保合約的相應影 響。

年內,本集團的業務主要專注於能源勘探 及生產板塊(「能源業務」)以及油儲及貿易 板塊(「油儲業務」),然而由於勘探和鑽井投 資的市況及可用資金,有關業務之開發受 到限制。於二零二三年十二月三十一日,本 集團的借款為人民幣3,934,716,000元,當中 人民幣1,569,065,000元已逾期。於二零二三 年十二月三十一日,本集團的逾期應付利 息為人民幣907,037,000元。餘下集團的若 干借款含交叉違約條款,導致須立即於二 零二三年十二月三十一日償還借款人民幣 8,618,000元。於二零二三年十二月三十一 日,本集團的現金及現金等價物為人民幣 2,143,000元。

以上事項,連同綜合財務報表附註2.1(b)所 述的其他事項,表明可能導致本集團的持 續經營能力產生重大疑慮的事項或情況存 在各種不確定性。



In view of such circumstances, the directors of the Company have, during the year and up to the date of the approval of these consolidated financial statements, taken the following measures to mitigate the liquidity pressure and to improve the financial position of the Group, to refinance its operation and to restructure its debts:

- i) The Group has been actively negotiating with the relevant banks and lenders of the Disposal Group to release or discharge the Relevant Guarantees. Since the date of the disposal till 31 December 2023, guarantees of RMB2,210,636,000 had been discharged while guarantees of RMB5,036,883,000 are expected to be released in year 2024 and RMB984,955,000 that did not meet the recognition criteria for financial guarantee contracts are disclosed as contingent liabilities.
- The Group has also been actively negotiating with the relevant financial institution and certain promissory note holders regarding the borrowings of RMB1,569,065,000 to take the following actions:
  - (a) During the current year, the maturity date of promissory notes with aggregate principal amount of RMB1,144,342,000 was successfully extended to December 2025. As at 31 December 2023, outstanding promissory notes amounting to RMB1,179,111,000 were not extended nor repaid upon the scheduled repayment dates and thus became overdue, and RMB8,618,000 became immediately repayable pursuant to the cross-default terms under the relevant loan agreements. The Company is in the process of negotiating with these promissory note holders for further arrangements, including the extension of maturity dates and obtaining waiver from the lender for the due payment pursuant to the relevant cross-default terms.
  - (b) As at 31 December 2023, the Group had other borrowing of RMB47,555,000 which was overdue. The Group is in the process of negotiating with the relevant lender for extension of repayment and renewal of such borrowing.
  - (c) As at 31 December 2023, the Group had secured borrowing of RMB342,399,000 which was overdue. The Group is in the process of negotiating with the relevant financial institution for extension of repayment and renewal of such borrowing.

- iii) As at 31 December 2023, the Group has drawn down USD119,951,000 (equivalent to approximately RMB851,390,000) in total from the loan facility, provided by entity controlled by Mr. Zhang Zhi Rong, who agreed to provide a loan facility up to USD250,000,000 (equivalent to approximately RMB1,774,450,000) to the Group for the funding of the oilfield operations of the energy exploration and production segment. As at 31 December 2023, the carrying amount is RMB760,755,000 and it is payable by 31 December 2025.
- iv) The Group has focused on its operations in development of the energy exploration and production segment. During the current year, a number of wells were in production in the Republic of Kyrgyzstan ("Kyrgyzstan").

Management expects to realise an increase of oil output through further development and expansion of this segment, thereby generating steady operating cash flows.

As at 31 December 2023, the Group has drawn down RMB5,725,000 in total from the loan facility, provided by an entity controlled by a close family member of Mr. Zhang Zhi Rong, who agreed to provide a loan facility up to RMB40,000,000 to the Group for the funding in respect of the energy exploration and production segment. In addition, the Group also entered into a cooperative framework agreement during the year ended 31 December 2018 with an independent third party who agreed to provide materials for the exploration and production of crude oil with an aggregate amount up to USD500,000,000, in exchange for an option to purchase up to 70% of the total crude oil produced by the Group at 92% to 95% of the market price as a form of repayment until all the liabilities are repaid. Such facility has not been utilised up to 31 December 2023.

The consolidated financial statements have been prepared on a going concern basis, the validity of which depends on the outcome of these measures, which are subject to multiple uncertainties, including (i) whether the Group is able to obtain the agreement from the banks and lenders to release or discharge fully the Company's guarantees for the borrowings owed by the Disposal Group; (ii) whether the Group is able to convince the banks and lenders not to demand for repayment of the outstanding loans of the Disposal Group before the completion of the full release of the Company's guarantees; (iii) whether the Group is able to negotiate with all existing promissory note holders to make further arrangements including extension of the maturity dates; (iv) whether the Group is able to negotiate with the relevant financial institution and lenders for the renewal or extension for repayment for the borrowings; (v) whether the Group is able to obtain waivers from the relevant promissory note holders for the due payment in relation to those notes that have cross-default terms and extend the repayment dates when they fall due; (vi) whether the Group can successfully implement a business plan for its Energy Business and Oil Storage Business to generate cash inflows; and (vii) whether the Group can obtain additional sources of financing, including those to finance the Energy Business and draw down from the various facilities made available to the Group by entities controlled by Mr. Zhang Zhi Rong and a close family member of Mr. Zhang Zhi Rong, during the year as and when needed.

Should the Group fail to achieve the above-mentioned plans and measures, it might not be able to continue to operate as a going concern, and adjustments would have to be made to write down the carrying value of the Group's assets to their recoverable amounts, to provide for any further liabilities which might arise, and to reclassify non-current assets and non-current liabilities as current assets and current liabilities. # Disclaimer of Opinion Issued by the Independent Auditor

As a result of the matters discussed in the section headed "Going Concern and Mitigation Measures", the Group's financial conditions, together with the other matters as described in note 2.1(b) to the consolidated financial statements, indicate the existence of multiple uncertainties which may cast significant doubt about the Group's ability to continue as a going concern, the Company's auditor does not express an opinion on the Group's consolidated financial statements for the year ended 31 December 2023. The Independent Auditor's Report is contained in pages 91 to 94 of this annual report.

As set out in note 2.1(b) to the consolidated financial statements as contained in this annual report, the Directors of the Company have been undertaking a number of measures to improve the Group's liquidity and financial position, to refinance its operations and to restructure its debts.

The Board and Audit Committee agreed with the views of the management and the auditor regarding the multiple uncertainties relating to going concern. There is no disagreement by the Board, the management nor the Audit Committee with the position taken by the Company's auditor regarding the disclaimer of opinion.

The Directors will continue to use their best efforts to protect and uphold the Company's best interest, including ongoing negotiation with the relevant banks and lenders for the Relevant Guarantees, renewal and extension of the Group's borrowings and development of the energy exploration and production. The Group, the Directors and the management will be proactive to resolve matters relating to the disclaimer of opinion throughout the coming years.

### Shareholders' Rights

Under the Articles of Association, in addition to regular Board meetings, Directors of the Company, on the written requisition of any one or more shareholders of the Company holding not less than 10% of the paid-up capital of the Company which carry voting rights, shall convene an extraordinary general meeting to address specific issues of the Company.

The requisition must (i) specify the objects of the meeting, the name of the requisitionist(s), their contact details and the number of ordinary shares in the Company held by them, (ii) be signed by the requisitionist(s) and (iii) be deposited at the Company's principal place of business in Hong Kong.

### **Overview**

China Huarong Energy Company Limited (the "**Group**" or "**we**") is principally engaged in energy exploration and production businesses in the Republic of Kyrgyzstan (the "**Kyrgyzstan**"), and oil storage business in the People's Republic of China (the "**PRC**"). We were granted rights to conduct the energy exploration and production businesses by holding 60% interests in the projects involving five oilfields located in the Fergana Valley of Kyrgyzstan. Besides, we hold 50.46% of the equity interest of Nantong Zhuosheng Petrochemical Co., Ltd. for the provision of oil storage and trading businesses. This Environmental, Social and Governance ("**ESG**") Report (the "**Report**") summarizes the ESG initiatives, plans and performances of the Group in 2023, and demonstrates our on-going commitment towards sustainable development.

### **About this Report**

This Report has been prepared in compliance with the requirement under the "ESG Reporting Guide" set out in the Appendix C2 of the Rules Governing the Listing of Securities on the Main Board of The Stock Exchange of Hong Kong Limited, for the period from 1 January 2023 to 31 December 2023 (the "**Reporting Period**"). The reporting boundary of this Report covers the Group's energy exploration and production businesses in Kyrgyzstan, and oil storage and trading businesses in the PRC. Key Performance Indicators ("**KPIs**") that need to be revealed compulsorily as required by the "ESG Reporting Guide" are all addressed in the "Environmental Sustainability" and "Social Sustainability" sections of this Report. Alongside with the reporting principles of the "ESG Reporting Guide", this Report also discloses the related laws and regulations that have been complied.

### 概覽

中國華榮能源股份有限公司(「本集團」或 「我們」)主要業務為於吉爾吉斯共和國(「 青 爾吉斯」)從事能源勘探及生產,以及在中 華人民共和國(「中國」)從事油儲業務。我 們透過持有位於吉爾吉斯費爾干納盆地五 個油田項目的60%權益,獲授權經營能源 勘探及生產業務。另外,我們透過持有南 通焯晟石油化工有限公司50.46%股權從事 油儲及貿易業務。本份環境、社會及管治 (「ESG」)報告(「本報告」)總結了本集團於二 零二三年的ESG舉措、計劃和表現,並展 示了我們對可持續發展的持久承諾。


### **Materiality Assessment**

## Environmental Sustainability

#### **Emissions**

The Group's core crude oil exploration and production businesses consume certain amount of natural resources, which directly impact the environment and generate greenhouse gases ("GHG"). Thus we firmly adhere the green production principle and strive to enhance crude oil extraction efficiency. We discharge pollutants in strict compliance with the statutory requirements and standards of Kyrgyzstan, and ensure all our emissions within legal limits. Our environmental protection engineers regularly inspect the crude oil extraction sites to identify the high environmental safety risk processes. They are required to report the Group's environmental protection works guarterly to avoid major accidents that may damage the environment. In addition, there are external consultants to monitor the entire production process and provide professional advices. The State Inspection for Environmental and Technical Safety of the Kyrgyzstan conducts annual inspections of the Group and provides inspection reports. During the Reporting Period, the State Inspection for Environmental and Technical Safety of Kyrgyzstan issued an environmental protection non-violation certificate to the Group, which means our emissions were within the national limits.

For the oil storage and trading businesses, the environmental management department is responsible for arranging dedicated personnel for environmental protection related matters. We have implemented pollution prevention measures and closely monitored the environmental conditions surrounding the production sites. Pollutant purification initiatives such as sewage treatment stations, and oil and gas collection devices are placed to reduce the pollutants in wastes. Besides, we regularly introduce waste sources and treatment methods, and emergency responses to environmental pollution accidents to employees to enhance their environmental awareness and adaptability.

### 環境可持續發展

排放

本集團的核心原油勘探及生產業務消耗一 定數量的自然資源,直接影響環境並產生 溫室氣體(「GHG」)。因此,我們堅持綠色生 產原則,致力提高原油開採效益。我們嚴 格依照吉爾吉斯法定要求和標準排放污染 物,確保我們所有排放在法定限度內。我 們的環保工程師定期檢查原油開採現場, 識別高環境安全風險工序。他們需要每季 報告本集團環保工作狀況,避免發生破壞 環境的重大事故。此外,還有外部顧問監 控整個生產流程並提供專業建議。吉爾吉 斯國家安全環保監督局對本集團進行年度 檢查並出具檢查結論書。於匯報期間,吉 爾吉斯國家安全環保監督局向本集團頒發 了環保無違規證書,證明我們的排放均在 國家標準範圍內。

油儲及貿易業務方面,環境管理部門負責 安排專人負責環保相關事宜。我們實施了 污染防控措施,並密切監測生產場地周圍 的環境狀況。實施污染物淨化措施如設置 污水處理站、油氣回收裝置,以減少廢棄 物中的污染物。此外,我們定期向員工介 紹廢物來源和治理方法,及環境污染事故 應急處置辦法,提升其環保意識及應變能 力。

During the Reporting Period, the Group generated 5.85kg of Nitrogen Oxides, 0.80kg of Sulphur Oxides and 0.43kg of Particulate Matter. The total GHG emission for the Group was 1,587.0tonnes CO<sub>2</sub>e for the same period.

Hazardous wastes may be generated during the crude oil exploration and production, possibility from the leakage of crude oil or sewage. There are strict measures for the Group to monitor the oil pipelines and various equipment in the production sites to avoid crude oil leakage. Our production sites are equipped with sewage tanks and anti-seepage cloth, and oil booms and oil-absorbing felts are installed at the pier to prevent harmful wastes from seeping into the soil. Qualified outsourcing companies are responsible for the safe treatment of sewage to ensure within legal discharge standards. Hazardous wastes will be transported to the central collection points for centralized treatment, stored in sealed oil tanks and then processed by qualified outsourcing companies.

For oil storage and trading businesses, our production sites, equipment, safety protection, fire protection, life-saving and environmental protection equipment all meet the safety requirements of relevant laws. We conduct regular inspection and maintenance on all equipment, and configure sufficient anti-pollution emergency equipment, such as oil booms and oil skimmers.

The non-hazardous wastes generated by the Group are mainly daily operation wastes in production sites and offices, such as plastics, paper, and domestic garbages. All employees are required to reduce waste generation, purchase durable and environmental-friendly products in daily operations. The Group follows the "3R" (Reduce, Reuse, Recycle) waste management principle to properly handle and dispose wastes. Recycle bins are placed in production sites and offices to collect and classify wastes. Classified wastes will be sent to recycling centers for disposal by professional sanitation service companies. We acknowledge the importance of reducing wastes from sources. The Group has basically accomplished paperless office by encouraging employees to use electronic documents and utilize electronic communications. We also promote reusing old office equipment and changing the habit of throwing away immediately after use. Meals in our staff canteens are well planned to reduce food wastes.

- Electricity The Group's use of electricity was mainly from the production sites and daily operations in offices. We always remind our staff to reduce electricity consumption. Energy saving and environmental-friendly equipment and office supplies have been used in operations. Following are the electricity saving measures implemented by the Group:
  - Use of LED lightings;
  - Display "Turn off the lights after work" signs in prominent places in production sites and offices;
  - ✓ Encourage employees to use less air conditioning and maintain indoor air temperature at 25 degree Celsius;
  - Check the status of all electrical appliances everyday to prevent people from leaving without turning off electrical appliances;
  - Hire maintenance specialists to repair and clean the air-conditioning system regularly;
  - Purchase electrical appliances with energy efficiency labels.
- Water

The Group's water consumption mainly came from the production sites and daily operations in offices. As water is a precious resource that is indispensable to our society, we adopt the following measures on water conservation:

- Cut off unnecessary water usage from the sources, and regularly review the water consumptions in production sites and offices;
- Post "Water Conservation" signs in prominent places in production sites and offices;
- Remind employees to turn off the tap after use and stop water supply during non-office hours;
- Develop water recycling measures, and properly recycle and reuse water;
- Repair or replace water facilities immediately if water leakage is found.

- Gasoline and Diesel The Group's use of gasoline and diesel were mainly from the business vehicles in our daily operations. We implemented following measures to reduce gasoline and diesel consumption:
  - ✓ Use of low emission gasoline and diesel;
  - Purchase electric vehicles or low-fuel consumption vehicles;
  - ✓ Advocate shared use of business vehicles in business activities;
  - Require employees to use public transportations for non-critical business activities;
  - Encourage employees to conduct video and audio conferences to replace on-site meetings and reduce business travels.
- Paper

The Group's paper usage mainly came from production sites and daily operations in offices. We advocate paperless office and information automation, and following are our measures to reduce paper consumption:

- Procure environmental-friendly paper;
- ✓ Set double-sided printing as printers' default setting;
- Recycle of used paper;
- Utilize email, intranet and scanners to transmit or store documents electronically;
- Use of electronic means to promote the Group's products to reduce paper promotional materials.

#### **Environmental and Natural Resources**

Apart from the emissions and resource consumptions discussed above, the Group's operations did not have other direct and material impact on the environment and natural resources.

#### **Climate Change**

The Group recognizes climate change is one of the greatest risks confronting humanity, in particular extreme weather is threatening our community and business operations. It is vital to understand our corporate role in addressing climate change threats, which could impact the Group in terms of both its business profitability and long-term resilience. During the Reporting Period, we maintained our vigilance in monitoring and addressing climate-related concerns that are pertinent to our business. We have identified the following physical and transitional risks, included them in the monitoring list and formulated corresponding mitigation actions.

Looking ahead, the Group will continue to closely monitor the environmental protection policies and regulatory trends in Kyrgyzstan, the PRC and worldwide. We shall invest in corresponding environmental protection measures timely to enhance the Group's sustainability performance.

#### **Sustainability Targets**

In 2021, the Group has set sustainability targets of the GHG emission intensity, non-hazardous waste generated intensity and the intensity of use of various resources will be maintained stable for the next three to five years. During the Reporting Period, the targets could not be achieved due to decrease in the Group's revenue. We will regularly review the sustainability targets and adopt the measures stated in this Report to achieve the targets.

## Social Sustainability

#### Employment

The Group firmly believes that talents are the cornerstone of our continuous business growth. We highly value talents and consider talents are our valuable assets. Thus we are eager to provide all employees a fair, open, safe and healthy working platform. The Human Resources Department is responsible for the implementation of the Group's recruitment, dismissal and welfare policies, which are strictly in accordance with the relevant employment laws and regulations of Kyrgyzstan and the PRC. In Kyrgyzstan, we actively promote localization which does not only to satisfy the local employee ratio requirement, but also to provide employment opportunities for local citizens. The main focuses of the Group's employment policy are employees' diversity and inclusion as our employees are from different countries and races. We treat all employees equally in terms of recruitment, employment, compensation, training, promotion, dismissal and retirement, regardless of gender, race, age, disability, family status, marital status, sexual orientation, religious belief, nationality or any other factors unrelated to work. There is zero-tolerance of discrimination within the Group and disciplinary actions would be taken if any non-compliance of the equal opportunities is found. We respect the rights and interests of female employees. They are entitled to have fair opportunities for employment and promotion. Allowances for the International Women's Day has been provided and special festival activities were held.

本集團堅信人才是我們業務持續成長的 基石。我們高度重視人才,認為人才是我 們的寶貴資產。因此,我們積極為所有員 工提供一個公平、公開、安全、健康的工 作平台。人力資源部負責執行本集團的招 聘、解僱及福利政策,嚴格按照吉爾吉斯 和中國相關勞動法律法規執行。在吉爾吉 斯,我們積極推動本地化,不僅為滿足當 地員工比例要求,也為當地民眾提供就業 機會。因為我們的員工來自不同國家和種 族,本集團僱傭政策的主要焦點是員工的 多元化和包容性。我們在招聘、僱用、薪 資、培訓、晉升、解僱和退休相同對待所 有員工,無論性別、種族、年齡、殘疾、 家庭狀況、婚姻狀況、性取向、宗教信 仰、國籍或任何其他與工作無關的因素。 本集團對歧視採取零容忍態度,如發現任 何不遵守平等機會的行為,我們將採取紀 律處分。我們尊重女性員工的權益。她們 有權享有公平的就業和晉升機會,並於國 際三八婦女節發放津貼及舉辦特色節慶活 動。

The Group is committed to attracting outstanding talents, and our recruitment process is open and fair. The Human Resources Department prepares annual recruitment plans at the beginning of the year based on business development needs. Recruitment strictly adheres with the legal requirements in each business location. Job applicants are selected only based on their performance, personal attributes, job experiences and career aspirations. Labour contracts are signed in accordance with equality, voluntariness and mutual negotiations. We provide "Employee Handbook" to all staff, especially the Chinese-Russian bilingual "Employee Handbook" for employees in Kyrgyzstan to protect their rights. Pre-employment trainings are provided for the newly joined staff. They are trained and mentored by experienced employees in production sites. The Group fully complies with the statutory minimum wage requirement in each business location. and also pays social insurance and pensions for all employees. Employees' working hours and rest periods are set in accordance with the laws. In addition to statutory paid leaves, employees are also entitled to sick leave, maternity leave, marriage leave and compassionate leave.

The Group conducts quarterly and annual employee performance appraisals to evaluate employees' performance. It is also the reference for promotion and salary adjustment to retain outstanding staff. Our priority is to promote internal well-performed and high-potential employees. Staff promotions and salary adjustments are only based on their performance, capabilities and professional ethics. There is a clear dismissal system under the "Employee Handbook". The Group will only dismiss employees reasonably and in accordance with the laws in of each business location. Any unfair or unreasonable dismissal is strictly prohibited.

As of 31 December 2023, the total number of employees within the reporting boundary of this Report was 142. All employees are full-time staff. During the Reporting Period, 20 employees left the Group.

本集團按季度及年度進行員工績效考核, 評估員工的工作表現,這也是升職、薪資 調整的參考,以保留優秀員工。我們的首 要任務是提拔內部表現良好和高潛力的員 工。員工的晉升和薪資調整僅基於他們的 表現、能力和專業道德。《員工手冊》中有 明確的辭退制度。本集團只會合理及根據 各業務地點的法律解僱員工,嚴禁任何不 公平或不合理的解僱行為。

於二零二三年十二月三十一日,本集團於 本報告匯報範圍內的員工數目為142人。全 部為全職員工。於匯報期間,離職員工有 20人。

During the Reporting Period, the Group was in full compliance with relevant employment laws and regulations regarding remuneration, dismissal, recruitment, promotion, working hours, holidays, equal opportunities, diversity, anti-discrimination, welfares and etc.

#### **Occupational Health and Safety**


The crude oil exploration and production businesses involves handful of processes with potential occupational health and safety risks. Thus employees' health and safety is always on the top of our agenda, and we strive to provide healthy and safe workplaces. We strictly abide by the laws and regulations related to occupational health and safety in each business location. The Safety Committee is responsible for the Group's occupational health and safety matters, which covers labour protection, equipment safety, workplace conditions, personnel training and business knowledge inspection. In Kyrgyzstan, the full-time safety engineers conduct daily supervision and rectification according to local laws. They are required to report the safety situation of production sites every quarter. The leaders of production and engineering departments are required to conduct daily inspection with the focus on checking high-risk points, and closely monitoring oil pipelines and related equipment. Once a safety problem is found, on-site education must be carried out immediately, as well as timely rectification. We provide safety protective equipment especially for dangerous types of work. The Group's disaster response code provides all employees the clear safety process guidelines and contingency measures.

Fire is the most risky incident faced by the Group. We formulated various fire emergency measures, and strictly prohibiting employees from smoking and lighting fires in production sites. Electrical hazard signs are posted at appropriate locations to remind employees to pay attention to fire safety. We unified the identification signs of dangerous goods, and standardized the use and storage of flammable and explosive items. We placed escape route maps in prominent places in offices, and equipped with emergency medical kits and fire-fighting equipment. It is strictly forbidden for any items to occupy the emergency exit passages. We regularly inspect the fire-fighting facilities to ensure that they are not damaged or expired, and arrange fire drills periodically. The Group has agreements with the fire brigades in each business location to carry out joint emergency response to accidents.

#### 職業健康與安全

原油勘探和生產業務涉及不少潛在的職業 健康與安全風險的工序。因此,員工的健 康和安全是我們的首要選項,我們努力提 供健康和安全的工作場所。我們嚴格遵守 各業務地點有關職業健康與安全的法律 法規。安全委員會負責本集團的職業健康 與安全事務,內容涵蓋勞工保護、設備安 全、工作場所條件、人員培訓和業務知識 檢查。在吉爾吉斯,專職安全工程師根據 當地法律進行日常監督和整改,每季報告 牛產場地安全。牛產和工程部門負責人需 要做好日常檢查,重點檢查高風險點,嚴 密監控輸油管及相關設備。一旦發現安全 問題,必須立即進行現場教育,並及時整 改。我們特別針對危險類型的工作提供安 全防護設備。本集團的災難應變準則為所 有員工提供了明確的安全流程指南和緊急 措施。



appropriate work arrangements and medical follow-ups will be made. Insurances are purchased for employees. We conduct guarterly safety and health trainings for employees. The Human Resources Department holds regular discussions with employees to take care of their mental health and help them to relieve work pressure. In any unfortunate event of casualty accidents, the Group will provide immediate assistance to the injured employees. The Safety Committee will also investigate each accident to prevent recurrence

During the Reporting Period, the Group did not violate any relevant laws and regulations regarding occupational health and safety. For the past three years, the Group has not recorded any work-related fatalities and loss of working days due to work injury.

#### **Development and Training**

On-the-job training is vital to employees' career development. Enhancing employees' knowledge and skills will promote the competitiveness of the Group. The Group's employee training system consists of three parts: pre-job trainings for new employees, on-the-job trainings and self-improvement trainings for existing employees. Employees must obtained relevant professional qualifications or vocational training certificates before on board. The Human Resources Department is responsible for enhancing the skills of employees and assisting them to pass the professional qualification assessments in each business location. Regular staff trainings are arranged based on employees' positions, roles, career goals and needs. For instance, we arranged all employees to participate the safety trainings and each department conducted its own business trainings. The Group provides examination leave to encourage employees to acquire professional qualifications in their spare time. We are fully responsible for employees' internal training costs and partially responsible for employees to join those external trainings that may help to accomplish the Group's business needs or personal development.

於匯報期間,本集團沒有違反任何職業健 康與安全相關的法律法規。過去三年,本 集團並無錄得任何工作死亡或因工業意外 受傷而損失工作日數。

#### 發展與培訓

在職培訓對員工的職涯發展至關重要。 提升員工的知識和技能將推進本集團的 競爭力。本集團員工培訓體系由新進員工 上崗前培訓、在崗員工在職培訓及自我提 升培訓三部分所組成。員工上崗前必須取 得相關專業資格或職業訓練證書。人力資 源部負責提升員工技能,協助員工通過各 業務地點的專業資格評估。定期員工培訓 根據員工的職位、角色、職業目標和需求 安排。例如,我們安排全員參加安全培訓 及各部門進行各自的業務培訓。本集團提 供考試假,鼓勵員工利用空閒時間取得專 業資格。我們全額支付員工的內部培訓費 用,並部分支付員工參加有助於完成本集 團業務需求或個人發展的外部培訓。

During the Reporting Period, the Group organized 2,104 hours of training for the entire staff, which represented an average of 14.8 hours of training per employee.

#### Labour Standard

The Group is fully aware that child labour and forced labour violate basic human rights. We strictly abide the laws and regulations in each business location, and implement strict measures to prevent child labour and forced labour. During the recruitment, we require the applicants to present their personal identification documents including identity cards, academic certificates, employment records, military service certificates, medical reports and etc., to ensure that the age and other personal information provided are correct and can be legally employed. Working hours and rest time of employees are according to the laws and regulations. Employees who work overtime are only on voluntary basis. For any overtime works during the peak season, we provide extra vacations for compensation to ensure sufficient rest of the staff. The Group will issue warnings and even dismissal if there is any violation of laws and regulations related to child labour and forced labour.

During the Reporting Period, the Group was not in violation of any laws and regulations related to the prevention of child labour and forced labour.

#### **Supply Chain Management**

While the Group strongly supports sustainable development, we also expect our suppliers to fulfill the same social responsibilities. Thus we closely monitor the ESG performance of the entire supply chain. The Group's "Administrative Measures for Tendering and Bidding" stipulates that the supplier selection process shall be conducted in open, fair and transparent manner. All suppliers will be given equal opportunities and at least three potential suppliers must be approached. Our Bidding Committee strictly follows the "Administrative Measures for Tendering and Bidding" to evaluate all potential suppliers, including their prices, service scopes, financial status, environmental awareness, occupational health and safety, loyalty and etc. Environmental-friendly suppliers are given selection priority. We have taken every step to avoid corruption or bribery in the procurement process. Suppliers are required to declare their interests to avoid conflicts or transfer of interests. Our contracts with suppliers specify the suppliers' obligations. Suppliers are bound to perform in accordance with the contracts by the deposit system. After the cooperation is confirmed, suppliers must prevent any possible adverse environmental impacts from their operations and production processes. We engaged independent supervisory agencies to conduct annual inspections on suppliers' safety, environmental protection, labour protection and etc. Based on the inspection reports, we may require suppliers for rectifications and warnings will be given to those unqualified suppliers.

During the Reporting Period, there were 187 suppliers for the Group within the reporting boundary of this Report, including 5 from Kyrgyzstan and 182 from the PRC.

#### **Product Responsibility**

Provision of high-quality products to customers is the key to gain their long-term trust and support. The Group's product quality assurance system ensures that our products satisfy customers demand and fulfill the legal requirements in each business location. We regularly review the product quality to identify the problems and timely ratify the deficiencies. For unqualified products, we will evaluate with the industry experts and prepare written reports to improve quality. We provide work-flow and product knowledge trainings to our sales representatives, and ensure they would not make any false publicity. All external product publicities must be approved by the management before being released.

The Group's complaint handling system and procedures ensure customer complaints will be handled timely. Customers can submit feedback and complaints through our service hotlines, emails and surveys. We will arrange appropriate staff to handle the complaints based on their content. Follow up actions and remedial measures will be prepared in the shortest possible time.

#### 供應鏈管理

本集團大力支持可持續發展的同時,也期 望供應商能履行同樣的社會責任。因此, 我們密切監控整個供應鏈的ESG表現。本 集團的《招投標管理辦法》規定供應商甄 選過程要公開、公平及透明。所有供應商 享有平等的機會,並且必須接觸至少三個 潛在供應商。我們的招標委員會嚴格依照 《招投標管理辦法》對所有潛在供應商進 行評估,包括其價格、服務範圍、財務狀 況、環保意識、職業健康與安全、忠誠度 等,優先選擇環境友善供應商。我們已採 取一切措施避免採購過程中出現貪污或賄 路。供應商必須申報其利益,以避免利益 衝突或利益輸送。我們與供應商的合約列 明供應商的責任,以保證金制度約束供應 商履行合同。在確定合作後,供應商必須 防止其營運和生產過程對環境可能產生的 負面影響。我們聘請了獨立監管機構對供 應商的安全、環保、員工保護等進行年度 檢查。根據檢查報告,我們可以要求供應 商進行整改,及對不合格的供應商將給予 警告。

於匯報期間,本報告的報告範圍內與本集 團合作的供應商共有187家,其中5家來自 吉爾吉斯及182家來自中國。

## 產品責任

為客戶提供高品質的產品是獲得客戶長 期信任和支持的關鍵。本集團的產品質量 保證體系確保我們的產品符合客戶需求, 並符合各業務地點的法定要求。我們定 期審查產品質量以發現問題,並及時整改 缺陷。對於不合格的產品,我們將與行之 專家一起評估,並準備書面報告以提高品 知識培訓,確保他們不會進行任何虛假 知識培訓,確保他們不會進行任何虛 個。所有外部產品宣傳必須經過管理層批 准後才能發佈。

本集團的投訴處理制度和程序確保客戶投 訴得到及時處理。客戶可以透過我們的服 務熱線、電子郵箱和意見調查提交回饋和 投訴。我們將按投訴內容安排相應人員處 理,將在最短的時間內準備好後續行動和 補救措施。

## ENVIRONMENTAL, SOCIAL AND GOVERNANCE REPORT 環境、社會及管治報告

The Group recognizes the importance of protecting intellectual property rights. We established management systems for handling matters related to patent and intellectual property rights, which intellectual property rights are protected through receiving or registering patents. The Group refuses to provide or use any products or services that violate copyrights or intellectual property rights. We only procure genuine products, and all software and information used are legally licensed.

The Group ensures that necessary steps and measures have been taken to preserve the confidentiality and data of customers and suppliers. Before we collect customer and supplier information, we have to obtain their signed personal information collection consent statements. The purposes of data collection are clearly stated in the statement and the data could only be used for the stated purposes at the time of collection. The right to access and use customer and supplier data is limited to relevant departments and employees. We always remind all employees of the Group's requirements for handling customer and supplier data and privacy. Employees are required to sign confidentiality agreement, which agreed not to disclose and improperly use customer and supplier data.

During the Reporting Period, the Group did not violate any laws and regulations regarding the product responsibility, intellectual property rights and data privacy. The Group also did not have any products sold being recalled and received complaints.

#### **Anti-Corruption**

The Group believes that integrity is the foundation for maintaining corporate competitive advantage and there is zero-tolerance of any form of corruption. We strictly comply with the laws and regulations related to anti-corruption in each business location. Employees are required to sign the "Integrity Practice Commitment", which prohibits employees in participation of any bribery, extortion, fraud and money laundering activities. They are not allowed to accept funds or gifts from customers and suppliers, and they must complete the interest declaration when necessary. In addition, the Group will introduce our anti-corruption policy to suppliers before signing contracts and suppliers are required to sign the "Integrity Agreement for Tendering and Bidding". We regularly arrange business ethics and anti-corruption trainings for our directors and employees. During the Reporting Period, the Group organized a total of 96 hours of trainings related to anti-corruption for directors and employees. The Group will handle any corruption case seriously and employees who violated the laws will be handed over to the judiciaries.

The Group's independent Internal Audit Department formulated our internal audit regulations. Internal auditors are responsible for our internal audit supervision and internal risk control system establishment. Management regularly reviews the reports of internal audit, and organizes special meetings to implement relevant improvement suggestions and prevent corruption risks.

The Group's whistle-blowing system allows whistle-blowers to report any suspected misconducts to the Audit Committee under the Board through dedicated email. The Audit Committee will investigate those suspected misconducts confidentially and reports the misconduct cases to the Board at least once a year. Immediate corrective actions will be taken once any violation of regulations is found.

During the Reporting Period, the Group did not receive any corruption lawsuits against the Group or its employees. Meanwhile, the Group and its employees were not in violation of any of the relevant laws and regulations in relation to bribery, extortion, fraud and money laundering.

#### **Community Investment**

The Group's ongoing business development is closely tied to the well-being of the communities where we serve. Thus we are keen to contribute in constructing a cohesive and caring society in each business location. We highly value the importance of participating in community services and are committed to leveraging our resources to contribute the society. We pay special attention to fostering employees' awareness of social responsibility and encourage them to voluntary participate in charity events to build cohesion relationships with the local community of each business location. 本集團獨立運作的內部審計部制定了我們 的內部審計規章。內部審計員負責我們的 內部審計監督及內部風險控制體系建設。 管理層定期審閱內部審核報告,組織專題 會議落實相關改善建議,防範貪污風險。

## **Disclaimer of Opinion**

We were engaged to audit the consolidated financial statements of China Huarong Energy Company Limited (the "**Company**") and its subsidiaries (collectively, the "**Group**") set out on pages 95 to 213, which comprise the consolidated statement of financial position as at 31 December 2023, the consolidated statement of profit or loss, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended; and the notes to the consolidated financial statements, which include material accounting policy information.

We do not express an opinion on the consolidated financial statements of the Group. Because of the potential interaction of the multiple uncertainties and their possible cumulative effect on the consolidated financial statements as described in the Basis for Disclaimer of Opinion section of our report, it is not possible for us to form an opinion on these consolidated financial statements. In all other respects, in our opinion, the consolidated financial statements have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

## **Basis for Disclaimer of Opinion** Multiple Uncertainties Relating to Going Concern

As set out in Note 2.1(b) to the consolidated financial statements, as at 31 December 2023, the Group had a total deficit of RMB9,020,675,000 and the Group's current liabilities exceeded its current assets by RMB8,108,929,000. The Group maintained cash and cash equivalents of RMB2,143,000 as at 31 December 2023.

On 9 October 2018, the Group entered into a conditional sale and purchase agreement to dispose of the core assets and liabilities of shipbuilding, offshore engineering, engineering machinery and marine engine building segments (the "**Shipbuilding Business**", together with the holding company of the Shipbuilding Business referred to as the "**Disposal Group**") with Unique Orient Limited (the "**Purchaser**"), an independent third party. Pursuant to certain supplemental agreements signed with the Purchaser, the sale shares of Able Diligent Limited, the holding company of the Disposal Group, was transferred to the Purchaser on 10 March 2019. As at 31 December 2023, financial guarantees provided by the Company to the banks and lenders of the Disposal Group, inclusive of principals and interest, amounted to RMB5,036,883,000. The Group has considered the impact and recognised financial guarantee contract of the same amount as at 31 December 2023. 致中國華榮能源股份有限公司股東

## 無法表示意見

我們已獲委聘審計列載於第95至213頁中國 華榮能源股份有限公司(「**貴公司**」)及其附 屬公司(統稱「**貴集團**」)的綜合財務報表, 包括於二零二三年十二月三十一日的綜合 財務狀況表、截至該日止年度的綜合損益 表、綜合全面收益表、綜合權益變動表及 綜合現金流量表;以及綜合財務報表附註, 包括重大會計政策資料。

我們不對 貴集團的綜合財務報表發表意 見。由於多個不確定性的潛在相互作用及 其對綜合財務報表的可能累加影響,如我 們報告「導致無法表示意見的基礎」一節所 述,我們無法對該等綜合財務報表發表意 見。有關所有其他方面,我們認為綜合財 務報表已按照香港公司條例的披露規定妥 善編製。

## **導致無法表示意見的基礎** 與持續經營相關的多項不確定事項

誠如綜合財務報表附註2.1(b)所載,於二零 二三年十二月三十一日, 貴集團總虧絀為 人民幣9,020,675,000元,而 貴集團流動負 債超出其流動資產人民幣8,108,929,000元。 於二零二三年十二月三十一日, 貴集團維 持現金及現金等價物人民幣2,143,000元。

於二零一八年十月九日, 貴集團已與獨立 第三方東唯有限公司(「**買方**」)訂立有條件 出售及購買協議,以出售造船、海洋工程、 工程機械及動力工程板塊(「**造船業務**」,連 同造船業務控股公司統稱為「**出售集團**」)的 核心資產及負債。根據與買方簽訂的若干 補充協議,出售集團控股公司Able Diligent Limited的銷售股份已於二零一九年三月十 日轉讓予買方。於二零二三年十二月三十一 日, 貴公司就出售集團向銀行及借款人 提供的財務擔保(包括本金及利息)為人民 幣5,036,883,000元。 貴集團已考慮其影響 並於二零二三年十二月三十一日確認財務 擔保合約。



# INDEPENDENT AUDITOR'S REPORT 獨立核數師報告

During the year, the Group's operation was focused primarily on the energy exploration and production segment [the "**Energy Business**"], and oil storage and trading segment (the "**Oil Storage Business**"], the development of which has however been limited due to market conditions and availability of funds for investing in exploration and drilling of wells. As at 31 December 2023, borrowings of the Group, amounted to RMB3,934,716,000, out of which RMB1,569,065,000 were overdue. As at 31 December 2023, overdue interest payables of the Group amounted to RMB907,037,000. Certain borrowings of the Group contain cross-default terms, causing borrowings of RMB8,618,000 as at 31 December 2023 as immediately repayable. The Group had cash and cash equivalents of RMB2,143,000 as at 31 December 2023.

The directors of the Company have been undertaking a number of measures to improve the Group's liquidity and financial position, to refinance its operations and to restructure its debts which are set out in Note 2.1(b) to the consolidated financial statements. The consolidated financial statements have been prepared on a going concern basis, the validity of which depends on the outcome of these measures, which are subject to multiple uncertainties, including (i) whether the Group is able to obtain the agreement from the banks and lenders to release or discharge fully the Company's guarantees for the borrowings owed by the Disposal Group; (ii) whether the Group is able to convince the banks and lenders not to demand for repayment of the outstanding loans of the Disposal Group before the completion of the full release of the Company's guarantees; (iii) whether the Group is able to negotiate with all existing promissory note holders to make further arrangements including extension of the maturity dates; (iv) whether the Group is able to negotiate with the relevant financial institution and lender for the renewal or extension for repayment for the borrowings; (v) whether the Group is able to obtain waivers from the relevant promissory note holders for the due payment in relation to those notes that have cross-default terms and extend the repayment dates when they fall due; (vi) whether the Group can successfully implement a business plan for its Energy Business and Oil Storage Business to generate cash inflows; and (vii) whether the Group can obtain additional sources of financing, including those to finance the Energy Business and draw down from the various facilities made available to the Group by entities controlled by Mr. Zhang Zhi Rong and a close family member of Mr. Zhang Zhi Rong, during the year as and when needed.

These conditions, together with others described in Note 2.1(b) to the consolidated financial statements, indicate the existence of multiple uncertainties which may cast significant doubt over the Group's ability to continue as a going concern.

貴集團的業務主要專注於能源勘 年內, 探及生產板塊(「能源業務」)以及油儲及貿 易板塊(「油儲業務」),然而由於勘探和鑽 井投資的市況及可用資金,有關業務之開 發受到限制。於二零二三年十二月三十一 貴集團的借款為人民幣3,934,716,000 Η, 元,當中人民幣1,569,065,000元已逾期。於 二零二三年十二月三十一日, 貴集團的 逾期應付利息為人民幣907,037,000元。 貴 集團的若干借款含交叉違約條款,導致須 立即於二零二三年十二月三十一日償還借 款人民幣8,618,000元。於二零二三年十二月 三十一日, 貴集團的現金及現金等價物 為人民幣2.143.000元。

貴公司董事一直採取多項措施改善 貴集 團的流動性及財務狀況,為其營運再融資 及重組其債務(詳情載於綜合財務報表附 註2.1(b))。綜合財務報表在持續經營的基 礎上編製。該編製基礎是基於上述改善 措施實施的結果,而該等措施的實施結果 取決於多項不確定事項,包括[i] 貴集團 是否能夠取得銀行及貸方的同意,以全部 釋放或解除 貴公司對出售集團所欠借款 的擔保;[ii] 貴集團是否能夠於 貴公司擔 保全部解除完成前説服銀行及貸方不要求 償還出售集團的未償還貸款;[iii] 貴集團 能否與現有全部承兑票據持有人磋商以作 進一步安排,包括延長到期日;[iv] 貴集 團能否與有關金融機構及貸方磋商重續或 延期償還借款; [v] 貴集團能否就與具有 交叉違約條款及於到期時延長還款日期的 該等票據有關的到期付款從相關承兑票據 持有人獲取豁免; [vi] 貴集團能否為其能 源業務及油儲業務成功執行業務計劃以產 生現金流;及[vii] 貴集團能否取得額外融 資來源,包括為其能源業務提供資金的融 資來源,以及動用由張志熔先生及張志熔 先生家屬所控制的實體於年內及有需要時 向 貴集團所提供多項融資。

以上事項,連同綜合財務報表附註2.1(b)所 述的其他事項,表明可能導致 貴集團的 持續經營能力產生重大疑慮的事項或情況 存在各種不確定性。

As a result of the above-mentioned multiple uncertainties, the potential interaction of these uncertainties, and the possible cumulative effect thereof, we were unable to form an opinion as to whether the going concern basis of preparation is appropriate.

Should the Group fail to achieve the above-mentioned plans and measures, it might not be able to continue to operate as a going concern, and adjustments would have to be made to write down the carrying value of the Group's assets to their recoverable amounts, to provide for any further liabilities which might arise, and to reclassify non-current assets and non-current liabilities as current assets and current liabilities. The effect of these adjustments has not been reflected in the consolidated financial statements.

## Responsibilities of Directors and Those Charged with Governance for the Consolidated Financial Statements

The directors of the Company are responsible for the preparation of the consolidated financial statements that give a true and fair view in accordance with International Financial Reporting Standards and the disclosure requirements of the Hong Kong Companies Ordinance, and for such internal control as the directors determine is necessary to enable the preparation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, the directors are responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the Group or to cease operations, or have no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Group's financial reporting process.

## 1 General information

China Huarong Energy Company Limited (the "**Company**") was incorporated in the Cayman Islands on 3 February 2010 as an exempted company with limited liability under the Companies Law of the Cayman Islands. Its registered address is Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman, KY1– 1111, Cayman Islands.

The Company is an investment holding company. The principal activities of the subsidiaries are set out in Note 32 to the consolidated financial statement.

The consolidated financial statements are presented in Renminbi ("**RMB**"), unless otherwise stated.

## 2 Material Accounting Policy Information

The material accounting policy information applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

## 2.1 Basis of preparation

## (a) Statement of compliance

The consolidated financial statements of the Company have been prepared in accordance with International Financial Reporting Standards ("IFRSs"). The consolidated financial statements have been prepared under the historical cost convention, except as modified by the material accounting policy information stated below.

The preparation of the consolidated financial statements in conformity with IFRSs requires the use of certain critical accounting estimates. It also requires management to exercise its judgment in the process of applying the Group's material accounting policy information.

Except as described below, the material accounting policy information adopted are consistent with all the year's presented rules unless otherwise stated.

As at 31 December 2023, the Group had a total deficit of RMB9,020,675,000 and the Group's current liabilities exceeded its current assets by RMB8,108,929,000. The Group maintained cash and cash equivalents of RMB2,143,000 as at 31 December 2023.

On 9 October 2018, the Company entered into a conditional sale and purchase agreement with Unique Orient Limited (the "Purchaser"), an independent third party, to dispose of the core assets and liabilities of shipbuilding, offshore engineering, engineering machinery and marine engine building segment (the "Shipbuilding Business") together with the holding company of the Shipbuilding Business (the "Disposal Group") at a consideration of HKD1 (the "Transaction"). There were certain conditions precedent pursuant to the Transaction, which included, but not limited to, the successful issuance of certain convertible preference Shares ("CPS") to certain bank creditors of the subsidiaries of the Disposal Group, and the release or discharge of the relevant guarantees provided by the Company in respect of the debts of the Shipbuilding and Engineering Businesses (the "Relevant Guarantees"). The conditional sale and purchase agreement and the issuance of CPS were approved by the shareholders of the Company and CPS were issued in December 2018.

On 3 March 2019, supplemental agreements were signed with the Purchaser, such that (1) the transfer of the sale shares of Able Diligent Limited, the holding company of the Disposal Group, to the Purchaser should take place on or before 31 August 2019; (2) the Purchaser agreed to procure the release or discharge of the Relevant Guarantees; and (3) the Purchaser agreed to execute a share charge over the sale shares in favour of the Company. As at 31 December 2023, Relevant Guarantees provided by the Company to the banks and lenders of the Disposal Group, inclusive of principals and interest, amounted to RMB5,036,883,000. The Group has considered and recognised the corresponding impact of such financial guarantee contracts as at 31 December 2023.

As at 31 December 2023, borrowings of the Group amounted to RMB3,934,716,000, out of which RMB1,569,065,000 were overdue, while borrowings of the Group amounting to RMB8,618,000 contained cross-default terms as at 31 December 2023 and became immediately repayable. Total overdue interest payables of the Group amounted to RMB907,037,000. These borrowings are further explained below:

 The Group had promissory notes with an aggregate principal amount of RMB2,447,565,000 outstanding as at 31 December 2023, out of which approximately RMB263,226,000, RMB11,817,000 and RMB904,068,000 (totalling RMB1,179,111,000) had been overdue since 2020, 2021 and 2022 respectively. The outstanding promissory notes amounting to RMB8,618,000 became immediately repayable pursuant to the cross-default terms under the relevant loan agreements;

The above conditions indicate the existence of multiple uncertainties, which may cast significant doubt upon the Group's ability to continue as a going concern.

In view of such circumstances, the directors of the Company have, during the current year and up to the date of the approval of these consolidated financial statements, taken the following measures to mitigate the liquidity pressure and to improve the financial position of the Group, to refinance its operation and to restructure its debts:

i) The Group has been actively negotiating with the relevant banks and lenders of the Disposal Group to release or discharge the Relevant Guarantees. Since the date of the disposal till 31 December 2023, guarantees of RMB2,210,636,000 had been discharged while guarantees of RMB5,036,883,000 are expected to be released in year 2024 and RMB984,955,000 that did not meet the recognition criteria for financial guarantee contracts are disclosed as contingent liabilities.

They are of the opinion that, taking into account the above-mentioned plans and measures, the Group will have sufficient working capital to finance its operations and to meet its financial obligations as and when they fall due within the next twelve months from the date of the Group's statement of financial position. Accordingly, the directors are satisfied that it is appropriate to prepare the consolidated financial statements on a going concern basis. Notwithstanding the above, multiple uncertainties exist as to whether management of the Company will be able to achieve its plans and measures as described above. Whether the Group will be able to continue as a going concern would depend upon the Group's ability to generate adequate financing and operating cash flows through the successful fulfillment of the following plans:

- obtaining the agreement from the banks and lenders to release or discharge the Relevant Guarantees for the borrowings owed by the Disposal Group;
- ii) convincing the banks and lenders not to demand for repayment of the outstanding loans of the Disposal Group before the completion of the release of the Relevant Guarantees;
- iii) negotiating with all existing promissory note holders of outstanding principals of RMB2,447,565,000 together with accrued interests thereon for further arrangements including extension of the maturity dates;
- iv) negotiating with the relevant lender for the renewal or extension for repayments for the other borrowing of RMB47,555,000 that was overdue as at 31 December 2023;

Should the Group fail to achieve the abovementioned plans and measures, it might not be able to continue to operate as a going concern, and adjustments would have to be made to write down the carrying value of the Group's assets to their recoverable amounts, to provide for any further liabilities which might arise, and to reclassify non-current assets and non-current liabilities as current assets and current liabilities. The effect of these adjustments has not been reflected in the consolidated financial statements.

Amendments to IAS 1 and IFRS Practice Statement 2 Disclosure of Accounting Policies

IAS 1 is amended to replace all instances of the term "significant accounting policies" with "material accounting policy information". Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements.

The amendments also clarify that accounting policy information may be material because of the nature of the related transactions, other events or conditions, even if the amounts are immaterial. However, not all accounting policy information relating to material transactions, other events or conditions is itself material. If an entity chooses to disclose immaterial accounting policy information, such information must not obscure material accounting policy information.

IFRS Practice Statement 2 Making Materiality Judgements (the "**Practice Statement**") is also amended to illustrate how an entity applies the "four-step materiality process" to accounting policy disclosures and to judge whether information about an accounting policy is material to its financial statements. Guidance and examples are added to the Practice Statement.

The Group has revisited the accounting policy information it has been disclosing and considered it is consistent with the amendments and removing or reducing the immaterial accounting policies such that immaterial policy information does not obscure the material information.

The amendments narrow the scope of the initial recognition exemption of deferred tax liabilities and deferred tax assets in paragraphs 15 and 24 of IAS 12 "Income Taxes" ("**IAS 12**") such that it does not apply to transactions that give rise to equal and offsetting temporary differences on initial recognition.

Prior to the adoption of Amendments to IAS 12, for leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group previously applied IAS 12 requirements to the leasing transaction as a whole. Temporary differences relating to right-of-use assets and lease liabilities are assessed on a net basis.

Upon the application of the amendments, the Group recognises a deferred tax asset (to the extent that it is probable that taxable profit will be available against which the deductible temporary difference can be utilised) and a deferred tax liability for all deductible and taxable temporary differences associated with the right-of-use assets and the lease liabilities.

Based on the management's assessment, the application of the amendments has had no material impact on the Group's financial position and performance because the deferred tax assets and the deferred tax liabilities as a result of the adoption of Amendments to IAS 12 qualify for offset under paragraph 74 of IAS 12. As disclosed in note 20(c), the Hong Kong Employment and Retirement Schemes Legislation (Offsetting Arrangement) (Amendment) Ordinance 2022 [the "Amendment Ordinance"] was gazetted in June 2022 and will take effect on 1 May 2025 (the "Transition Date"). The Amendment Ordinance has two effects: (i) the accrued benefits derived from an employer's mandatory MPF contributions can no longer be used to offset long service payment ("LSP") in respect of the employment period after the Transition Date (post-transition LSP); and (ii) the last month's salary immediately preceding the Transition Date (instead of the date of termination of employment) is used to calculate the portion of LSP in respect of the employment period before the Transition Date (pre-transition LSP).

In July 2023, the HKICPA published "Accounting implications of the abolition of the MPF-LSP offsetting mechanism in Hong Kong" that provides accounting guidance for the accounting for the impact arising from the Abolition.

The HKICPA guidance illustrates that an entity may account for the accrued benefits arising from its MPF contributions that have been vested with an employee and which would be used to offset the employee's LSP benefits (offsetable accrued benefits) as a deemed contribution by the employee towards the LSP in accordance with paragraph 93(a) of HKAS 19 "Employee Benefits" ("HKAS 19"), which is consistent with IAS 19 "Employee Benefits". However, upon the enactment of the Amendment Ordinance, the accrued benefits derived from mandatory employer MPF contributions cannot be used to offset an employee's post-transition LSP obligation so that an entity can no longer apply the practical expedient of recognising the deemed contribution as a reduction of service cost under paragraph 93(b) of HKAS 19. Accordingly, it resulted a catch-up adjustment for past service cost, in accordance with paragraph 94(a) of HKAS 19, and a corresponding increase in the LSP obligation since the MPF-LSP offsetting mechanism was not contemplated in the original LSP legislation.

# 2.2 Principles of consolidation and equity accounting

### (a) Subsidiaries

Subsidiaries are all entities (including structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

The acquisition method of accounting is used to account for business combinations by the Group (refer to Note 2.3).

Intercompany transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the consolidated statement of profit or loss, consolidated statement of comprehensive income, consolidated statement of changes in equity and consolidated statement of financial position respectively.

The Group treats transactions with non-controlling interests that do not result in a loss of control as transactions with equity owners of the Group. A change in ownership interest results in an adjustment between the carrying amounts of the controlling and non-controlling interests to reflect their relative interests in the subsidiary. Any difference between the amount of the adjustment to non-controlling interests and any consideration paid or received is recognised in a separate reserve within equity attributable to owners of the Company.

When the Group ceases to consolidate or equity account for an investment because of a loss of control, joint control or significant influence, any retained interest in the entity is remeasured to its fair value with the change in carrying amount recognised in profit or loss. This fair value becomes the initial carrying amount for the purposes of subsequently accounting for the retained interest as an associate, a joint venture or financial asset. In addition, any amounts previously recognised in other comprehensive income in respect of that entity are accounted for as if the Group had directly disposed of the related assets or liabilities. This may mean that amounts previously recognised in other comprehensive income are reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable IFRSs.

The acquisition method of accounting is used to account for all business combinations, regardless of whether equity instruments or other assets are acquired. The consideration transferred for the acquisition of a subsidiary comprises the:

- (i) fair values of the assets transferred
- (ii) liabilities incurred to the former owners of the acquired business
- (iii) equity interests issued by the Group
- (iv) fair value of any asset or liability resulting from a contingent consideration arrangement, and
- (v) fair value of any pre-existing equity interest in the subsidiary

Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are, with limited exceptions, measured initially at their fair values at the acquisition date. The Group recognises any non-controlling interest in the acquired entity on an acquisition-by-acquisition basis either at fair value or at the non-controlling interest's proportionate share of the acquired entity's net identifiable assets.

Acquisition-related costs are expensed as incurred.

The excess of the consideration transferred, amount of any non-controlling interest in the acquired entity, and acquisition-date fair value of any previous equity interest in the acquired entity over the fair value of the net identifiable assets acquired is recorded as goodwill. If those amounts are less than the fair value of the net identifiable assets of the business acquired, the difference is recognised directly in profit or loss as a bargain purchase.

Contingent consideration is classified either as an equity or a financial liability. Amounts classified as a financial liability are subsequently remeasured to fair value with changes in fair value recognised in profit or loss.

If the business combination is achieved in stages, the acquisition date carrying value of the acquirer's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date. Any gains or losses arising from such remeasurement are recognised in profit or loss.

### 2.4 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Executive Directors of the Company who make strategic decisions.

### 2.5 Foreign currency translation

#### (a) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in RMB, which is the Company's functional and the Group's presentation currency.

### (b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions or valuation where items are re-measured. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss. They are deferred in equity if they relate to qualifying cash flow hedges and qualifying net investment hedges or are attributable to part of the net investment in a foreign operation.

### 2.6 Oil properties

The successful efforts method of accounting is used for oil exploration and production activities. Costs are accumulated on a field-by-field basis. All costs for development wells, support equipment and facilities, and proved mineral interests in oil properties are capitalised within construction in progress under property, plant and equipment. Geological and geophysical costs are expensed when incurred. Costs directly associated with an exploration well, and exploration and property leasehold acquisition costs, are capitalised within construction in progress until the determination of reserves is evaluated. If it is determined that commercial discovery has not been achieved, these costs are charged to profit or loss.

Once commercial reserves are found, construction in progress relevant to oil properties are tested for impairment, or whenever facts and circumstances indicate impairment. No depreciation and depletion is charged during the exploration and evaluation phase. When development is completed on a specific field, it is transferred to oil properties.

An impairment loss is recognised for the amount by which the exploration and evaluation assets' carrying amount exceeds their recoverable amount. The recoverable amount is the higher of the exploration and evaluation assets' fair value less costs of disposal and their value in use.

Oil properties are depreciated using the units-ofproduction method. Unit-of-production rates are based on proved developed reserves, which are oil reserves estimated to be recovered from existing facilities using current operating methods. Oil volumes are considered to be part of production once they have been measured through meters at custody transfer or sales transaction points at the outlet valve on the field storage tank.

Proven oil properties are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged in profit or loss during the financial period in which they are incurred.

#### **Co-operation Rights**

The Co-operation Rights represent rights to cooperate with the national oil company of Kyrgyzstan in the operation of the five oil fields zones ("Co-operation **Rights**"). The Co-operation Rights are stated at cost less accumulated amortisation and any impairment losses. The Co-operation Rights are amortised using the unit-ofproduction method. Unit-of-production rates are based on proved reserves, which are oil reserves estimated to be recovered from existing facilities using current operating methods. Oil volumes are considered to be part of production once they have been measured through meters at custody transfer or sales transaction points at the outlet valve on the field storage tank.

Other intangible assets that are acquired by the Group are stated at cost less accumulated amortisation (where the estimated useful life is finite) and impairment losses (see note 2.11).

Amortisation of intangible assets with finite useful lives is charged to profit or loss on a straight-line basis over the assets' estimated useful lives. The software with finite useful lives are amortised from the date they are available for use and their estimated useful lives is one year. Both the period and method of amortisation are reviewed annually.

Intangible assets are not amortised while their useful lives are assessed to be indefinite. Any conclusion that the useful life of an intangible asset is indefinite is reviewed annually to determine whether events and circumstances continue to support the indefinite useful life assessment for that asset. If they do not, the change in the useful life assessment from indefinite to finite is accounted for prospectively from the date of change and in accordance with the policy for amortisation of intangible assets with finite lives as set out above.

### 2.9 Goodwill

Goodwill is measured as described in note 8. Goodwill is not amortised but it is tested for impairment annually, or more frequently if events or changes in circumstances indicate that it might be impaired, and is carried at cost less accumulated impairment losses. Gains and losses on the disposal of an entity include the carrying amount of goodwill relating to the entity sold.

Goodwill is allocated to cash-generating units for the purpose of impairment testing. The allocation is made to those cash-generating units or groups of cash-generating units that are expected to benefit from the business combination in which the goodwill arose. The units or groups of units are identified at the lowest level at which goodwill is monitored for internal management purposes.

### 2.10 Investments and other financial assets

#### (i) Classification

The Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through other comprehensive income ("OCI") or through profit or loss), and
- those to be measured at amortised cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

For assets measured at fair value, gains and losses will either be recorded in profit or loss or OCI. For investments in equity instruments that are not held for trading, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income ("**FVOCI**").

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

#### (iii) Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss ("**FVPL**"), transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVPL are expensed in profit or loss.

Financial assets with embedded derivatives are considered in their entirety when determining whether their cash flows are solely payment of principal and interest.

#### Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. There is one measurement category into which the group classifies its debt instruments:

 Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Interest income from these financial assets is included in finance income using the effective interest rate method. Any gain or loss arising on derecognition is recognised directly in profit or loss and presented in "other gains — net" together with foreign exchange gains and losses.

#### Equity instruments

The Group subsequently measures all equity investments at fair value. Where the Group's management has elected to present fair value gains and losses on equity investments in OCI, there is no subsequent reclassification of fair value gains and losses to profit or loss following the derecognition of the investment. Dividends from such investments is recognised in profit or loss as other income when the Group's right to receive payments is established.

Change in the fair value of financial assets at FVPL are recognised in "other gains — net" in the statement of profit or loss as applicable. Impairment losses (and reversal of impairment losses) on equity investments measured at FVOCI are not reported separately from other changes in fair value.

### (iv) Impairment

The Group assesses on a forward-looking basis the expected credit losses associated with its debt instruments carried at amortised cost. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables, the Group applies the simplified approach permitted by IFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables, see Note 3.1(b) for further details.

Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date.

### 2.12 Inventories

Crude oil inventories are stated at the lower of cost and net realisable value. Costs of inventories represent relevant production costs and are determined on a weighted average basis. Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

### 2.13 Trade and other receivables

Trade receivables are amounts due from customers for goods sold or services performed in the ordinary course of business. If collection of trade and other receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If not, they are presented as non-current assets.

Trade receivables are recognised initially at the amount of consideration that is unconditional unless they contain significant financing components, when they are recognised at fair value. The Group holds the trade receivables with the objective to collect the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method. See Note 3.1(b) for a description of the Group's impairment policies.

#### (i) Ordinary shares

Ordinary shares and non-redeemable preference shares are classified as equity.

Incremental costs directly attributable to the issue of new shares are shown in equity as a deduction, net of tax, from the proceeds.

#### (ii) Convertible preference shares

Non-redeemable convertible preference shares issued by the Company that contain the conversion option components are classified as equity on initial recognition in accordance with the substance of the contractual arrangements and the definitions of an equity instrument. The conversion option allows the holder of the non-redeemable convertible preference shares to convert the convertible preference shares into a fixed number of the Company's own ordinary shares and therefore the whole instrument is classified as an equity instrument.

The convertible preference shares are initially recognised at their par value in share capital. The difference between the par value of the issued convertible preference shares and its fair value is recognised in share premium.

### 2.16 Trade and other payables

Trade payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Trade and other payables are classified as current liabilities if payment is due within one year or less (or in the normal operating cycle of the business if longer). If not, they are presented as noncurrent liabilities.

Trade and other payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facility will be drawn down. In this case, the fee is deferred until the draw-down occurs. To the extent there is no evidence that it is probable that some or all of the facilities will be drawn down, the fee is capitalised as a prepayment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the end of the reporting period.

### 2.18 Provisions

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation, and the amount has been reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

### 2.19 Current and deferred income tax

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

#### (a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of each reporting period in the countries where the Company and its subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

#### (b) Deferred income tax

#### Inside basis differences

Deferred income tax is recognised, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill, the deferred income tax is not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss and do not give rise to equal taxable and deductible temporary differences. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the end of each reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred income tax assets are recognised only to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

Deferred income tax is provided on temporary differences arising on investments in subsidiaries, except for deferred income tax liability where the timing of the reversal of the temporary difference is controlled by the Group and it is probable that the temporary difference will not reverse in the foreseeable future.

### (c) Offsetting

Deferred income tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets against current tax liabilities and when the deferred income taxes assets and liabilities relate to income taxes levied by the same taxation authority on either the taxable entity or different taxable entities where there is an intention to settle the balances on a net basis.

### 2.20 Employee benefits

#### (a) Short-term obligations

Liabilities for wages and salaries, including nonmonetary benefits, annual leave and accumulating sick leave that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related service are recognised in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the consolidated statement of financial position.

The group companies in the PRC and Kyrgyzstan participate in defined contribution retirement plans and other employee social security plans, including pension, medical, other welfare benefits, organised and administered by the relevant governmental authorities for employees in the PRC and Kyrgyzstan. The Group contributes to these plans based on certain percentages of the total salary of employees, subject to a certain ceiling, as stipulated by the relevant regulations.

The Group has no further payment obligations once the contributions have been paid. The contributions are recognised as employee benefit expense when they are due. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

#### (c) Bonus plan

The Group recognises a provision for bonus when contractually obliged or when there is a past practice that has created a constructive obligation.

### 2.21 Revenue recognition

Revenue comprises the fair value of the consideration received or receivable for the sale of goods in the ordinary course of the Group's activities. Revenue from sale of goods of the Group was primarily generated from production and sales of oil, oil storage and trading.

Revenue are recognised when or as the control of the goods is transferred to the customer, and there is no unfulfilled obligation that could affect the customer's acceptance of the product. Delivery occurs when the product have been transported to the specified location, the risks of obsolescence and loss have been transferred to the customer, and either the customer has accepted the products in accordance with the sales contract, the acceptance provisions have lapsed, or the Group has objective evidence that all criteria for acceptance have been satisfied.

Revenue from the production and sales of oil are recognised at a point in time when the customer picks up the oil products from the Group, as such the control of the goods is transferred to the customer. The Group does not provide shipment of oil products to customers at any specified location. The performance obligation is completely fulfilled upon the pick-up and the Group then has the right to invoice and recognises the revenue for the oil sold.

Revenue from oil storage is recognised in equal instalments over the periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the use of the leased asset. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are earned.

Revenue from trading is generated from the trading of bulk commodities domestically and is recognised at a point in time, on the passing of control of goods to the customer in accordance with shipping terms.

### 2.22 Government grants

Government grants are recognised in the consolidated statement of financial position initially when there is reasonable assurance that they will be received and that the Group will comply with the conditions attaching to them. Grants that compensate the Group for expenses incurred are recognised as income in profit or loss on a systematic basis in the same periods in which the expenses are incurred. Grants that compensate the Group for the cost of an asset are deducted from the carrying amount of the asset and consequently are effectively recognised in profit or loss over the useful life of the asset by way of reduced depreciation expense.

### 2.23 Interest income

Interest income on financial assets at amortised cost calculated using the effective interest method is recognised in the consolidated statement of profit or loss as part of other income.

Interest income is presented as finance income where it is earned from financial assets that are held for cash management purposes. Any other interest income is included in other income.

Interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset except for financial assets that subsequently become credit-impaired. For credit-impaired financial assets, the effective interest rate is applied to the net carrying amount of the financial asset (after deduction of the loss allowance).

### 2.24 Borrowing costs

General and specific borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation. All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

### 2.25 Leases

Leases are recognised as a right-of-use asset and a corresponding liability at the date at which the leased asset is available for use by the Group.

Contracts may contain both lease and non-lease components. The Group allocates the consideration in the contract to the lease and non-lease components based on their relative stand-alone prices. However, for leases of real estate for which the Group is a lessee, it has elected not to separate lease and non-lease components and instead accounts for these as a single lease component.

- amounts expected to be payable by the Group under residual value guarantees;
- the exercise price of a purchase option if the Group is reasonably certain to exercise that option; and

Lease payments to be made under reasonably certain extension options are also included in the measurement of the liability.

The lease payments are discounted using the interest rate implicit in the lease. If that rate cannot be readily determined, which is generally the case for leases in the Group, the lessee's incremental borrowing rate is used, being the rate that the individual lessee would have to pay to borrow the funds necessary to obtain an asset of similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions.

- the amount initially recognised less, where appropriate, the cumulative amount of income recognised in accordance with the principles of IFRS 15 Revenue from Contracts with Customers.

The fair value of financial guarantees is determined based on the present value of the difference in cash flows between the contractual payments required under the debt instrument and the payments that would be required without the guarantee, or the estimated amount that would be payable to a third party for assuming the obligations.

Where guarantees in relation to loans or other payables of associates are provided for no compensation, the fair values are accounted for as contributions and recognised as part of the cost of the investment.

### (ii) Diluted earnings per share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account:

- the after-income tax effect of interest and other financing costs associated with dilutive potential ordinary shares; and
- the weighted average number of additional ordinary shares that would have been outstanding assuming the conversion of all dilutive potential ordinary shares.

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange rate risk and interest rate risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(i) Foreign exchange risk

The Group is exposed to foreign exchange risk arising primarily from the transactions in its Energy Business with asset denominated in US dollar ("**USD**") and borrowings denominated in USD and Hong Kong dollar ("**HKD**"). Foreign exchange risk arises from future commercial transactions and recognised assets and liabilities which are denominated in a currency that is not the entity's functional currency.

Certain trade receivables, other receivables, deposits, cash and cash equivalents, trade and other payables and borrowings are denominated in USD and HKD which are also exposed to foreign exchange risk. Details of the Group's trade and other receivables, deposits, cash and cash equivalents, trade and other payables and borrowings denominated in foreign currencies are disclosed in Notes 11, 12, 16 and 17 respectively.

The Group's certain financial guarantees are denominated in RMB. For the entity operating in Kyrgyzstan, most of the transactions are denominated in their functional currency which is USD.

At 31 December 2023, if RMB had weakened/ strengthened by 5% against the USD and HKD respectively with all other variables held constant, post-tax loss for the year would have been approximately RMB257,493,000 higher/lower (2022: RMB241,222,000), mainly as a result of foreign exchange differences on translation of USD and HKD denominated monetary assets and liabilities. 3 財務風險管理(續)

The Group has no significant interest-bearing assets except for cash and cash equivalents with short maturities. Certain of the Group's short-term borrowings at fixed rates expose the Group to fair value interest-rate risk. Since all fixed-rate borrowings are current and at market interest rate, the directors are of the opinion that the fair value interest-rate risk is minimal. The Group analyses its interest rate exposure on a dynamic basis and will consider the interest rate exposure when enter into any financing, renewal of existing positions and alternative financing transactions.

At 31 December 2023, if interest rate had increased/decreased by 100 basis points with all other variables held constant, post-tax loss for the year would have been approximately RMB3,424,000 higher/lower (2022: RMB3,327,000).

The Group expects that there is no significant credit risk associated with cash at banks since they are deposited with credit worthy financial institutions. Management does not expect that there will be any significant losses from non-performance by these counterparties.

As at 31 December 2023, the Group had a deficit of RMB9,020,675,000 (2022: RMB8,510,311,000) and the Group's current liabilities exceeded its current assets by RMB8,108,929,000 (2022: RMB7,532,680,000). The Group maintained cash and cash equivalents of RMB2,143,000 (2022: RMB14,583,000) as at 31 December 2023.

As at 31 December 2023, borrowings of the Group, amounted to RMB3,934,716,000, out of which RMB1,569,065,000 were overdue, while borrowings of the Group amounting to RMB8,618,000 contained cross-default terms as at 31 December 2023 and become immediately repayable. Total overdue interest payables of the Group amounted to RMB907,037,000. These borrowings are further explained below:

i) The Group had promissory notes with an aggregate principal amount of RMB2,447,565,000 outstanding as at 31 December 2023, out of which approximately RMB263,226,000, RMB11,817,000 and RMB904,068,000 (totalling RMB1,179,111,000) had been overdue since 2020, 2021 and 2022 respectively. The outstanding promissory notes amounting to RMB8,618,000 became immediately repayable pursuant to the cross-default terms under the relevant loan agreements.

The above conditions indicate the existence of multiple uncertainties, which may cast significant doubt upon the Group's ability to continue as a going concern. In view of such circumstances, the directors of the Company have, during the current year and up to the date of the approval of these consolidated financial statements, taken the following measures to mitigate the liquidity pressure and to improve the financial position of the Group, to refinance its operation and to restructure its debts:

i) The Group has been actively negotiating with the relevant banks and lenders of the Disposal Group to release or discharge the Relevant Guarantees. Since the date of disposal until 31 December 2023, guarantees of RMB2,210,636,000 had been discharged while guarantees of RMB5,036,883,000 are expected to be released in year 2024 and RMB984,955,000 that did not meet the recognition criteria for financial guarantee contracts are disclosed as contingent liabilities (Note 34).

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debt.

The capital structure of the Group consists of shareholders' equity. Capital is managed so as to maximise the return to shareholders while maintaining a capital base to allow the Group to operate effectively in the marketplace and sustain future development of the business. This ratio is calculated as total liabilities divided by total assets.

The Group's total liabilities and total assets positions and debt-asset ratio at 31 December 2023 and 2022 were as follows:

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are addressed below.

# 4.1 Critical accounting estimates (a) Going concern

The Group prepares cash flow projections that cover a period of not less than twelve months from 31 December 2023. Taking into account the plans and measures as described in Note 2.1(b), the Group will have sufficient working capital to finance its operations and to meet its financial obligations as and when they fall due within the next twelve months from the date of the statement of financial position. The consolidated financial statements is prepared on a going concern basis.

Significant uncertainties exist as to whether management of the Company will be able to achieve its plans and measures as described in Note 2.1(b). Whether the Group will be able to continue as a going concern would depend upon the Group's ability to generate adequate financing and operating cash flows through the successful fulfilment of the plans as described in Note 2.1(b). 围烛会让什社四讯工

The Group follows the guidance of IAS 36 "Impairment of Assets" to determine when assets are impaired, which requires significant judgment. In making this judgment, the Group evaluates, among other factors, the duration and extent to which the recoverable amount of assets is less than their carrying balance, including factors such as the industry performance and changes in operational and financing cash flows. For the purpose of assessing impairment, assets are grouped at the lowest level for which there are separately identifiable cash flows (a CGU). The recoverable amount of the CGU has been determined based on value-in-use calculations or fair value less cost to sell, whichever is higher. These calculations require the use of estimates, including operating results, income and expenses of the business, future economic conditions on growth rates and future returns. Significant changes in the key assumptions on which the recoverable amount of the assets is based could significantly affect the Group's financial position and results of operations. Based on management's assessment, no impairment was recognised during the year ended 31 December 2023 (2022: Nil). Details of which have been disclosed in Note 8.

Management will increase the depreciation expense where useful lives are less than previously estimated lives. It will write-off or write-down technically obsolete or nonstrategic assets that have been abandoned or sold. Actual economic lives may differ from estimated useful lives. The Group is subject to income taxes in numerous jurisdictions. Significant judgement is required in determining the provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the current and deferred income tax assets and liabilities in the period in which such determination is made.

Deferred income tax assets relating to certain temporary differences and tax losses are recognised when management considers it is likely that future taxable profits will be available against which the temporary differences or tax losses can be utilised. When the expectations are different from the original estimates, such differences will impact the recognition of deferred income tax assets and income tax charges in the period in which such estimates have been changed.

### (e) Estimation of oil reserves

Estimation of oil reserves is a key element in the Group's investment decision-making process in energy exploration and production segment. It is also an important element in testing for impairment. Changes in proved oil reserves, particularly proved developed reserves, will affect unit-ofproduction depreciation, depletion and amortisation recorded in the Group's consolidated financial statements for property, plant and equipment and intangible assets related to oil production activities. A reduction in proved developed reserves will increase depreciation, depletion and amortisation charges. Proved reserve estimates are subject to revision, either upward or downward, based on new information, such as from drilling and production activities or from changes in economic factors, including product prices, contract terms or development plans.

The Group makes estimate on costs required to fulfil the relevant obligation of guarantee contracts when the guaranteed amount is claimed by the counterparty to the guarantee. Such estimation is based on the available information as at reporting date and is determined by the Group's practical experience, the default history, the collateral held and financial position of guaranteed assessed on an individual basis in the industry and taking into consideration of industry information and market data.

### 4.2 Critical accounting judgment

The Group applies (i) IFRS 3 to transactions and other events that meet the definition of a business combination within the scope of IFRS 3 and (ii) the principle of control defined in IFRS 10 in the preparation of consolidated financial statements. Judgement is required to (i) determine the fair values of the assets acquired, the liabilities assumed, the date of acquisition, and the purchase consideration, and on the allocation of the purchase consideration to the identifiable assets and liabilities; and (ii) assess whether the Group has obtained control over the subsidiaries.

## 5 Segment Information

Management has determined the operating segments based on the reports reviewed by the chief operating decision-maker that are used to make strategic decisions. These reports are prepared on the same basis as the consolidated financial statements.

The chief operating decision-maker is identified as the Executive Directors of the Company. The Executive Directors consider the business, performance from both a geographic and product perspective and has identified two reportable segments of its business:

- 1) Energy exploration and production: this segment derive its revenue from sales of crude oil in Kyrgyzstan;
- Oil storage and trading: this segment derive its revenue from a) renting its capacity in the provision of oil storage services; and b) trading the relevant commodities in China.

The Group has acquired shoreline rights and leasehold land through business combination in prior year. They are recognised at their fair value at the date of acquisition and are subsequently amortised on a straight-line based over their estimated useful lives.

### Shoreline rights

The shoreline rights represent rights to occupy and use of 418 meters of the Yangtze River coastline and corresponding waters. Lump sum payments were made upfront to acquire the shoreline rights from the previous registered owner, and there are no ongoing payments to be made under the terms of the lease agreements. The shoreline rights are stated at cost less accumulated depreciation and any impairment losses. The shoreline rights are depreciated using the straight-line method over their estimated useful lives of 33 years.

The leasehold land relates to the land located in Mainland China which was acquired through a long-term agreement on land use rights. The Group is the registered owner of these property interests, including the whole or part of undivided share in the underlying land. Lump sum payments were made upfront to acquire these property interests from their previous registered owners, and there are no ongoing payments to be made under the terms of the land lease. The leasehold land is stated at cost less accumulated depreciation and any impairment losses. The leasehold land is depreciated using the straight-line method over their estimated useful lives of 33 years.

The shoreline rights and leasehold land with an aggregate carrying amount of RMB200,941,000 (2022: RMB207,205,000) have been pledged to a financial institution for the borrowings owed by the Disposal Group.

The intangible assets include rights to cooperate with the national oil company of Kyrgyzstan in the operation of the five oil fields zones ("**Co-operation Rights**"). The Co-operation Rights are stated at cost less accumulated amortisation and any impairment losses. As at 31 December 2023, 76 wells (2022: 73 wells) were at production. As a result, amortisation of RMB1,120,000 (2022: RMB1,105,000) has been charged to profit or loss during the year based on the units-of production method.

During the year ended 31 December 2018, the Group entered into a loan agreement with a related party who agreed to provide a loan facility up to RMB40,000,000 to the Group for the funding in respect of the energy exploration and production segment. As at 31 December 2023, the Group has drawn down RMB5,725,000 for exploration and drilling wells.

Management has reviewed the operational performance and considered the operation's sensitivity to a range of factors including commodity prices, capital expenditure and concluded that there is currently no further impairment or reversal of the previously recognised impairment.

### **Impairment Assessment**

At the end of each reporting period, the management of the Group performs impairment assessments on its assets. Each segment represents an individual cash generating unit ("**CGU**") in accordance with IAS 36 "Impairment of Assets".

The recoverable amounts of the CGUs have been determined based on value-in-use calculations or fair value less cost to sell, whichever is higher. The management of the Group's estimation of the recoverable amount of the each CGU is determined based on a value-in-use calculation, by using a discounted cash flow ("**DCF**") model, which requires various parameters and inputs, among which the projection of amount and timing of future capital expenditures to enable the exploration and development of new oil production wells is a critical input. This projection, nonetheless, hinges on the overall financial position of the Group. 8 無形資產及商譽 (續)

### Energy exploration and production segment

When measuring the recoverable amount of the energy exploration and production segment, management mainly takes oil properties, construction-in-progress and Cooperation Rights into account.

The combination of geopolitical turmoil and concerns about oil output levels in major producing countries contributed to the decline in crude oil futures by over 10% in 2023. These factors underscore the complexity and volatility inherent in the global oil market. Due to the present economic uncertainty, it is expected that expenditures in Energy Business would only start to be resumed by the Group by 2026, the earliest.

With internal judgement of the international market environment, combined with the delay of the discharge of the Financial Guarantee, the management of the Group decided to keep the conservative parameters and inputs in the projection of the amount and timing of the capital expenditures to be invested in the energy exploration and production operation.

The management of the Group assumed that no further capital expenditure shall be invested in the energy exploration and production operation until 2026. Accordingly, the energy exploration and production operation will be relying on its own production and cash flow to sustain its operation over the next two to three years.

The calculation of value-in-use uses pre-tax (2022: pretax) cash flow forecast covering a period from year 2024 to year 2061 based on production plan for wells within the operating period granted under the Co-operation Rights. The impairment assessment is not prepared under the perpetual aspect, and the management of the Group determined 2061 as the operation terminal year.

地緣政治動盪及對主要產油國石油產 量水平的擔憂導致二零二三年原油期 貨下跌超過10%。該等因素突顯了全 球石油市場固有的複雜性及波動性。 由於現時的經濟不確定性,預計本集 團在能源業務方面的開支最早將於二 零二六年前開始恢復。

結合國際市場環境的內部判斷,加之 財務擔保延遲解除,本集團管理層決 定於預測將投入至能源勘探及生產業 務的資本開支的金額及時間時繼續採 用保守的參數及輸入值。

本集團管理層假設在二零二六年之前 不會向能源勘探及生產業務投放任何 其他資本開支。因此,能源勘探及生 產業務在未來兩年至三年內將依賴其 自身的生產及現金流量維持運營。

In addition, the principal parameters used in determining the recoverable amount of the Group's assets include estimates of proved and unproved reserves, future commodity prices, as well as best estimate of development costs. The management of the Group has applied consistent estimation of proved and unproved reserves as of 2023 and 2022, which is reviewed and updated by professional valuers of Valtech Valuation Advisory Limited involving professional members of Society of Petroleum Engineers with over 30 years of experience in the petroleum industry in relation to the technical assessment of reservoir and evaluation oil and gas projects, in accordance with a competent person's report prepared in September 2018. The expected exploration volume by the end of 2061 is 23.45 million tonnes, which represented 99.9% of proved reserves as at 31 December 2023.

The Group referred to the weighted average cost of capital of the oil and gas industry when determining the discount rate and made relevant adjustments according to specific risks in Kyrgyzstan. ### Oil storage and trading segment

Goodwill is allocated to the Group's oil storage and trading segment CGU. When measuring the recoverable amount of the oil storage and trading segment, management mainly takes machinery and equipment, building and structure, construction-in-progress, shoreline rights, leasehold land and goodwill into account.

The recoverable amount of CGU is determined based on DCF. The underlying inputs were in accordance with the financial budgets covering a five-year period approved by the board of directors of the Company. The free cashflow was predominantly based on revenue driven by the utilization of the storage facility, less the relevant operating costs. The Group has estimated the utilization of the storage facility range between 80-90%. The pre-tax discount rate applied to the cash flow projection was 15.20% (2022: 14.96%). Whilst the assessment was prepared under perpetual aspect, the growth rate used to extrapolate the cash flows beyond the five-year period was 2.2% (2022: 3.0%).

As a result of the above assessment, the recoverable amount of the CGU exceeds its carrying value, and the Group concluded that there was no impairment for the year ended 31 December 2023 (2022: Nil). The management also considered that any reasonable possible change in any of the assumptions would not cause the recoverable amount of the CGU below its carrying amount.

(a) In December 2018, the Company issued a total of the 7,006,000,000 convertible preference shares with nominal value of HKD0.50 each, amounting to HKD3,503,000,000 (equivalent to RMB3,100,000,000) to a bank creditor to settle bank borrowings and interests totaling RMB3,100,000,000. The 7,006,000,000 convertible preference shares consisted of three classes, 2,330,000,000 of class A shares, 2,330,000,000 of class B shares and 2,346,000,000 of class C shares. Ordinary shares converted from convertible preference shares converted from class B and class C convertible preference shares will be subject to a lock-up period of six and twelve months, respectively.

Holders of the convertible preference shares are not entitled to the right to vote at any general meeting of the Company, yet they have the right to attend such meetings. They have the rights to receive any dividends pari passu to the holders of ordinary shares on the basis of the number of shares converted. Except for the mentioned, each convertible preference share shall have the same rights as each of the ordinary shares.

As at 31 December 2022 and 2023, no convertible preference shares had been converted into ordinary shares.

The exercise price per share under the Pre-IPO Share Options shall be equal to a 50% discount to the Offer Price (i.e. HKD4 per share, the exercise price of the outstanding share options granted was adjusted to HKD20 per consolidated share of HK0.50 each with effect from 29 March 2016). Each of the Pre-IPO Share Options has a 10-year exercisable period, from 19 November 2010 ("Old Grant Date"), and ending on the expiration of the tenth anniversary of the date of acceptance of the grant of options, on 26 October 2020. As at 31 December 2020, the number of outstanding share options granted was adjusted for the effect of share consolidation and no share options were vested and exercisable after the share consolidation adjustment. The Pre-IPO Share Option Scheme expired during the year ended 31 December 2020.

Commencing from the date on which trading in the shares of the Company first commenced on the Main Board of the Hong Kong Stock Exchange, being 19 November 2010 ("**Listing Date**"), the expiry of first, second, third, and fourth anniversaries of the Listing Date, the relevant grantee might exercise options up to 20%, 40%, 60%, 80% and 100% respectively.

The fair value of the share options granted on 24 October 2010, determined using the binominal model (the "**Model**"), ranging from HKD4.38 to HKD5.17 per option. The significant inputs into the Model were the share price of HKD8 at the Listing Date, exercise price shown above, expected dividend yield rate of 1.32%, risk-free rate of 2.09%, an expected option life of ten years and expected volatility of 55.0%. The volatility measured was based on the average annualised standard deviations of the continuously compounded rates of return on the share prices of comparable companies with similar business operations.

No share option is exercisable prior to the first anniversary of 30 April 2012 (the "New Grant Date"). On each of the first, second, third, fourth and fifth anniversaries of the New Grant Date, a further 20% of the share options granted to the selected employees might be exercised, provided that no share option should be exercised after 30 April 2022. The Share Option Scheme expired during the year ended 31 December 2022.

The fair value of the share options granted on 30 April 2012, determined using the Model, ranged from HKD0.63 to HKD0.64 per option. The significant inputs into the Model were the share price of HKD1.94 at the New Grant Date, the exercise price shown above, expected dividend yield rate of 4.66%, risk-free rate of 1.14%, an expected option life of 10 years and expected volatility of 54.50%. The volatility measured was based on the average annualised standard deviations of the continuously compounded rates of return on the share prices of comparable companies with similar business operations.

#### Long service payment obligations

Pursuant to the Hong Kong Employment Ordinance, the Group has the obligation to pay long service payment ("LSP") to qualifying employees in Hong Kong upon retirement, subject to a minimum of 5 years' employment period, based on the formula of "last monthly wages (before termination of employment)  $\times$  2/3  $\times$  years of service". Last monthly wage is capped at HK\$22,500 while the amount of long service payment shall not exceed HK\$390,000. This obligation is accounted for as a post - employment defined benefit plan. The Mandatory Provident Fund Schemes Ordinance permits the withdrawal of accrued benefits derived from an employer's MPF contributions for the purpose of offsetting LSP payable to an employee under the Employment Ordinance. The LSP obligation, if any, is presented on a net basis.

The Employment and Retirement Schemes Legislation (Offsetting Arrangement) (Amendment) Ordinance 2022 (the "Amendment Ordinance") was gazetted in June 2022 and will take effect on 1 May 2025 (the "Transition Date"). Under the Amended Ordinance, accrued benefits derived from an employer's mandatory MPF contributions after the Transition Date can only be applied to offset the pre-Transition Date LSP obligation but no longer eligible to offset the post Transition Date LSP obligation. Furthermore, the LSP obligation before the Transition Date will be calculated based on the last monthly wages immediately preceding the Transition Date.

The Group has not accounted for the offsetting mechanism owing to immateriality and its abolition as disclosed in note 2.1(c).
