## **SUMMARY OF POWER GENERATION FOR MARCH 2024**

This voluntary announcement is made by Shandong Hi-Speed New Energy Group Limited (the "Company", together with its subsidiaries, the "Group") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 643,209 megawatt-hour ("MWh") for March 2024, representing an increase of approximately 20.6% compared with the corresponding period of 2023. For the three months ended 31 March 2024 (the "Period"), the aggregate power generation of the Group amounted to approximately 1,532,973 MWh, representing an increase of approximately 14.6% compared with the corresponding period of 2023.

The operating power generation\* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for March 2024 was approximately 652,672 MWh, representing an increase of approximately 6.7% compared with the corresponding period of 2023. For the Period, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 1,553,758 MWh, representing an increase of approximately 2.1% compared with the corresponding period of 2023.

\* The operating power generation included (i) the power generation of the projects held by the Group, the associates and the joint ventures of the Group; and (ii) the power generation of the projects managed by the Group through the provision of entrusted management services.
