Reference is made to the announcement of the Company dated 17 April 2024 ("**Placing Announcement**") in relation to the entering into of the Placing Agreement between the Company and the Placing Agent whereby the Company has conditionally agreed to place, through the Placing Agent, up to an aggregate of 28,800,000 Placing Shares on a best effort basis to not less than six Placees at a price of HK\$0.56 per Placing Share.

Reference is also made to the supplemental announcement of the Company dated 18 April 2024 ("**Supplemental Announcement**") in relation to the entering into of the Supplemental Agreement between the Company and the Placing Agent whereby the Company and the Placing Agent mutually agreed to amend the Placing Price (as defined in the Placing Agreement) from HK\$0.56 per Placing Share to HK\$0.63 per Placing Share.

Terms and expressions used in this supplemental announcement shall bear the same meaning as used in the Placing Announcement, unless the context requires otherwise.

On 30 April 2024, the Company and the Placing Agent have agreed in writing to further amend the Placing Price to HK\$0.67 per Placing Share.

On 30 April 2024, the Company and the Placing Agent entered into a Second Supplemental Agreement to (i) further amend the Placing Price to HK\$0.67 per Placing Share; and (ii) extend the long stop date for fulfilling the conditions precedent to the completion of the Placing under the Placing Agreement from 30 April 2024 to 16 May 2024 as more time is required to satisfy the conditions. All other terms of the Placing Agreement shall remain unchanged, save as amended by the Second Supplemental Agreement.

Accordingly, assuming the maximum 28,800,000 Placing Shares are fully placed, the gross proceeds and net proceeds (after deducting the placing commission and other related expenses) are estimated to be approximately HK\$19,296,000 and HK\$18,517,000 respectively.

Other than the Placing Price (as further amended) and the extension of the long stop date for the fulfillment of the Conditions to Completion of the Placing, there is no amendment or variation to the number of Placing Shares, the Placing Condition or other terms in the Placing Agreement. Placing Price (as further amended)

The Placing Price (as further amended) of HK\$0.67 represents:

The Company intends to apply the net proceeds from the Placing as to approximately HK\$3,000,000 for repayment of shareholders loan(s), approximately HK\$11,000,000 for business expansion and the remainder for general working capital of the Group.

In light of the prevailing financial conditions of the Group, the Board considers that the Placing to be a suitable financial option as compared to other means of financing as it enables the Group to raise capital in an efficient manner without increasing interest burden on the Group, strengthen the financial position of the Company and represents a good opportunity to broaden the Shareholders' base and capital base of the Company.
