In the case of joint holders, the vote of the senior who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint holder(s) and for this purpose, seniority will be determined by the order in which the names stand first in the Register of Members.

To be valid, this second form of proxy together with the power of attorney or other authority under which it is signed or a notarially certified copy thereof, must be deposited at the registered office of the Company at 26th Floor, Harcourt House, 39 Gloucester Road, Wanchai, Hong Kong or the Company's share registrar, Tricor Secretaries Limited at 17th Floor, Far East Finance Centre, 16 Harcourt Road, Hong Kong, not less than 48 hours before the time for holding the Meeting or adjourned meeting(s) or poll (as the case may be).
8. The proxy need not be a member of the Company but must attend the Meeting in person to represent you.
9. Completion and delivery of the second form of proxy will not preclude you from attending and voting at the Annual General Meeting if you so wish, in such event, the instrument appointing a proxy shall be deemed to be revoked.

IMPORTANT: A SHAREHOLDER OF THE COMPANY (THE "SHAREHOLDER") WHO HAS ALREADY LODGED WITH THE COMPANY'S SHARE REGISTRAR THE PROXY FORM WHICH WAS SENT TOGETHER WITH THIS NOTICE OF THE MEETING DATED 17 APRIL 2024 (THE "FIRST PROXY FORM") SHOULD NOTE THAT:

- (i) if no second form of proxy is lodged with the Company's share registrar, the First Proxy Form, if correctly completed, will be treated as a valid proxy form lodged by the Shareholder. The proxy/proxies so appointed by the Shareholder will be entitled to vote at its/his/her discretion or to abstain from voting on any resolution properly put to the 2024 Annual General Meeting including the resolutions for the re-election of Ms. Leng Wei Qian and Mr. Yao Jia Yong as Directors set out in the supplemental circular dated 6 May 2024 sent together with this second form of proxy;
- (ii) if this second form of proxy is lodged with the Company's share registrar 48 hours prior to the time appointed for holding the 2024 Annual General Meeting (the **"Closing Time"**), such second form of proxy, if correctly completed, will be treated as a valid proxy form lodged by the Shareholder and will revoke and supersede the First Proxy Form previously lodged by the Shareholder; and
- (iii) if this second form of proxy is lodged with the Company's share registrar after the Closing Time, or if lodged before the Closing Time but is incorrectly completed, the proxy appointment under this second proxy form will be invalid. The First Proxy Form, if correctly completed, will be treated as a valid proxy form lodged by the Shareholder. The proxy/proxies so appointed by the Shareholder under the First Proxy Form will be entitled to vote in the manner as mentioned in (i) above as if no second form of proxy was lodged with the Company's share registrar.
