Any member entitled to attend and vote at the 2023 AGM is entitled to appoint one or more proxies to attend and vote on your behalf. A proxy needs not be a member of the Bank. Any alterations made in this proxy form should be initialled by the person who signs it.
- 4. IMPORTANT: Please indicate with a "\sqrt{"}" in the appropriate box under the column marked "For" if you wish to vote in favour of a resolution. Please indicate with a "\sqrt{"}" in the appropriate box under the column marked "Against" if you wish to vote against. Please indicate with a "\sqrt{"}" in the appropriate box under the column marked "Abstain" if you wish to abstain from voting on a resolution, and the shares abstained will be counted in the calculation of the required majority. Failure to tick the box will entitle your proxy to cast your vote at his/her discretion. The proxy is also entitled to vote at his/her discretion on any other resolution duly submitted to the 2023 AGM in addition to those set out in the notice of 2023 AGM.
- 5. This proxy form must be signed by you or your attorney duly authorized in writing, or under the common seal or under the hand of a director or a duly authorized attorney in case of a legal person. If the proxy form is signed by an attorney, the power of attorney or other authorization document giving such authorization shall be notarized.
- 6. In cases of joint holders of a share, any one of such holders is entitled to vote at the 2023 AGM, by himself/herself or by proxy, as if he/she is the only one entitled to do so among the joint holders. However, only the vote of the person whose name stands first on the register of members in respect of such share shall be accepted if more than one joint holder attend the 2023 AGM personally or by proxy.
- 7. In order to be valid, this proxy form together with the power of attorney or other authority (if any) must be deposited at the H Share Registrar, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not less than 24 hours before the time fixed for holding the 2023 AGM or any adjournment thereof (as the case may be).
