The Company wishes to update the Shareholders and potential investors of the Company that, on the basis that the Creditors' Scheme was sanctioned by the High Court on 19 March 2024, the Company and the Joint Petitioners had filed a consent summons to the High Court dated 22 March 2024 to seek for order by consent that, inter alia, leave be granted for the Re-Amended Petition be dismissed. On 12 April 2024, the legal adviser of the Company received the High Court's order dated 25 March 2024 sets out that the Re-Amended Petition be dismissed.
