EXPANSION OUTSIDE HENAN

As of 30 April 2024, the Group had 36 projects under management in provinces other than Henan with an aggregate GFA of 3,926,142 sq. m., accounting for 12.3% of the total GFA of the Group's projects under management. These projects cover nine provinces or autonomous region outside Henan, including Anhui, Shanxi, Shaanxi, Hebei, Xinjiang, Hainan, Inner Mongolia, Hubei and Shandong.

CONTRACTED SALES OF PROJECTS UNDER MANAGEMENT
