ANNOUNCEMENT POWER GENERATION FOR APRIL 2024

The board of directors (the "Board") of China Longyuan Power Group Corporation Limited* (the "Company") announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (the "Group") for April 2024 on a consolidated basis amounted to 6,587,037 MWh, representing a year-on-year decrease of 12.26% as compared with the corresponding period of 2023. In particular, the wind power generation registered a decrease of 19.39%, the coal-fired power generation registered a decrease of 7.28%, and other renewable energy power generation of the Group for 2024 amounted to 27,812,286 MWh, representing a year-on-year increase of 2.59% as compared with the corresponding period of 2023. In particular, the wind power generation registered a decrease of 4.45%, the coal-fired power generation registered an increase of 6.73%, and other renewable energy power generation registered an increase of 222.22%.
