FURTHER DELAY IN DESPATCH OF CIRCULAR

References are made to (i) the announcement of Future World Holdings Limited (the “**Company**”) dated 22 March 2024 in relation to, among other things, the Assignment; and (ii) the announcement of the Company dated 17 April 2024 in relation to the delay in dispatch of circular (the “**Announcements**”). Unless the context requires otherwise, capitalised terms used herein shall bear the same meanings as defined in the Announcements.
