POLL RESULTS OF THE ANNUAL GENERAL MEETING

All resolutions as set out in the notice of the Annual General Meeting were duly passed by way of a poll at the Annual General Meeting held on Tuesday, 21 May 2024.

Reference is made to the circular of Trigiant Group Limited (“**Company**”) dated 26 April 2024 (“**Circular**”) in relation to, among other matters, the proposals for the (i) grant of general mandates to issue and repurchase shares of the Company; and (ii) re-election of directors of the Company to be passed at the annual general meeting of the Company held on 21 May 2024 (“**Annual General Meeting**”). Unless otherwise specified, capitalised terms used in this announcement shall have the same meaning as those defined in the Circular.

The Board is pleased to announce that all resolutions as set out in the notice of the Annual General Meeting dated 26 April 2024 were duly passed by the Shareholders by way of a poll at the Annual General Meeting.

As at the date of the Annual General Meeting, there were a total of 1,791,500,000 Shares in issue. To the best of the Directors’ knowledge, information and belief having made all reasonable enquiries, no Shareholder was required to abstain from voting on the resolutions proposed at the Annual General Meeting. As such, there were a total of 1,791,500,000 Shares, representing 100% of the issued share capital of the Company as at the date of the Annual General Meeting, entitling the Shareholders to attend and vote on the resolutions proposed at the Annual General Meeting. None of the Shareholders was entitled to attend

and abstain from voting in favour of the resolutions proposed at the Annual General Meeting according to Rule 13.40 of the Listing Rules. None of the Shareholders has stated their intention in the Circular to vote against the resolutions proposed or to abstain from voting at the Annual General Meeting.

The full text of the resolutions was set out in the notice of the Annual General Meeting. The poll results of the resolutions are as follows:
