At the Annual General Meeting of Tian An China Investments Company Limited (the “Company”) held on 22nd May, 2024 (the “AGM”), a poll was demanded by the Chairman of the Meeting for voting on all the proposed resolutions as set out in the notice of the AGM dated 26th April, 2024 (the “Notice”). As at the date of the AGM, the total number of issued shares of the Company was 1,466,069,491 shares, which was the total number of shares entitling the holders to attend and vote on the resolutions at the AGM. There were no shares of the Company entitling the holders to attend and abstain from voting in favour of the proposed resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) and no shareholders of the Company or their associates were required under the Listing Rules to abstain from voting on the proposed resolutions at the AGM. There was no restriction on any shareholders of the Company to cast votes on any of the proposed resolutions at the AGM and there was no party who had stated his/her/its intention in the circular to the shareholders of the Company dated 26th April, 2024 to vote against or to abstain from voting on the proposed resolutions at the AGM.

The Company’s share registrar, Tricor Secretaries Limited, was appointed as the scrutineer for the vote-taking at the AGM.

Except Dr. Moses Cheng Mo Chi who was unable to attend, all directors of the Company attended the AGM in person or by electronic means.
