If any proxy other than the Chairman of the meeting of the Company is preferred, please strike out the words "the Chairman of the meeting or" and insert the name and address of the proxy desired in the space provided. A shareholder may appoint one or more proxies to attend and vote on his/her behalf. A proxy need not be a shareholder of the Company. A proxy of a shareholder who has appointed more than one proxy may only vote on a poll. Any alteration made to this form of proxy must be initialed by the person(s) who sign(s) it.
- 5. **Important:** If you wish to vote for any resolution, please put a tick in the box marked "FOR" or insert the number of H shares held by you. If you wish to vote against any resolution, please put a tick in the box marked "AGAINST" or insert the number of H shares held by you. If you do not indicate how you wish your proxy to vote, your proxy will be entitled to exercise his discretion. Your proxy will also be entitled to vote at his discretion on any resolution properly put to the H Shareholders' Class Meeting other than those referred to in the notice of the H Shareholders' Class Meeting.
- 6. This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a legal person, must be either executed under its seal or under the hand of its director or other attorney duly authorised to sign the same. In case of joint holders, this form of proxy must be signed by the shareholder whose name stands first in the register of members of the Company.
- 7. To be valid, this form of proxy and, if such proxy is signed by a person on behalf of the appointer pursuant to a power of attorney or other authority, a notarially certified copy of that power of attorney or other authority must be delivered to the H share registrar of the Company in Hong Kong, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not less than 24 hours before the time appointed for holding the H Shareholders' Class Meeting (or any adjournment thereof).
- 8. In the case of joint holders of shares of the Company, only holder whose name stands first in the register of members of the Company shall alone be entitled to vote at the H Shareholders' Class Meeting either in person or by proxy in respect of such shares.
- 9. The H Shareholders' Class Meeting is expected to be held for less than half a day. Shareholders and their proxies who attend the H Shareholders' Class Meeting shall arrange for their own transportation and accommodation at their own expenses. Shareholders shall produce their identity documents when attending the H Shareholders' Class Meeting.
