POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 24 MAY 2024

At the Annual General Meeting of Shenwan Hongyuan (H.K.) Limited (the “Company”) held at Level 6, Three Pacific Place, 1 Queen’s Road East, Hong Kong, on Friday, 24 May 2024 (the “AGM”), a poll was taken for voting on all the proposed resolutions as set out in the Notice of Annual General Meeting dated 25 April 2024. Unless the context requires otherwise, capitalised terms used in this announcement shall have the same meanings as those defined in the circular dated 25 April 2024.

As at the date of the AGM, the number of shares in issue of the Company was 1,561,138,689 shares, which was the total number of shares entitling the holders to attend and vote for or against all resolutions at the AGM. There were no restrictions on any shareholders casting votes on any of the proposed resolutions at the AGM.
