**POLL RESULTS OF THE ANNUAL GENERAL MEETING
HELD ON 27 MAY 2024**

MS Group Holdings Limited (the “**Company**”) announces that at its annual general meeting held on 27 May 2024 (the “**AGM**”), all the proposed resolutions set out in the notice of the AGM dated 23 April 2024 (the “**AGM Notice**”) were passed on a poll.

As at the date of the AGM, the total number of issued shares of the Company was 200,000,000. The total number of shares of the Company entitling its shareholders to attend and vote for or against the resolutions proposed at the AGM was 200,000,000. There were no shareholders of the Company entitled to attend and abstain from voting in favour of any resolutions proposed at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) nor was any shareholders of the Company required under the Listing Rules to abstain from voting at the AGM. Save for Mr. Asvaintra Bhanusak who was unable to attend the AGM due to other business arrangement, all other Directors of the Company (the “**Directors**”) attended the AGM in person or by electronic means.

The Company’s Hong Kong branch share registrar, Tricor Investor Services Limited was appointed as the scrutineer at the AGM for the purpose of vote-taking. The poll results in respect of the respective resolutions proposed at the AGM were as follows:
