Reference is made to the announcement in relation to the circular (the “Circular”) and the notice (the “AGM Notice”) of the annual general meeting (the “AGM”) both dated 23 April 2024 of Shanghai Fudan Microelectronics Group Company Limited\* (上海復旦微電子集團股份有限公司) (the “Company”). Unless otherwise defined, terms used herein shall have the same meaning as defined in the AGM Notice and the Circular.

The Board is pleased to announce that all the resolutions as set out in the AGM Notice were duly passed by poll at the AGM held on 28 May 2024.

As at the date of the AGM, the Company has a total of 819,060,400 Shares of RMB0.10 each in issue, which was the total number of Shares entitling the shareholders of the Company to attend and vote at the AGM. No Shareholders were restricted from voting on any of the proposed resolutions at the AGM.

BDO Limited was appointed by the Company as scrutineer for vote-taking. Two shareholder representatives and one supervisor of the Company also participated in the vote-tabulation and acted as the scrutineer for vote-taking. Two lawyers from Shanghai Allbright Law Offices, the PRC legal advisor of the Company, witnessed the convening of the meeting, the procedures for holding the meeting and the voting results.
