Redsun Properties Group (Holdings) Limited is wholly owned by Hong Yang Group Company Limited, which in turn is wholly owned by Hong Yang International Limited, which in turn is owned as to 50% and 50% by Hong Yang Group (Holdings) Limited (a company wholly owned by Mr. Zeng Huansha) and Mr. Zeng Huansha, respectively. Accordingly, Redsun Properties Group (Holdings) Limited and its associates (who in aggregate held 2,400,000,000 Shares, representing approximately 71.88% of the issued share capital of the Company as at the date of the EGM) were required to abstain, and had abstained, from voting on the ordinary resolutions approving the same at the EGM. Accordingly, the total number of Shares entitling the Shareholders (save for and except Redsun Properties Group (Holdings) Limited and his associates) to attend and vote on the ordinary resolutions proposed at the EGM was 938,898,000.
