No parties have stated their intention in the circular to the shareholders dated 29 April 2024 containing the notice of the AGM to vote against or abstain from voting on any of the resolutions at the AGM.

Mr. Li Yue, Mr. Chan Hoi Chau and Mr. Li Wei attended the AGM.

The Company’s branch share registrar, Tricor Abacus Limited, acted as the scrutineer for the vote-taking at the AGM.
