**POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON
31 MAY 2024**

Reference is made to the circular (the “**Circular**”) of China Jicheng Holdings Limited (the “**Company**”) dated 30 April 2024 in respect of the re-election of retiring directors and grant of general mandates to issue Shares and repurchase Shares. Terms used in this announcement shall have the same meanings as those defined in the Circular unless the context requires otherwise.

At the AGM, voting on the proposed resolutions as set out in the notice of AGM dated 30 April 2024 was taken by way of poll. The Company’s branch share registrar in Hong Kong, Tricor Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.

The total number of Shares entitling the Shareholders to attend and vote for or against all the resolutions at the AGM was 412,550,000, representing the entire issued share capital of the Company as at the date of the AGM. There was no Share entitling any Shareholders to attend and vote only against any resolutions at the AGM. There were no restrictions on the Shareholders casting votes on any of the proposed resolutions at the AGM and there were no Shareholders required to abstain from voting at the AGM.

The executive director, Mr. Chung Kin Hung, Kenneth attended the AGM. Mr. Huang Wenji, Mr. Yang Guang and Mr. Lin Zhenshuang did not attend the AGM due to other business arrangement.

The independent non-executive director, Mr. Tso Sze Wai attended the AGM. Mr. Yang Xuetai and Ms. Lee Kit Ying, Winnie did not attend the AGM due to other business arrangement.
