## ANNOUNCEMENT POWER GENERATION FOR MAY 2024

The board of directors (the "Board") of China Longyuan Power Group Corporation Limited\* (the "Company") announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (the "Group") for May 2024 on a consolidated basis amounted to 6,577,161 MWh, representing a year-on-year decrease of 7.52% as compared with the corresponding period of 2023. In particular, the wind power generation registered a decrease of 10.08%, the coal-fired power generation registered a decrease of 21.02%, and other renewable energy power generation of the Group for 2024 amounted to 34,389,447 MWh, representing a year-on-year increase of 0.49% as compared with the corresponding period of 2023. In particular, the wind power generation registered a decrease of 5.55%, the coal-fired power generation registered a decrease of 0.33%, and other renewable energy power generation registered an increase of 165.37%.
