POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 7 JUNE 2024

At the annual general meeting of Mingfa Group (International) Company Limited (the “**Company**”) held on 7 June 2024 (the “**AGM**”), a poll was required for voting on all the resolutions as set out in the notice of the AGM dated 19 April 2024 (the “**Notice**”). The Company’s branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.

As at the date of the AGM, the total number of issued shares of the Company was 6,093,451,026 shares, which was the total number of shares in the Company entitling the shareholders of the Company (the “**Shareholders**”) to attend and vote for or against the resolutions at the AGM.

There were no restrictions on any Shareholders casting votes in any of the resolutions at the AGM under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and no Shareholders were required under the Listing Rules to abstain from voting on any of the resolutions proposed at the AGM.

Shareholders representing 2,611,509,025 shares of the Company were present, in person or by proxy or corporate representative, at the AGM.
