As at 25 April 2024 and 26 April 2024, the Company made a series of repurchase in respect of its A Shares on the Shenzhen Stock Exchange, with a total number of 1,877,000 A Shares repurchased.

The cancellation of the 1,877,000 A Shares repurchased by the Company was completed on 10 May 2024. Accordingly, the total number of issued shares of the Company was reduced by 1,877,000 Shares to 2,909,265,855 Shares (comprising 1,811,265,855 A Shares and 1,098,000,000 H Shares). In accordance with the Resolution on the Consideration of the 2023 Profit Distribution Plan passed at the board meeting held on 26 March 2024 (Tuesday) and the Annual General Meeting held on 6 June 2024 (Thursday), the Company will remain the total cash dividend of approximately RMB9,012,243,000 to be distributed to all shareholders unchanged, and based on the total number of Shares in issue as at 12 June 2024 (Wednesday), which is the record date, of the distribution amount per share will be adjusted accordingly from RMB3.096 per Share to RMB3.098 per Share. No bonus shares will be awarded, nor capital reserve will be converted to increase the share capital.
