Based on the management's preliminary review of the Group's operating data and the sales and promotion plans of the Group, the management expects that the Group will have a relatively lower net profit for the first half of 2024 of around RMB1.0 million, representing a decrease of approximately 70 to 80 percent as compared with the net profit of RMB4.5 million for the same period last year. The primary reason for the decrease in net profit is due to an increase in selling and distribution expenses incurred for both online and conventional channels, such as online platform promotion fees, during the first half of 2024, which negatively impact the Group's net profit margin.
