PERSONAL INFORMATION COLLECTION STATEMENT

- Your Personal Data may be disclosed or transferred by Link REIT or Link to companies under Link REIT; subsidiaries of Link; the Unit Registrar, and/or other agents, third-party service providers or contractors that offer administrative, telecommunication, computer, payment or other data processing services to Link or Unit Registrar in connection with the above Purposes. Your Personal Data may also be transferred to law enforcement agencies or regulatory authorities should Link or the Unit Registrar be required to do so by law or in response to requests from them.
