There were no Shares entitling any Shareholders to attend and abstain from voting in favour of the Resolutions at the AGM pursuant to Rule 13.40 of the Listing Rules and no Shareholder was required under the Listing Rules to abstain from voting on the Resolutions at the AGM. None of the Shareholders had stated its/his/her intention in the Circular to vote against or abstain from voting on the Resolutions at the AGM.

Mr. Li Hongtao, an executive Director and Mdm. Shing Mo Han Yvonne, independent non-executive Director, attended the AGM in person. Ms. Zhang Yi, Mr. Zhang Qipeng and Mr. Chi Benbin, non-executive Directors, and Mr. Li Hongji and Mr. Wang Dennis, independent non-executive Directors, attended the AGM by electronic means.

Computershare Hong Kong Investor Services Limited, the Company's share registrar, was appointed as the scrutineer for vote-taking at the AGM.
