SUMMARY OF POWER GENERATION FOR MAY 2024

This voluntary announcement is made by Shandong Hi-Speed New Energy Group Limited (the "Company", together with its subsidiaries, the "Group") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 645,533 megawatt-hour ("MWh") for May 2024, representing an increase of approximately 19.1% compared with the corresponding period of 2023. For the five months ended 31 May 2024 (the "Period"), the aggregate power generation of the Group amounted to approximately 2,755,700 MWh, representing an increase of approximately 13.6% compared with the corresponding period of 2023.

The operating power generation* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for May 2024 was approximately 659,688 MWh, representing an increase of approximately 9.1% compared with the corresponding period of 2023. For the Period, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 2,801,765 MWh, representing an increase of approximately 1.9% compared with the corresponding period of 2023.

* The operating power generation included (i) the power generation of the projects held by the Group, the associates and the joint ventures of the Group; and (ii) the power generation of the projects managed by the Group through the provision of entrusted management services.
