ANNOUNCEMENT ON PAYMENT OF 2024 PRINCIPAL AND INTEREST FOR 2024 FIRST TRANCHE OF ULTRA-SHORT-TERM DEBENTURES

This announcement is made by China Datang Corporation Renewable Power Co., Limited* (the “**Company**”) pursuant to Rules 13.09 and 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcement of the Company dated 26 April 2024 (the “**Issuance Announcement**”) in relation to the issuance of 2024 first tranche of the ultra-short-term debentures (the “**Ultra-Short-Term Debentures**”). Unless the context requires otherwise, capitalised terms used in this announcement shall have the same meanings ascribed thereto in the Issuance Announcement.
