RESULTS

For the financial year ended 31 March 2024, the Group's consolidated revenue was approximately HK\$211,845,000 (2023: approximately HK\$231,557,000). The loss attributable to equity holders of the Company was approximately HK\$19,352,000 (2023: profit of approximately HK\$1,050,000) while loss per share was HK7.45 cents (2023: earnings per share of HK0.40 cents).

BUSINESS REVIEW

The global market environment was filled with challenges in the year under review. Despite the Covid-19 pandemic was gradually faded away, as affected by the macroeconomic environment, the global economic recovery remained at a slow pace and all sectors of society are striving to move forward.

The global economic environment is impacted by uncertain factors of inflation, geopolitical tensions, tightening of financial conditions. The persistent decline in consumers' confidence is hindering the global recovery, further stimulated the turn to weakening trade. Follow by the rise in costs across various areas such as logistics, finance, trade and promotion coupled with labor shortages, business competitions are becoming more intensified, posting severe challenges to businesses across industries.

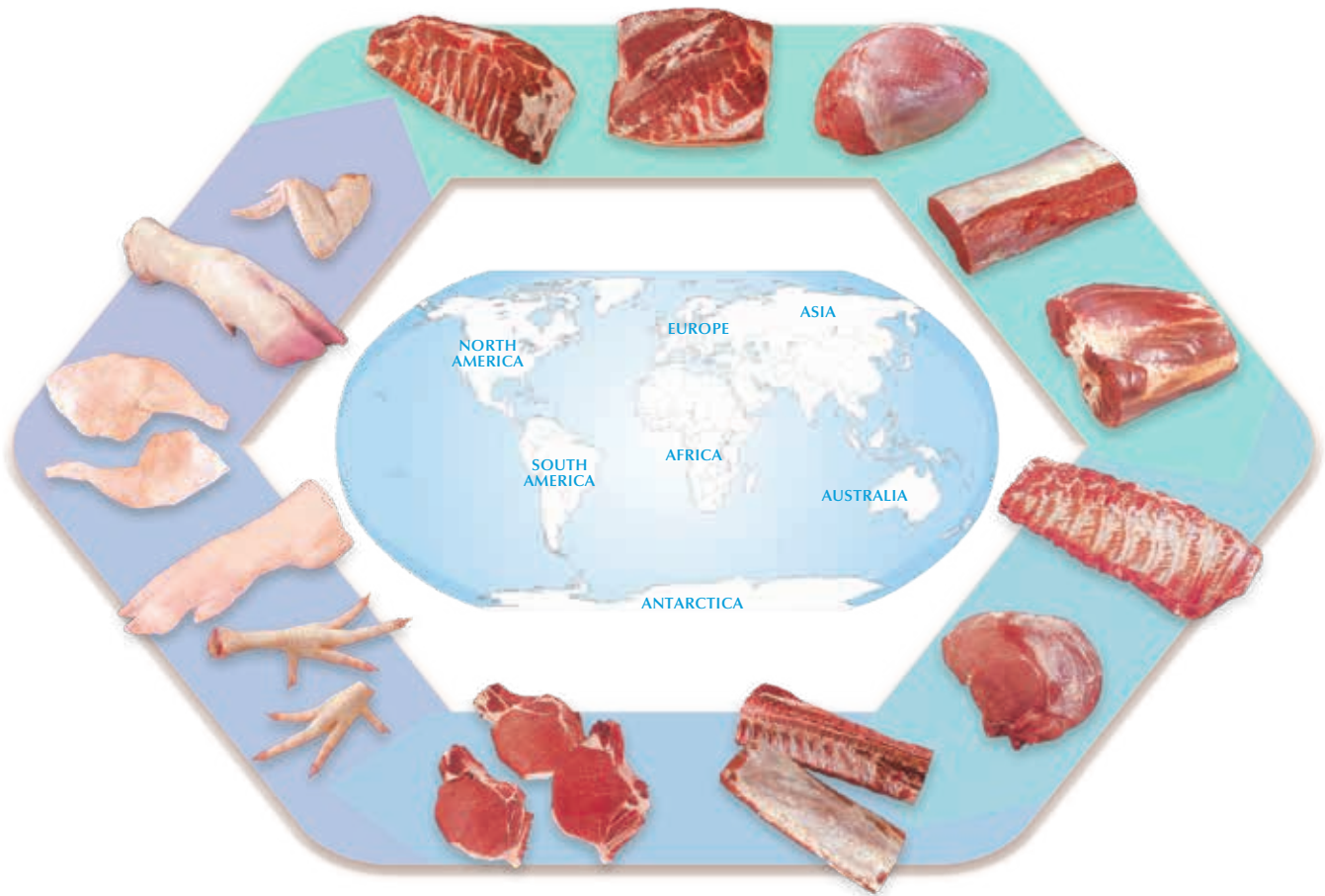
業績

截至二零二四年三月三十一日止財政年度，本集團的綜合收益約為211,845,000港元（二零二三年：約231,557,000港元）。本公司權益持有人應佔虧損約為19,352,000港元（二零二三年：溢利約1,050,000港元），每股虧損為7.45港仙（二零二三年：每股盈利0.40港仙）。

業務回顧

在回顧年度內，全球市場環境充滿挑戰。儘管疫情逐漸消退，然而受大環境影響，世界經濟復甦仍然緩慢，社會各界須砥礪前行。

全球經濟正面臨著通脹、地緣政治局勢緊張、金融環境收緊等不確定性影響。消費者的信心持續下降，阻礙了全球復甦，並進一步催化了貿易疲弱之轉向。隨著各方面例如物流、金融、貿易及宣傳成本上漲並勞動力短缺，令營商環境競爭越趨激烈、為各行各業帶來了嚴峻的挑戰。



Always bring you the world's superior quality frozen meats
從世界每個角落帶來優質凍肉

For the domestic market, affected by the macro-environment, the market did not experience strong rebound as looking forwarded, further new challenges were faced in the year under review. Upon the lifting of Hong Kong travel restrictions after the pandemic, citizens were indulged in revenge outbound travel and drive the popularity of cross-border spending, leading to the significant and unexpected decline in local consumption. On the other hand, the numbers of inbound visitors, their consumption patterns, and the proportion of overnight visitors were deviated from the past experience. All these changes have a great impact to the market, requiring considerable time to explore on the new directions.

The Group determinates to walk hand in hand with the community. By utilising our trade experience, networking, and market intelligence in the frozen food trade business, we adopt the flexible and strategic business plan for moving forward. Despite the ever-changing business environment, we are endeavored to enhance our market competitiveness, strengthen the foundation and cope with the challenges.

至於本地市場，受大環境影響，市場並未經歷期望中的強力反彈，更在回顧年度內面臨全新的考驗。在疫情後香港旅遊限制解除，市民熱衷於出外旅遊以及掀起了跨境消費的潮流，令本地消費意料之外地大幅度減少。在另一方面，入境旅客的數目，其消費模式，過夜訪港旅客量均有別於從前。以上各種轉變對本地市場打擊甚大，須要相當時間去摸索新方向。

本集團決意與社會各界並肩前行，利用在冷凍食品貿易業務方面的經驗、網絡和市場觸角，我們採取靈活和富策略性的業務計劃奮力前行。儘管經營環境不斷變化，我們仍將繼續竭盡全力提高市場競爭力，強基固本，迎難而上。

Frozen Meats Trading

The catering and frozen meat trading industries in Hong Kong faced a challenging business environment during the year ended 31 March 2024. The Hong Kong economy experienced a period of slow growth, the overall consumption sentiment slowed down and the fashion of cross-border consumption developed. In the period of review, more and more Hong Kong residents changed to shop and spend in the Chinese Mainland, resulted in the local frozen meat market being severely affected especially the supply to retail and catering sector, the demand of the middle to high range restaurants significantly shrank. Therefore on sales strategy, besides consolidation the sales to our long term customers, we focus on the fast food chain sector. In the period of review, sales in fast food chain sector have recorded a remarkable growth of about 32% as compared to previous year and able to achieve higher gross profit for the Group. Therefore we will continue to strengthen the business in this sector in the coming years.

We are endeavor to maintain a robust and reliable supply chain, as well as provide a competitive range of product supply to our customers. To ride on our network and competitive edge, in coping with the market trend, our frozen meats trading segment expanded our product portfolio to include a wider range of high-quality frozen meat products, catering to diverse customer preferences. We successfully introduced the “Hokkaido Snow Dream Pork” brand to the local market and became an exclusive selling agent in Hong Kong and Macau. In view of the increasing market demand for pork from Hokkaido, Japan, this strategic expansion is hoped to contribute to increased sales and market penetration. We also explored hormone-free meat products in recent years and introduced hormone-free chicken products from suppliers that adopt international hygiene standards.

To navigate the uncertain market environment, we would focus on cost control, supply chain optimisation, developing new products that cater to evolving consumer preferences and opening up new overseas markets to increase the profit margins.

Catering Business

The catering business operates two restaurant brands – “Beefar’s” and “Gyumai”. We have one “Beefar’s” restaurant offering high-quality “Satsuma” brand of Japanese wagyu beef in Japanese BBQ style and three “Gyumai” restaurants offering supreme beef from Japan, Australia and USA in all-you-can-eat Japanese Yakiniku and shabu-shabu style.

In the year under review, it was a tough year for the catering industry in Hong Kong. Challenges posed to the catering industry included rising energy prices, fierce market competition, changes in consumption patterns and cross-border consumption to the mainland. During the year, the catering industry was also hit by a slower than-expected economic recovery in Hong Kong. With the lifting of Hong Kong travel restrictions, there was a notable increase in outbound travel, yet the inbound traveler arrivals simply could not fill the gap. In such an unfavourable business climate, our business as well as the whole catering industry in Hong Kong were severely affected.

凍肉貿易業務

在二零二四年三月三十一日的年度內，香港餐飲及凍肉貿易行業面對著充滿挑戰的商業環境。香港經濟放緩，整體消費情緒減慢，並發展出北上內地消費的潮流。在回顧期內，越來越多香港居民轉往內地購物和消費，令凍肉市場無論在零售及餐飲方面，特別是中至高檔的本地需求均大幅減弱。因此在銷售策略上，除了我們多年的穩固客戶，我們將重點放在業務主要在香港的連鎖快餐店部分。在回顧期內，連鎖快餐店部分的銷售額較去年錄得約32%的顯著增長，並能為本集團實現更高毛利。因此未來幾年我們將繼續加強在這個領域的客戶的業務。

我們致力於維持強大而可靠的供應鏈，並為客戶提供具有競爭力的產品。憑藉我們的網路及競爭優勢，因應市場趨勢，我們的凍肉貿易分部擴大了產品組合，包括更廣泛的優質凍肉產品，以滿足不同客戶的喜好。成功將北海道豬肉「雪夢豚」品牌引進本地市場，成為香港及澳門地區獨家代理商。鑑於市場對日本北海道豬肉的需求不斷增加，此次策略擴張有助於增加銷售量和市場滲透率。近年來我們也引進了無激素肉製品，此乃採用了符合國際衛生標準之供應商生產的無激素雞肉產品。

應對目前不穩定的市場環境，我們將專注於成本控制、供應鏈優化、開發迎合不斷變化的消費者喜好的新產品以及開拓新的海外市場以提高利潤。

餐飲業務

餐飲業務經營了兩個餐廳品牌 — 「Beefar's」和「牛舞」。我們擁有一間「Beefar's」餐廳以日式燒烤風格提供優質「薩摩牛」品牌日本和牛，以及三間「牛舞」餐廳，以任食自助日式燒肉和日式涮鍋風格提供來自日本、澳洲和美國的頂級牛肉。

在回顧年度，對香港餐飲業來說是艱難的一年。餐飲業面臨的挑戰包括能源價格上漲、市場競爭激烈、消費模式轉變、及跨境北上消費等。餐飲業亦因香港經濟復甦慢於預期而受到打擊。隨著香港旅遊限制解除，出境旅遊顯著增加，但入境旅遊人數未能填補這缺口。在如此不利的商業環境下，我們及本港整體的餐飲業務均受到嚴重影響。

Facing such difficult market condition, we actively face the challenge and do our best endeavor to cope the changing environment. On internal management, strict cost control measures were promptly adopted to minimise the food wastage cost and streamlined the kitchen operation. We also employed new sales strategies to improve the operation efficiency by introducing more value for money menu to attract both new and existing customers. Also, promotion was launched in social media to stimulate sales growth, including advertising in the Chinese Mainland to expand our customer base and build up our brand reputation.

Other Business

The segment of communication and advertising design business is growing steadily. We offer a diversity of services and specialise in providing comprehensive above the line and below the line advertising services. Riding on the well-known brands of "Satsuma" and "L'Grow" in the meats trading sector, and restaurant brands of "Beefar's" and "Gyumai" we built and the business network of our Group, we developed more new businesses from both catering and other sectors. Besides maintaining our existing clients, we will focus on the marketing and digital media business in the future.

Food Business Investment

The Group continues to hold approximately 29.99% (2023: 29.99%) equity interest of Four Seas Mercantile Holdings Limited ("FSMHL") as a strategic investment in the food business.

Despite the challenging business environment and low market sentiment, FSMHL's overall performance met expectations during the review period. FSMHL's business is mainly concentrated in Hong Kong, Chinese Mainland and Japan. The depreciation of Renminbi and Japanese yen in the period under review also affected the revenue of FSMHL.

Food distribution is the core business of FSMHL, during the year, it continued to introduce a diverse range of Japanese foods and explored more opportunities in the food distribution segment. Products like Japanese ice cream, Japanese eggs, Japanese milk, Japanese tofu and Japanese rice achieved remarkable sales and became a stable income source.

Following the acquisition of Miyata Co., Ltd. ("Miyata"), FSMHL was able to introduce foods produced in Chinese Mainland into the Japanese market. The long history in Japan and strong network of retail and distribution with a vast customer base of Miyata brought synergy to FSMHL and strengthened the connection between Hong Kong, Chinese Mainland and Japan.

For the financial year ended 31 March 2024, the Group's share of profit from associates, primarily by FSMHL was HK\$10,393,000 (2023: HK\$12,214,000).

面對嚴峻的市場情況，我們積極面對挑戰並盡力應對環境的轉變。在內部管理方面，我們及時採取嚴格的成本控制措施，並精簡廚房運作。我們也採用新的銷售策略，透過推出更多物有所值的菜單來吸引新舊客戶，從而提高營運效率。此外，我們亦在社交媒體上推出了促銷活動以刺激銷售增長，包括在內地投入廣告宣傳，以擴大我們的客戶群及建立我們的品牌聲譽。

其他業務

傳訊及廣告設計業務分部增長穩定。我們提供多元化的服務並專注於提供全面的線上線下廣告設計服務。憑藉我們在肉類貿易領域廣受認可的「薩摩牛」和「L'Grow」品牌，以及餐飲行業建立的「Beefar's」和「牛舞」品牌以及集團的業務網絡，我們拓展了餐飲以及其他行業的新客戶。除了維護現有的客戶外，未來我們將專注於市場營銷和數字媒體業務之發展。

食品業務投資

本集團繼續持有四洲集團有限公司（「四洲集團」）之股份權益約29.99%（二零二三年：29.99%）作為對食品業務的策略性投資。

儘管營商環境充滿挑戰且市場氣氛低迷，四洲集團於回顧期間的整體表現仍符合預期。四洲集團的業務主要集中在香港、中國大陸和日本。於回顧年度內，人民幣和日圓貶值直接影響了四洲集團的收入。

食品分銷是四洲集團的核心業務，在年度內繼續引入多元化的日本食品，並在食品分銷領域尋找更多機會。日本雪糕、日本蛋、日本牛奶、日本豆腐、日本米等產品銷售成績顯著，成為穩定的收入來源。

收購宮田株式会社（「宮田」）後，四洲集團得以將中國大陸生產的食品引進日本市場。宮田在日本的悠久歷史、強大的零售和分銷網絡以及龐大的客戶群為四洲集團帶來了協同效應，並加強了香港、中國大陸和日本之間的聯繫。

截至二零二四年三月三十一日止財政年度，本集團來自四洲集團的應佔聯營公司溢利為10,393,000港元（二零二三年：12,214,000港元）。

PROSPECTS

Looking forward to the coming year, the full recovery of global economy is sluggish and uncertain. The slowdown of global economic growth, the high-interest rate environment and sustained geopolitical tensions will continue to impact the overall global economy that could be anticipated the various operating costs will continue to rise. For the domestic market, with dampened consumer sentiment and significant shifts in consumer behavior and preferences, timely business adjustments and period of acclimation is needed for both the market and enterprises.

The Group will continue actively monitor the changing market situation, and adopt the suitable policy and strategies. We will consolidate our foundation; strengthen our experience and network, deepening the long term relationship with the overseas suppliers. For the demand of the market is uncertain, we will explore for overseas opportunities to expand our sales network. By widening our range product offering and develop distribution of unique, high quality and cost effective products, and widen our target market to fit for the demand of larger scope of customers. On the other hand, in view of the persistent inflation, we will adopt strict cost control measures and adopt flexible policies to lower down the impact on the raising operating cost. The Group will continue to source in a flexible and diversified manner to stabilise its cost, adjust and strengthen its sales strategies, to speed up new product development with a view to achieving higher profit margin.

FSMHL, the strategic investment partner of the Group, with 50 years of successful experience in operating diversified businesses, maintained its leading position in the Hong Kong market. In the coming year, it will continue to adhere to its development strategy of "Rooted in Hong Kong, Expanding to Chinese Mainland, and Reaching Out to the World". Based in Hong Kong, while maintaining its leading position in the local market, it will continue to strive to preserve its competitive advantage in Chinese Mainland and also develop new opportunities in Japan and other regions. We have no doubt that FSMHL will bring good revenue to the Group continuously.

Despite the operating environment is full of challenges and persistent external pressures, the Group will keep up the flexibility and adaptability, proactively respond to market changes with suitable strategies, further fully utilise the Group's competitive advantages and experience to forge ahead in the uncertain market conditions. Leveraging our long-standing business relationships with local customers and overseas suppliers, with their support the Group will continue endeavor in providing delicious, nutritious, and high-quality food products to the public.

展望

展望來年，全球經濟全面復甦緩慢並有待觀望。全球經濟增長放緩及高息環境下，與及地緣政治持續緊張將繼續影響全球經濟，可以預期各樣經營成本將繼續有上升的趨勢。在本地市場方面，隨著消費意慾低迷和消費者行為及偏好重大的轉變，市場和企業均需要適時的商業調整與磨合時間。

本集團將繼續積極關注不斷變化的市場形勢，並採取合適的政策和策略。我們將鞏固現有的基礎，加強我們的經驗和網絡，深化與海外供應商的長期合作關係。面對市場需求的不確定性，我們將尋找海外機會以擴大銷售網絡。透過拓寬我們的產品組合，提供獨特、優質、高性價比的產品，以擴大目標市場，滿足更多客戶的需求。另一方面，在通脹持續的情況下，我們將嚴格控制成本及採取靈活的政策，以減低對經營成本上升的影響。本集團將繼續以靈活及多元化的方法採購，以達至穩定成本，並調整及加強銷售策略，加快新產品開發爭取更高利潤。

本集團的策略性投資夥伴四洲集團，憑藉50年經營多元化業務的成功經驗，在香港市場穩佔領先地位。來年，四洲集團將繼續堅持「立足香港、面向內地、走出世界」的發展策略。在維持本地市場領先地位的同時，將繼續致力於保持在中國內地的競爭優勢，並在日本及其他地區開拓新機遇。我們深信四洲集團將繼續為本集團帶來良好收入。

儘管經營環境充滿挑戰和外圍壓力持續，本集團將保持靈活變通，以合適的市場策略及時應對市場的變化，以及充分利用集團的競爭優勢和經驗，在市場不明朗的環境下奮力向前。憑藉與本地客戶及海外供應商的長期業務關係和支持，本集團將繼續為大眾提供美味、營養和高品質的食品。

For the year ended 31 March 2024, the Group's consolidated revenue recorded at approximately HK\$211,845,000, a decrease of 8.5% over approximately HK\$231,557,000 of previous financial year. Such revenue drop was mainly attributable to the decrease in revenue from both trading and catering segments severely hit by the economic downturn and change in consumption habit.

Frozen Meats Trading Business

The revenue generated from frozen meats trading business for the current year was approximately HK\$157,525,000 (2023: HK\$167,635,000) representing 74.4% of the Group's total revenue and it remains as the core business of the Group.

The economic downturn, low consumer sentiment and popularity of cross-border consumption to the Chinese Mainland posted a great challenge to our core business. The demand and price for premium quality products provided huge revenue source in previous years dropped significantly recently. Luckily, the sales in fast food chain segment, whose business focus is mainly in Hong Kong, increased approximately for 32% and partially outweighed the drop in revenue. We will continue to focus in this section and strengthen the relationship with our existing clients in order to achieve higher gross profit.

While the profit margin of the traditional frozen meat products fell, the new products including premium quality products like Japanese pork and plant-based products helped to maintain the profit margin at around 6.6% (2023: 6.7%).

The segment results were also affected by the rise in operating expenses including the distribution and administrative expenses. The operating expenses to sales rose by 1.4% as compared to the previous year.

The overall segment result of the frozen meats trading business for the year under review was a loss of approximately HK\$5,108,000 (2023: HK\$4,117,000).

截至二零二四年三月三十一日止年度，本集團的綜合收入約為211,845,000港元，較上個財政年度約231,557,000港元減少8.5%。收入下降主要是貿易及餐飲分部收入減少，此乃受到經濟低迷及消費習慣改變的嚴重影響所致。

凍肉貿易業務

本年度凍肉貿易業務產生的收入約為157,525,000港元（二零二三年：167,635,000港元），佔本集團總收入的74.4%，仍然是本集團的核心業務。

經濟低迷、消費意欲降低、跨境到中國大陸消費普及等，對我們的核心業務帶來巨大挑戰。往年提供龐大收入來源的優質產品的需求和價格近期大幅下降。幸好，主要業務集中在本地的快餐連鎖店分部的銷售額增長約32%，抵消了部分收入的跌幅。我們將繼續專注在該板塊，加強與現有客戶的關係，以實現更高的毛利。

雖然傳統冷凍肉產品的利潤率下降，但新產品包括日本豚肉等優質產品和植物性產品有助於將利潤率維持於6.6%（二零二三年：6.7%）。

貿易業務的業績也受到經營費用，包括分銷及行政開支上升的影響，經營費用與銷售額的比例比上年增長1.4%。

凍肉貿易業務於回顧年度的整體分部業績虧損約5,108,000港元（二零二三年：4,117,000港元）。

Catering Business

The revenue from catering business decreased for 16.0% to approximately HK\$50,431,000 for current year. The popularity of cross-border consumption in the mainland China and rise in operating costs severely impacted the catering industry in Hong Kong. Our restaurants, being in the middle to high range, were most affected under such unfavourable situation. The operating costs especially the labour costs increased significantly as compared to the previous year and also the absent of government's anti-epidemic funds and the wage subsidies under the "Employment Support Scheme" program in current year further worsen the segment results.

The segment loss for the current year was approximately HK\$10,036,000 as compared to a loss of approximately HK\$2,800,000 for previous financial year.

Other Businesses

For the year under review, the revenue from segment of communication and advertising design businesses was approximately HK\$3,889,000, slightly decreased by 0.1% from approximately HK\$3,894,000 of previous financial year. The segment achieved a profit of approximately HK\$1,821,000, as compared to approximately HK\$1,630,000 for previous year, representing an increase of 11.7%. With the support of the customers from catering, retails, banking and properties sectors, the segment maintained stable growth.

餐飲業務

本年度餐飲業務收入減少16.0%至約50,431,000港元。內地跨境消費日漸流行及經營成本上升，嚴重衝擊香港餐飲業。我們的中高檔餐廳在此不利情況下受到最大的影響。營運成本尤其是勞工成本較上年大幅上升，再加上本年度缺少了政府抗疫基金及「保就業計劃」下的工資補貼，令餐飲分部的虧損進一步惡化。

本年度餐飲分部虧損約10,036,000港元，上一財政年度則虧損約2,800,000港元。

其他業務

於回顧年度內，傳播及廣告設計業務分部的收入約為3,889,000港元，較上一財政年度約3,894,000港元輕微減少0.1%。該分部錄得溢利約1,821,000港元，較去年約1,630,000港元增加11.7%。在餐飲、零售、銀行、房地產等客戶的支持下，該業務分部的業務維持穩定成長。

Revenue

There was a slight drop in overall revenue over the previous financial year. As disclosed in the Operating Segment Information of note 4 to the financial statements in this annual report, revenue from trading segment decreased by approximately 6.0% to approximately HK\$157,525,000 because the demand in high-quality products, such as the wagyu beef dropped due to the unfavourable economic situation. Revenue from the catering segment decreased by approximately 16.0% to approximately HK\$50,431,000 as the demand for middle to high range restaurants, like "Gyumai", significantly declined due to the shift of consumption to the Chinese Mainland. Due to the revenue from catering segment fell, the trading segment revenue accounting for 74.4% of the overall revenue, an increase from 72.4% in previous financial year.

Gross Profit Margin

The Group's gross profit margin slightly decreased to 21.4% from 21.9% of previous financial year. The profit margin in the catering segment increased from 60.6% to 63.0%, however, the effect was offset by the drop in the gross profit margin in the trading segment from 6.7% to 6.6%. The improvement in the gross profit margin in the catering segment was mainly attributable to the strict cost control measure that reduced the cost of food wastage.

收入

整體收入較上一財政年度略有下降。誠如本年報財務報表附註4經營分部資料所披露，貿易分部的收入減少約6.0%至約157,525,000港元，原因是由於經濟不景氣，優質產品，例如日本和牛產品的需求減少。餐飲分部的收益減少約16.0%至約50,431,000港元，原因是北上中國大陸消費增加，對本地中高檔餐廳，如「牛舞」，的需求大幅下降。由於餐飲業務收入下降，貿易業務收入佔整體收入的比例為74.4%，較上一財政年度的72.4%有所上升。

毛利率

本集團毛利率由上一財政年度的21.9%小幅下降至21.4%。餐飲分部的毛利率由60.6%上升至63.0%，但其影響被貿易分部的毛利率由6.7%下降至6.6%所抵銷。餐飲分部毛利率的改善主要是受益於嚴格的成本控制措施，以致降低了食品浪費之成本。

Trade Receivables Turnover

Trade receivables turnover days were 32 days (2023: 26 days) after impairment allowance to trade receivables, attributable to the relatively higher proportion of sales deriving from customer groups whose credit payment days are normally longer as compared to last year.

Inventory Turnover

Inventory turnover days were 90 days (2023: 93 days) and the closing inventory for the current year amount to approximately HK\$43,182,000 (2023: approximately HK\$39,265,000) resulting from the significant decrease in high-quality frozen meats, mainly wagyu beef from restaurants caused by the change in consumer behaviour and popularity of cross-border consumption in the Chinese Mainland.

Operating Expenses to Sales

The Group's ratio of operating expenses to sales was 24.4% (2023: 21.8%). The increase in expenses was mainly attributable to the decrease in sales of both the trading and catering businesses driven by the economic downturn.

Food Business Investment

The Group continues to hold approximately 29.99% (2023: 29.99%) equity interest of FSMHL as a strategic investment in the food business.

For the financial year ended 31 March 2024, the Group's share of profit from associates, primarily by FSMHL was HK\$10,393,000 (2023: HK\$12,214,000).

Distribution Business

Food distribution is the core business of FSMHL. It has developed steadily over the years and has an extensive distribution network. Customers include department stores, supermarkets, convenience stores, fast food restaurants, wholesalers, retailers, restaurants, bars, hotels and Airlines, etc., to meet the different needs of Hong Kong consumers. FSMHL has also cooperated with well-known food manufacturers all over the world from more than ten countries and regions, covering a wide range of products, including ice cream, eggs, tofu, rice, milk, snacks, milk powder, health food, plum wine, soy sauce, ham and sausage, etc. to meet the diverse needs of consumers.

With the acquisition of Miyata, FSMHL further expanded the Group's food agency business by introduced foods produced in Chinese Mainland into the Japanese market. With Miyata's strong retail and distribution network together with the vast customer base, FSMHL also sourced more Japanese foods for both the Hong Kong and Chinese Mainland markets.

應收貿易賬款周轉

計提應收賬款減值撥備後，應收貿易賬款還款周期為32天(二零二三年：26天)，這是由於信用付款天數較長的客戶群的銷售比例相對去年增加所致。

存貨周轉

存貨周轉天數為90天(二零二三年：93天)，本年度的期末存貨約為43,182,000港元(二零二三年：約39,265,000港元)，主要是由於本地消費行為的改變及跨境往中國大陸消費的普及，餐廳客戶對優質冷凍肉，主要是和牛，需求大幅減少所致。

經營費用與銷售比率

本集團經營費用與銷售額的比率為24.4%(二零二三年：21.8%)。費用增加主要是由於經濟低迷所影響導致貿易及餐飲業務的銷售額減少所致。

食品業務投資

本集團繼續持有四洲集團約29.99%(二零二三年：29.99%)的股份權益，作為對食品業務的策略性投資。

截至二零二四年三月三十一日止財政年度，本集團來自聯營公司(主要為四洲集團)的應佔溢利為10,393,000港元(二零二三年：12,214,000港元)。

食品代理業務

食品分銷是四洲集團的核心業務。多年來穩步發展，擁有龐大的分銷網絡。顧客包括百貨公司、超級市場、便利店、快餐店、批發商、零售商、餐廳、酒吧、酒店及航空公司等，滿足香港消費者的不同需求。四洲集團也與全球十多個國家和地區的知名食品生產商合作，代理產品範圍廣泛，包括雪糕、雞蛋、豆腐、大米、牛奶、零食、奶粉、保健食品、梅酒、醬油、火腿及香腸等，滿足消費者的多樣化需求。

透過收購宮田，四洲集團進一步拓展了本集團的食品代理業務，將中國大陸生產的食品引入日本市場。憑藉著宮田強大的零售及分銷網絡以及龐大的客戶群，四洲集團亦為香港及中國大陸市場採購更多的日本食品。

Manufacturing Business

FSMHL highly valued food quality and hygiene to achieve the goal of “Eating Safely, Eating Happily”. It adopted a comprehensive monitoring system to ensure its products are safe, high-quality, and tasty. Through meticulous quality control and advanced production monitoring systems, FSMHL takes great pride in the quality of its products. FSMHL has received numerous accreditations including “HACCP”, “ISO9001”, “ISO 22000”, and “GMP” system certifications, the “Q-Mark License” of the Hong Kong Q-Mark Certification Scheme for over 30 years, and the “HKQAA Hong Kong Registration – Oil” from the Hong Kong Quality Assurance Agency. The certifications are a testimony to the quality of the Group’s food products and the standards it demands of itself. FSMHL has 17 plants in Hong Kong and Chinese Mainland, where it manufactures various specialty foods. With its one-stop production and targeted sales strategies, it is capable of meeting market needs and consolidating its leading status in the industry. The associated company formed with Calbee Japan, Calbee Four Seas Co., Ltd., now has two food production plants, one in Tseung Kwan O in Hong Kong and the other in Shantou, Chinese Mainland, producing popular snacks like potato chips, shrimp strips and corn sticks, in both Hong Kong and Chinese Mainland.

Retailing and Catering Business

FSMHL’s Chinese and Japanese restaurants are well-regarded in Hong Kong and Guangdong. They are well known and loved for their appetizing dishes, efficient management, and remarkable services. Restaurants including “Panxi” garden restaurant in Guangzhou, “Shiki • Etsu” Japanese restaurant, “Kung Tak Lam” Shanghai vegetarian restaurant, “Sushiyoshi” Japanese omakase restaurant, and Chinese Mainland’s “Sushi Oh” revolving sushi restaurant, continue to be loved by diners. The Japanese snacks store “Okashi Land”, “Japanese Ice Cream House” Japanese specialty ice-cream and snack stores “YOKU MOKU” cookie stores and “Miyata Store” of FSMHL remained popular among the Hong Kong consumers. Recognising the huge market demand in the Greater Bay Area, a “Four Seas Okashi Land” flagship store at Sungang Metro Station in Luohu District will be opened soon. FSMHL dedicated to bringing Japanese on-trend refreshments to consumers in Hong Kong and the Chinese Mainland markets.

食品製造業務

四洲集團高度重視食品品質和衛生，以實現「食得放心、食得開心」的宗旨。設立了完善的監控制度，確保產品安全、優質、美味。透過細緻的品質控制和先進的生產監控系統，四洲集團對其產品品質感到非常自豪。四洲集團已獲得多項認證，包括「HACCP」、「ISO9001」、「ISO 22000」和「GMP」系統認證、香港 Q 嘜計劃 30 年以上認證之「Q 嘜准用證」及獲「香港品質保證局」頒發的《香港品質保證局香港註冊 – 食油》。這些認證是本集團食品品質及其自身要求標準的證明。四洲集團在香港和中國大陸擁有 17 家廠房，生產各種特色食品。憑藉一站式生產和針對性銷售策略，滿足不同市場的需求，鞏固行業內的領先地位。與日本卡樂 B 成立的聯營公司卡樂 B 四洲有限公司，現擁有兩間食品生產廠，一間位於香港將軍澳，另一間位於中國內地汕頭市，生產薯片、蝦條及粟米條等大眾零食供應香港和中國大陸市場。

零售及餐飲業務

四洲集團的中式和日式餐廳在香港和廣東地區享譽盛名。餐廳以美味的菜餚、高效的管理和卓越的服務聞名而受到喜愛。廣州「泮溪」園林酒家、「四季•悅」日本料理、「功德林」上海素食餐廳、「壽司芳 Sushiyoshi」以及中國內地「壽司皇」日本迴轉壽司餐廳繼續受到食客喜愛。四洲集團的日本零食店「零食物語」、日本特色雪糕「日本雪糕屋」、「YOKU MOKU」餅乾店及「宮田商店」仍深受香港消費者歡迎。認識到大灣區巨大的市場需求，位於羅湖區筲崗地鐵站的「四洲零食物語」旗艦店即將開幕。四洲集團致力於為香港和中國內地市場的消費者帶來日本的流行美食。

Liquidity and financial resources

The Group generally finances its operations with internally generated cash flows and facilities granted by its principal bankers. As at 31 March 2024, the Group had banking facilities of HK\$200,753,000 (2023: HK\$200,753,000) of which 15% (2023: 11%) had been utilised. The Group had a gearing ratio of 6% (2023: 4%) as at 31 March 2024. This is expressed as the total interest-bearing bank borrowings to equity attributable to equity holders of the Company. Bank borrowings of the Group, denominated in Hong Kong dollars, are mainly trust receipt loans (the “Interest-Bearing Bank Borrowings”) at prevailing market interest rates. The Interest-Bearing Bank Borrowings which are classified as current liabilities are repayable within one year. As at 31 March 2024, the Group held cash and cash equivalents of HK\$74,575,000 (2023: HK\$81,505,000). There were no significant changes in the Group’s contingent liabilities and no charges on the Group’s assets at the end of the reporting period.

Staff employment

The total number of employees of the Group as at 31 March 2024 was 67 (2023: 75). Remuneration packages are generally structured by reference to market terms and individual qualifications. Salaries and wages are normally reviewed annually based on performance appraisals and other relevant factors.

流動資金及財政資源

本集團一般以內部流動現金及主要往來銀行授出之信貸作為業務之融資。於二零二四年三月三十一日，本集團擁有銀行信貸額約200,753,000港元（二零二三年：200,753,000港元），其中15%（二零二三年：11%）經已動用。本集團於二零二四年三月三十一日之資本與負債比率為6%（二零二三年：4%），亦即須繳付利息之銀行借款總額與權益歸屬於本集團權益所有者之比例。本集團之銀行借款主要以港元為結算貨幣，並主要為根據當時通行市場息率之信託收據貸款（「須繳付利息之銀行貸款」）。有關貸款分類為流動負債之須繳付利息之銀行貸款須於一年內償還。於二零二四年三月三十一日，本集團擁有之現金及現金等值約為74,575,000港元（二零二三年：81,505,000港元）。於報告期末，本集團並無重大或然負債，而本集團之資產並無作任何抵押。

員工聘用

本集團於二零二四年三月三十一日之聘用員工總數為67人（二零二三年：75人）。僱員薪酬一般參考市場條款及個別資歷而釐定。薪金及工資一般按表現及其他相關因素而作每年檢討。

Currently, Mr. Lan is the chairman of The Hong Kong Tuberculosis, Chest and Heart Diseases Association, the chairman of the Hospital Governing Committee of Grantham Hospital, a member of the Hospital Governing Committees of Ruttonjee Hospital and Tang Shiu Kin Hospital, and a member of the management committee of Freni Care and Attention Home. He is a graduate of The University of Hong Kong and a fellow of The Chartered Insurance Institute. Mr. Lan has extensive experience in the insurance industry with intensive involvement in corporate development.

Mr. CHEUNG Wing Choi, aged 69, has been an independent non-executive director of the Company since August 2016. Mr. Cheung holds a Bachelor of Commerce degree and a Postgraduate Diploma in Information Processing from University of Queensland in Australia. He is a fellow member of the Hong Kong Institute of Certified Public Accountants, an associate member of the Chartered Institute of Management Accountants in the United Kingdom and a Chartered Global Management Accountant. He has over 30 years of professional and commercial experience both in Hong Kong and Australia. He is also an independent non-executive director of FSMHL.

Mr. WONG, Louis Chung Yin, aged 42, has been an independent non-executive director of the Company since August 2020. Mr. Wong holds a Bachelor of Commerce degree from Macquarie University in Australia. He has numerous years of experience in investment and management of trading, retailing and food and beverage businesses, as well as marketing experience in retailing and wholesaling of high-end products.

Senior Management

Ms. NG Ching Mei, aged 49, is the financial controller and company secretary of the Company. Ms. Ng holds a bachelor's degree of Business Administration in Accounting and Finance from the University of Hong Kong and is a fellow member of the Hong Kong Institute of Certified Public Accountants. She has extensive experience in the field of auditing, accounting and financial management. Prior to joining the Company, she had worked for several publicly listed companies and multinational corporations.

In the year under review, sales to the Group's five largest customers accounted for approximately 34% of the Group's total sales for the year and the sale to the largest customer included therein amounted to approximately 23%. Purchases from the Group's five largest suppliers accounted for approximately 62% of the total purchases for the year and purchases from the largest supplier included therein amounted to approximately 31%.

None of the directors of the Company or any of their associates or any shareholders (which, to the best knowledge of the directors, own more than 5% of the Company's total number of issued shares) had any beneficial interest in the Group's five largest customers and suppliers.

PURCHASE, SALES OR REDEMPTION OF LISTED SECURITIES OF THE COMPANY

Neither the Company, nor any of its subsidiaries purchased, sold or redeemed any of the Company's listed securities during the year.

CONTINUING CONNECTED TRANSACTIONS

During the year under review, the Group had the following continuing connected transactions, certain details of which are disclosed in compliance with the requirements of Chapter 14A of the Listing Rules.

The following continuing connected transactions are exempt from the independent shareholders' approval requirement under Rule 14A of the Listing Rules, and the respective amount has not exceeded the relevant annual cap as disclosed in the announcement dated 25 March 2021 and 7 December 2021.

Purchase of premium beef, beef products and other meat products

On 21 September 2018, the Company entered into a master supply agreement (the "2018 Master Supply Agreement") with Kamichiku Holdings Co., Ltd. (the "Supplier") for the Group's purchase of premium beef and beef products from the Supplier and/or its subsidiaries. The second master supply agreement (the "2021 Master Supply Agreement") was entered by the Company with the Supplier for a period of three financial years ending 31 March 2024 on 25 March 2021 in respect of the expiry of the 2018 Master Supply Agreement. A supplemental agreement ("the Supplemental Agreement") was entered by the Company with the Supplier on 7 December 2021 to revise the annual cap to meet the increase in both sales volume and estimate future sales volume. The 2021 Master Supply Agreement was expired on 31 March 2024 and the third master supply agreement (the "2024 Master Supply Agreement") was entered on 19 March 2024 by the Company with the Supplier for a period of three financial years ending 31 March 2027.

As the Supplier is interested in 40% of FS-Kamichiku Company Limited, a 60% held non-wholly owned subsidiary of the Group, the Supplier is a connected person at the subsidiary level of the Company and the entering into of the master supply agreements and the supplemental agreement constitutes continuing connected transactions for the Company under the Listing Rules. Details of the continuing connected transaction were disclosed in the announcement dated 21 September 2018, 25 March 2021, 7 December 2021 and 19 March 2024.

於二零一八年九月二十一日，本公司與Kamichiku Holdings Co., Ltd.（「供應商」）訂立主要供應協議（「二零一八年主要供應協議」），內容有關本集團向供應商及／或其附屬公司採購優質牛肉及牛肉產品。於二零二一年三月二十五日，本公司與供應商訂立第二份主要供應協議（「二零二一年主要供應協議」），為期三個財政年度至截至二零二四年三月三十一日止，以應對二零一八年主要供應協議到期屆滿。於二零二一年十二月七日，本公司與供應商訂立補充協議（「補充協議」）以修訂年度上限以應付銷量及估計未來銷售之增加。二零二一年主要供應協議於二零二四年三月三十一日屆滿，於二零二四年三月十九日，本公司與供應商訂立第三份主要供應協議（「二零二四年主要供應協議」），為期三個財政年度至截至二零二七年三月三十一日止。

由於供應商持有一間本集團擁有60%的非全資附屬公司FS-Kamichiku Company Limited之40%權益，因此供應商為本公司附屬公司層面的關連人士，根據上市規則，訂立主要供應協議及補充協議構成本公司之持續關連交易。有關持續關連交易之詳情已於日期為二零一八年九月二十一日、二零二一年三月二十五日、二零二一年十二月七日及二零二四年三月十九日之公告披露。

For the year ended 31 March 2024, the amount paid by the Group to the Supplier for the purchase of premium beef and beef products was approximately HK\$14,680,000 which did not exceed the annual cap for 2024 of HK\$50 million.

The independent non-executive directors of the Company have reviewed the continuing connected transactions in relation to the purchases of premium beef and beef products set out above and have confirmed that these continuing connected transactions were entered into (i) in the ordinary and usual course of business of the Group; (ii) on normal commercial terms or better; and (iii) according to the agreement governing them on terms that are fair and reasonable and in the interests of the Company's shareholders as a whole.

Ernst & Young, the Company's auditors, were engaged to report on the Group's continuing connected transactions for the year ended 31 March 2024 in accordance with Hong Kong Standard on Assurance Engagements 3000 (Revised) Assurance Engagements Other Than Audits or Reviews of Historical Financial Information and with reference to Practice Note 740 *Auditor's Letter on Continuing Connected Transactions under the Hong Kong Listing Rules* issued by the Hong Kong Institute of Certified Public Accountants. Ernst & Young have issued their unqualified letter containing their findings and conclusions in respect of the continuing connected transactions disclosed above by the Group in accordance with Rule 14A.56 of the Listing Rules.

Save as disclosed above, other significant related party transactions entered into by the Group during the year ended 31 March 2024 set out in the note 29 to the financial statements included transactions that constitute continuing connected transactions and are fully exempt from shareholders' approval, annual review and disclosure requirements under Chapter 14A of the Listing Rules.

SUFFICIENCY OF PUBLIC FLOAT

Based on information that is publicly available to the Company and within the knowledge of the directors, at least 25% of the Company's total number of issued shares were held by the public as at the date of this report.

The Company’s corporate governance policies and practices are applied and implemented in the manners as stated in the below Corporate Governance Report.

CORPORATE PURPOSE, CULTURE AND VALUES

Our corporate culture is built around our dedication to providing delicious, nutritious and hygienic food to the general public. We always regard food hygiene, safety and quality as our top priority. It is consistent and aligned with the Company’s purpose to be a leading corporation in the food industry and its values of acting lawfully, ethically and responsibly across all levels of the Company.

To achieve the corporate purpose and sustainable long-term success, the Board adopted and implemented a corporate strategy with a view to maintain its leading position in the food industry by sourcing delicacies from all over the world, delivery of high-quality products and services, efficient use of resources, and continuous learning, improvement and innovation.

The Board believes these corporate values are embedded throughout all levels of the Company. By so acting, the Board believes that shareholders’ wealth will be maximised in the long term and that its employees, those with whom it does business and the communities in which it operates will all be benefited.

CORPORATE GOVERNANCE PRACTICES

The Company and the management are committed to maintaining good corporate governance with an emphasis on the principles of transparency, accountability and independence to all shareholders of the Company. The Company believes that good corporate governance is essential to continuous growth and enhancement of shareholders’ value. The Company periodically reviews its corporate governance practices with reference to the latest development of corporate governance. Throughout the year under review, the Company has applied the principles of and complied with the code provisions of the Corporate Governance Code (the “CG Code”) as set out in Appendix C1 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”), details are set out below.

The role of the Board is to set up strategic goals, performance objectives and operational policies; establish a framework of prudent and effective controls which enables risk (including but not limited to business, operation as well as environmental, social and governance (“ESG”) risks) to be assessed and managed; delegate authorities to the management to manage and supervise the business of the Group; and ensure the management monitor performance against objectives being set.

The Company has formalised a written guideline for the division of responsibilities between the Board and the management. Certain responsibilities or functions have been delegated by the Board to the management which include the day-to-day business operation of the Group, execution of corporate strategies, approval of business and financial plans and budgets and preparation of annual and interim financial statements. The Board has reserved for its decision matters of the Group covering the approval of significant changes in accounting or capital structure; approval of public announcements and the financial statements; approval of major acquisitions, disposals and major capital projects; approval of material borrowings and any issuing or buying back of equity securities; and approval of the annual budget and setting of the dividend policy.

All directors have full and timely access to all the information of the Company and may, upon request, seek independent professional advice in appropriate circumstances, at the Company’s expense, for discharging their duties to the Company.

The Company has established mechanisms which will ensure that there are channels (in addition to independent non-executive directors of the Company) where independent views are available, including the access by directors of the Company to external independent professional advice to assist their performance of duties.

Directors’ and Officers’ Insurance

The Company has taken out appropriate insurance cover for the Directors in respect of legal actions taken against the directors arising out of corporate activities.

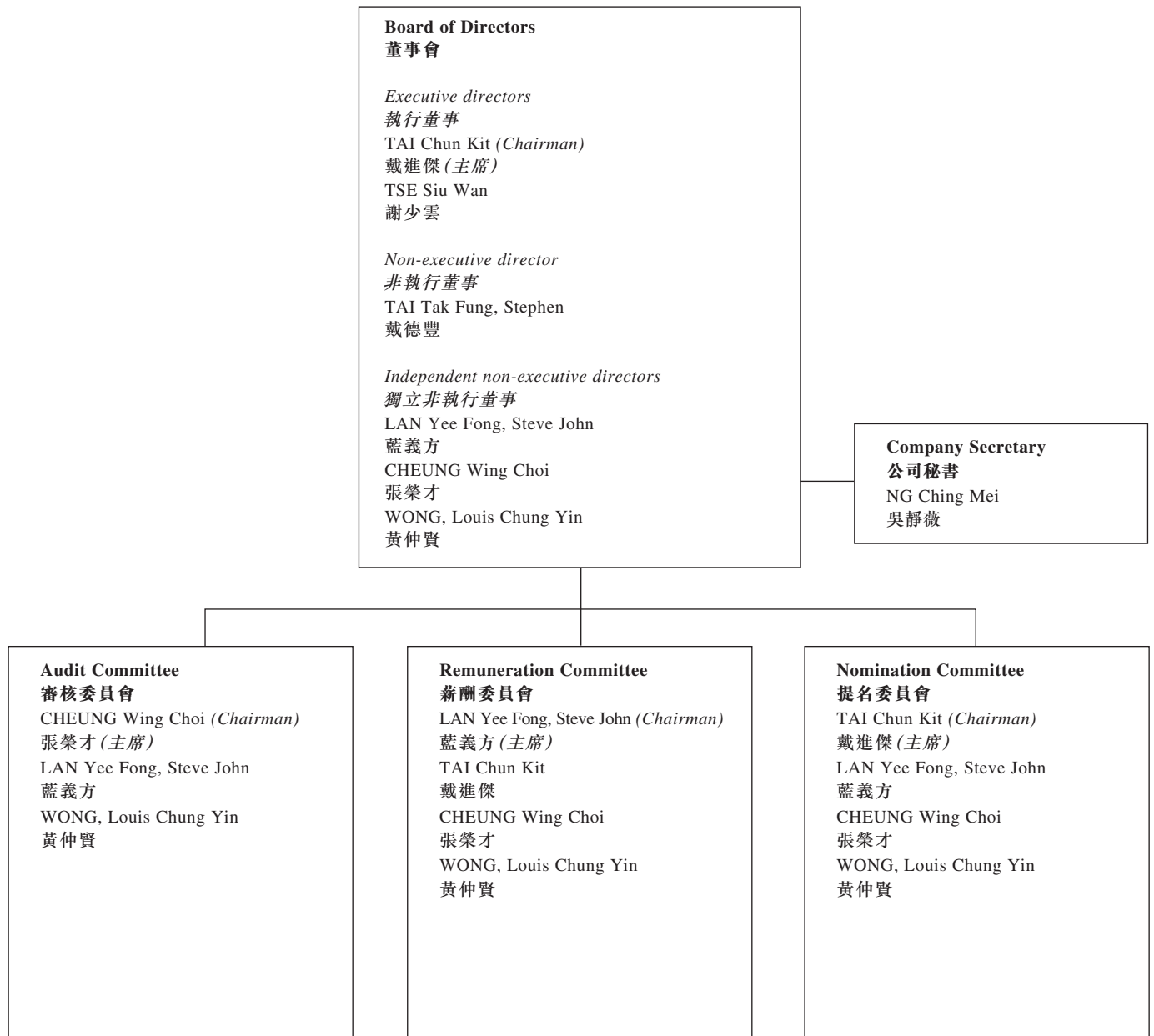

If a substantial shareholder or a director has a conflict of interest in a matter to be considered material by the Board, the matter will be dealt with in accordance with applicable rules and regulations and, if appropriate, an independent Board committee will be set up to deal with the matter.

Directors' Appointment and Re-election

The Board is empowered under the articles of association of the Company (the "Articles of Association") from time to time and at any time to appoint any person as a director either to fill a casual vacancy or as an addition to the Board. Appointments are first considered by the Nomination Committee and recommendations of the Nomination Committee are then put to the Board for decision. Details in respect of the process and criteria for the Nomination Committee to select and recommend candidates for directorship are provided in the section headed "Nomination Committee" in this Corporate Governance Report.

In accordance with the Articles of Association, one-third of the directors for the time being or, if their number is not three or a multiple of three, then the number nearest one-third but not less than one-third, shall retire from office by rotation and re-election by shareholders at the annual general meeting of the Company, such that every director is subject to retirement by rotation at least once every three years.

Directors' Continuous Professional Development

Each newly appointed director receives a comprehensive, formal and tailored induction on the first occasion of his/her appointment to ensure proper understanding of the operations and business of the Company and full awareness of director's responsibilities and obligations under the Listing Rules and relevant regulatory requirements.

根據組織章程細則，於本公司股東周年大會，當時三分之一之董事，或倘其數目並非三或三之倍數，則以最接近三分之一但不少於三分之一之人數為準，須輪值告退及由股東膺選連任，而每名董事均須最少每三年輪值告退一次。

The primary duties of the Audit Committee are to review and supervise the financial reporting system and the risk management and internal control systems of the Group, to monitor the integrity of the Company's financial statements and review significant financial reporting judgements, to maintain an appropriate relationship with the Company's external auditor and to oversee the audit process.

The Audit Committee has held two meetings during the year ended 31 March 2024 to review the accounting principles and practices adopted by the Group and discuss internal controls and financial reporting matters including a review of the interim financial statements for the six months ended 30 September 2023 and the annual financial statements for the year ended 31 March 2023 of the Group. The Audit Committee has also reviewed the annual results for the year ended 31 March 2024 of the Group.

The company secretary of the Company shall call a meeting of the Nomination Committee. The Nomination Committee shall make recommendations for the Board’s consideration and approval. The ultimate responsibility for selection and appointment of Directors rests with the entire Board.

The Nomination Committee will review the Nomination Policy, at any time as appropriate or at least annually, to ensure the effectiveness of the Nomination Policy. The Nomination Committee will discuss any revisions that may be required, and recommend any such revisions to the Board for consideration and approval.

Board Diversity Policy

The Company considers increasing diversity at the Board level as an essential element in maintaining a competitive advantage. The Company has adopted a Board diversity policy (the “Diversity Policy”) which sets out the approach to achieve diversity in the Board of the Company. The Board is also responsible for presenting a balanced, clear and understandable assessment of both annual and interim reports, inside information announcements and other disclosures required under the Listing Rules and other regulatory requirements.

The responsibilities of the Company's external auditor, Messrs. Ernst & Young ("EY"), are set out in the Independent Auditor's Report of this Annual Report.

The directors are not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

External Auditor's Remuneration

EY have been re-appointed as the Company's external auditor by shareholders at the 2023 annual general meeting until the conclusion of the next annual general meeting. They are primarily responsible for providing audit services in connection with the financial statements of the Company for the year ended 31 March 2024.

For the year ended 31 March 2024, fees paid or payable to EY amounted to approximately HK\$1,620,000 (2023: HK\$1,700,000) for audit and related services and approximately HK\$174,000 (2023: HK\$192,500) for other non-audit services which include the taxation services.

RISK MANAGEMENT AND INTERNAL CONTROLS**Compliance with Risk Management and Internal Control Code Provisions**

The Board acknowledges its overall responsibilities for maintaining adequate risk management and internal control systems to safeguard shareholders' investments and the Group's assets and reviewing their effectiveness. The systems, including the strategies, policies and expectations on the oversight, have been designed to manage rather than to eliminate the risk of failure in achieving the Group's business objectives. Therefore, it can only provide reasonable but not absolute assurance against material misstatement, loss or fraud.

Risk management and internal control systems are designed and put in place with a view to safeguard the Group's assets and business operations. In order to successfully implement, support and sustain the risk management process, the Group has taken into account the factors including risk-aware culture, risk prioritisation, as well as allocation of roles and responsibilities. The systems are featured with defined organisational and management structure with authorities properly delegated to qualified personnel from different management levels within the Group.

Executive directors of the Company determine the business strategies and objectives of the Group, and evaluate and determine the nature and extent of risks (including but not limited to business, operation as well as ESG risks) the Group is willing to take in achieving the Group's strategic objectives and therefore are accountable for the effectiveness of the risk management.

Senior management from different departments identifies and evaluates the risks (including but not limited to business, operation as well as ESG risks) which may potentially impact the major business processes, including key operational and financial processes, regulatory compliance and information security, monitors the risks and takes measures to mitigate risks in daily operations.

Periodic meetings are held between the delegated executive directors and senior management. Standing instructions have been provided to management of the Group that if any material issue relating to risk management and internal control systems that may have or have had a material impact on the business of the Group arise, it should be reported on a timely basis.

Internal control procedures are designed to protect the Group's assets against misappropriation and disposition; ensure proper maintenance of accounting records for provision of reliable financial information used for business decision or publication; and to provide reasonable assurance against material misstatement. The internal audit function reviews the major operational, financial and compliance controls and risk management function on a continuing basis to cover the major operations of the Group.

The delegated executive directors and senior management have reported to the Board the effectiveness of the risk management and internal control systems for the year under review. The Board has reviewed the effectiveness of the systems including the adequacy of resources, staff qualifications and experience of the Group's accounting and financial reporting functions and considers that the risk management and internal control systems of the Group are effective and adequate.

Disclosure of Inside Information

The Company has developed its disclosure policy which provides a general guide to the Company's directors, officers, senior management and relevant employees in handling inside information, monitoring information disclosure and responding to enquiries.

OPINION

We have audited the consolidated financial statements of Hong Kong Food Investment Holdings Limited (the "Company") and its subsidiaries (the "Group") set out on pages 52 to 139, which comprise the consolidated statement of financial position as at 31 March 2024, and the consolidated statement of profit or loss, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including material accounting policy information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 March 2024, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the Hong Kong Companies Ordinance.

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the HKICPA. Our responsibilities under those standards are further described in the *Auditor's responsibilities for the audit of the consolidated financial statements* section of our report. We are independent of the Group in accordance with the HKICPA's *Code of Ethics for Professional Accountants* (the "Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

意見

我們已審計列載於第52頁至第139頁的香港食品投資控股有限公司(「貴公司」)及其附屬公司(「貴集團」)的綜合財務報表，此綜合財務報表包括二零二四年三月三十一日的綜合財務狀況表與截至該日止年度的綜合損益表、綜合全面收益表、綜合權益變動表及綜合現金流量表，以及綜合財務報告附註，包括重大會計政策資料。

我們認為，該等綜合財務報表已根據香港會計師公會(「香港會計師公會」)頒佈的香港財務報告準則(「香港財務報告準則」)真實而中肯地反映了貴集團於二零二四年三月三十一日的綜合財務狀況及截至該日止年度的綜合財務表現及綜合現金流量，並已遵照香港公司條例妥為擬備。

Accordingly, our audit included the performance of procedures designed to respond to our assessment of the risks of material misstatement of the consolidated financial statements. The results of our audit procedures, including the procedures performed to address the matters below, provide the basis for our audit opinion on the accompanying consolidated financial statements.

2. ACCOUNTING POLICIES

2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") and the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for financial assets at fair value through profit or loss and an investment property which have been measured at fair value. These financial statements are presented in Hong Kong dollars ("HK\$") and all values are rounded to the nearest thousand except when otherwise indicated.

Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 March 2024. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

Generally, there is a presumption that a majority of voting rights results in control. When the Company has less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

2. 會計政策

2.1 編製基準

本財務報表乃根據由香港會計師公會(「香港會計師公會」)頒佈之香港財務報告準則(「香港財務報告準則」)(包括所有香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋)及香港公司條例予以編製。除按公平值透過損益入賬的金融資產及投資物業已按公平值計量外,本財務報表乃以歷史成本法編製。本財務報表以港幣(「港幣」)呈列,除另有註明者外,所有數值均四捨五入至最接近千位數。

綜合賬目基準

綜合財務報表包括本公司及其附屬公司(以下統稱「本集團」)截至二零二四年三月三十一日止年度的財務報表。附屬公司為本公司直接或間接控制的實體(包括結構性實體)。當本集團通過參與投資對象的活動而承受浮動回報之風險或享有獲得浮動回報之權利,並能透過於投資對象之權力(即賦予本集團現有有能力指引投資對象相關活動之既存權利)影響該等回報時,即取得控制權。

一般而言,假定擁有大多數投票權即擁有控制權。倘本公司擁有少於大多數的投資對象投票或類似權利,則本集團於評估其是否擁有對投資對象之權力時會考慮一切相關事實及情況,包括:

- (a) 與投資對象其他投票持有人的合約安排;
- (b) 其他合約安排所產生的權利;及
- (c) 本集團的投票權及潛在投票權。

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises the related assets (including goodwill), liabilities, any non-controlling interest and the exchange fluctuation reserve; and recognises the fair value of any investment retained and any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

損益及其他全面收益的各組成部分會歸屬於本公司擁有人及非控股權益，即使此舉引致非控股權益結餘為負數。本集團內部各公司之間的所有資產及負債、權益、收入、開支及現金流量於綜合賬目時全數抵銷。

倘有事實及情況顯示上文所述之三項控制權要素有一項或多項出現變動，則本集團會重新評估其是否對被投資方擁有控制權。於附屬公司擁有權益之變動而並無失去控制權，於入賬時列作權益交易。

倘本集團失去對一間附屬公司之控制權，則其終止確認相關資產(包括商譽)、負債、任何非控股權益及匯兌波動儲備；以及確認所保留任何投資之公平值及損益中任何因此產生之盈餘或虧絀。先前於其他全面收益表內確認之本集團應佔部分按與假設本集團直接出售相關資產或負債所須採用之相同基準，在適當情況下重新分類至損益或保留溢利。

Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. Amendments to HKFRS Practice Statement 2 *Making Materiality Judgements* provide non-mandatory guidance on how to apply the concept of materiality to accounting policy disclosures. The Group has disclosed the material accounting policy information in note 2.4 to the financial statements. The amendments did not have any impact on the measurement, recognition or presentation of any items in the Group's financial statements.
- (b) Amendments to HKAS 8 clarify the distinction between changes in accounting estimates and changes in accounting policies. Accounting estimates are defined as monetary amounts in financial statements that are subject to measurement uncertainty. The amendments also clarify how entities use measurement techniques and inputs to develop accounting estimates. Since the Group's approach and policy align with the amendments, the amendments had no impact on the Group's financial statements.

- (c) Amendments to HKAS 12 *Deferred Tax related to Assets and Liabilities arising from a Single Transaction* narrow the scope of the initial recognition exception in HKAS 12 so that it no longer applies to transactions that give rise to equal taxable and deductible temporary differences, such as leases and decommissioning obligations. Therefore, entities are required to recognise a deferred tax asset (provided that sufficient taxable profit is available) and a deferred tax liability for temporary differences arising from these transactions.

Prior to the initial application of these amendments, the Group applied the initial recognition exception and did not recognise a deferred tax asset and a deferred tax liability for temporary differences for transactions related to leases. The Group has applied the amendments on temporary differences related to leases as at 1 April 2022. Upon initial application of these amendments, the Group recognised (i) a deferred tax asset for all deductible temporary differences associated with lease liabilities (provided that sufficient taxable profit is available), and (ii) a deferred tax liability for all taxable temporary differences associated with right-of-use assets at 1 April 2022.

Upon the application of the amendments, the Group has determined the temporary differences arising from right-of-use assets and lease liabilities separately, which have been reflected in the recognition disclosed in note 25 of the financial statements. However, they did not have any material impact on the overall deferred tax balances presented in the consolidated statement of financial position as the related deferred tax balances qualified for offsetting under HKAS 12.

- (d) Amendments to HKAS 12 *Internal International Tax Reform – Pillar Two Model Rules* introduce a mandatory temporary exception from the recognition and disclosure of deferred taxes arising from the implementation of the Pillar Two model rules published by the Organisation for Economic Co-operation and Development. The amendments also introduce disclosure requirements for the affected entities to help users of the financial statements better understand the entities' exposure to Pillar Two income taxes, including the disclosure of current tax related to Pillar Two income taxes separately in the periods when Pillar Two legislation is effective and the disclosure of known or reasonably estimable information of their exposure to Pillar Two income taxes in periods in which the legislation is enacted or substantively enacted but not yet in effect. The Group has applied the amendments retrospectively. Since the Group did not fall within the scope of the Pillar Two model rules, the amendments did not have any impact to the Group.

於首次應用該等修訂本之前，本集團應用初始確認例外情況，並無就租賃相關交易產生的臨時差額確認遞延稅項資產及遞延稅項負債。本集團已於二零二二年四月一日應用有關租賃的臨時差額的修訂。於初始應用該等修訂本後，本集團已(i)就租賃負債相關的所有可扣減臨時差額確認遞延稅項資產(惟須具備充足應課稅溢利)；及(ii)就於二零二二年四月一日的使用權資產相關的所有應課稅臨時差額確認遞延稅項負債。

於應用該等修訂本後，本集團已分別確認使用權資產及租賃負債產生之臨時差額，並已於財務報表附註25所披露的確認中反映。然而，由於綜合財務狀況表所呈列的整體遞延稅項結餘根據香港會計準則第12號合資格進行抵銷，因此該等修訂本對相關遞延稅項結餘並無任何重大影響。

2.3 ISSUED BUT NOT YET EFFECTIVE HONG KONG FINANCIAL REPORTING STANDARDS (continued)

Amendments to HKFRS 10 and HKAS 28 address an inconsistency between the requirements in HKFRS 10 and in HKAS 28 in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss resulting from a downstream transaction when the sale or contribution of assets constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to HKFRS 10 and HKAS 28 was removed by the HKICPA. However, the amendments are available for adoption now.

Amendments to HKFRS 16 specify the requirements that a seller-lessee uses in measuring the lease liability arising in a sale and leaseback transaction to ensure the seller-lessee does not recognise any amount of the gain or loss that relates to the right of use it retains. The amendments are effective for annual periods beginning on or after 1 January 2024 and shall be applied retrospectively to sale and leaseback transactions entered into after the date of initial application of HKFRS 16 (i.e., 1 January 2019). Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

The 2020 Amendments clarify the requirements for classifying liabilities as current or non-current, including what is meant by a right to defer settlement and that a right to defer must exist at the end of the reporting period. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement. The amendments also clarify that a liability can be settled in its own equity instruments, and that only if a conversion option in a convertible liability is itself accounted for as an equity instrument would the terms of a liability not impact its classification. The 2022 Amendments further clarify that, among covenants of a liability arising from a loan arrangement, only those with which an entity must comply on or before the reporting date affect the classification of that liability as current or non-current. Additional disclosures are required for non-current liabilities that are subject to the entity complying with future covenants within 12 months after the reporting period. The amendments shall be applied retrospectively with early application permitted. An entity that applies the 2020 Amendments early is required to apply simultaneously the 2022 Amendments, and vice versa. The Group is currently assessing the impact of the amendments and whether existing loan agreements may require revision. Based on a preliminary assessment, the amendments are not expected to have any significant impact on the Group's financial statements.

香港財務報告準則第10號及香港會計準則第28號(修訂本)針對香港財務報告準則第10號及香港會計準則第28號之間有關投資者與其聯營公司或合營企業之間之資產出售或注資兩者規定之不一致。該修訂規定，當資產出售或注資構成一項業務時，須全數確認下游交易產生的收益或虧損。當交易涉及資產不構成一項業務時，由該交易產生之收益或虧損於該投資者之損益內確認，惟僅以不相關投資者於該聯營公司或合營企業之權益為限。該等修訂將按前瞻基準應用。香港會計師公會取消了之前香港財務報告準則第10號和香港會計準則第28號(修訂本)的強制生效日期。然而，該等修訂可供現時採納。

香港財務報告準則第16號之修訂本訂明計量售後回租交易產生的租賃負債所用的賣方-承租人之規定，以確保賣方-承租人不曾確認與所保留使用權有關的任何損益金額。修訂本於二零二四年一月一日或之後開始之年度期間生效，並須追溯應用至於初始應用香港財務報告準則第16號之日期(即二零一九年一月一日)後訂立之售後回租交易，亦可提早應用。預期修訂本對本集團的財務報表並無任何重大影響。

二零二零年修訂本澄清將負債分類為流動或非流動的規定，包括延遲清償權利的含義，以及報告期末必須存在延遲權利。負債的分類不受該實體行使權利延遲清償的可能性所影響。該等修訂亦澄清，負債可以用其自身的股權工具進行結算，僅於可轉債的轉換權本身作為股權工具入賬時，負債的條款方不會影響其分類。二零二二年修訂進一步澄清，於貸款安排所產生的負債契約中，僅實體於報告日期或之前須遵守的契約方會影響負債分類為流動或非流動。對於實體於報告期後12個月內須遵守未來契約的非流動負債，須對有關負債作出額外披露。該等修訂應追溯應用。允許提早應用。提前應用二零二零年修訂的實體須同時應用二零二二年修訂，反之亦然。本集團現正評估該等修訂的影響以及是否需要修訂現有貸款協議。根據初步評估，該等修訂預期不會對本集團的財務報表產生任何重大影響。

2.3 ISSUED BUT NOT YET EFFECTIVE HONG KONG FINANCIAL REPORTING STANDARDS (continued)

Amendments to HKAS 7 and HKFRS 7 clarify the characteristics of supplier finance arrangements and require additional disclosure of such arrangements. The disclosure requirements in the amendments are intended to assist users of financial statements in understanding the effects of supplier finance arrangements on an entity's liabilities, cash flows and exposure to liquidity risk. Earlier application of the amendments is permitted. The amendments provide certain transition reliefs regarding comparative information, quantitative information as at the beginning of the annual reporting period and interim disclosures. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to HKAS 21 specify how an entity shall assess whether a currency is exchangeable into another currency and how it shall estimate a spot exchange rate at a measurement date when exchangeability is lacking. The amendments require disclosures of information that enable users of financial statements to understand the impact of a currency not being exchangeable. Earlier application is permitted. When applying the amendments, an entity cannot restate comparative information. Any cumulative effect of initially applying the amendments shall be recognised as an adjustment to the opening balance of retained profits or to the cumulative amount of translation differences accumulated in a separate component of equity, where appropriate, at the date of initial application. The amendments are not expected to have any significant impact on the Group's financial statements.

2.3 已頒佈但尚未生效之香港財務報告準則 (續)

香港會計準則第7號及香港財務報告準則第7號修訂本澄清供應商融資安排的特點，並規定須就該等安排作出額外披露。該等修訂的披露規定旨在幫助財務報表的使用者了解供應商融資安排對實體的負債、現金流量及流動資金風險的影響。允許提早應用該等修訂。該等修訂就比較資料、年報期開始時的定量信息及中期披露提供若干過渡豁免。該等修訂預期不會對本集團的財務報表產生任何重大影響。

香港會計準則第21號修訂本訂明實體應如何評估某種貨幣可否兌換為另一種貨幣，以及在缺乏可兌換性的情況下，實體應如何估計計量日期的即期匯率。該等修訂要求披露信息，使財務報表使用者了解貨幣不可兌換的影響。允許提早應用。在應用該等修訂時，實體不得重列比較資料。首次應用該等修訂的任何累計影響應在首次應用之日確認為對保留溢利期初餘額的調整或於權益單獨組成部分的累計折算差額的調整(如適用)。該等修訂預期不會對本集團的財務報表產生任何重大影響。

2.4 MATERIAL ACCOUNTING POLICIES

Investments in associates

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

The Group's investments in associates are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. Adjustments are made to bring into line any dissimilar accounting policies that may exist. The Group's share of the post-acquisition results and other comprehensive income of associates is included in the consolidated statement of profit or loss and consolidated other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associates are eliminated to the extent of the Group's investments in the associates, except where unrealised losses provide evidence of an impairment of the asset transferred. Goodwill arising from the acquisition of associates is included as part of the Group's investments in associates.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

2.4 重大會計政策

於聯營公司之投資

聯營公司乃本集團長期持有其權益投票權一般不少於20%及足以對有重大影響力之實體。重大影響力指參與投資對象財政及經營決策的權力，但非控制或聯合控制該等政策。

本集團於聯營公司之投資按本集團應佔之資產淨額按權益法計算減去任何減值損失，列入本集團綜合財務狀況表內。任何可能存在的相異會計政策已作出相應調整使之貫徹一致。本集團應佔聯營公司之收購後業績及其他全面收益分別計入綜合損益表及綜合其他全面收益。此外，當於聯營公司之股權直接確認變動時，本集團於綜合權益變動表確認其應佔之任何變動（倘適用）。本集團與其聯營公司進行之交易產生之未變現收益及虧損，以本集團於聯營公司之投資為限予以撇銷，惟倘未變現虧損提供已轉讓資產之減值證據則除外。收購聯營公司產生之商譽乃計入為本集團於聯營公司之部份投資。

倘對聯營公司的投資成為對合營公司的投資，或對合營公司的投資成為對聯營公司的投資，則不會重新計量保留權益，而是繼續按權益法將投資列賬。在所有其他情況下，若本集團失去對聯營公司的重大影響力或合營公司的共同控制權，會按公平值計量及確認保留投資。失去對聯營公司的重大影響力或對合營公司的共同控制權時聯營公司或合營公司的賬面值與保留投資公平值及出售所得款項之間的差額於損益確認。

業務合併及商譽

業務合併乃以購買法入賬。轉讓之代價乃以收購日期的公平值計算，該公平值為本集團轉讓的資產於收購日期的公平值、本集團自被收購方之前度擁有人承擔的負債，及本集團發行以換取被收購方控制權的股本權益的總和。於各業務合併中，本集團選擇按公平值或按依據比例分佔之被收購方可識別資產淨值，計量於被收購方之非控股權益。非控股權益之所有其他部份按公平值計量。收購成本於產生時列為開支。

Business combinations and goodwill (continued)

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts by the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability that is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 March. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

2.4 重大會計政策(續)

業務合併及商譽(續)

當所收購的一組活動及資產包括一項投入及一項實質過程，而兩者對創造產出的能力具重大貢獻，則本集團認為其已收購一項業務。

當本集團收購一項業務時，會根據合約條款、於收購日期的經濟環境及相關條件，評估將承接的金融資產及負債，以作出適合的分類及標示，其中包括將被收購方主合約中的嵌入式衍生工具進行分離。

倘業務合併分階段進行，收購方先前持有的被收購方股權於收購日期的公平值應按收購日期的公平值透過損益重新計量。

由收購方將予轉讓的任何或然代價將於收購日期按公平值確認。歸類為資產或負債的或然代價按公平值計量，公平值的變動於損益確認。歸類為權益之或然代價毋須重新計量。其後結算在權益中入賬。

商譽起初按成本計量，即已轉讓總代價、已確認非控股權益及本集團先前由持有的被收購方股權的公平值總額，超逾與所收購可識別資產淨值及所承擔負債的差額。如總代價及其他項目低於所收購資產淨值的公平值，於評估後其差額將於損益內確認為議價收購收益。

於初始確認後，商譽按成本減任何累計減值虧損計量。商譽每年須作減值測試，但倘有事件或情況變動而顯示賬面值可能有損，則須更頻密地作減值測試。本集團會於每年三月三十一日進行減值測試。為了進行減值測試，因業務合併而購入的商譽自購入之日被分配至預期可從合併產生的協同效益中獲益的本集團各個現金產生單位或現金產生單位組別，而無論本集團其他資產或負債是否已分配予該等單位或單位組別。

2.4 MATERIAL ACCOUNTING POLICIES (continued)**Business combinations and goodwill (continued)**

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

Fair value measurement

The Group measures its investment property, equity investments and club debenture at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

2.4 重大會計政策 (續)**業務合併及商譽 (續)**

減值乃透過評估與商譽有關的現金產生單元(或現金產生單元之組別)的可收回金額而確定。倘現金產生單元(或現金產生單元之組別)的可收回金額少於其賬面值,則應確認減值虧損。因商譽而確認的減值損失不應在期後撥回。

當商譽構成一個現金產生單元(或現金產生單元之組別)的一部份而該單元的某部份業務被出售,並在決定出售業務的損益時,與出售業務相關的商譽將包括在該業務的賬面值內。在此情況下出售的商譽將以出售業務和現金產生單元的保留部份的相對價值為基礎作計量。

公平值計量

本集團於各報告期末按公平值計量其投資物業、權益投資及會所債券。公平值為市場參與者於計量日期在有序交易中出售資產所收取的價格或轉讓負債所支付的價格。公平值計量乃根據假設出售資產或轉讓負債的交易於資產或負債主要市場或(在無主要市場情況下)最具優勢市場進行而作出。主要及最具優勢市場須為本集團可進入之市場。資產或負債的公平值乃按假設市場參與者於資產或負債定價時會以最佳經濟利益行事計量。

非金融資產的公平值計量須計及市場參與者能自最大限度使用該資產達致最佳用途,或將該資產出售予將最大限度使用該資產達致最佳用途的其他市場參與者,所產生的經濟效益。

本集團採納適用於不同情況且具備充分數據以供計量公平值的估值方法,以儘量使用相關可觀察輸入數據及儘量減少使用不可觀察輸入數據。

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 – based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for non-financial asset is required (other than inventories, goodwill and an investment property), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

2.4 重大會計政策(續)**公平值計量(續)**

所有載於本財務報告計量或披露的資產及負債乃基於對公平值計量整體而言屬重大的最低層輸入數據按以下公平值架構分類：

- 第一級 – 基於相同資產或負債於活躍市場的報價(未經調整)
- 第二級 – 基於對公平值計量而言屬重大的可觀察(直接或間接)最低層輸入數據的估值技巧
- 第三級 – 基於對公平值計量而言屬重大的不可觀察最低層輸入數據的估值技巧

就按經常性基準於本財務報告確認的資產及負債而言，本集團透過於各報告期末重新評估分類(基於對公平值計量整體而言屬重大的最低層輸入數據)確定是否發生不同等級轉移。

非金融資產減值

倘有顯示出現減值，或當需要對非金融資產(存貨、商譽及投資物業除外)作每年減值測試，則須估計資產之可收回價值。資產之可收回價值按資產或現金產生單元之使用價值，以及其公平值減出售成本之較高者計算，並就各個別資產而釐訂，除非資產並未能在大致獨立於其他資產或組別資產之情況下賺取現金流入，在此情況下，須釐訂資產所屬的現金產生單位之可收回金額。對現金產生單位進行減值測試時，倘公司資產(如總部大樓)可按合理且一致的基準或其他基準被分配至最小的現金產生單位組合，則該公司資產之部分賬面值將被分配至個別現金產生單位。

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises.

Related parties

A party is considered to be related to the Group if:

- (a) the party is a person or a close member of that person's family and that person
 - (i) has control or joint control over the Group;
 - (ii) has significant influence over the Group; or
 - (iii) is a member of the key management personnel of the Group;
- or
- (b) the party is an entity where any of the following conditions applies:
 - (i) the entity and the Group are members of the same group;
 - (ii) one entity is an associate or joint venture of the other entity (or of a parent, subsidiary or fellow subsidiary of the other entity);

減值虧損只於資產之賬面值超過其可收回數額時確認。於評估使用價值時使用反映當時市場對貨幣時間值以及與資產相關的特定風險的除稅前貼現率貼現出估計未來現金流量之現值。減值虧損按該減值資產之功能所屬開支分類於其產生之期間在損益表中支銷。

於各報告期末，將評估是否有顯示之前確認之減值虧損已不會出現或可能已減少。倘出現有關顯示，則須估計可收回之金額。之前確認之資產（商譽除外）減值虧損只能於用以釐訂資產之可收回數額之估計出現變動始能撥回，惟該數額不得超過假設有關資產於過往年度並未有確認減值虧損而予以釐訂之賬面值（扣除任何折舊／攤銷）。該撥回之減值虧損乃於其產生之期間計入損益表。

Property, plant and equipment and depreciation

Property, plant and equipment are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

物業、廠房及設備及折舊

物業、廠房及設備乃按成本扣除累計折舊及任何減值虧損列賬。物業、廠房及設備之成本值包括其購入價及令資產達致符合預計用途之操作狀況及運到使用地點之任何直接應計費用。

在物業、廠房及設備項目投產後產生之開支，例如維修及保養，通常在產生之期間從損益表扣除。如滿足確認標準，大型檢修開支將當作更換進行資本化，列入資產之賬面值。在物業、廠房及設備之重要部份需要定期更換時，本集團會將這些部份作為具有特定可使用期限之個別資產進行確認，並將彼等相應折舊。

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Investment properties

Investment properties are interests in land and building (including right-of-use assets) held to earn rental income and/or for capital appreciation. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair value of investment properties are included in the consolidated statement of profit or loss in the year in which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in the statement of profit or loss in the year of the retirement or disposal.

倘物業、廠房及設備項目之各部份有不同之可使用年期，此項目各部份成本將按合理之基礎分配，而每部份將作個別折舊。餘值、可使用年期及折舊法乃最少於各財政年度完結時予以檢討，並在有需要時作出調整。

物業、廠房及設備項目及於初步確認之任何重要部份於出售或當預期不會從其使用或出售獲取未來經濟利益時不再確認。物業、廠房及設備出售或報廢所產生之收益或損失按售出淨額減去該等資產賬面淨值後之差額確認於本年度損益表中。

投資物業

投資物業為持作賺取租金收入及／或用作資本增值的於土地及樓宇的權益（包括使用權資產）。該等物業初步以成本（包括交易成本）計量。於初步確認後，投資物業乃按反映報告期間結束時的市場狀況的公平值列賬。

投資物業公平值變動產生的收益或虧損計入產生年度的綜合損益表。

報廢或出售投資物業的任何收益或虧損於報廢或出售年度的損益表確認。

2.4 MATERIAL ACCOUNTING POLICIES (continued)**Leases**

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

(a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Where applicable, the cost of a right-of-use asset also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

Buildings	2 – 3 years
Equipment	2 years

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

2.4 重大會計政策 (續)**租賃**

本集團於合約開始時評估合約是否為或包含租賃。倘合約為換取代價而給予在一段時間內控制可識別資產使用之權利，則該合約為或包含租賃。

本集團作為承租人

本集團對所有租賃(惟短期租賃及低價值資產租賃除外)採取單一確認及計量方法。本集團確認租賃負債以作出租賃付款，而使用權資產指使用相關資產之權利。

(a) 使用權資產

使用權資產於租賃開始日期(其為相關資產可供使用之日期)確認。使用權資產乃按成本減累計折舊及任何減值虧損計量，並就租賃負債之任何重新計量作出調整。使用權資產之成本包括已確認租賃負債金額、已產生初始直接成本及於開始日期或之前作出之租賃付款減任何已收取之租賃優惠。倘適用，使用權資產的成本亦包括清拆及移除相關資產或復原相關資產或其所處位置的估計成本。使用權資產於租賃期及資產估計可使用年期(以較短者為準)內按直線法折舊，詳情如下：

樓宇	2至3年
設備	2年

倘於租賃期結束時租賃資產之擁有權轉讓至本集團或成本反映購買權之行使，折舊則按資產之估計可使用年期計算。

2.4 MATERIAL ACCOUNTING POLICIES (continued)**Leases (continued)***Group as a lessee (continued)***(b) Lease liabilities**

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset. The Group's lease liabilities are separately presented in the consolidated statement of financial position.

Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in other income and gains, net in the statement of profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as other income and gains, net in the period in which they are earned.

2.4 重大會計政策 (續)**租賃 (續)***本集團作為承租人 (續)***(b) 租賃負債**

租賃負債於租賃開始日期按租賃期內作出的租賃付款之現值確認。租賃付款包括固定付款(包括實質固定付款)減任何應收租賃優惠、取決於某一指數或比率之浮動租賃付款以及預期根據剩餘價值擔保支付之金額。租賃付款亦包括本集團合理確定將予行使之購買選擇權之行使價,以及在租賃條款反映了本集團行使選擇權終止租賃之情況下因終止租賃而支付之罰款。並非取決於某一指數或比率之浮動租賃付款於觸發付款之事件或條件發生期間確認為開支。

於計算租賃付款之現值時,由於租賃中隱含之利率不易確定,本集團使用其於租賃開始日期之增量借貸利率。於開始日期後,租賃負債之金額會增加以反映利息之增長,並就所作出之租賃付款作出扣減。此外,倘存在修改、租賃期更改、租賃付款更改(即某一指數或比率發生變化而導致未來租賃付款更改)或購買相關資產之選擇權評估變更,則重新計量租賃負債之賬面值。本集團之租賃負債於綜合財務狀況表獨立呈列。

本集團作為出租人

當本集團擔任出租人,其於租賃開始時(或當出現租賃修改時)將其租賃各自分類為經營租賃或融資租賃。

本集團並未轉讓資產擁有權所附帶之絕大部分風險及回報之租賃會分類為經營租賃。倘合約包含租賃及非租賃部分,本集團根據相對獨立售價基準將合約代價分配至各部分。由於其營運性質使然,租金收入於租賃期內按直線法入賬並計入於損益表中之其他收入及收益,淨額內。於磋商及安排經營租賃時產生之初始直接成本會加至租賃資產之賬面值,並於租賃期內按相同基準確認為租金收入。或然租金乃於其賺取期間內確認為其他收入及收益,淨額。

2.4 MATERIAL ACCOUNTING POLICIES (continued)**Leases (continued)***Group as a lessor (continued)*

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee are accounted for as finance leases.

When the Group is an intermediate lessor, a sublease is classified as a finance lease or operating lease with reference to the right-of-use asset arising from the head lease. If the head lease is a short-term lease to which the Group applies the on-balance sheet recognition exemption, the Group classifies the sublease as an operating lease.

Investments and other financial assets*Initial recognition and measurement*

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

2.4 重大會計政策 (續)**租賃 (續)***本集團作為承租人 (續)*

相關資產擁有權所附帶之絕大部分風險及回報會轉移至承租人之租賃乃入賬為融資租賃。

當本集團為中間出租人時，分租會參考主租賃所產生之使用權資產分類為融資租賃或經營租賃。倘主租賃為短期租賃而其中本集團應用資產負債表確認豁免，本集團則會將分租分類為經營租賃。

投資及其他金融資產*初始確認及計量*

金融資產於初始確認時分類為其後按攤銷成本、按公平值透過其他全面收益入賬及按公平值透過損益入賬計量。

金融資產於初始確認時的分類視乎金融資產合約現金流量的特徵及本集團管理該等資產的業務模式。除並無重大融資成分或本集團並未就此應用不調整重大融資成分影響實際權宜方法的應收貿易賬款外，本集團初步按其公平值加(倘並非按公平值入損益的金融資產)交易成本計量金融資產。根據下文「收益確認」所載政策，並無重大融資成分或本集團並未就此應用實際權宜方法的應收貿易賬款按香港財務報告準則第15號釐定的交易價格計量。

為使金融資產按攤銷成本或按公平值透過其他全面收益入賬分類及計量，需就未償還本金產生僅為支付本金及利息(「SPPI」)的現金流量。現金流量並非SPPI之金融資產按公平值透過損益分類及計量，而不論業務模式。

2.4 MATERIAL ACCOUNTING POLICIES (continued)**Investments and other financial assets (continued)***Initial recognition and measurement (continued)*

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

Purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace are recognised on the trade date, that is, the date the Group commits to purchase or sell the asset.

Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the statement of profit or loss when the asset is derecognised, modified or impaired.

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value recognised in the statement of profit or loss.

2.4 重大會計政策 (續)**投資及其他金融資產 (續)***初始確認及計量 (續)*

本集團管理金融資產的業務模式指為產生現金流量而管理金融資產的方式。業務模式釐定現金流量會否來自收取合約現金流量、出售金融資產或以上兩者。按攤銷成本分類及計量之金融資產以目的為持有金融資產以收取合約現金流量之業務模式持有，而按公平值透過其他全面收益分類及計量之金融資產以目的為持作收取合約現金流量及出售之業務模式持有。並非按上述業務模式持有之金融資產乃按公平值透過損益分類及計量。

購買或出售金融資產乃指於市場上按規則或慣例設定之時間框架內完成資產交易，乃按交易日（即本集團承諾購買或出售資產之日）基準確認。

後續計量

金融資產之後續計量乃視乎彼等之下列分類：

按攤銷成本計量的金融資產 (債務工具)

按攤銷成本計量的金融資產隨後使用實際利率法計量，並可予減值。收益及虧損於資產終止確認、修改或減值時於損益表中確認。

按公平值透過損益入賬之金融資產

按公平值透過損益入賬之金融資產按公平值於財務狀況表列賬，而公平值變動淨額於損益表中確認。

2.4 MATERIAL ACCOUNTING POLICIES (continued)**Investments and other financial assets (continued)***Financial assets at fair value through profit or loss (continued)*

This category includes equity investments which the Group had not irrevocably elected to classify at fair value through other comprehensive income. Dividends on the equity investments are also recognised as other income in the statement of profit or loss when the right of payment has been established.

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if and to what extent it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

2.4 重大會計政策 (續)**投資及其他金融資產 (續)***按公平值透過損益入賬之金融資產 (續)*

該類別包括本集團並無不可撤銷地選擇按公平值列入其他全面收益進行分類的權益投資。權益投資的股息在支付權確立時亦於損益表中確認為其他收入。

不再確認金融資產

金融資產 (或倘適用, 作為金融資產或類似金融資產組別一部份) 主要在下列情況不予確認 (即自本集團綜合財務狀況表移除):

- 從資產收取現金流之權利已屆滿; 或
- 本集團已轉讓從資產收取現金流之權利, 或已承擔根據「過賬」安排而在沒有重大時差下悉數將已收取之現金流支付有關第三者之責任; 及(a)本集團已將資產的大致所有風險及回報轉讓, 或(b)本集團並無轉讓或保留資產的大致所有風險及回報, 但已轉讓資產之控制權。

倘本集團已轉讓其收取從該項資產所得的現金流量之權利或已訂立過賬安排, 其評估是否保留該資產之所有權風險及回報及保留至何種程度。倘其並無轉讓或保留該資產之絕大部份風險及回報或轉讓該資產之控制權, 則本集團按本集團持續參與該資產之程度繼續確認該轉讓資產。於該情況下, 本集團亦確認相關負債。已轉讓資產及相關負債乃按反映本集團保留之權利及義務之基準計量。

2.4 MATERIAL ACCOUNTING POLICIES (continued)

Impairment of financial assets

The Group recognises an allowance for expected credit losses (“ECLs”) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information. The Group considers that there has been a significant increase in credit risk when contractual payments are more than 90 days past due.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group.

2.4 重大會計政策(續)

金融資產減值

本集團就所有並非按公平值透過損益入賬持有的債務工具確認預期信用損失(「預期信用損失」)撥備。預期信用損失乃以根據合約應付的合約現金流量與本集團預期收取的所有現金流量之間的差額為基準，按原有實際利率相近的差額貼現。預期現金流量將包括來自銷售所持有抵押品或其他信用增級的現金流量，此乃合約條款不可或缺的部分。

一般方法

預期信用損失於兩個階段進行確認。對於自初始確認後並無顯著增加的信貸風險，預期信用損失就可能於未來12個月內(12個月預期信用損失)出現的違約事件計提撥備。對於自初始確認以來有顯著增加的信貸風險，須在信貸虧損風險預期的剩餘年期計提虧損撥備，不論違約事件於何時發生(全期預期信用損失)。

於各報告日期，本集團評估自初始確認以來金融工具的信貸風險是否顯著增加時。於作出評估時，以來本集團將於報告日期金融工具發生的違約風險與於初始確認日期金融工具發生的違約風險進行比較，並考慮合理且具支持性的資料，包括無需付出不必要的成本或努力而可得的歷史及前瞻性資料。本集團認為，當合約付款逾期超過90天時，信貸風險顯著增加。

當合約付款已逾期90天，本集團將金融資產視為違約。然而，在若干情況下，當內部或外部資料顯示本集團不可能在本集團採取任何信貸提升安排前悉數收回未償還合約金額時，本集團可將該金融資產視為違約。

2.4 MATERIAL ACCOUNTING POLICIES (continued)**Impairment of financial assets (continued)***General approach (continued)*

A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

- Stage 1 – Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
- Stage 2 – Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
- Stage 3 – Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

Simplified approach

For trade receivables and contract assets that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

2.4 重大會計政策(續)**金融資產減值(續)***一般方法(續)*

倘無法合理預期可收回合約現金流量，則撇銷金融資產。

按攤銷成本計量的金融資產在一般方法下可能會減值，且除應用簡化法的應收貿易賬款(如下文詳述)外，有關資產於以下階段分類以計量預期信用損失。

- 第一階段 – 金融工具自初始確認以來信貸風險並未顯著增加，且其虧損撥備相等於12個月預期信用損失
- 第二階段 – 金融工具自初始確認以來信貸風險已顯著增加，但並非信貸減值金融資產且其虧損撥備相等於全期預期信用損失
- 第三階段 – 於報告日期為信貸減值的金融資產(惟並非購入或原為信貸減值)，其虧損撥備相等於全期預期信用損失

簡化法

就不包含重大融資成分的應收貿易賬款及合約資產，或當本集團應用實際權宜方法而不會就重大融資成分的影響調整而言，本集團採用簡化法進行預期信用損失計量。根據簡化法，本集團不會追蹤信貸風險的變化，而是於各報告日期按全期預期信用損失確認虧損撥備。本集團已根據其歷史信貸虧損經驗建立撥備矩陣，並根據債務人及經濟環境的前瞻性因素作出調整。

2.4 MATERIAL ACCOUNTING POLICIES (continued)**Financial liabilities***Initial recognition and measurement*

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, financial liabilities at amortised cost, or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of payables, loans and borrowings, net of directly attributable transaction costs.

The Group's financial liabilities include trade and bills payables, other payables and accruals, amounts due to associates, an amount due to a non-controlling shareholder, lease liabilities and interest-bearing bank borrowings.

Subsequent measurement of financial liabilities at amortised cost (trade and other payables, and borrowings)

After initial recognition, trade and other payables and interest-bearing borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

2.4 重大會計政策(續)**金融負債***初步確認與計量*

金融負債被分類為按公平值透過損益入賬之金融負債、按攤銷成本計量之金融負債或指定作為對沖之對沖工具之衍生工具(如適用)。

所有金融負債初步按公平值確認及倘為應付款項、貸款及借貸，則扣除直接應佔交易成本。

本集團之金融負債包括應付貿易賬款及票據、其他應付款項及應計負債、應付聯營公司款項、應付非控股股東款項、租賃負債及須繳付利息之銀行借貸。

以攤銷成本列賬之金融負債(應付貿易賬款及其他應付款項及借貸)之後續計量

於初步確認後，應付貿易賬款及其他應付款項及計息借貸其後按實際利率法以攤銷成本計量，惟倘折算之影響並不重大則以成本列賬。盈虧乃當負債不再被確認，並在進行實際利率攤銷程序時在損益表確認。

攤銷成本乃考慮收購事項任何折讓或溢價及屬實際利率不可或缺一部份之費用或成本後計算。實際利率攤銷計入損益表之融資成本內。

不再確認金融負債

倘負債下之責任獲履行或註銷或屆滿，金融負債不再確認。

當現有金融負債被同一貸款人以明顯不同之條款提供之另一金融負債取代，或現有負債之條款大幅修訂，例如交換或修訂，則被視為不再確認原負債而確認新負債，而相關之賬面金額之差額則在損益表確認。

2.4 MATERIAL ACCOUNTING POLICIES (continued)

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis or weighted average basis and includes all costs of purchase, costs of conversion, and other costs incurred in bringing the inventories to their present location and condition. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to disposal.

Cash and cash equivalents

Cash and cash equivalents in the statement of financial position comprise cash on hand and at banks, and short-term highly liquid deposits with a maturity of generally within three months that are readily convertible into known amounts of cash, subject to an insignificant risk of changes in value and held for the purpose of meeting short-term cash commitments.

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and at banks, and short-term deposits as defined above, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

金融工具的抵銷

只有在現行可予執行之法律權利以抵銷已確認金額及有意按淨額基準償付，或變現資產與清還負債同時進行，則抵銷金融資產及金融負債及於財務狀況表內呈報淨金額。

存貨

存貨按成本值及可變現淨值兩者之較低者入賬。成本以先入先出法或加權平均基準計算，包括購貨之所有成本、轉換成本、將存貨運至現時地點及達致目前狀態所產生之其他成本。可變現淨值乃將估計售價減去估計出售將引致之成本計算。

現金及現金等值項目

財務狀況表中的現金及現金等值項目包括庫存現金和銀行存款，以及一般在三個月內到期的高流動性短期存款，這些存款可隨時兌換成已知金額的現金，價值變動風險不大，持有目的是為了滿足短期現金承諾。

就綜合現金流量表而言，現金及現金等值項目包括庫存現金、銀行存款和上述定義的短期存款，減去應要求償還並構成本集團現金管理組成部分的銀行透支。

撥備

倘因過往事件須承擔現時責任（法定或推定），而履行該責任可能導致未來資源外流，且該責任所涉金額能夠可靠估計，則確認撥備。

所得稅

所得稅包括即期稅項及遞延稅項。與於損益賬外確認之項目有關之所得稅於損益賬外之其他全面收益或直接於權益確認。

即期稅項資產及負債，乃根據已實施或於報告期末已大致實施之稅率（及稅法），並考慮本集團業務所在國家之現有詮釋及慣例，按預期將從稅務局收回或將支付予稅務局之金額計量。

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and
- in respect of taxable temporary differences associated with investments in subsidiaries and associates, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and
- in respect of deductible temporary differences associated with investments in subsidiaries and associates, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

遞延稅項就於報告期末資產及負債之稅項基準及其於賬目中之賬面值之所有暫時性差額以負債法作出撥備。

所有應課稅暫時性差額均被確認為遞延稅項負債，惟以下情況除外：

- 因初次確認一項交易而該交易並非為商業合併之商譽或資產或負債而產生，及於進行交易時，不會對會計溢利或應課稅溢利或虧損構成影響之遞延稅項負債，且並不產生同等應納稅和可抵扣暫時性差異；及
- 有關可控制撥回暫時性差額之時間及暫時性差額於可預見之將來極不可能撥回之附屬公司與聯營公司之投資之應課稅暫時性差額。

所有可被扣減之暫時性差額及未使用之稅項抵免與任何未使用稅務虧損之結轉均被確認為遞延稅項資產。遞延稅項資產將於很有可能獲得應課稅溢利而就此可動用可扣減暫時性差額及未動用稅項抵免及未動用稅項虧損之結轉時予以確認，惟以下情況除外：

- 當可被扣減之暫時性差額相關之遞延稅項資產，因初次確認一項交易而該交易並非為商業合併之資產或負債而產生，及於進行交易時不會對會計溢利或應課稅溢利或虧損構成影響；及
- 有關於附屬公司與聯營公司之投資所產生之可扣減暫時性差額，遞延稅項資產以可能出現之暫時性差額於可預見未來可撥回及可能有足夠可動用應課稅溢利抵扣所動用暫時性差額時予以確認。

遞延稅項資產之賬面值於每個報告期末檢討，並扣減至當不再可能有足夠應課稅溢利讓所有或部份遞延稅項資產被動用為止。未被確認之遞延稅項資產會於每個報告期末重新評估，並在已可能有足夠應課稅溢利讓所有或部份遞延稅項資產被收回時才予以確認。

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right exists to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same tax authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Revenue recognition*Revenue from contracts with customers*

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

遞延稅項資產及負債以當資產被變現或負債被清還時預期之適用稅率衡量，並根據於報告期末已制定或實際會制定之稅率（及稅務法例）計算。

當及僅當本集團有可合法執行權利可將即期稅項資產與即期稅項負債抵銷，且遞延稅項資產與遞延稅項負債與同一稅務機關對同一應稅實體或於各未來期間預期待有大額遞延稅項負債或資產需要清償或收回時，擬按淨額基準清償即期稅務負債及資產或同時變現資產及清償負債之不同稅務實體徵收之所得稅相關，則遞延稅項資產與遞延稅項負債可予抵銷。

收入確認*客戶合約收益*

客戶合約收益乃於貨品或服務的控制權讓予客戶時確認，該金額能反映本集團預期就交換該等貨品或服務有權獲得的代價。

倘合約代價包含可變金額，則其根據本集團於就交換向客戶轉讓貨品或服務時將享有的代價金額進行估計。可變代價於合約開始時估計並受到限制，直至與可變金額相關的不確定性於其後解除時，有關累計已確認收益金額的重大收益撥回極可能不會產生時方可解除。

倘合約包含融資部分，就為轉讓貨品或服務予客戶融資向客戶提供重大利益超過一年，則收益按應收款項金額按本集團與客戶在合約訂立時於個別融資交易內反映的貼現率貼現的現值計量。倘合約載有為本集團提供超過一年重大融資利益的融資部分，則收益根據有關合約確認，包括根據實際利息法合約負債附有的利息開支。就付款與轉讓承諾貨品或服務之間的期間為一年或以下的合約而言，本集團使用香港財務報告準則第15號的實際權宜之策，即交易價格不會就重大融資部分的影響作出調整。

Revenue from the sale of goods and restaurant operations is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the goods.

Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that discounts the estimated future cash receipts over the expected life of the financial instrument to the net carrying amount of the financial asset.

Rental income is recognised on a time proportion basis over the lease term.

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

Employee benefits*Pension schemes*

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

銷售貨品及經營餐廳的收入於資產控制權轉移予客戶的時間點確認，一般是於貨品交付時。

其他收入

利息收入為採用實際利率法計算，乃按累計基準採用足以將金融工具於其預計年期的估計未來現金收入貼現至金融資產賬面淨值的利率。

租金收入乃按租期以時間比例確認。

股息收入乃於股東收取付款之權利確立後，與股息相關之經濟利益很可能會流入本集團，且股息金額能夠可靠地計量時確認。

僱員福利*退休保障計劃*

本集團根據強制性公積金條例，為若干符合資格的僱員設立定額供款強制性公積金退休福利計劃（「強積金計劃」）。供款乃根據有關僱員之基本薪金百分比計算，根據強積金計劃之規則於應支付時計入損益表。強積金計劃之資產乃與本集團之資產分開，並由獨立管理基金持有。本集團之僱主供款於供款時全數歸屬於僱員。

Foreign currencies

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of overseas subsidiaries are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the exchange rates that approximate to those prevailing at the dates of the transactions.

外幣

財務報告乃以港元(即本公司之功能貨幣)呈列。本集團內各公司釐訂本身之功能貨幣,而計入各公司財務報告之項目乃利用該功能貨幣而計量。本集團內各實體錄得之外幣交易初步以交易日期各自之功能貨幣匯率記錄。以外幣計值之貨幣資產及負債,按報告期末之匯率再換算為功能貨幣。結算或換算貨幣項目產生之差額計入損益表。

以外幣歷史成本計算之非幣值項目,利用初步交易之日之匯率換算。以外幣按公平值計算之非幣值項目,利用計量公平值之日之匯率換算。換算以公平值計量之非貨幣項目產生之盈虧予以處理,以與確認該項目公平值變動之盈虧一致(即公平值盈虧於其他全面收益或損益內確認之項目換算差額亦分別於其他全面收益或損益中確認)。

於釐定初始確認相關資產之匯率、取消確認預收代價相關非貨幣資產或非貨幣負債之開支或收入時,初始交易日期為本集團初始確認預收代價所產生非貨幣資產或非貨幣負債當日。倘有多項預付款或預收款項,則本集團釐定各項預收代價付款或收款之交易日期。

海外附屬公司之功能貨幣為港元以外之貨幣。於報告期末,該等實體之資產及負債按報告期末之匯率換算為港幣,其損益表按交易日期之匯率相若之匯率換算為港元。

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve, except to the extent that the differences are attributable to non-controlling interests. On disposal of a foreign operation, the cumulative amount in the reserve relating to that particular foreign operation is recognised in the statement of profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of an overseas subsidiary are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of the overseas subsidiary which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

收購一項海外業務產生之商譽及任何由收購所得之資產及負債賬面值之公平值調整均視為海外業務之資產及負債及以收市價換算。

就綜合現金流量表而言，海外附屬公司之現金流動按產生現金流動日期之匯率換算為港元。海外附屬公司全年產生之經常性現金流動按期內之加權平均匯率換算為港元。

編製本集團財務報告須要管理層對所報告之收入、支出、資產及負債之金額，以及或然負債之披露作出判斷、估計及假設。有關該等假設及估計之不確定因素可能導致日後需要對受影響之資產或負債之賬面值作出重大調整。

在採用本集團會計政策之過程中，除涉及估計者外，管理層已作出下列對財務報告已確認之金額產生最重大影響之判斷：

Accounting for investments in associates

The Group applies judgement in evaluating the financial results and accounting estimates of the listed associate and its subsidiaries for the purpose of equity accounting, and assesses whether there are any indicators of impairment for investments in the listed associate and its subsidiaries at the end of each reporting period. An impairment exists when the carrying values of the investments exceed their recoverable amounts, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair values less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value-in-use calculations are undertaken, management estimates the expected future cash flows from the associates and chooses a suitable discount rate in order to calculate the present value of those cash flows.

Impairment testing of property, plant and equipment and right-of-use assets

The Group determines whether property, plant and equipment and right-of-use assets are impaired when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying values of these assets exceed their recoverable amounts, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair values less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value-in-use calculations are undertaken, management estimates the expected future cash flows from the asset or cash-generating unit and chooses a suitable discount rate in order to calculate the present value of those cash flows.

Deferred tax assets

Deferred tax assets are recognised for unused tax losses to the extent that it is probable that taxable profit will be available against which the losses can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies. The carrying value of deferred tax assets recognised for losses available for offsetting against future taxable profits at 31 March 2024 was HK\$690,000 (2023: HK\$1,619,000). Further details are contained in note 25 to the financial statements.

於聯營公司之投資之會計處理

本集團運用判斷評估上市聯營公司及其附屬公司以權益會計法計算之財務業績及會計估算，並在各報告期末評估於上市聯營公司及其附屬公司之投資是否出現任何減值跡象。當投資之賬面值超過其可收回金額，即公平值減銷售成本與其使用價值之較高者，則存在減值。公平值減出售成本乃基於按公平原則所進行具約束力的類似資產銷售交易所得數據或可觀察市場價格扣除出售資產的增量成本計算。計算使用價值時，管理層估計聯營公司的預期未來現金流量，選擇合適的貼現率以計算該等現金流量的現值。

物業、廠房及設備以及使用權資產之減值測試

倘有跡象顯示賬面值可能無法收回，則本集團會釐定物業、廠房及設備以及使用權資產是否已減值。當該等資產之賬面值超過其可收回金額，即公平值減銷售成本與其使用價值之較高者，則存在減值。公平值減出售成本乃基於按公平原則所進行具約束力的類似資產銷售交易所得數據或可觀察市場價格扣除出售資產的增量成本計算。計算使用價值時，管理層估計資產或現金產生單位的預期未來現金流量，選擇合適的貼現率以計算該等現金流量的現值。

遞延稅項資產

在很有可能將有足夠的應課稅溢利來抵扣稅務虧損的限度內，應就未利用的稅務虧損確認遞延稅項資產。這需要管理層作出重大判斷來估計未來應課稅溢利發生的時間和金額，結合未來稅務規劃策略，以決定應確認的遞延稅項資產的金額。於二零二四年三月三十一日可用以與將來應課稅溢利抵銷之虧損並確認為遞延稅項資產的賬面值為690,000港元(二零二三年：1,619,000港元)。有關詳情載於財務報告附註25。

Significant judgement in determining the lease term of contracts with renewal options

The Group has several lease contracts that include extension and termination options. The Group applies judgement in evaluating whether or not to exercise the option to renew or terminate the lease. That is, it considers all relevant factors that create an economic incentive for it to exercise either the renewal or termination. After the commencement date, the Group reassesses the lease term if there is a significant event or change in circumstances that is within its control and affects its ability to exercise or not to exercise the option to renew or to terminate the lease (e.g., construction of significant leasehold improvements or significant customisation to the leased asset).

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

Provision for expected credit losses on trade receivables

The Group uses a provision matrix to calculate ECLs for trade receivables. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., customer type and rating).

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade receivables is disclosed in note 18 to the financial statements.

判斷 (續)

釐定有重續選擇權合約的租期時所用重大判斷

本集團擁有多個包括延期及終止選擇權的租賃合約。本集團於評估是否行使重續或終止租賃選擇權時運用判斷。其將所有會對行使重續或終止構成經濟激勵的相關因素進行考量。於開始日期後，如在本集團控制範圍內有影響其行使或不行使重續或終止選擇權的重大事件或情況變動(如重大租賃物業裝修或重大租賃資產訂製)，本集團會重新評估租期。

估計之不明朗因素

對下一個財政年度內之資產及負債之賬面值構成重大調整風險之未來及其他主要假設及於報告期末之估計之不明朗因素主要來源討論如下。

應收貿易賬款預期信用損失撥備

本集團使用撥備矩陣計算應收貿易賬款的預期信用損失。撥備率乃基於具有類似虧損模式的不同客戶分部組合(即按客戶類型及評級劃分)逾期日數釐定。

撥備矩陣初步基於本集團過往觀察所得違約率而釐定。本集團將調整矩陣，藉以按前瞻性資料調整過往信貸虧損經驗。於各報告日期，過往觀察所得違約率將予更新，並會分析前瞻性估計變動。

預期信用損失金額對情況及預測經濟環境的變化敏感。本集團過往信貸虧損經驗及預測經濟環境亦可能無法代表客戶日後的實際違約情況。有關本集團應收貿易賬款的預期信用損失已於財務報告附註18披露。

4. OPERATING SEGMENT INFORMATION

For management purposes, the Group is organised into business units based on their products and services and has three reportable operating segments for the year ended 31 March 2024 as follows:

- (a) the trading segment is engaged in the trading of frozen meats, seafood and vegetables in Hong Kong;
- (b) the catering segment is engaged in restaurant operations in Hong Kong; and
- (c) the “others” segment consists of the marketing of meat products and communication and advertising design.

Management monitors the results of the Group’s operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on reportable segment profit/loss, which is a measure of adjusted profit/loss before tax. 32. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's principal financial instruments comprise interest-bearing bank borrowings and cash and cash equivalents. The main purpose of these financial instruments is to raise finance for the Group's operations. The Group has various other financial assets and liabilities such as trade receivables and trade and bills payables, which arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk, liquidity risk and equity price risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

Interest rate risk

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's cash and cash equivalents and short term debt obligations with floating interest rates.

The Group's funding policy uses short term interest-bearing debts to finance its working capital requirements. The Group borrows mainly at floating interest rates.

The following table demonstrates the sensitivity to a reasonably possible change in interest rates, with all other variables held constant, of the Group's profit/(loss) before tax (through the impact on cash and cash equivalents and floating rate borrowings) and the Group's equity.

32. 財務風險管理目標及政策

Foreign currency risk

The Group has transactional currency exposures. Such exposures arise from sales or expenses of operating units in currencies other than the units' functional currencies. The Group's monetary assets, financing and transactions were principally denominated in Hong Kong dollar and United States dollar.

Since the Hong Kong dollar is pegged to the United States dollar, the Group's exposure to foreign currency risk in respect of the bank balances and trade and bills payables denominated in United States dollars is considered to be minimal.

Credit risk

The Group trades only with recognised and creditworthy customers. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant.

Maximum exposure and year-end staging

The table below shows the credit quality and the maximum exposure to credit risk based on the Group's credit policy, which is mainly based on past due information unless other information is available without undue cost or effort, and year-end staging classification as at 31 March. Equity price risk

Equity price risk is the risk that the fair values of equity securities decrease as a result of changes in the levels of equity indices and the value of individual securities. The Group is exposed to equity price risk arising from individual equity investments financial assets at fair value through profit or loss (note 20) as at 31 March 2024.

If the prices of the respective listed equity investments and other unlisted equity investment had been 3% higher/lower, with all other variables held constant, the Group's profit/loss for the year would have decreased/increased by approximately HK\$367,000 (2023: HK\$612,000) as a result of the changes in the fair value of the Group's financial assets at fair value through profit or loss.

Capital management

The primary objectives of the Group's capital management are to safeguard the Group's ability to continue as a going concern and to maintain healthy capital ratios in order to support its business and maximise shareholders' value.

The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions. To maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders, return capital to shareholders or issue new shares.

As at 31 March 2024, there was no indication of breach of covenants. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 March 2024 and 2023.

The Group monitors capital using a gearing ratio, which is interest-bearing bank borrowings divided by equity attributable to equity holders of the Company. The gearing ratio is regularly reviewed by senior management. The gearing ratios as at the end of the reporting periods were as follows:
