## **ANNOUNCEMENT POWER GENERATION FOR JULY 2024**

This announcement is made by China Datang Corporation Renewable Power Co., Limited\* (the “**Company**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company announces that, according to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (collectively, the “**Group**”) for July 2024 on consolidated basis amounted to 1,985,167 MWh, representing a decrease of 8.60% as compared with that of the corresponding period of 2023, of which, the wind power generation amounted to 1,640,718 MWh, representing a decrease of 15.68% as compared with that of the corresponding period of 2023; and the photovoltaic power generation amounted to 344,449 MWh, representing an increase of 52.26% as compared with that of the corresponding period of 2023. As of 31 July 2024, the total power generation of the Group for 2024 amounted to 19,110,375 MWh, representing a decrease of 0.96% as compared with that of the corresponding period of 2023, of which, the wind power generation amounted to 16,889,226 MWh, representing a decrease of 5.56% as compared with that of the corresponding period of 2023; and the photovoltaic power generation amounted to 2,221,149 MWh, representing an increase of 57.24% as compared with that of the corresponding period of 2023.
