### Dividend

On 30 July 2024, Standard Chartered PLC announced an interim cash only dividend for 2024 of 9 US cents.

If you are a Hong Kong ('HK') registered shareholder, you will automatically receive your cash dividend in HK dollars, unless you have a standing instruction in place to receive it in another currency. If you currently receive your dividend in HK dollars and you wish for this to continue, no further action is required.

If you are a HK registered shareholder, you may choose to receive your cash dividend in sterling or US dollars. If you want to receive this cash dividend and future dividends in sterling or US dollars, you can register, update and/or cancel your instructions electronically via [computershare.com/hk/contact](http://computershare.com/hk/contact).

If you are a HK registered shareholder and have a standing instruction in place to receive a scrip dividend, as no scrip dividend option is being offered, you will automatically receive your cash dividend in HK dollars, unless you complete a currency election form to receive the currency in sterling or US dollars on or before 16 September 2024.

If you want to receive this cash dividend and future dividends in sterling or US dollars, you can register, update and/or cancel your instructions electronically at [computershare.com/hk/contact](http://computershare.com/hk/contact) or complete the enclosed currency election form and send it to our registrar provided your instructions are received by our registrar by 4:30pm (HK time) on 16 September 2024.
