- 1). Number of such securities purchased on the London Stock Exchange, CBOE BXE, CBOE CXE since special resolution is 55,055,538. Standard Chartered PLC will be fully complying with the new treasury share regime introduced under the revised Hong Kong Listing Rules from 11 June 2024 onwards. The directors intend to cancel the shares purchased pursuant to the authority granted by the special resolution. The special resolution refers to resolution 25 approved by the issuer's shareholders at its annual general meeting held on 10 May 2024. That resolution authorises the issuer to make purchases of its ordinary shares (subject to certain conditions) until the end of its 2025 annual general meeting (or, if earlier, until the close of business on 9 August 2025), but during that period the issuer may agree to purchase shares where the purchase may not be completed (fully or partly) until after the authority ends, so as to enable the issuer to make a purchase of ordinary shares in accordance with any such agreement as if the 2024 authority had not ended.
