## **CHANGE OF CHIEF FINANCIAL OFFICER**

The board of directors (the “**Board**”) of H World Group Limited (the “**Company**”) hereby announces that Mr. ZOU Jun (“**Mr. Zou**”) will resign as the chief financial officer of the Company for personal reasons, effective on September 4, 2024. Ms. CHEN Hui (“**Ms. Chen**”), the chief compliance officer of the Company, has been appointed as the chief financial officer of the Company, effective on September 4, 2024.

Ms. Chen has deep financial management expertise in the travel and hotel industries in China. She initially joined the Company in 2014. From 2014 to early 2016, Ms. Chen served as the Company’s executive vice president of finance responsible for internal financial management and then chief financial officer. From March 2018 to February 2020, she was the chief financial officer of Cjia Group Limited\* (城傢集團有限公司), the Company’s affiliate company which primarily engages in providing apartment services. Ms. Chen rejoined the Company in February 2020 as the chief compliance officer. She then served as the chief financial officer of the Company from May 2021 to December 2022 and the chief compliance officer of the Company since December 2022. Her other previous work experiences also include chief financial officer of Home Inns Group\* (如家集團) and finance director of Trip.com. Ms. Chen received her master’s degree in management from Shanghai Jiaotong University\* (上海交通大學).
