## You may choose:

- to read the Corporate Communication published on the Company's website or The Stock Exchange of the Hong Kong Limited's website ("Website Version") instead of receiving printed copies; or
- (ii) to receive a printed English version only of the Corporate Communication; or
- (iii) to receive a printed Chinese version only of the Corporate Communication; or
- (iv) to receive both the printed English and Chinese versions of the Corporate Communication.

To contribute to the protection of our environment, we encourage you to select the Website Version. Even if you have chosen the Website Version, you reserve the right at any time by giving reasonable notice in writing to the Company's share registrar, Tricor Tengis Limited, to change your choice.

Please mark a "√" in the appropriate box on the enclosed reply form ("**Reply Form**") and sign and return it by post or by hand to the Company's share registrar, Tricor Tengis Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong within 28 days from date of this letter. If you post your Reply Form in Hong Kong, you may use the mailing label in the Reply Form and need not affix a stamp on the envelope when returning your Reply Form. Otherwise, please affix an appropriate stamp.

If the Company does not receive a duly completed and signed Reply Form from you (or another response from you indicating that you object to receiving the Website Version of Corporate Communications) within 28 days from date of this letter, you will be deemed, until you inform the Company otherwise by reasonable notice in writing at the office of the Company's share registrar at the above address or by email to <a href="mailto-hunghing-ecom@hk.tricorglobal.com">hunghing-ecom@hk.tricorglobal.com</a>, to have elected to receive all future Corporate Communications by Website Version instead of receiving them in printed form. In that event, when the Company makes a Corporate Communication, it will only send you a notification that the Corporate Communication has been made available on the Company's website or The Stock Exchange of the Hong Kong Limited's website. The notification will be sent to you by email or by post at your address as it appears in the Company's register of members maintained by the Company's share registrar.
